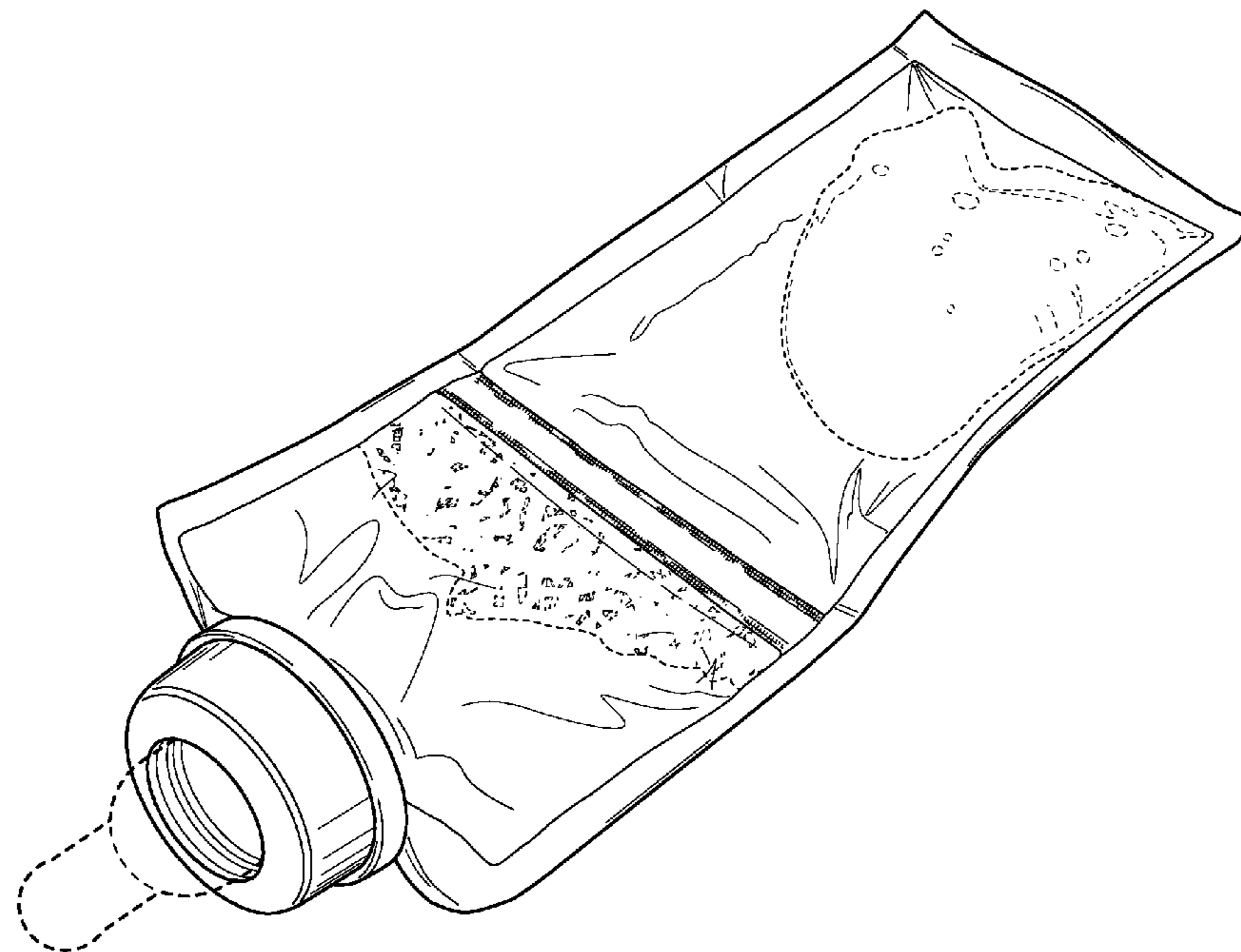
(57) **CLAIM**

We claim the ornamental design for a two-compartment disposable baby nursing pouch, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a two-compartment disposable baby nursing pouch, showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a top plan view thereof, the bottom plan view being a mirror image thereof; and, FIG. 5 is a left-side elevational view thereof, the right-side elevational view being a mirror image thereof. The broken lines in the figures showing a baby bottle nipple and the contents of the pouches depict environmental structure, and form no part of the claimed design.

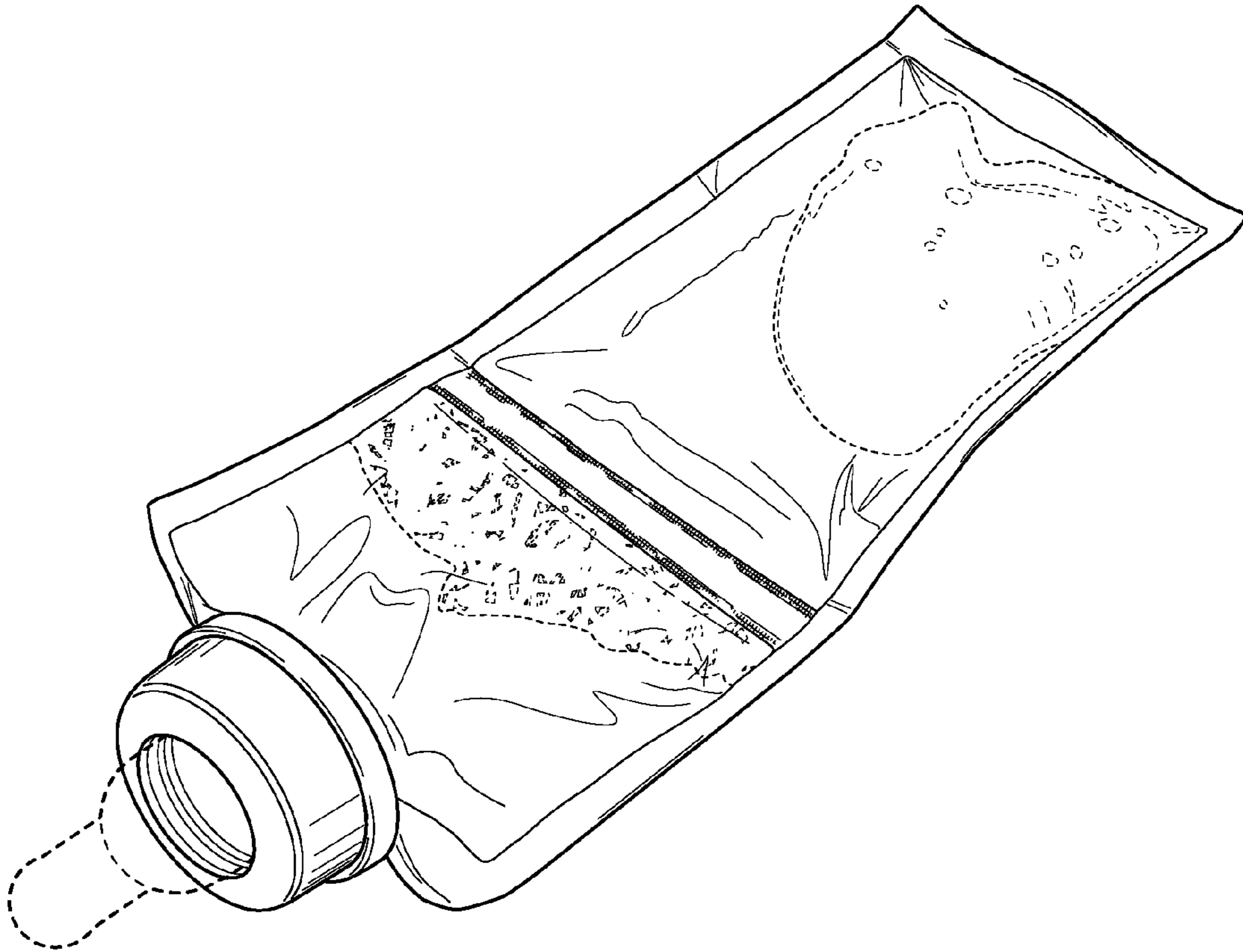

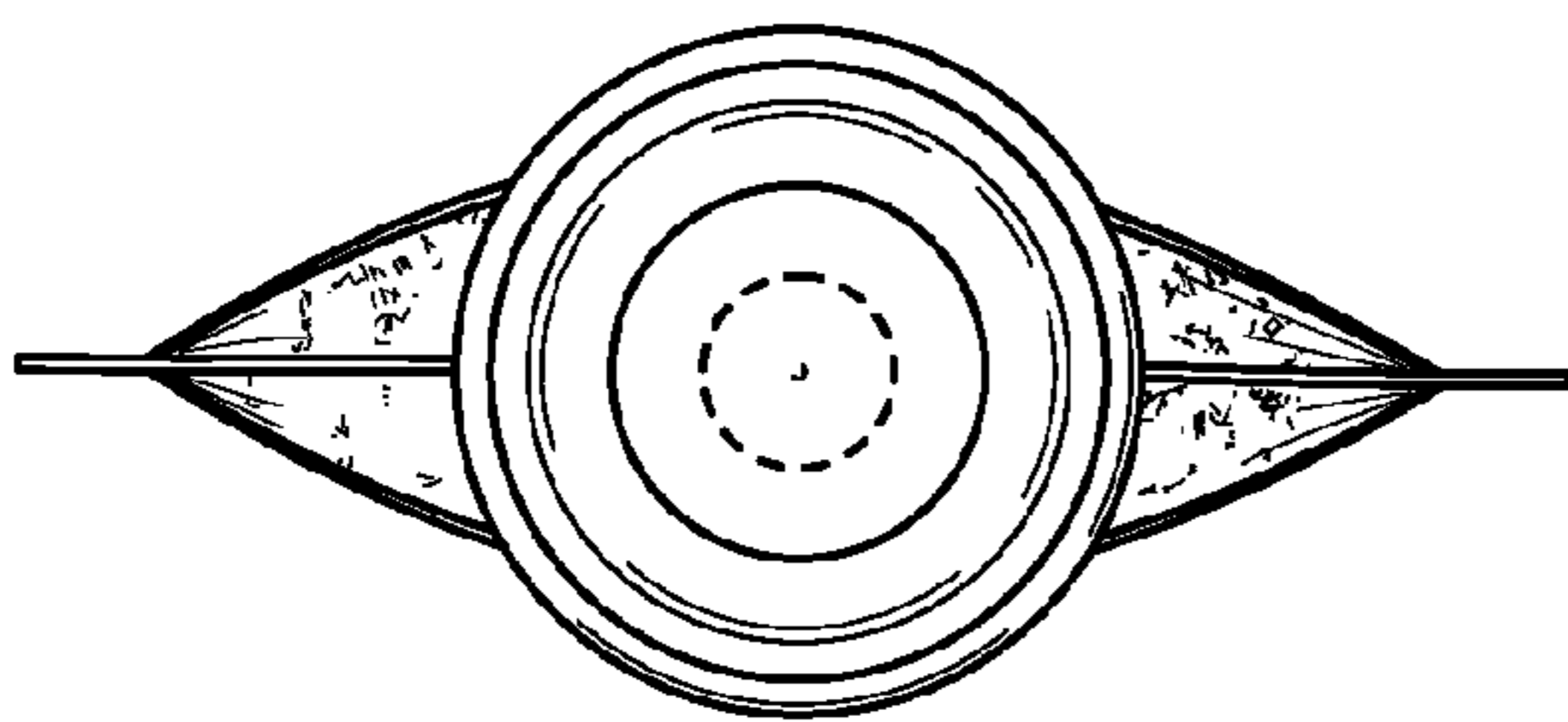

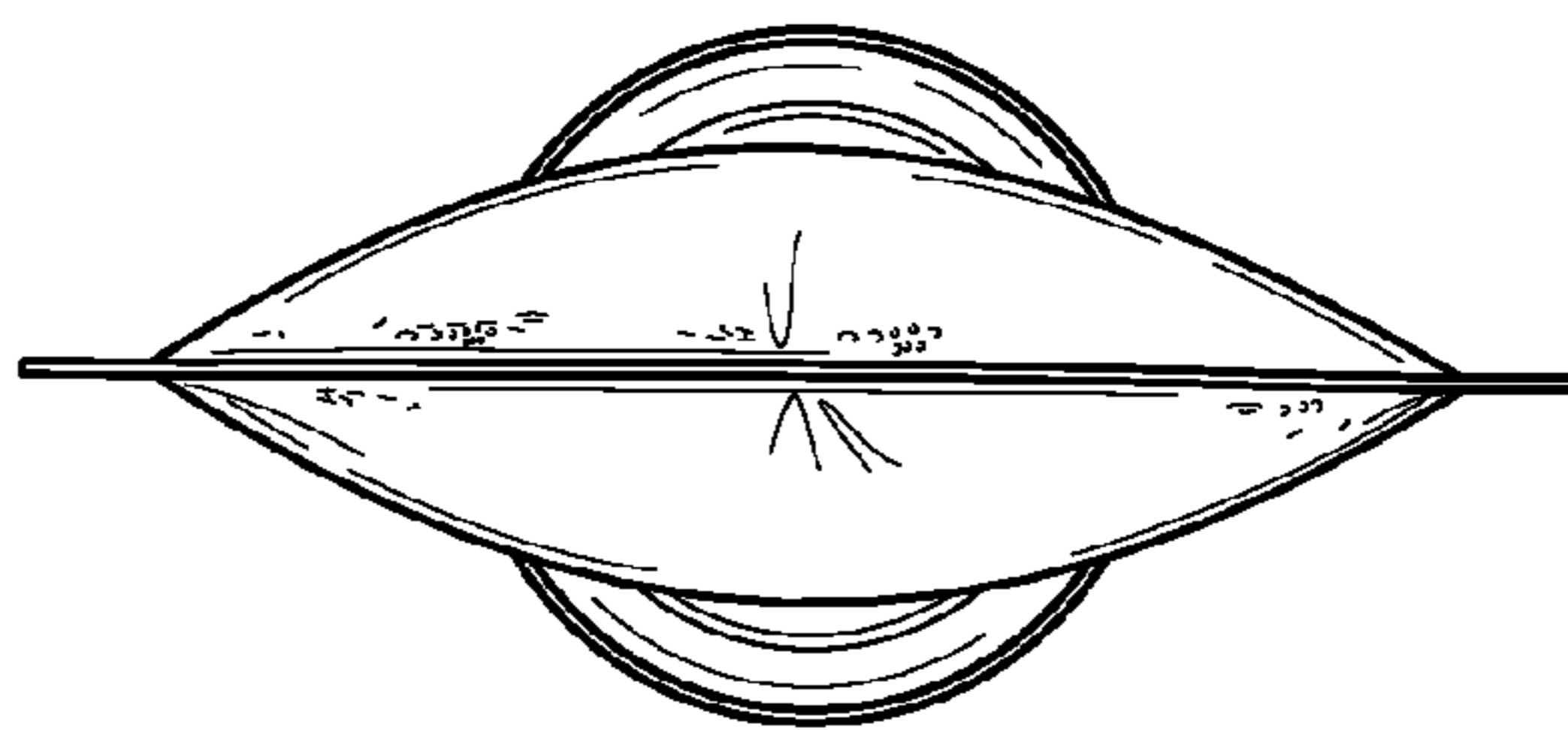

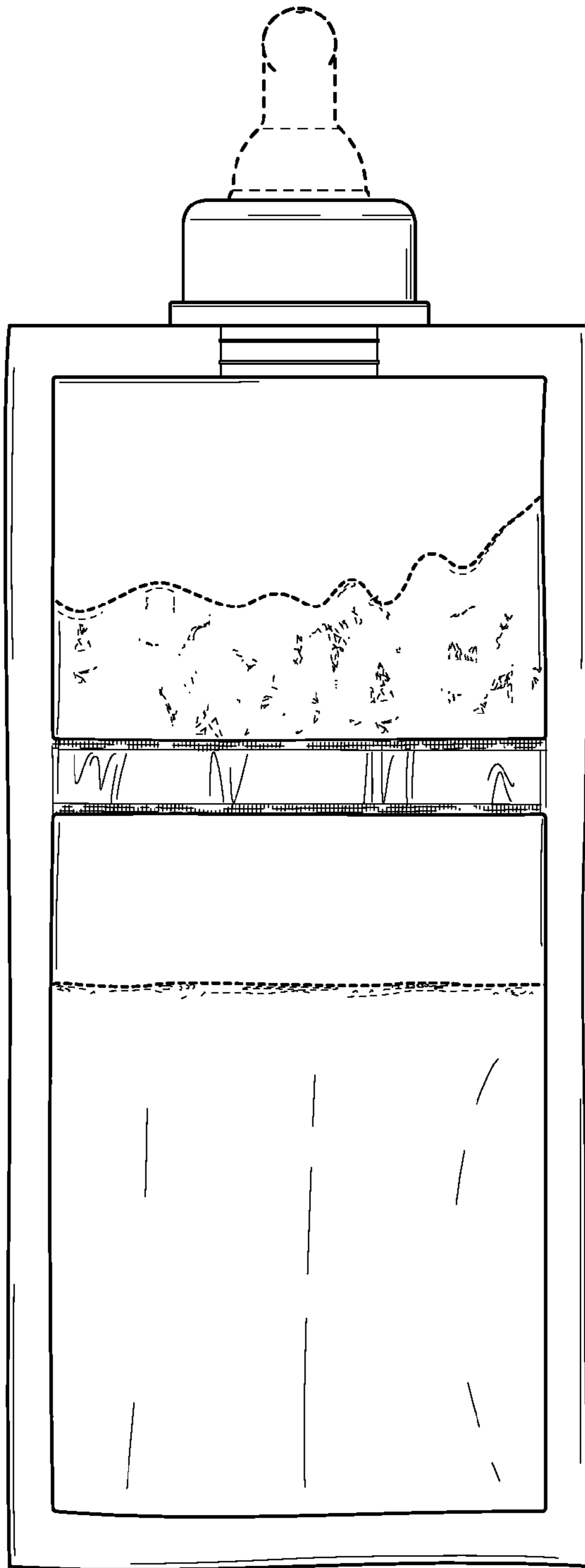

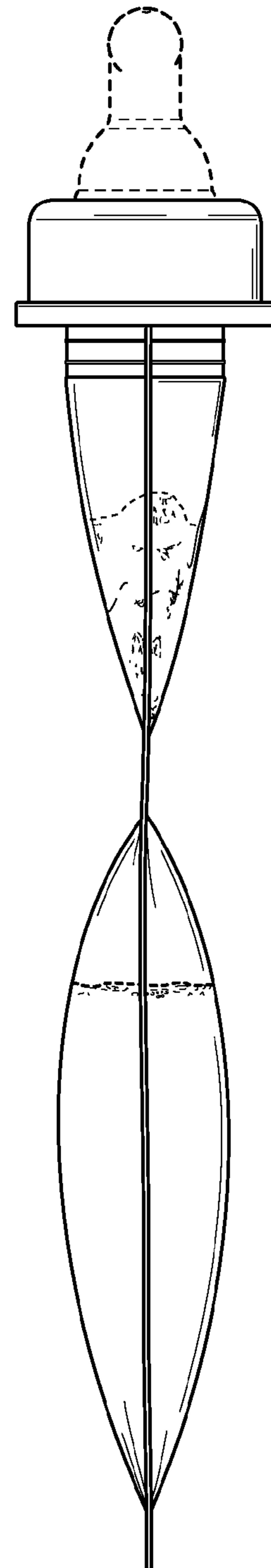
