FIG. 4 is a rear view of the embodiment

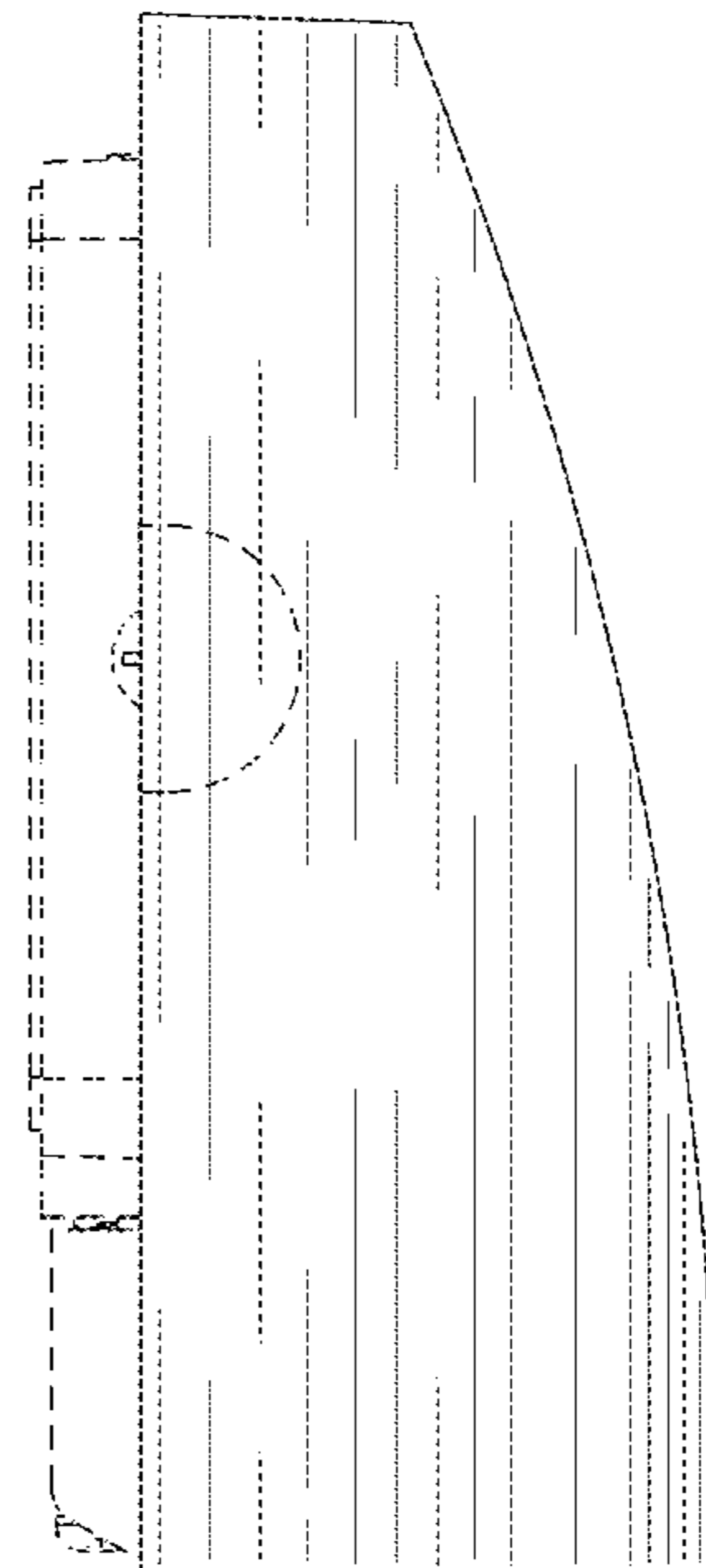
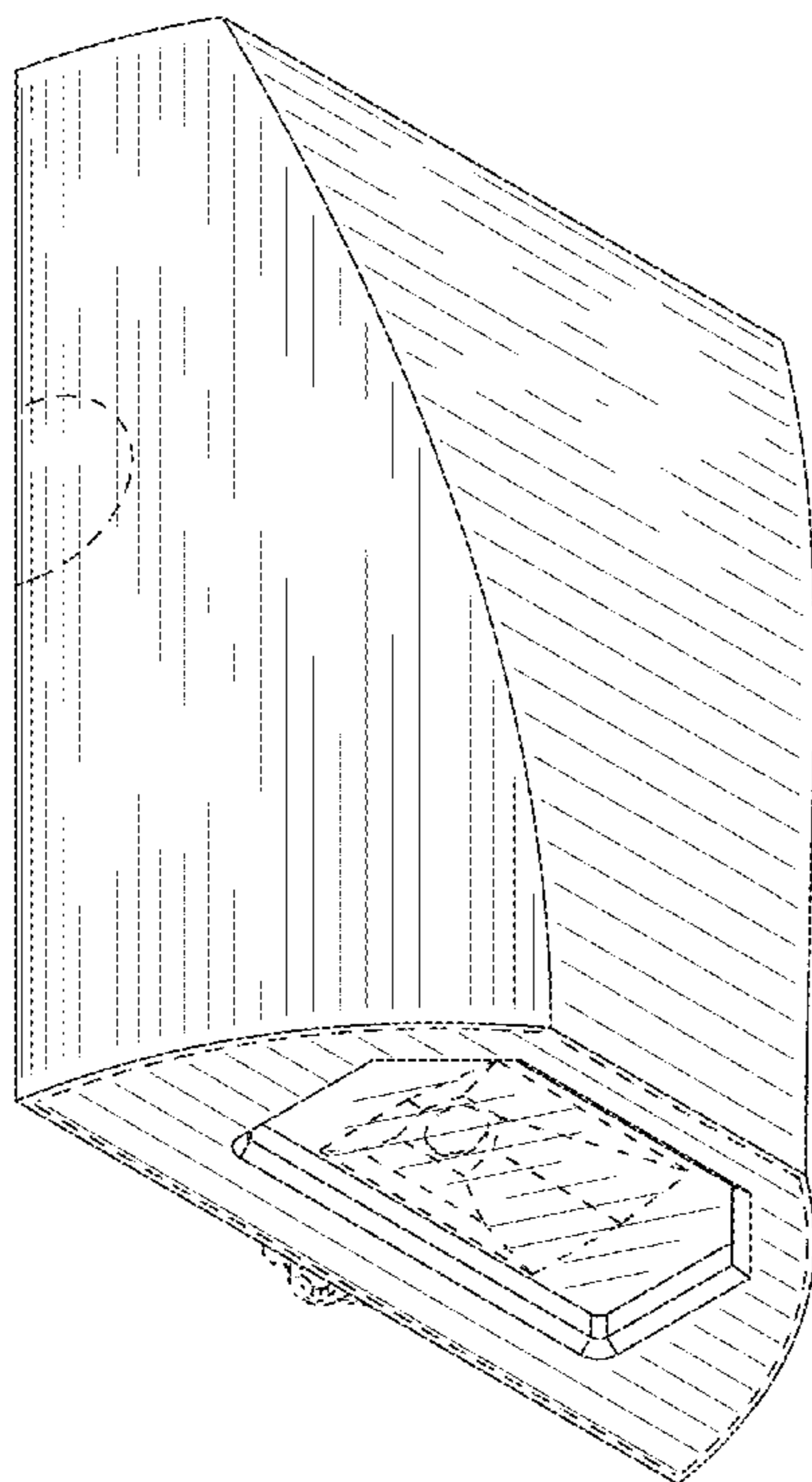
FIG. 5 is a left side view of the embodiment;

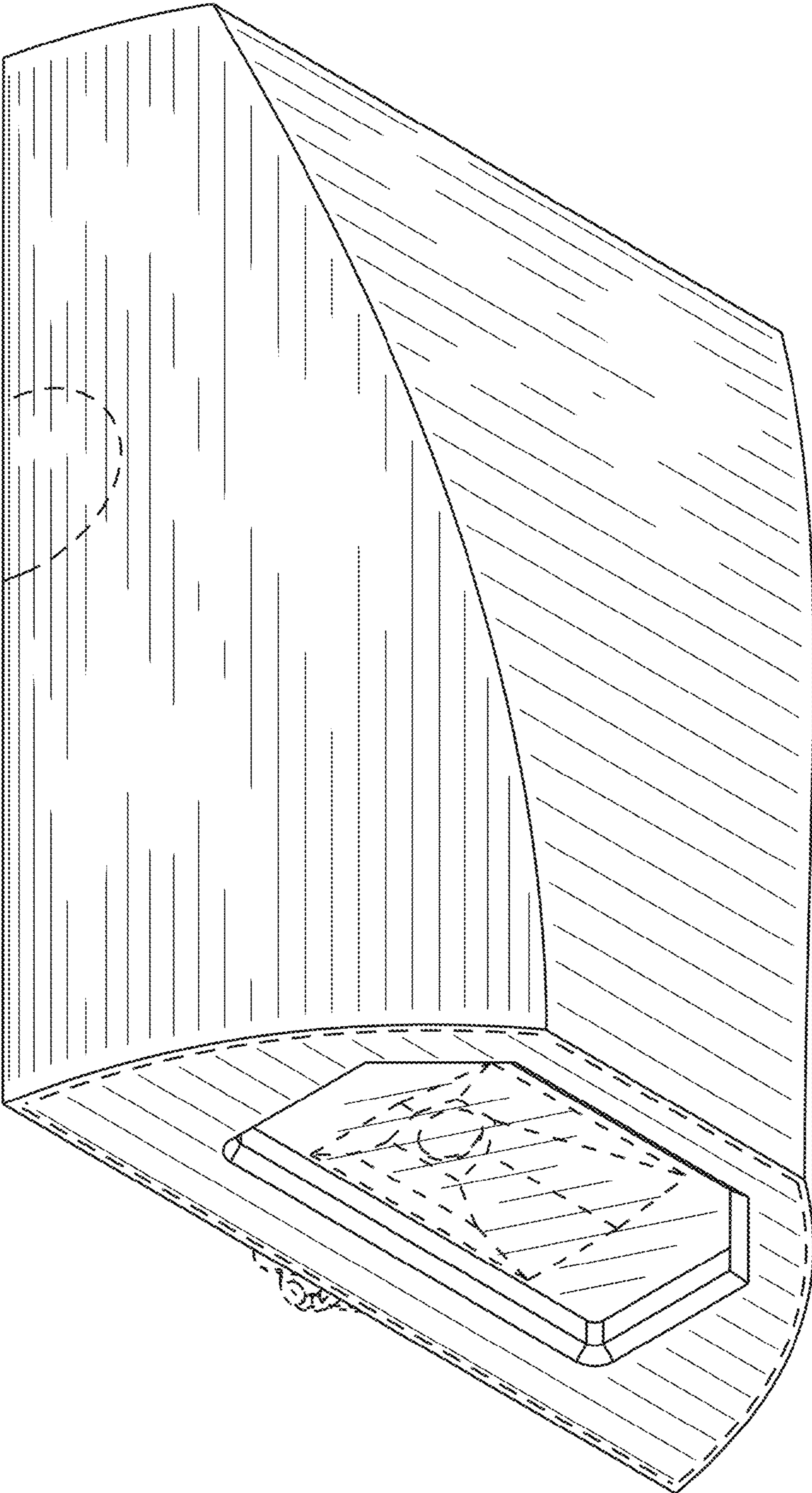

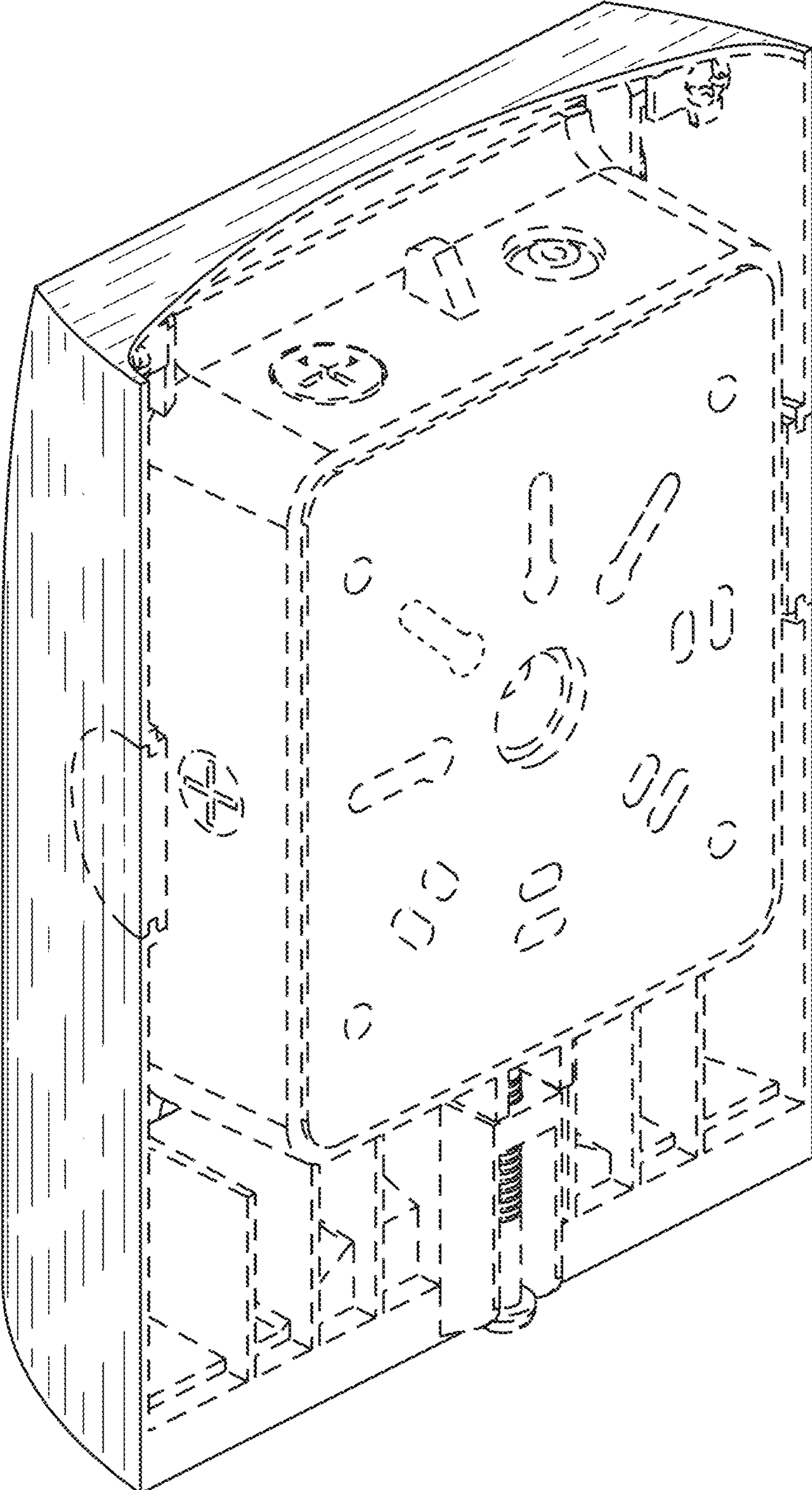

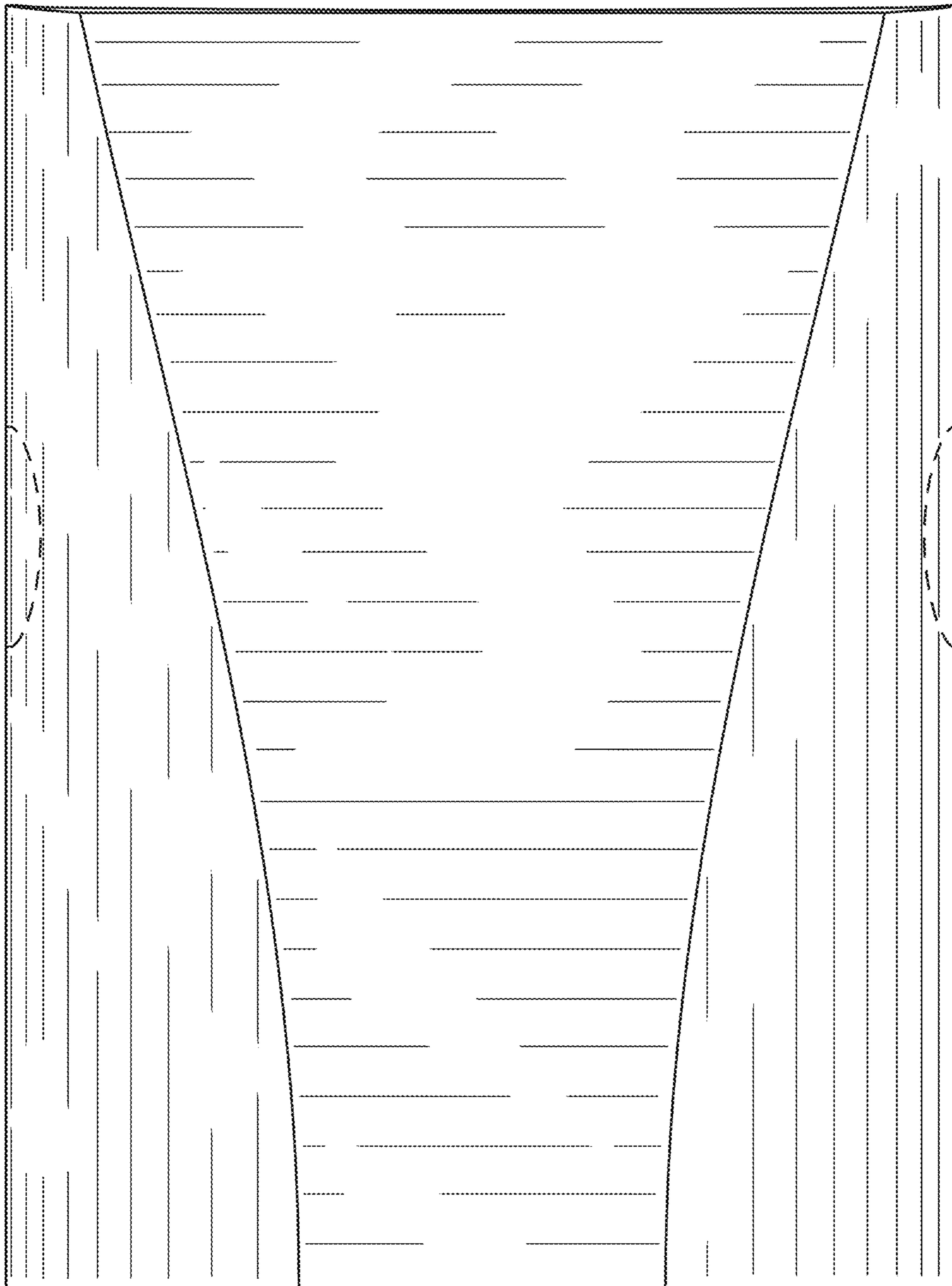

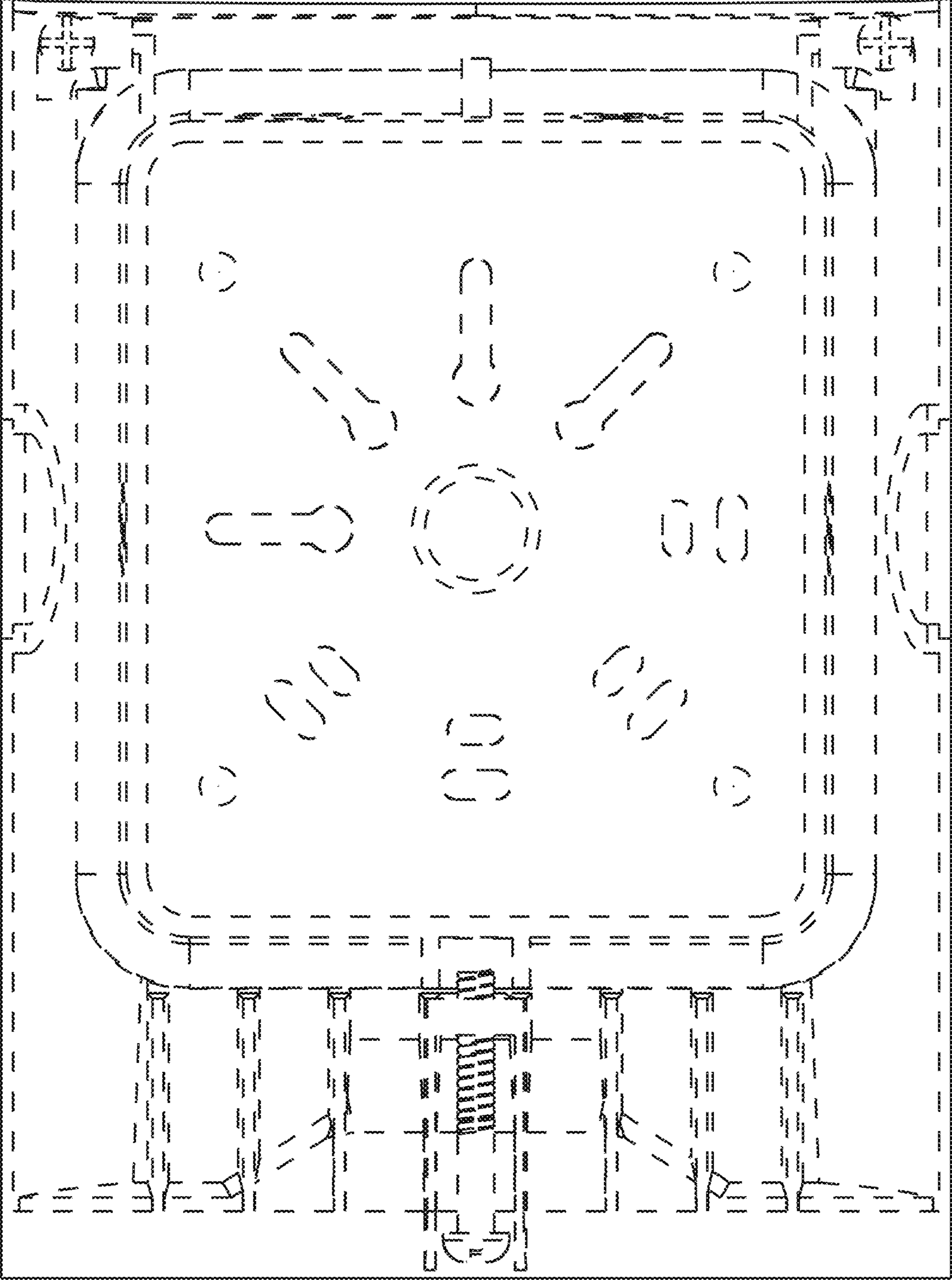

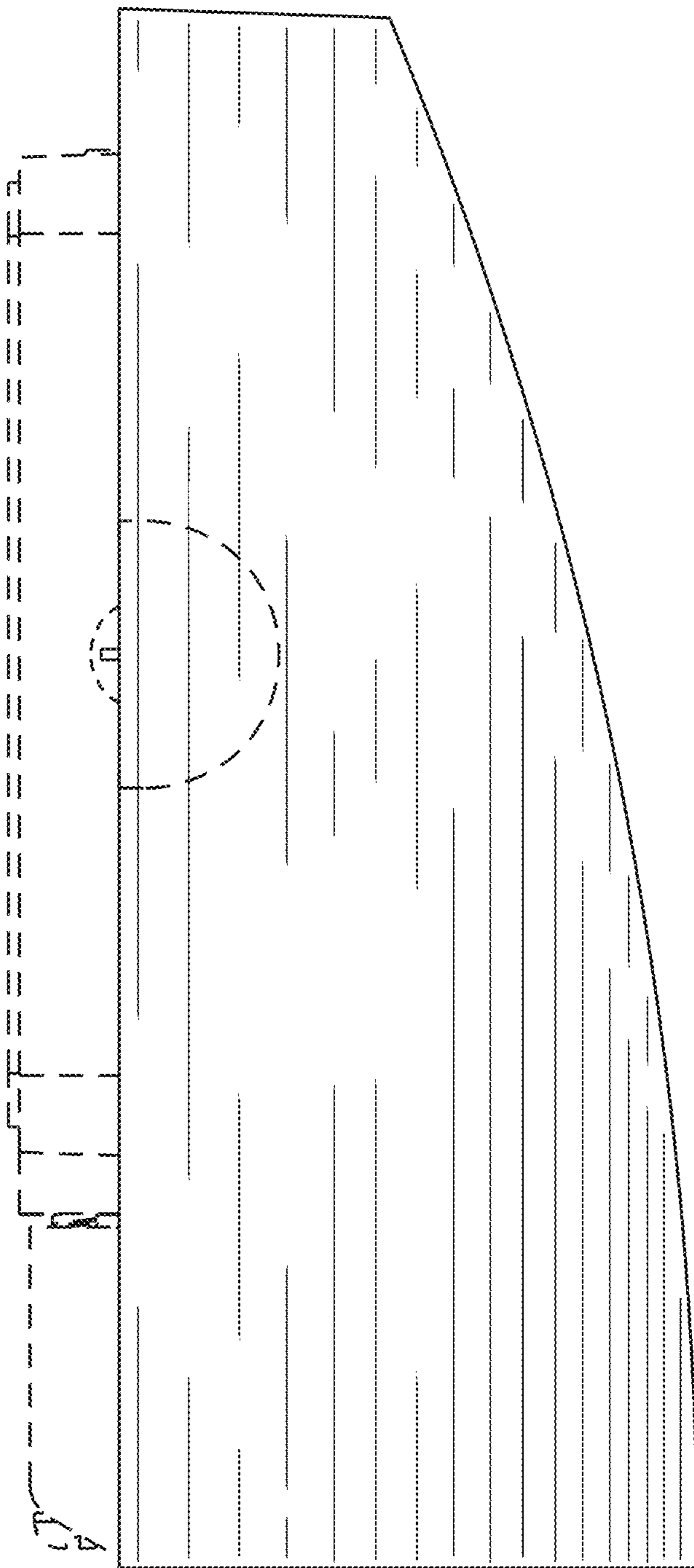

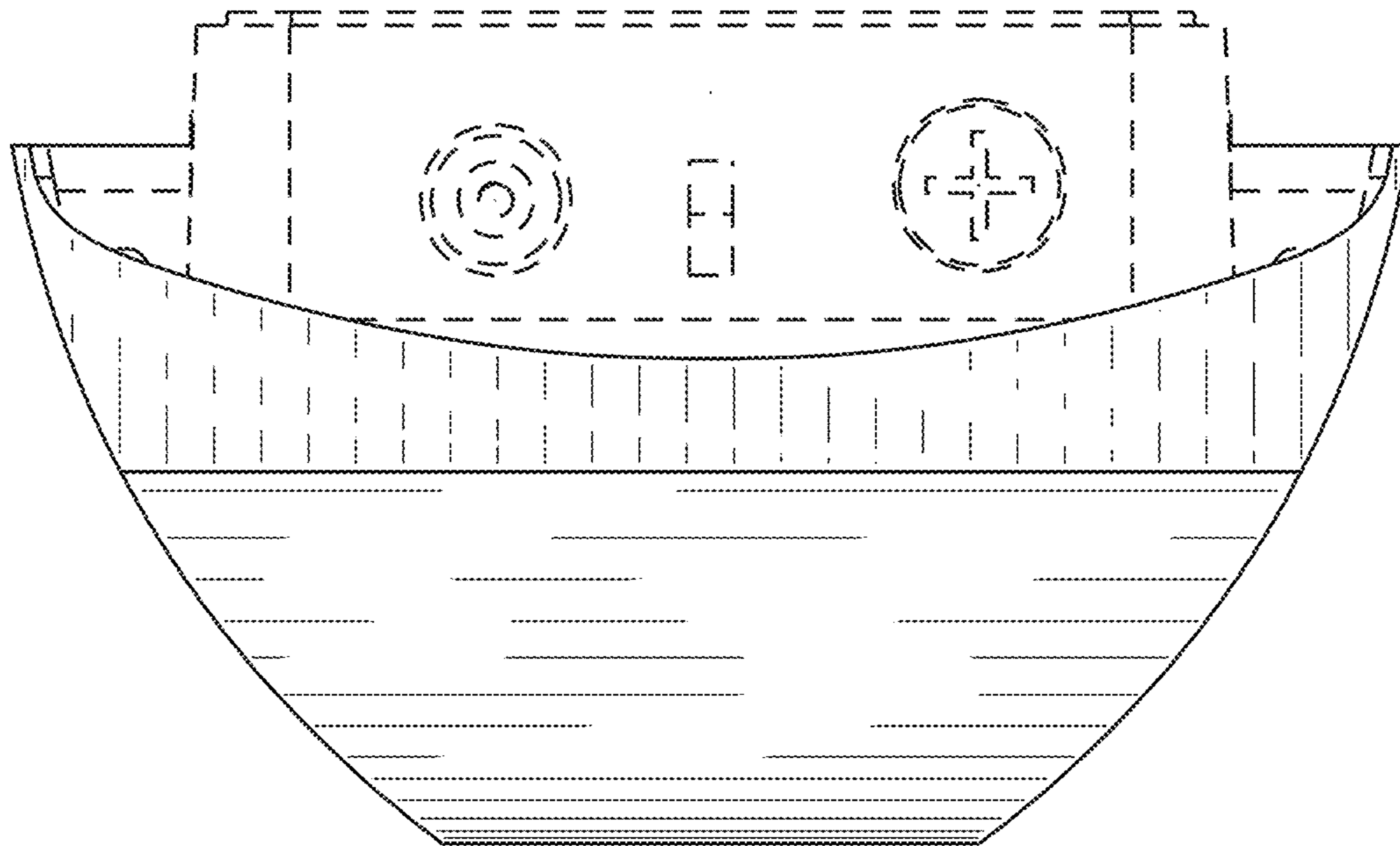

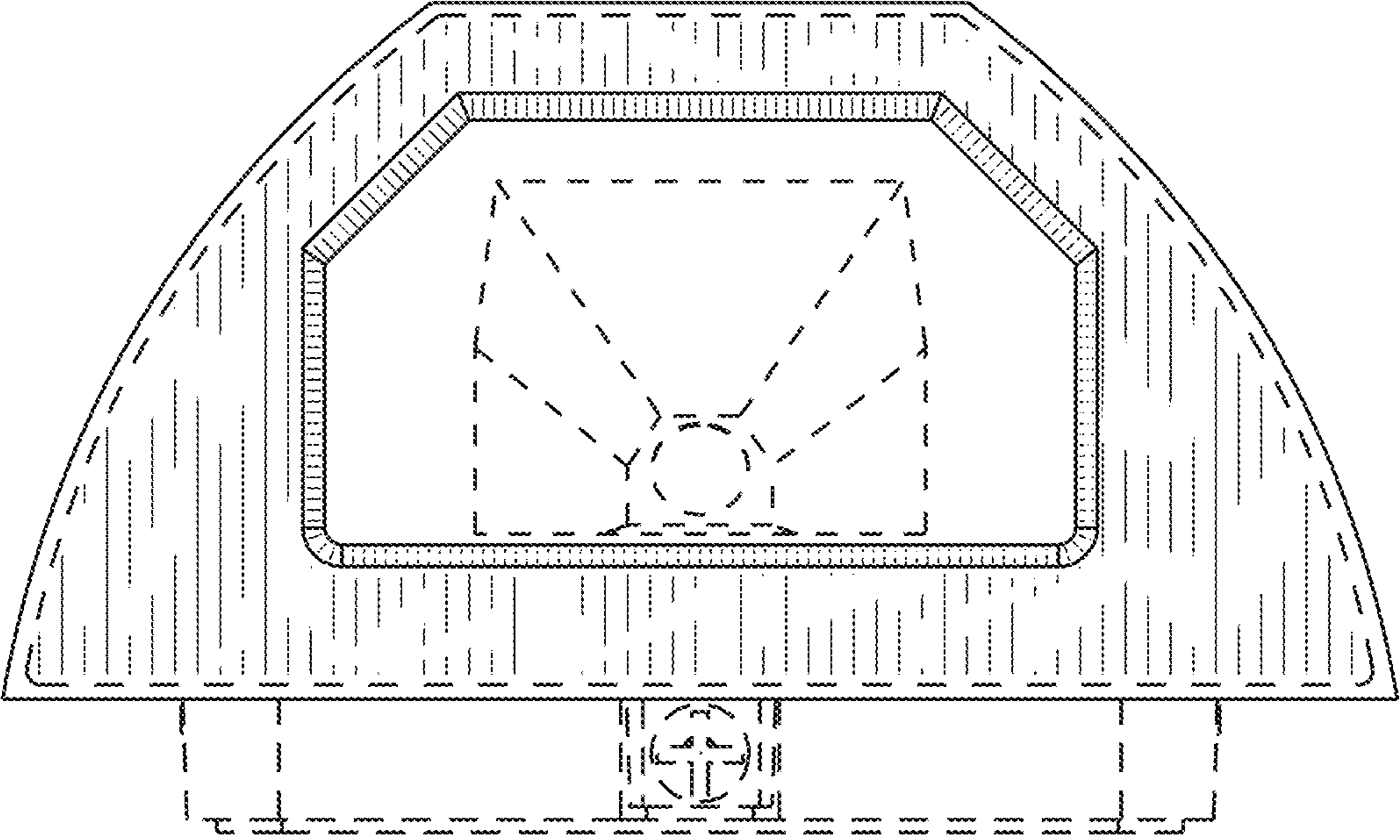
