The ornamental design for an appliance window, as shown
and described.

DESCRIPTION

FIG. 1 is a perspective view of the design for an appliance
window, which is illustrated in an exemplary location of a
door of an appliance;

FIG. 2 is a perspective view of the window of FIG. 1;

FIG. 3 is a front view of the window of FIG. 1;

FIG. 4 is a rear view of the window of FIG. 1;

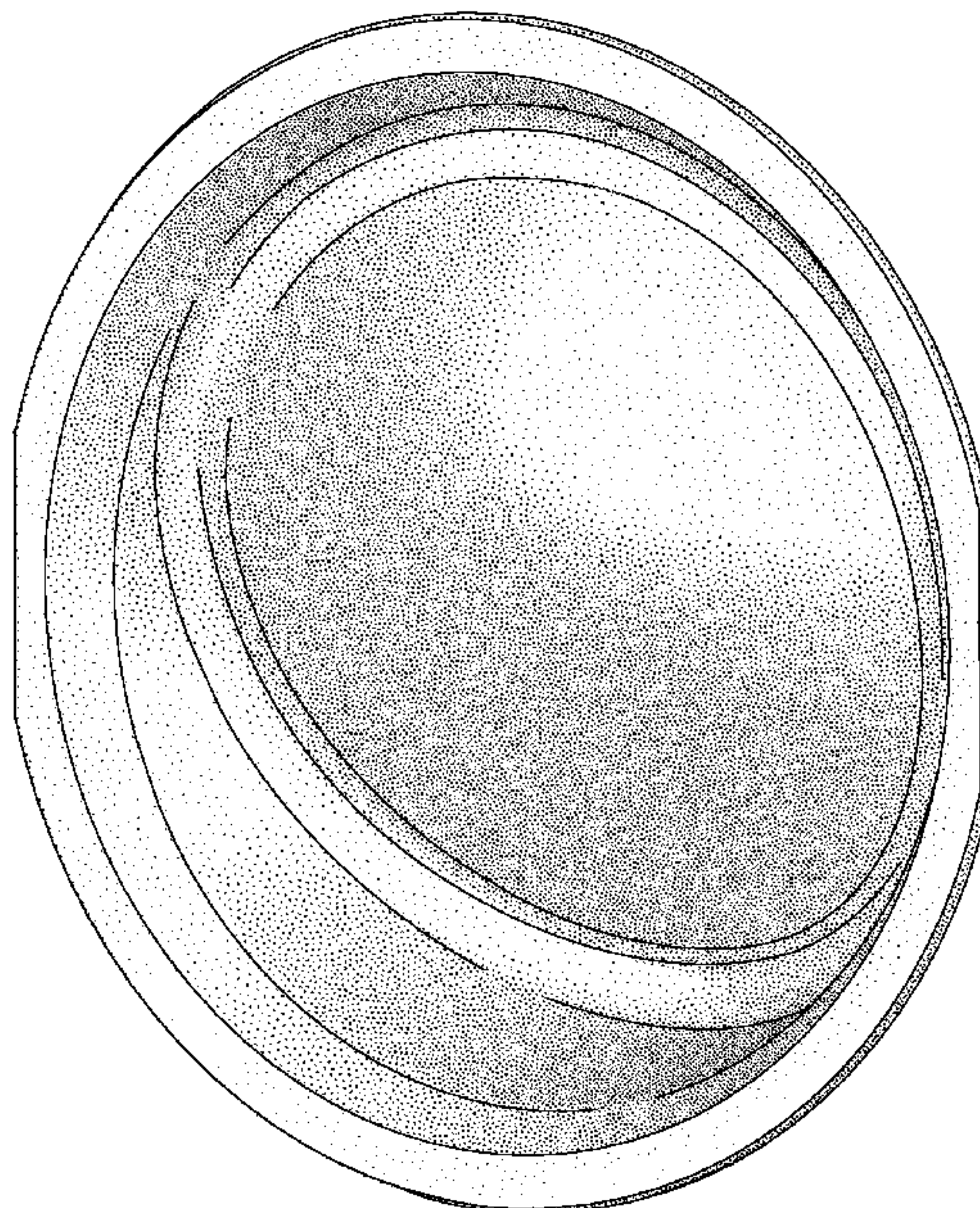
FIG. 5 is a right side view of the window of FIG. 1, with the

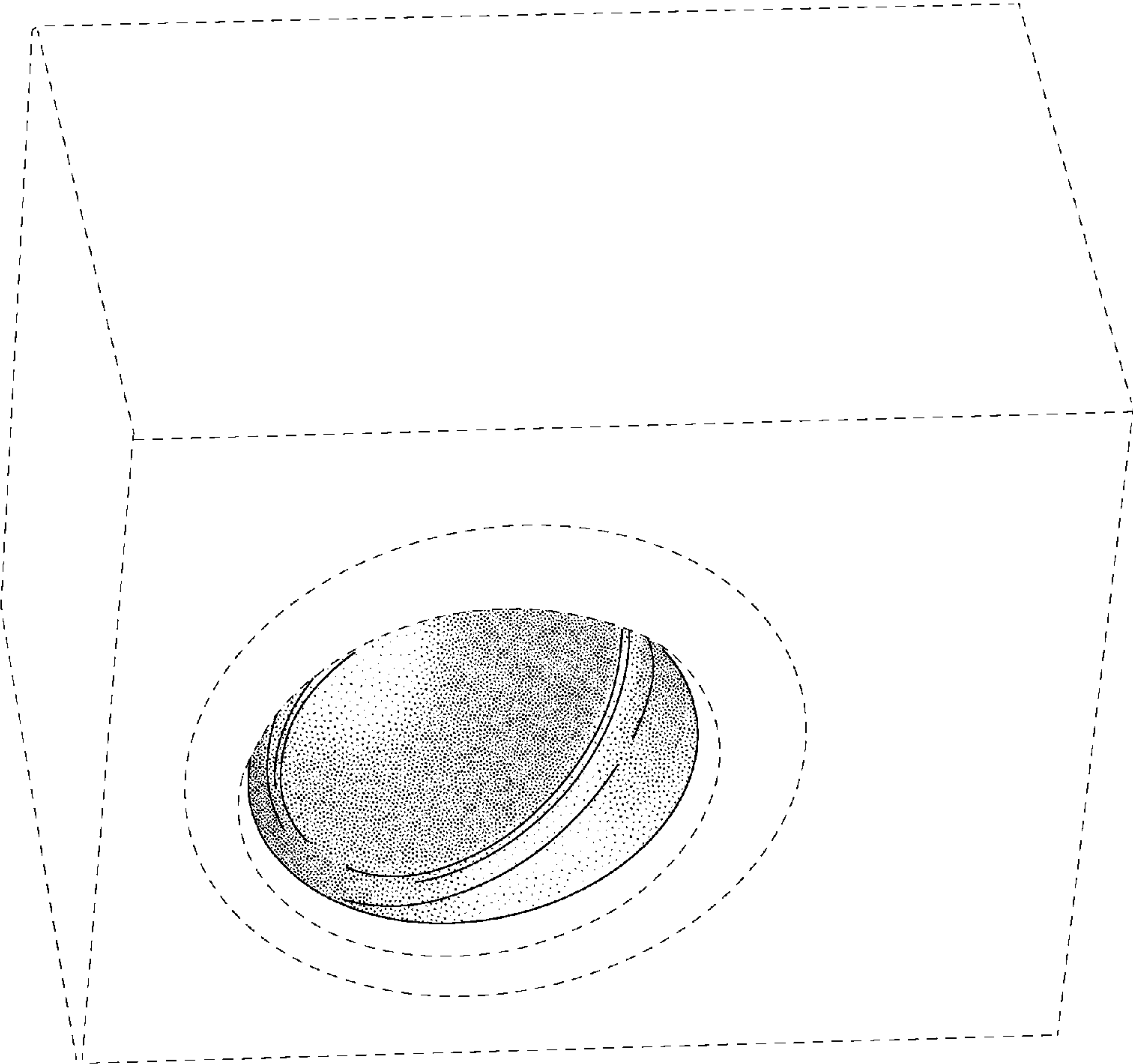

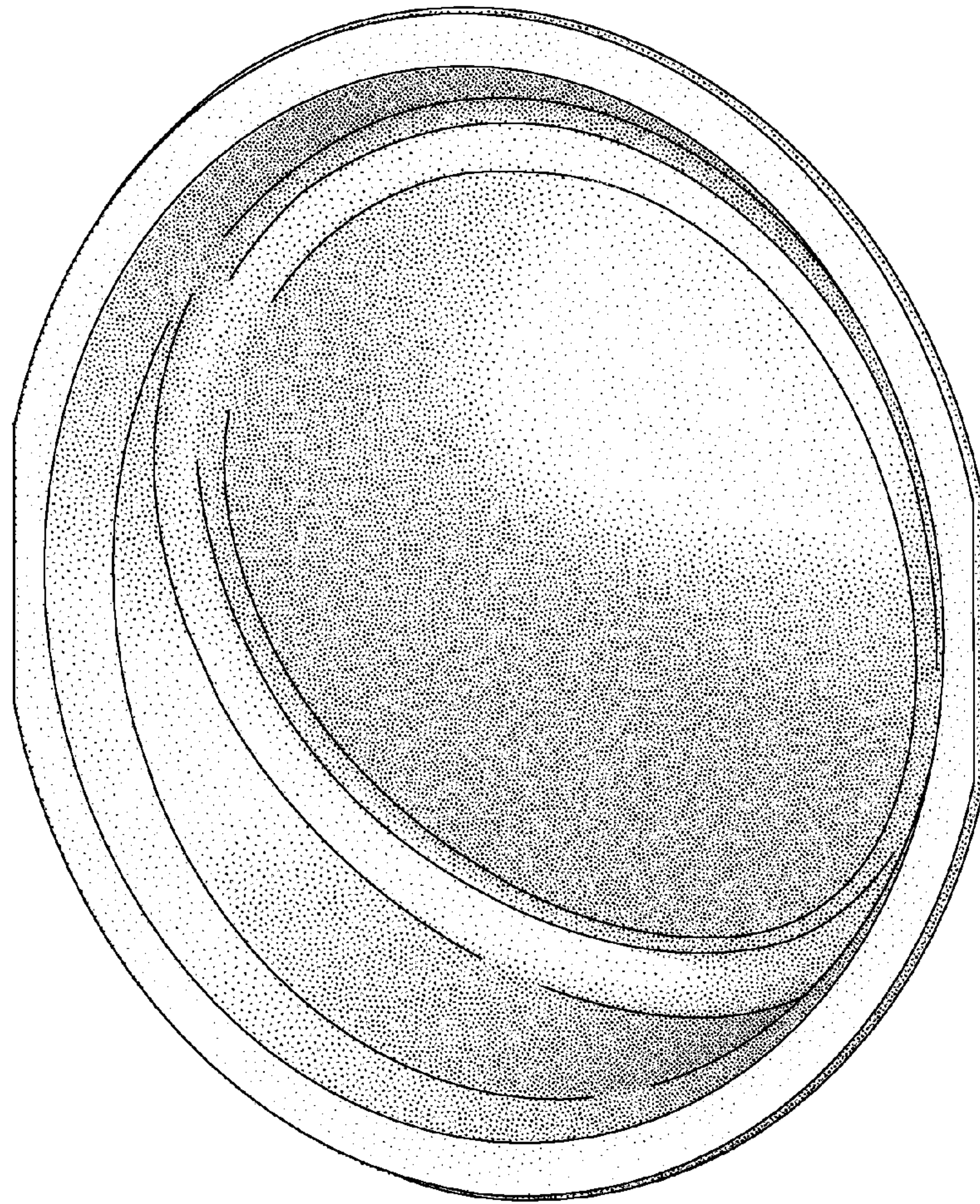

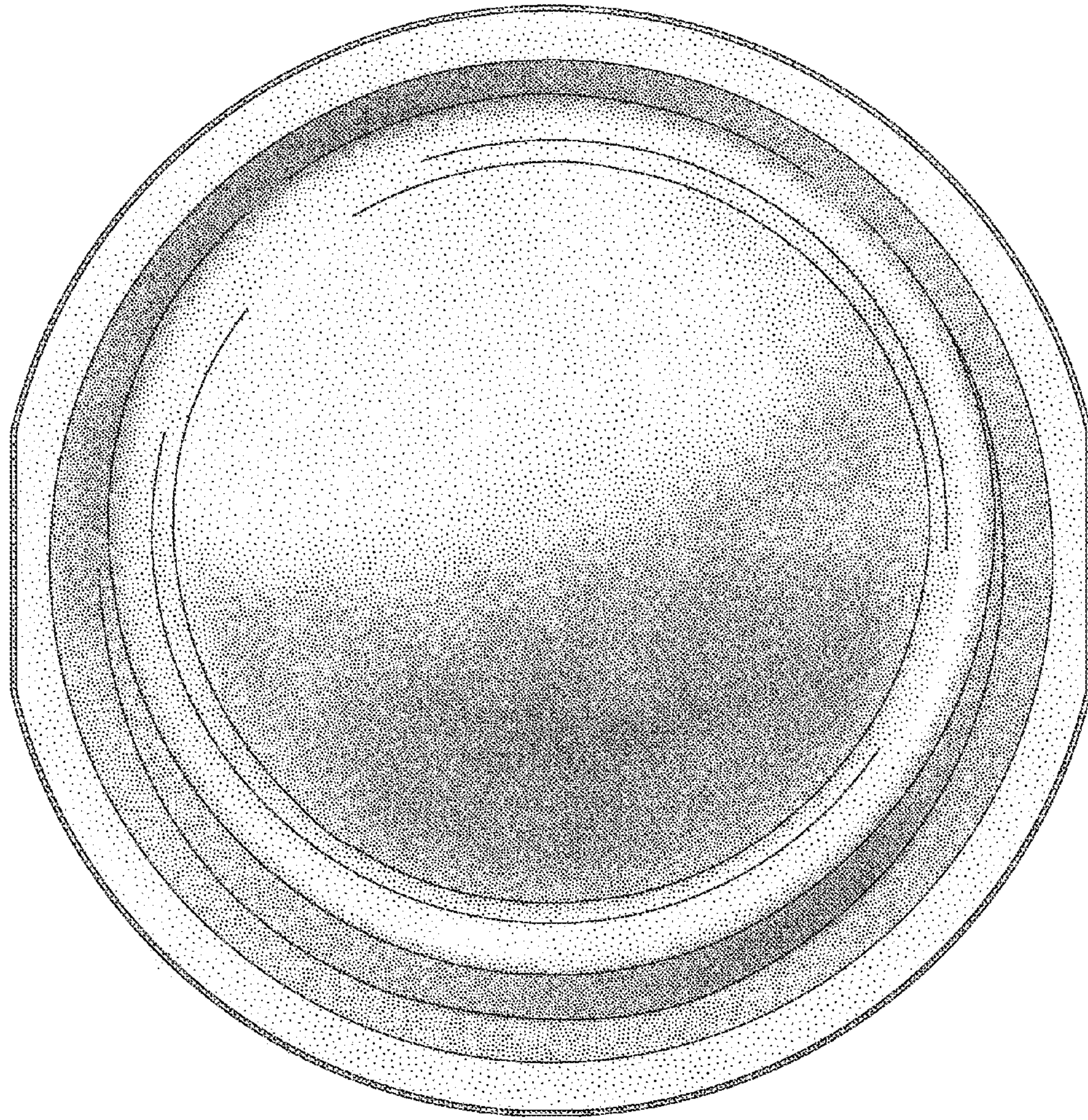

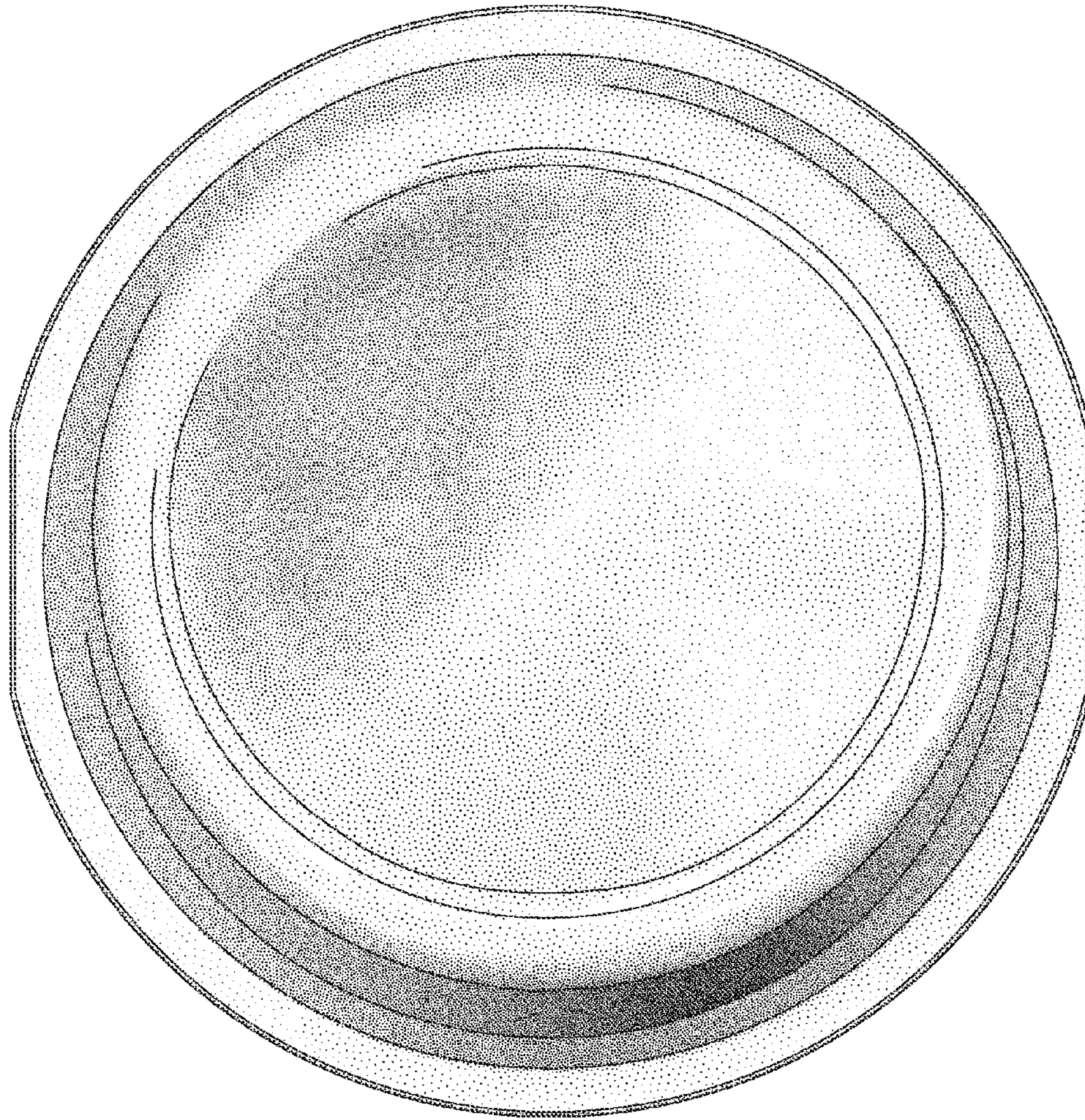

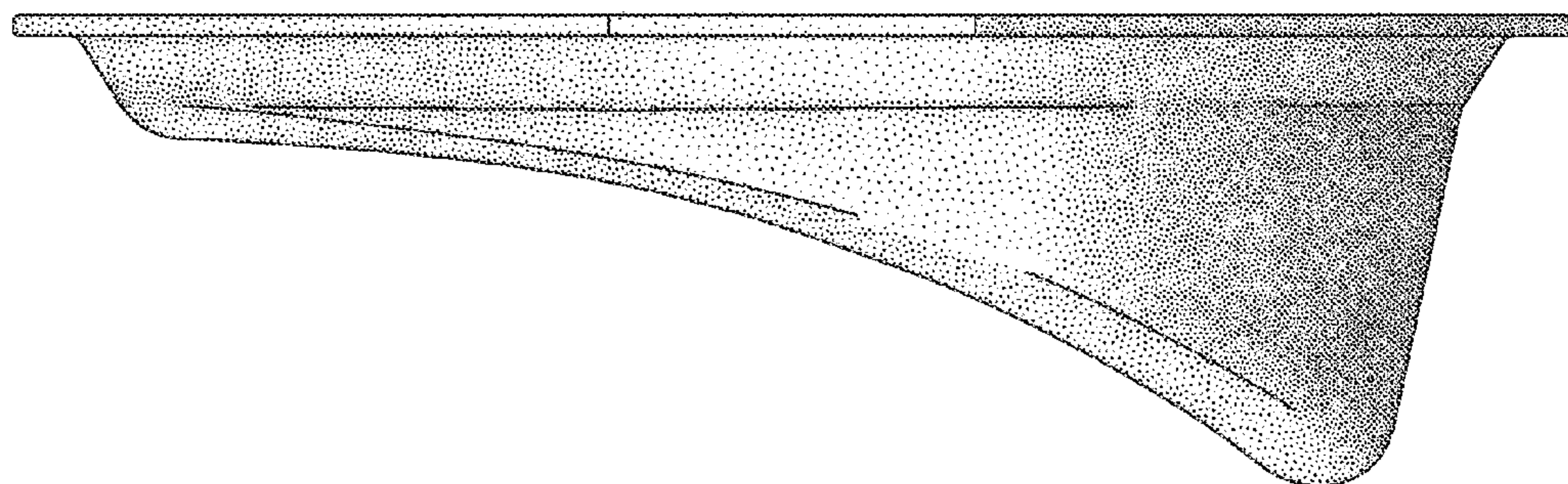

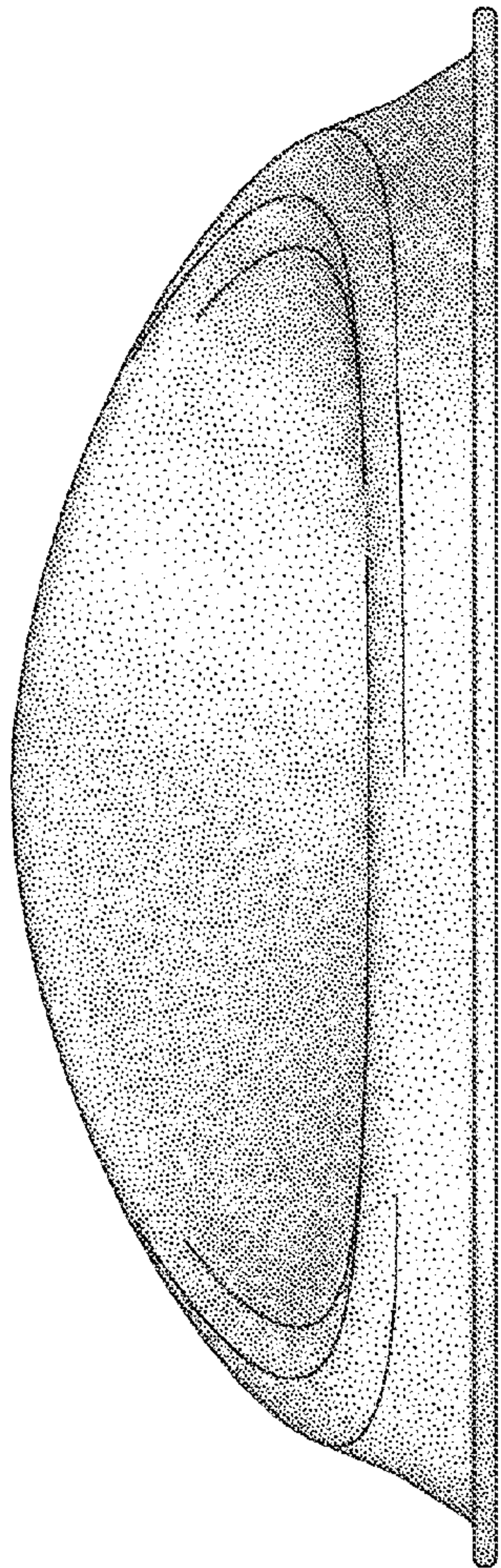

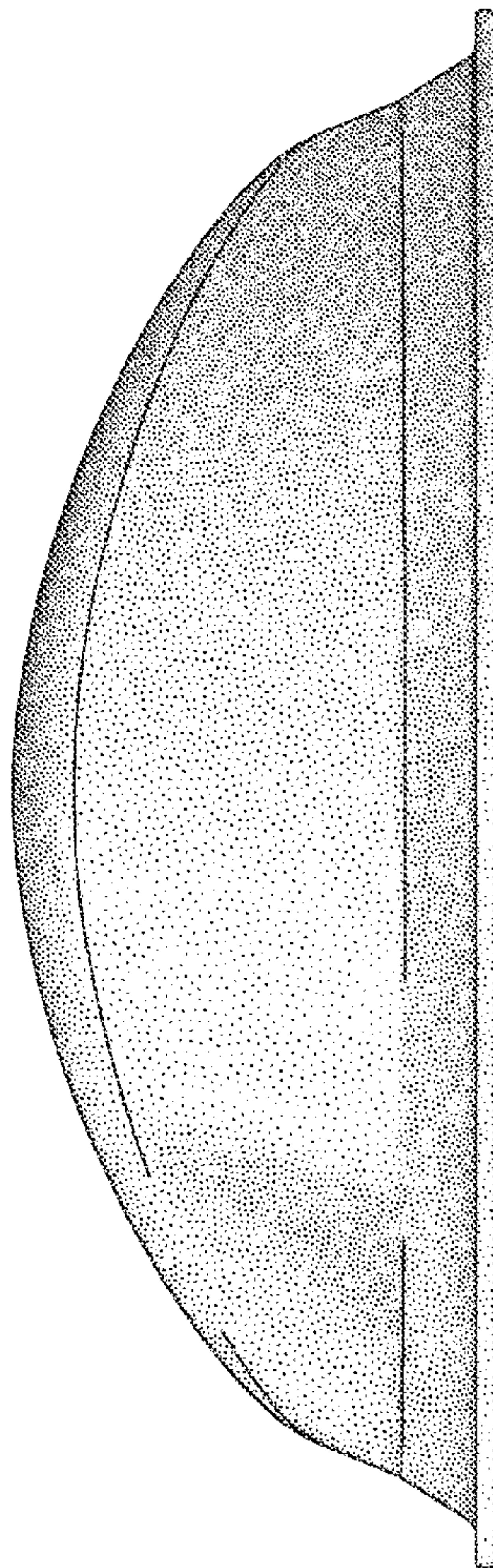
