(57) **CLAIM**

The ornamental design for a scrub top, as shown and described.

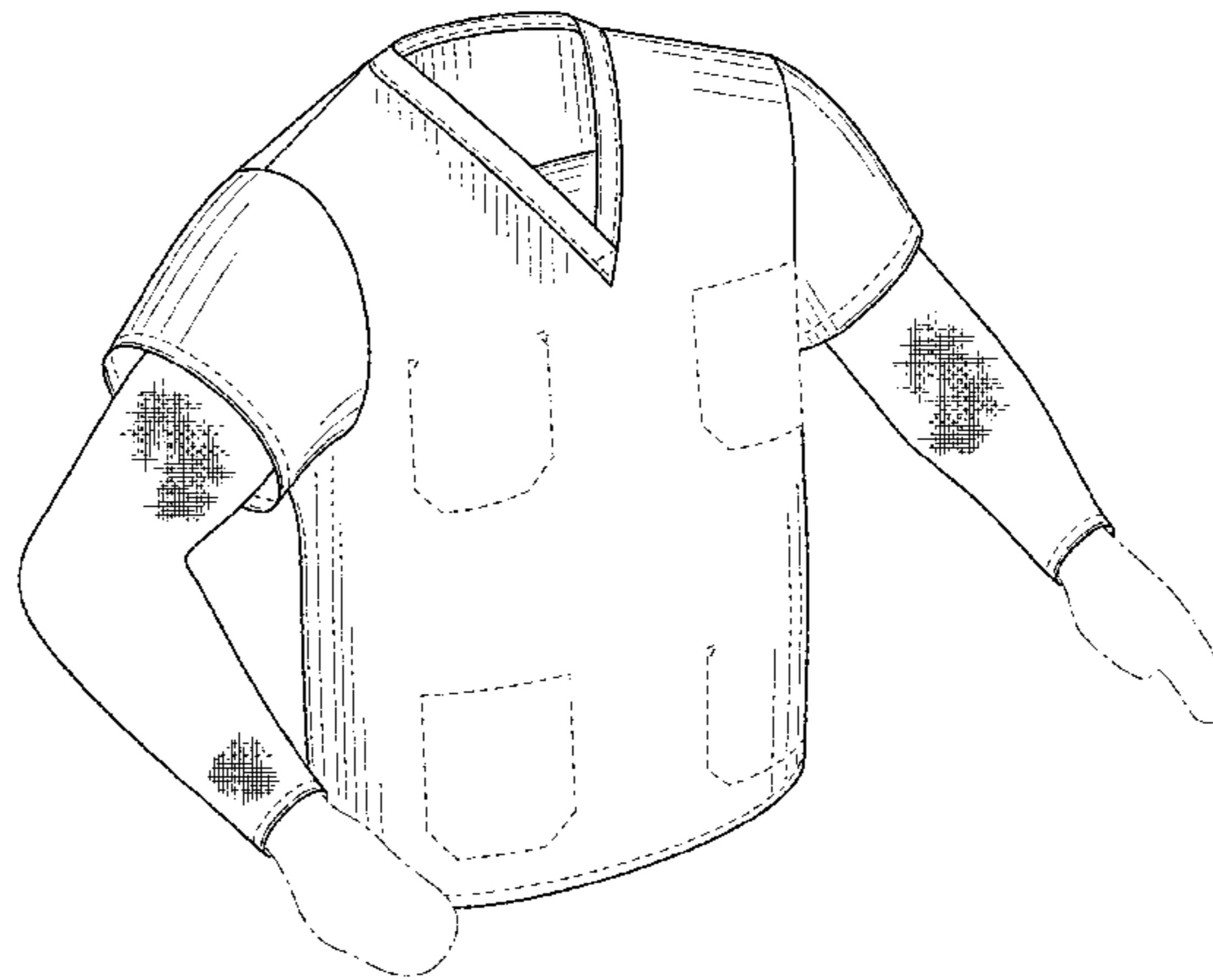
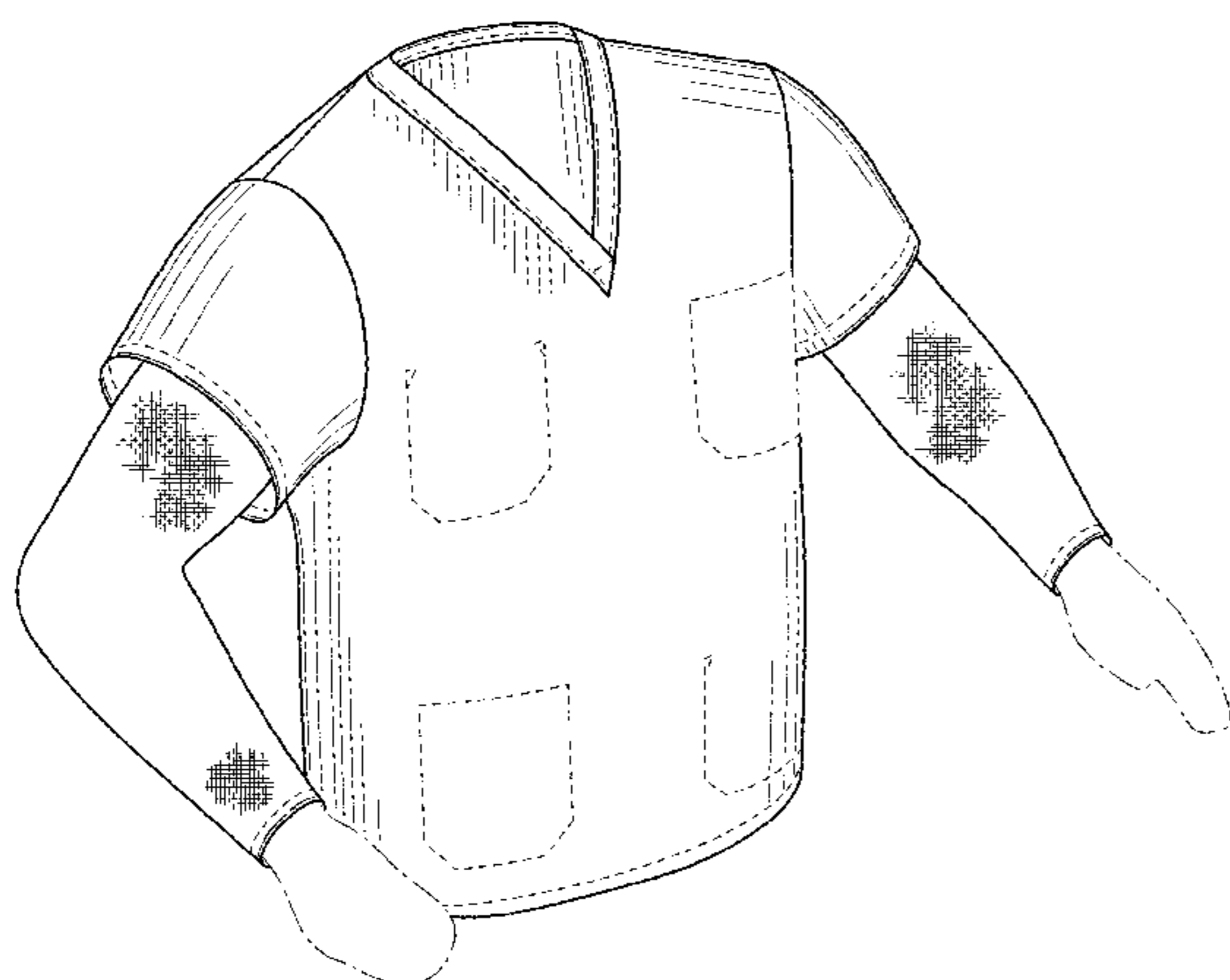


FIG. **20** is a second front perspective view thereof, with the right outermost short sleeve in a pulled back position;

FIG. **21** is a rear perspective view thereof, with the outermost short sleeves in a pulled down position;

FIG. **22** is a rear perspective view thereof, with the right outermost short sleeve in a pulled up position;

FIG. **23** is a front elevation view thereof, with the outermost short sleeves in a pulled down position; and,

FIG. **24** is a rear elevation view thereof.

The human hand and wrist shown in dot-dash lines illustrate the environment in which the design is used and form no part of the claimed design.

The stitching on the scrub-top is shown in broken lines and forms no part of the claimed design.

The cross-hatched pattern on the long sleeve portions of the scrub, although shown intermittently, is meant to represent an elastic fabric, and is understood to be distributed uniformly over the long sleeve portions of the scrub.

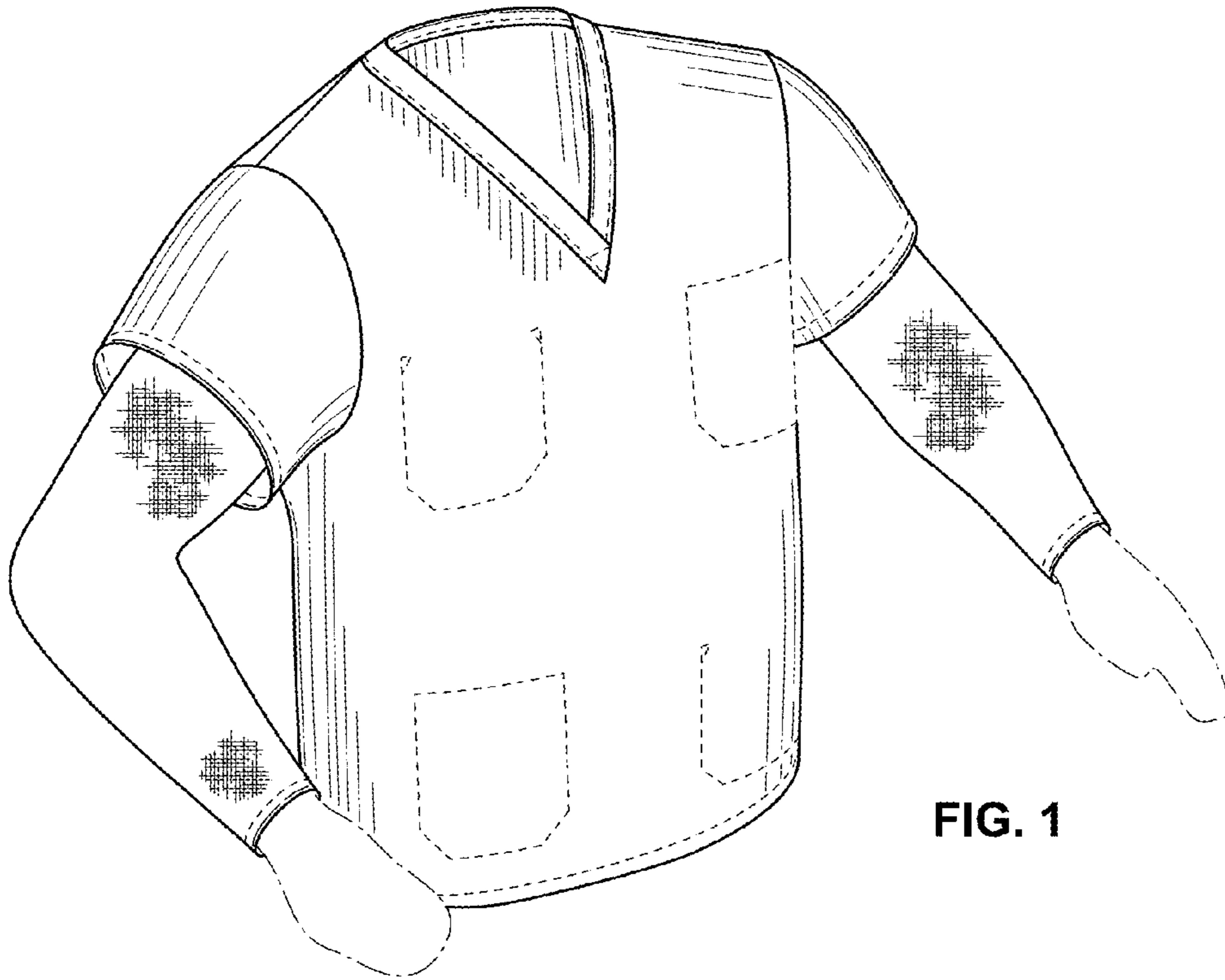

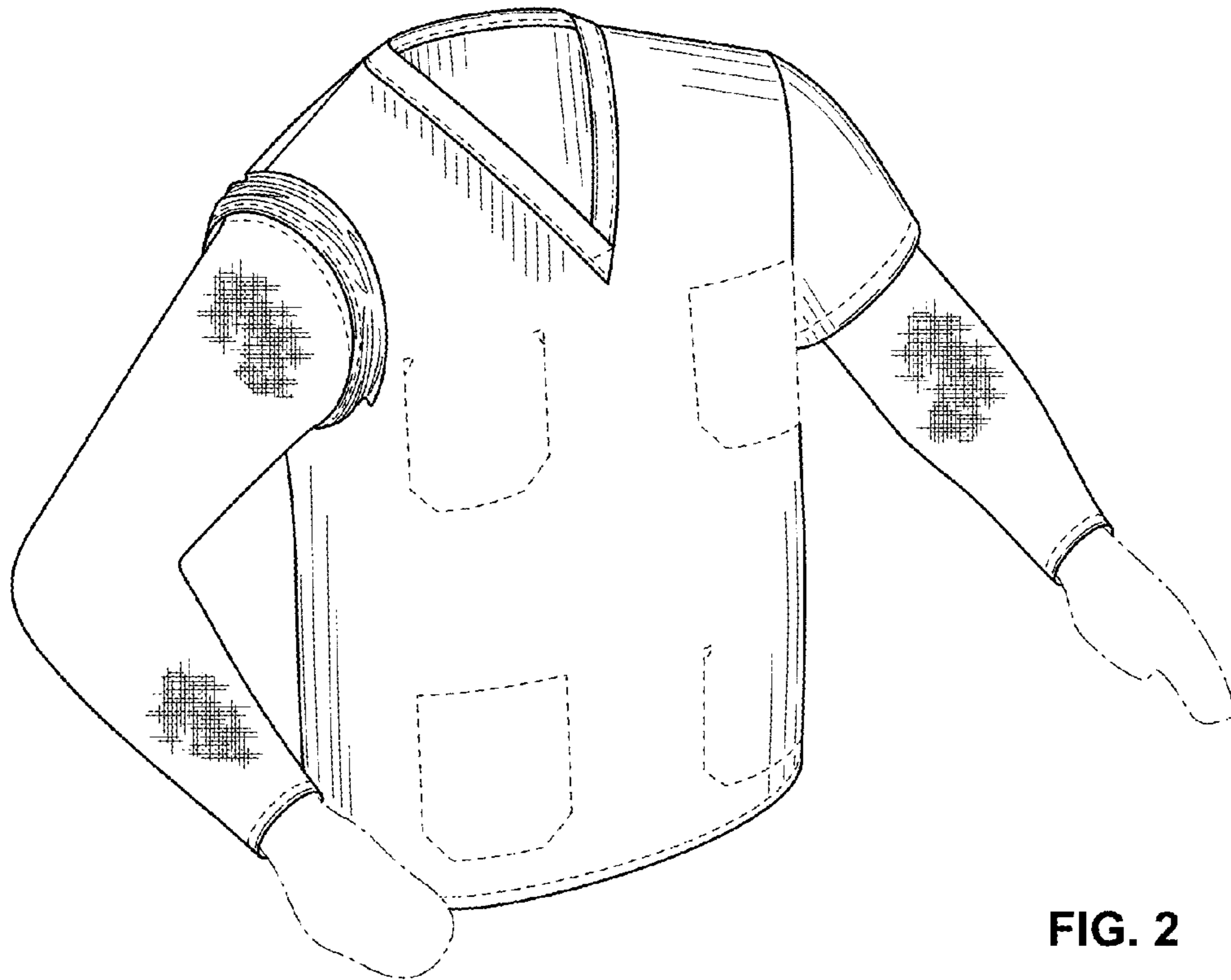

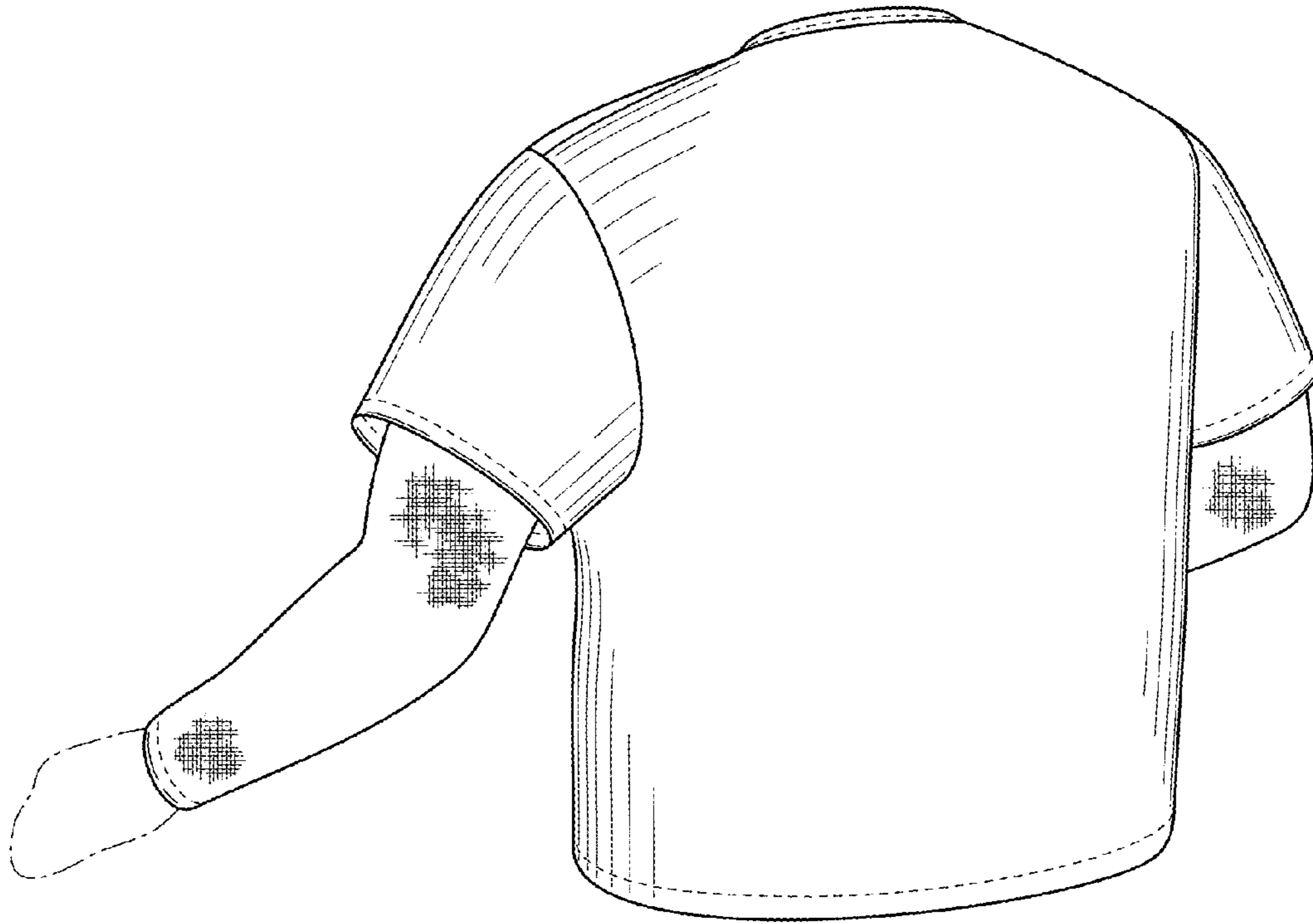

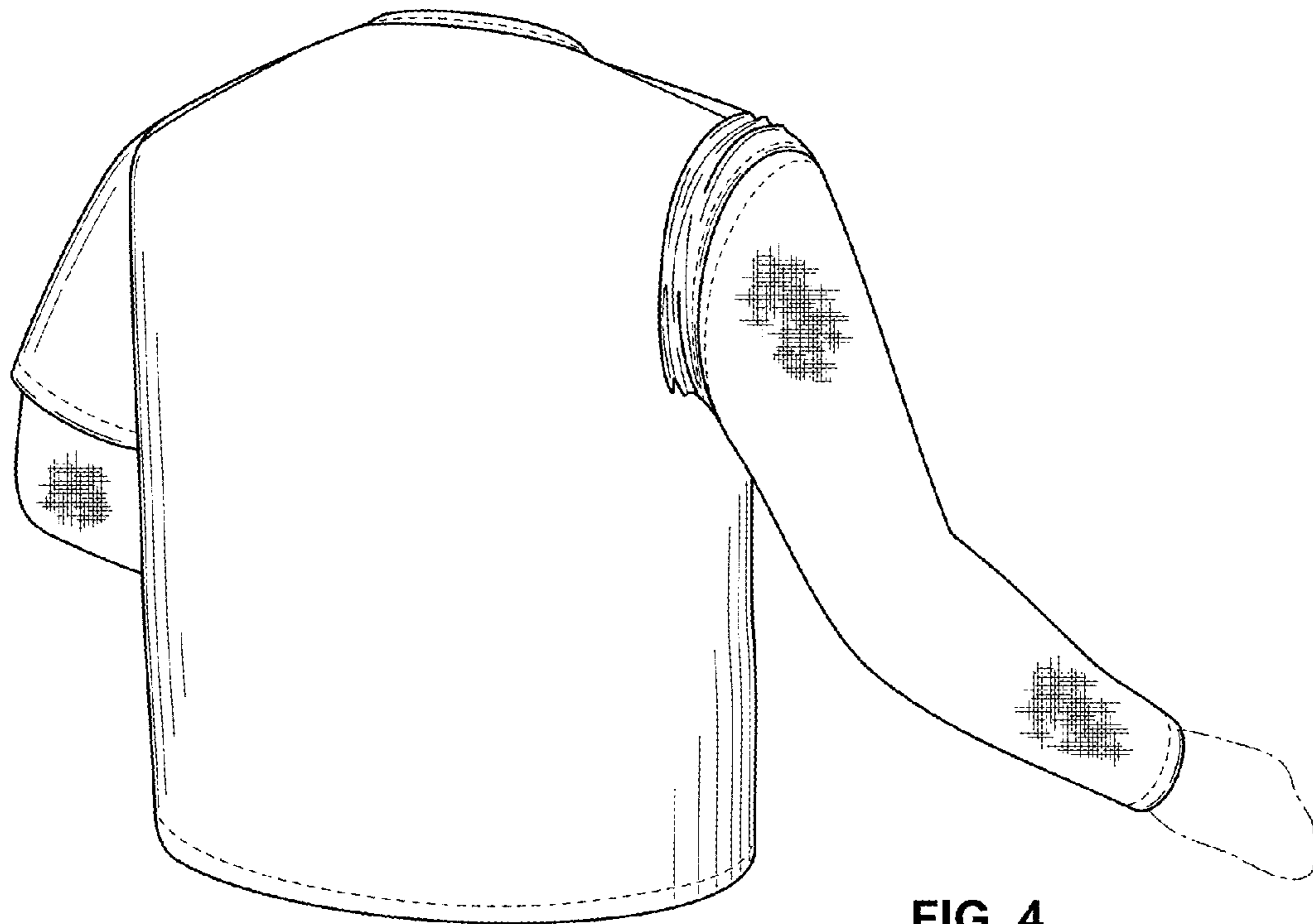

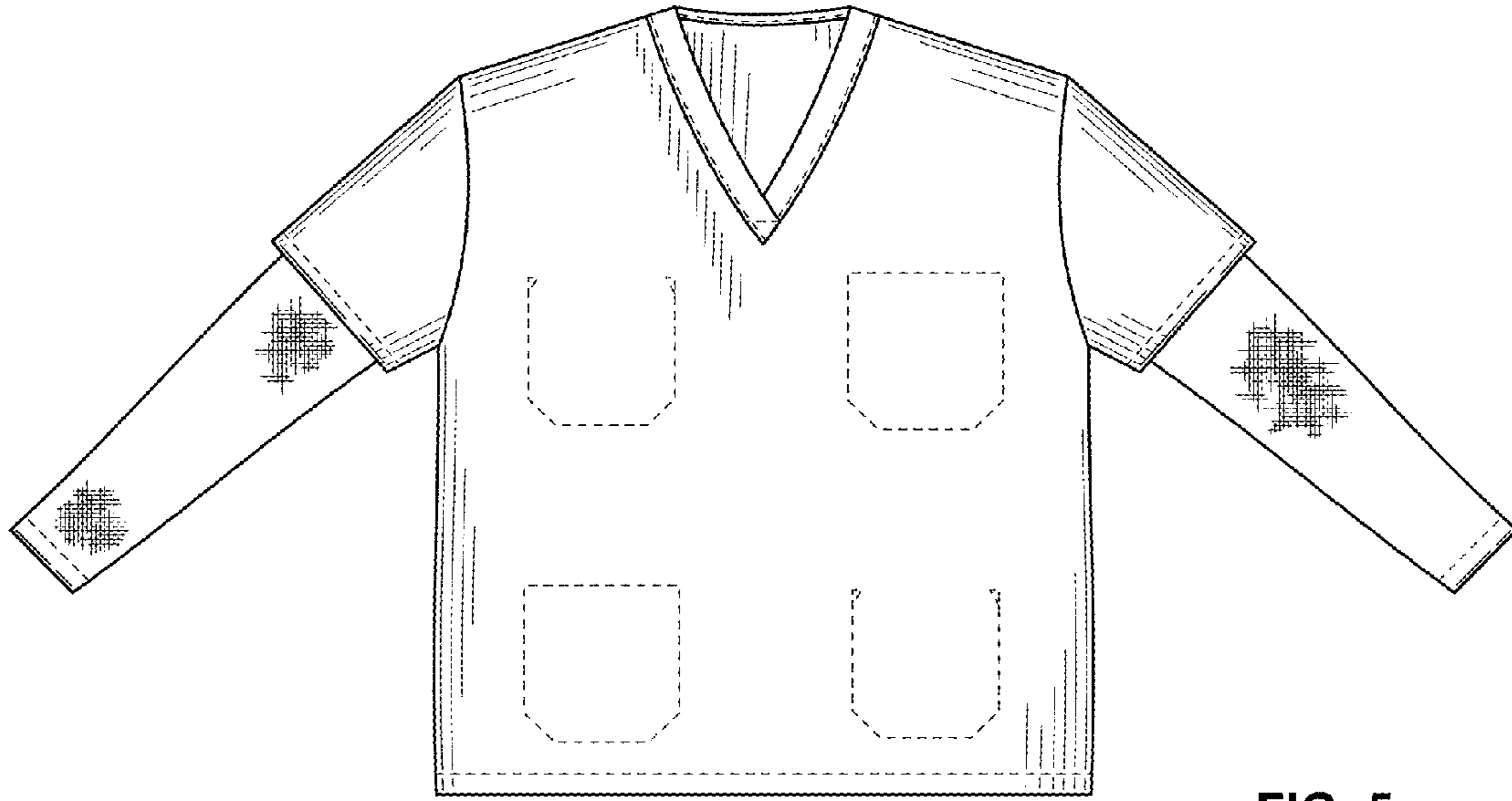

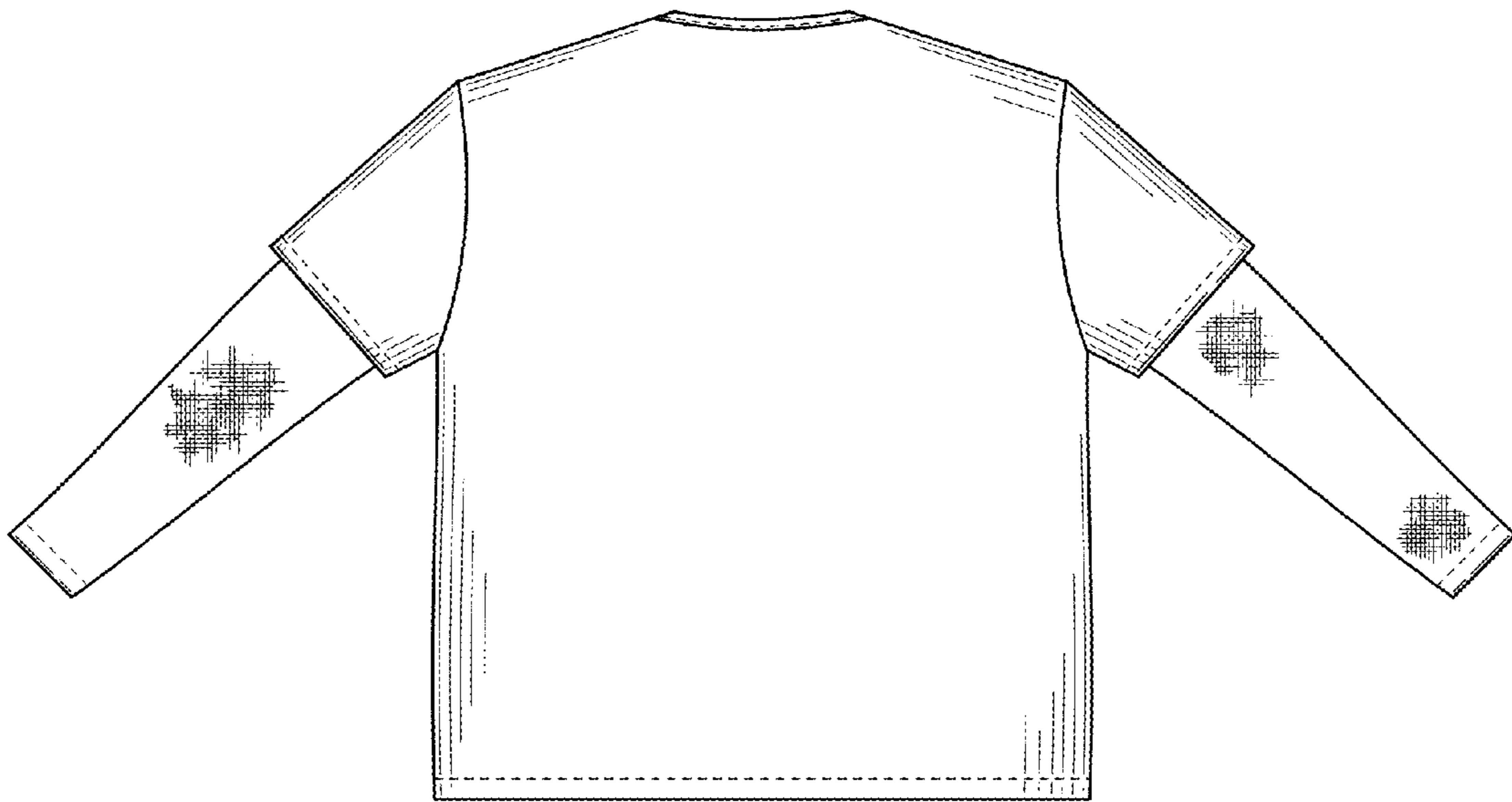

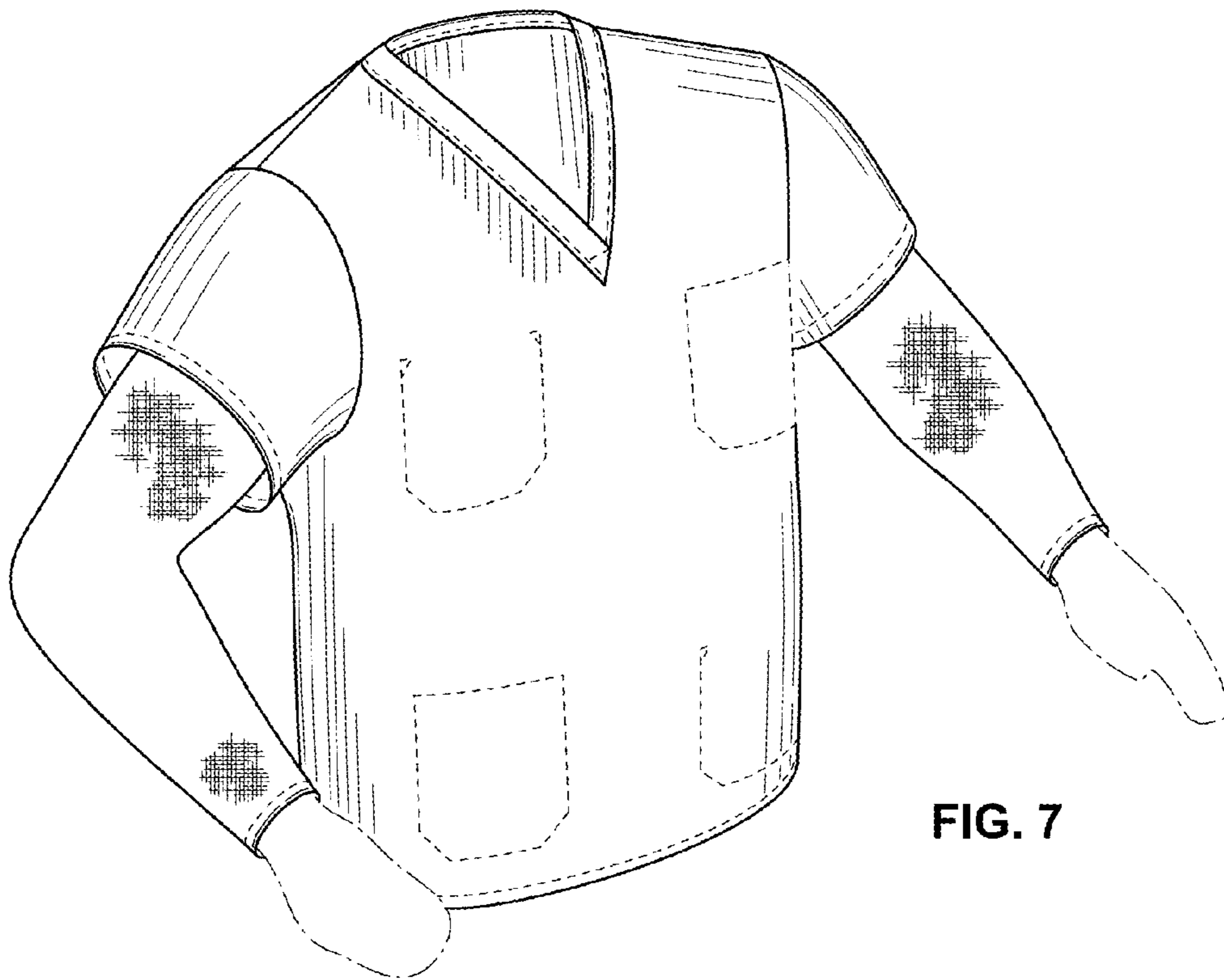

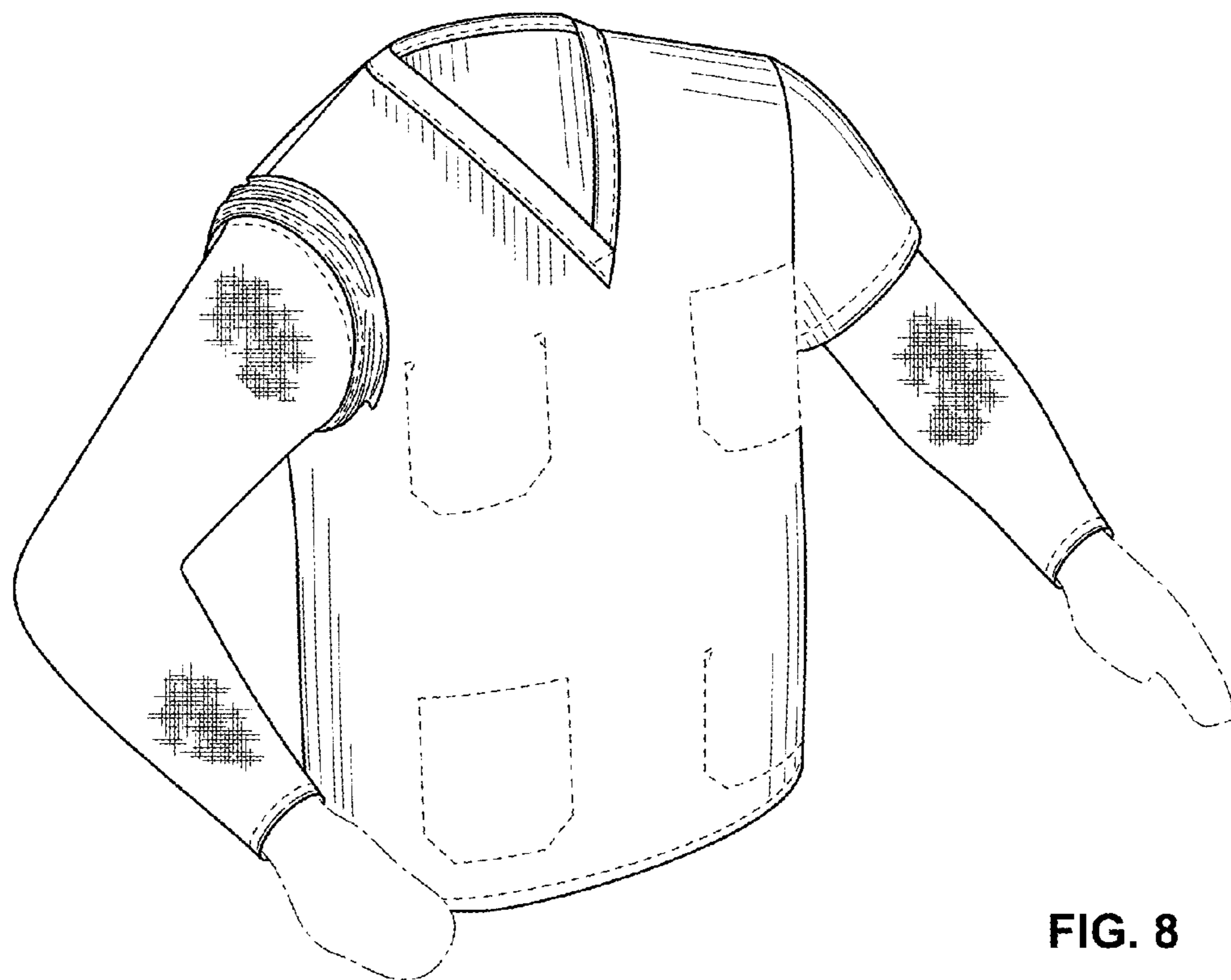

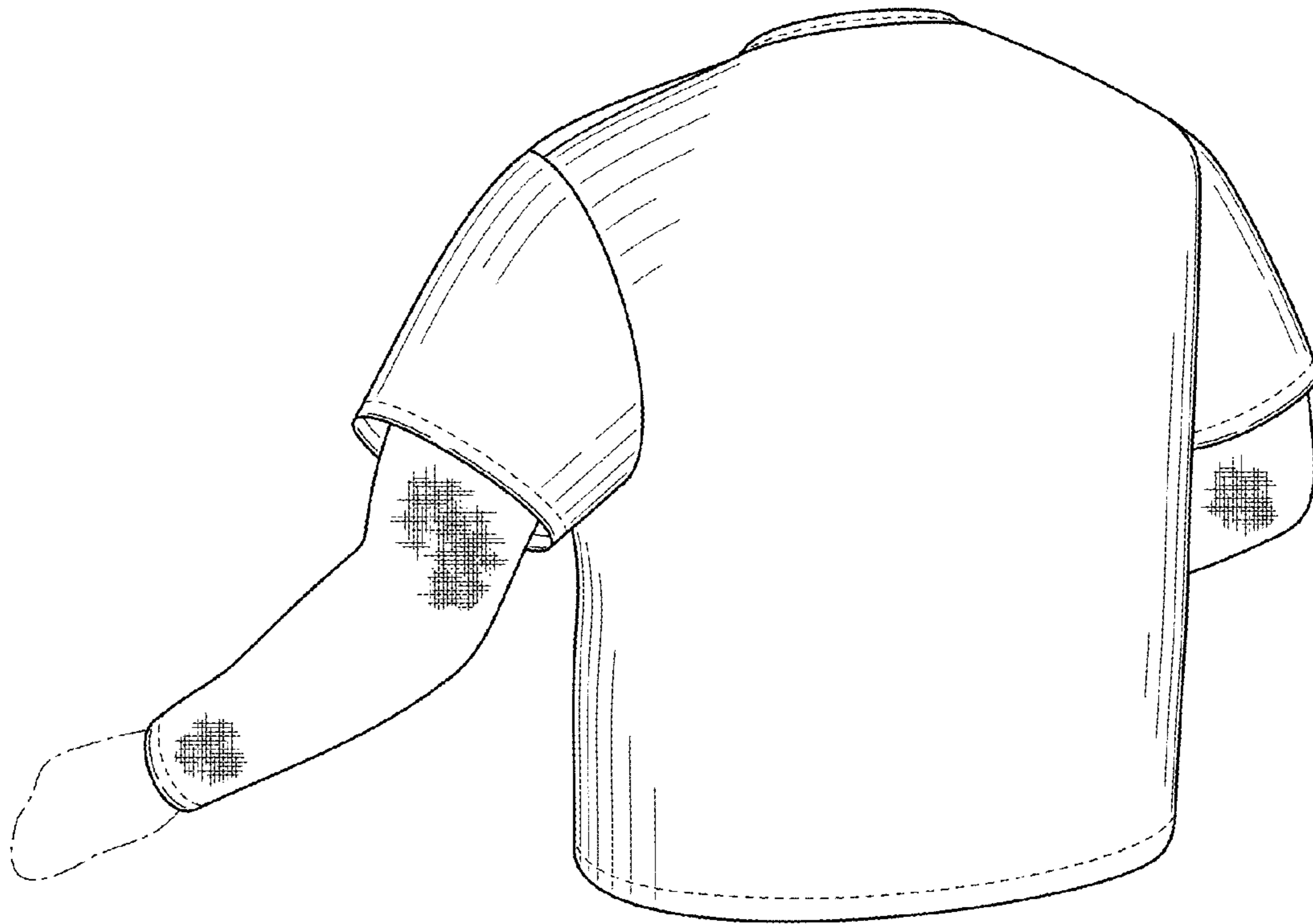

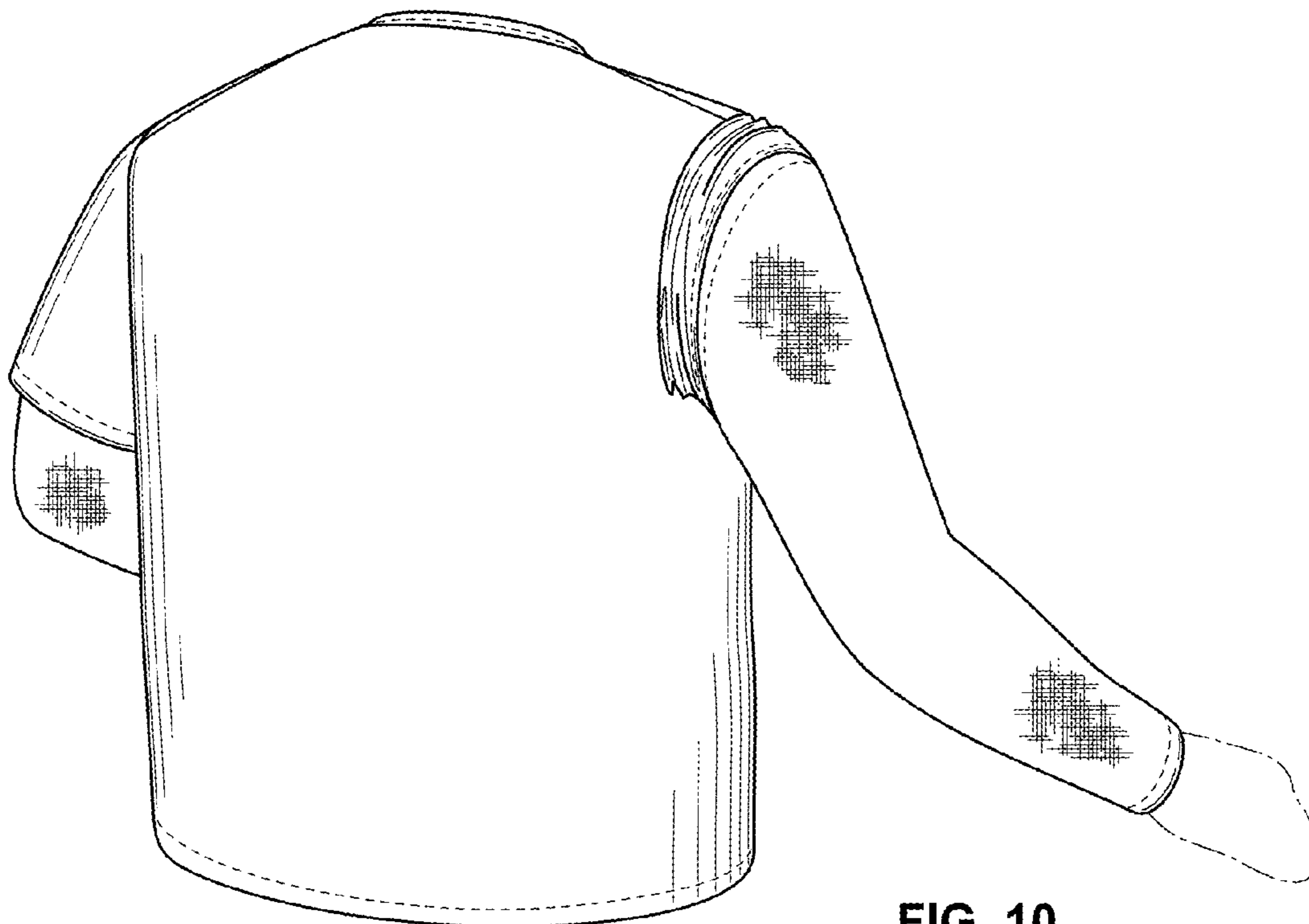

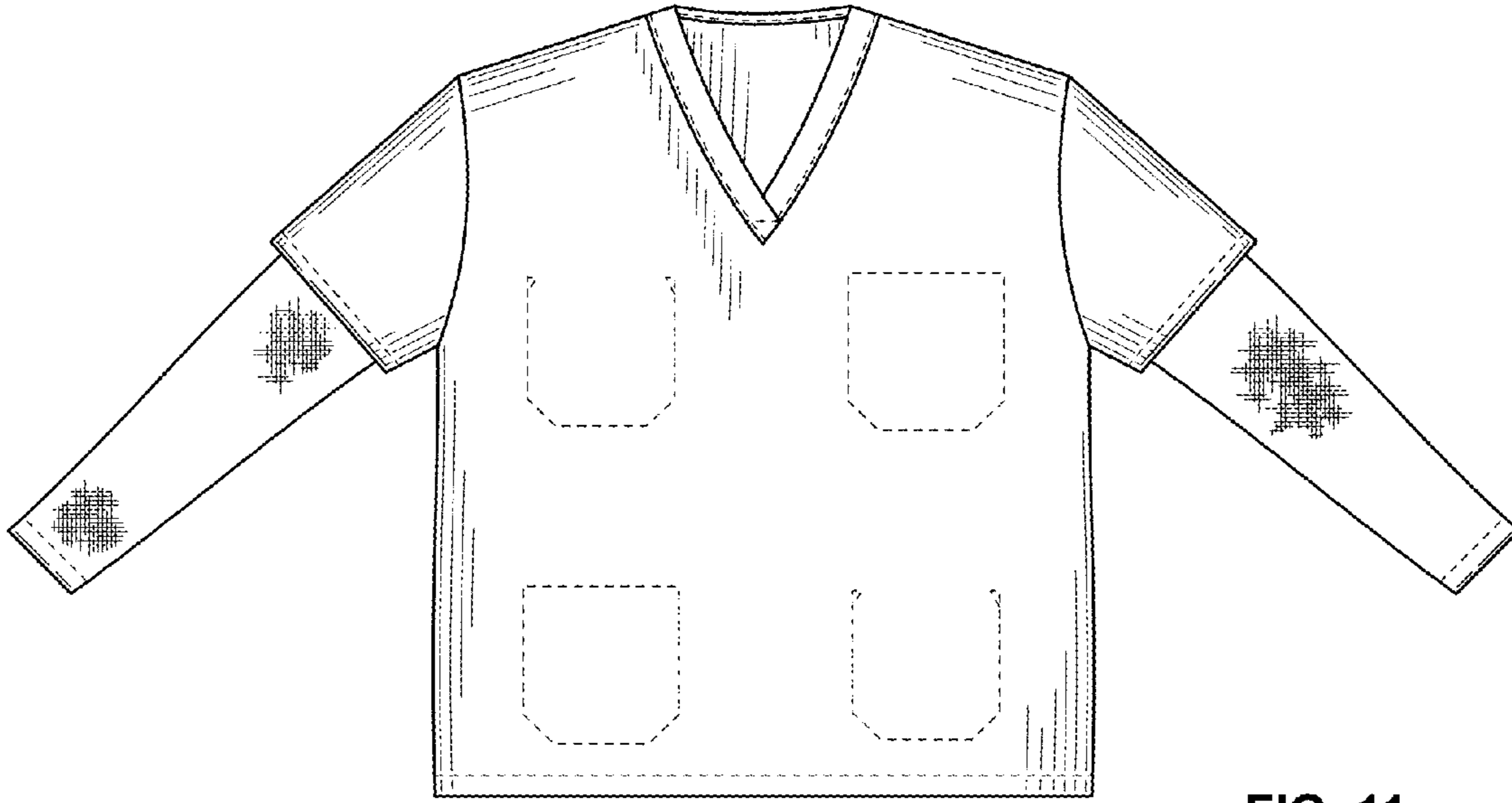

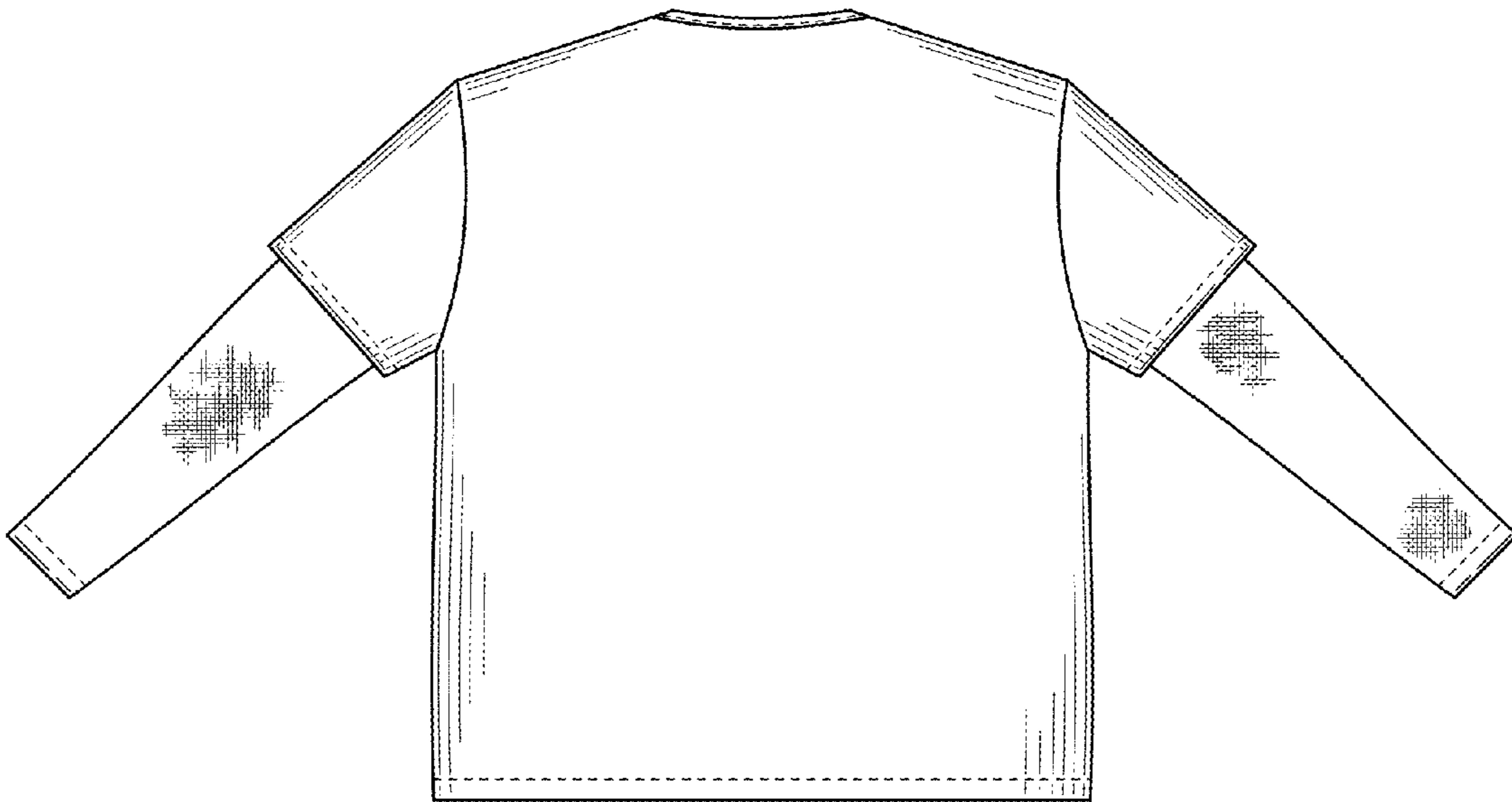

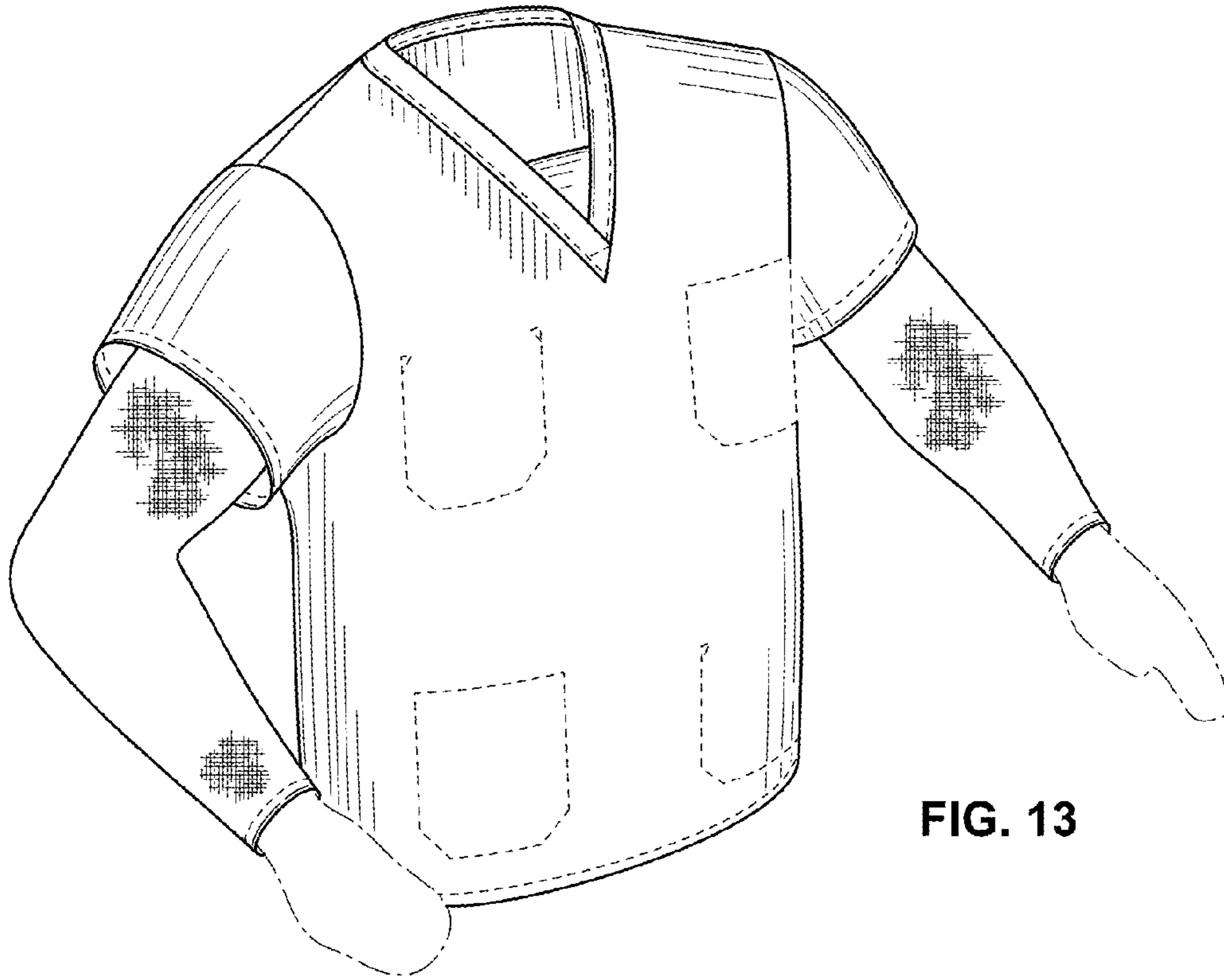

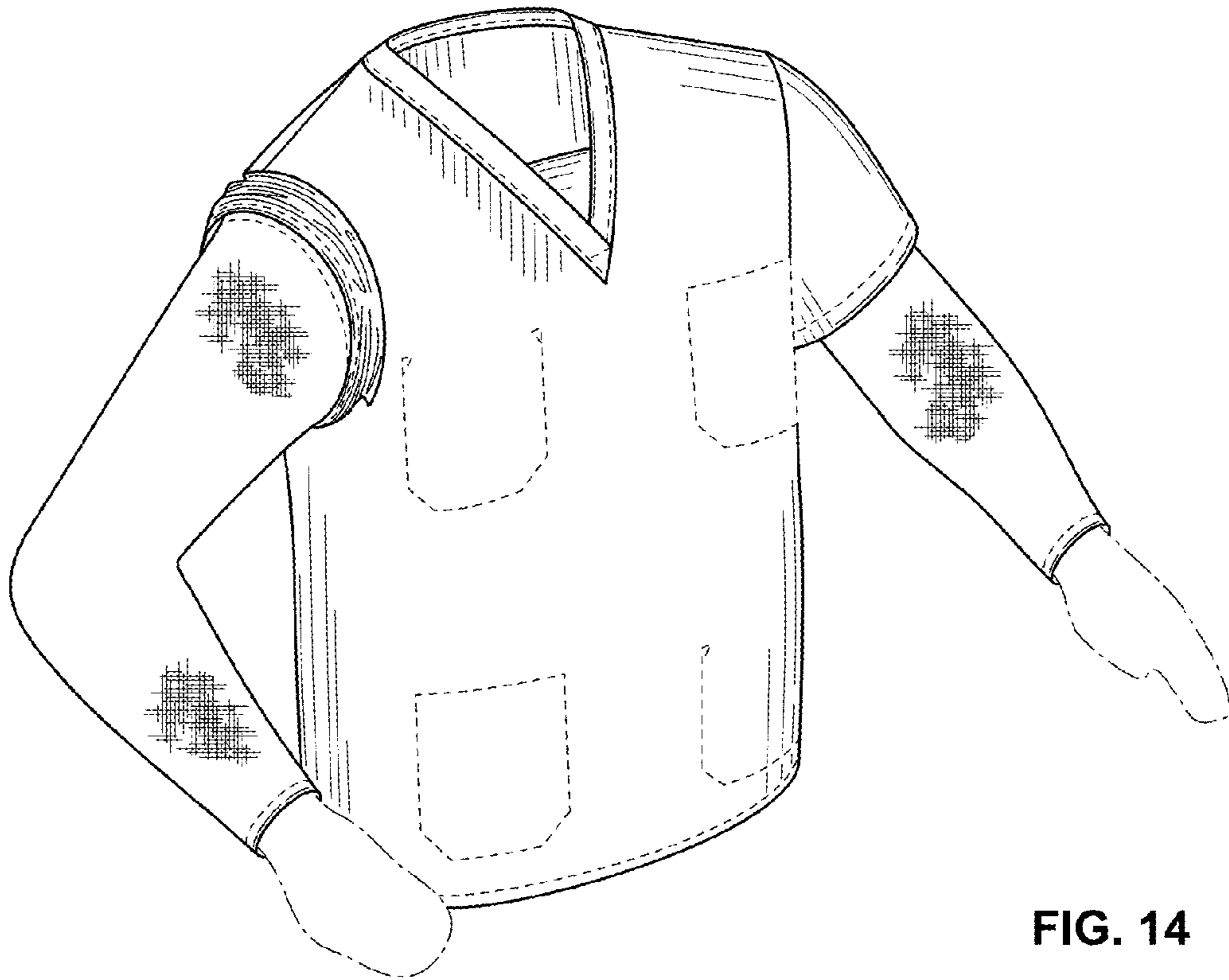

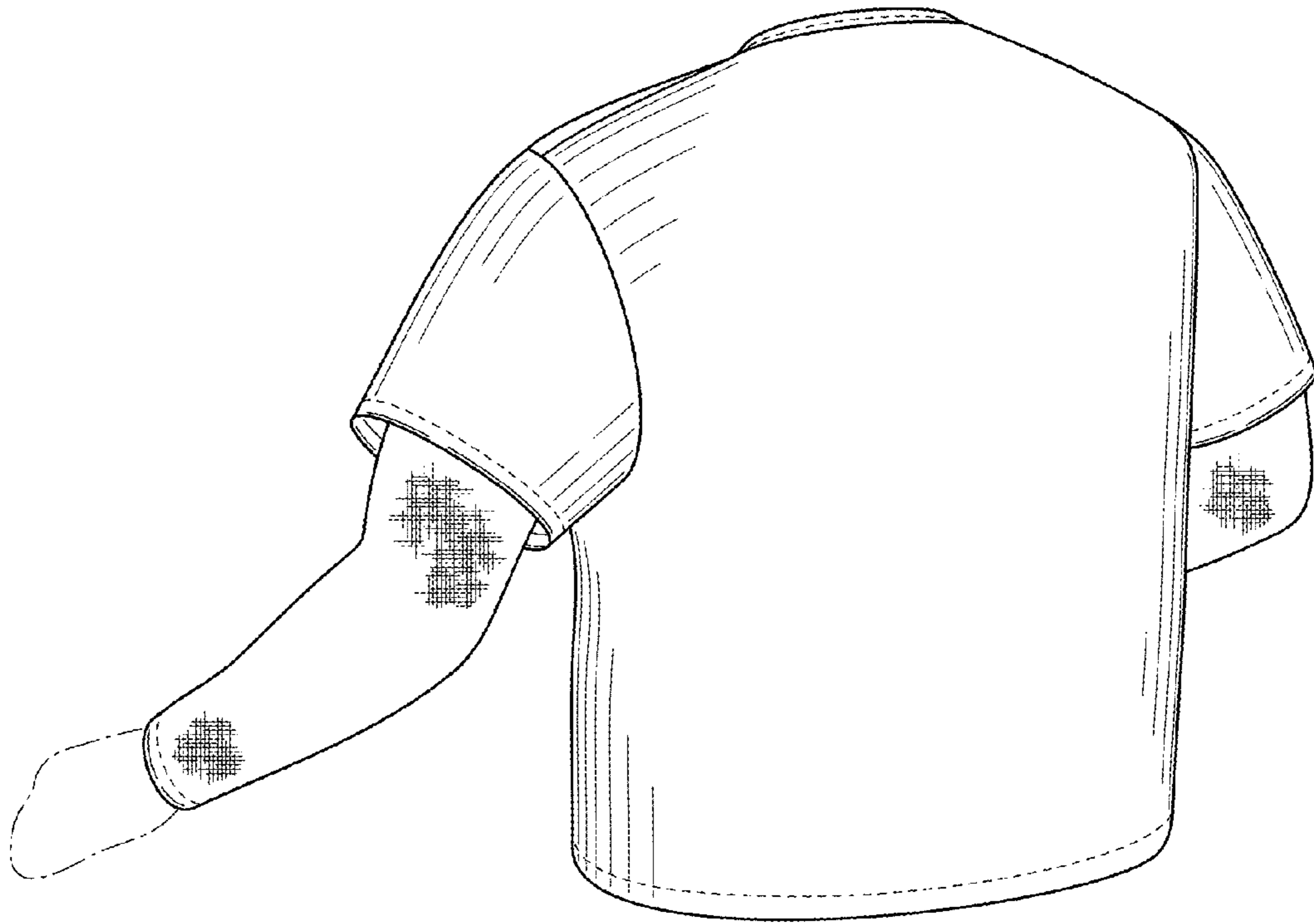

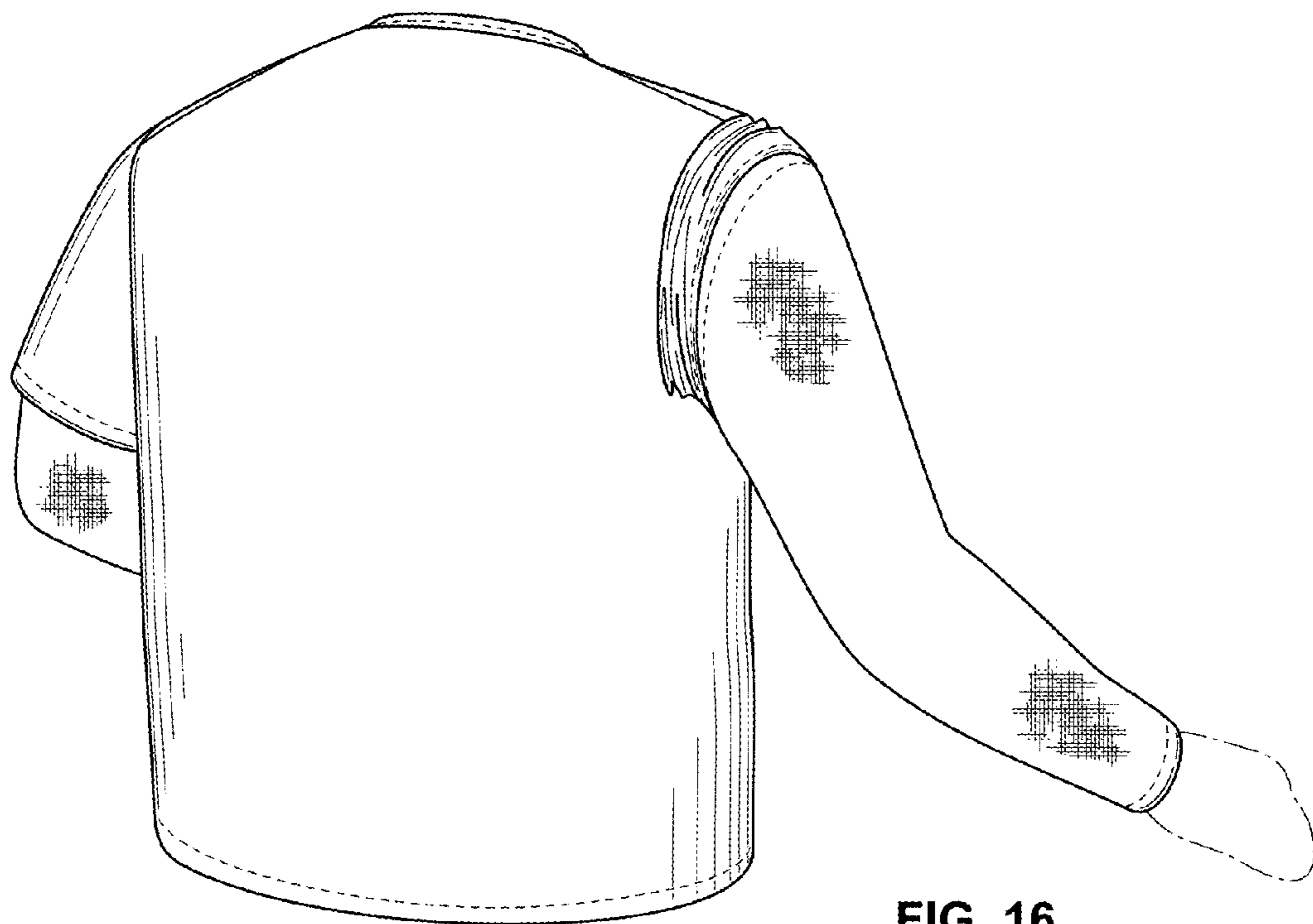

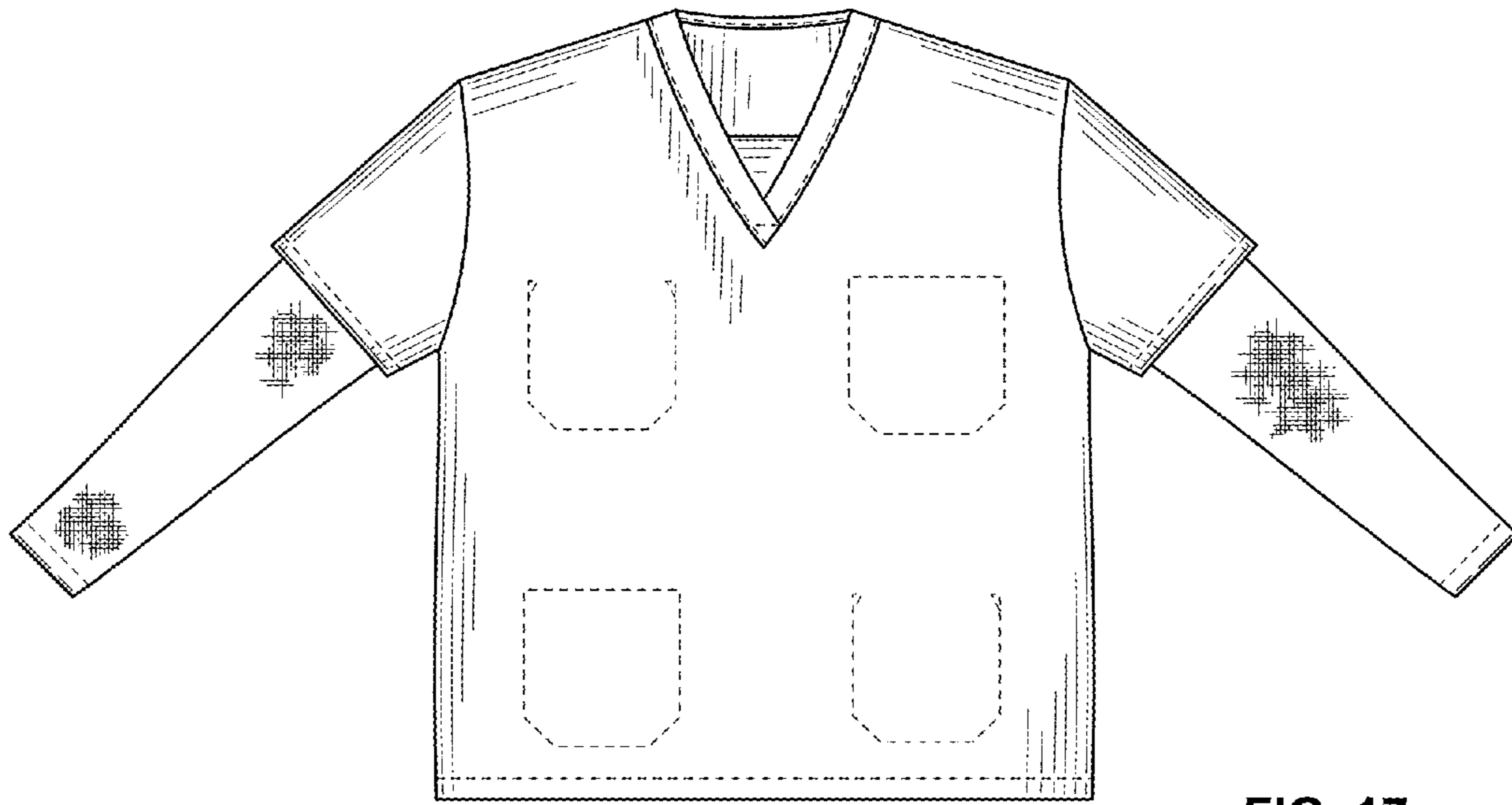

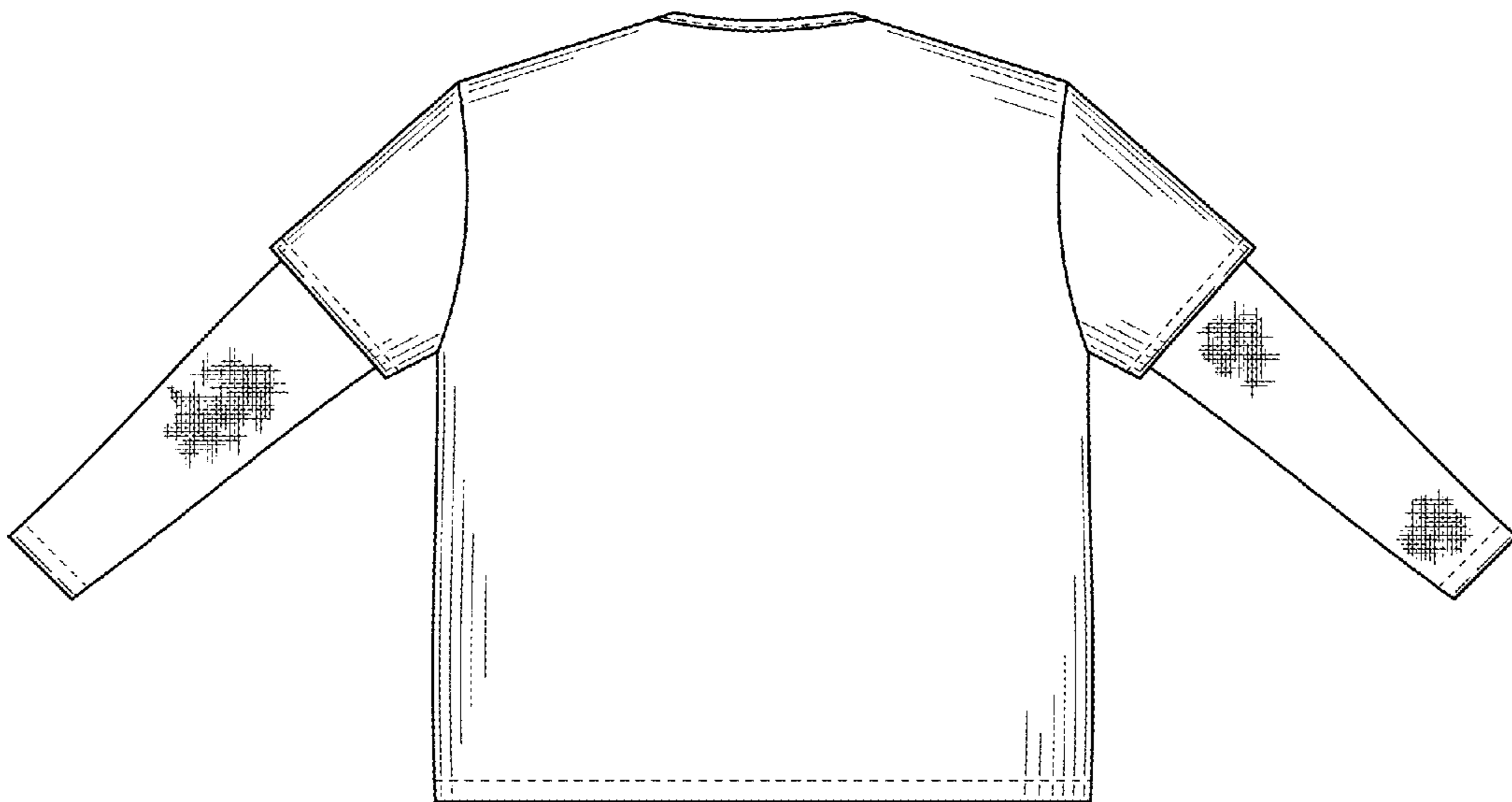

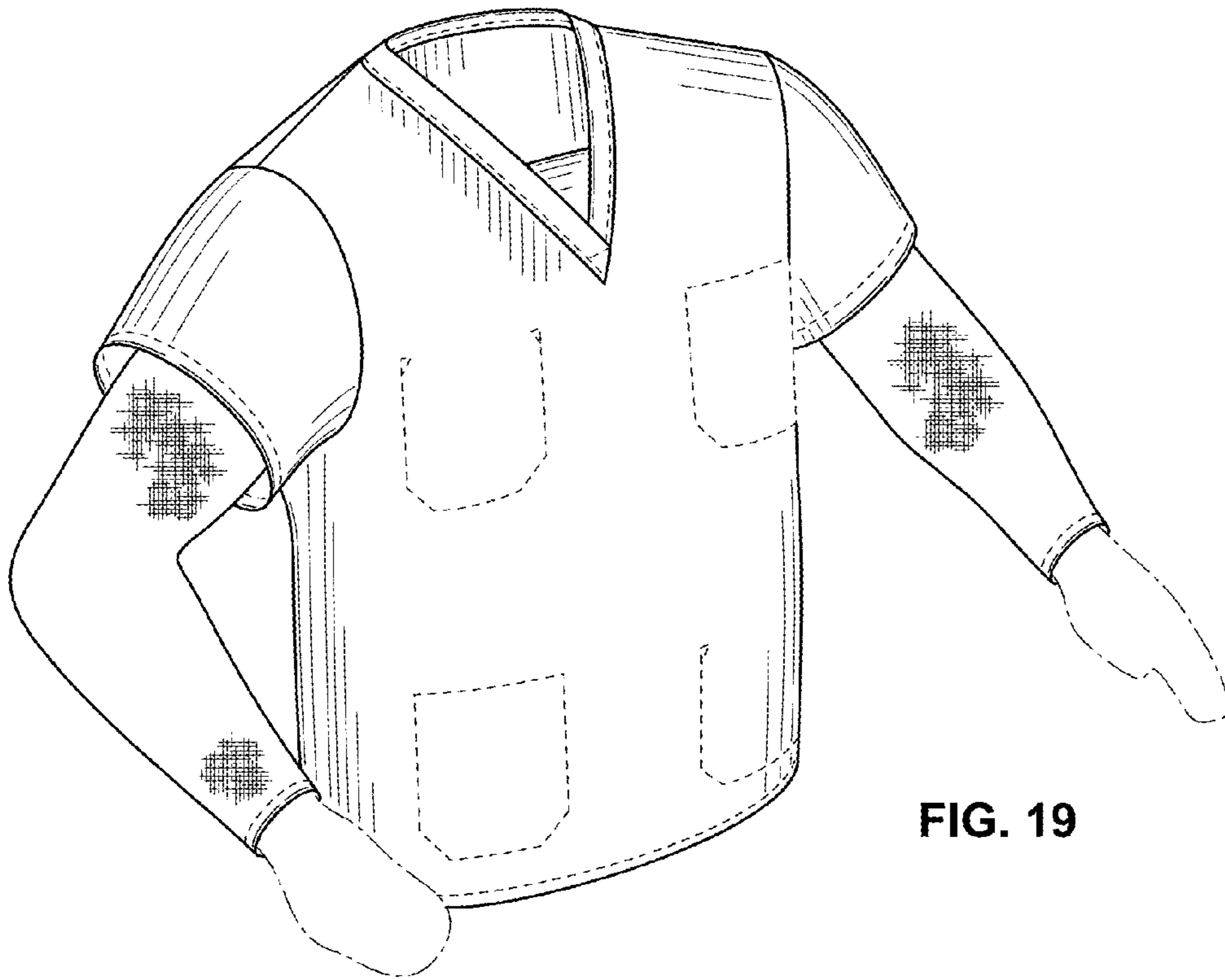

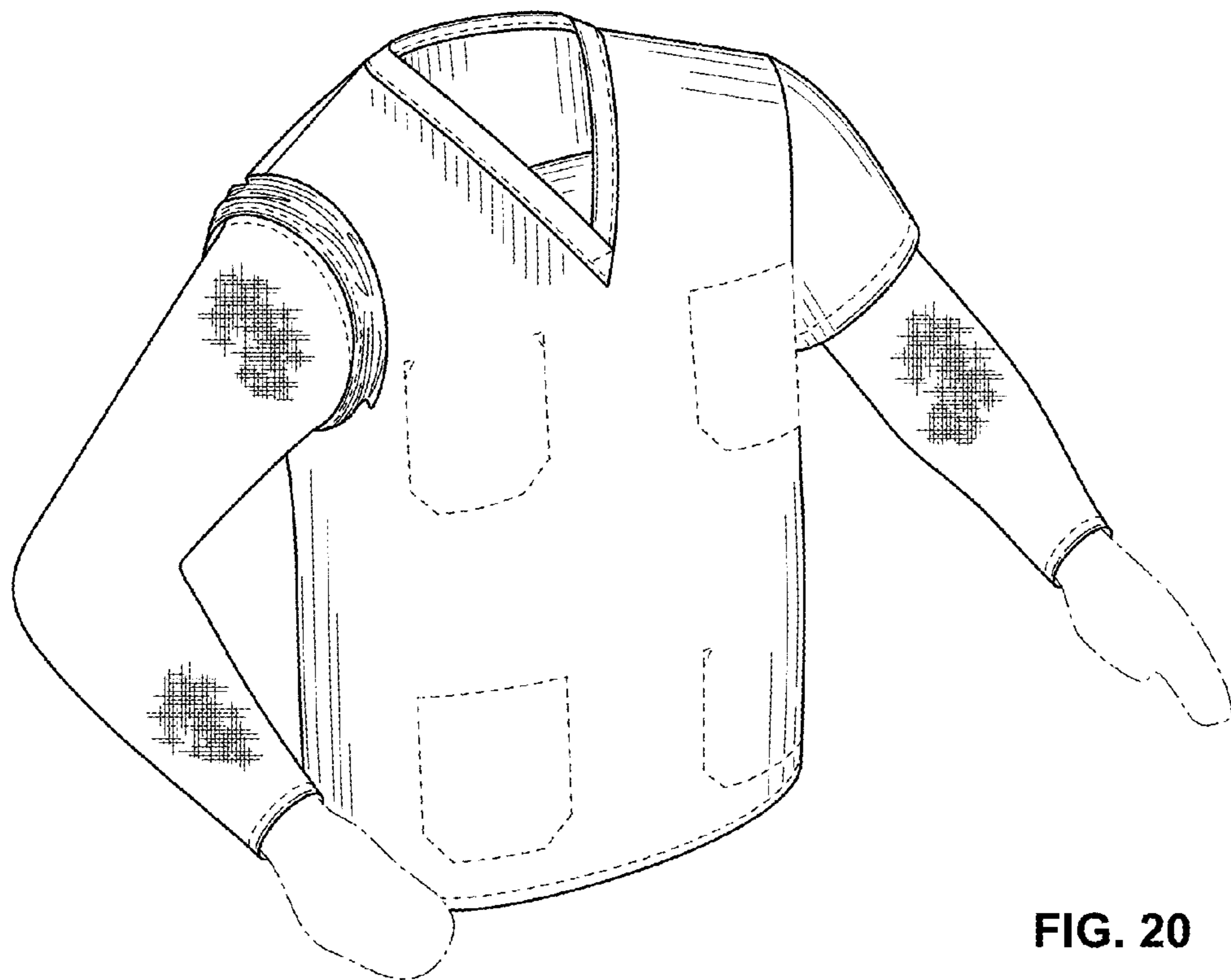

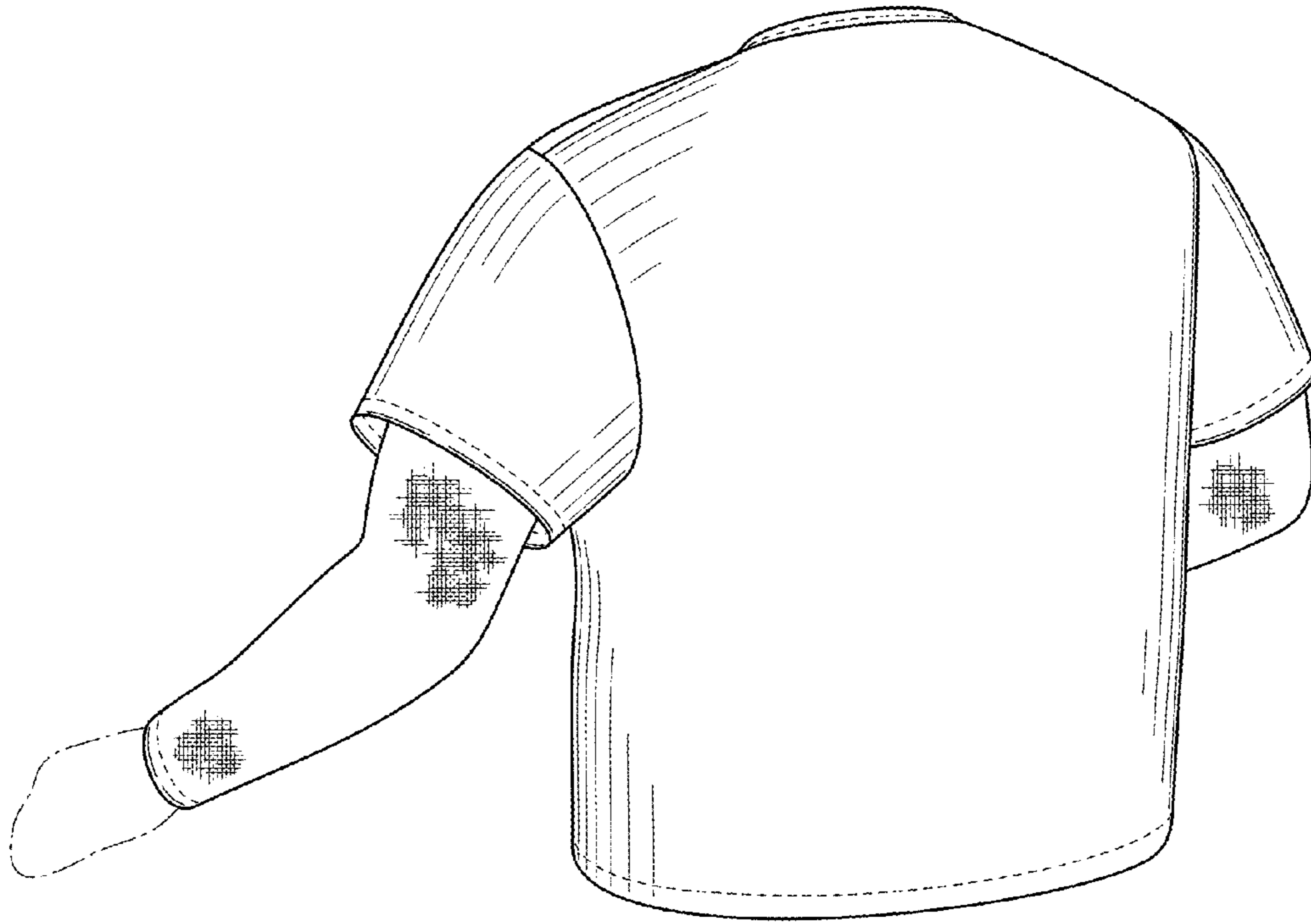

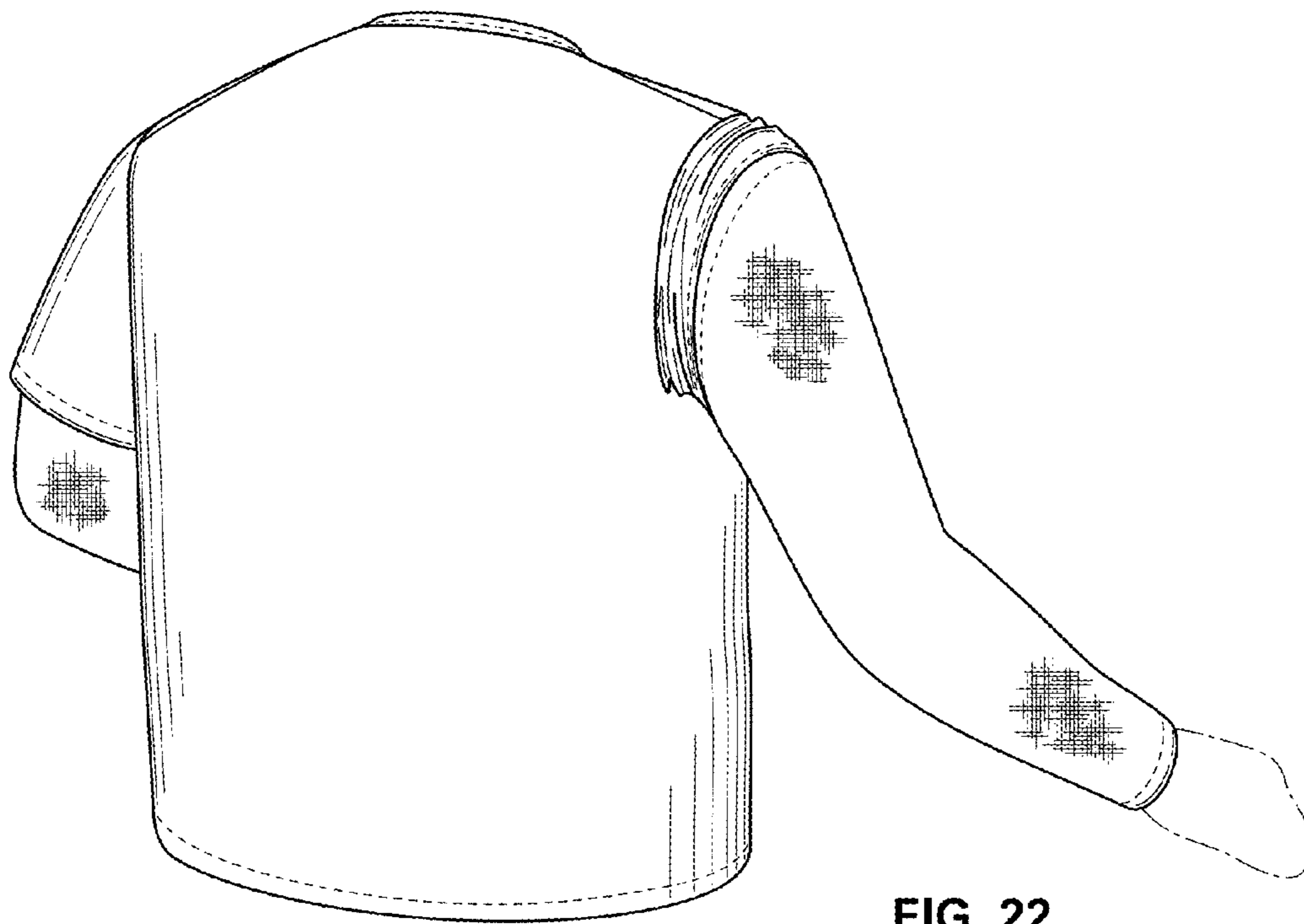

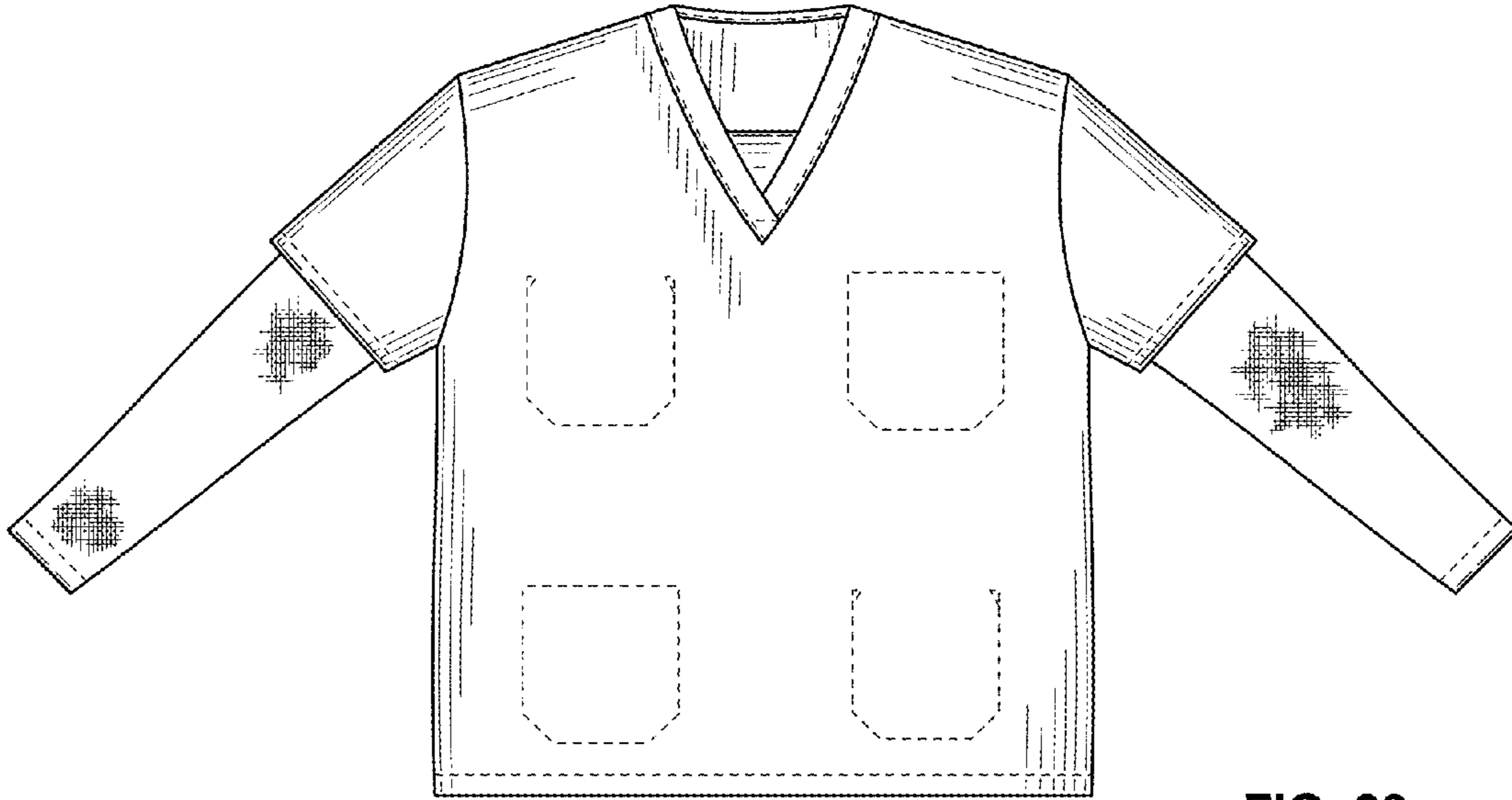

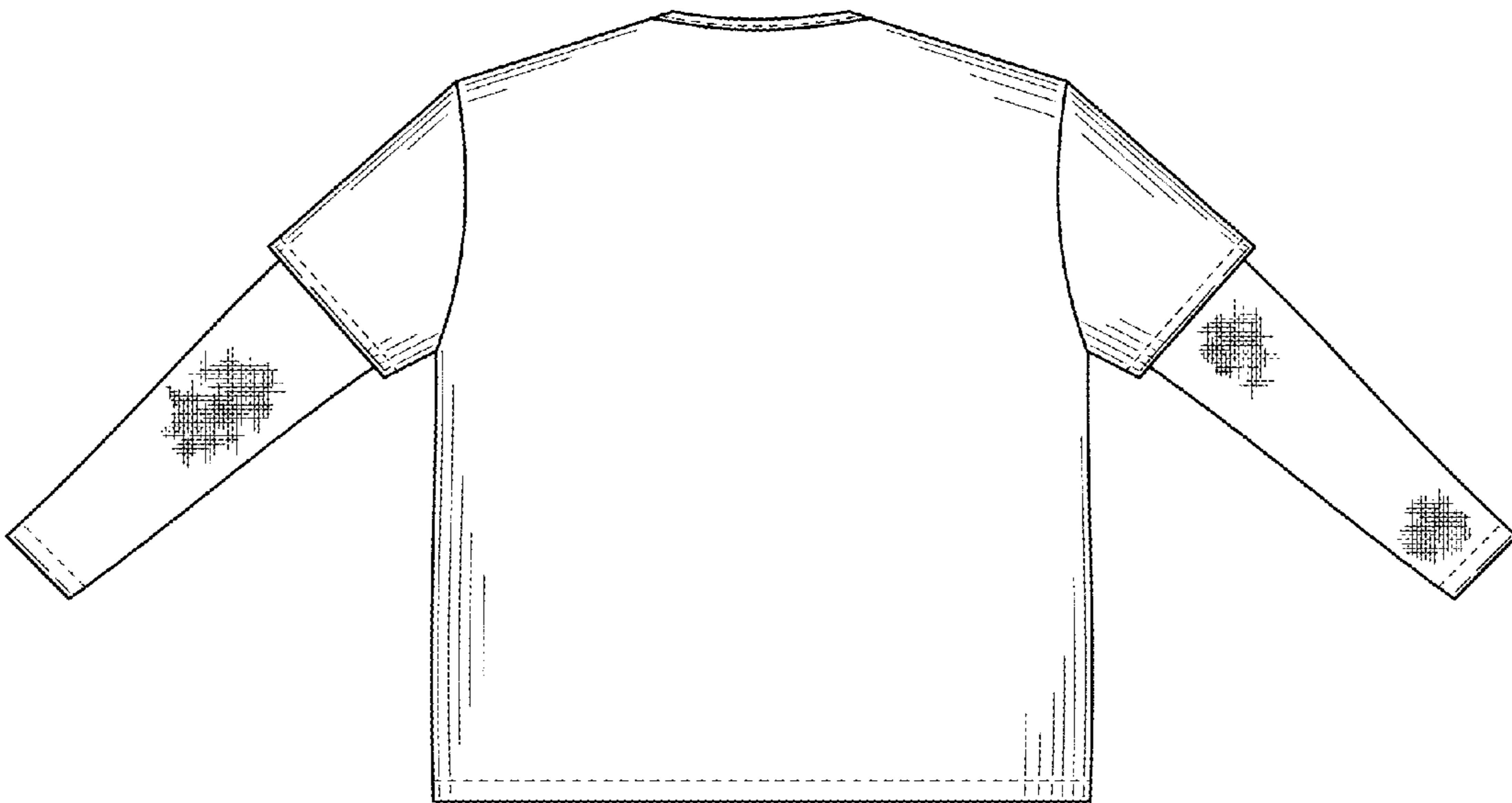
