FIG. 20 is a front view showing the sport tights of FIG. 12 laid flat. FIG. 21 is a rear view showing the sport tights of FIG. 12 laid flat; and, FIG. 22 is a right side view showing the sport tights of FIG. 12 laid flat. 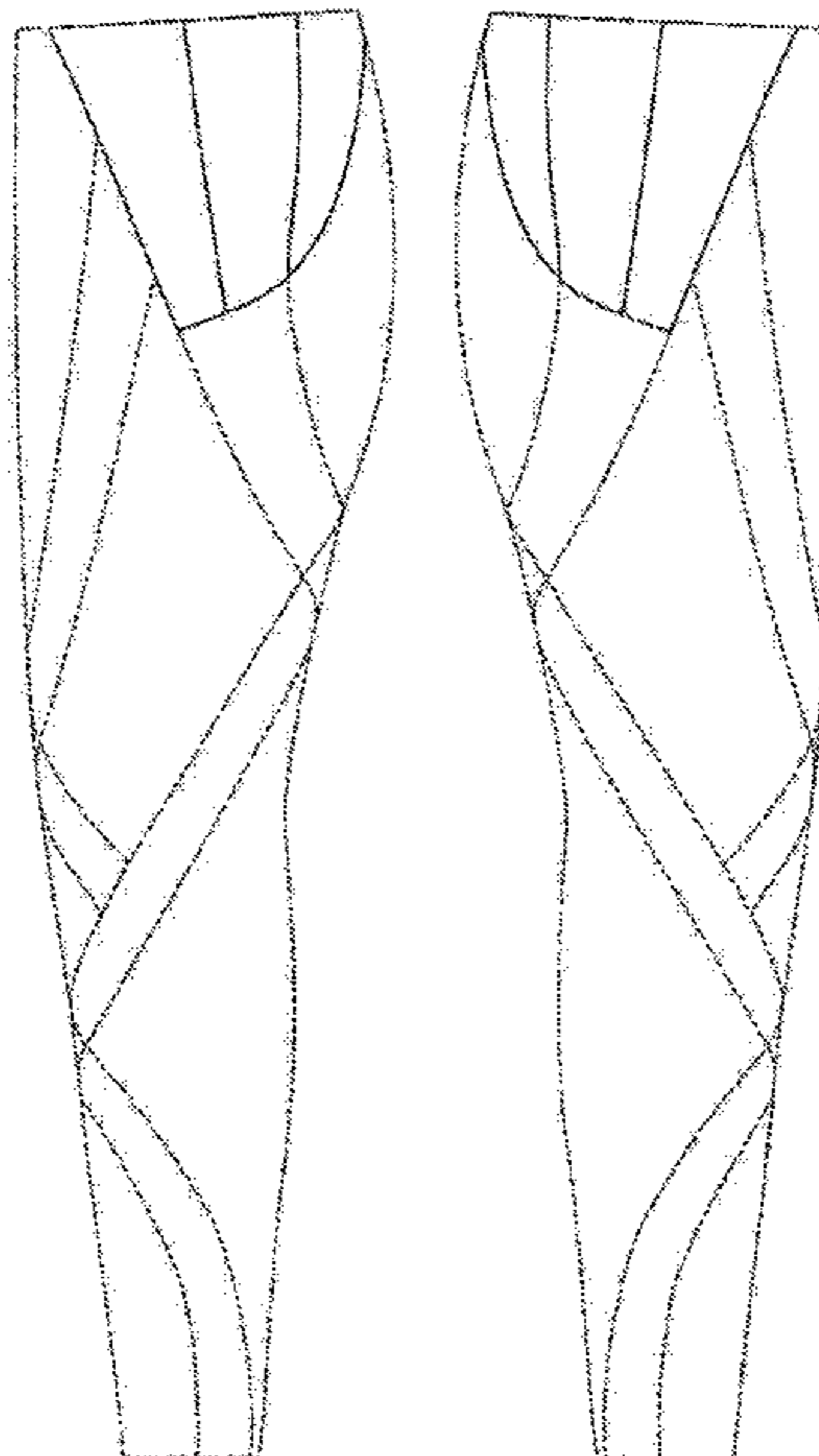

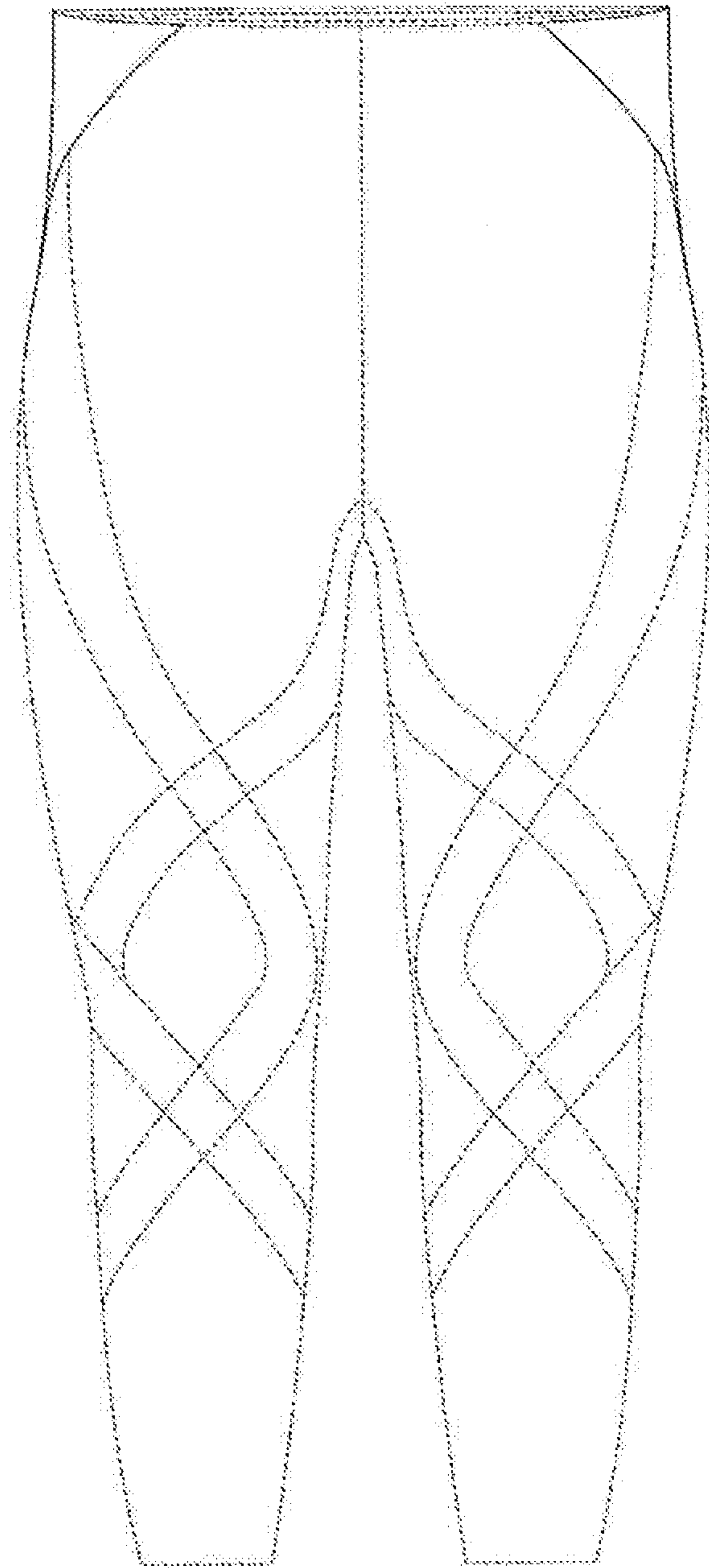

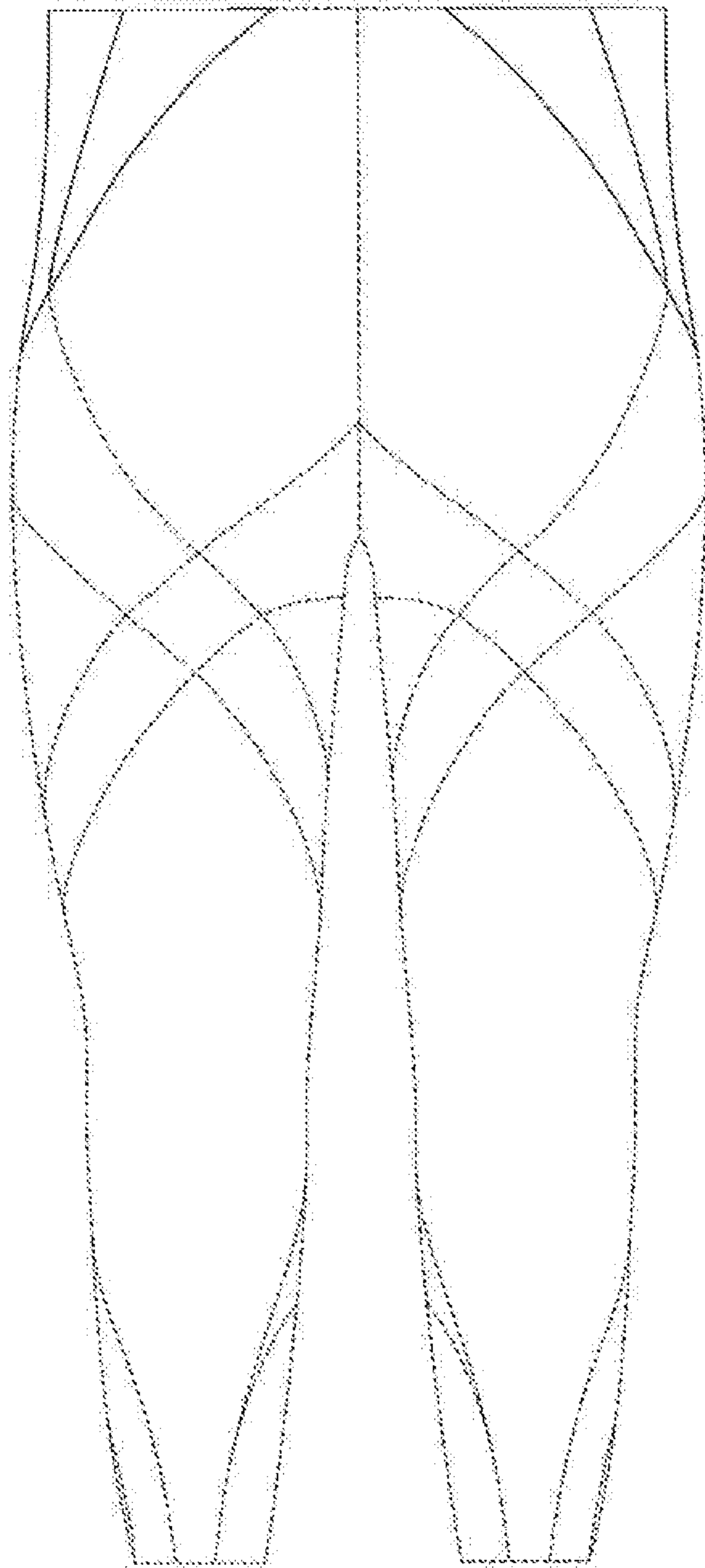

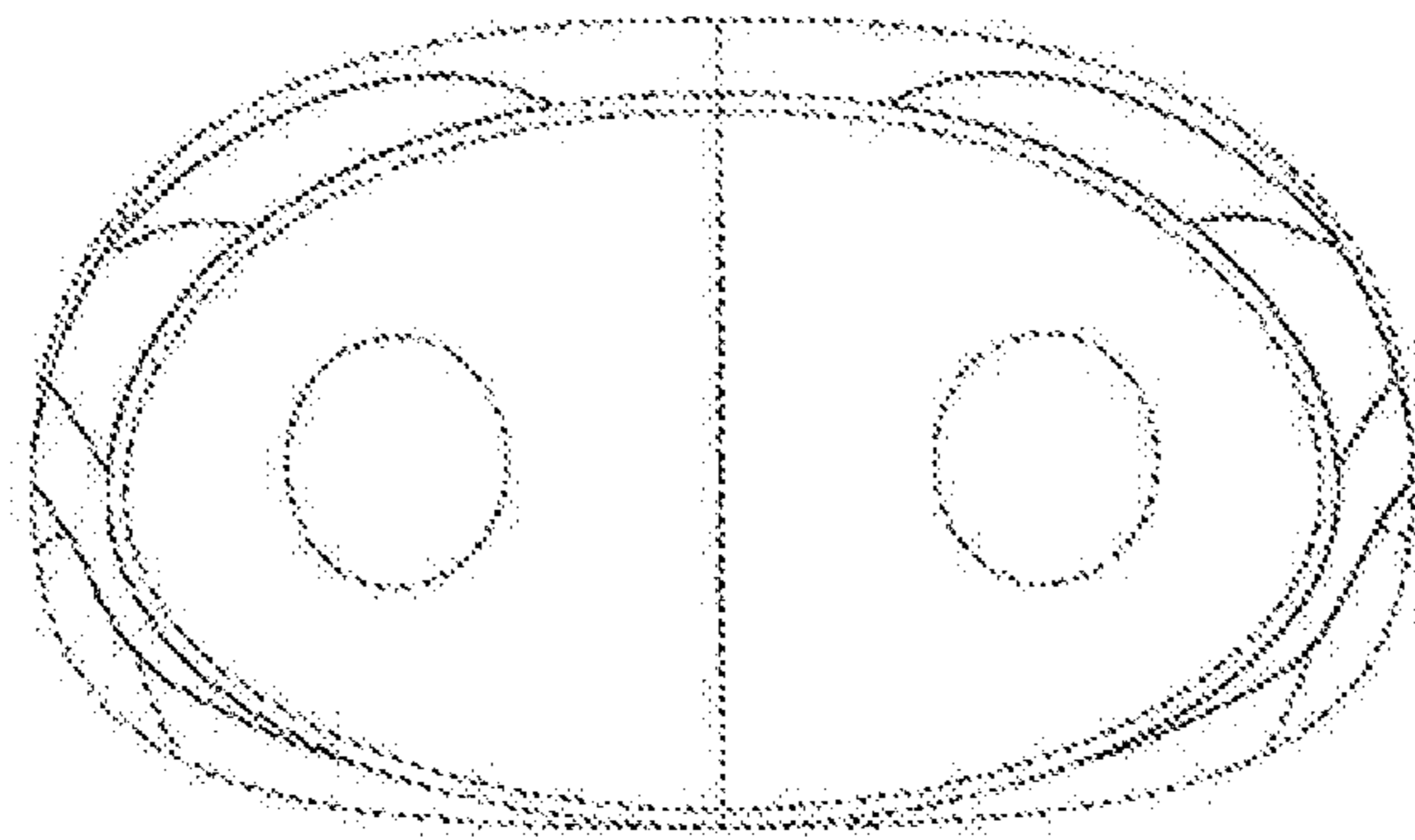

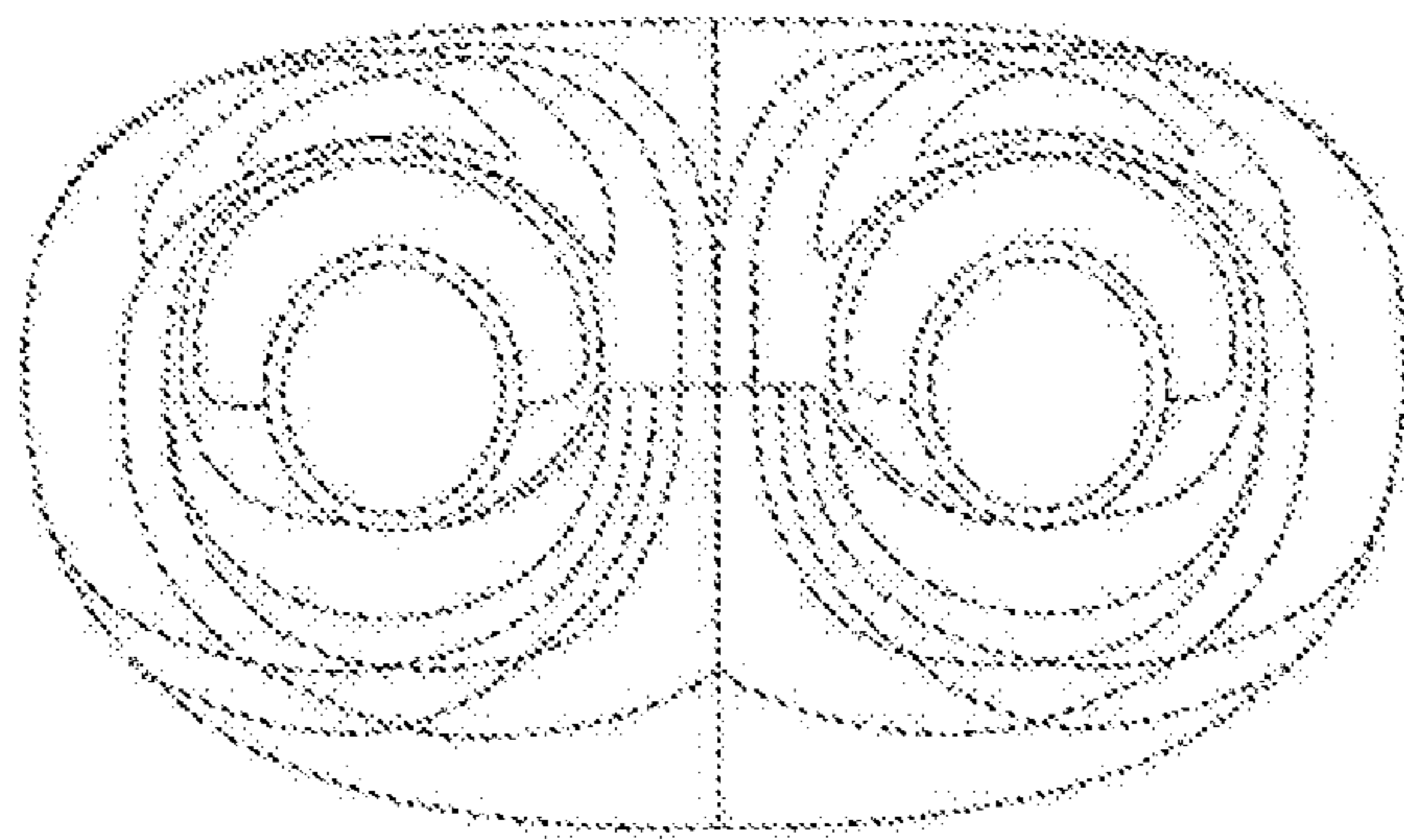

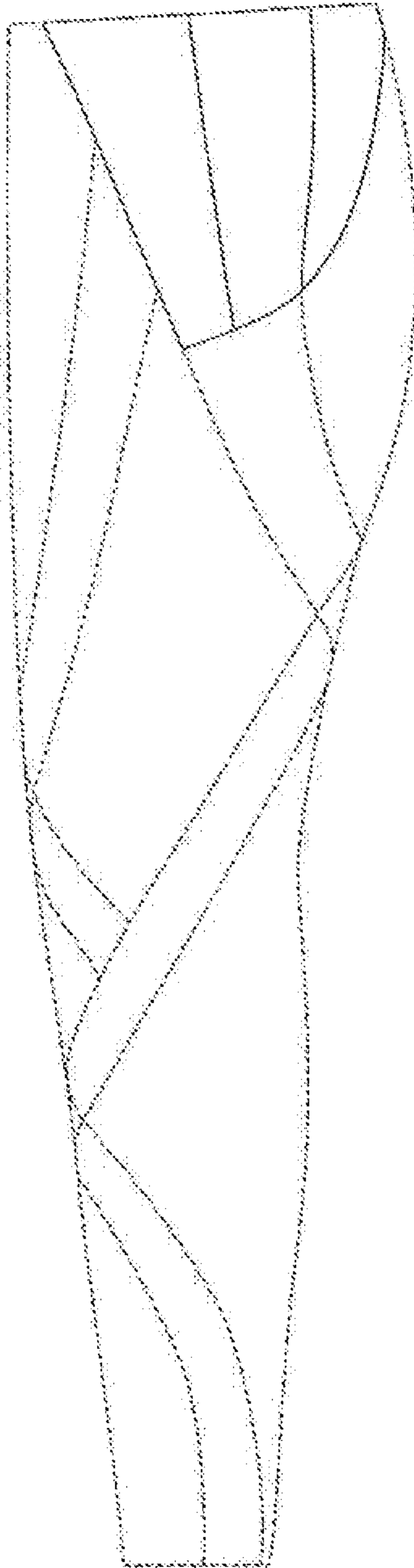

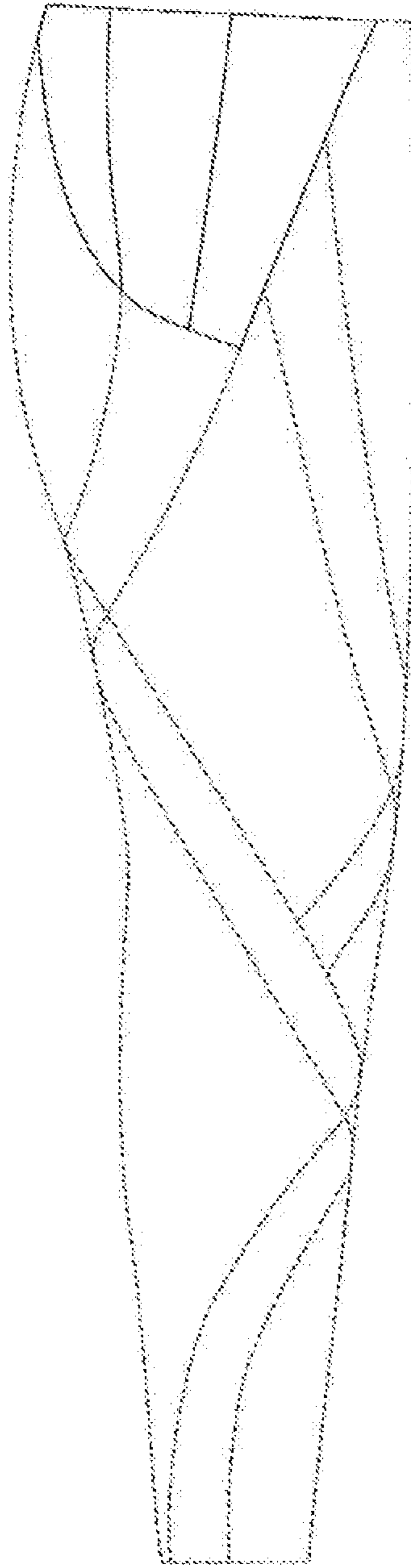

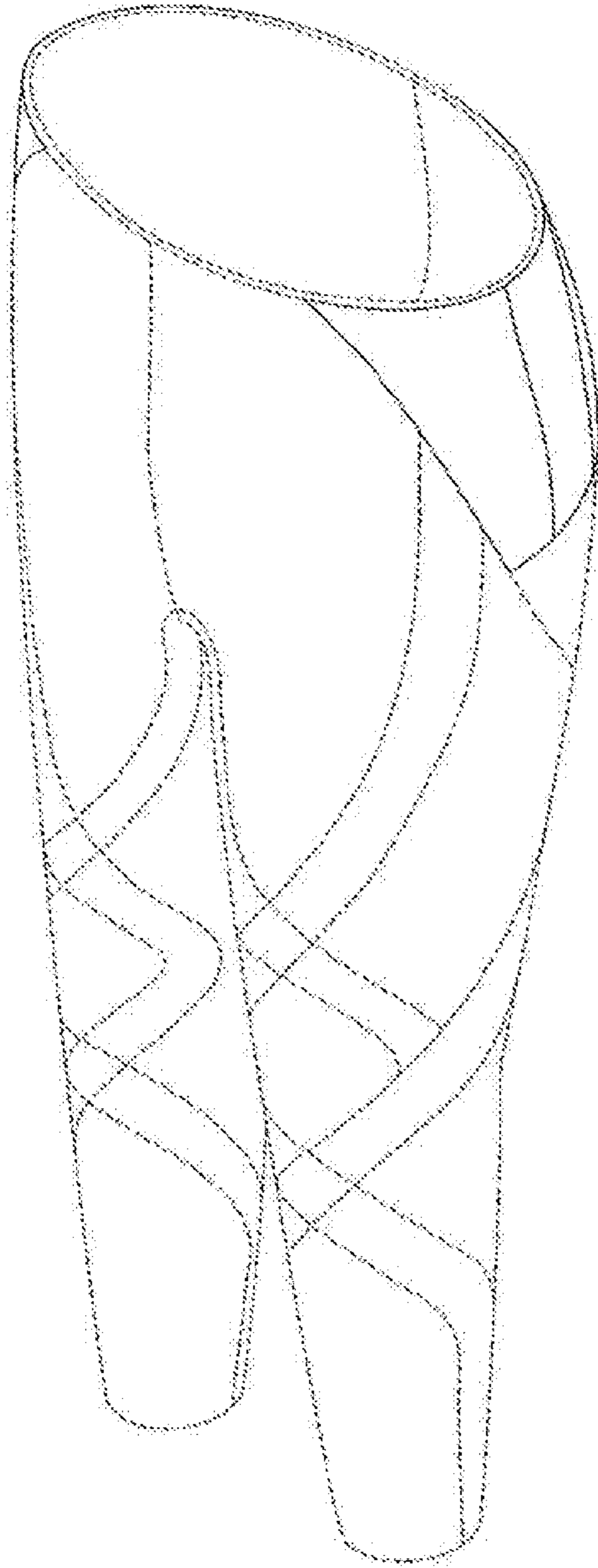

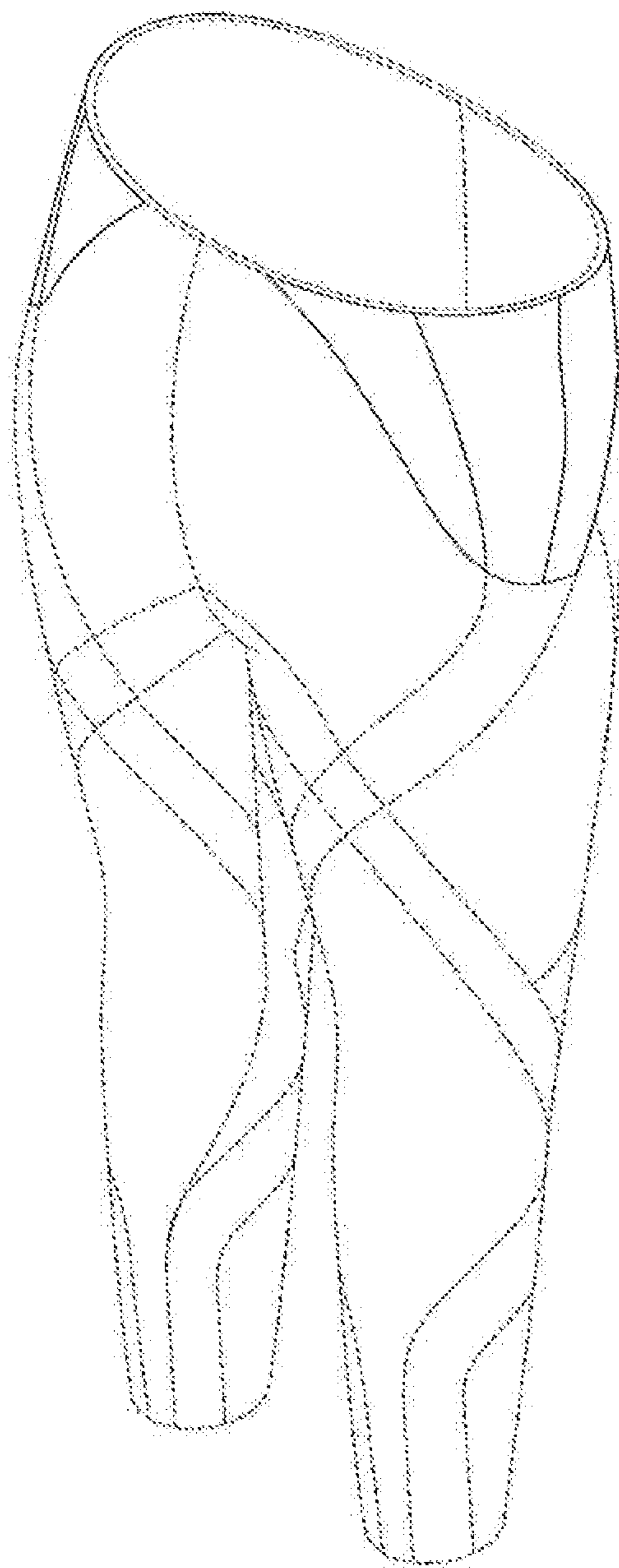

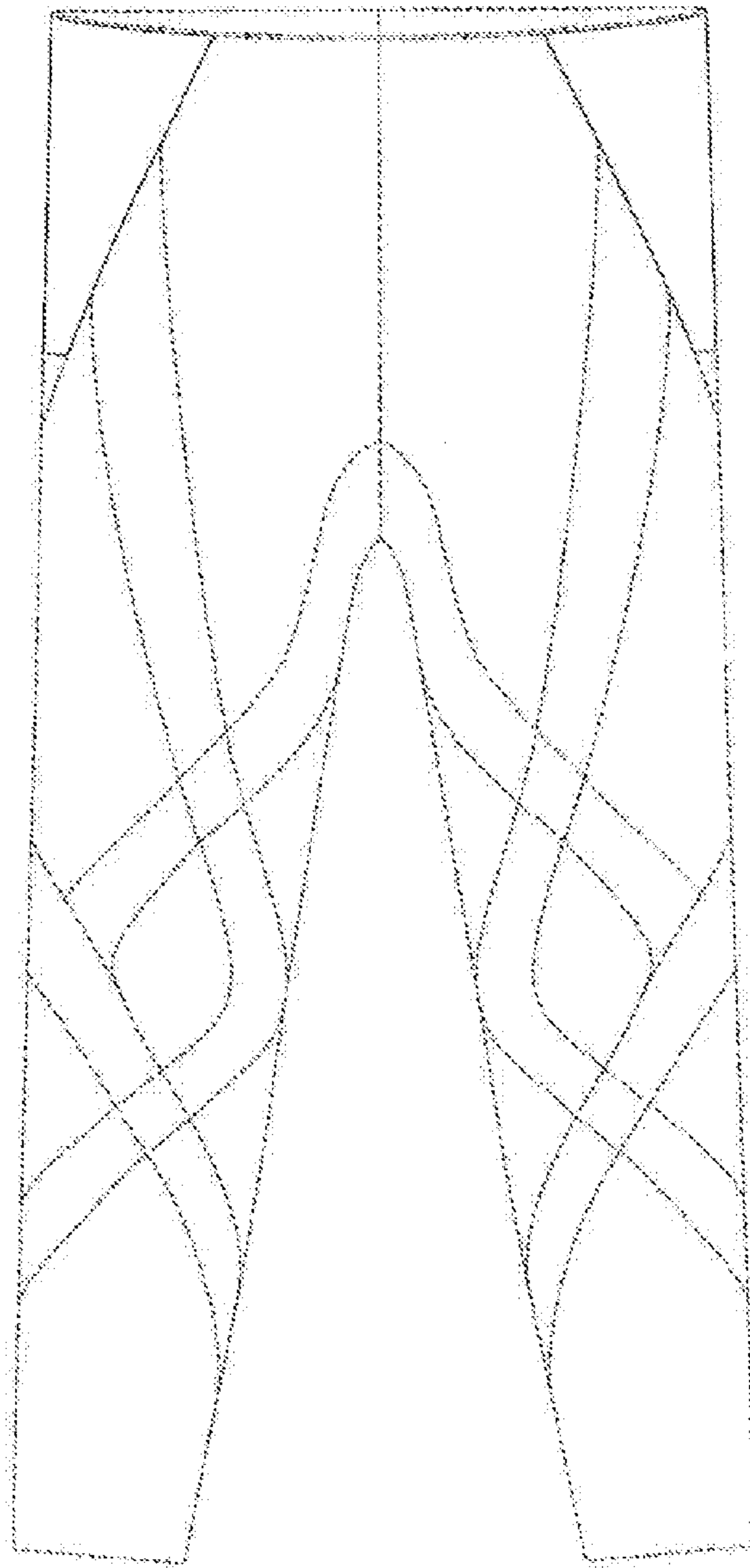

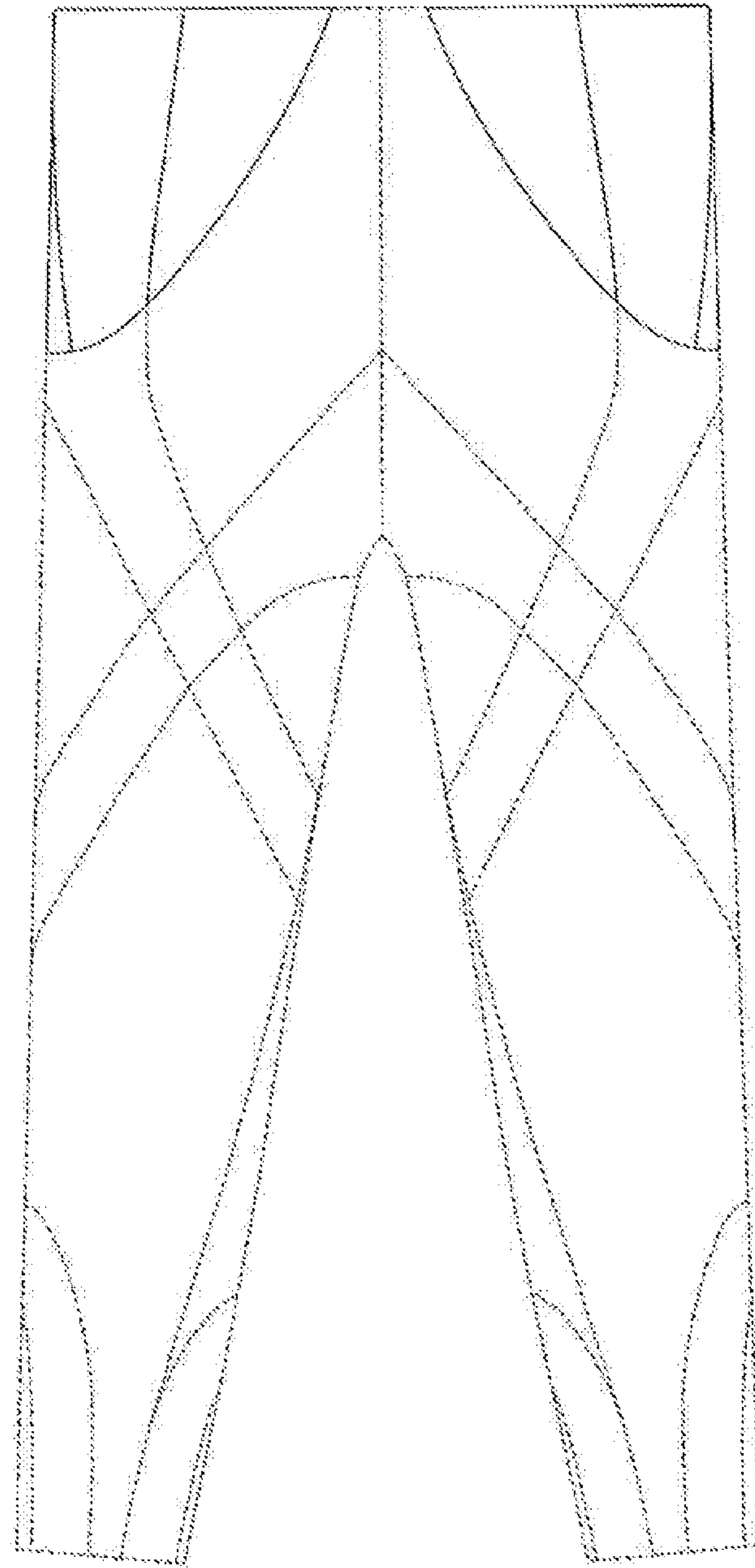

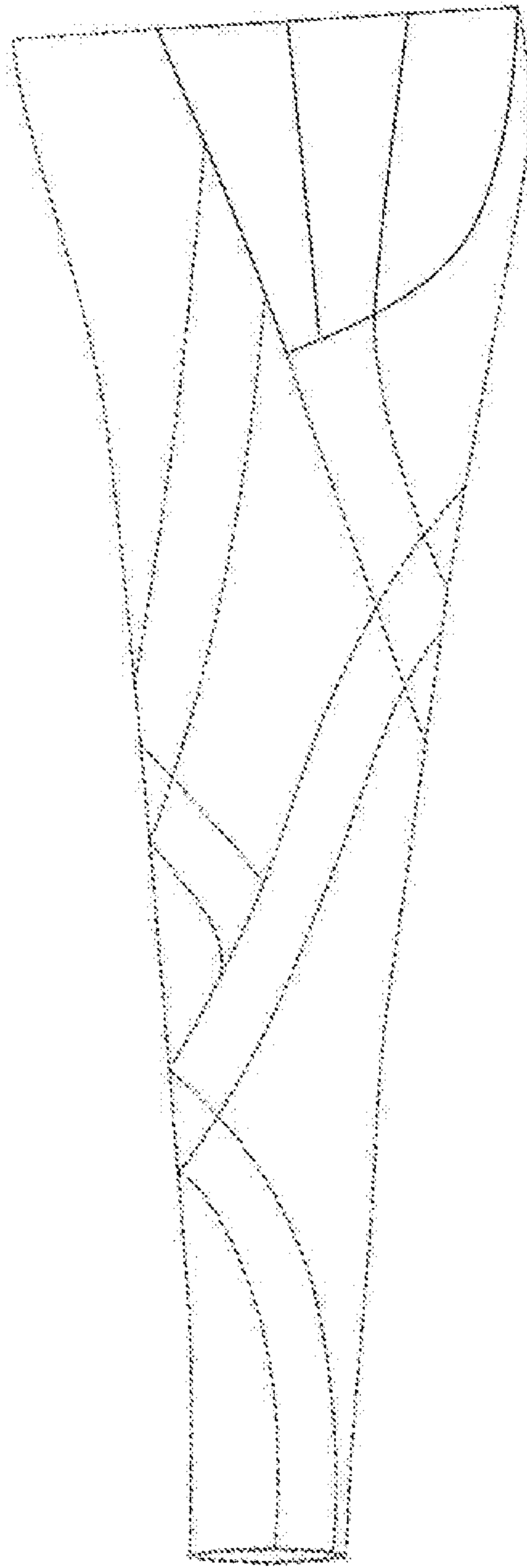

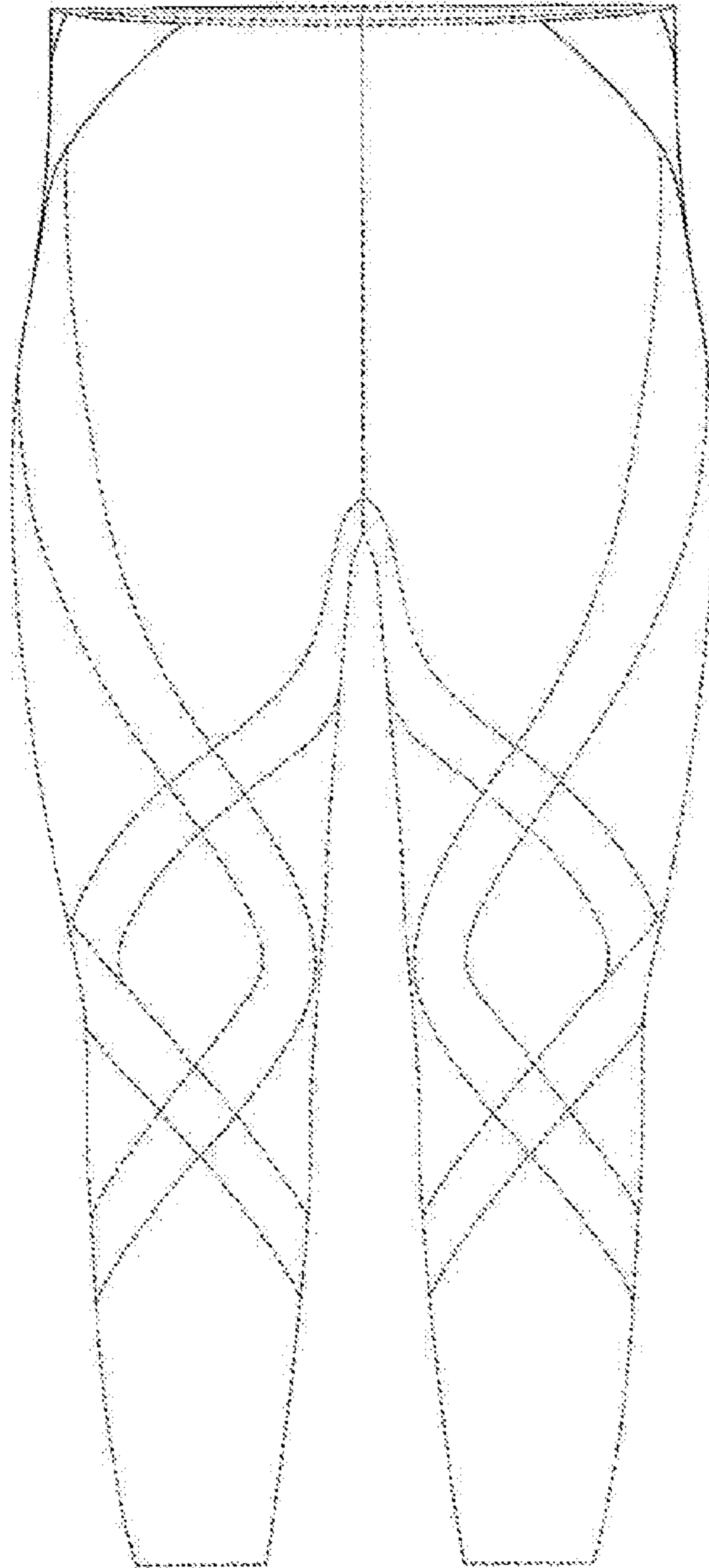

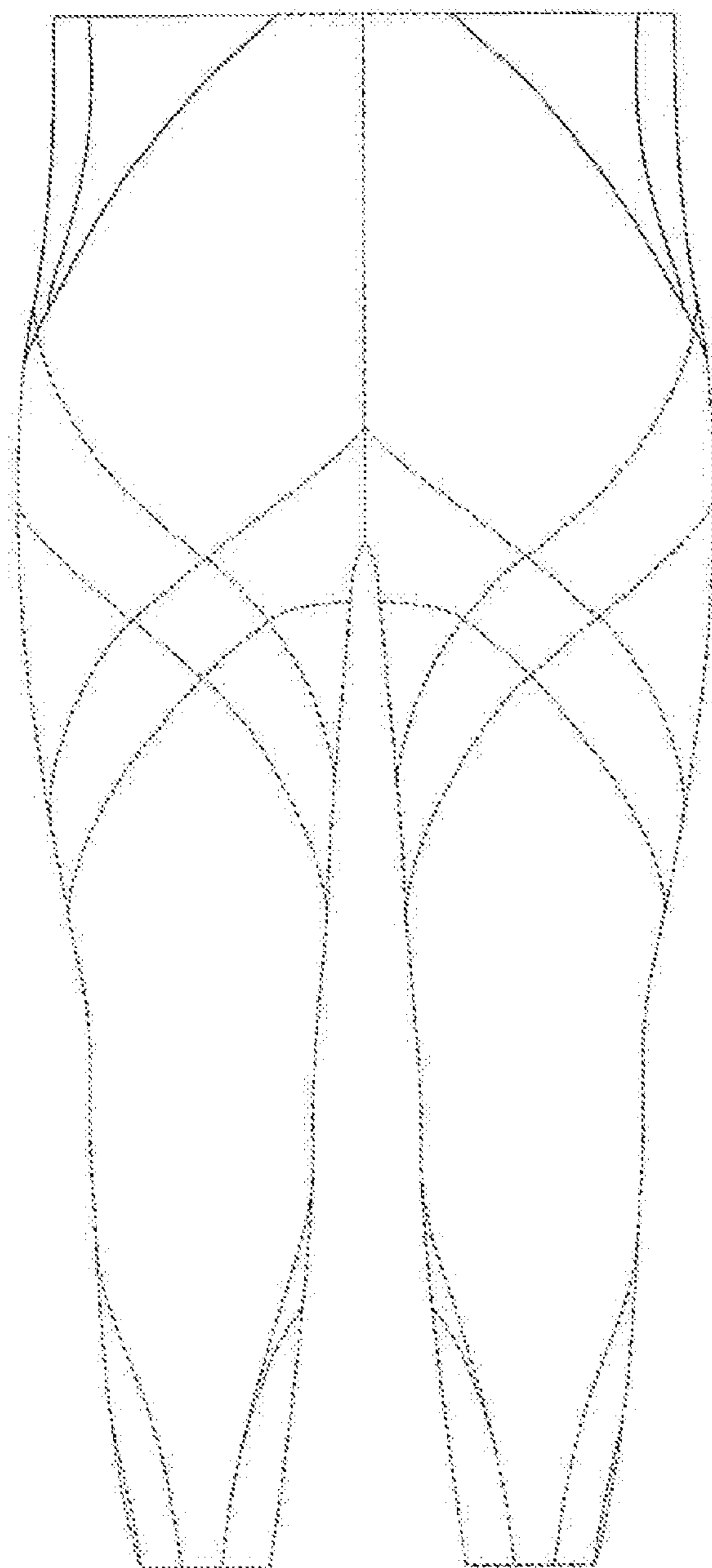

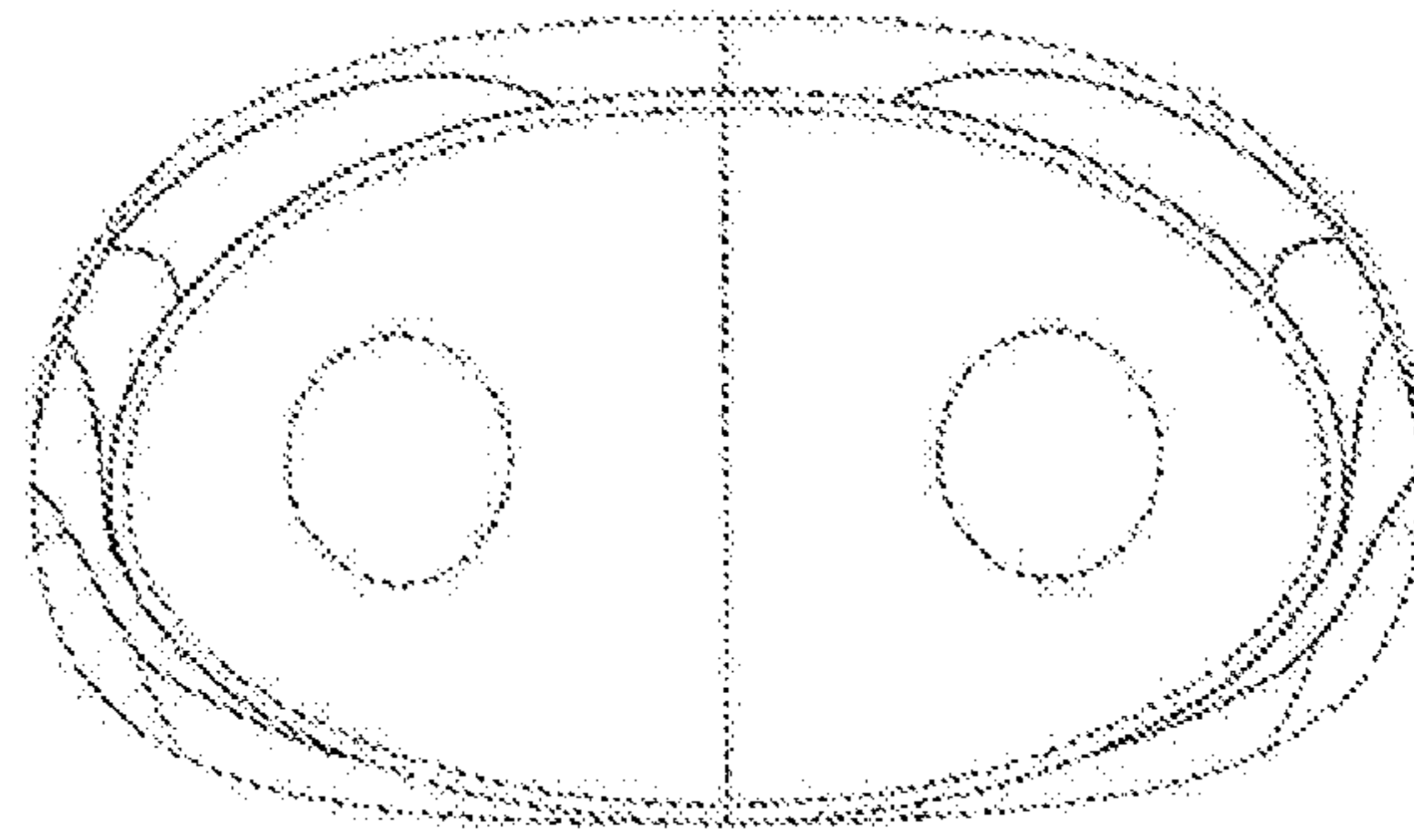

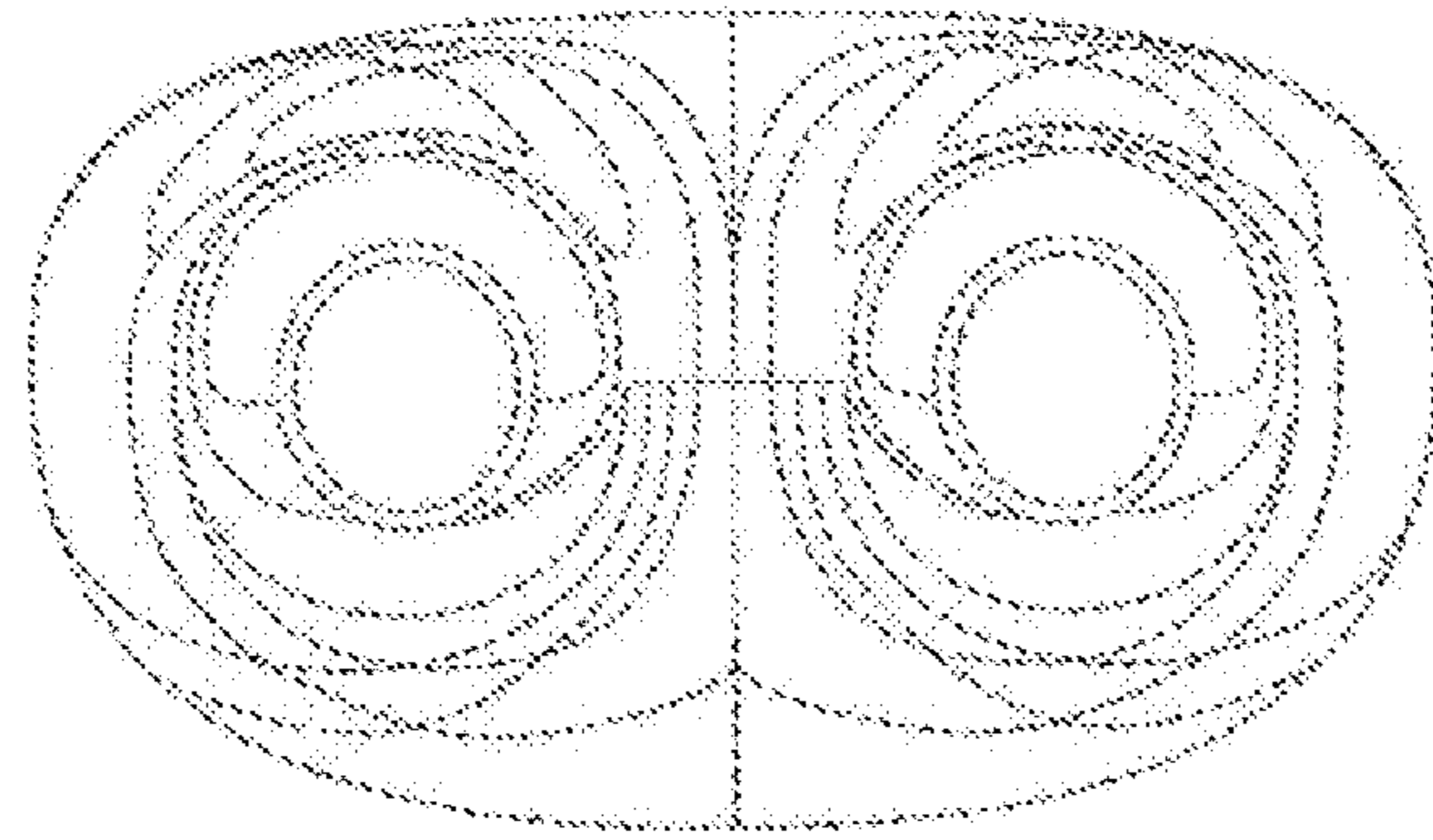

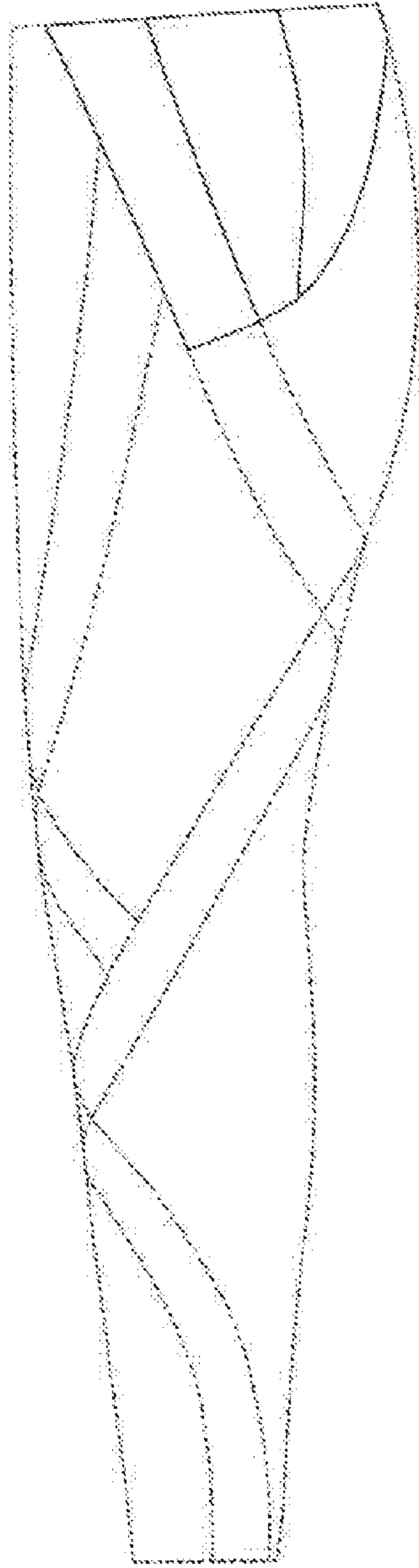

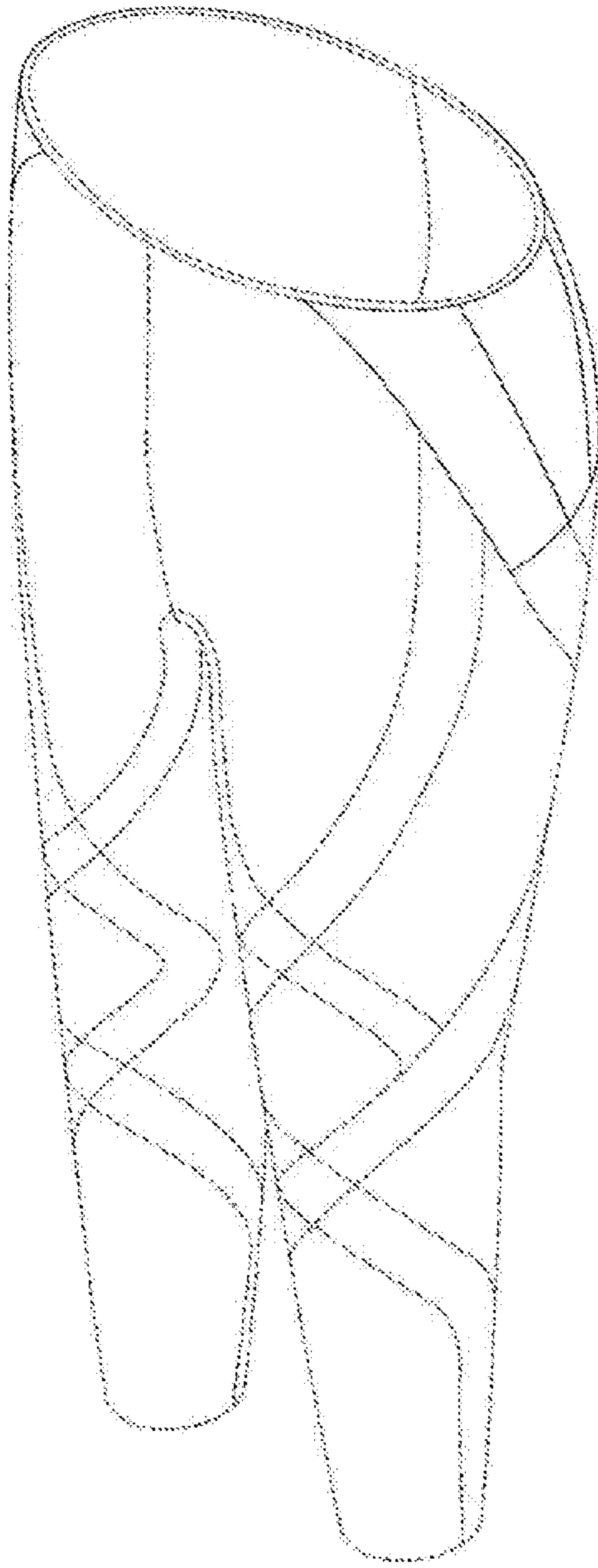

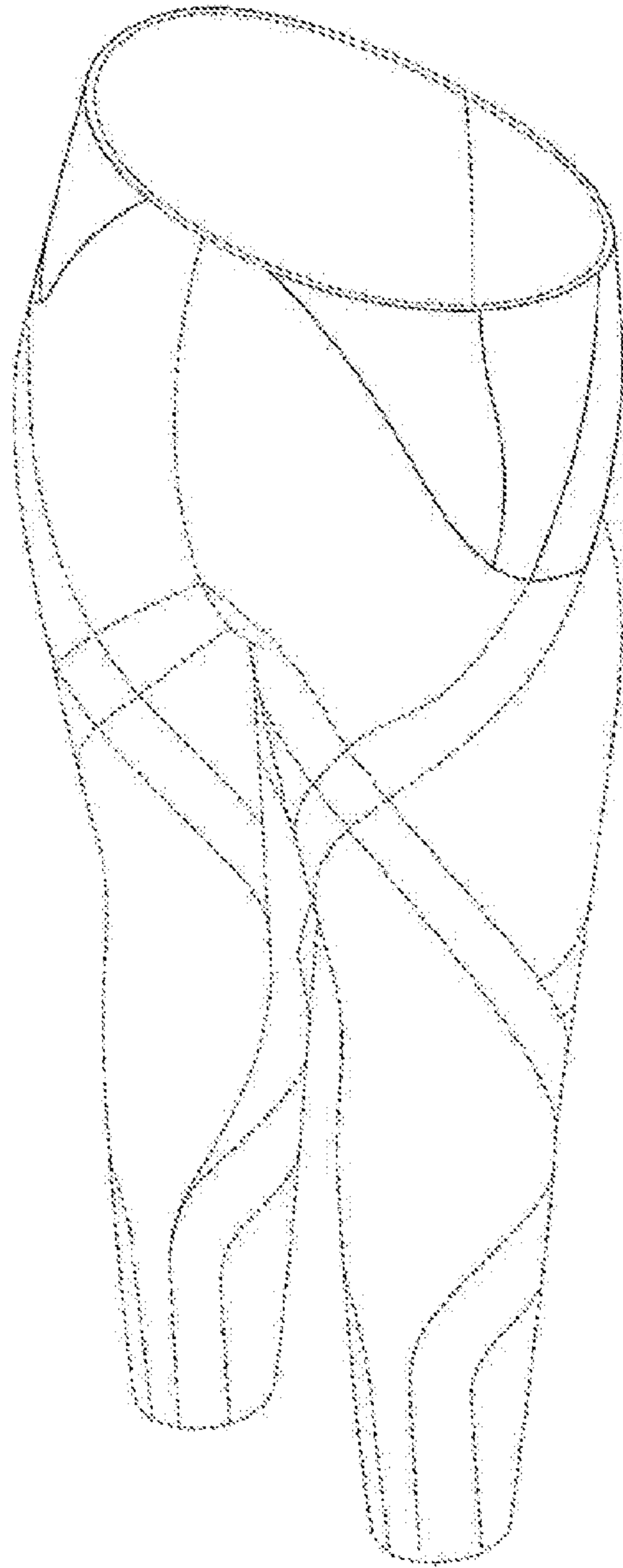

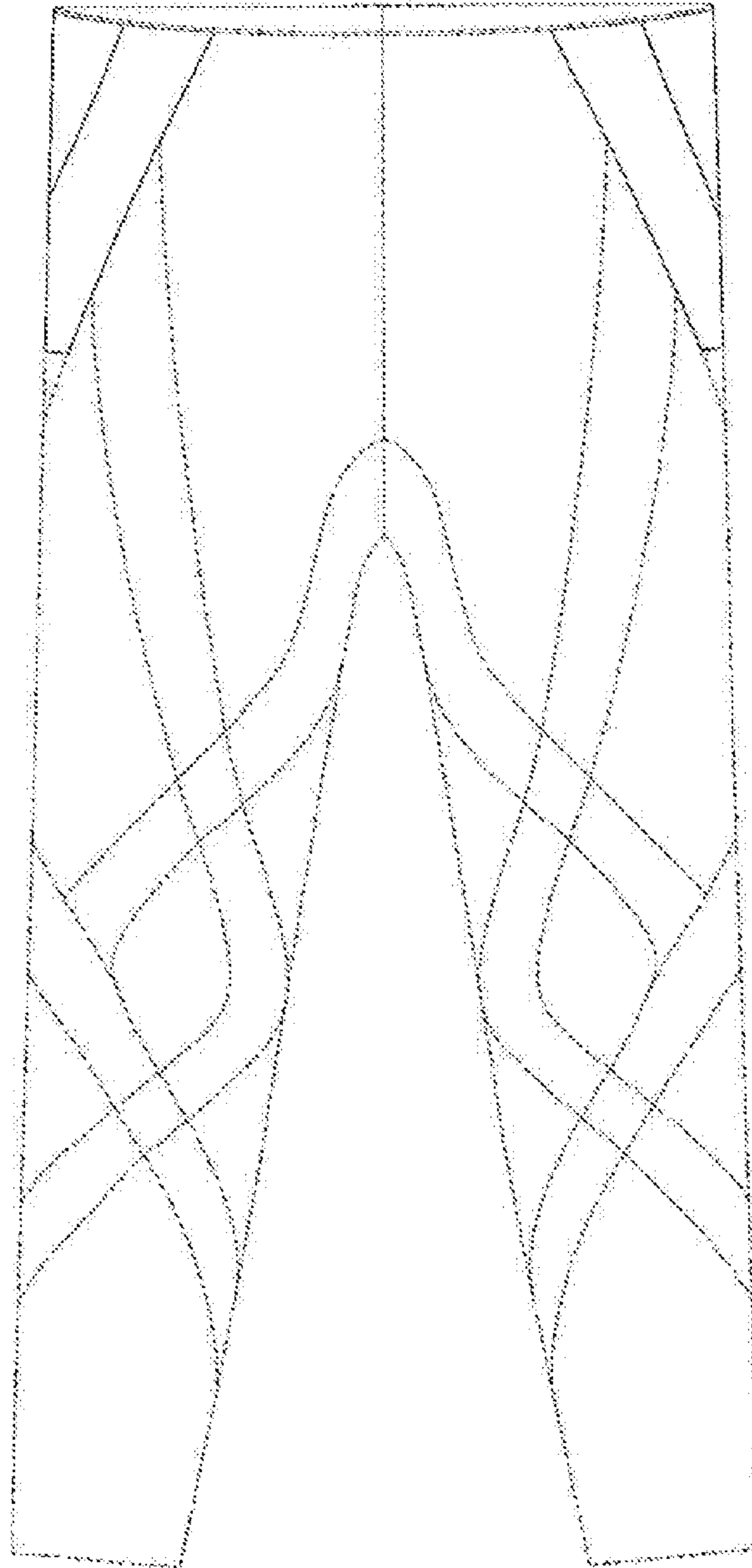

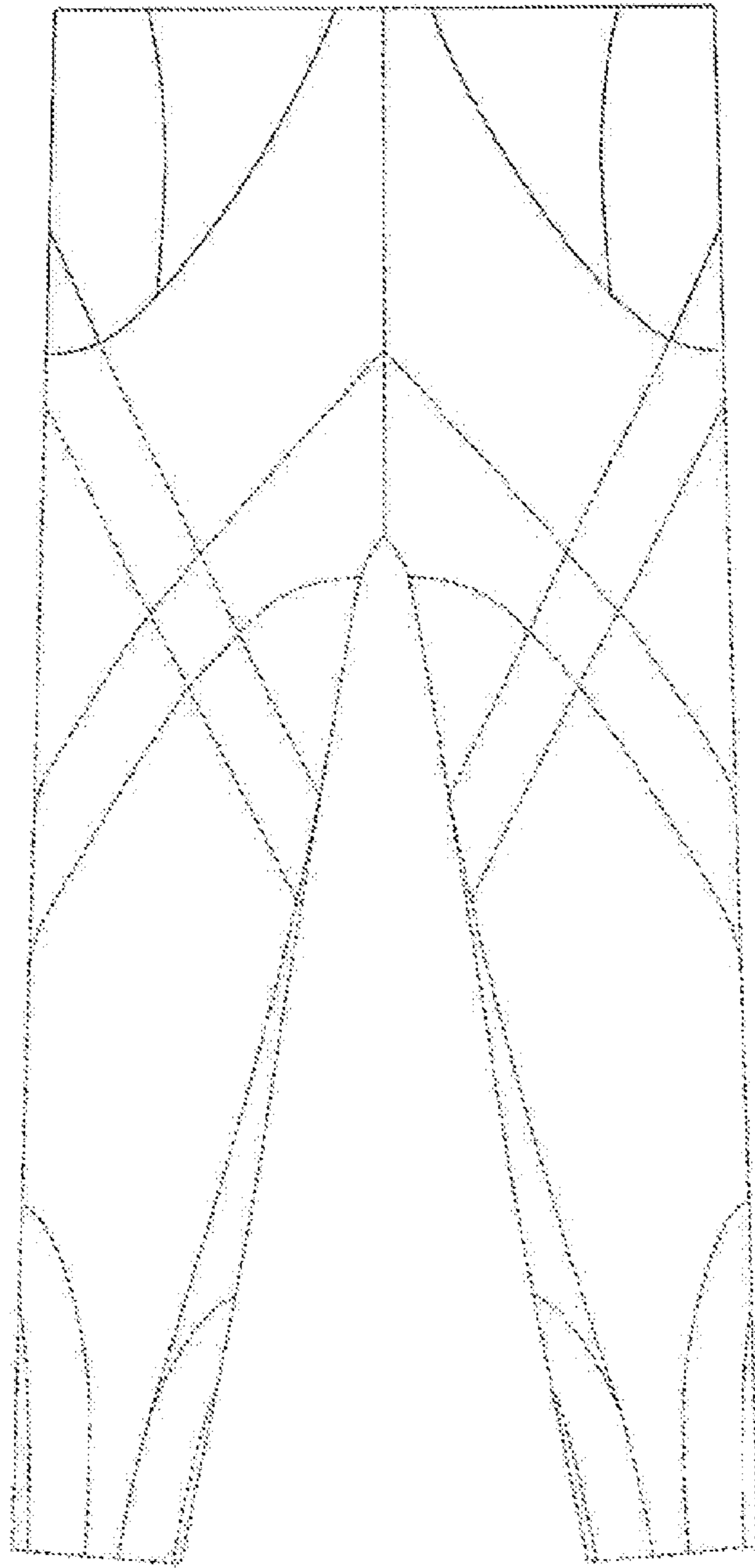

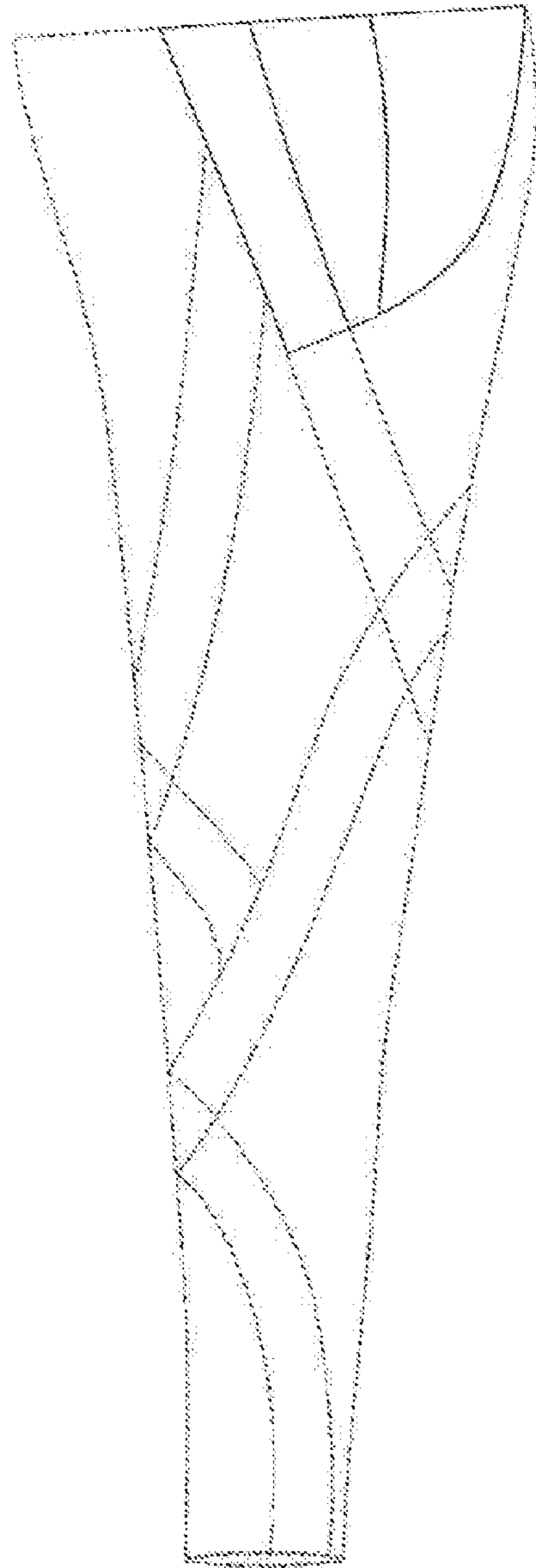
