DESCRIPTION

FIG. 1 is a plan view of one side of an embodiment of the embossed paper product; and,
FIG. 2 is an enlarged partial sectional view taken along line 2-2 in FIG. 1.
The outer rectangular broken lines depict the boundaries of the claim and form no part thereof. The dotted lines within the boundaries of FIG. 1 form part of the claimed design. The rear side of the embossed paper product forms no part of the claimed design.

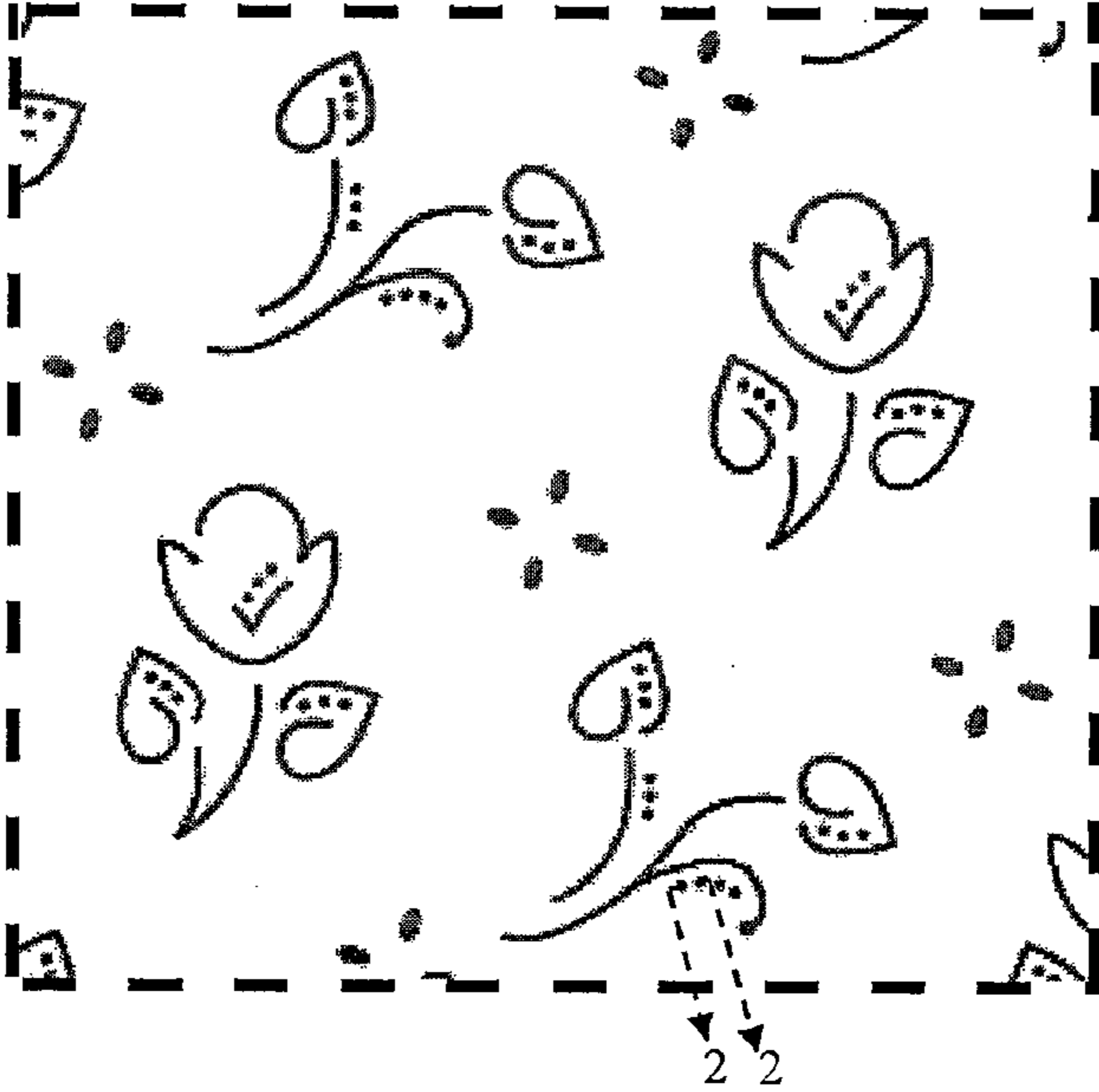

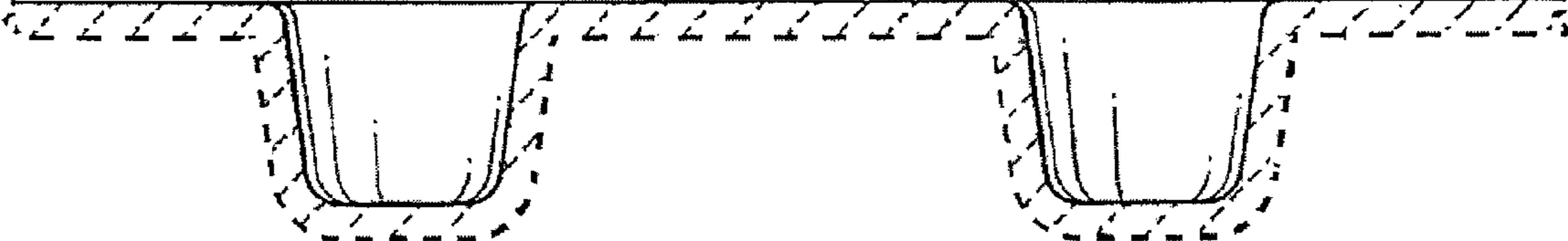
