The ornamental design for a molded mat, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom side of a molded mat showing our new design.

FIG. 2 is a front side view thereof;

FIG. 3 is a rear side view thereof;

FIG. 4 is a right side thereof;

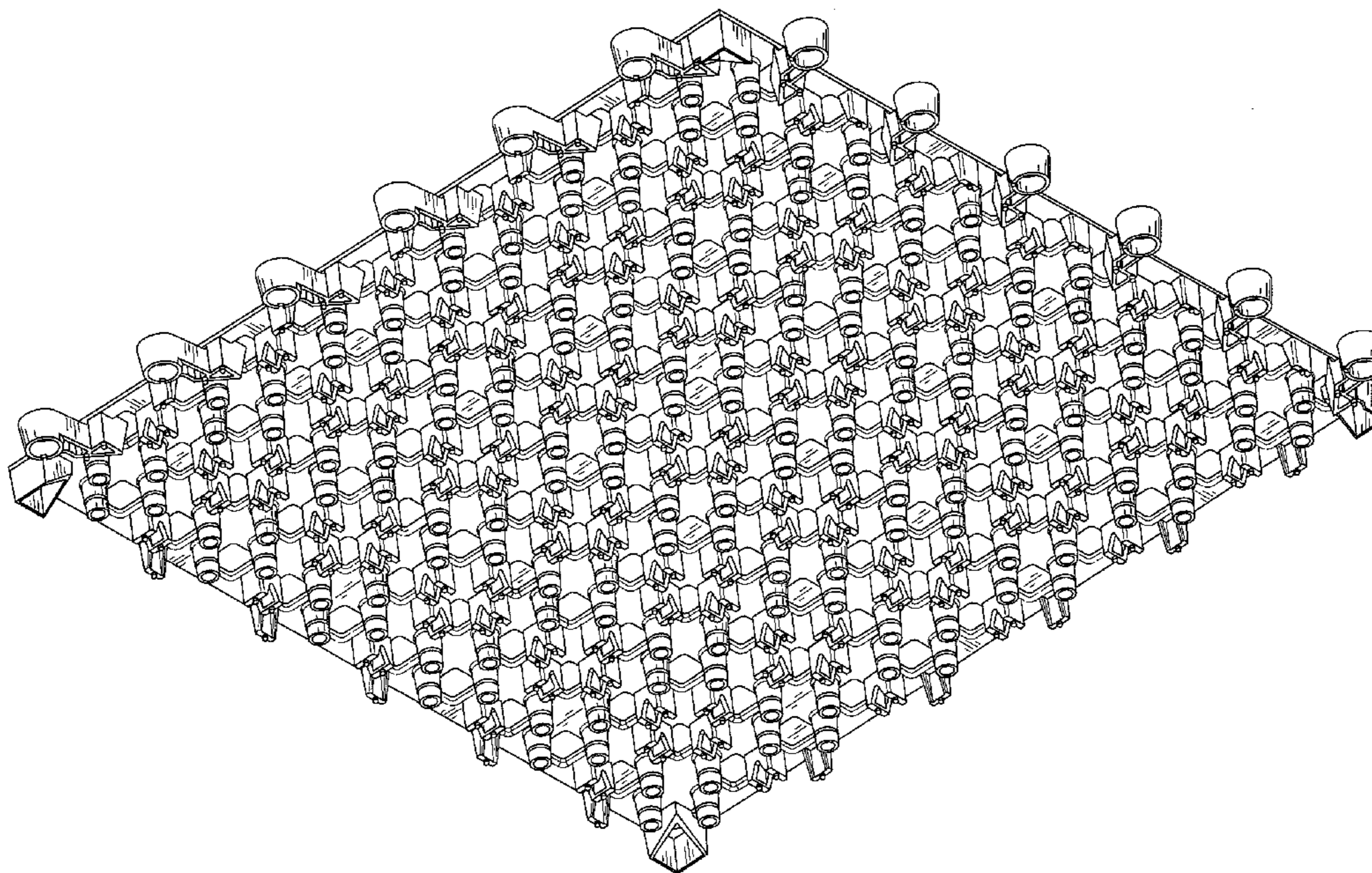
FIG. 5 is a left side thereof;

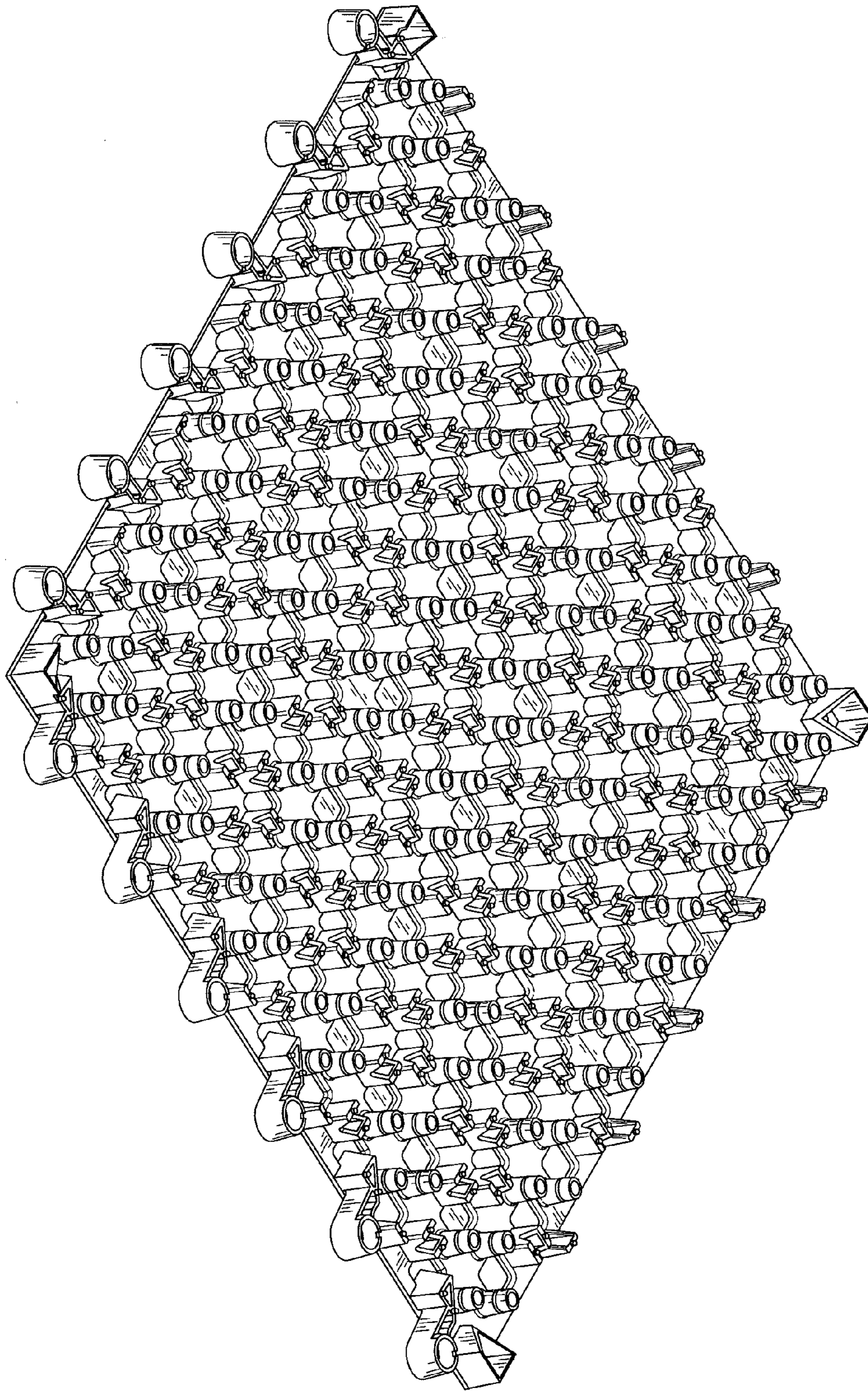

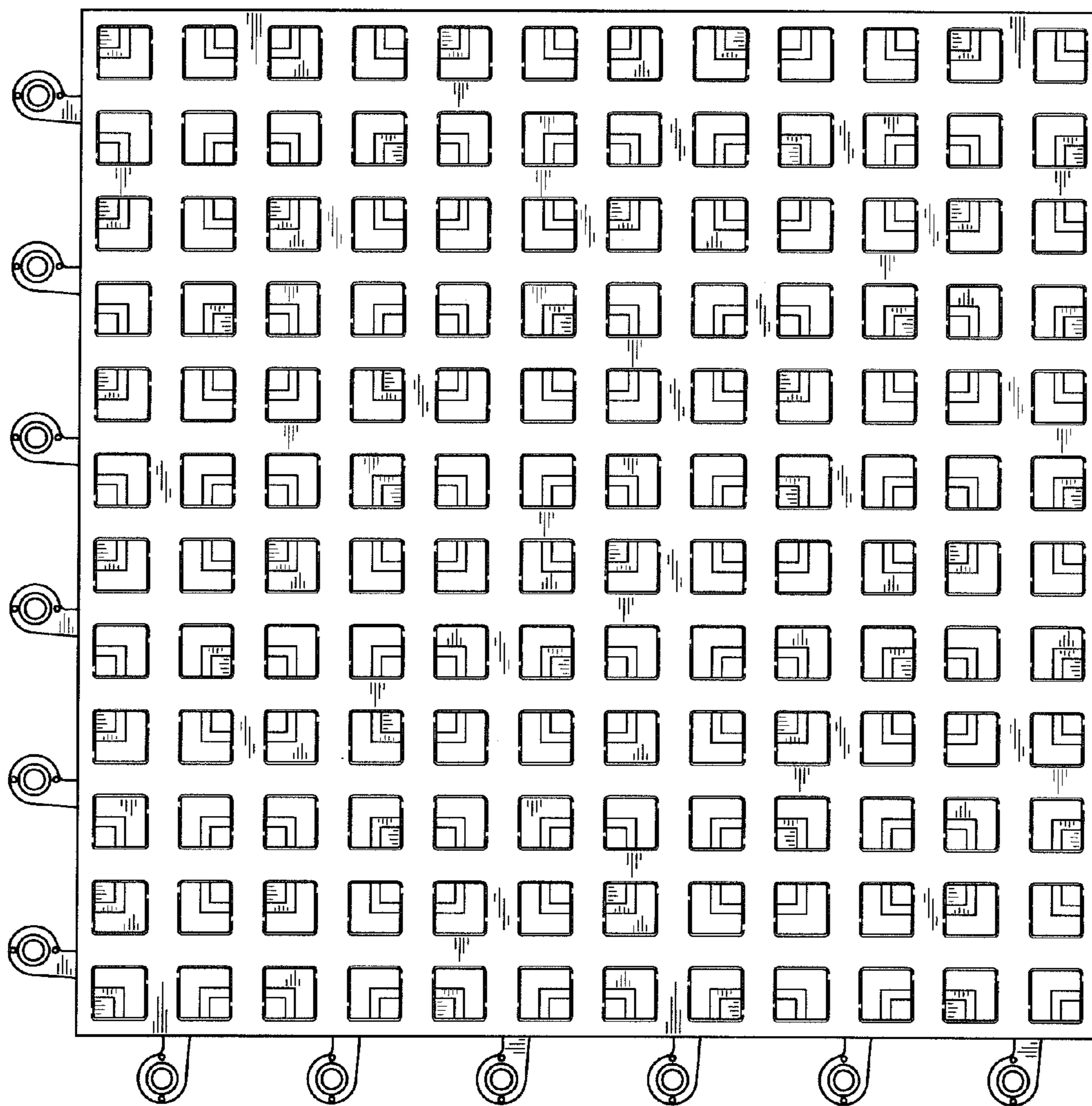

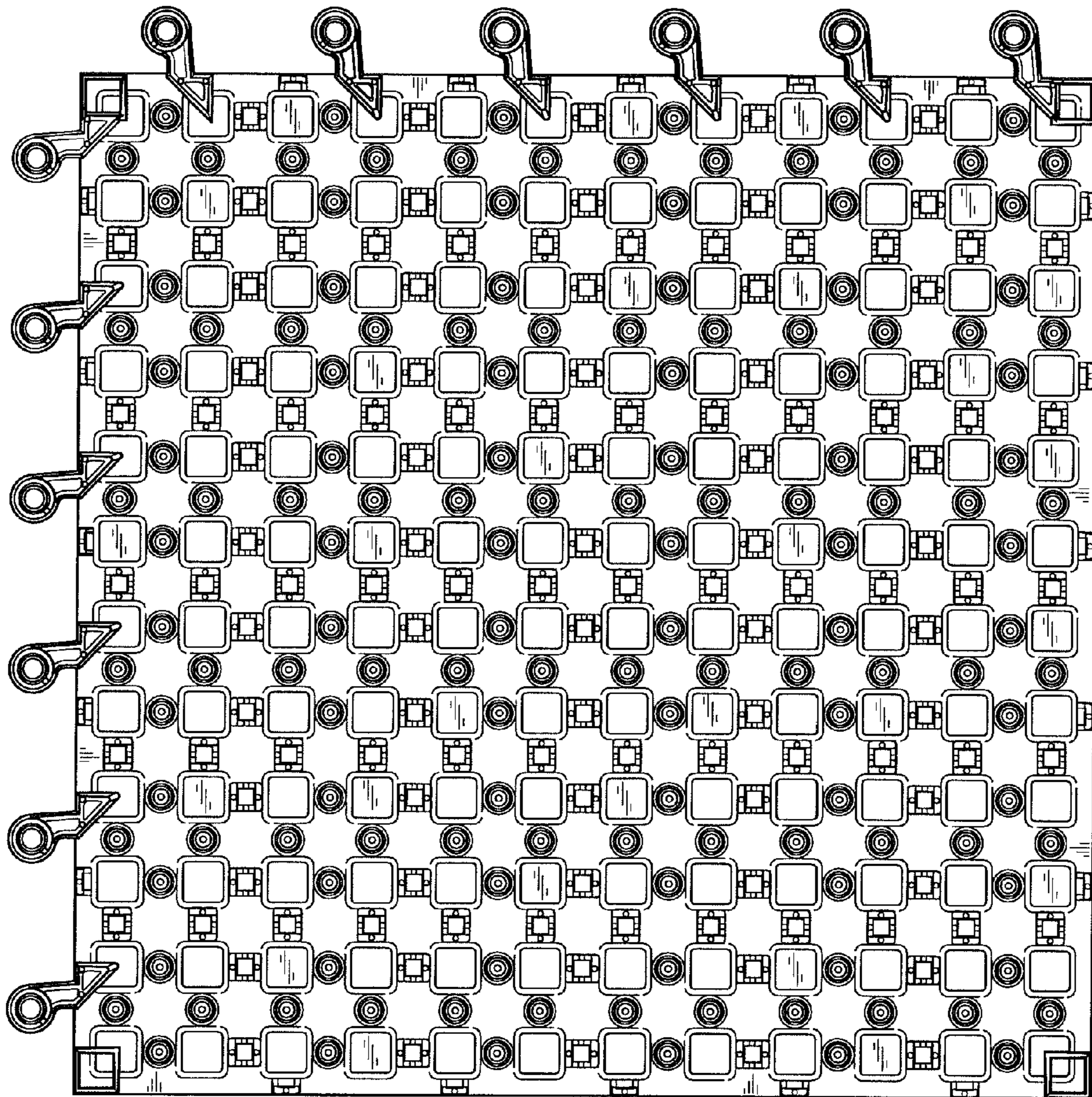
