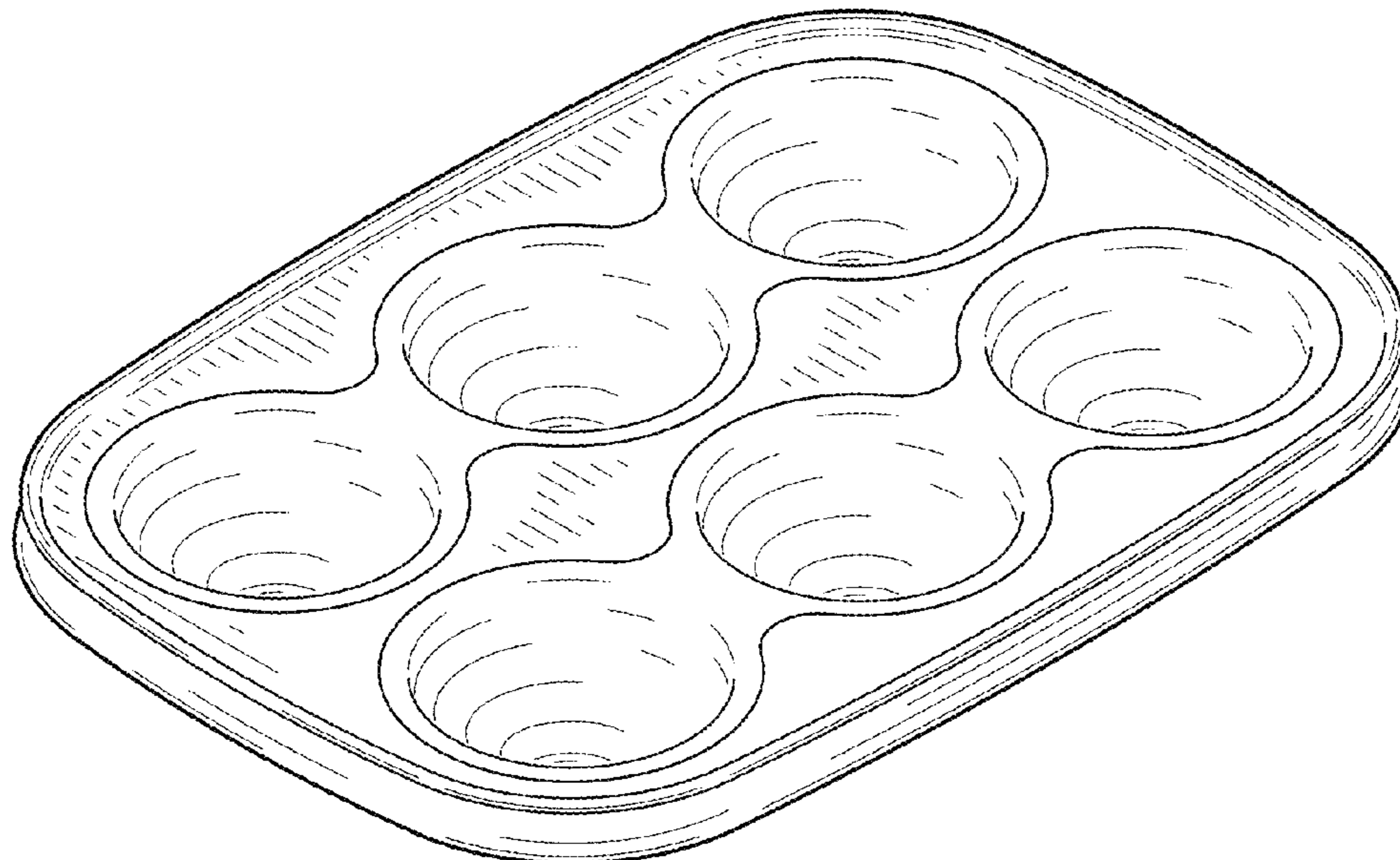

**DESCRIPTION**

FIG. 1 is a perspective view of a cookie dough tray, showing our new design;  
FIG. 2 is a top view of the cookie dough tray;  
FIG. 3 is a front view of the cookie dough tray, the back view being identical;  
FIG. 4 is a right side view of the cookie dough tray, the left side being identical; and,  
FIG. 5 is a bottom view of the cookie dough tray.  
Portions of the tray illustrated in phantom in the bottom view of the tray form no part of the claimed invention.

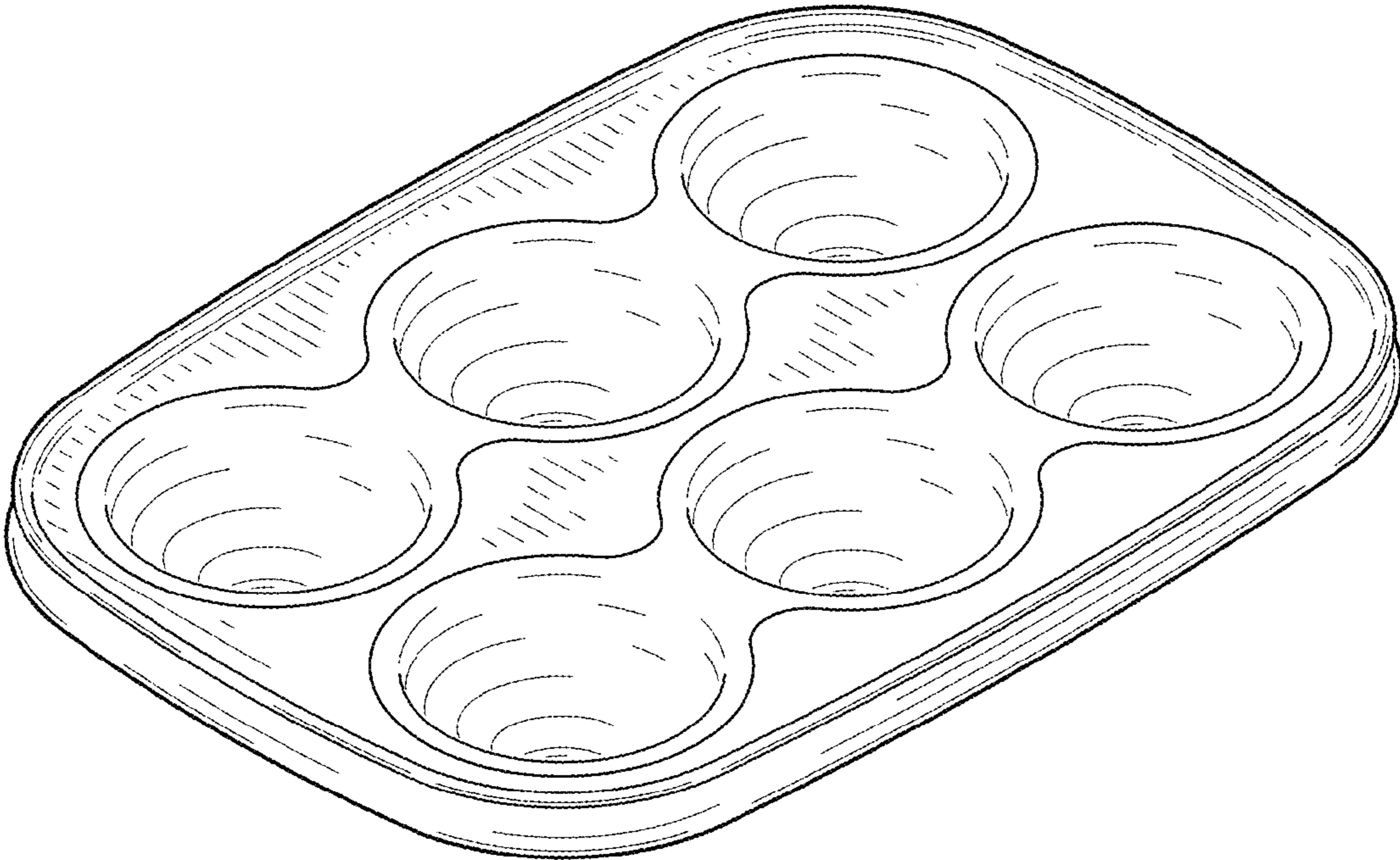

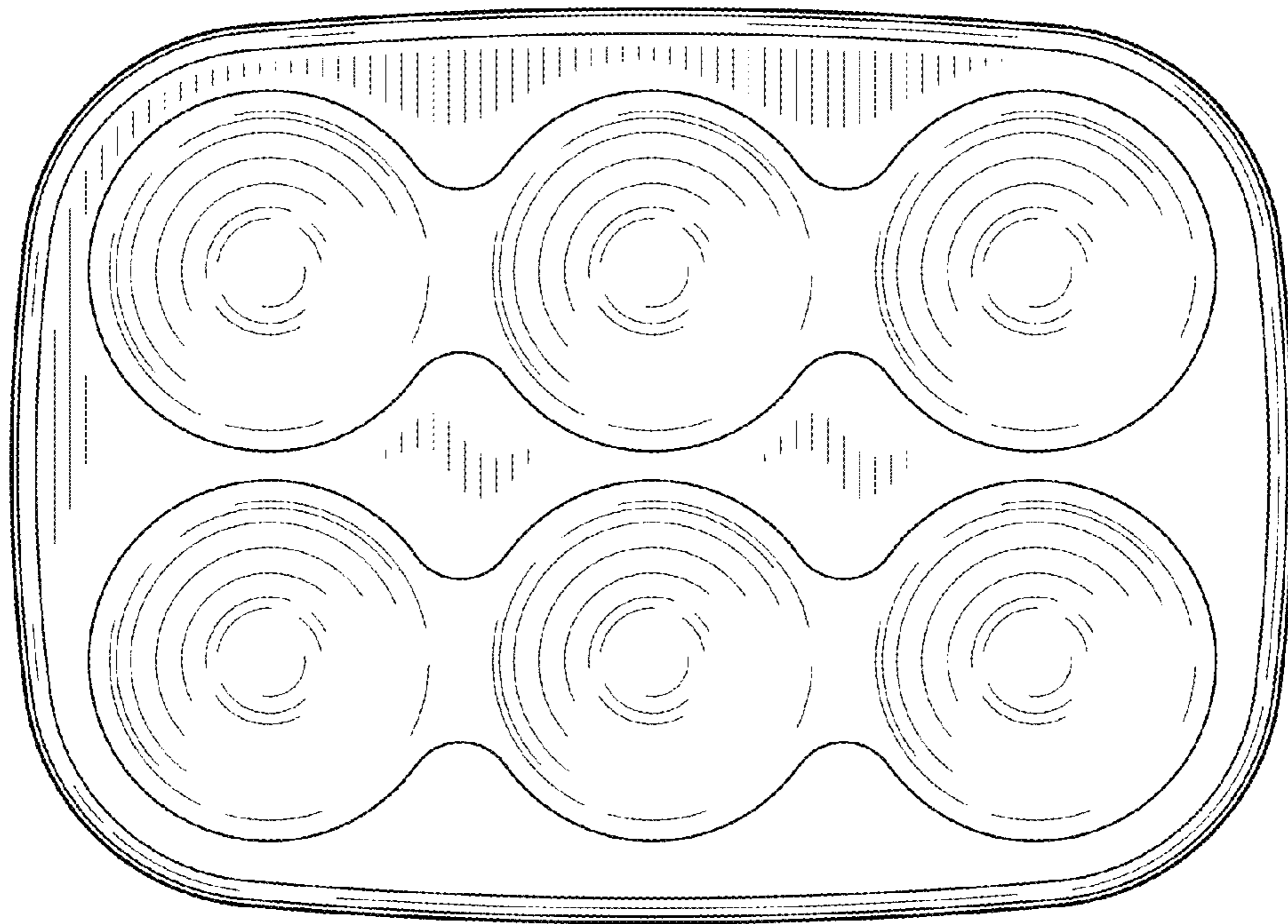

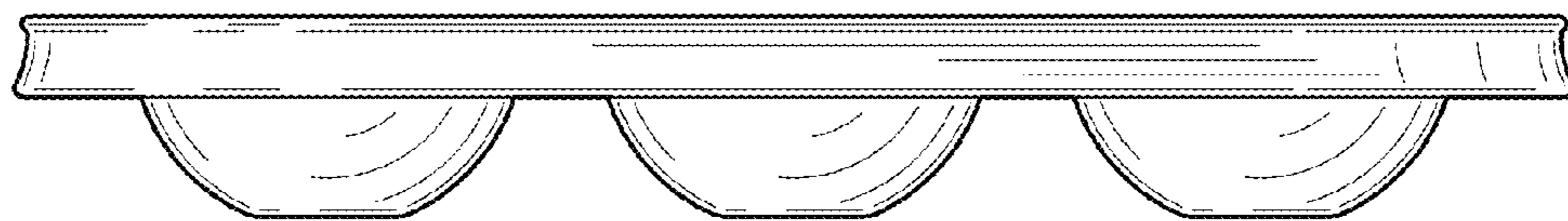

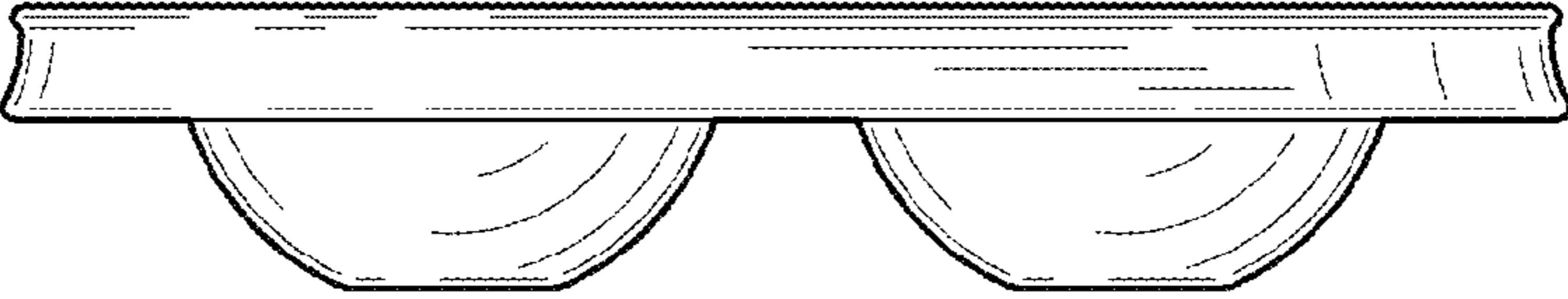

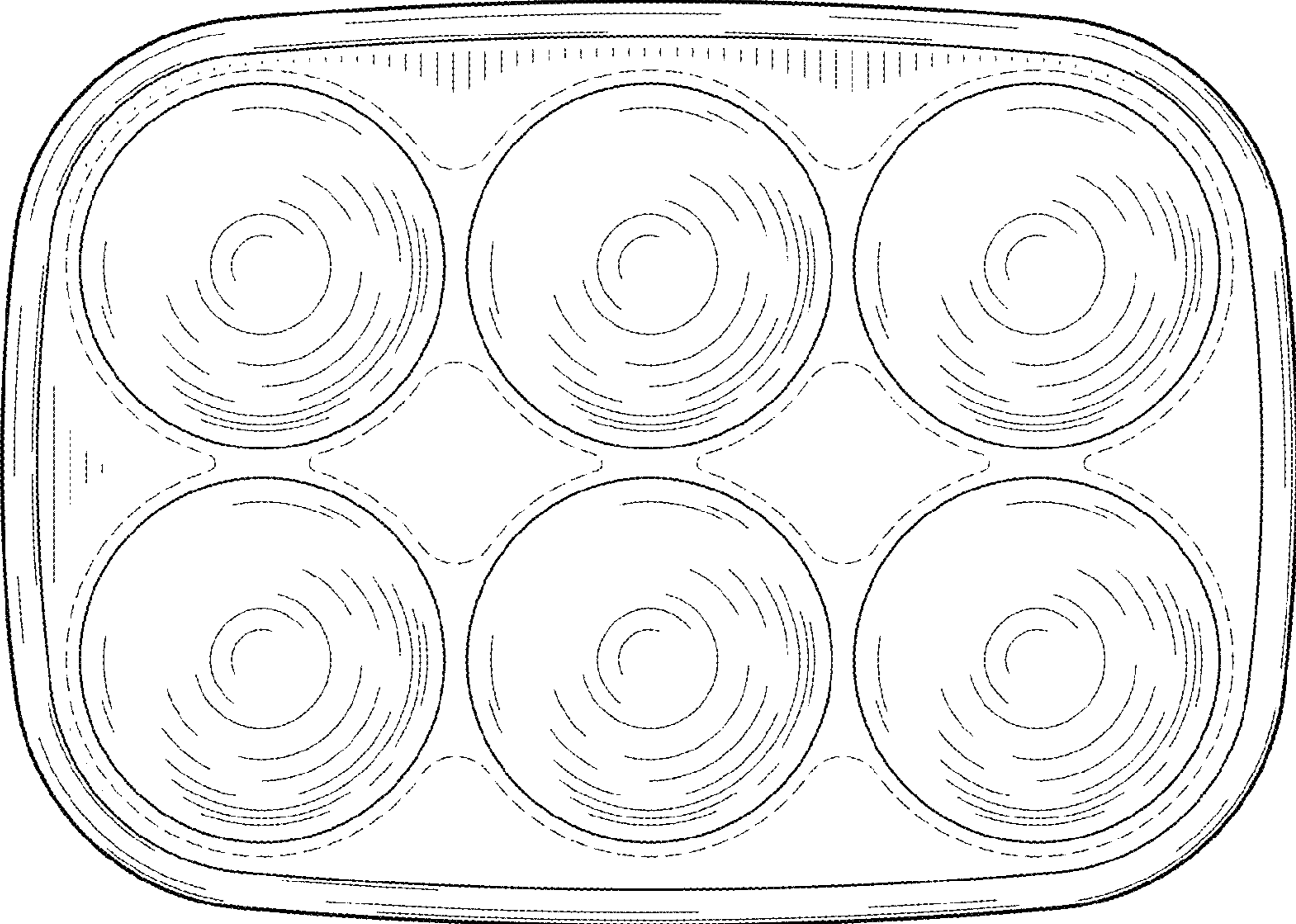
