(57) **CLAIM**

I claim the ornamental design of a can cover, as shown and described.

**DESCRIPTION**

FIG. 1 is a side view of a can cover, including a tip of a whipped cream can protruding from the top of the cover.

FIG. 2 is a top view of the can cover.

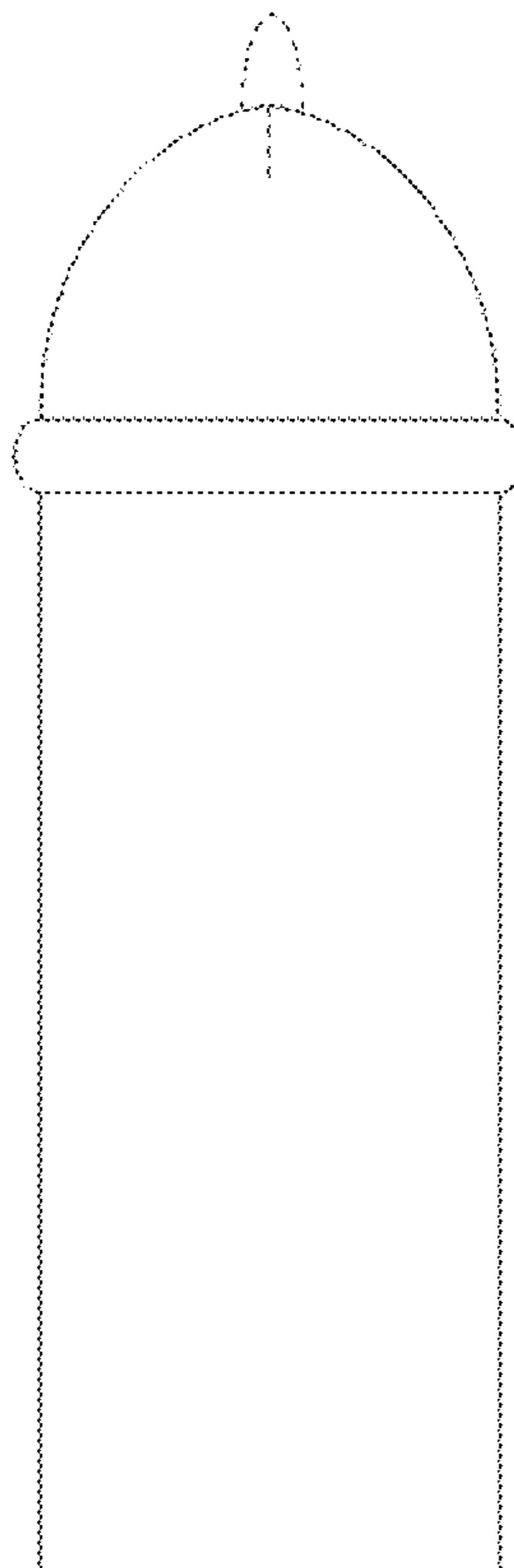
FIG. 3 is bottom view of the can cover.

FIG. 4 is a perspective view of the can cover as seen from the bottom; and,

FIG. 5 is a perspective view of the can cover as seen from the top.

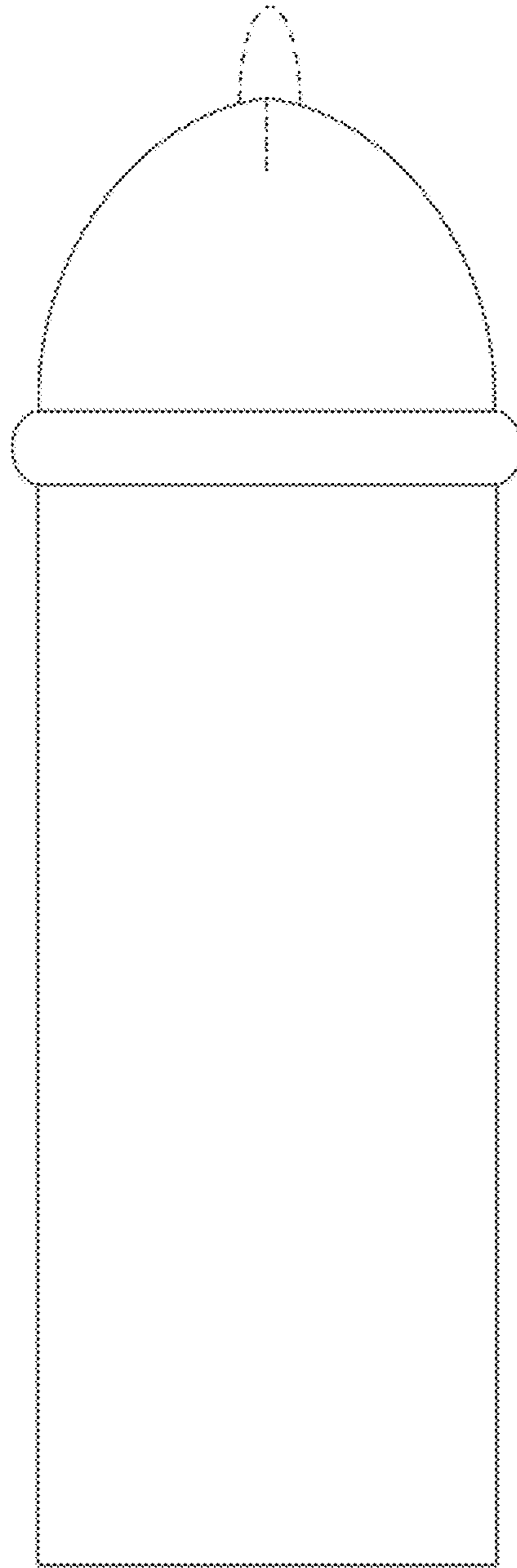

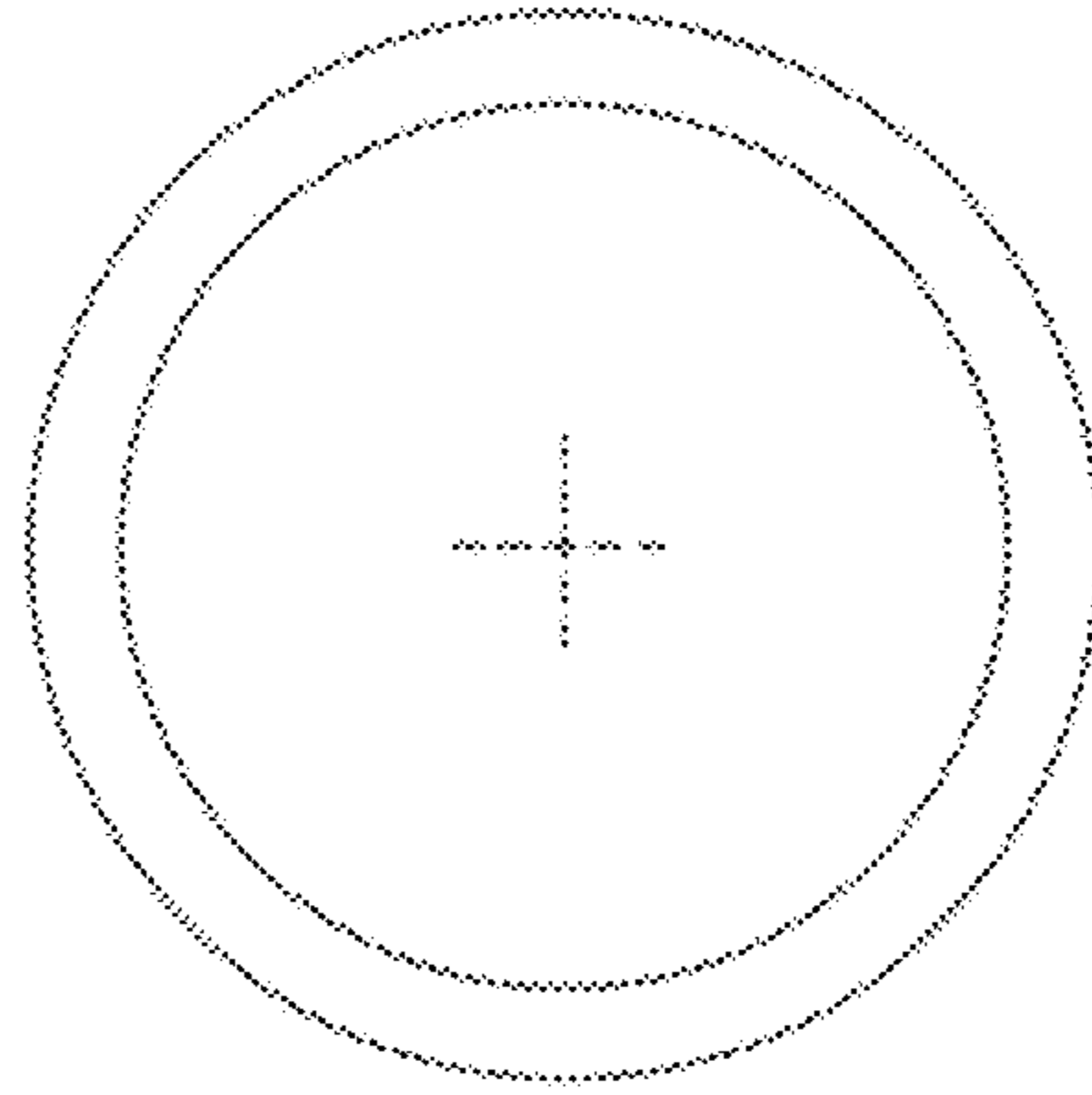

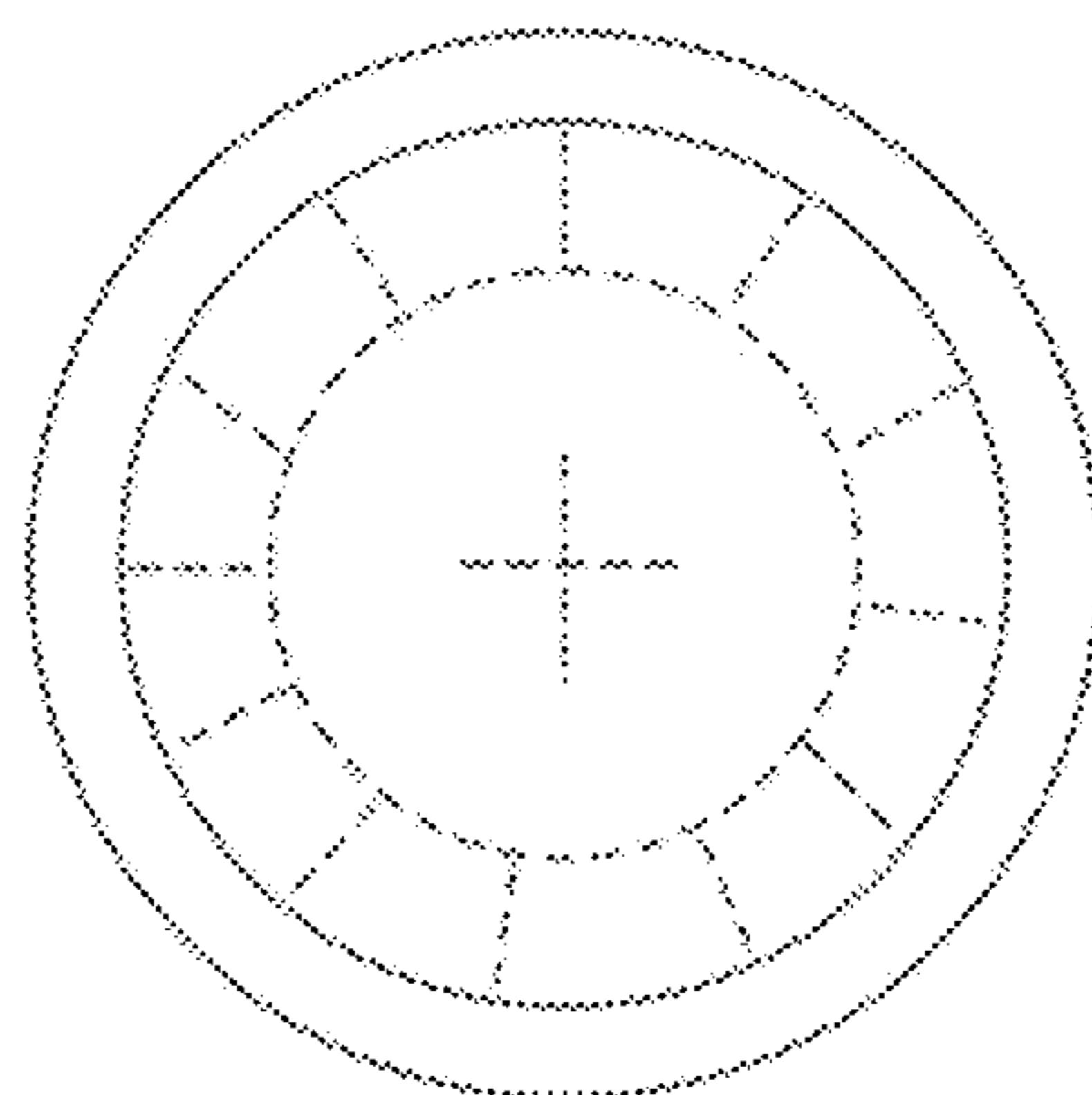

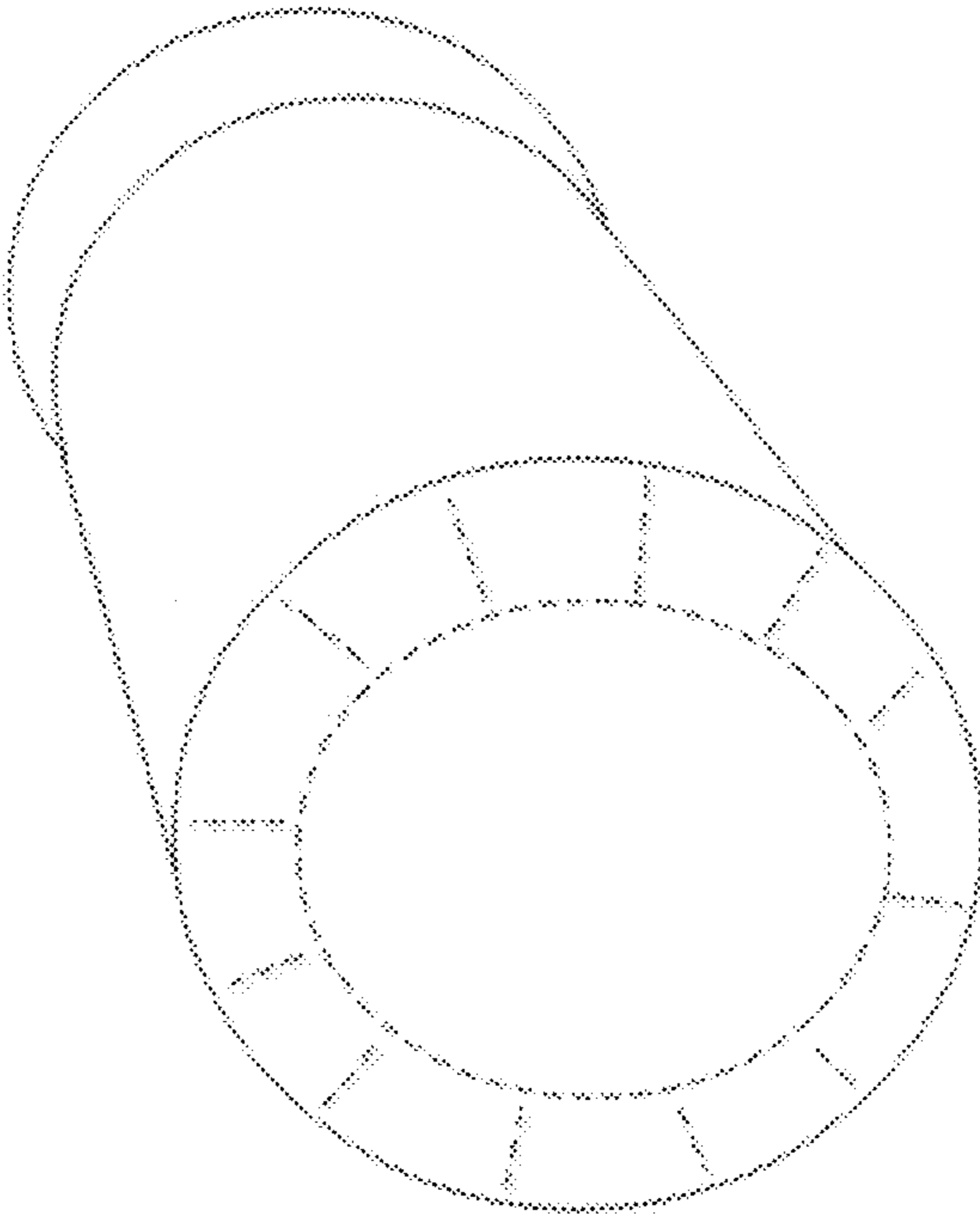

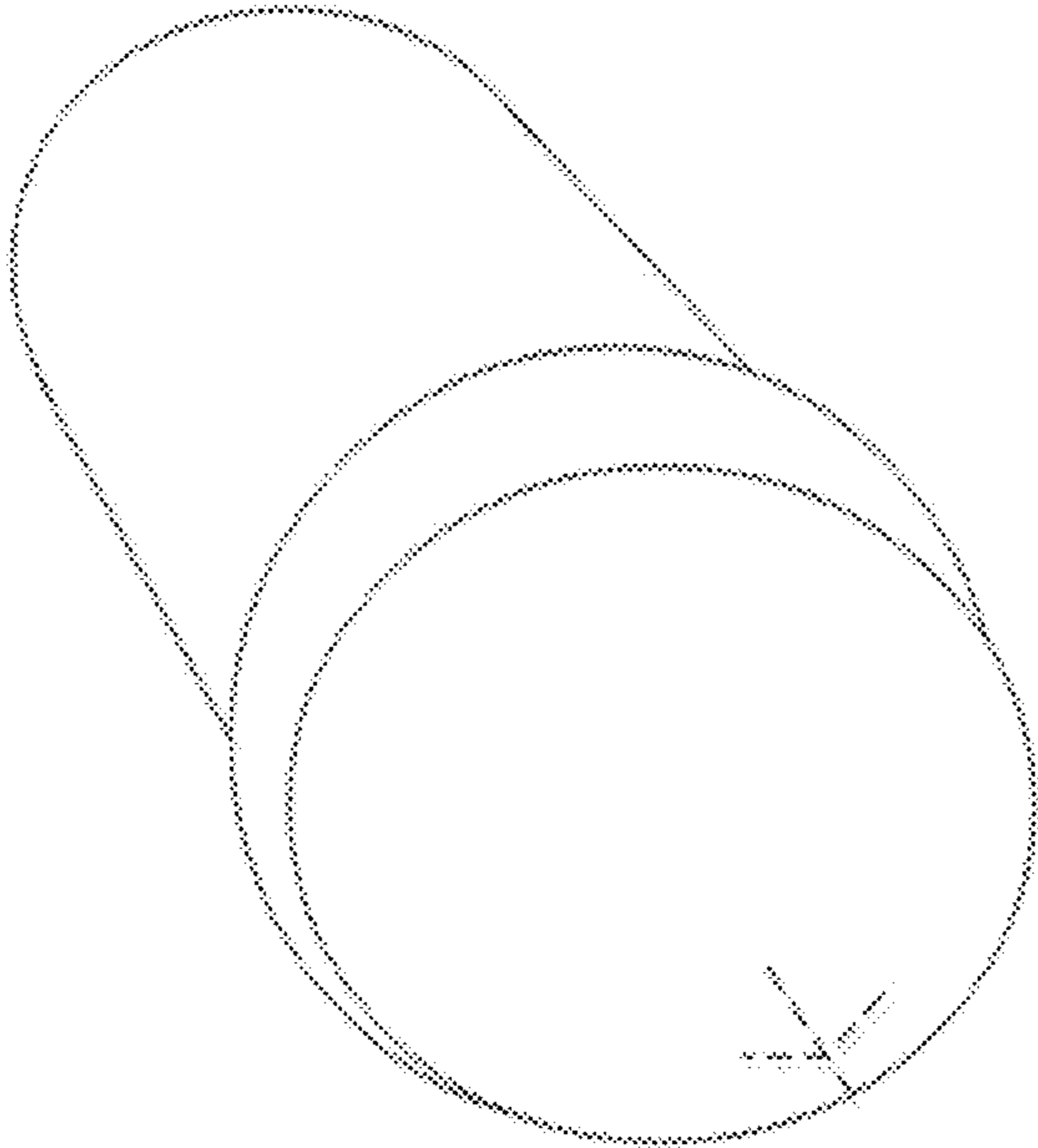
