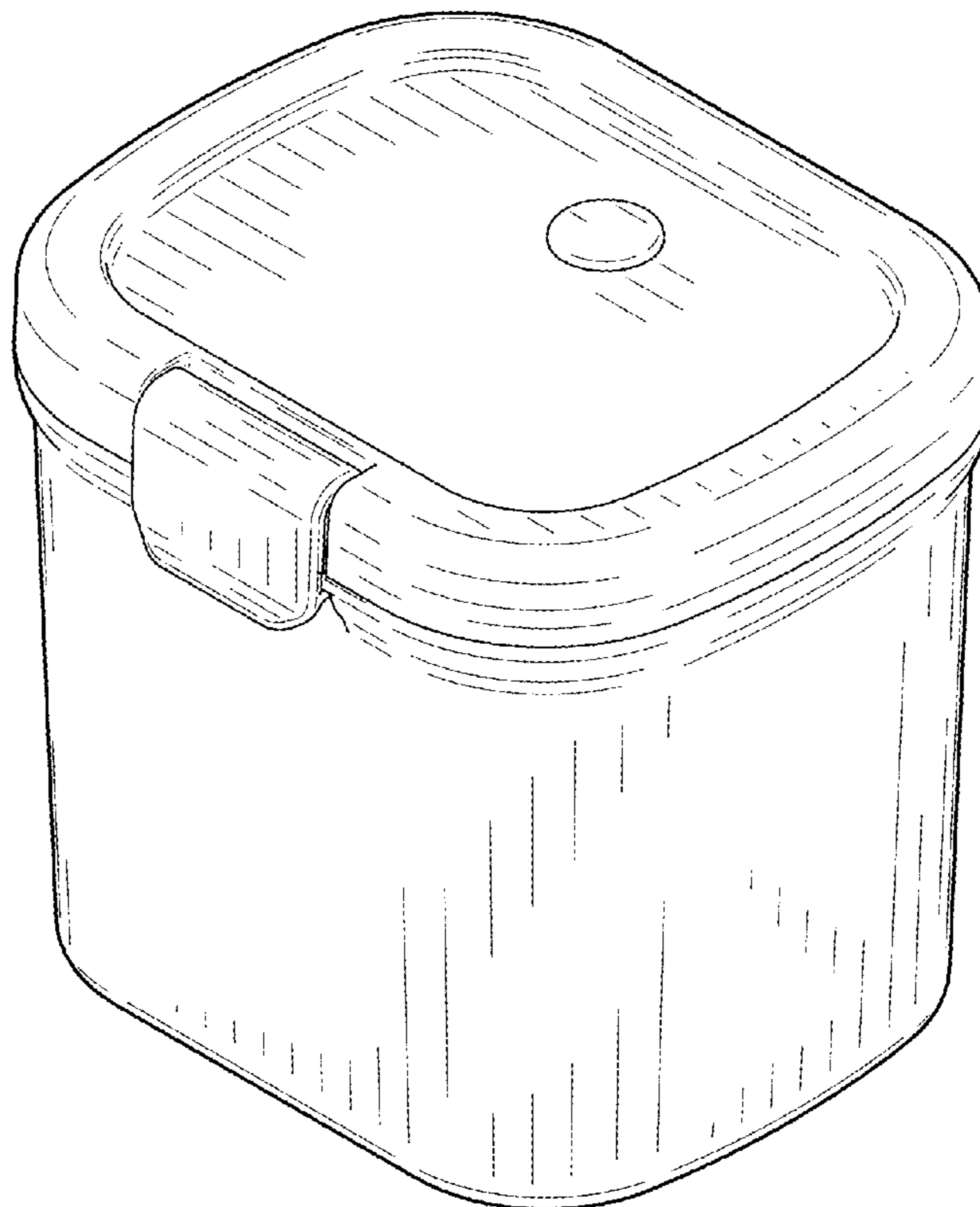
(57) **CLAIM**

I claim the ornamental design of a storage container, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the storage container, showing my new design.  
FIG. 2 is a front view of the storage container.  
FIG. 3 is a top view of the storage container.  
FIG. 4 is a front view of the storage container, shown with the lid in an open position.  
FIG. 5 is a right side view of the storage container, the left side view being a mirror image.  
FIG. 6 is a back view of the storage container; and,  
FIG. 7 is a bottom view of the storage container.

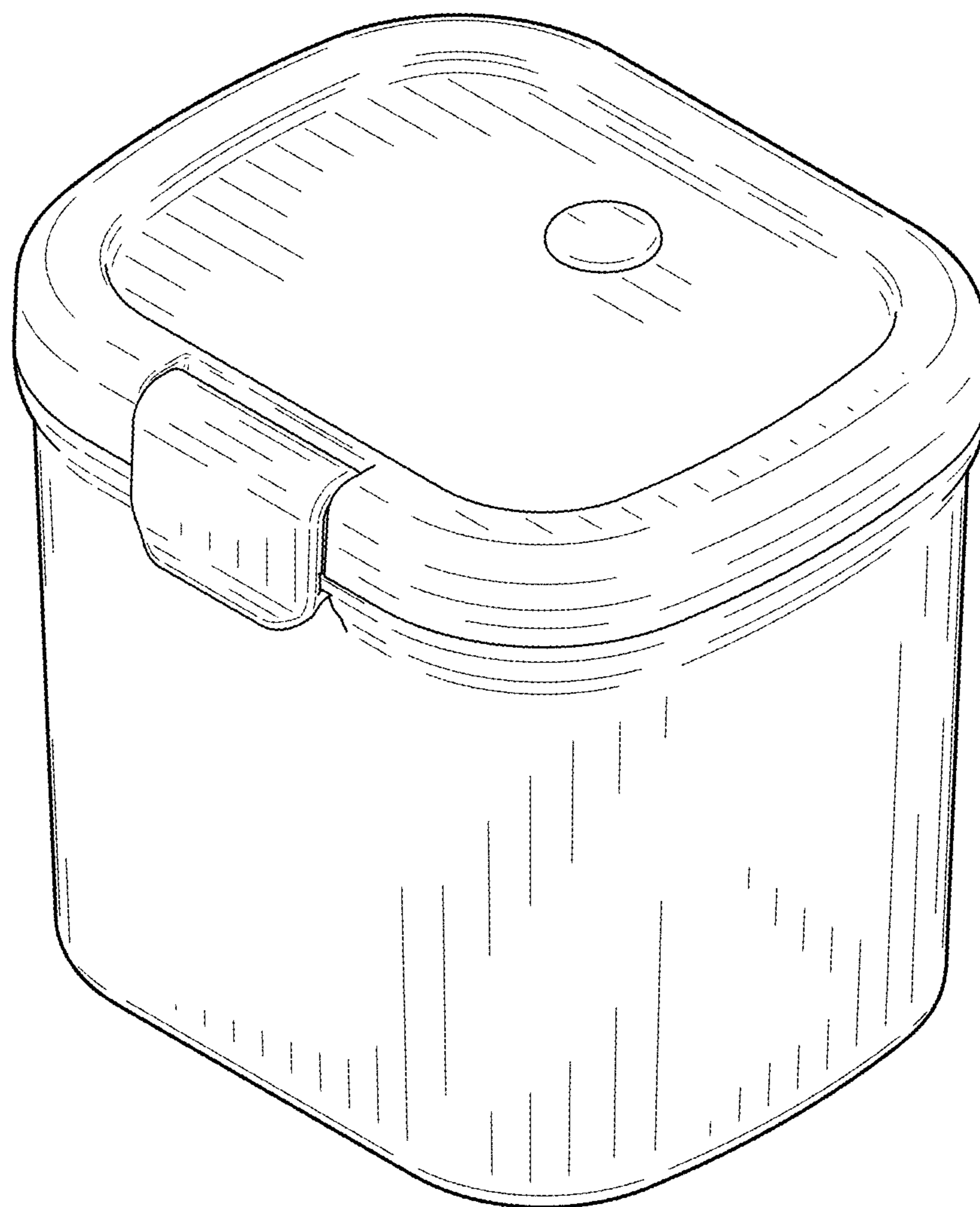

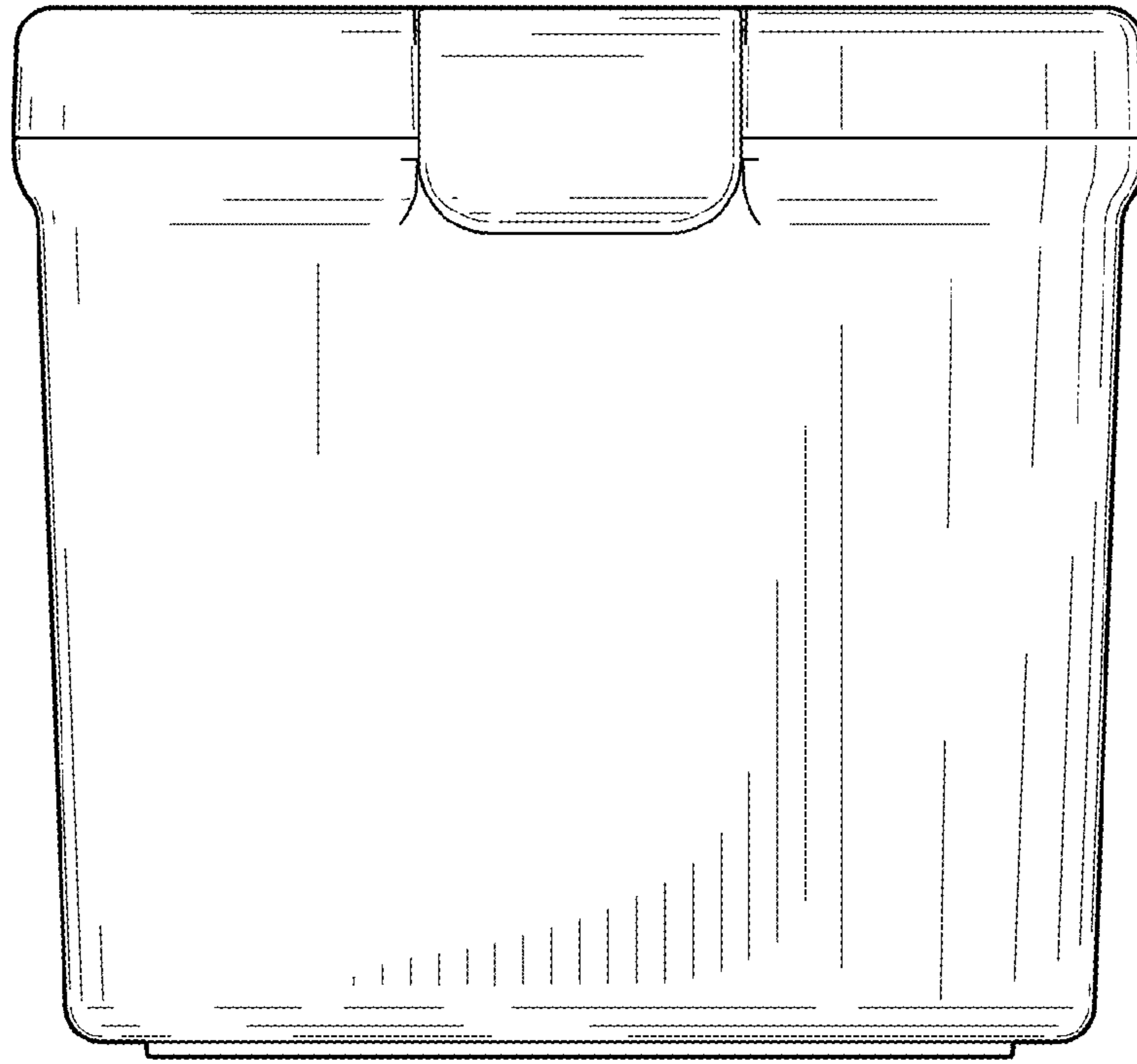

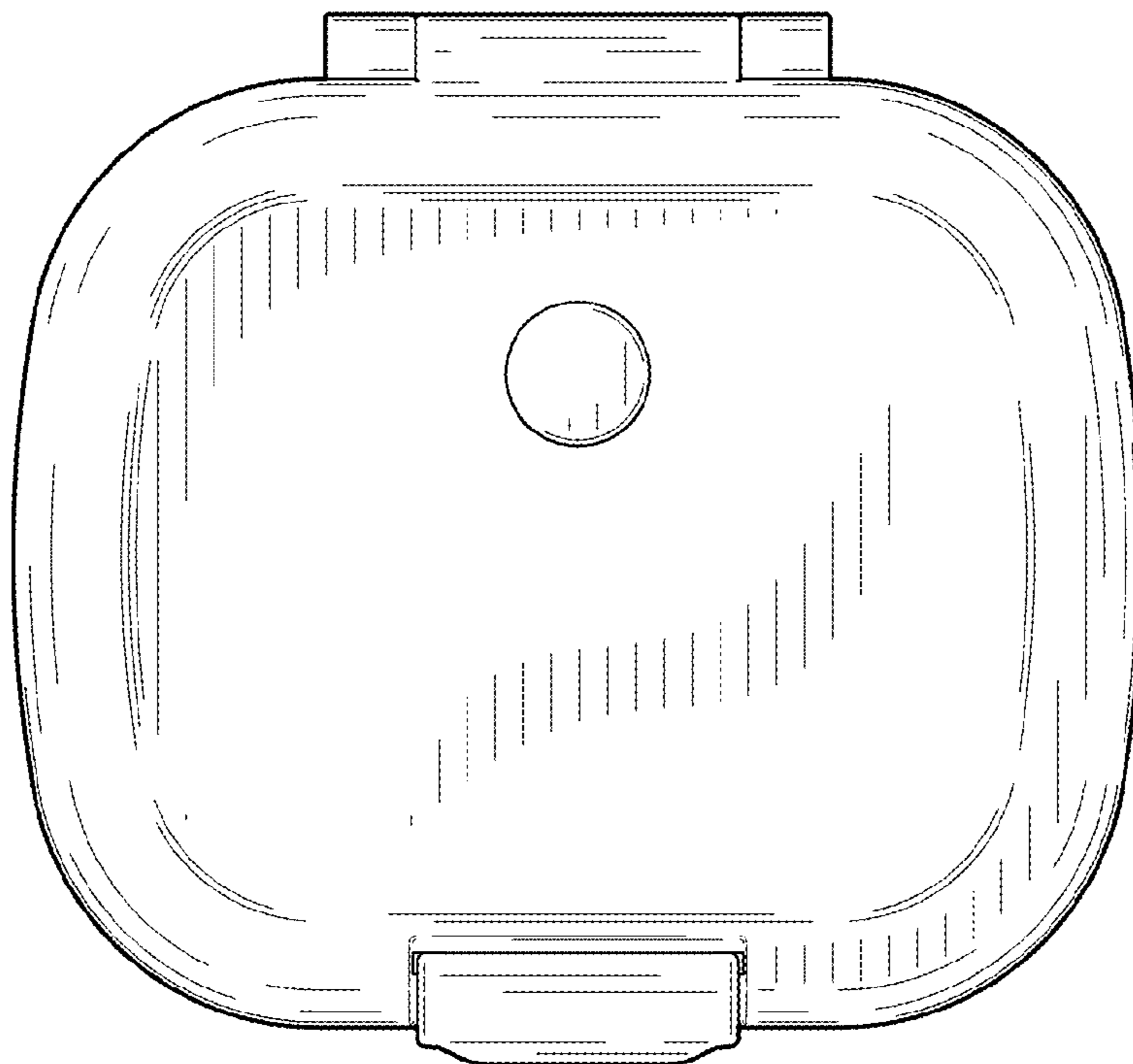

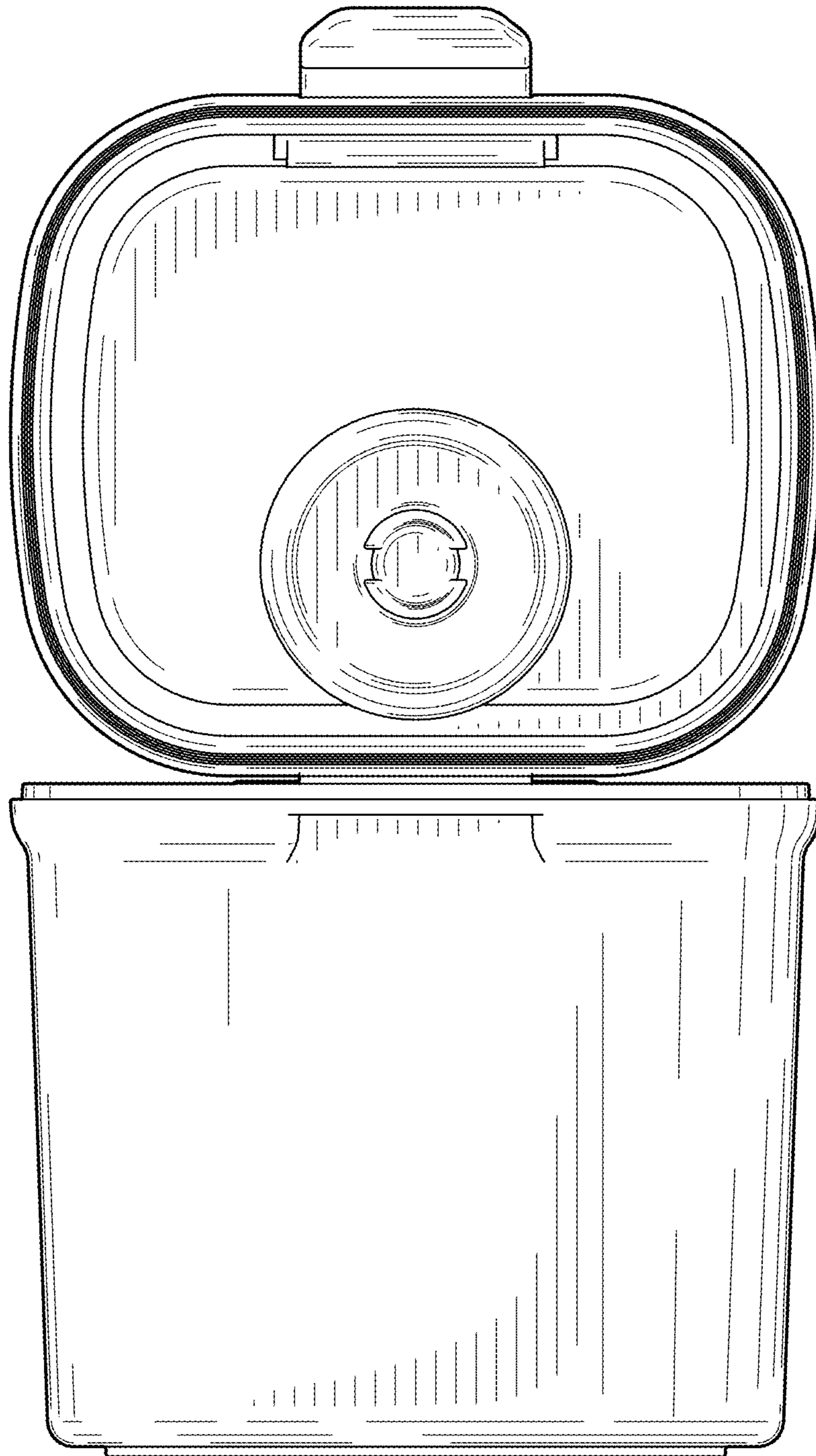

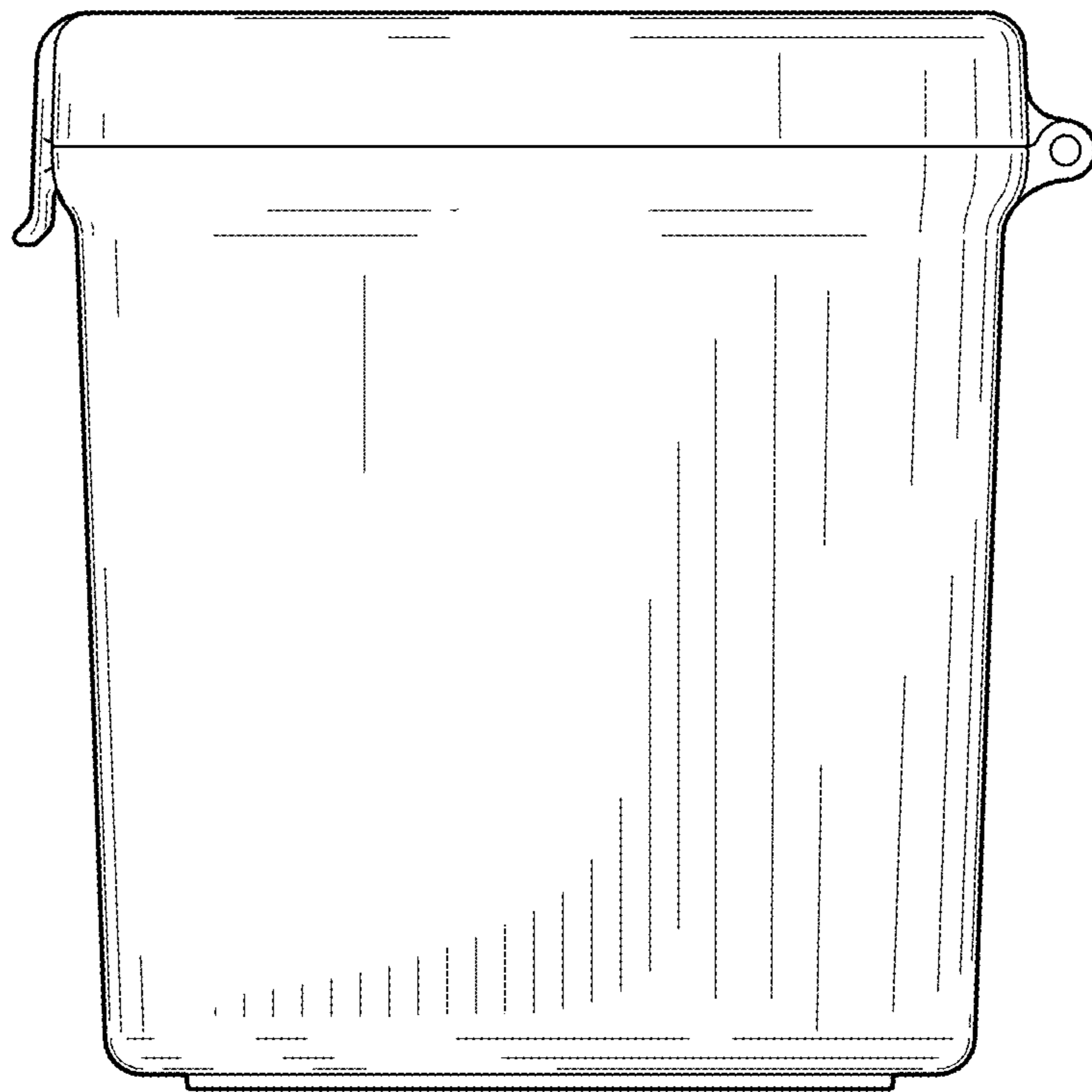

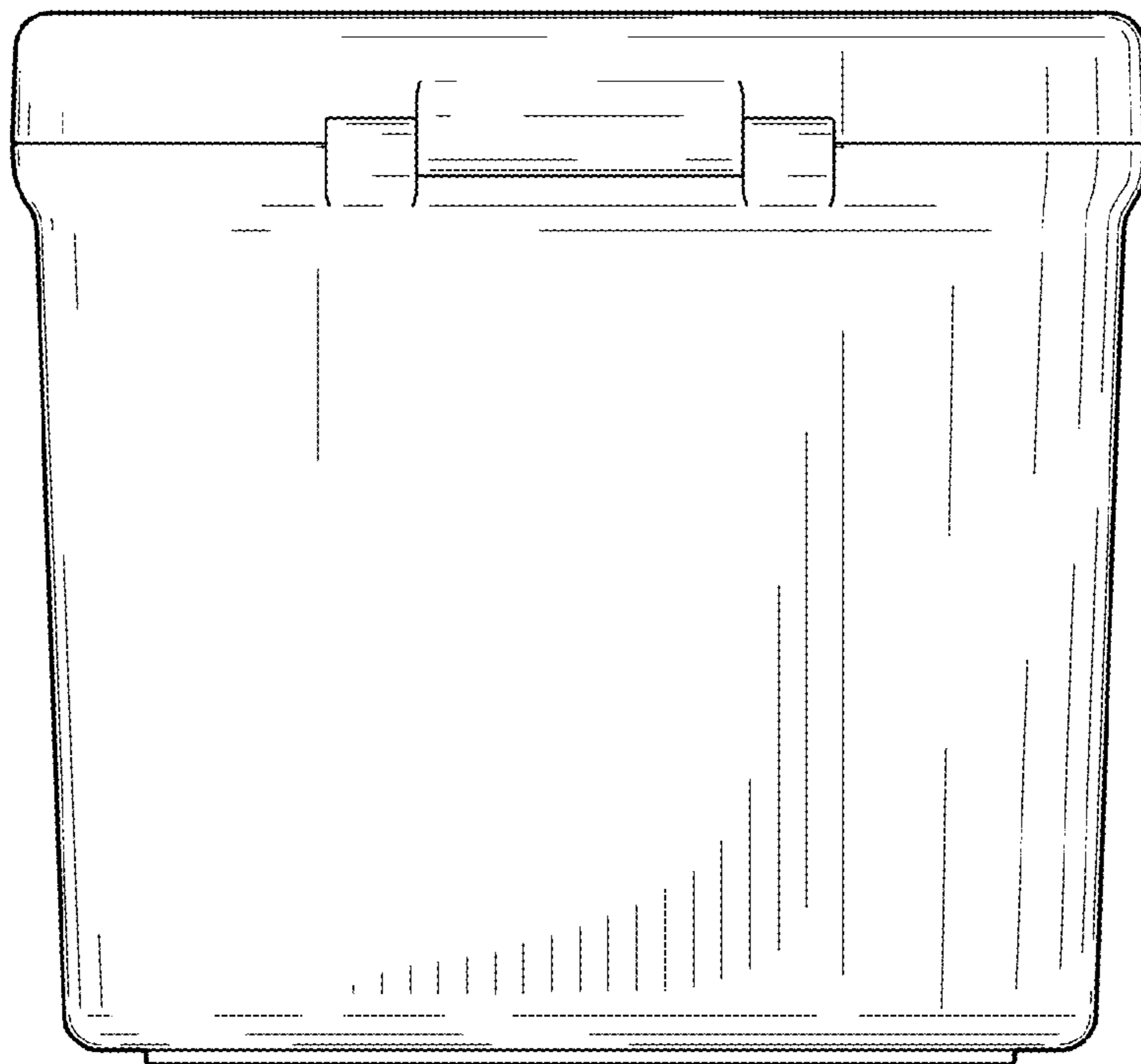

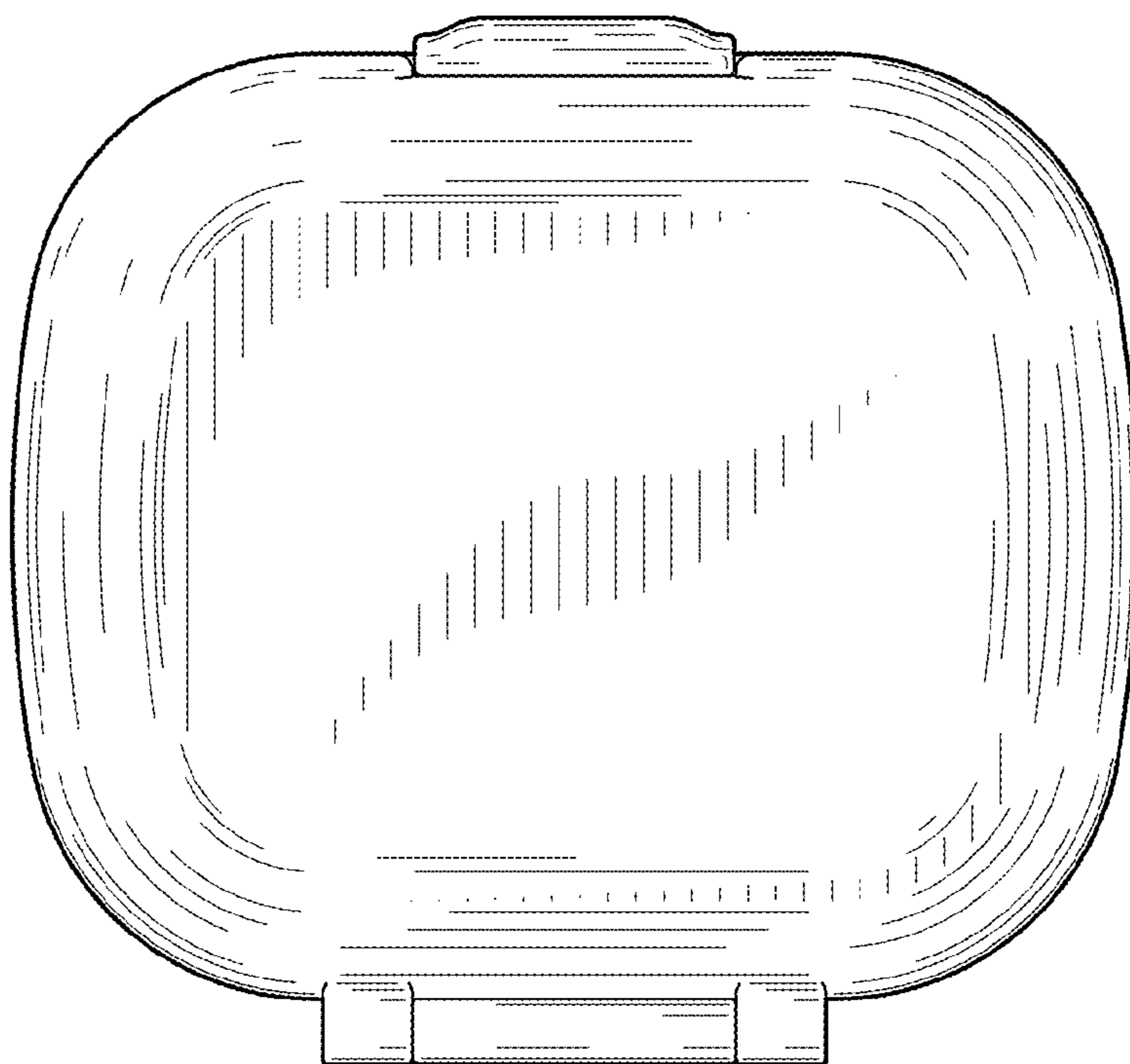
