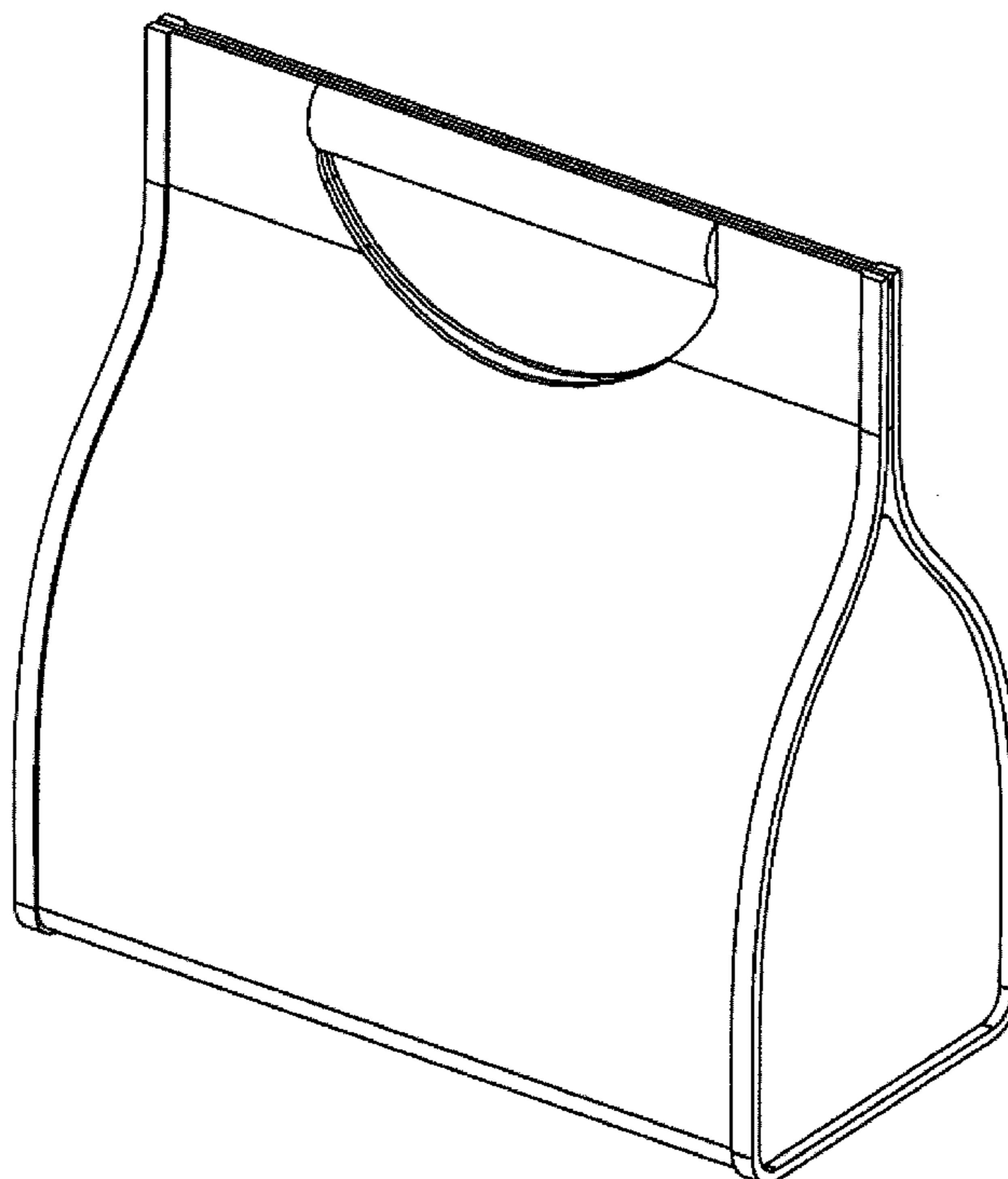
(57) **CLAIM**

The ornamental design of the lunch bag, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view taken from the upper, front, right-hand side of the lunch bag of the present invention; FIG. 2 is a perspective view taken from the lower, back, left-hand side of the lunch bag of FIG. 1; FIG. 3 is a side elevational view of the left side of the lunch bag of FIG. 1; FIG. 4 is a front elevational view of the lunch bag of FIG. 1; FIG. 5 is a side elevational view of the right side of the lunch bag of FIG. 1; FIG. 6 is a rear elevational view of the lunch bag of FIG. 1; FIG. 7 is a top plan view of the lunch bag of FIG. 1; and, FIG. 8 is a bottom plan view of the lunch bag of FIG. 1.

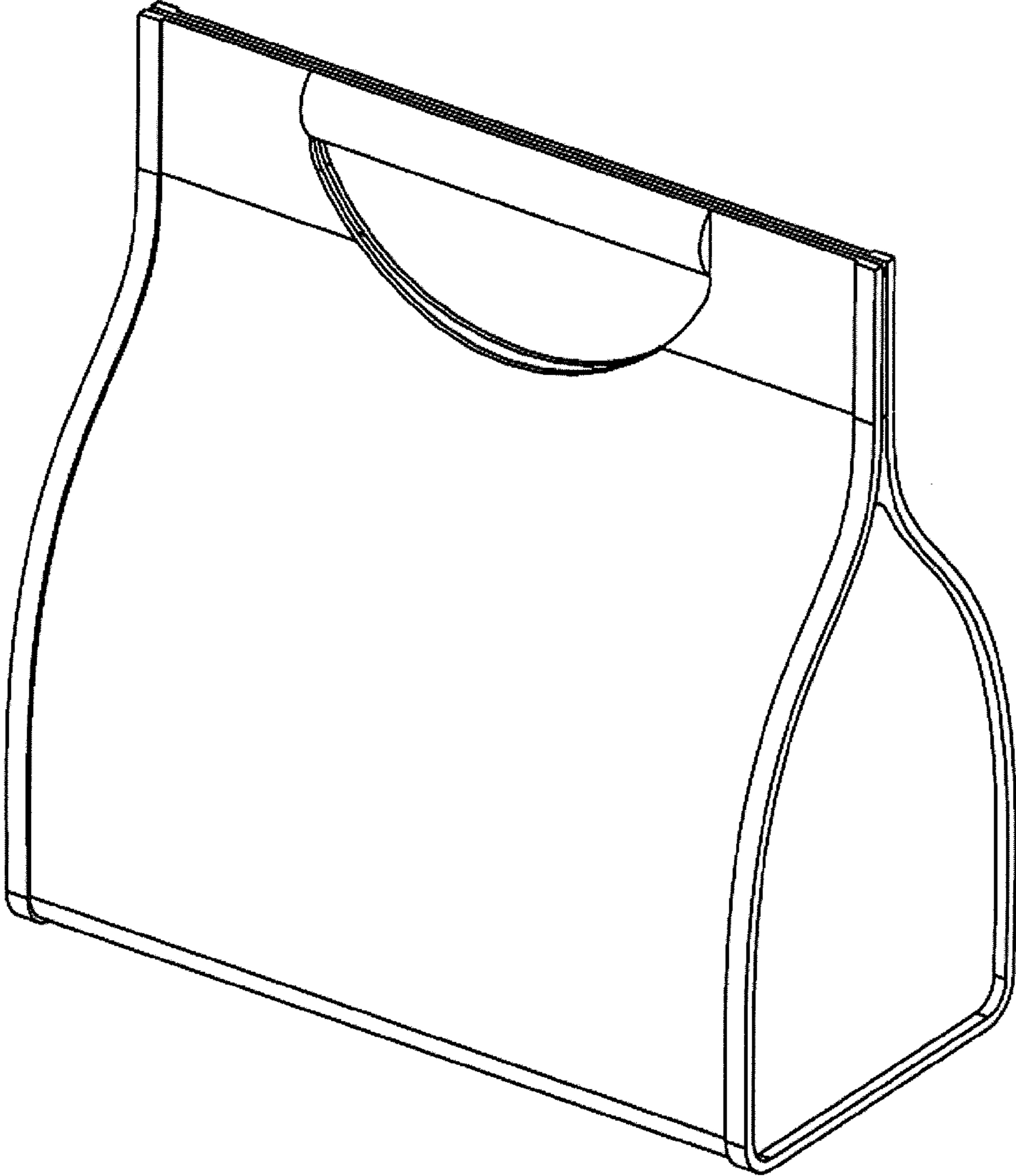

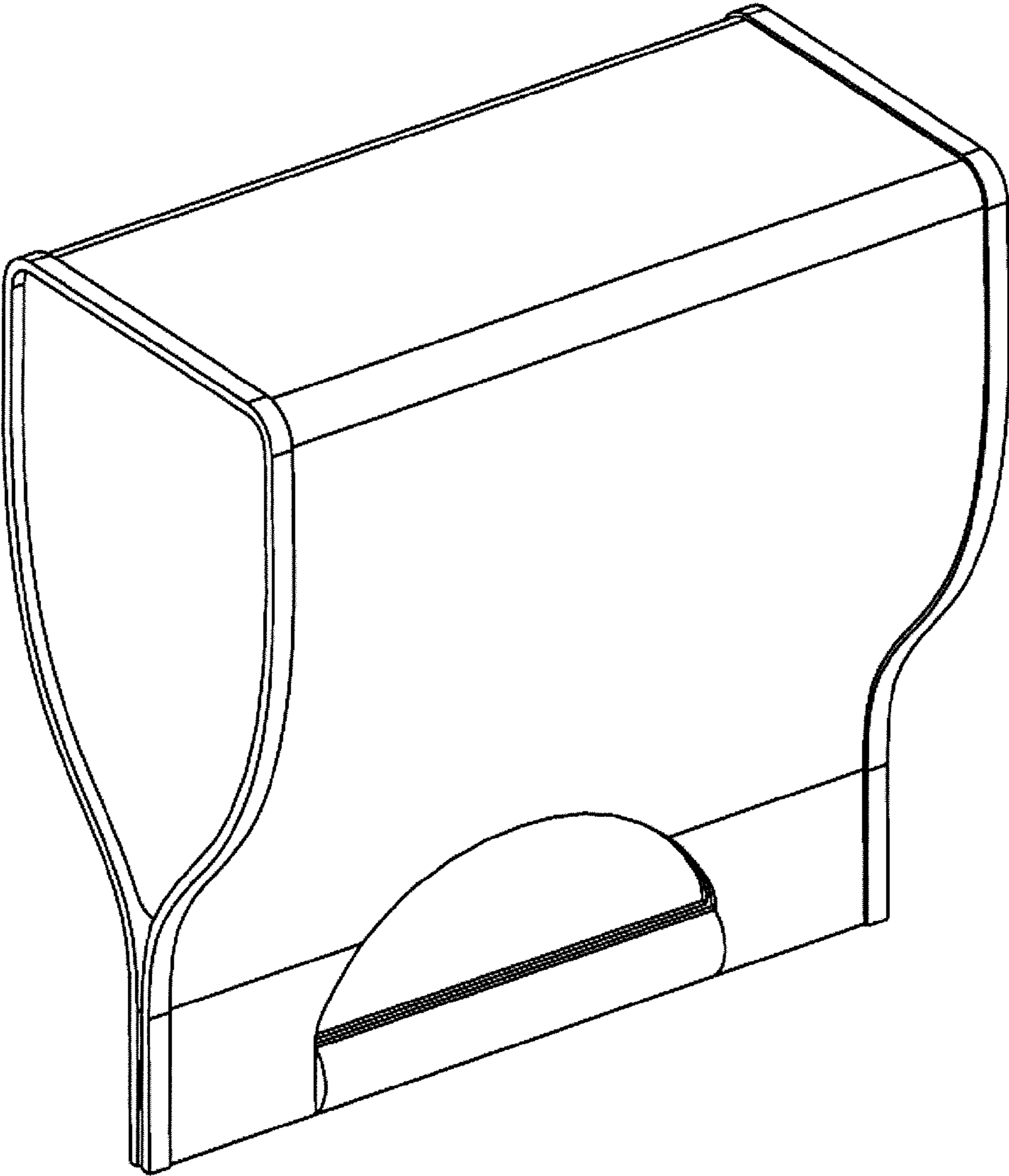

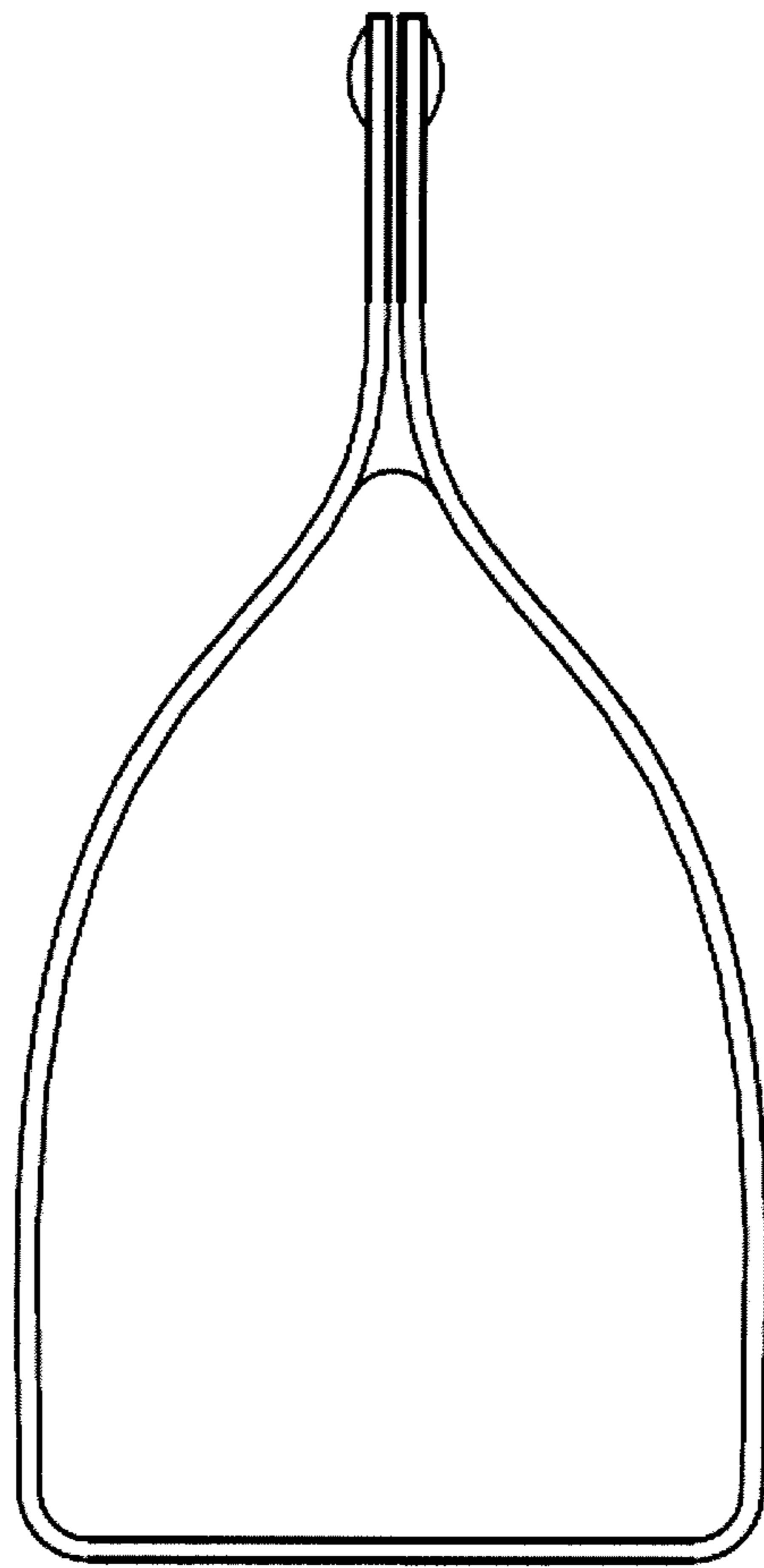

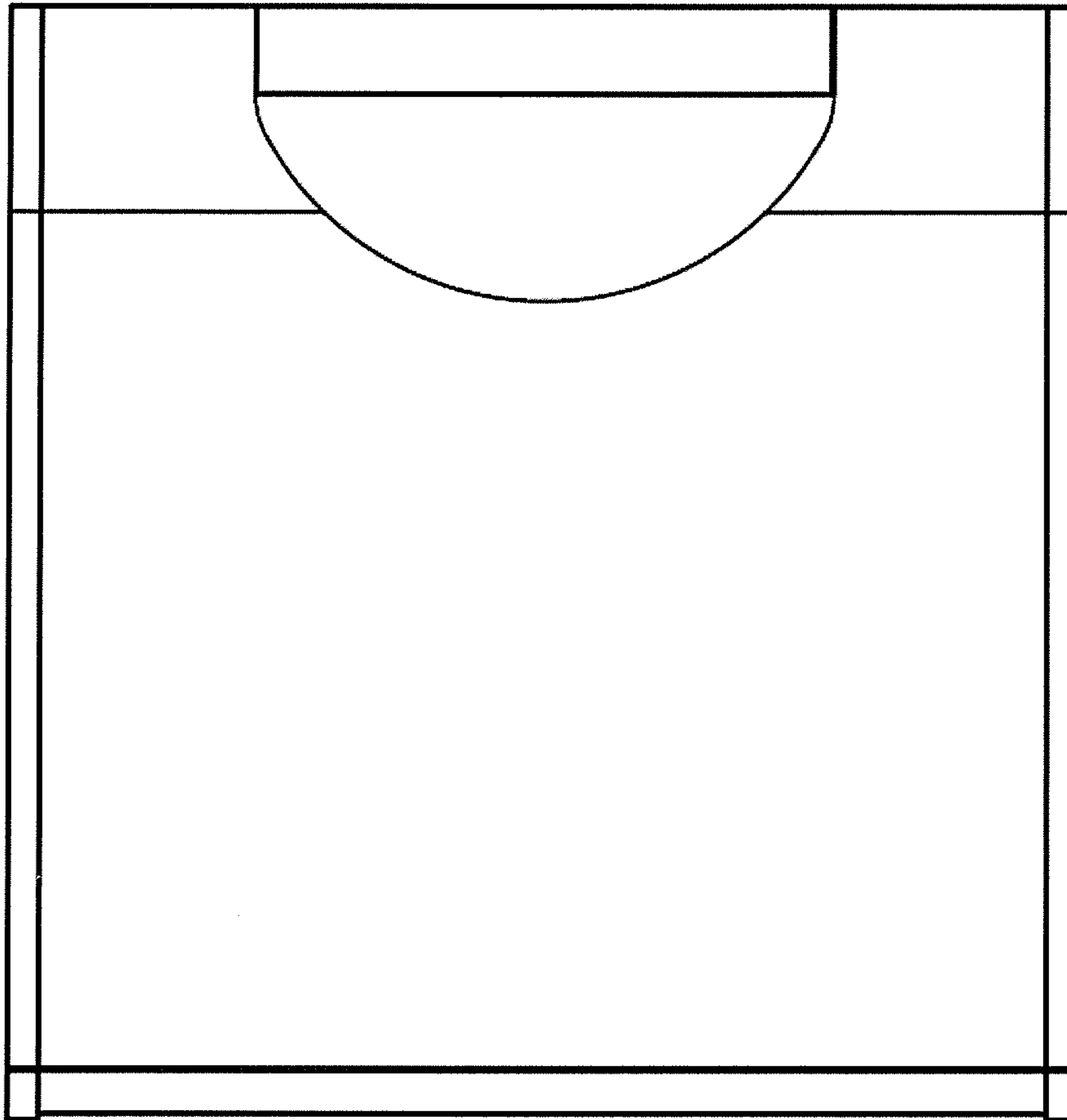

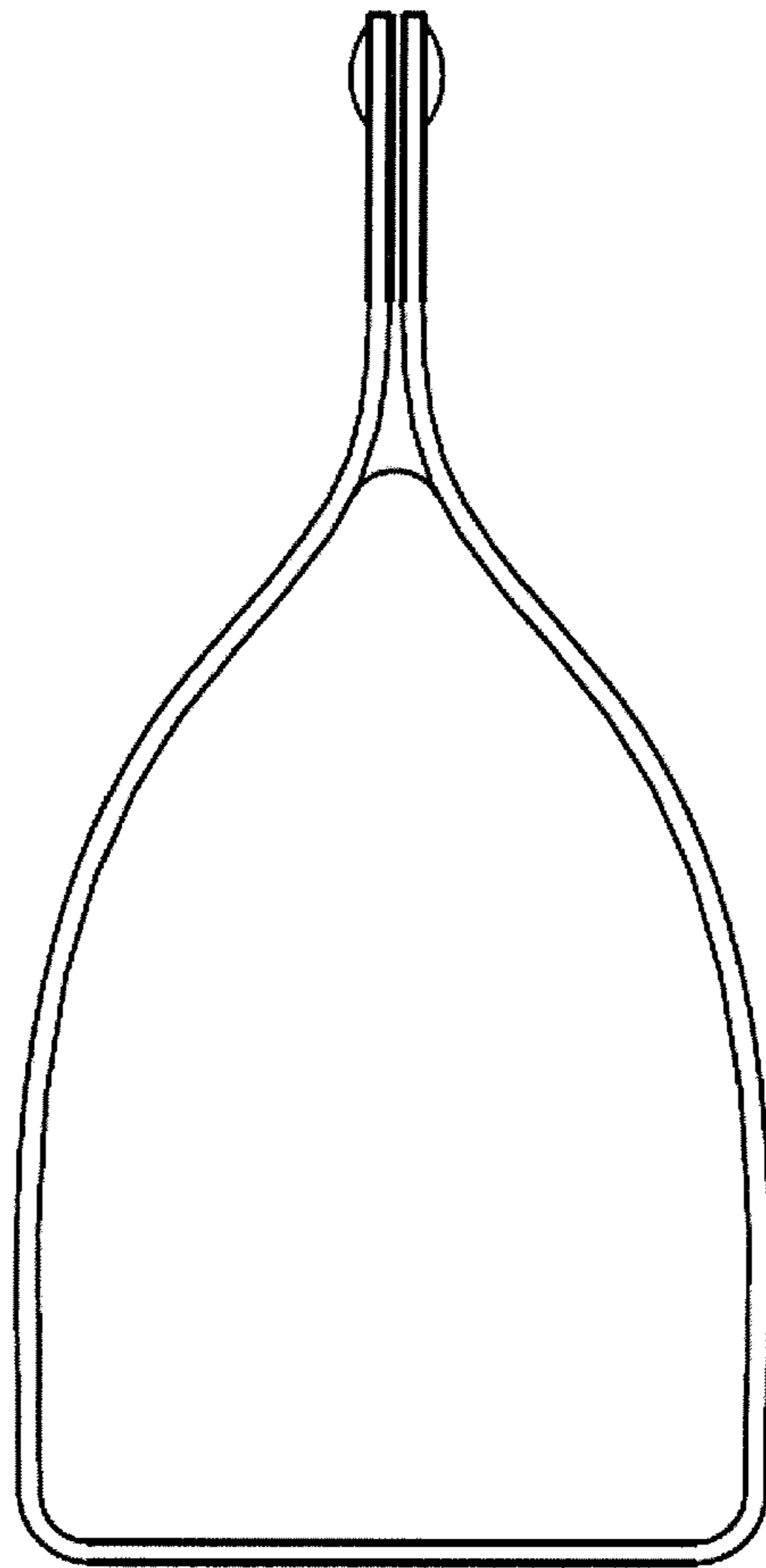

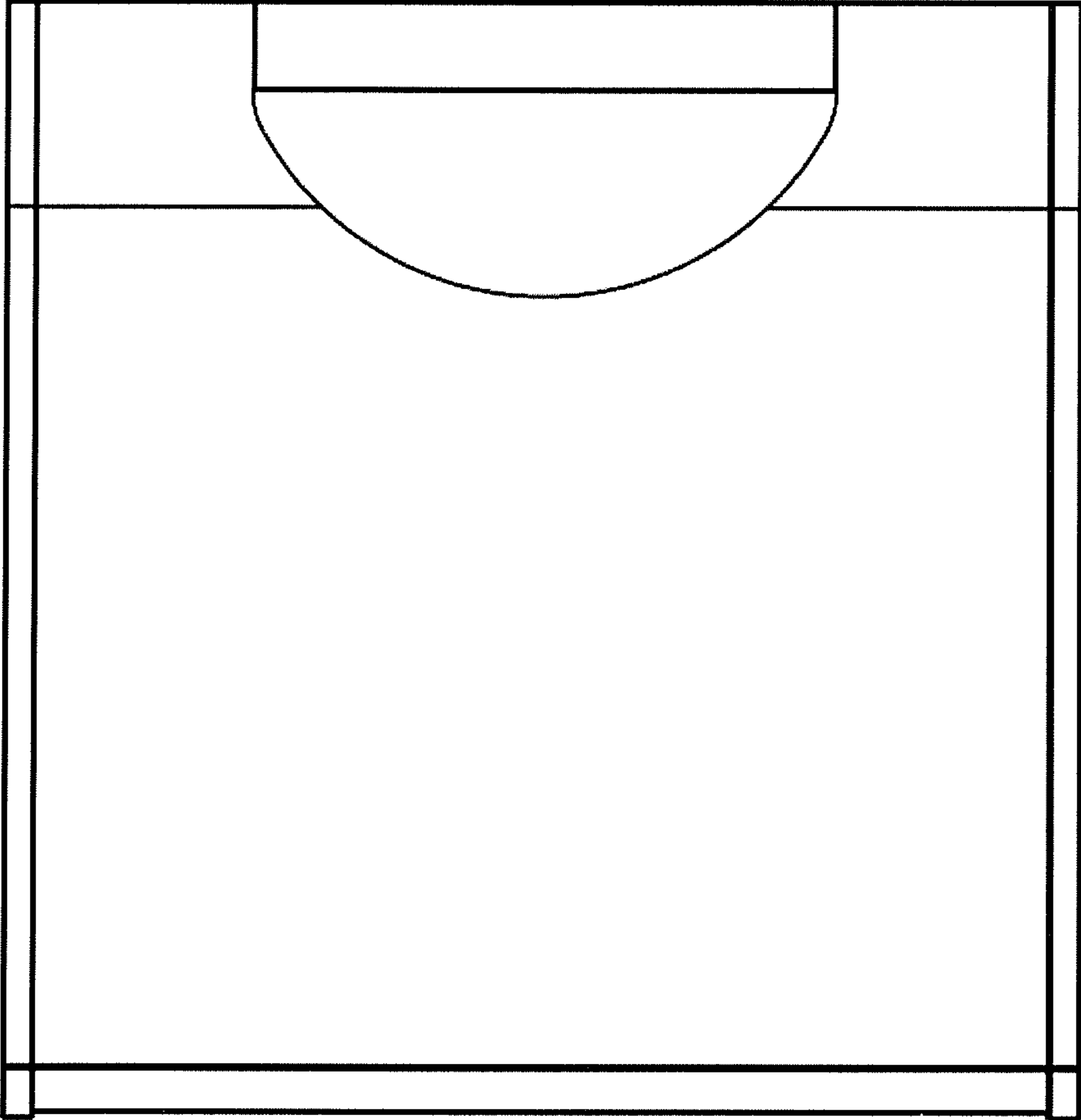

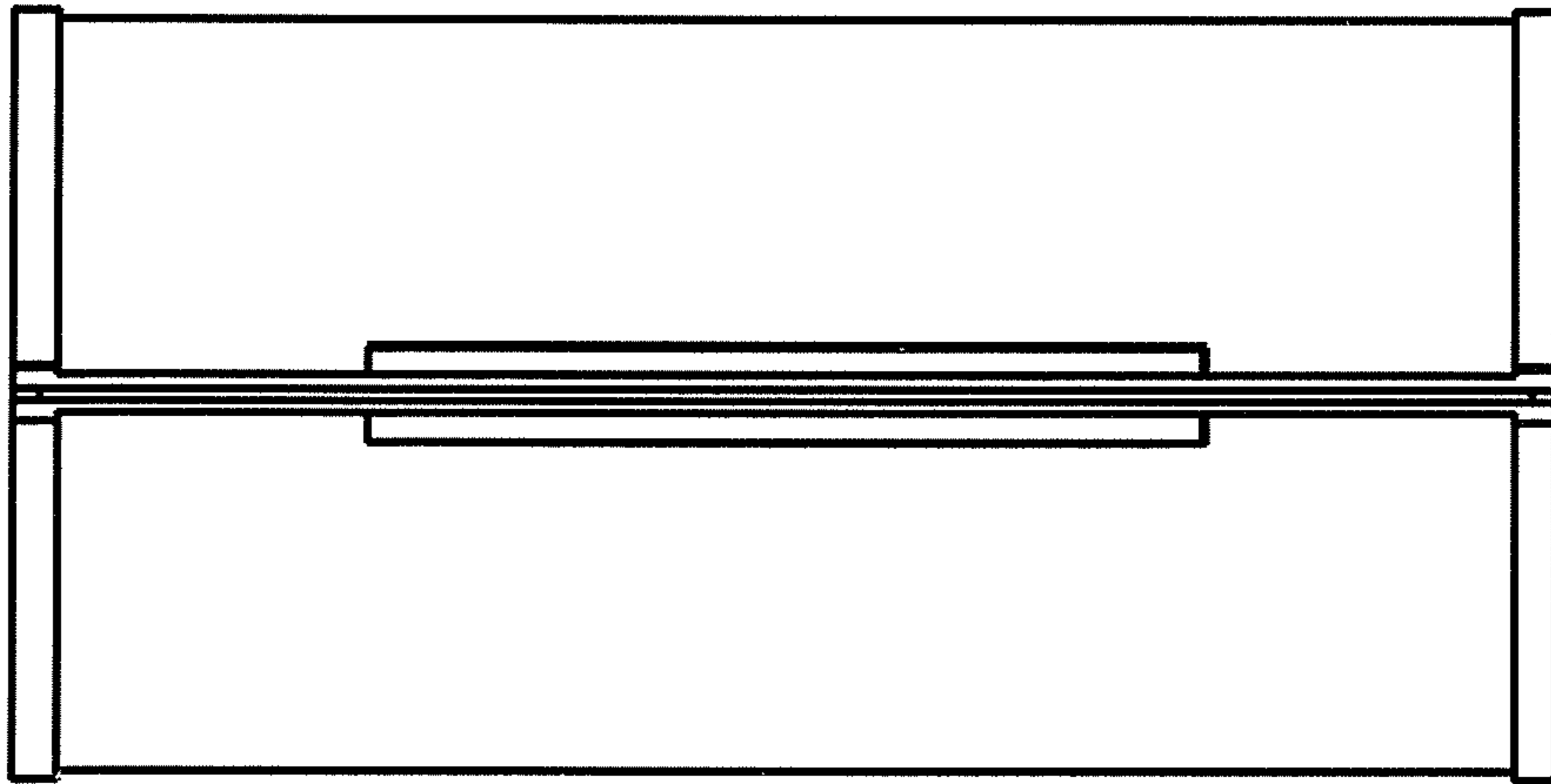

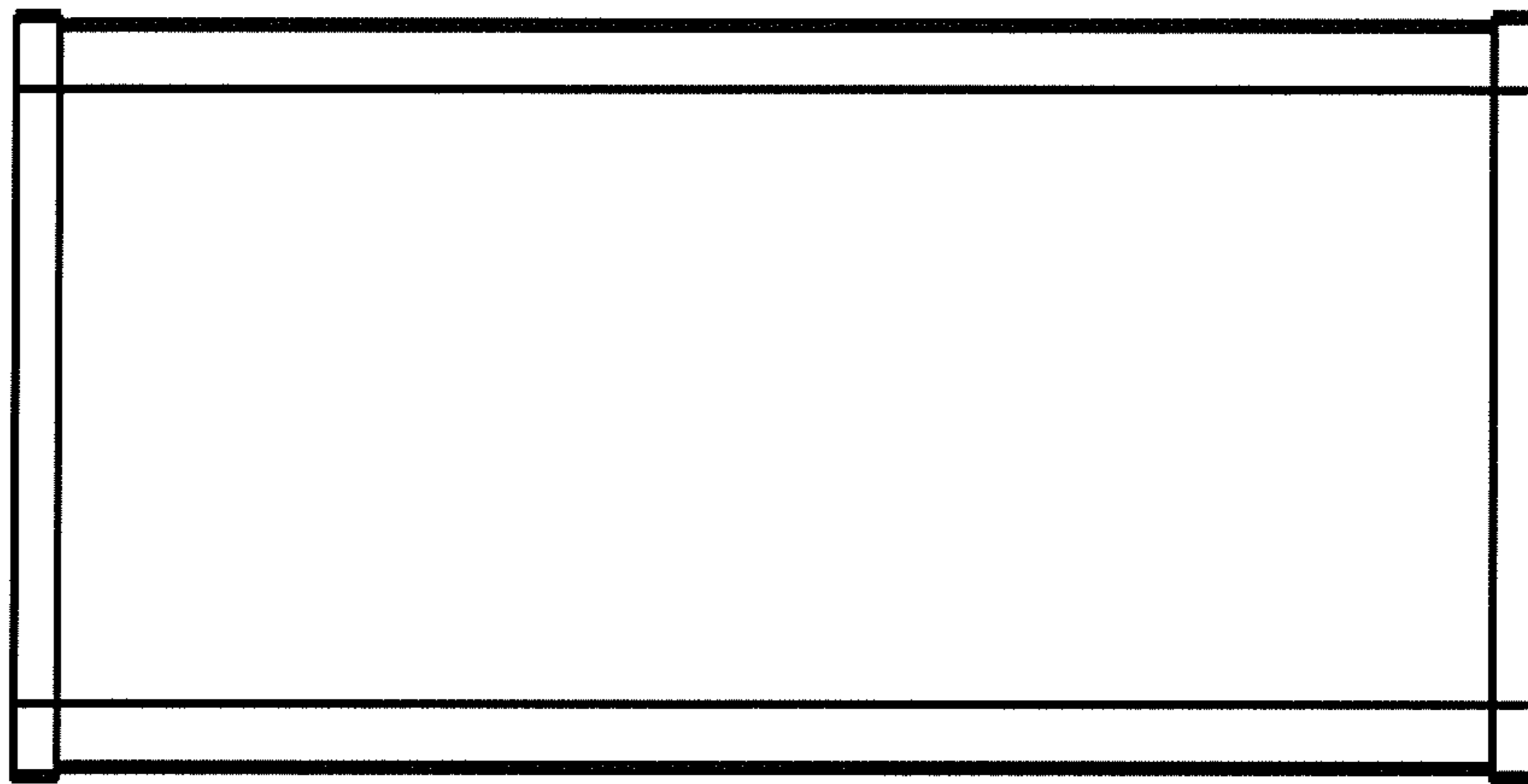
