FIG. 3 is a back view thereof;

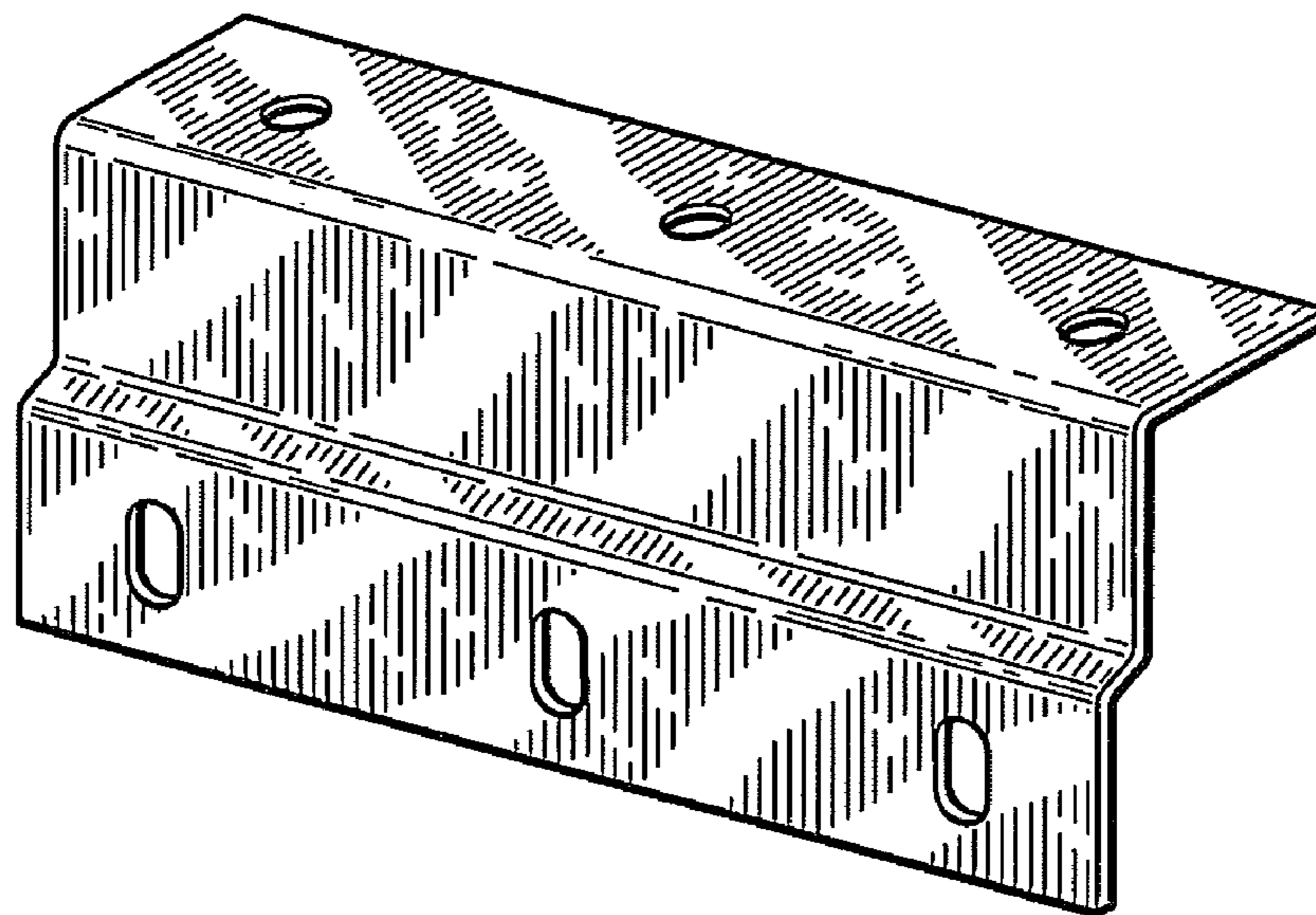
FIG. 4 is a top plan view thereof;

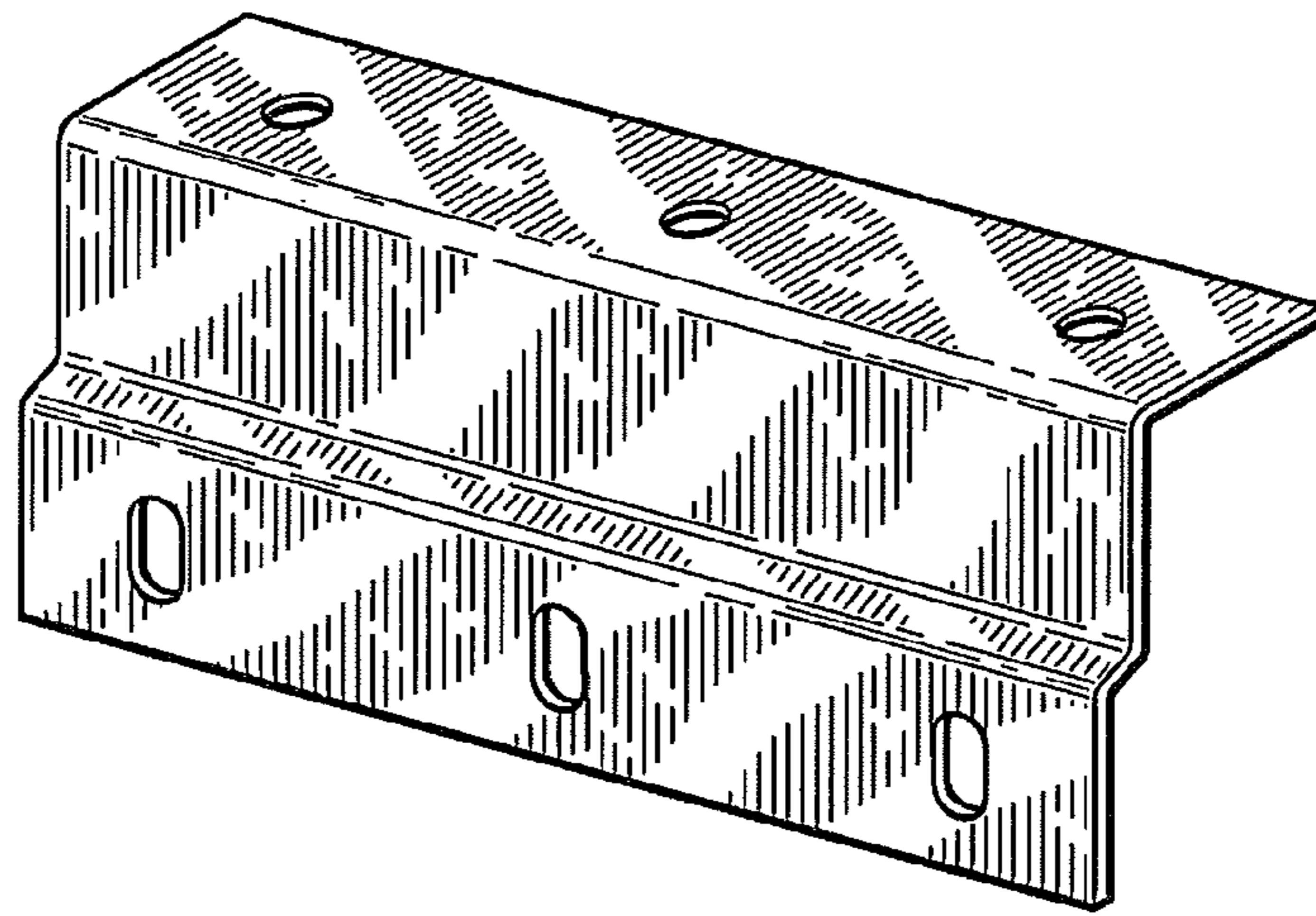

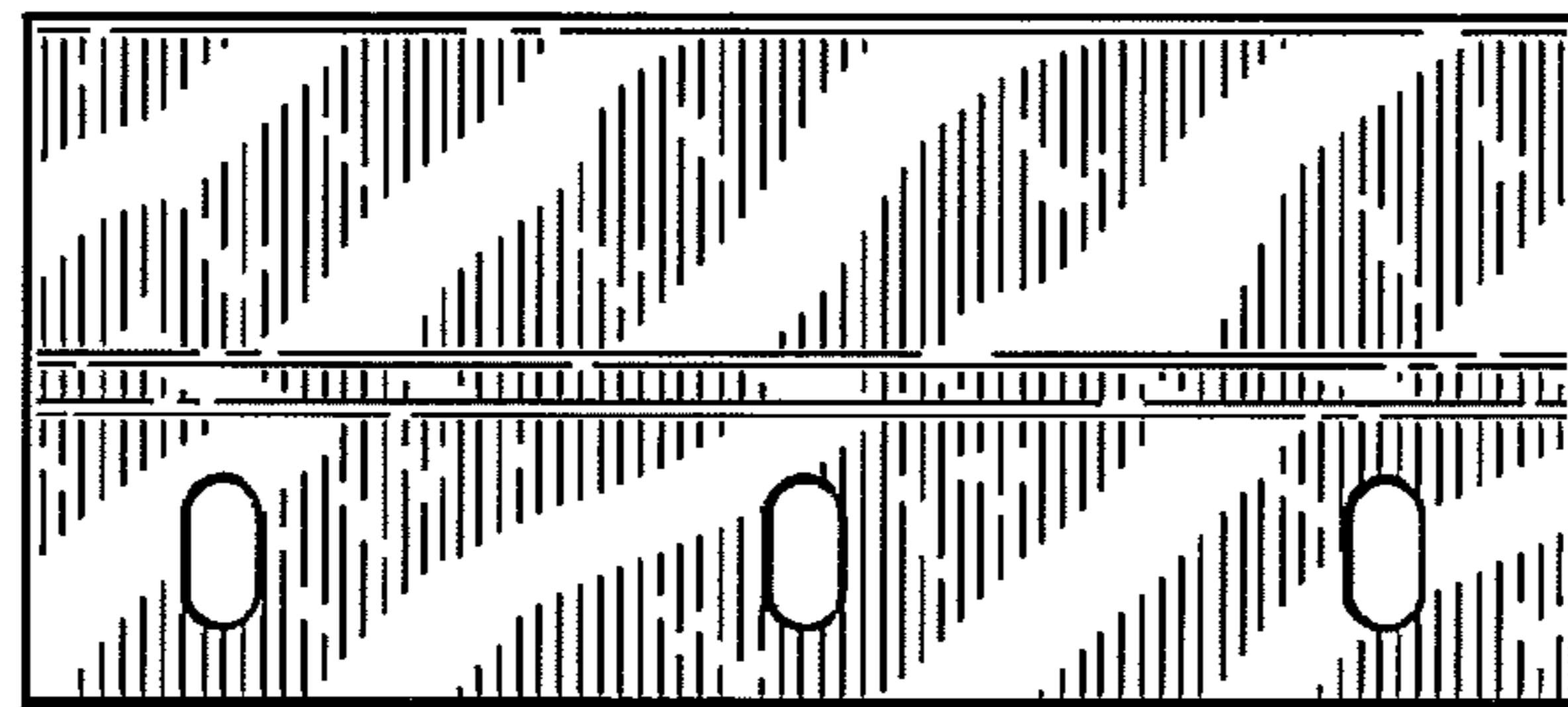

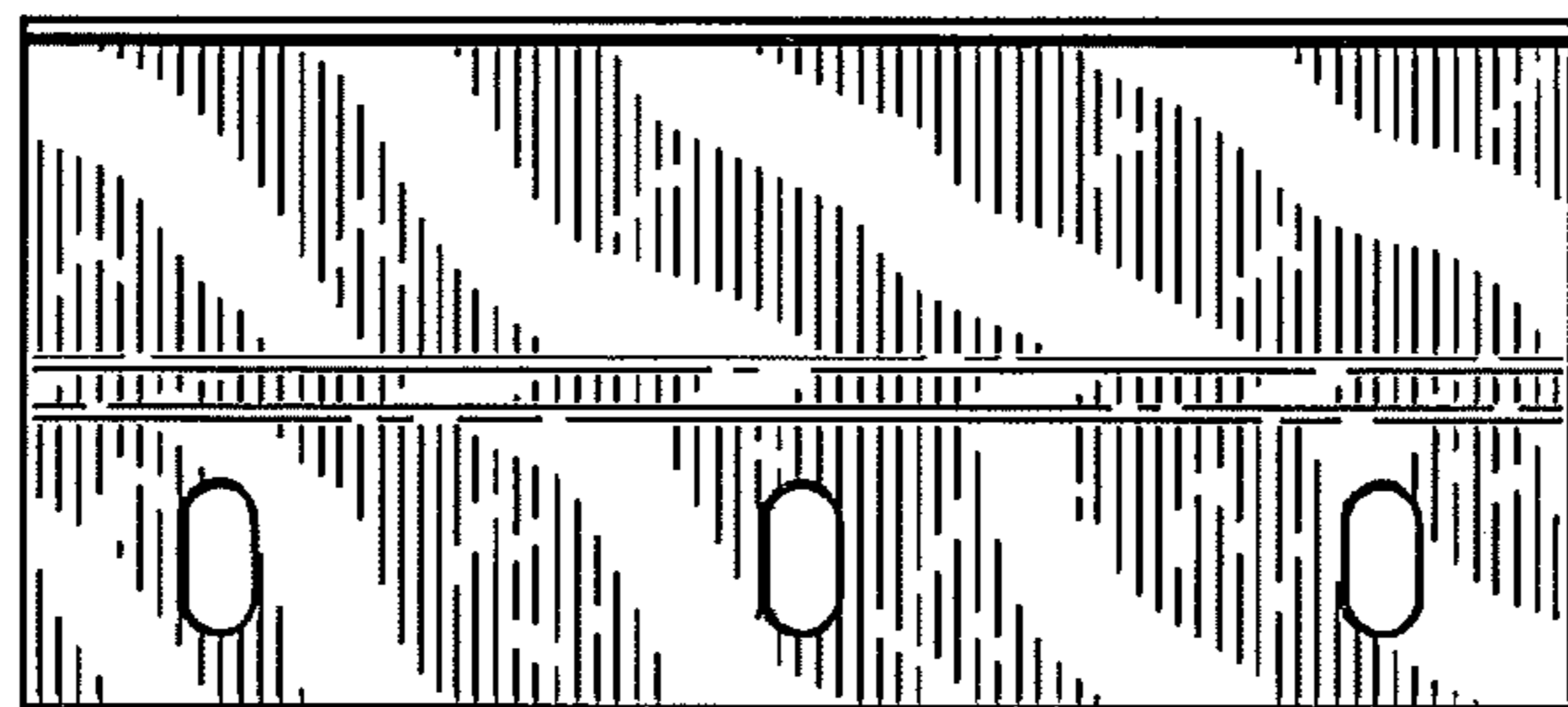

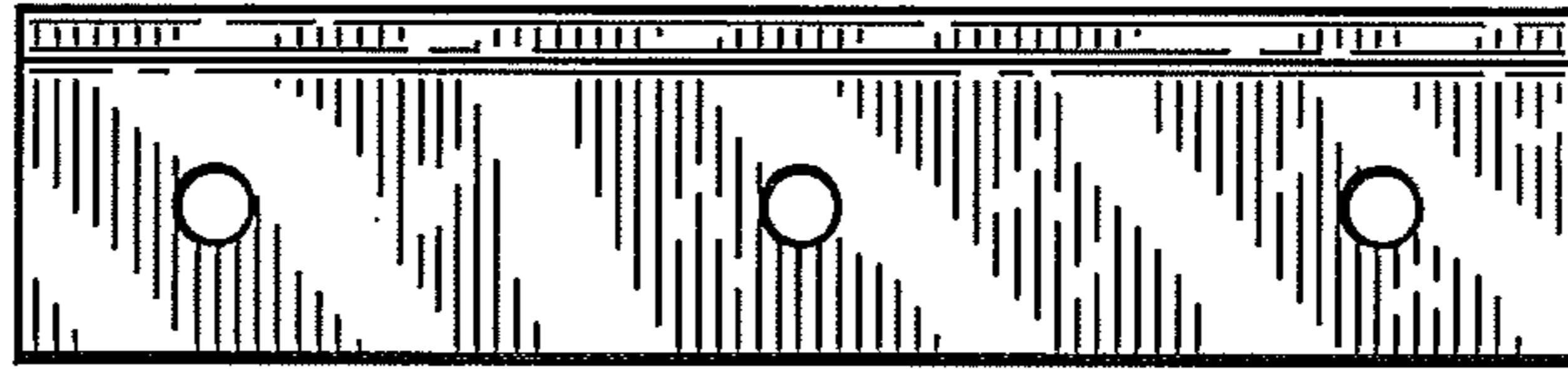

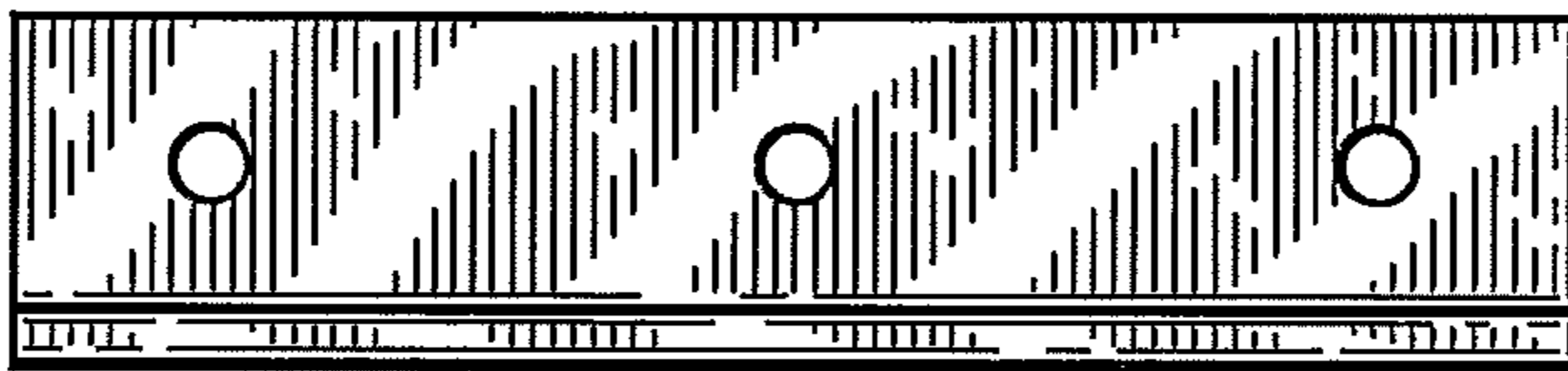

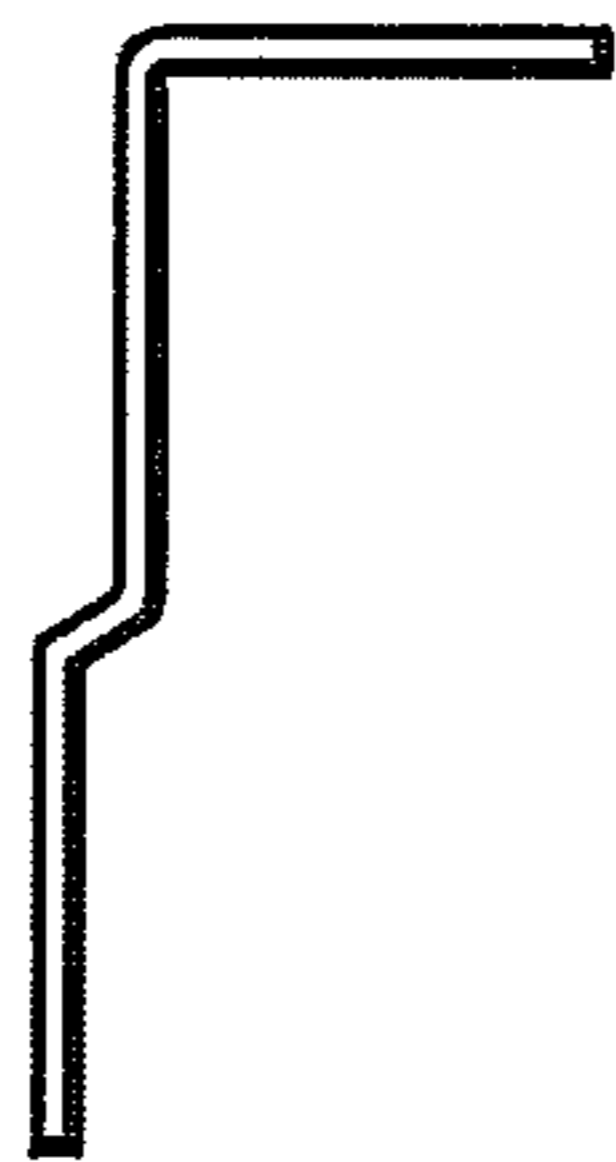

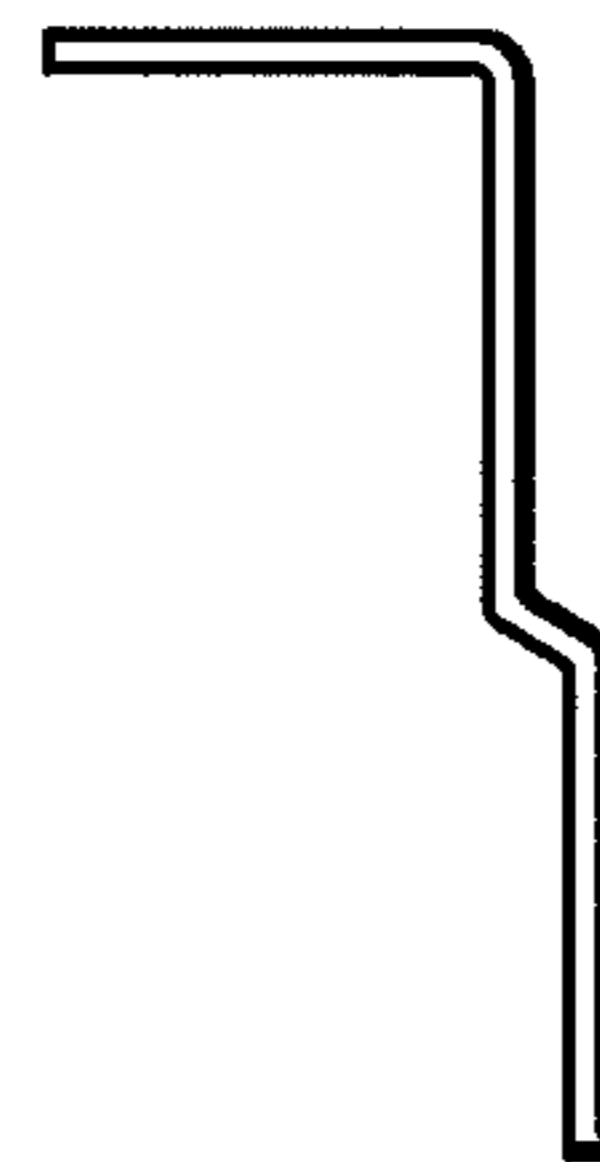
