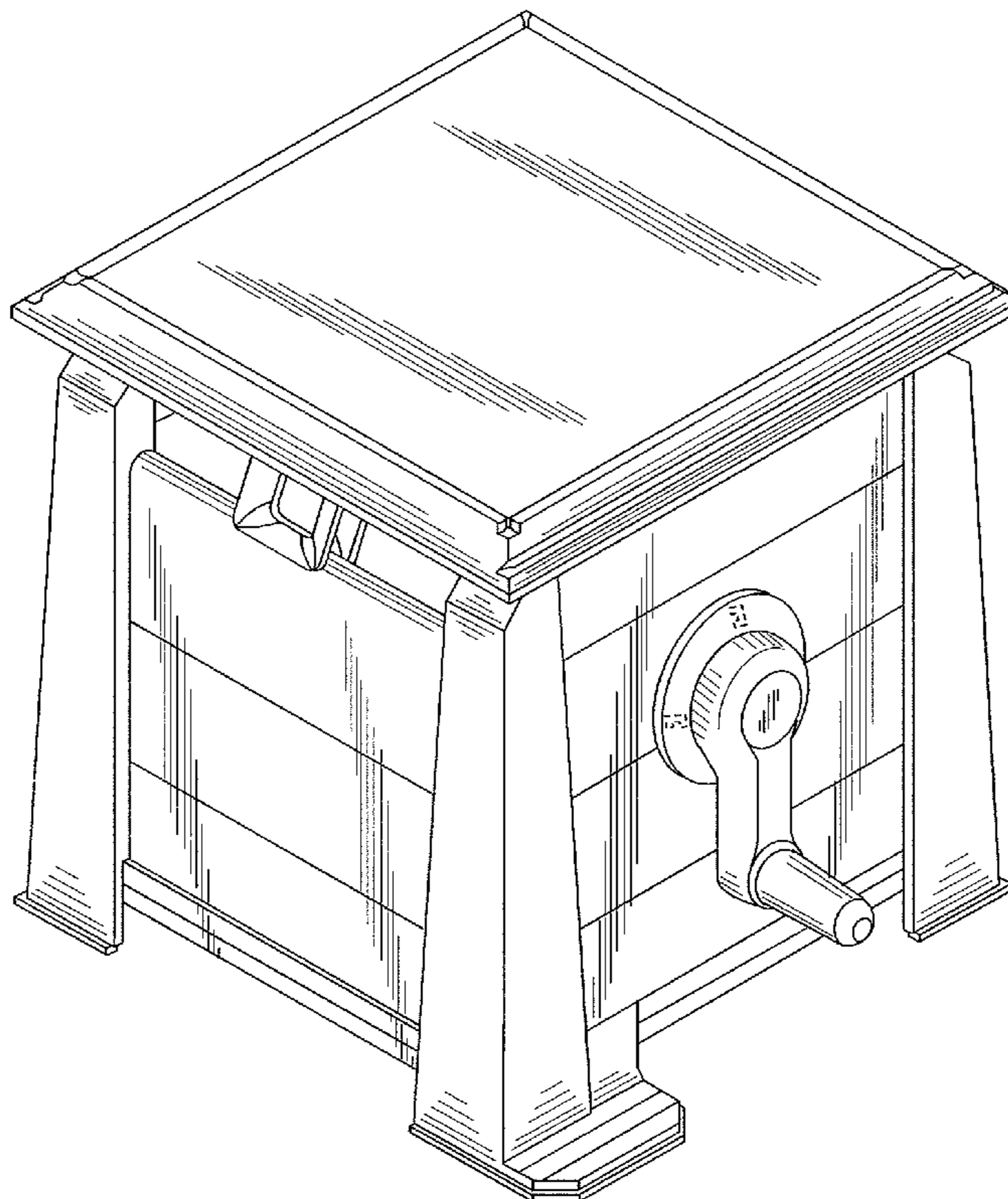
(57) **CLAIM**

DESCRIPTION

FIG. 1 is an isometric view of the hose reel deck box; FIG. 2 is a front side view of the hose reel deck box; FIG. 3 is a back side view of the hose reel deck box; FIG. 4 is a top view of the hose reel deck box; FIG. 5 is a bottom view of the hose reel deck box; FIG. 6 is a right side view of the hose reel deck box; and, FIG. 7 is a left side view of the hose reel deck box. 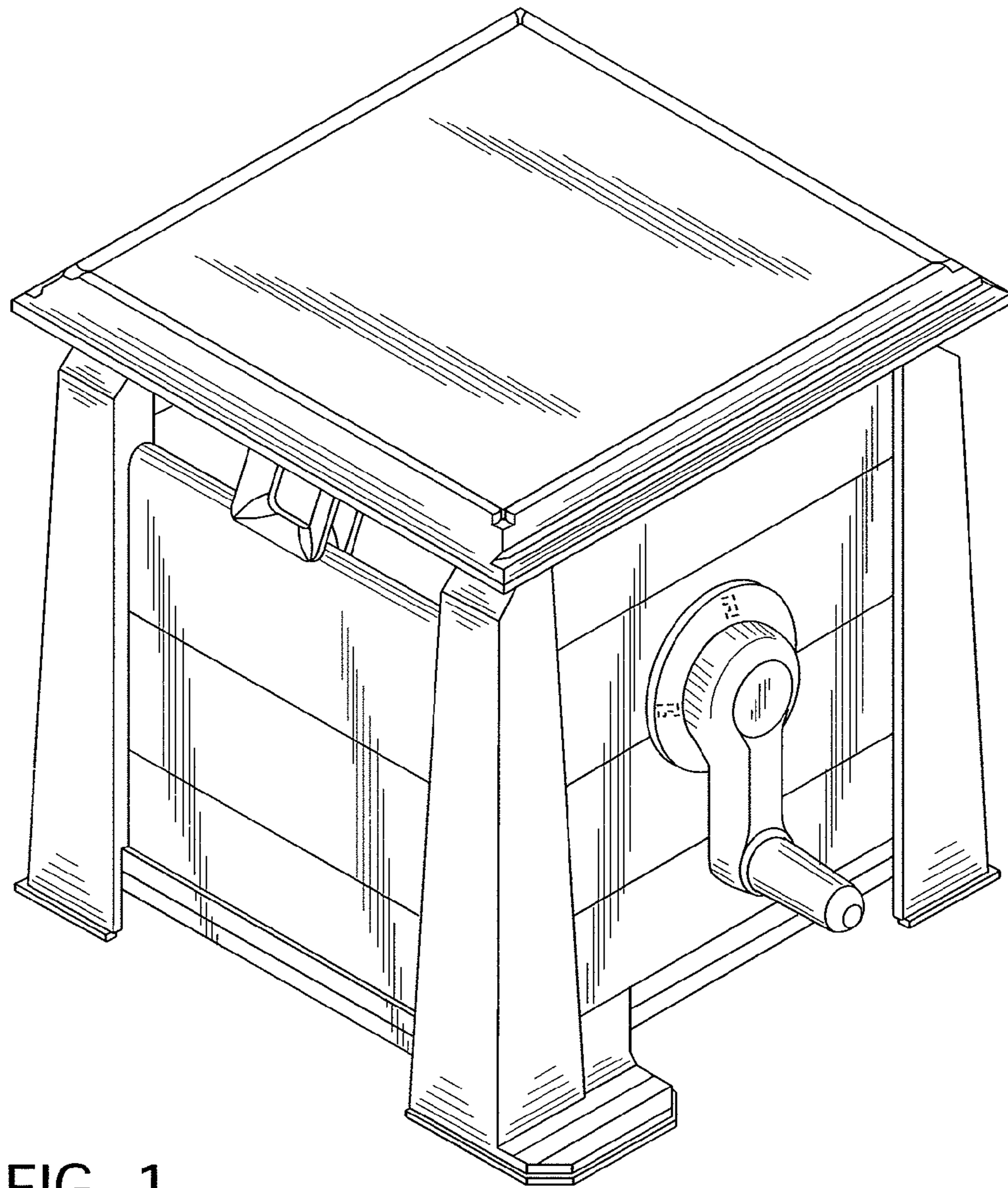

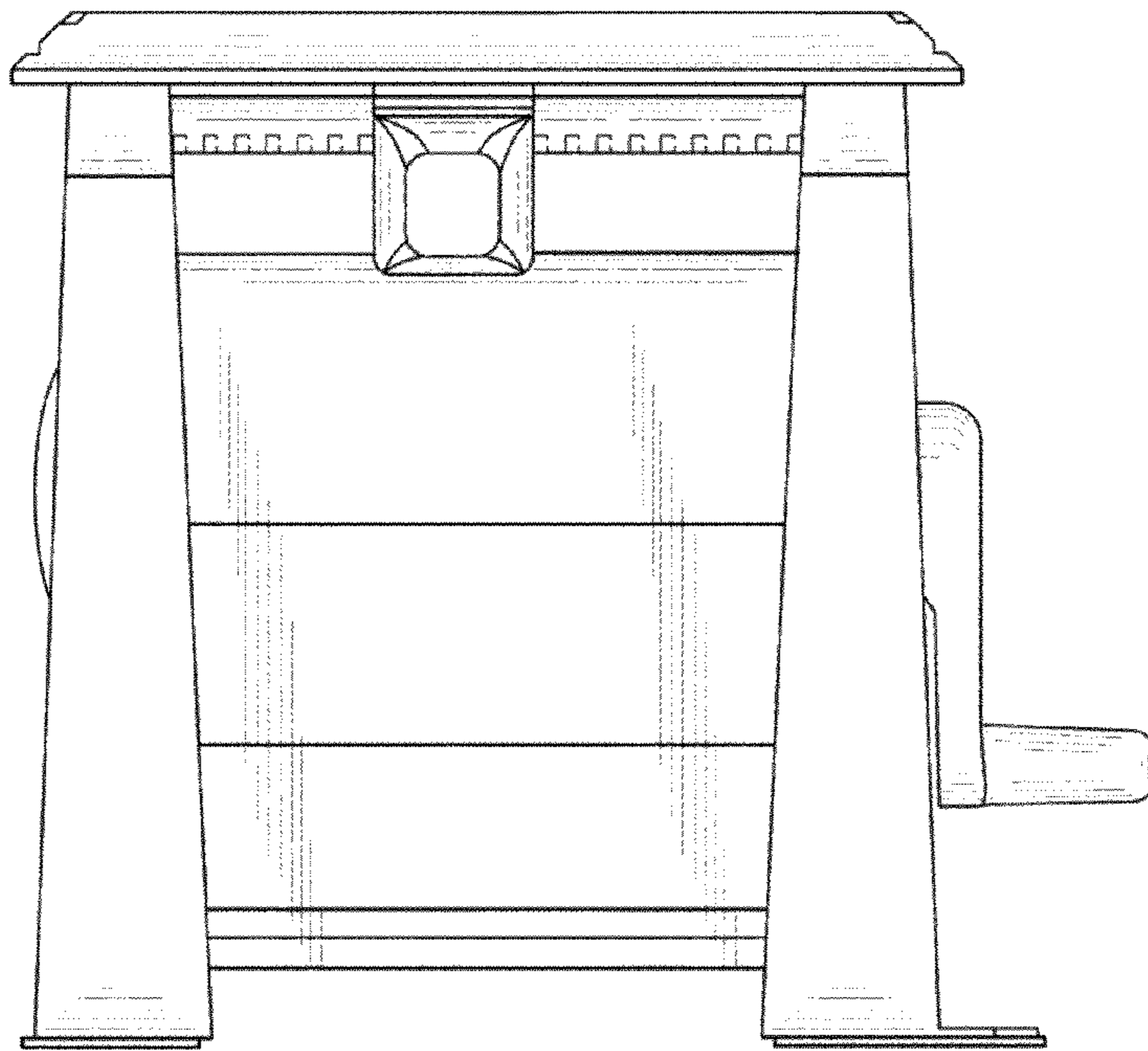

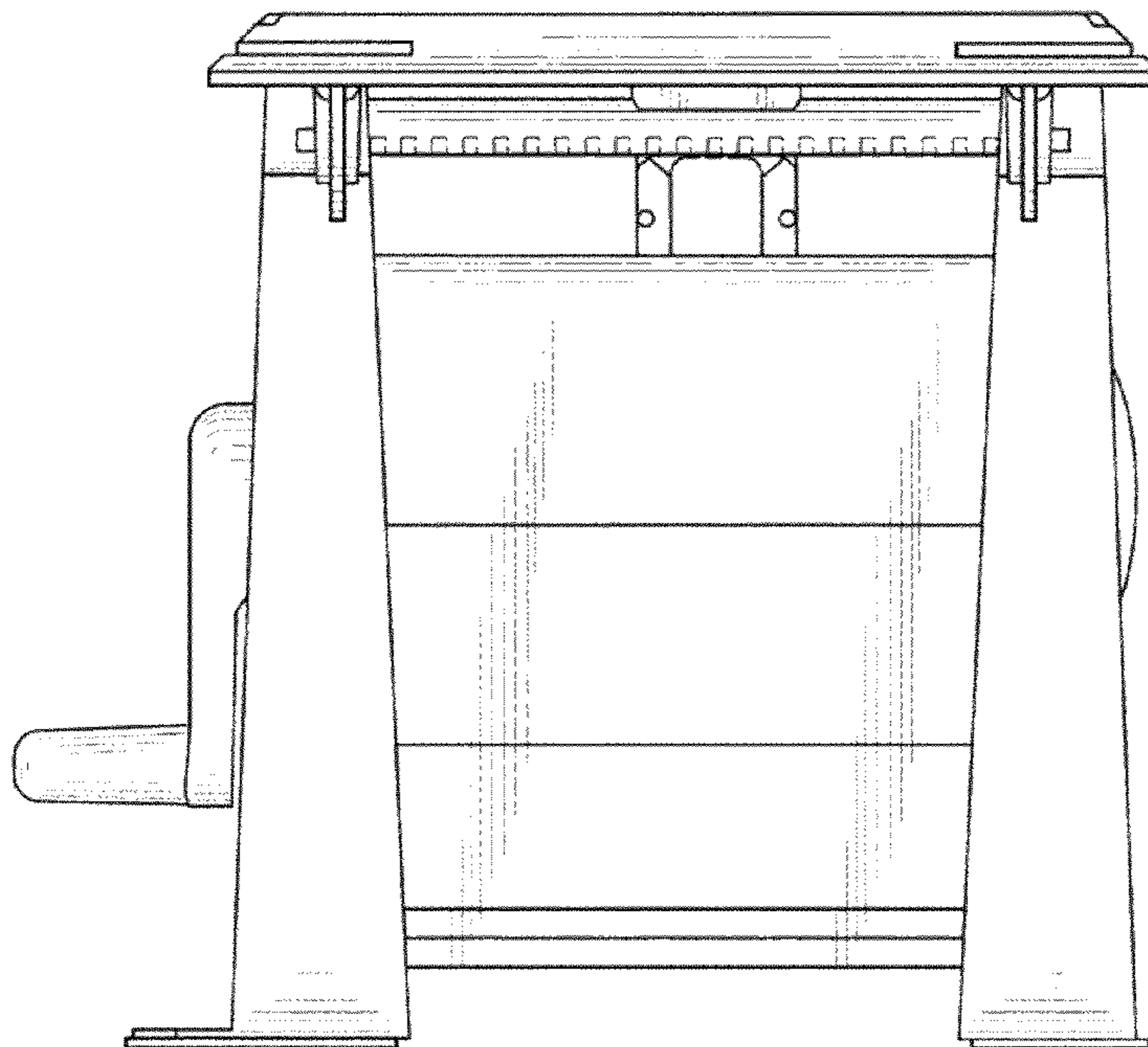

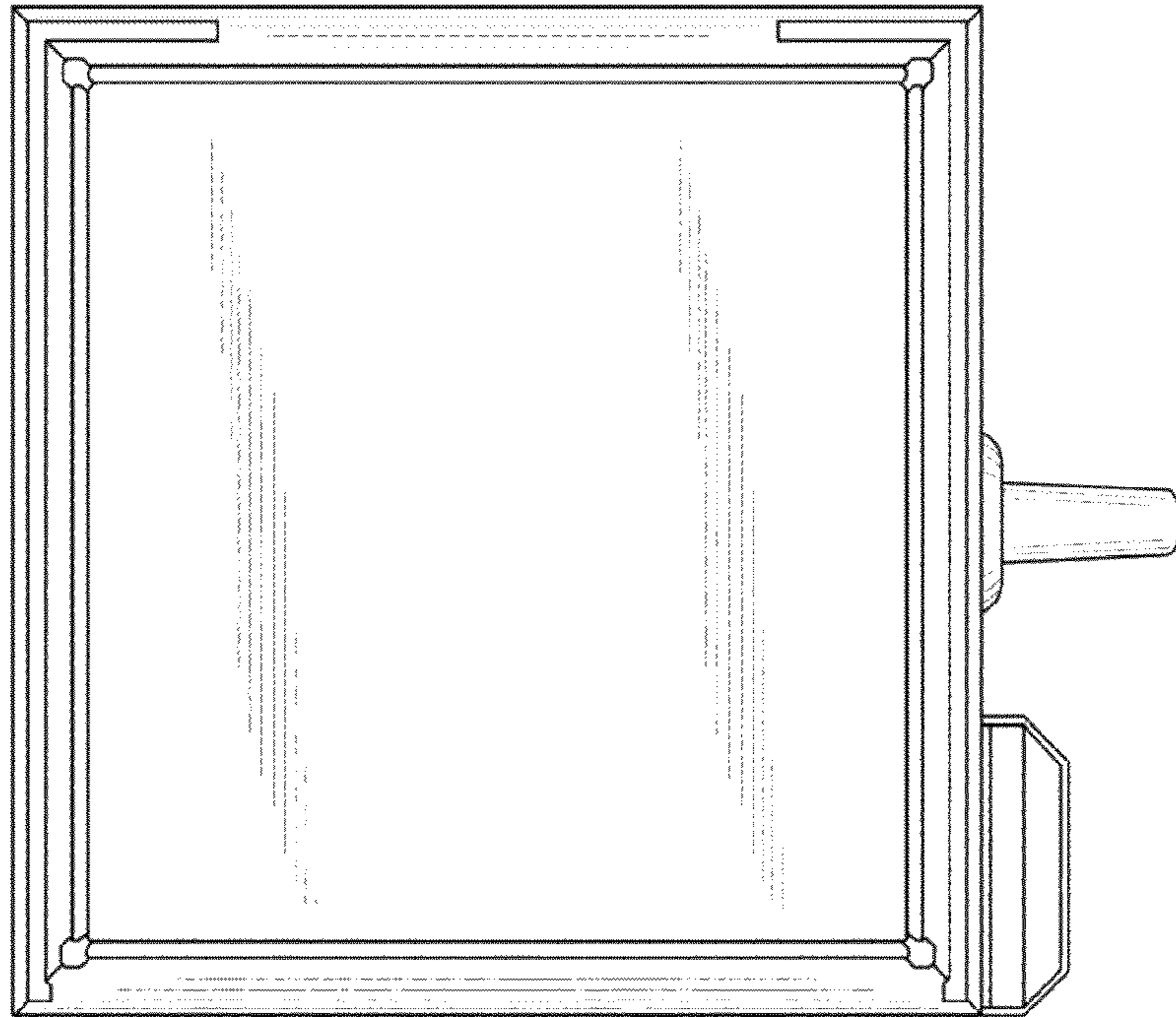

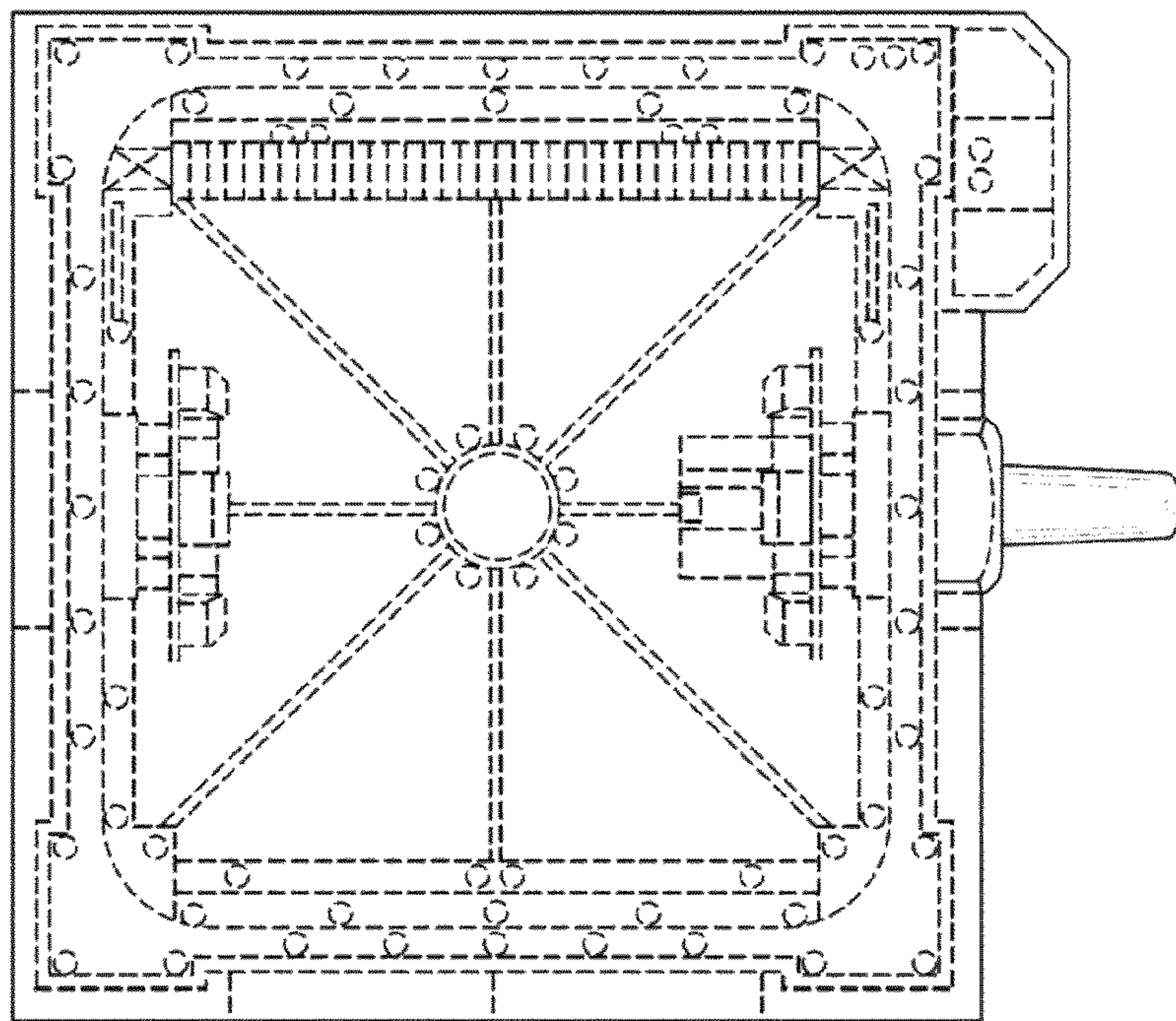

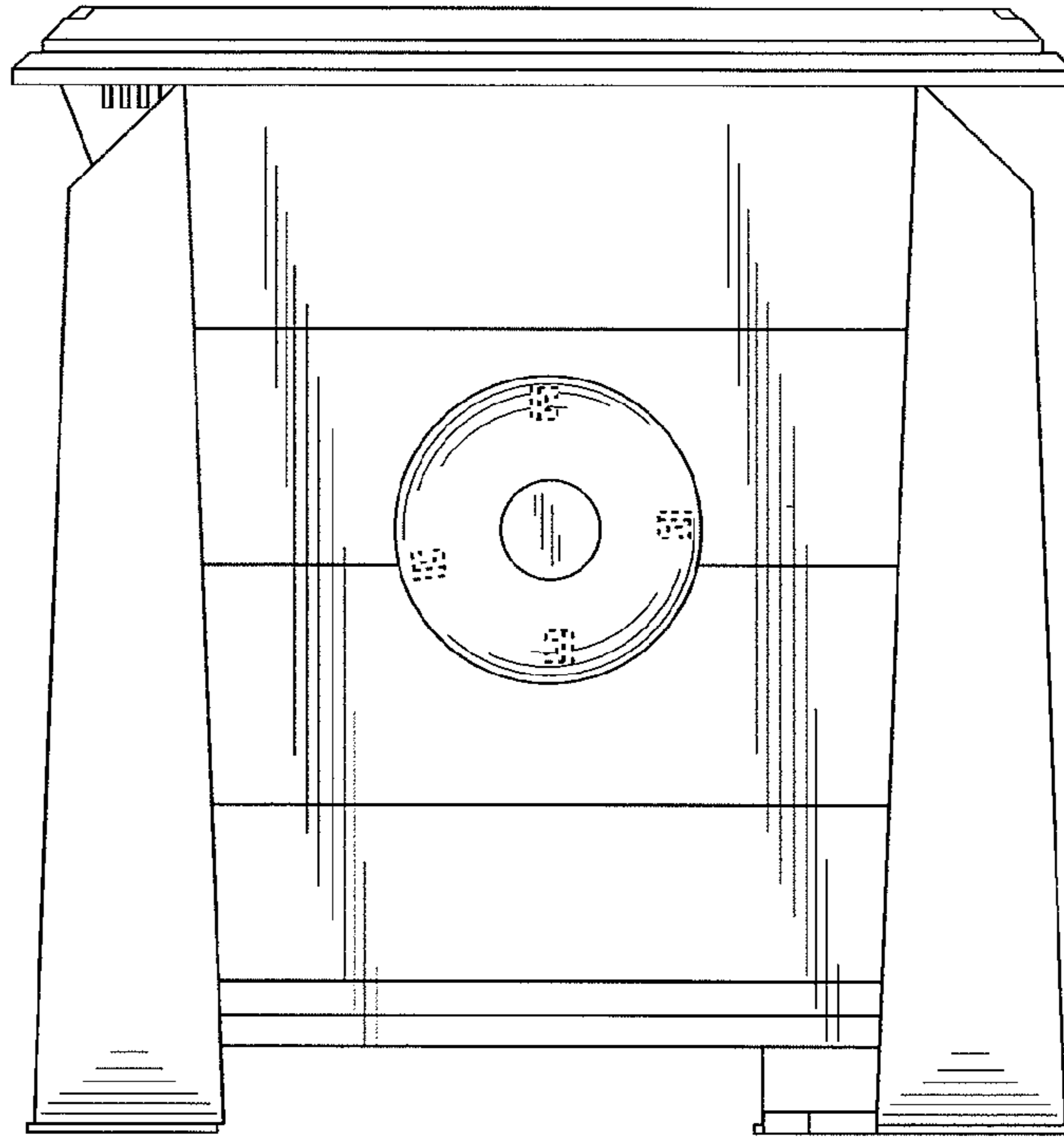

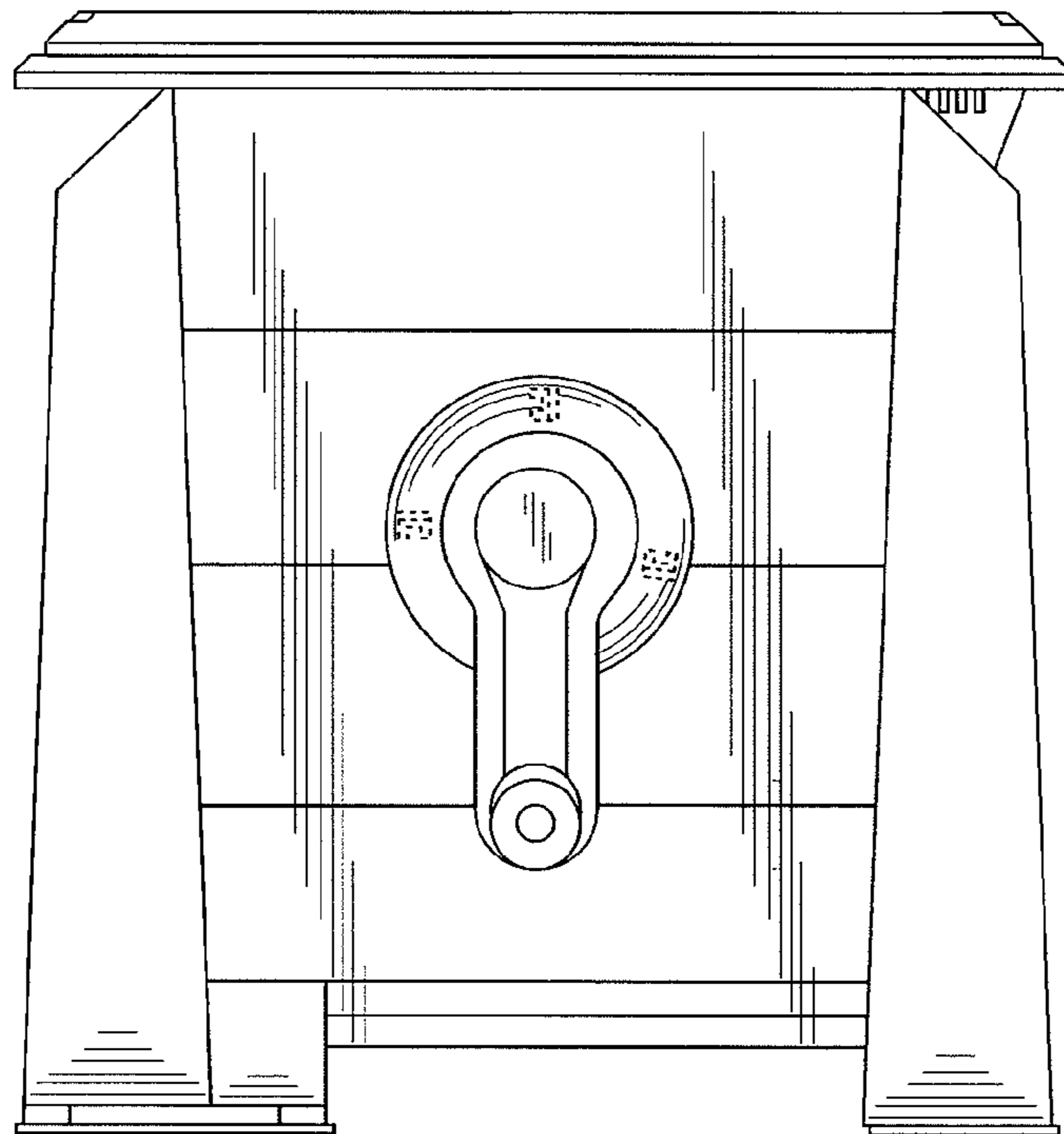
