DESCRIPTION

FIG. 1 is a top perspective view of a cup showing my new design;
FIG. 2 is a bottom perspective view thereof,
FIG. 3 is a front elevation view thereof, wherein the rear elevation view is a mirror image of this view;
FIG. 4 is a left side elevation view thereof, wherein the right side elevation view is a mirror image of this view;
FIG. 5 is a top view thereof;
FIG. 6 is a bottom view thereof; and,
FIG. 7 is a cross-section view of FIG. 3.

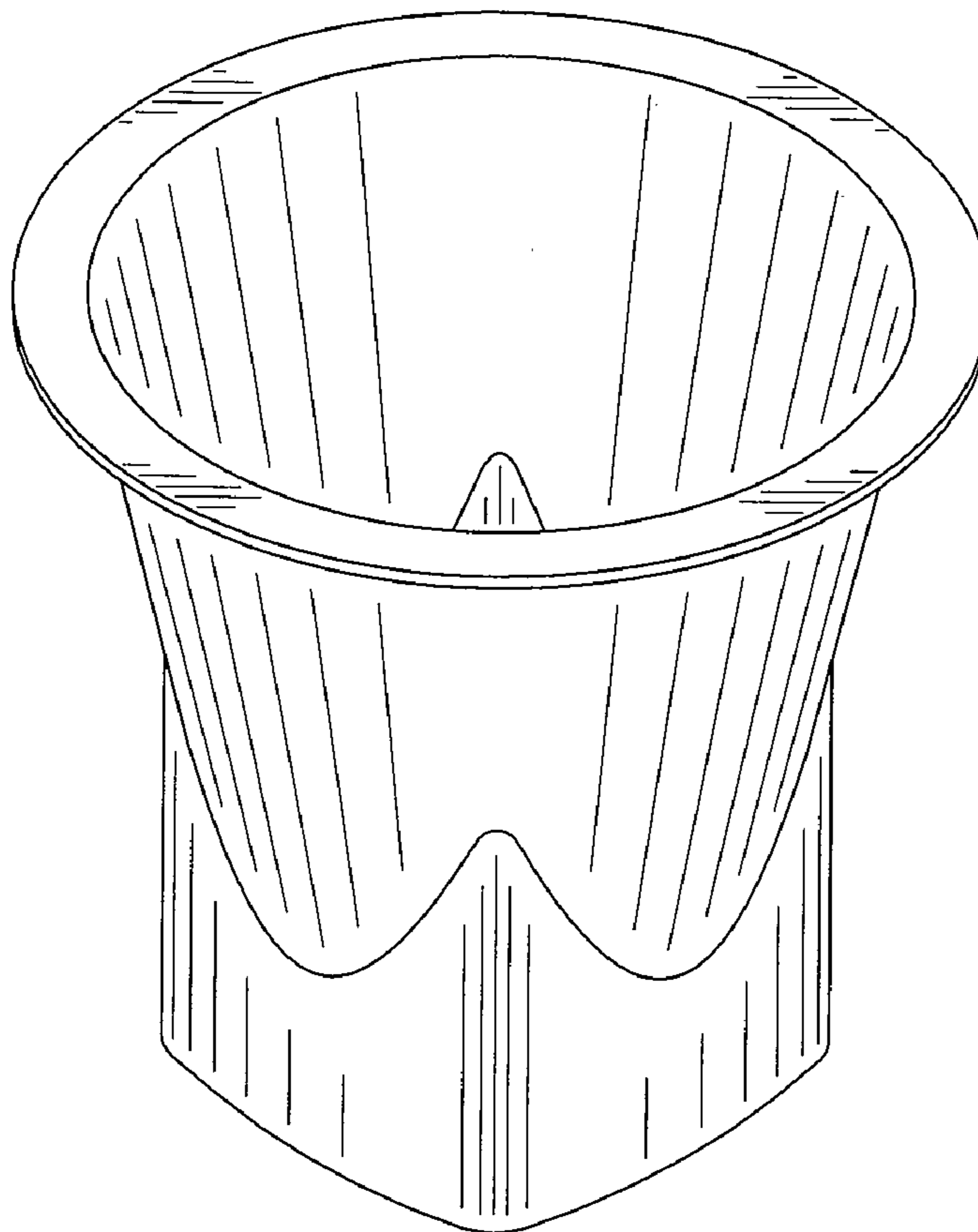

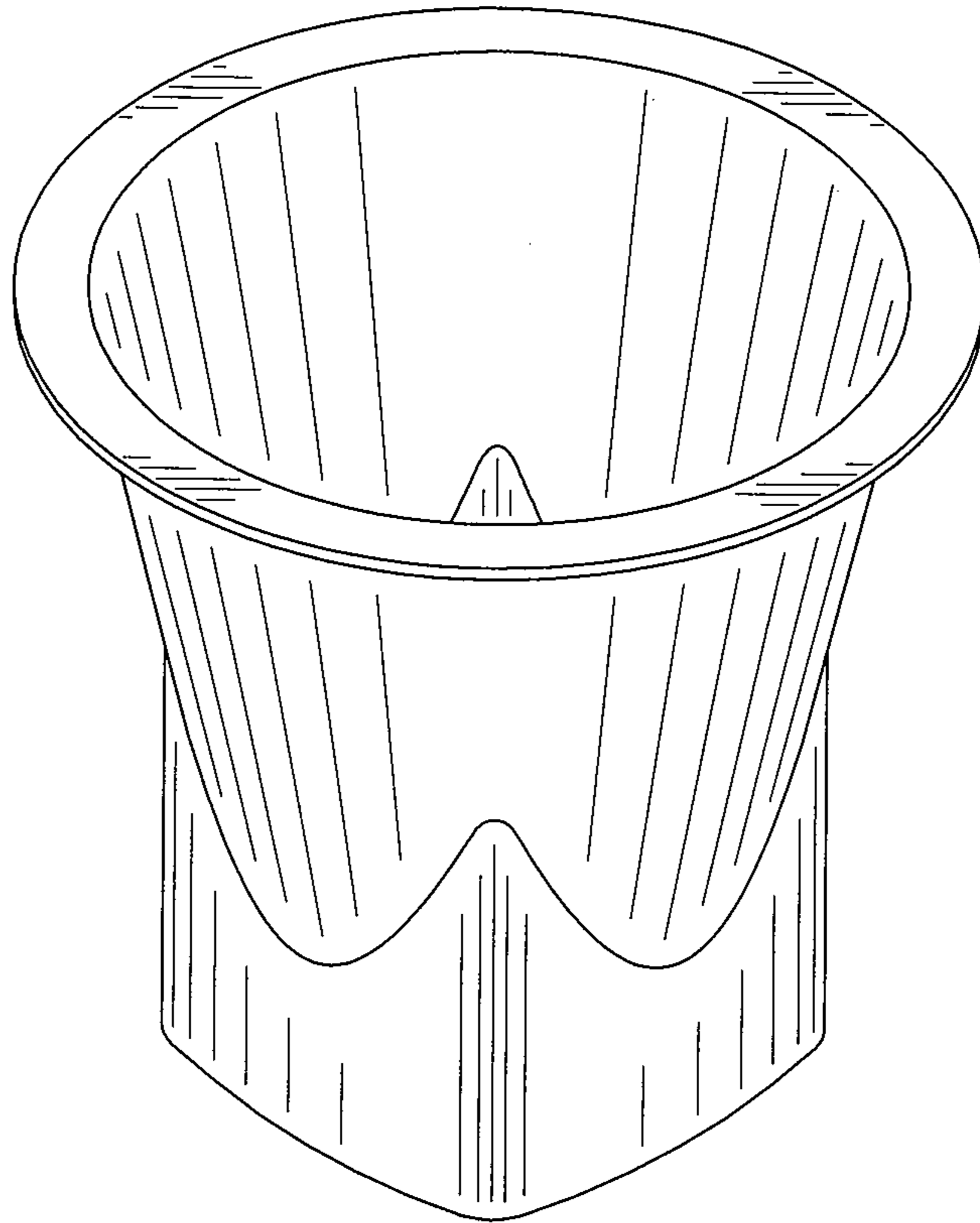

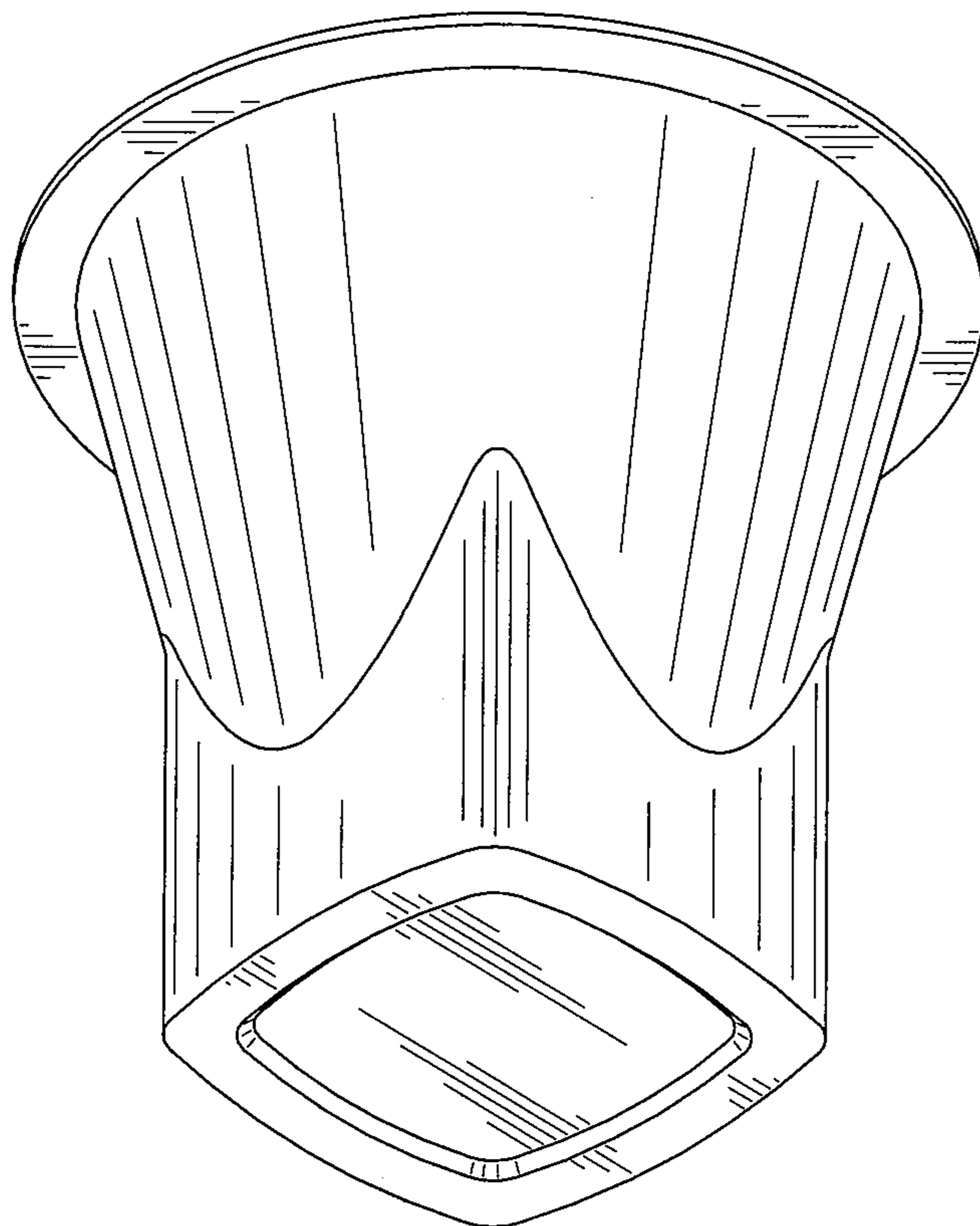
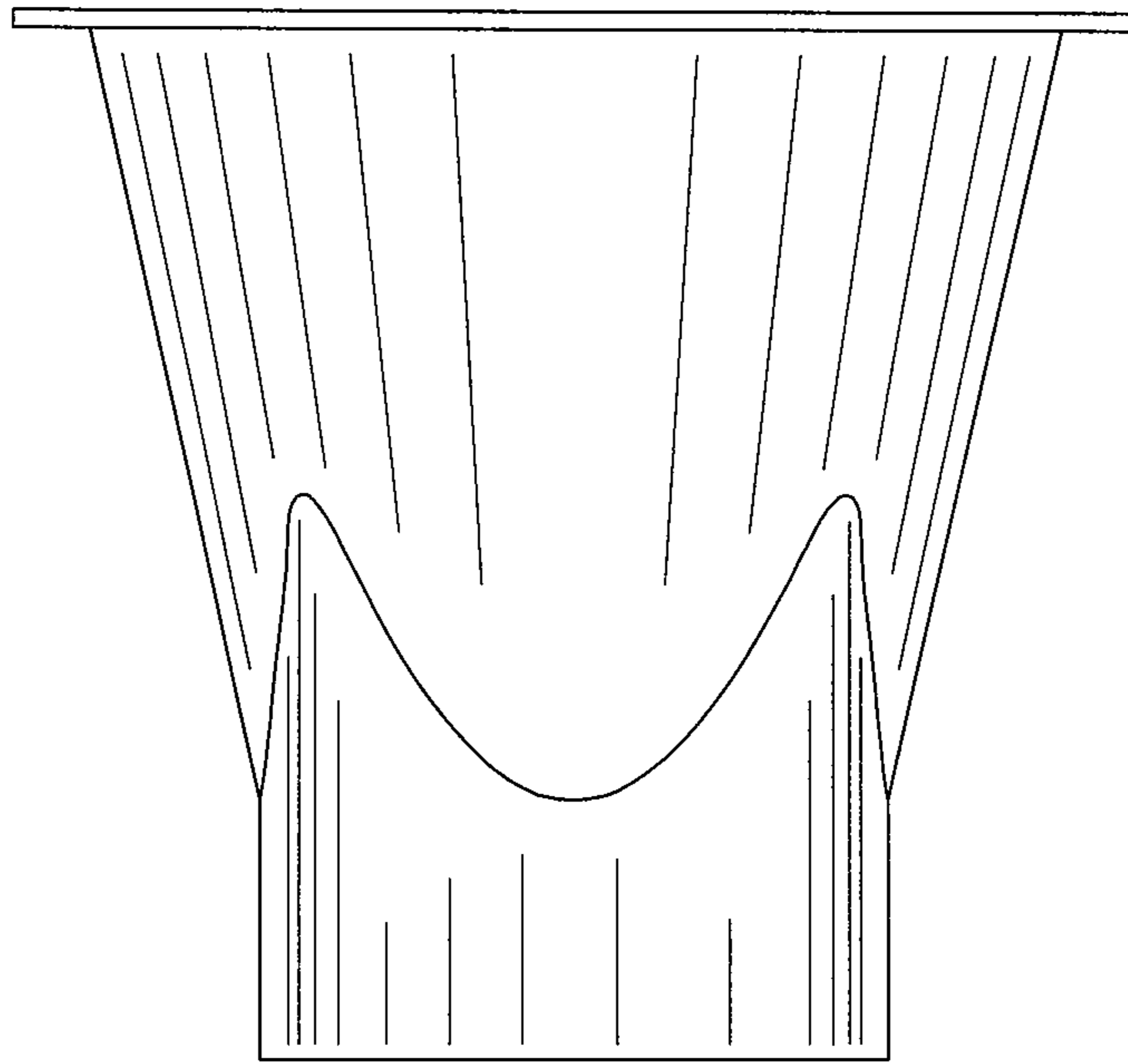

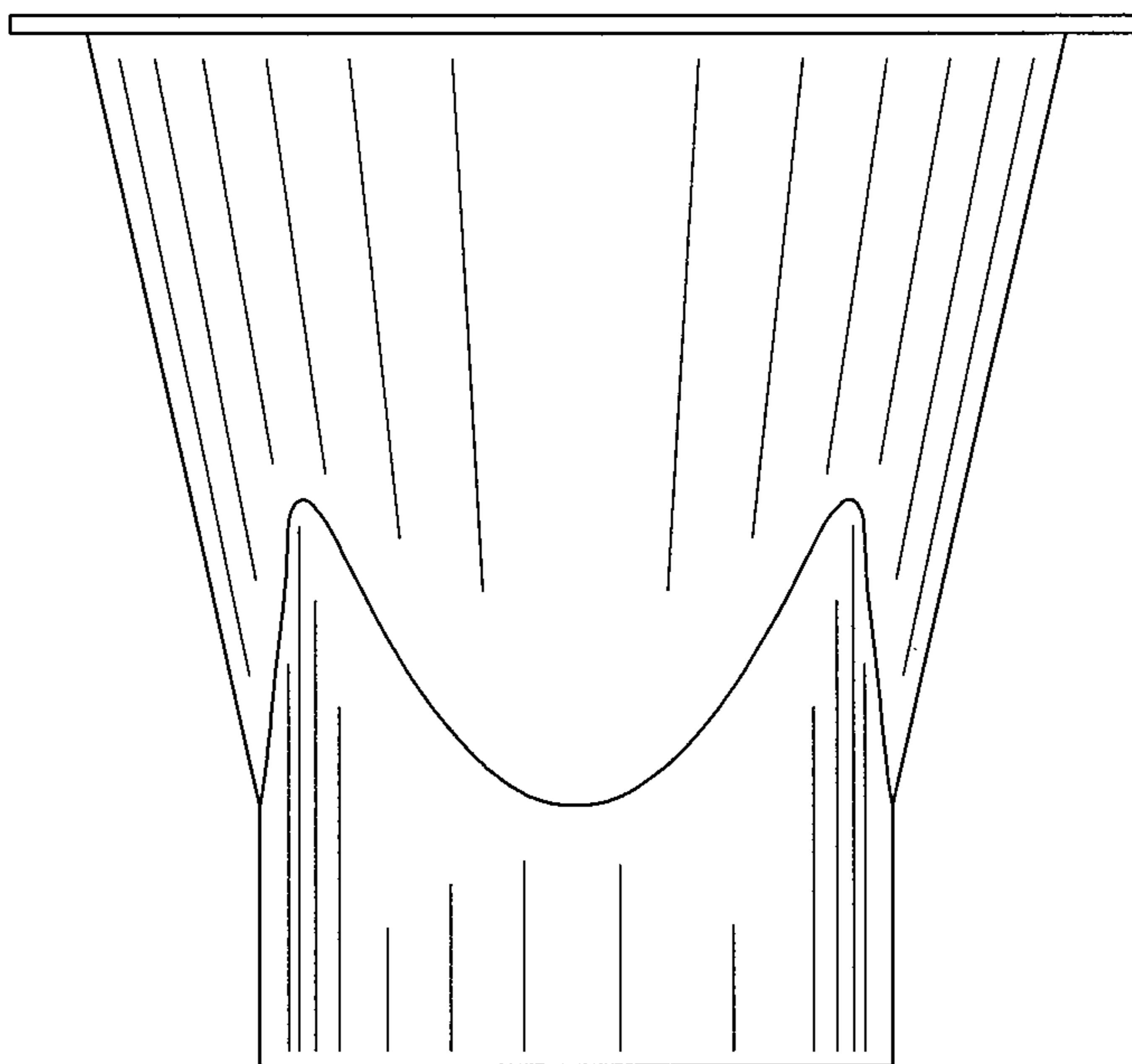

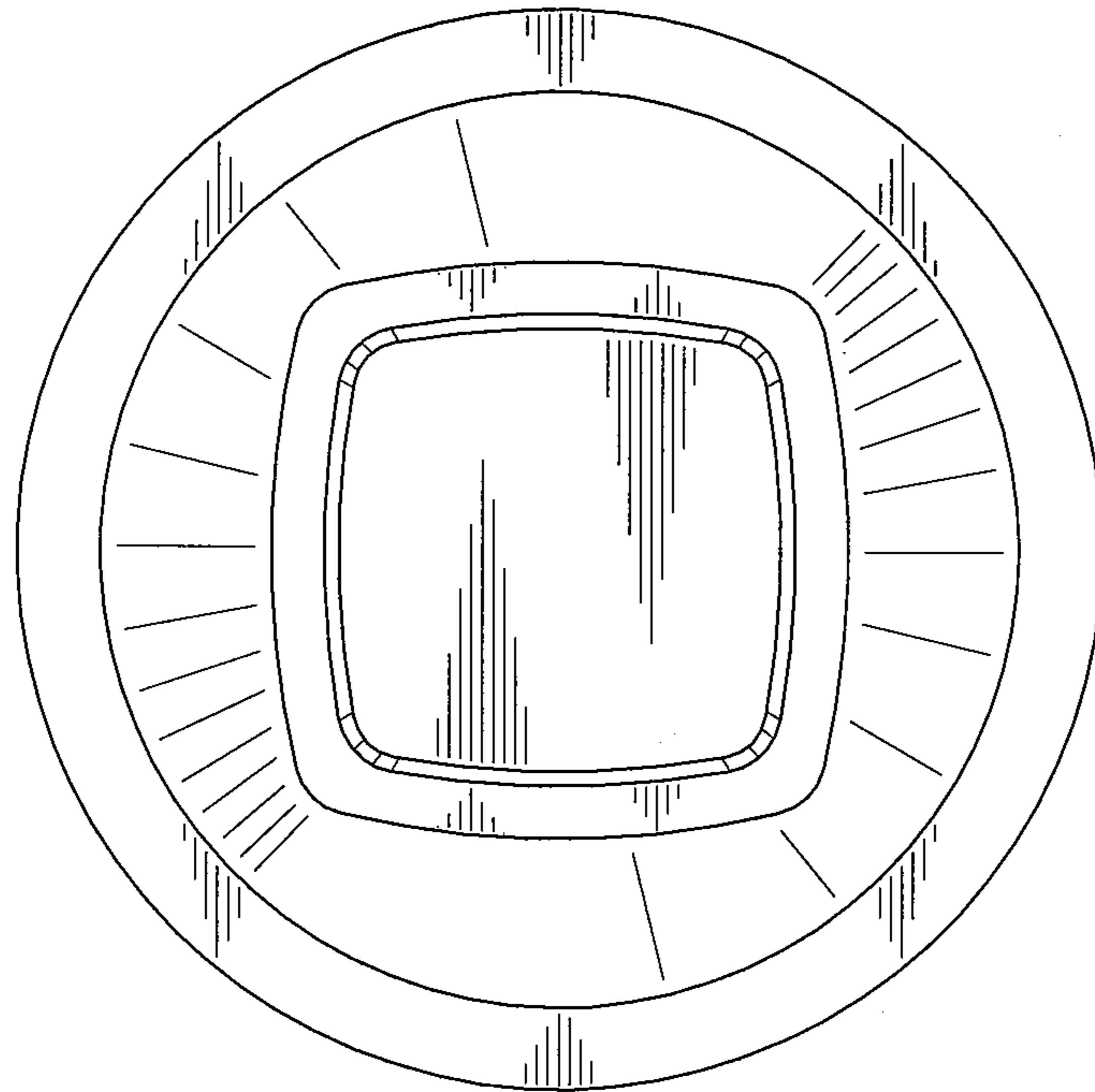

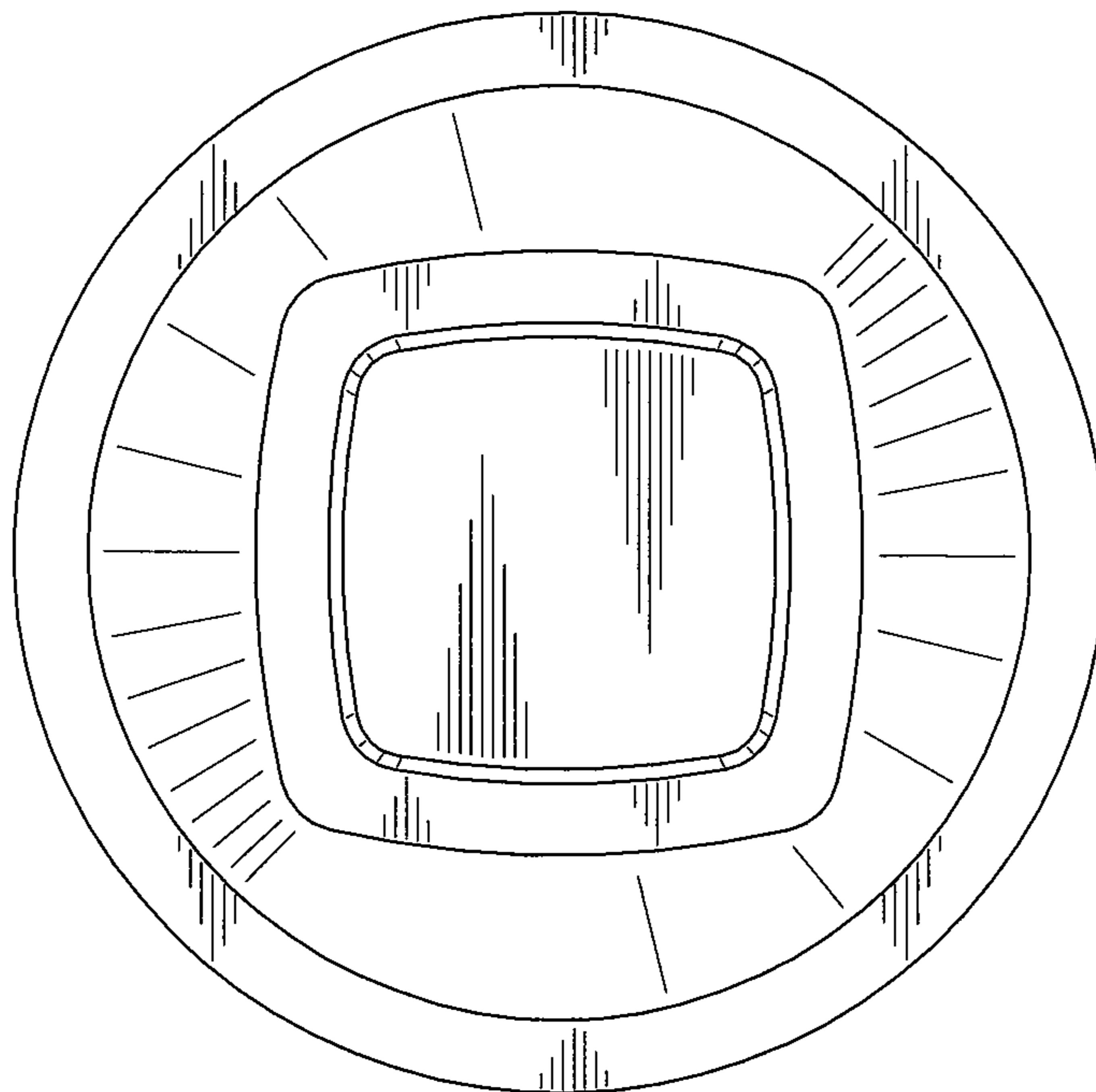
