(57) **CLAIM**

The ornamental design for a closure, as shown and described.

DESCRIPTION

FIG. 1 is a front isometric view of a closure, and FIG. 1 shows my new design with the lid in the closed position as the lid would be initially positioned with the closure body for installation of the closure on a container (not shown) for initial purchase by a consumer;

FIG. 2 is a rear isometric view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a right side elevational view thereof, the left side elevational view thereof being identical; and,

FIG. 5 is a front elevational view thereof, the rear elevational view thereof being identical.

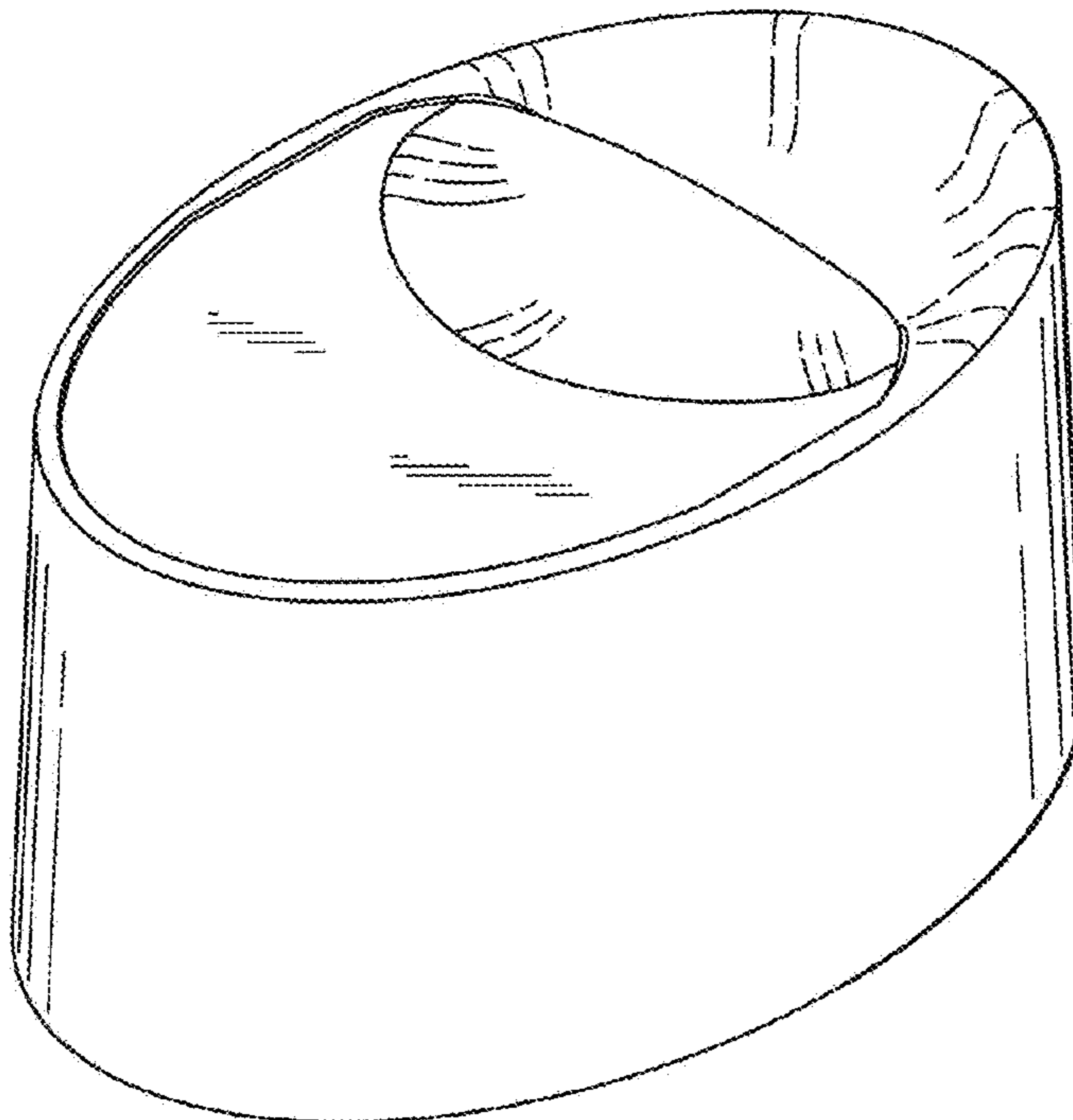

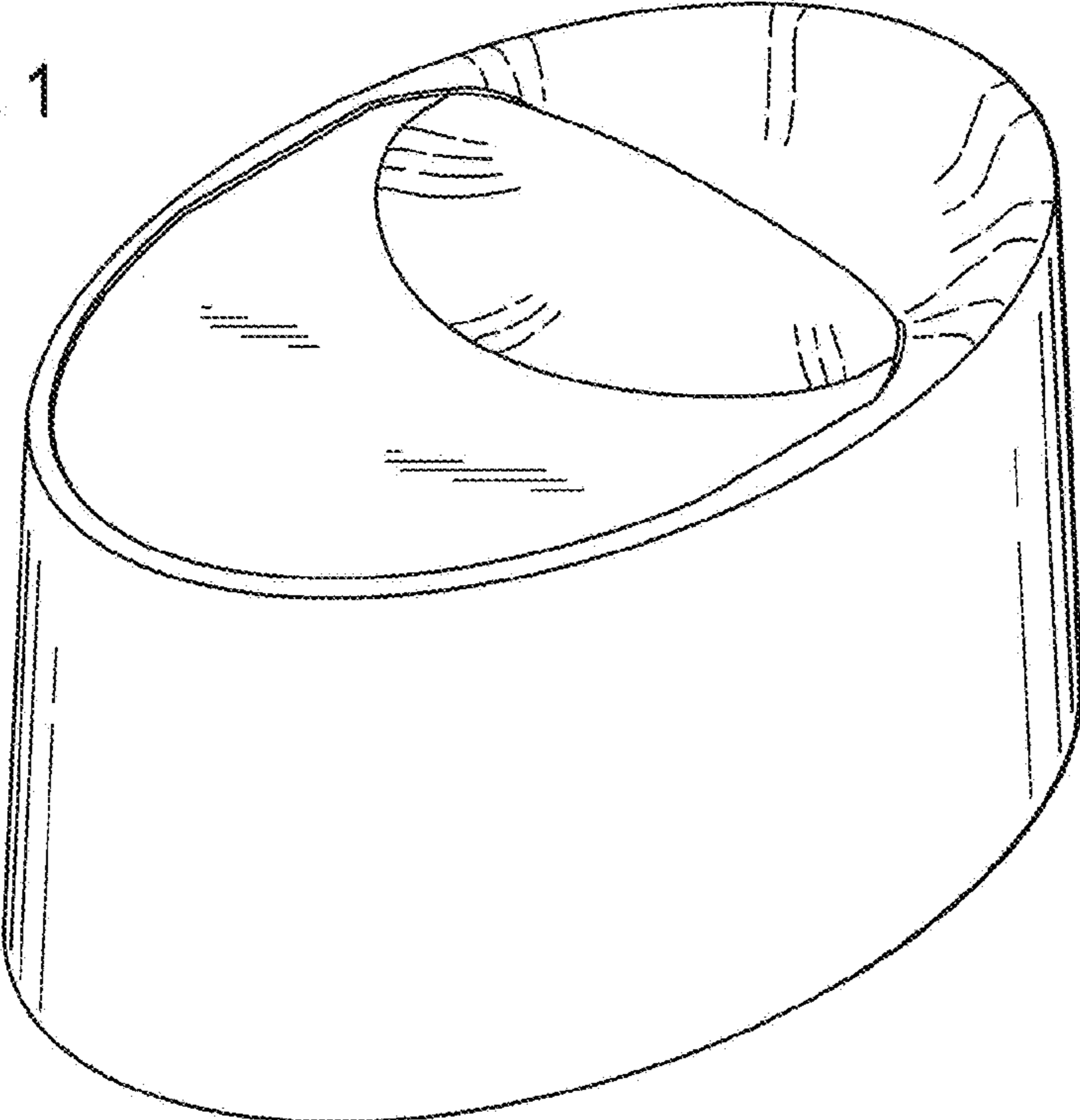
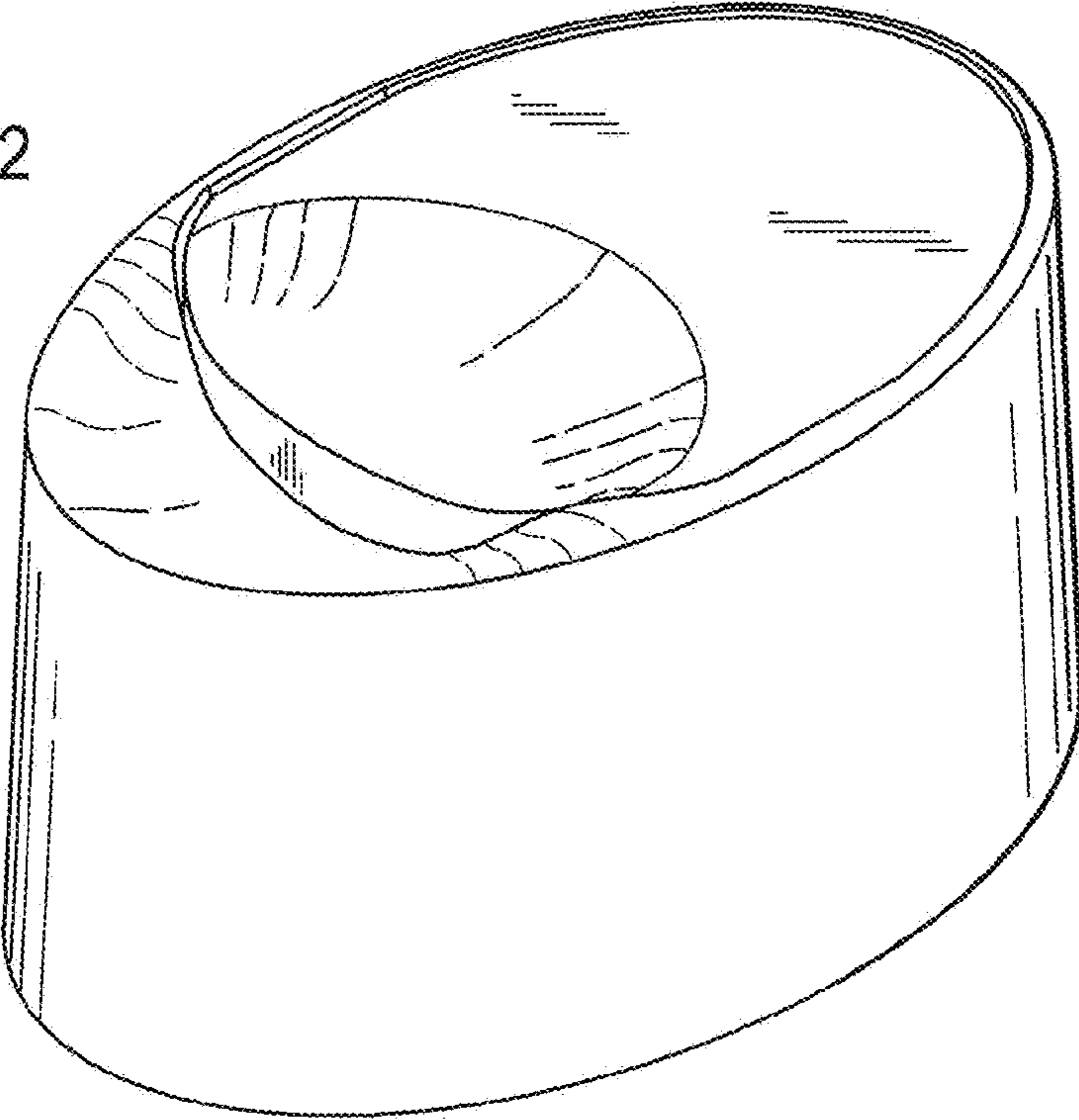

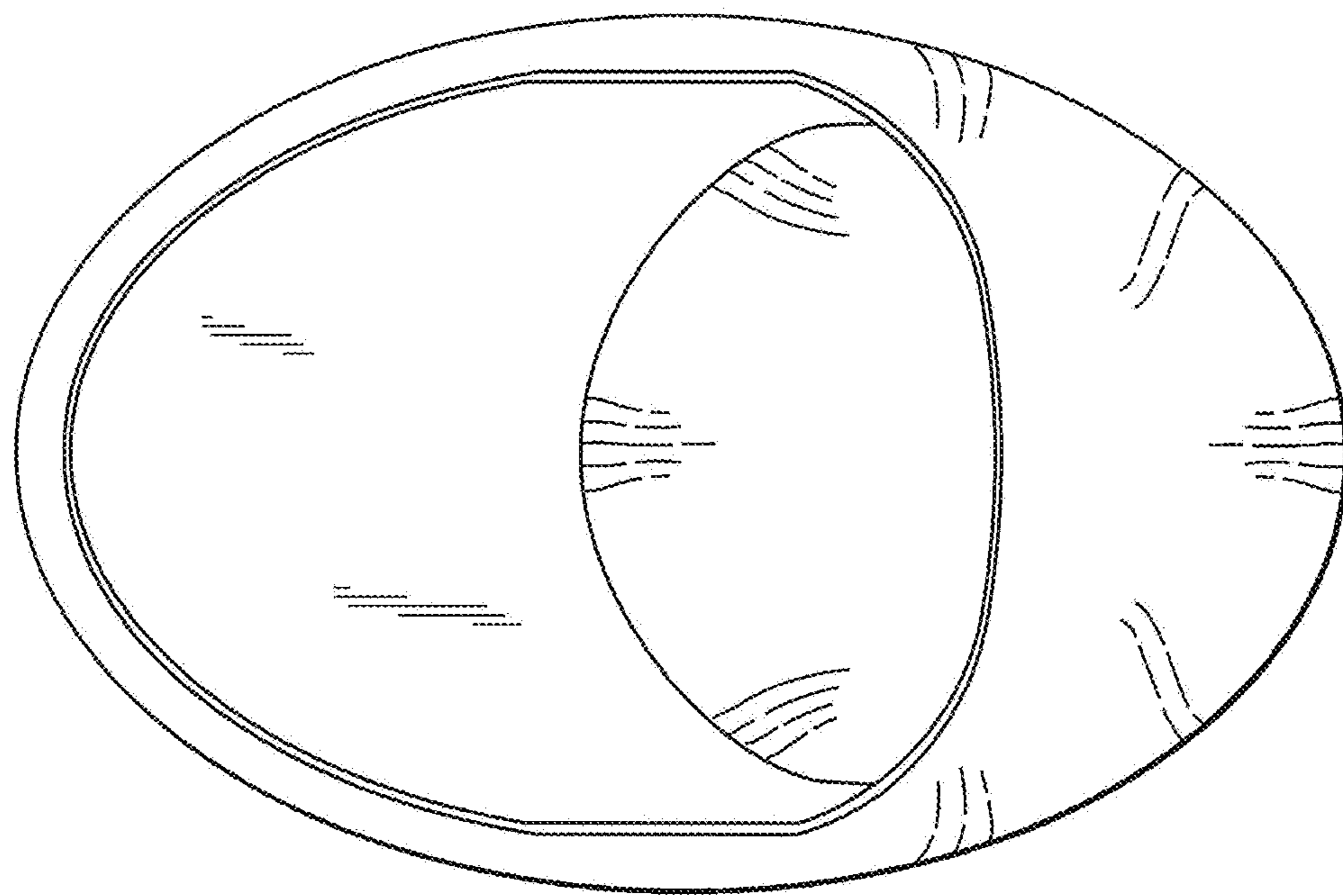

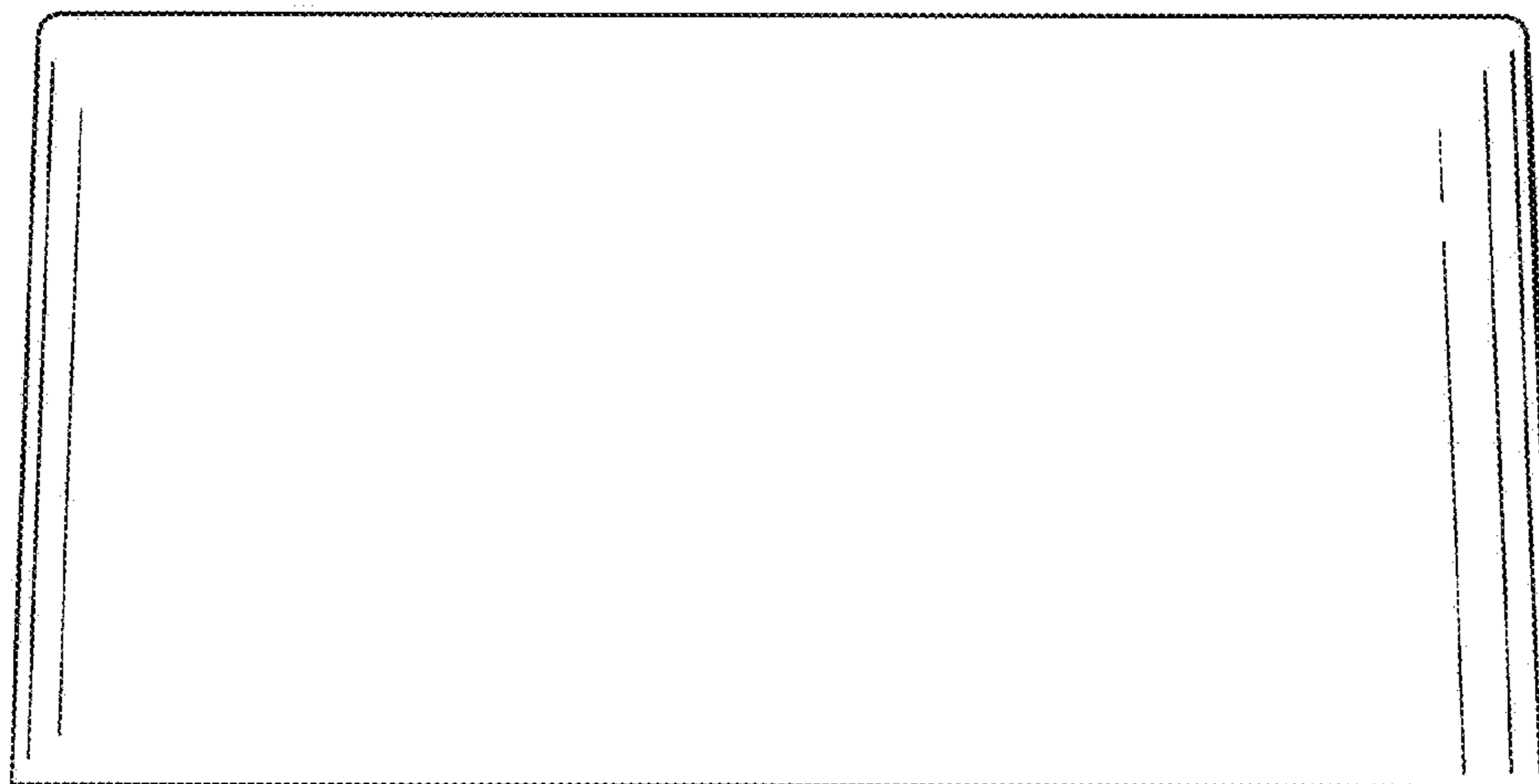

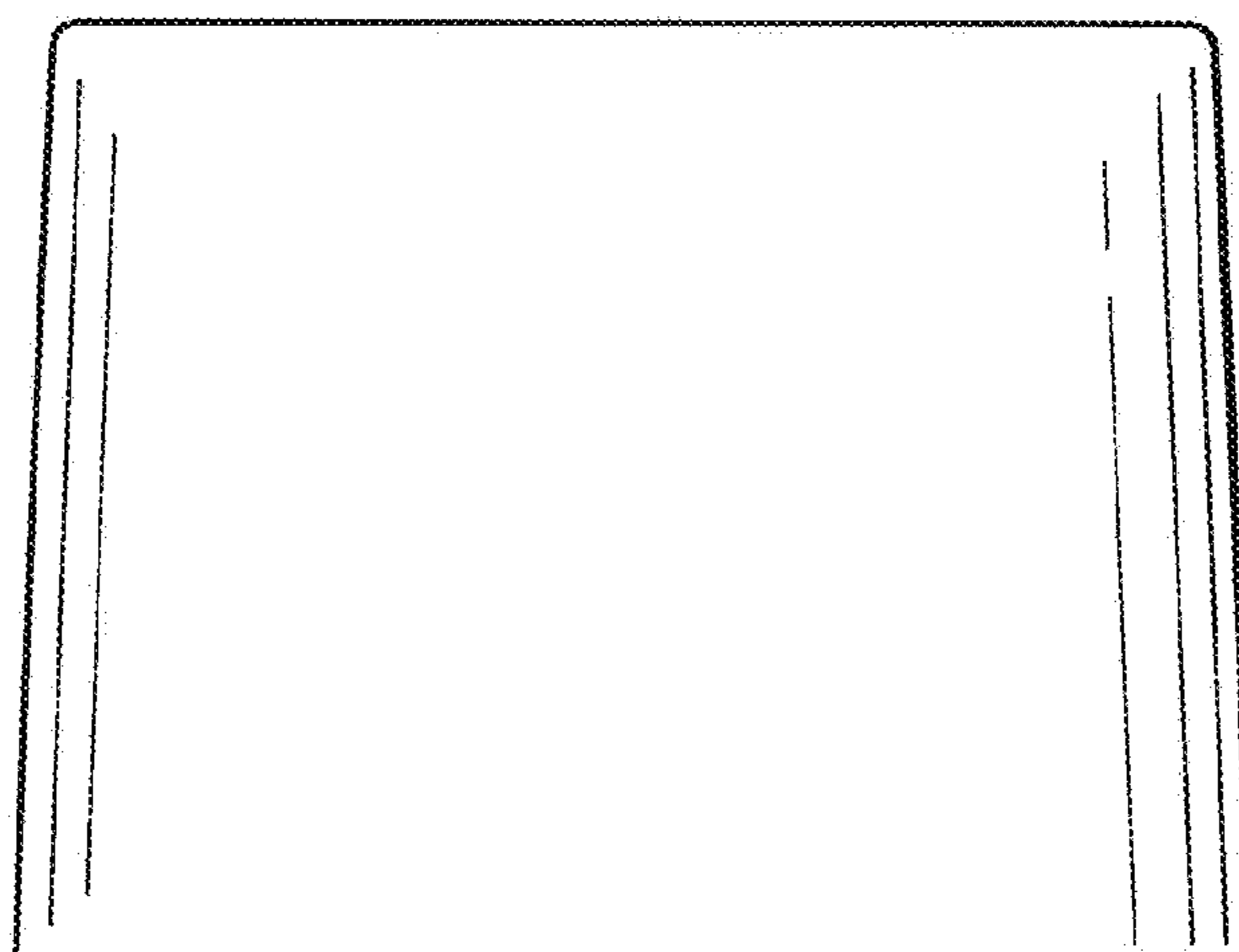
