FIG. 2 is an elevational view of the front of the lemon flexible pouch of FIG. 1;

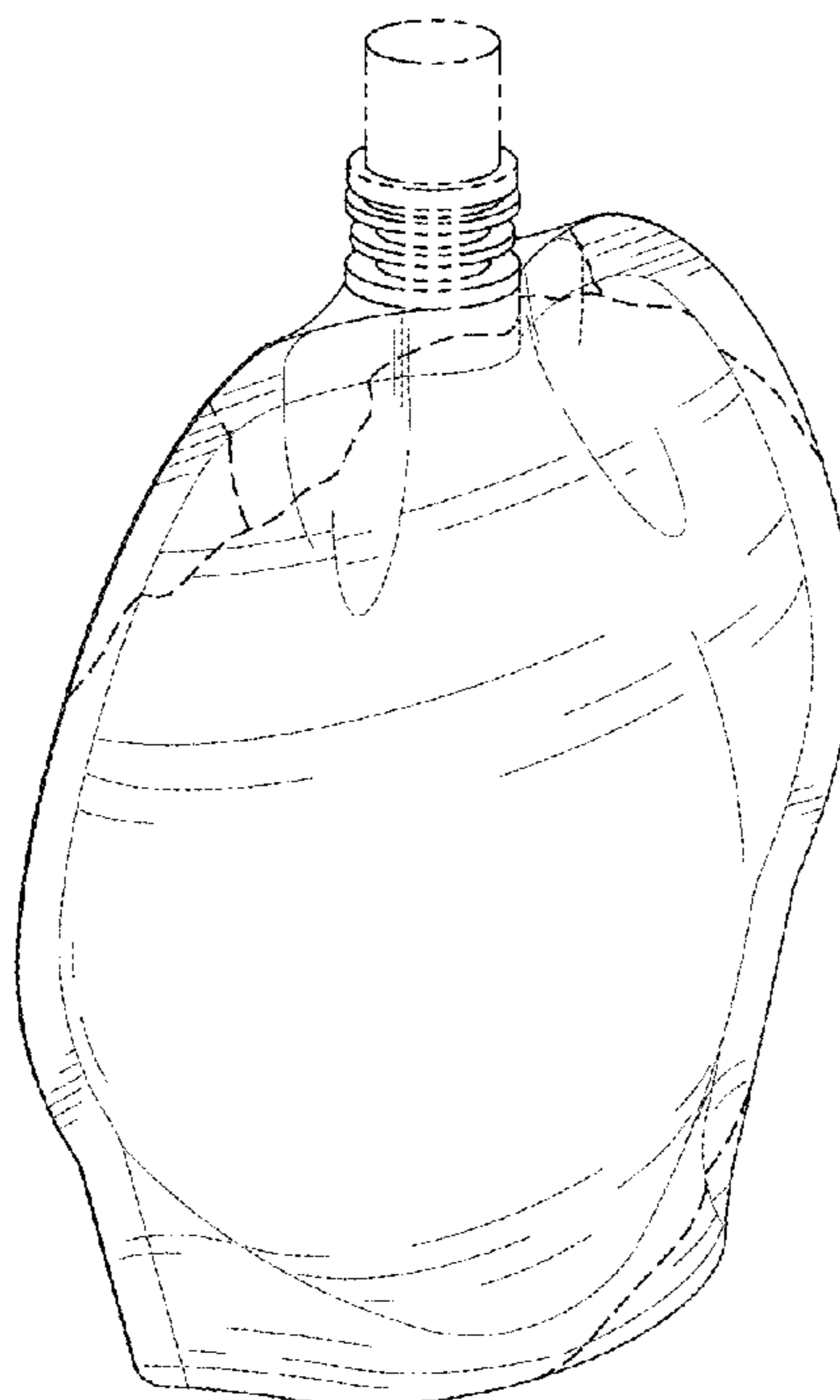
FIG. 3 is an elevational view of the side of the lemon flexible pouch of FIG. 1;

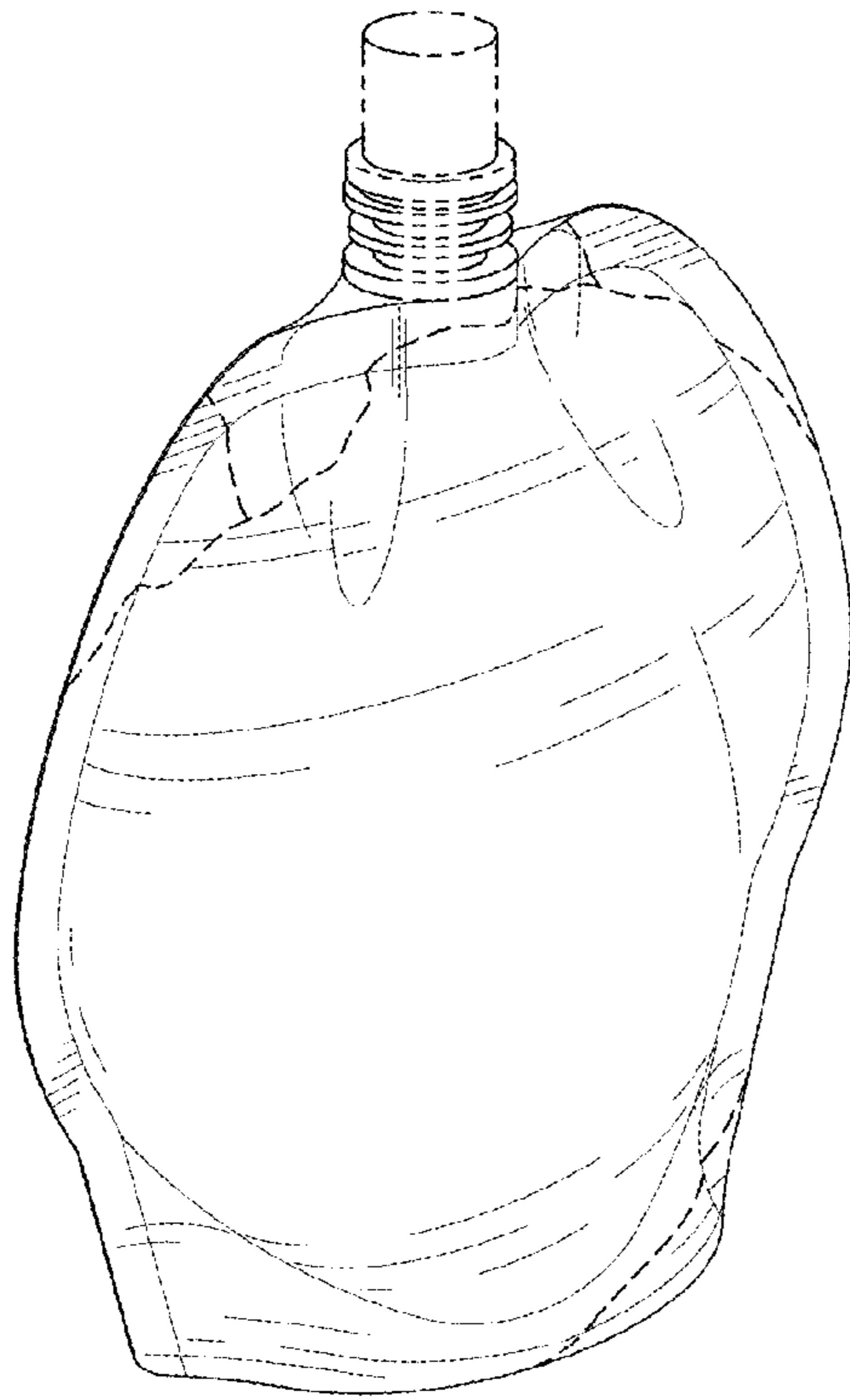

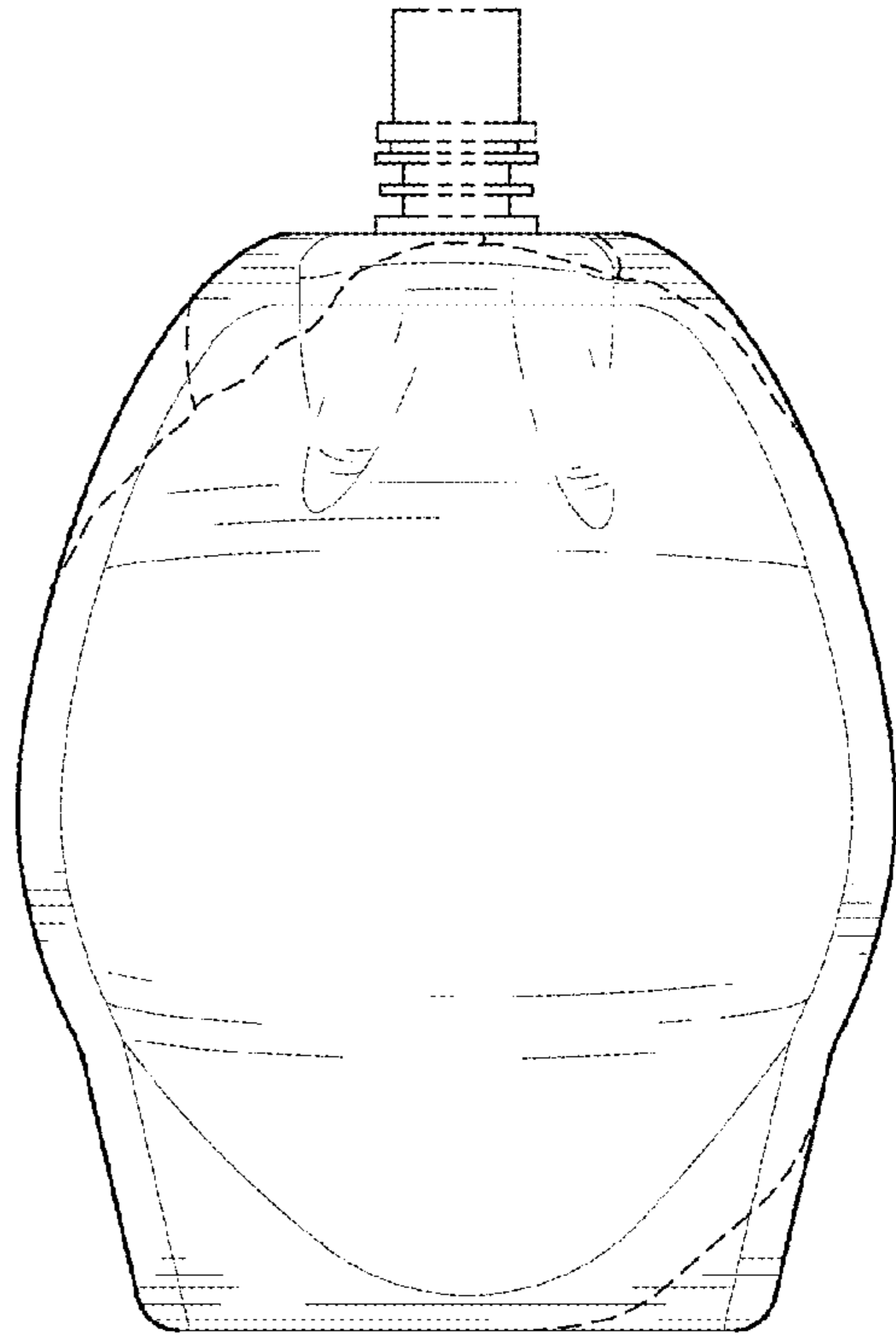

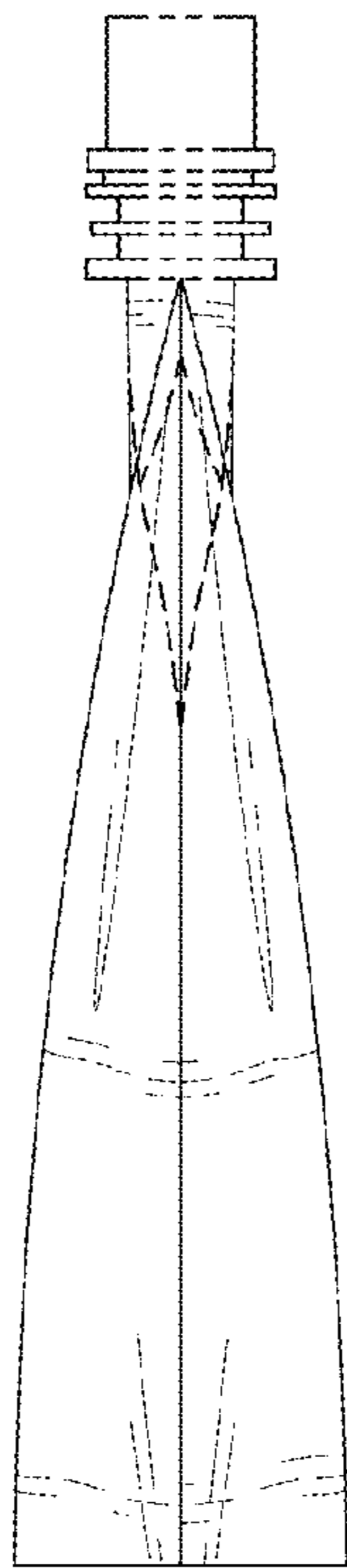

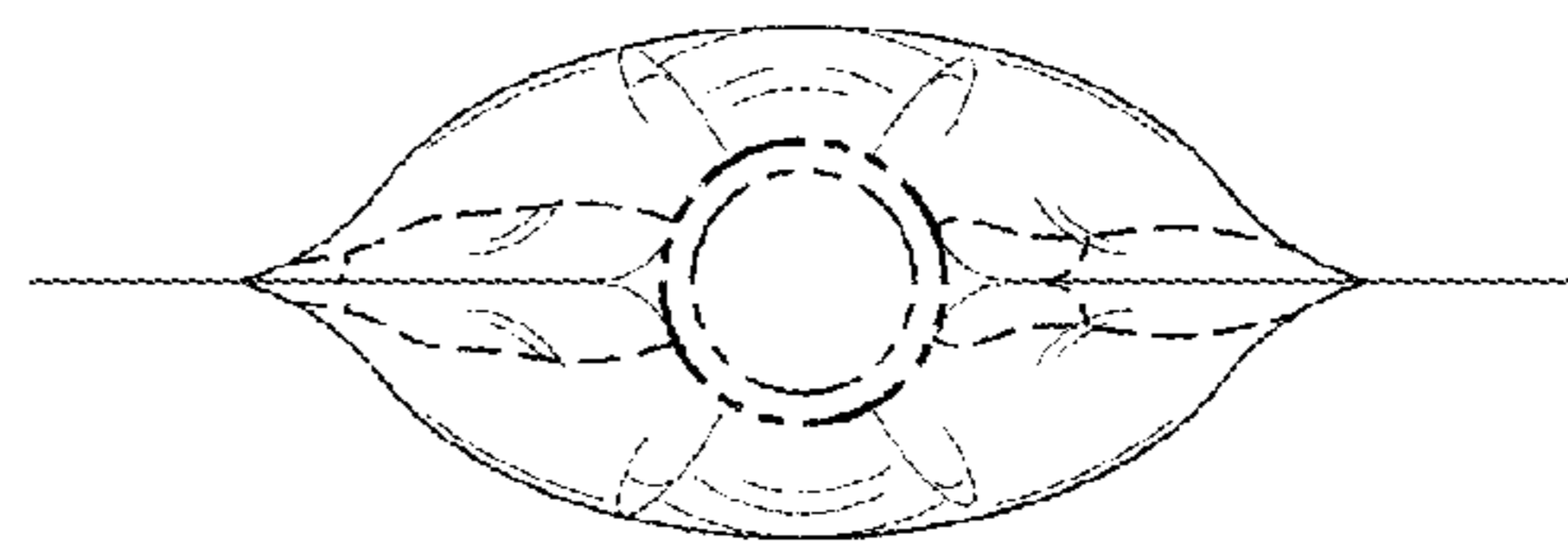

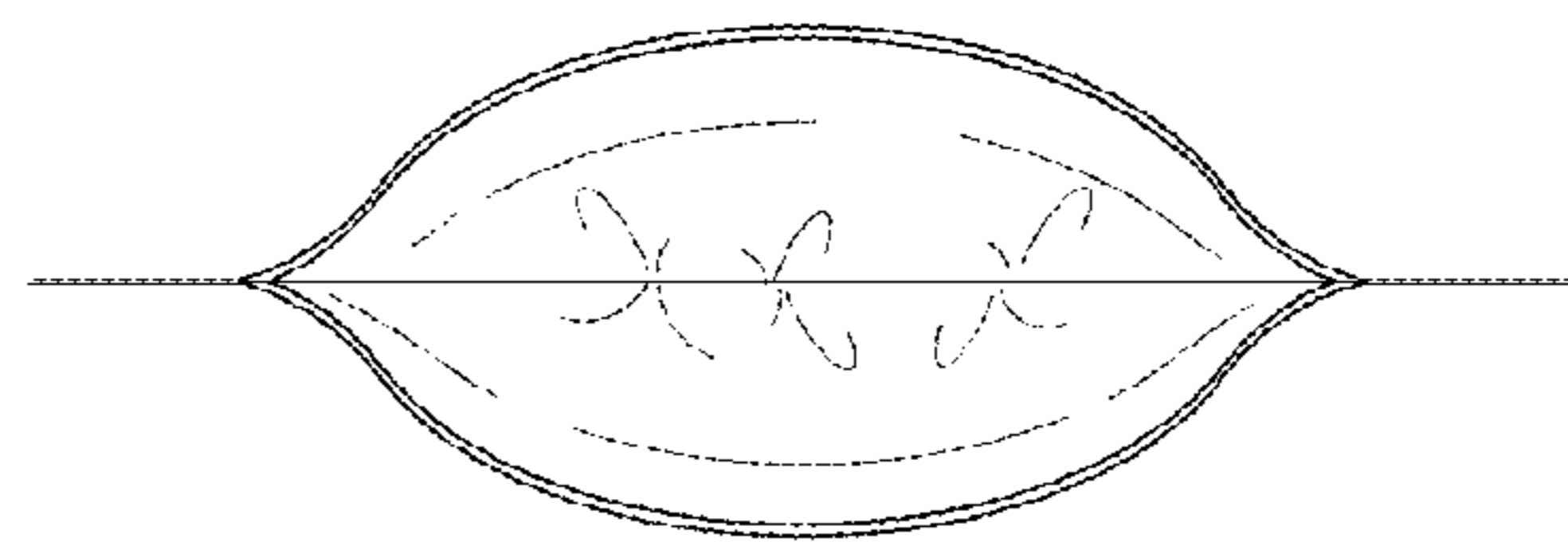
