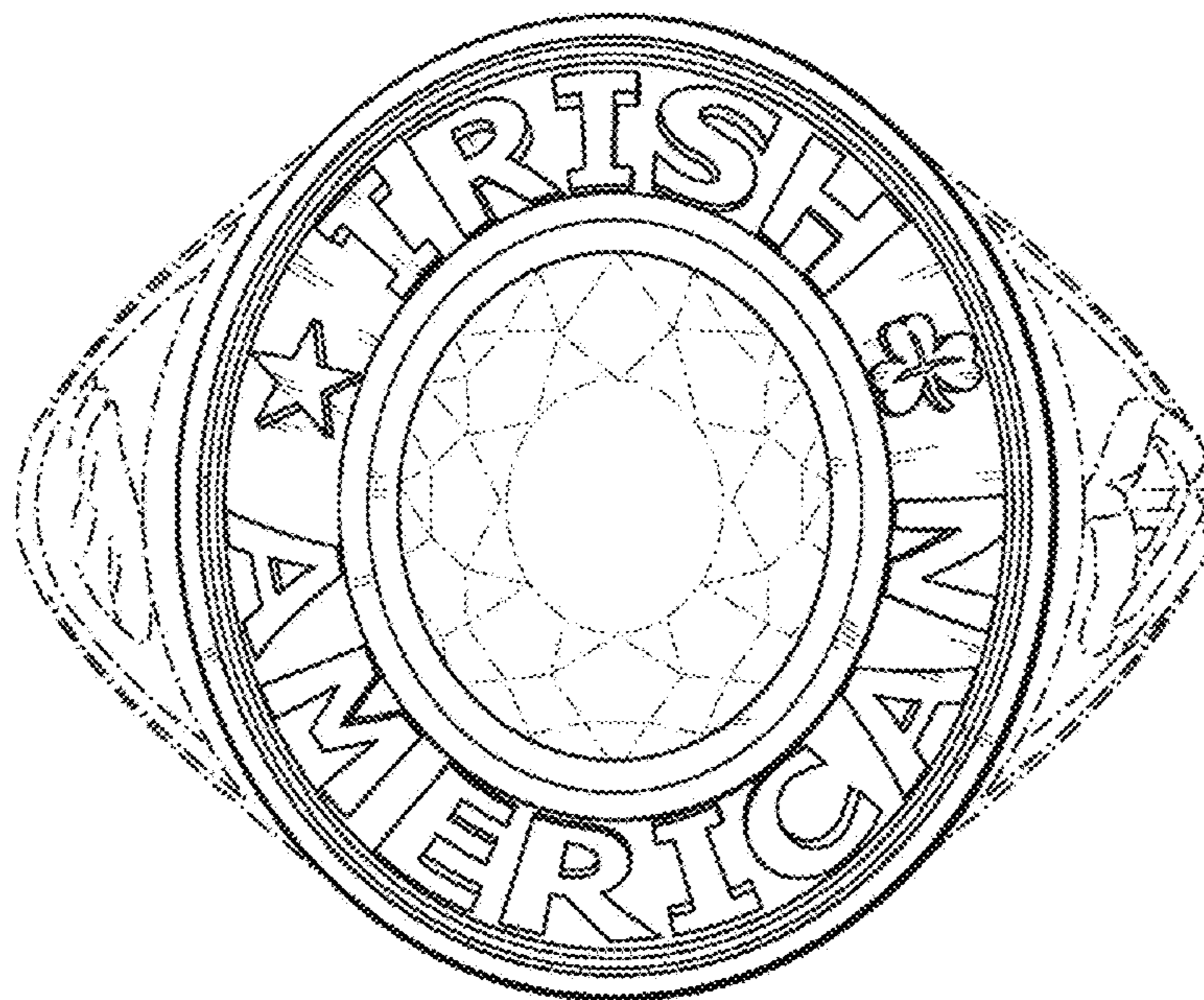
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top perspective view of a ring;
FIG. 2 is a top view of the ring in FIG. 1;
FIG. 3 is a right side view of the ring in FIG. 1;
FIG. 4 is a left side view of the ring in FIG. 1;
FIG. 5 is a front view of the ring in FIG. 1;
FIG. 6 is a rear view of the ring in FIG. 1; and,
FIG. 7 is a bottom view of the ring in FIG. 1.
The broken lines shown in the drawings represent portions of the Irish American ring that form no part of the claimed design.

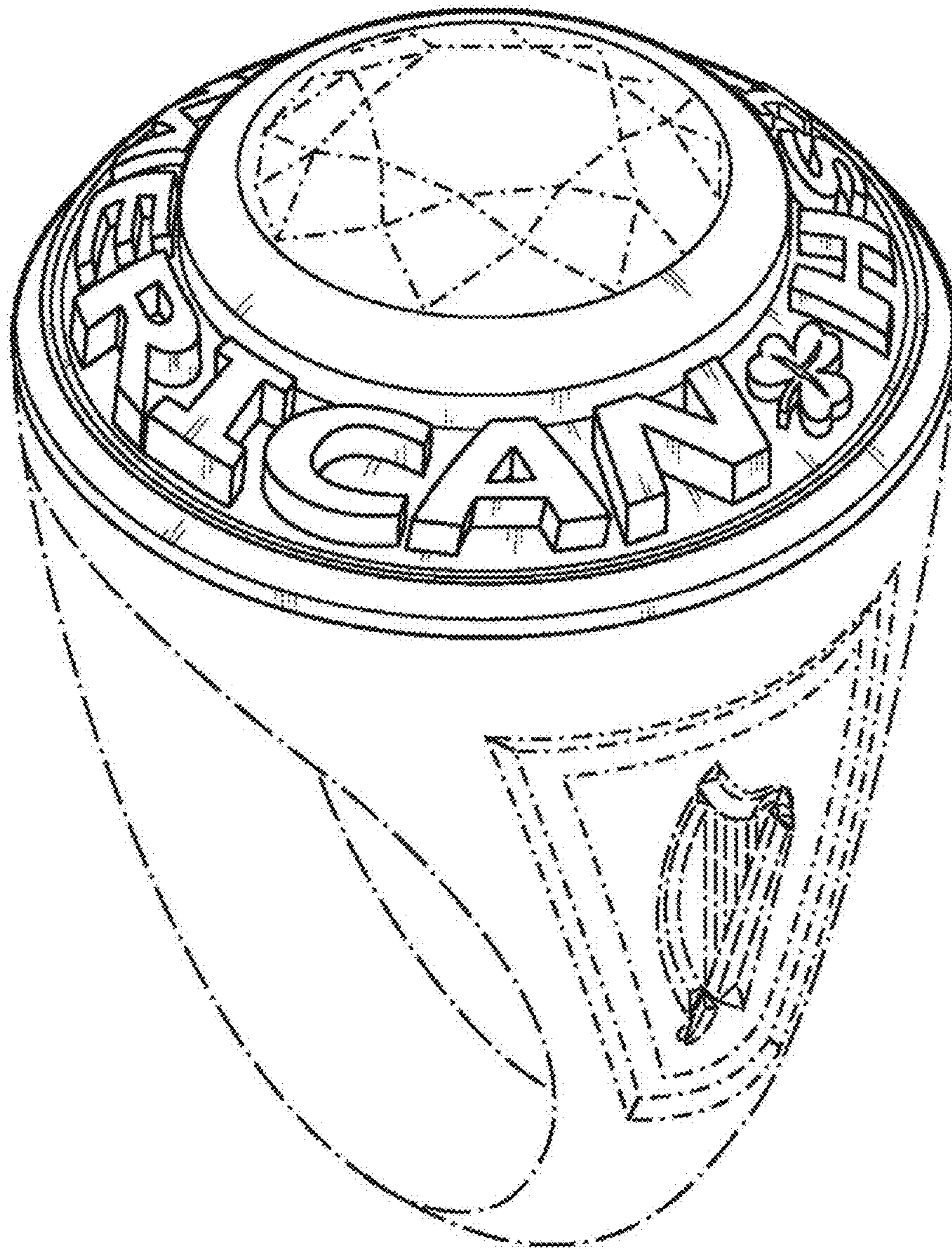

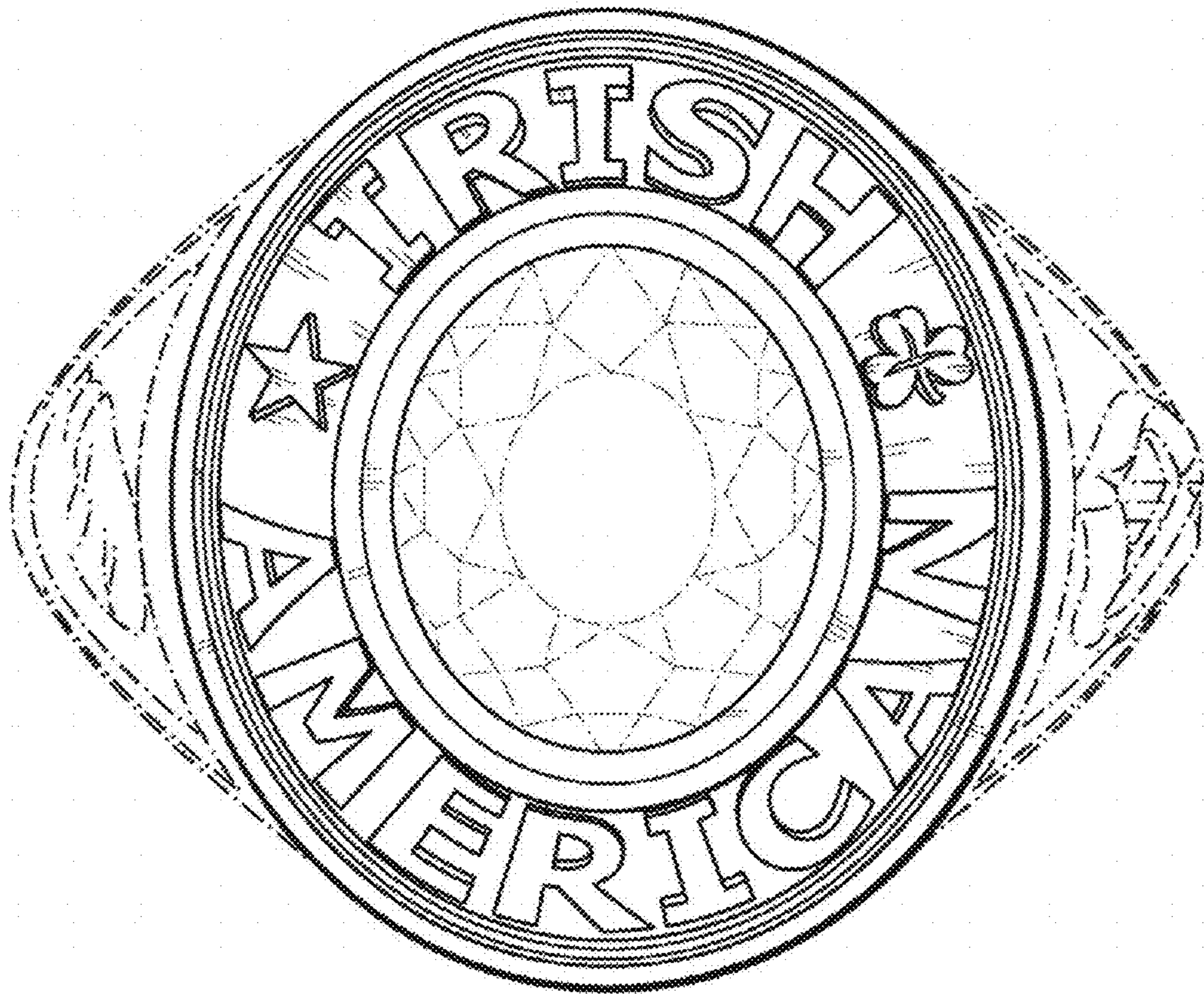

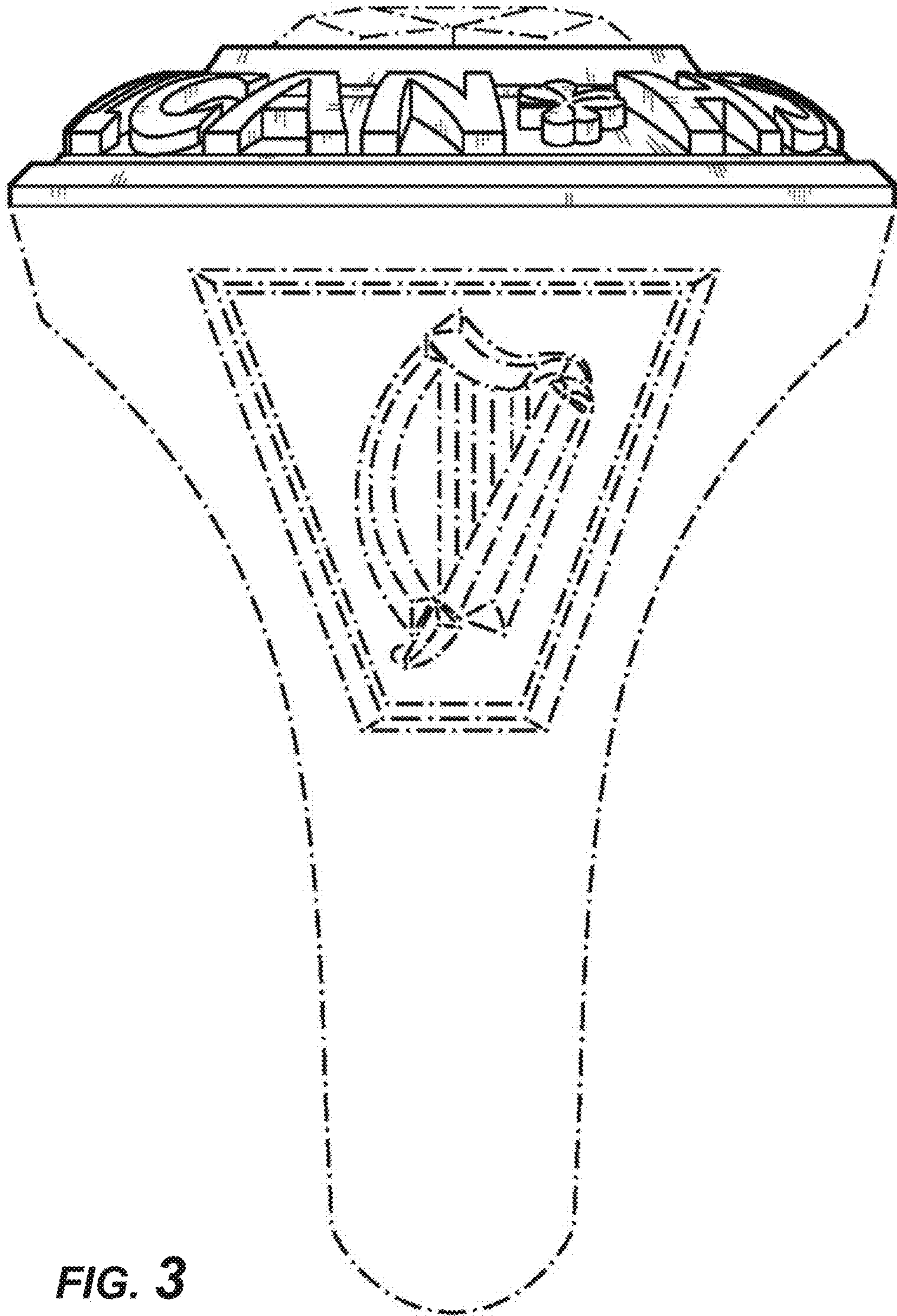

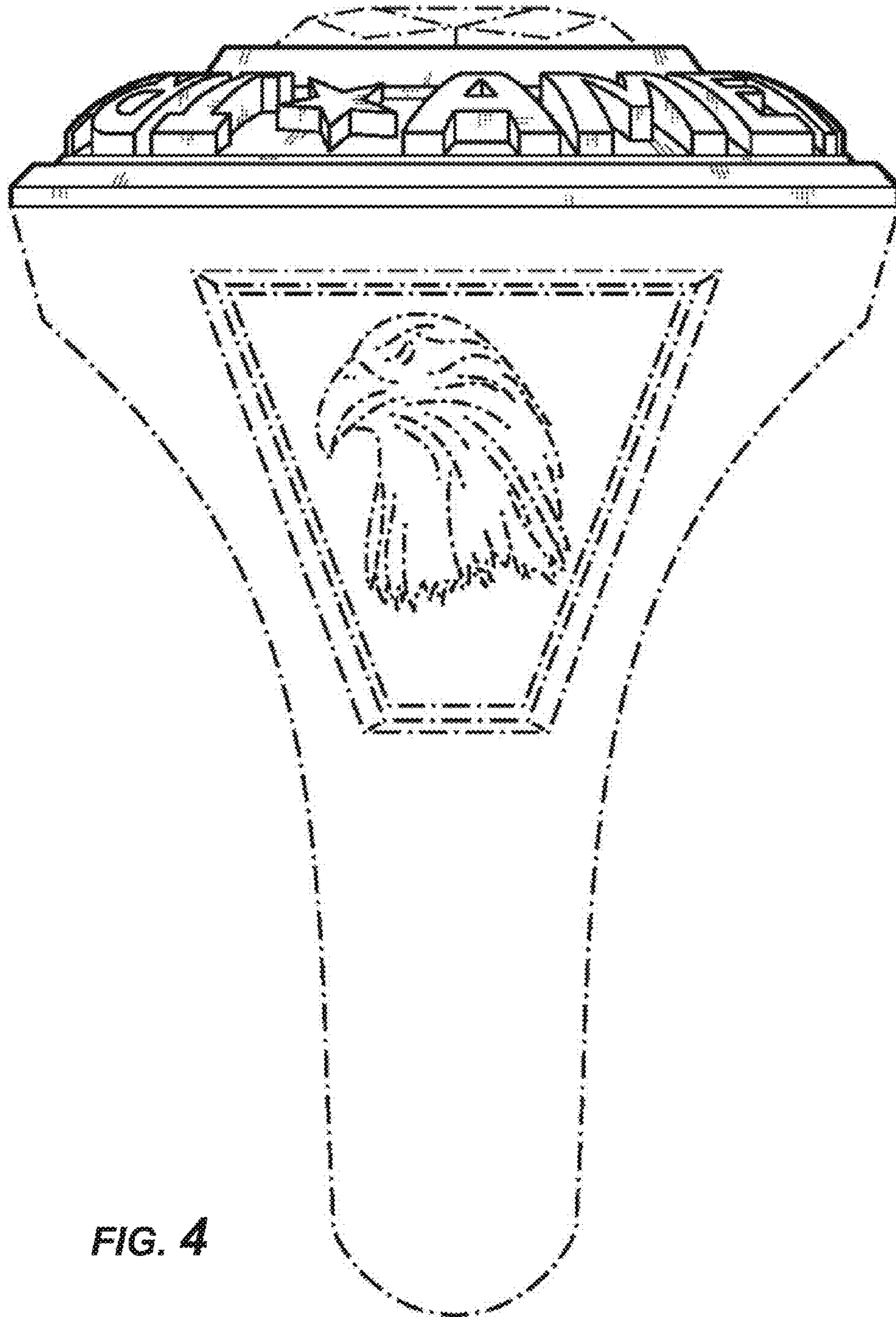

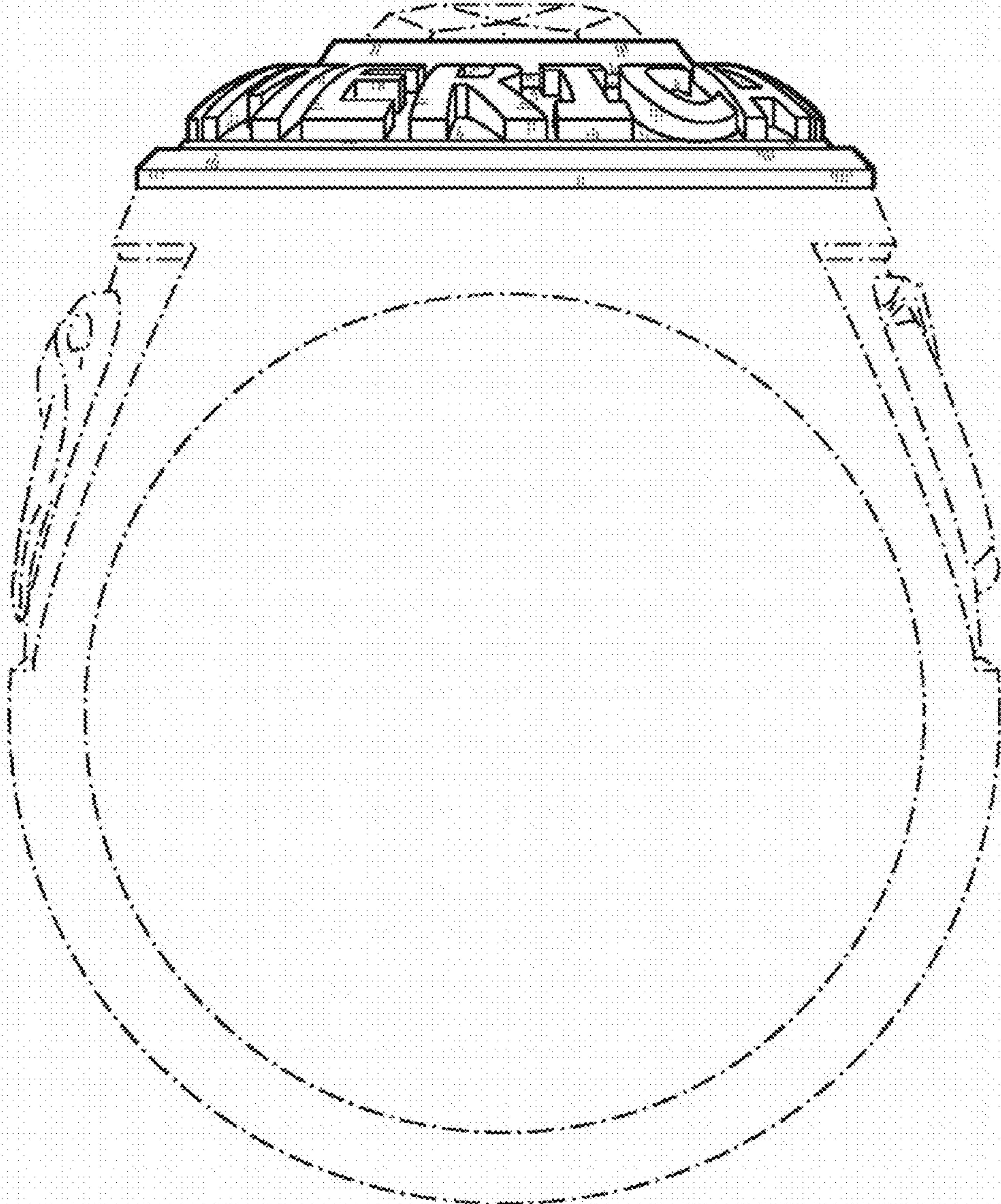

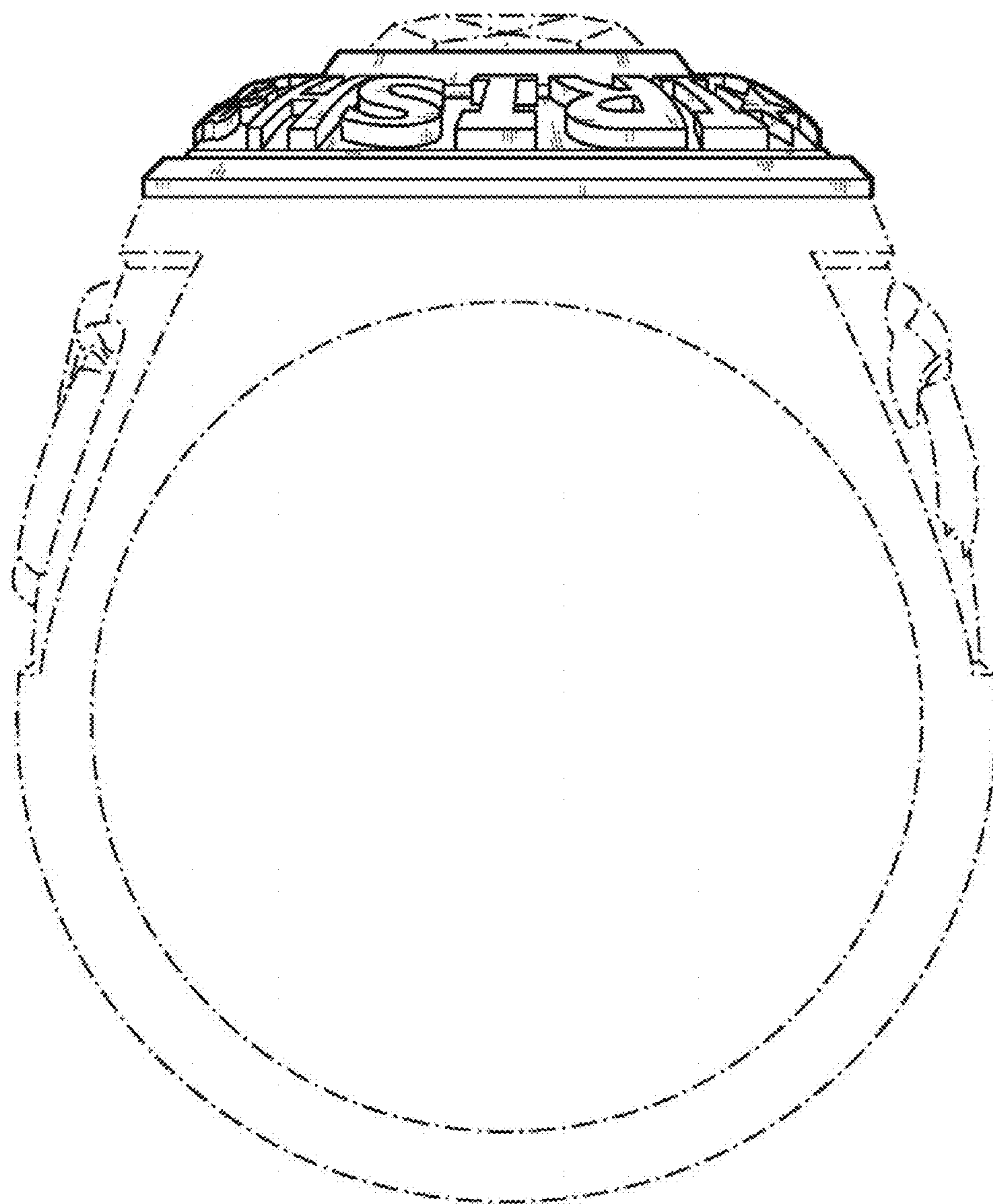

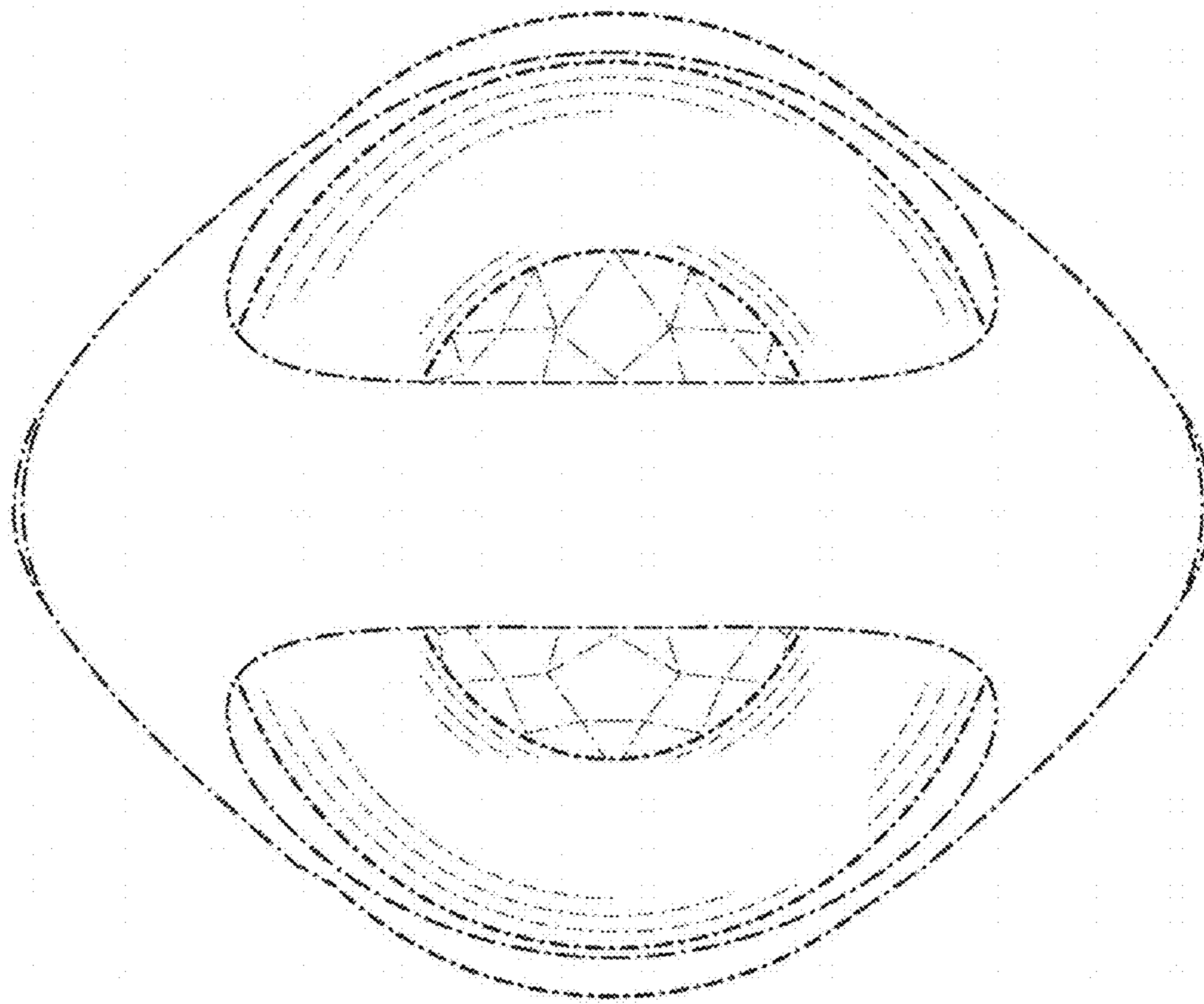
