I claim the ornamental design for a potted plant stabilizer, as shown and described.

DESCRIPTION

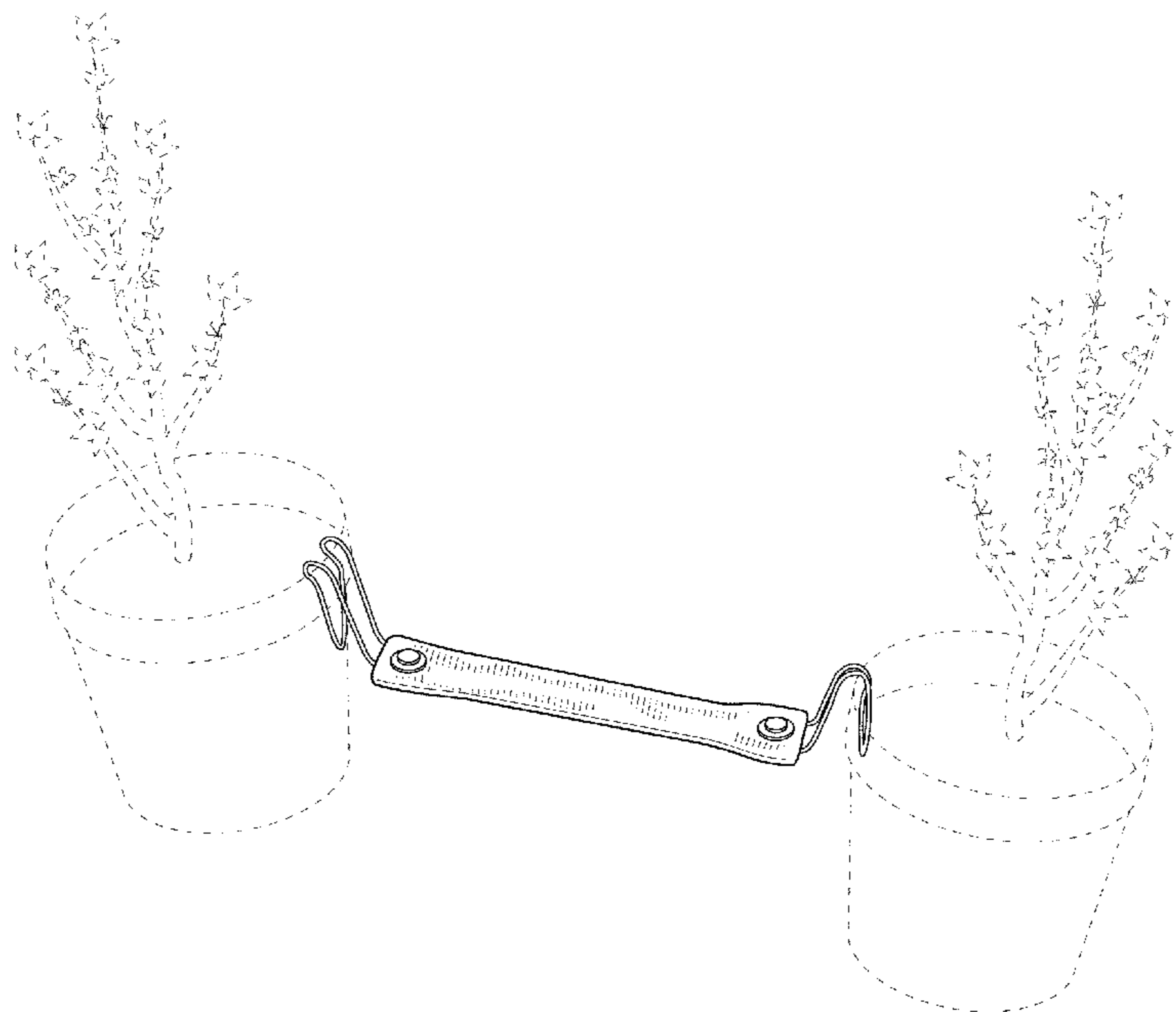
FIG. 1 is a top perspective view of a potted plant stabilizer, showing my new design;
 FIG. 2 is a bottom perspective view thereof;
 FIG. 3 is a left-side elevational view thereof, the right-side elevational view being a mirror image thereof;
 FIG. 4 is a front elevational view thereof, the rear elevational view being a mirror image thereof;
 FIG. 5 is a top plan view thereof; and,
 FIG. 6 is a bottom plan view thereof.
 The broken lines showing a pair of potted plants in FIG. 1 depict environmental matter and form no part of the claimed design.

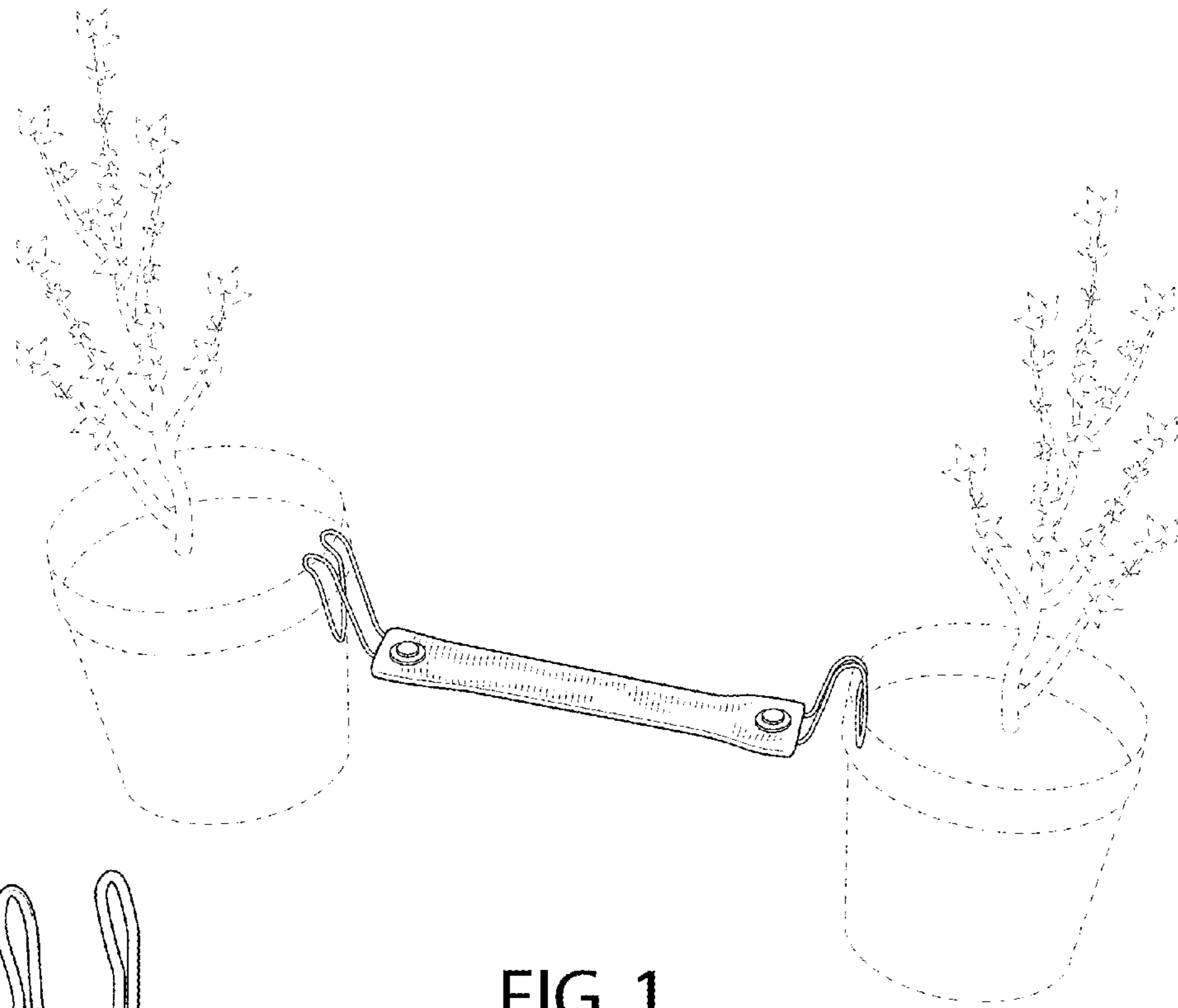

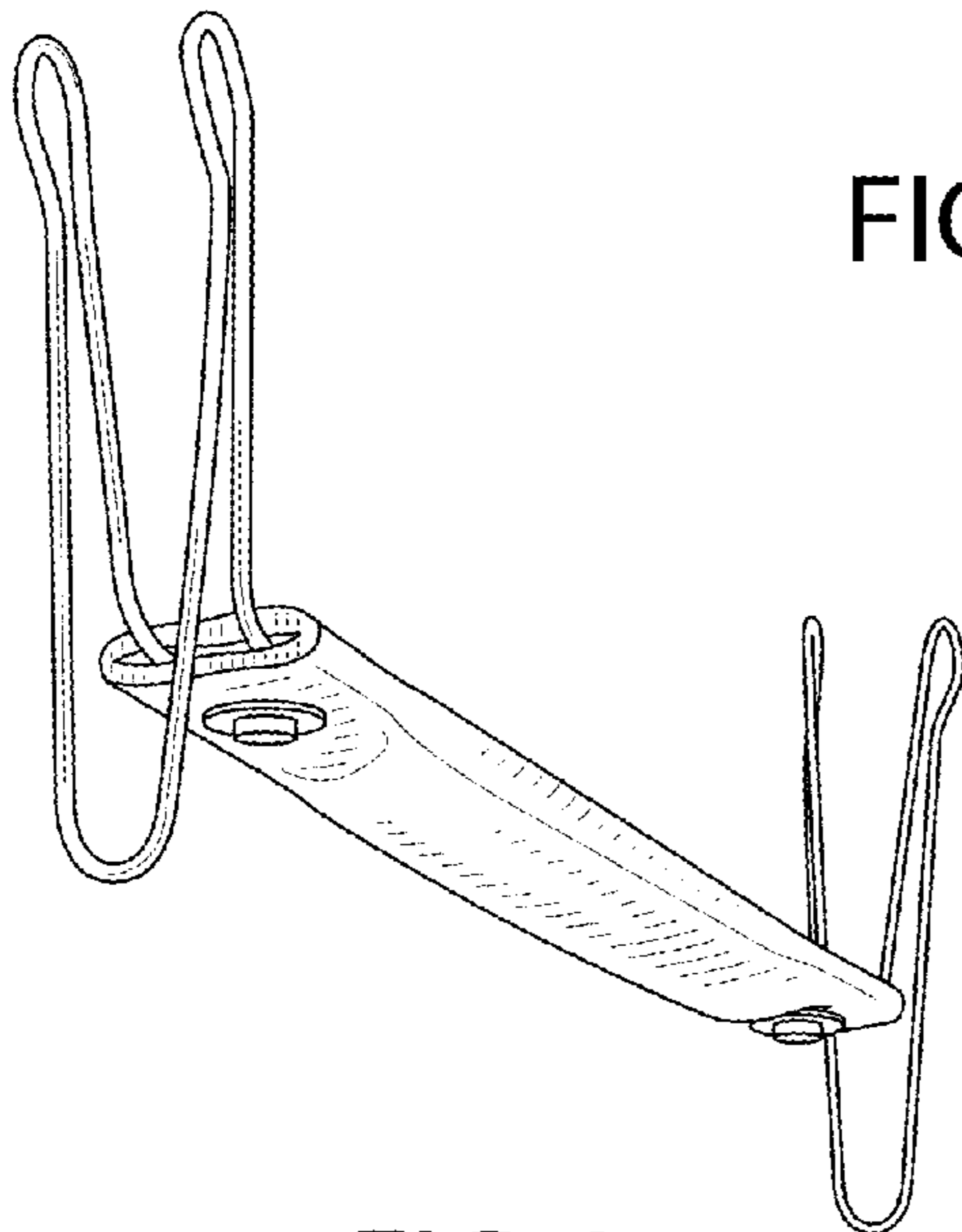

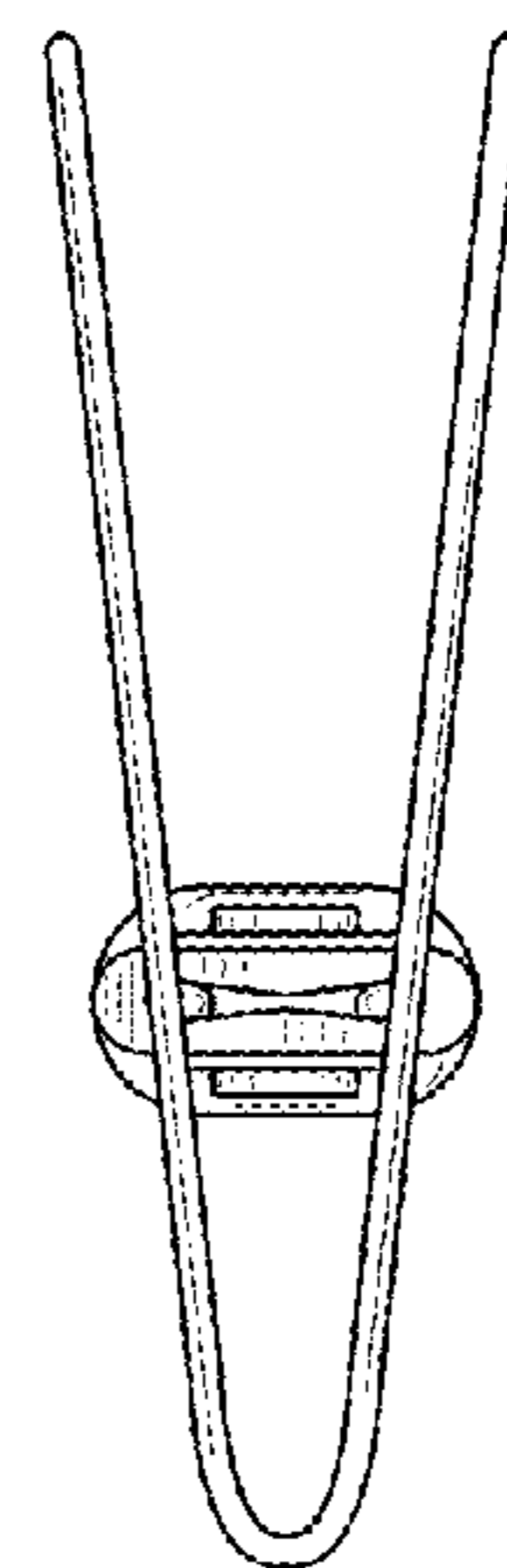

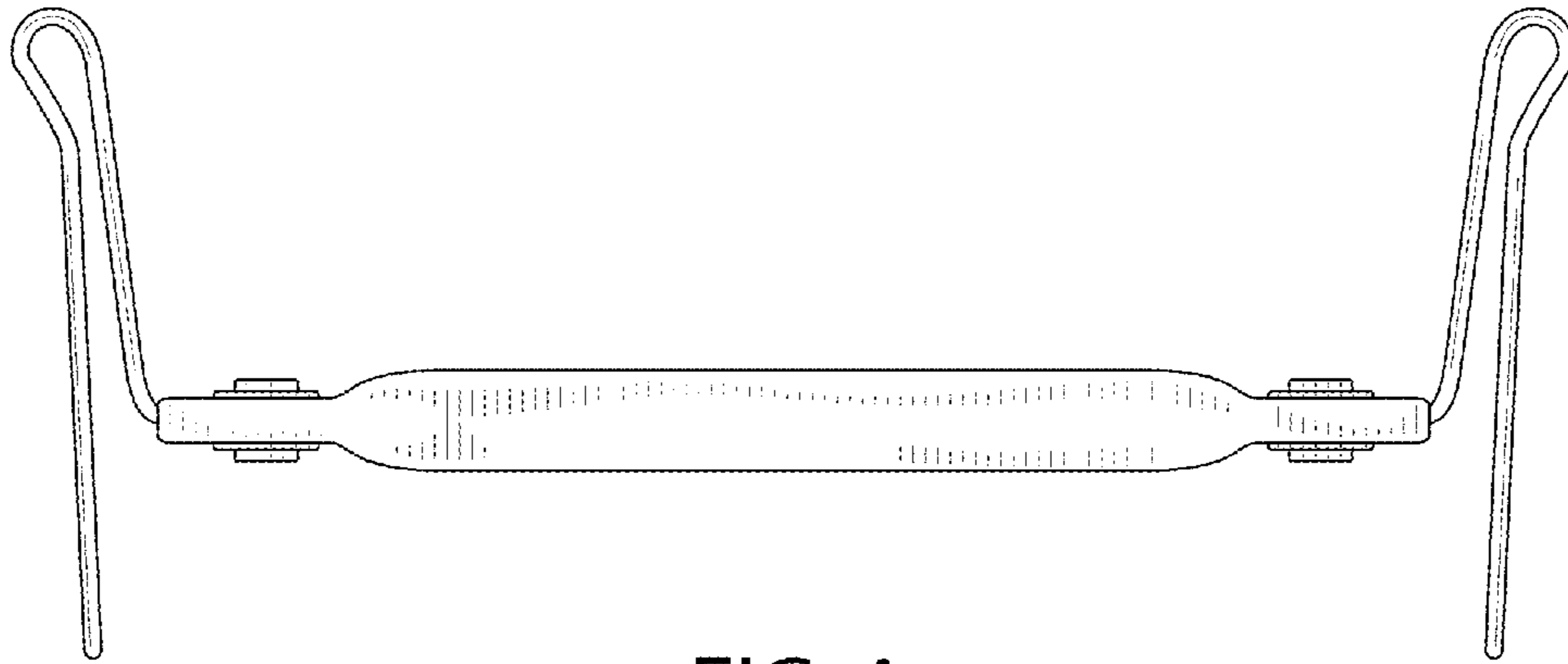

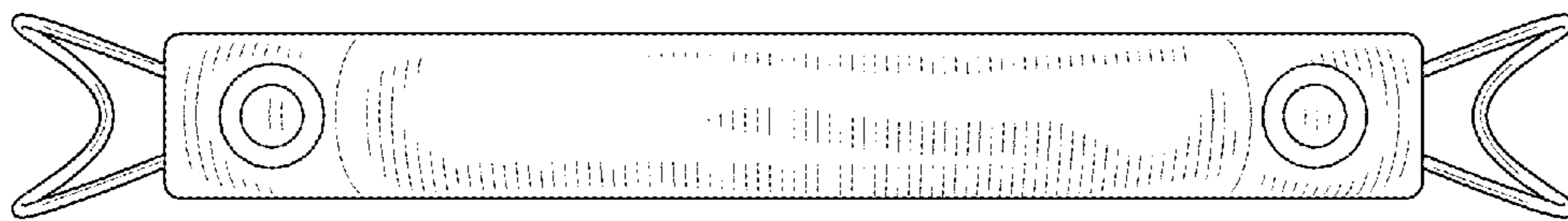

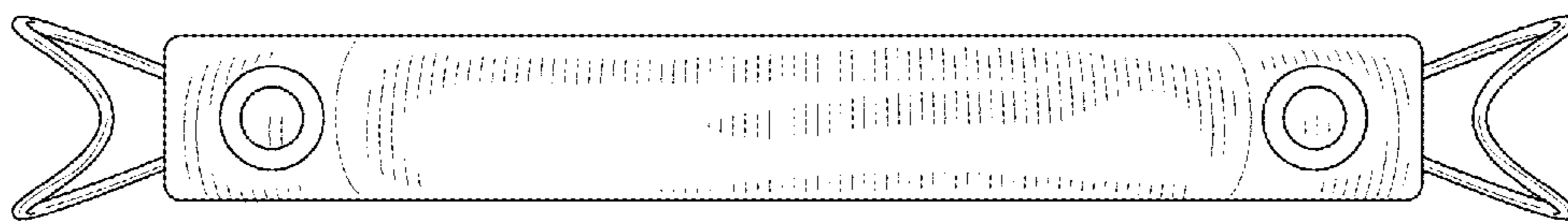
