device, as shown and described.

DESCRIPTION

FIG. 11 is a right side elevational view thereof

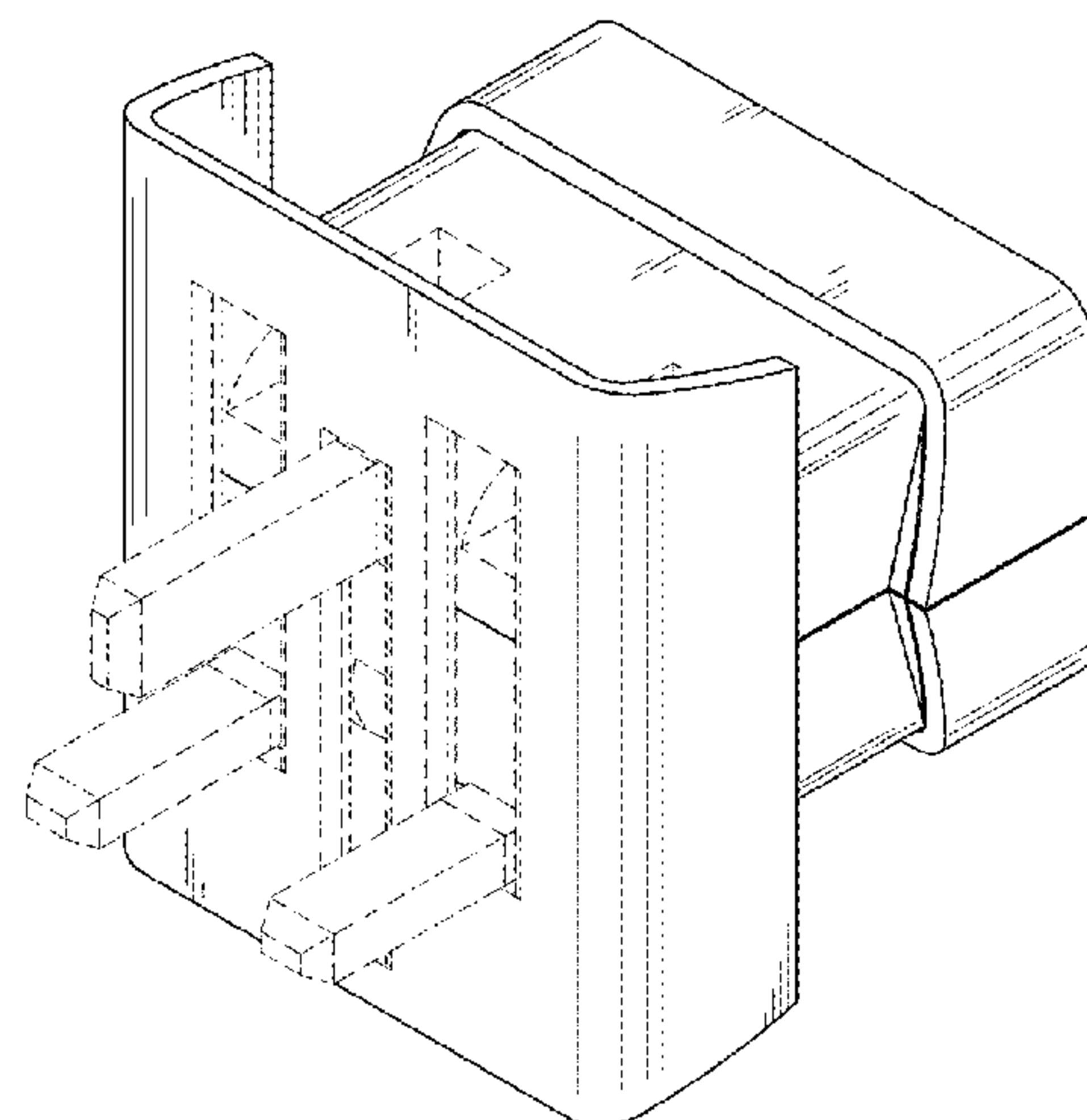
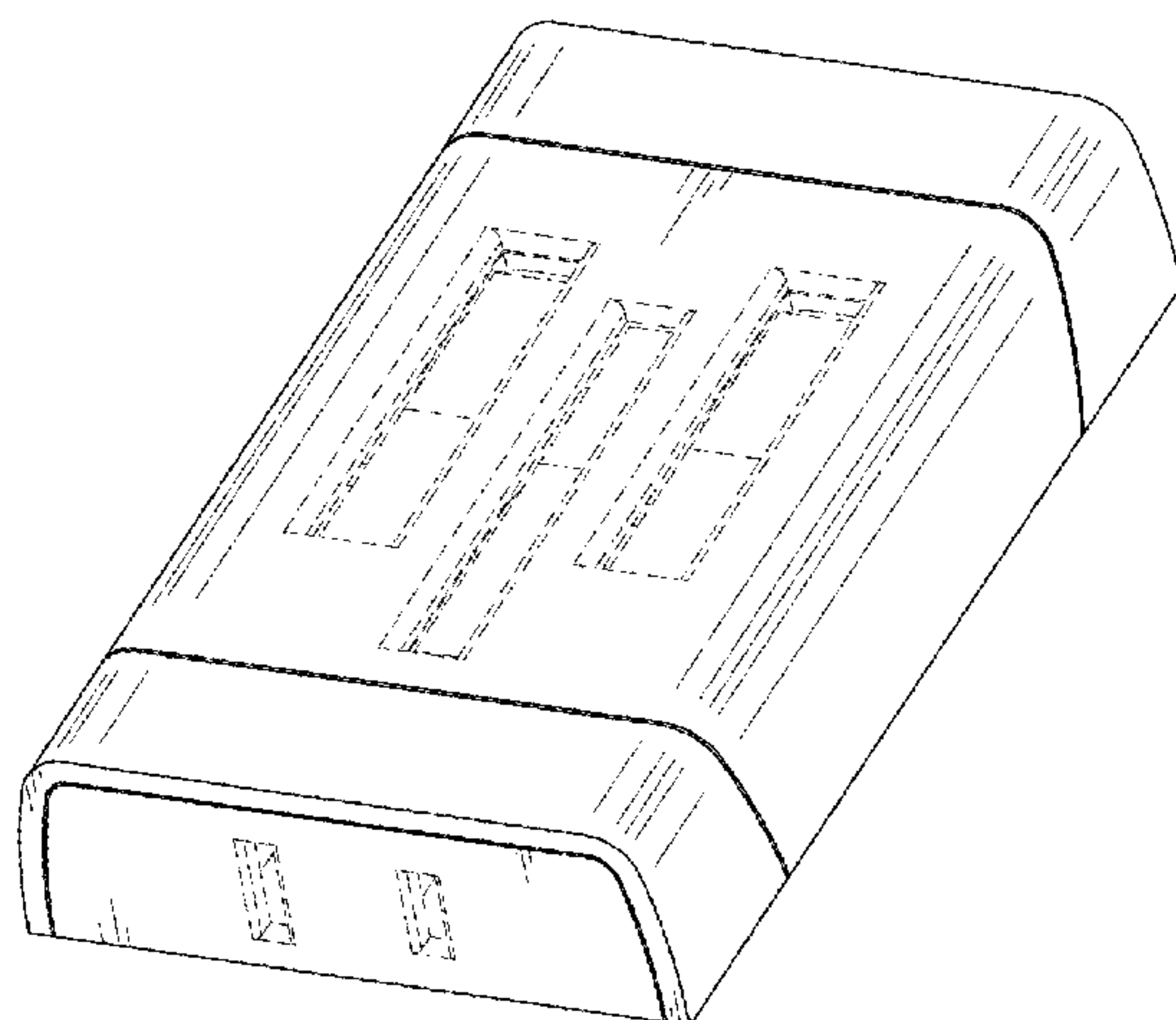
FIG. 12 is a left side elevational view thereof.

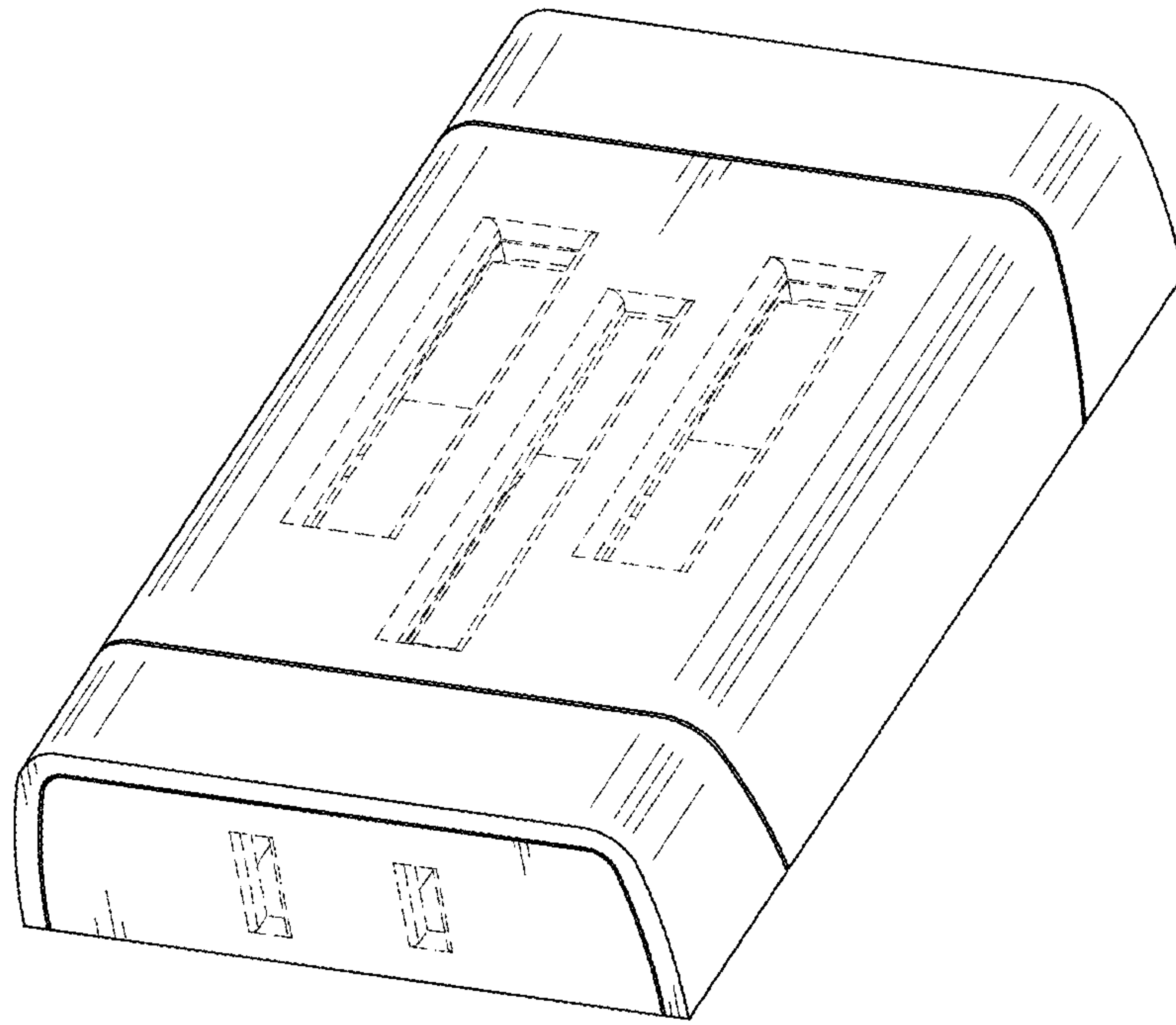

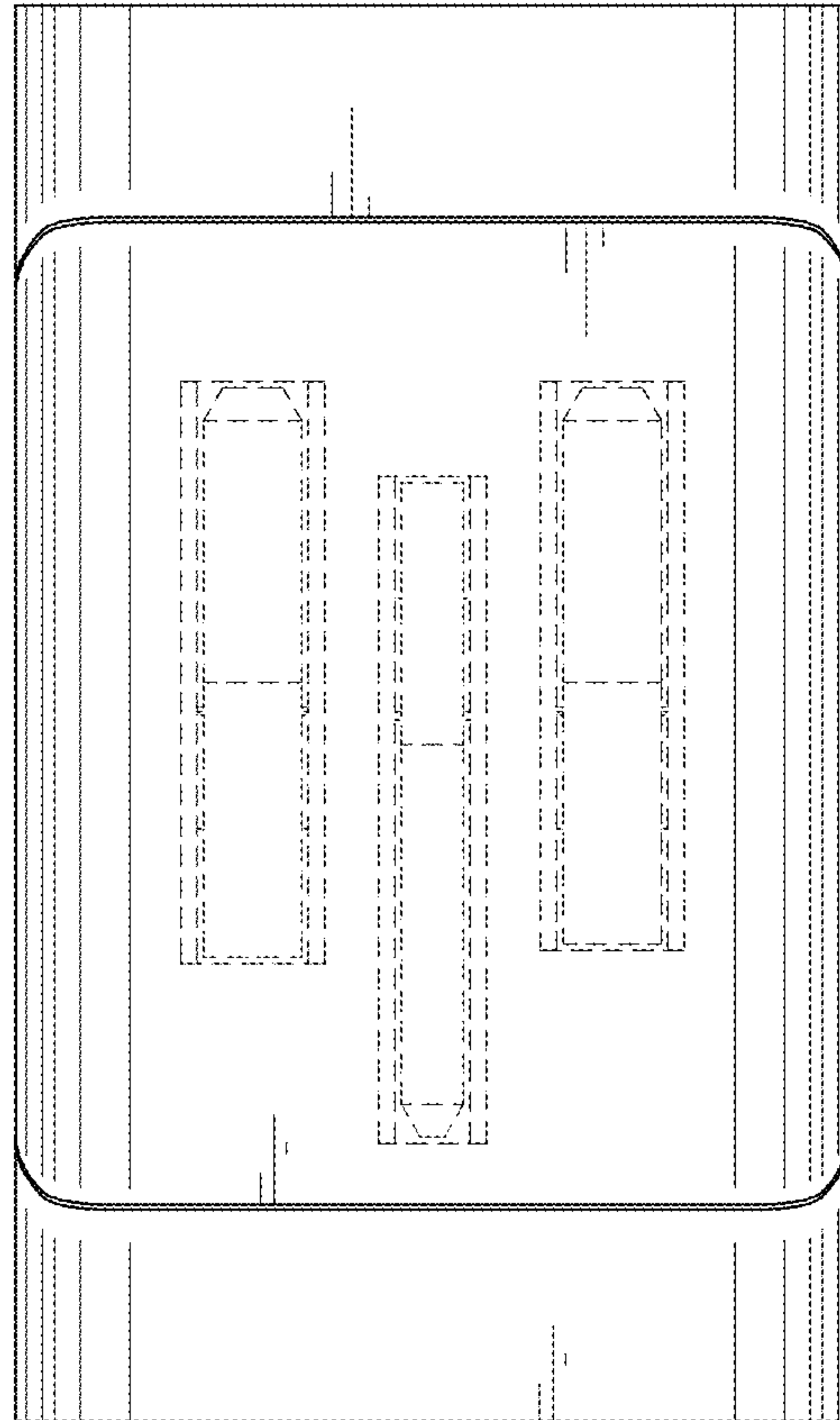

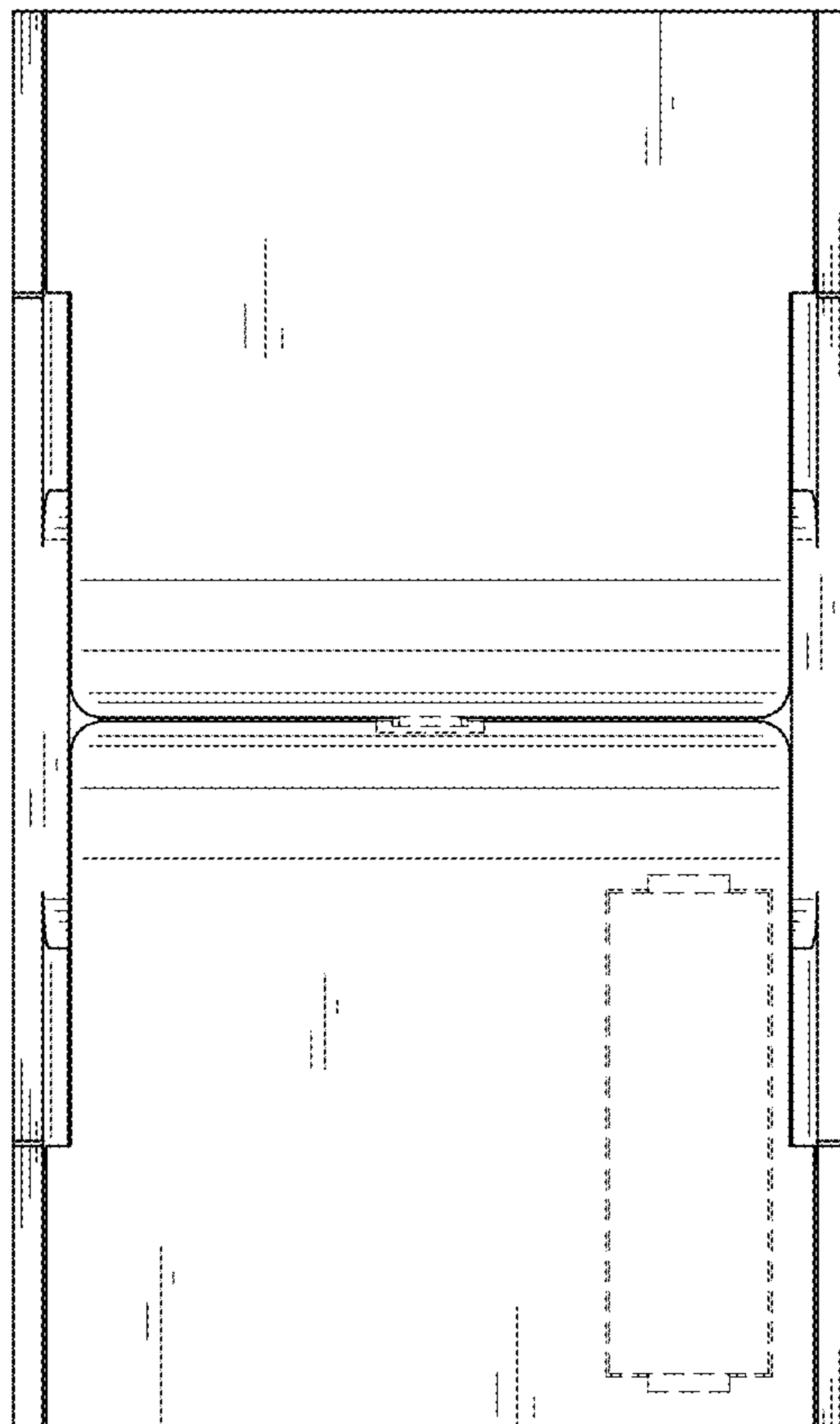

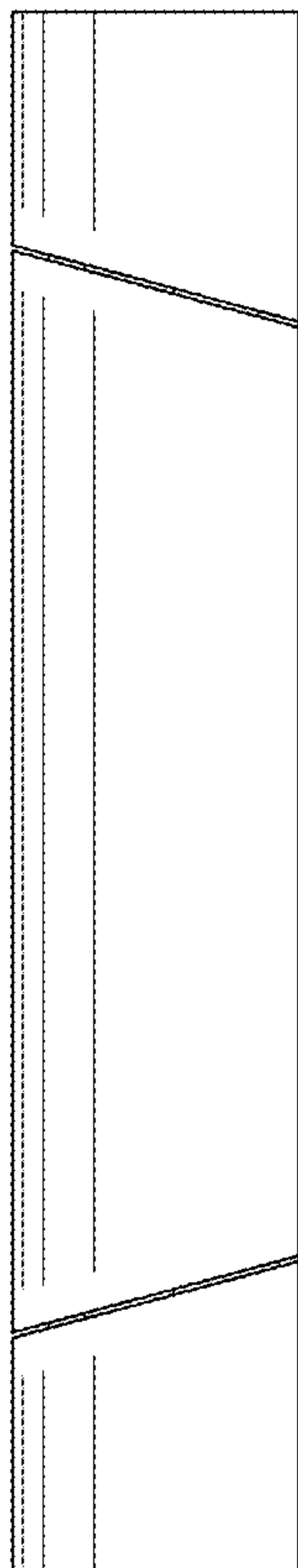

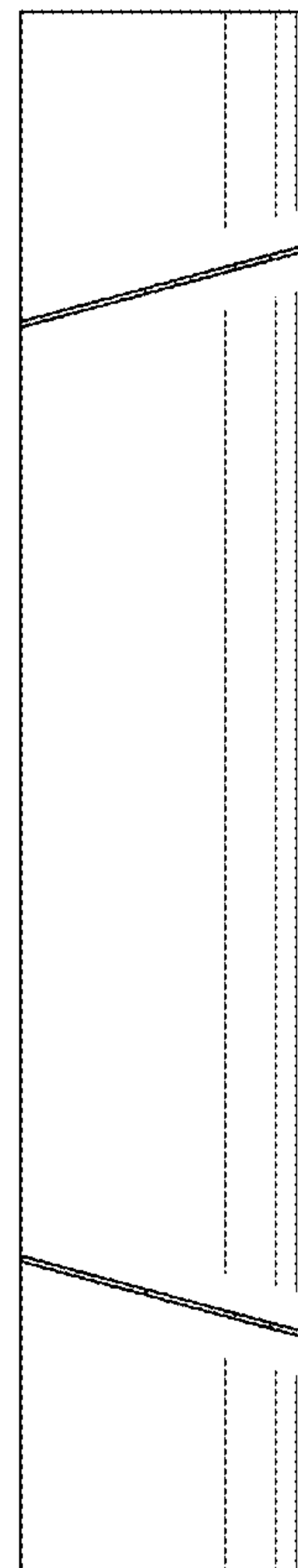

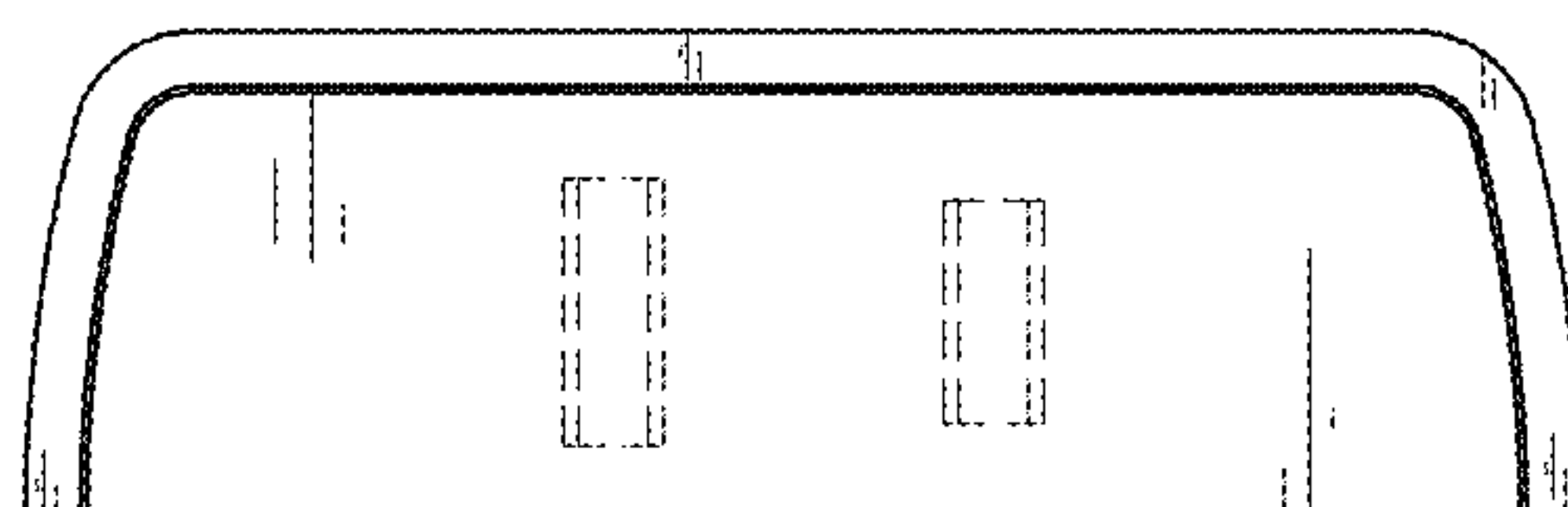

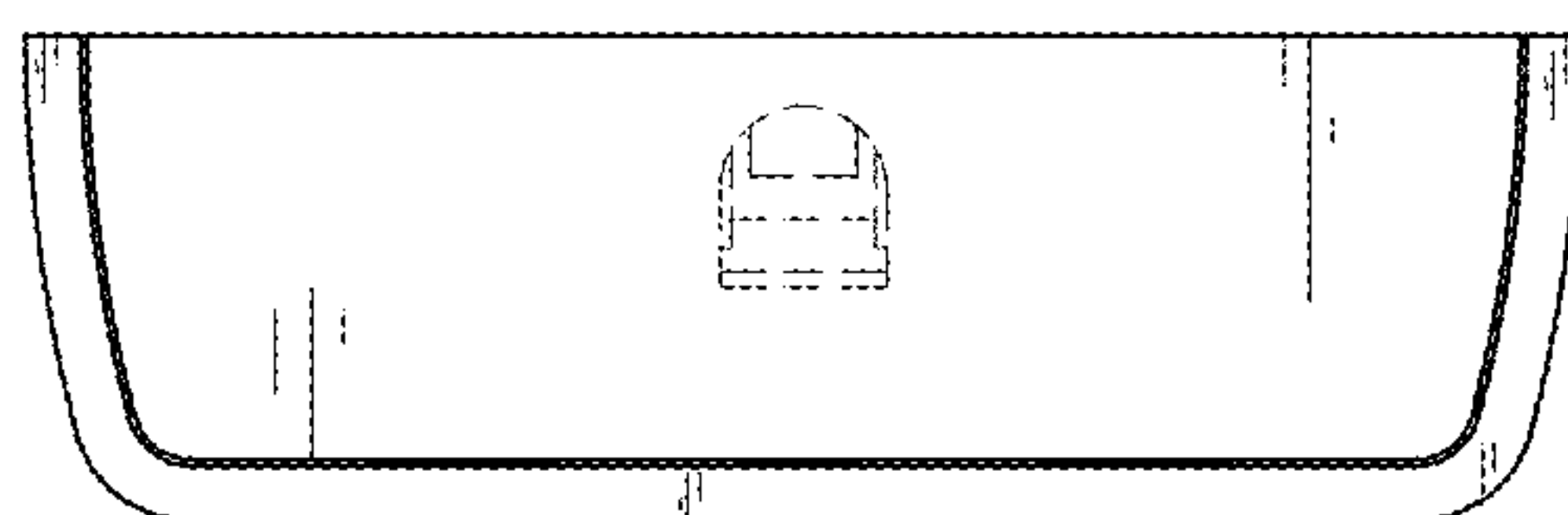

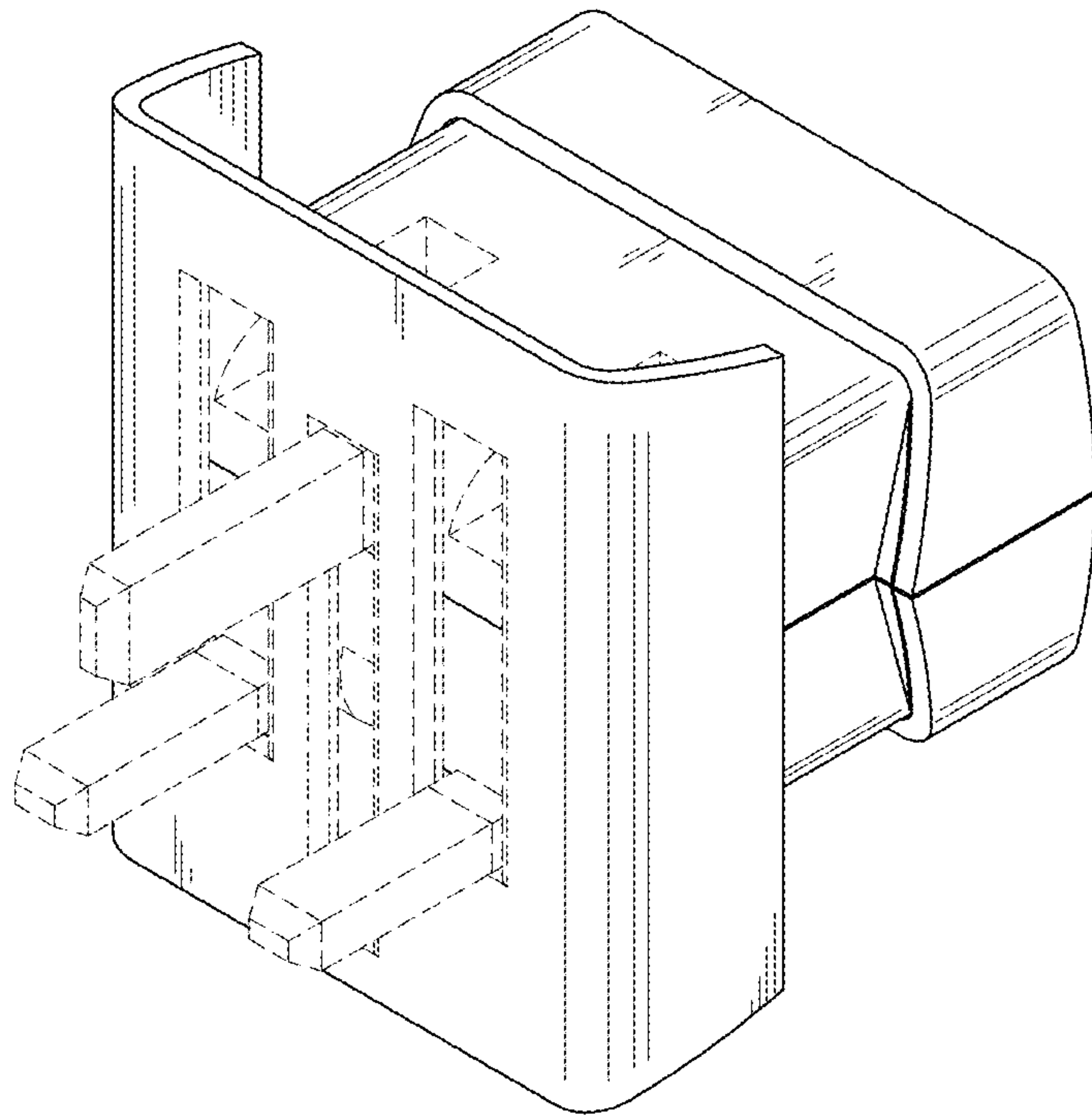

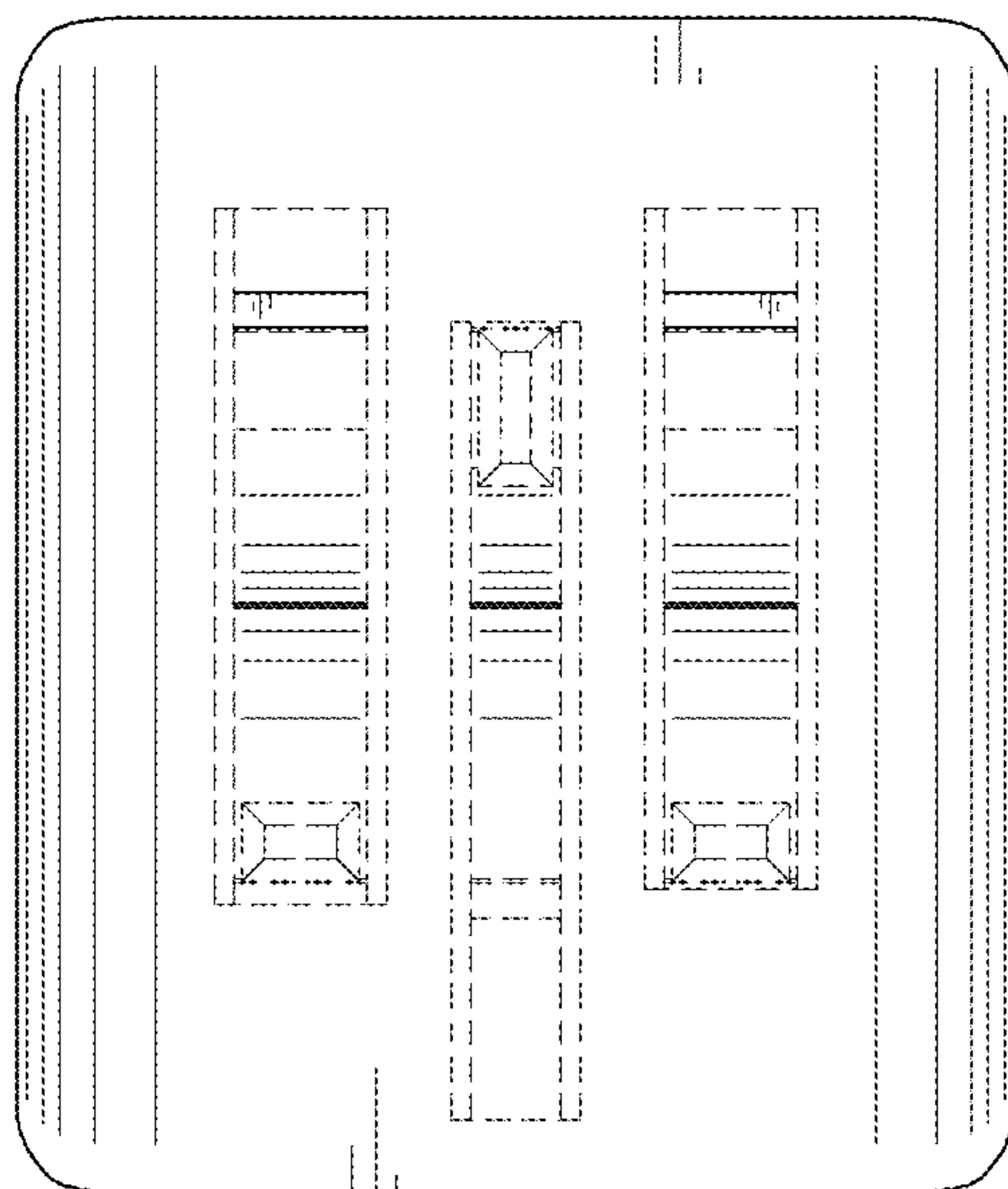

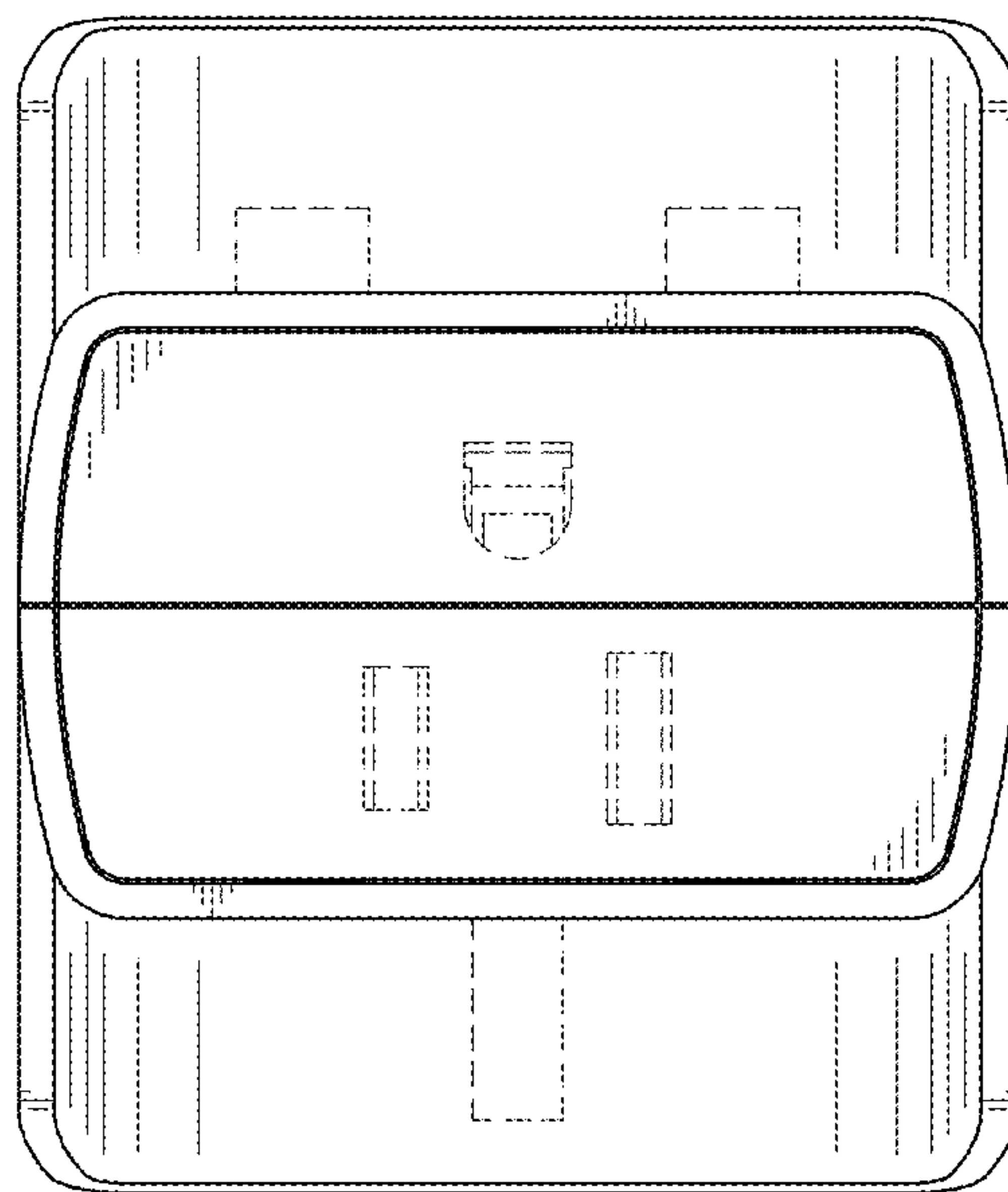

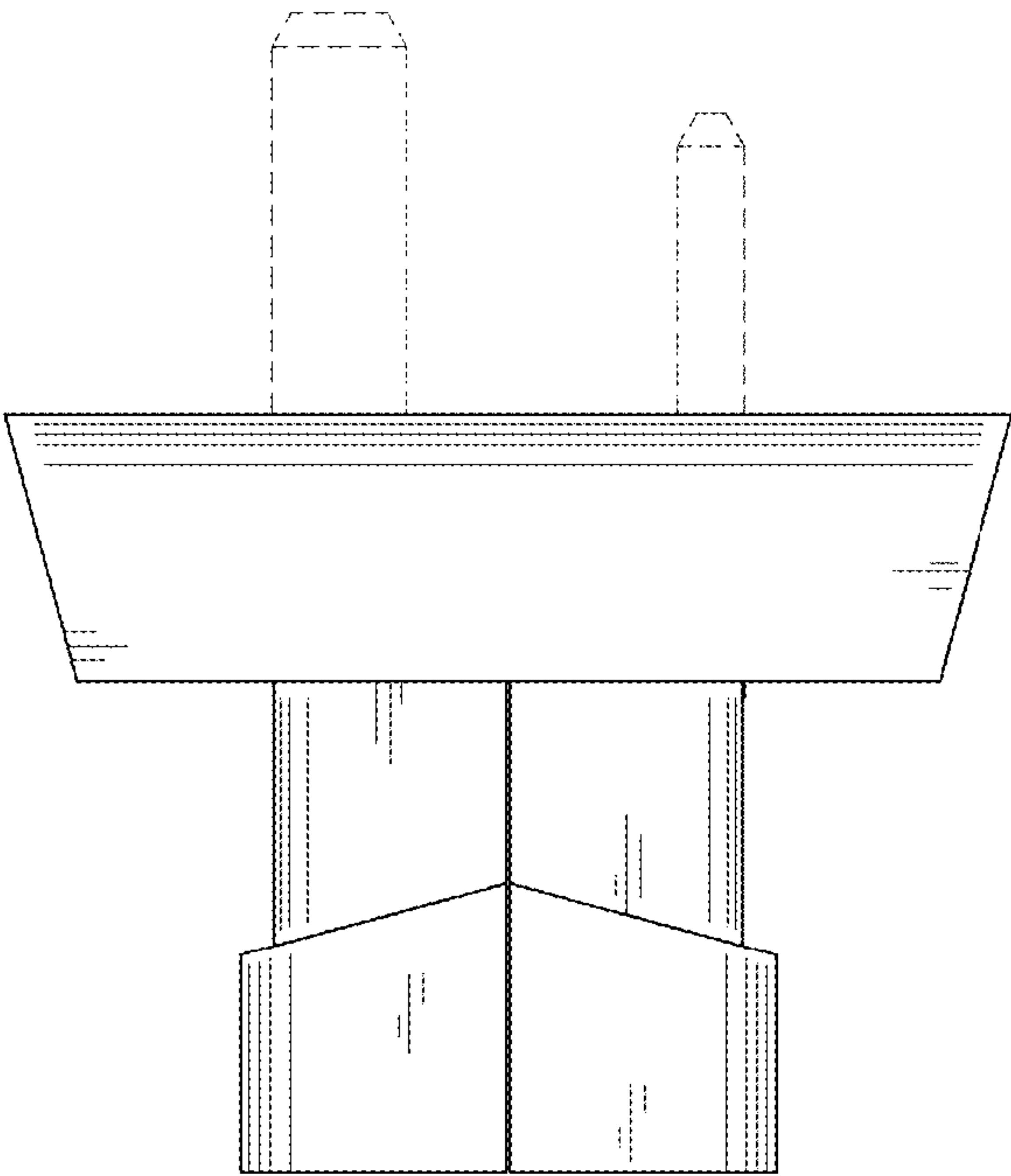

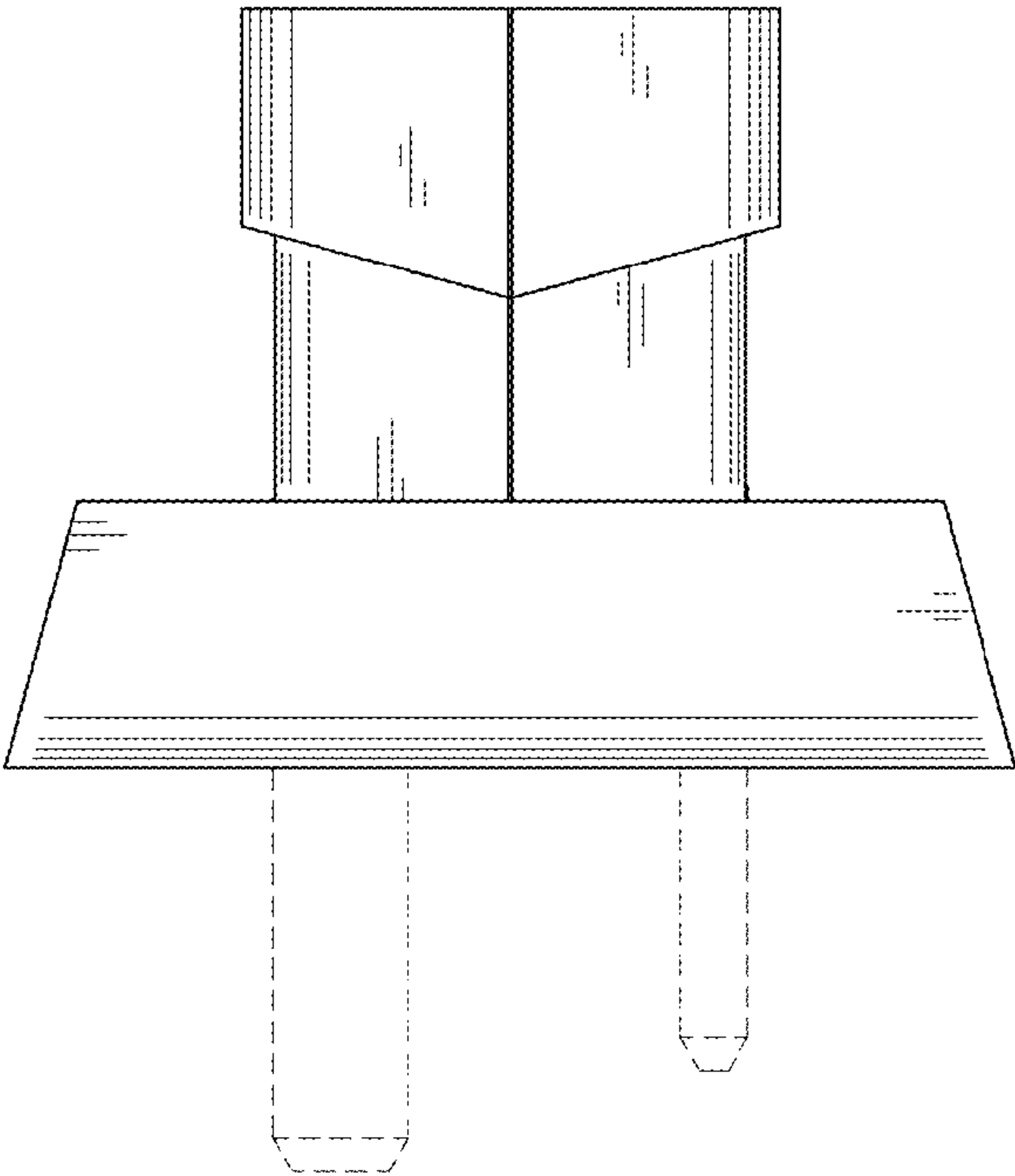

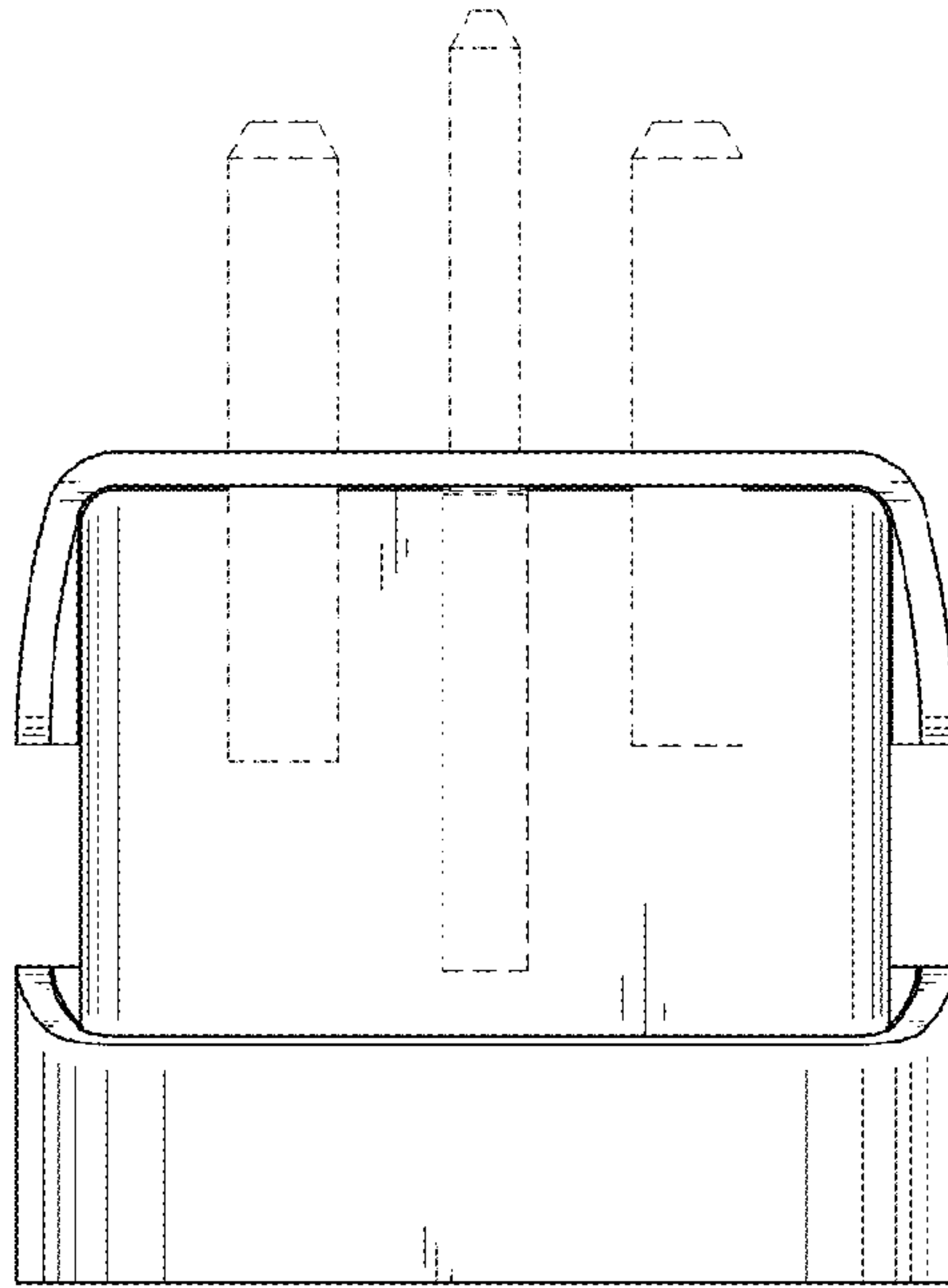

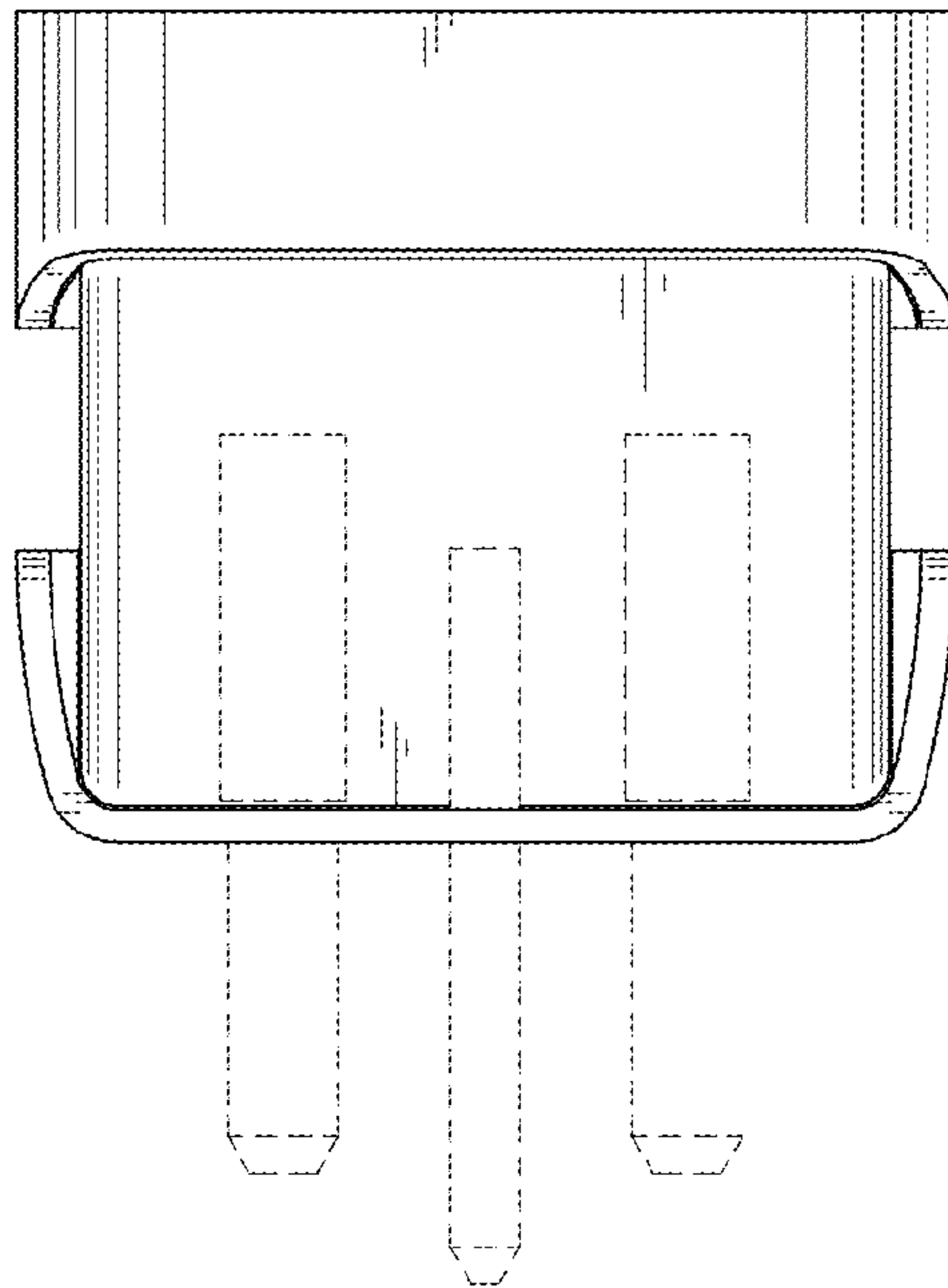
