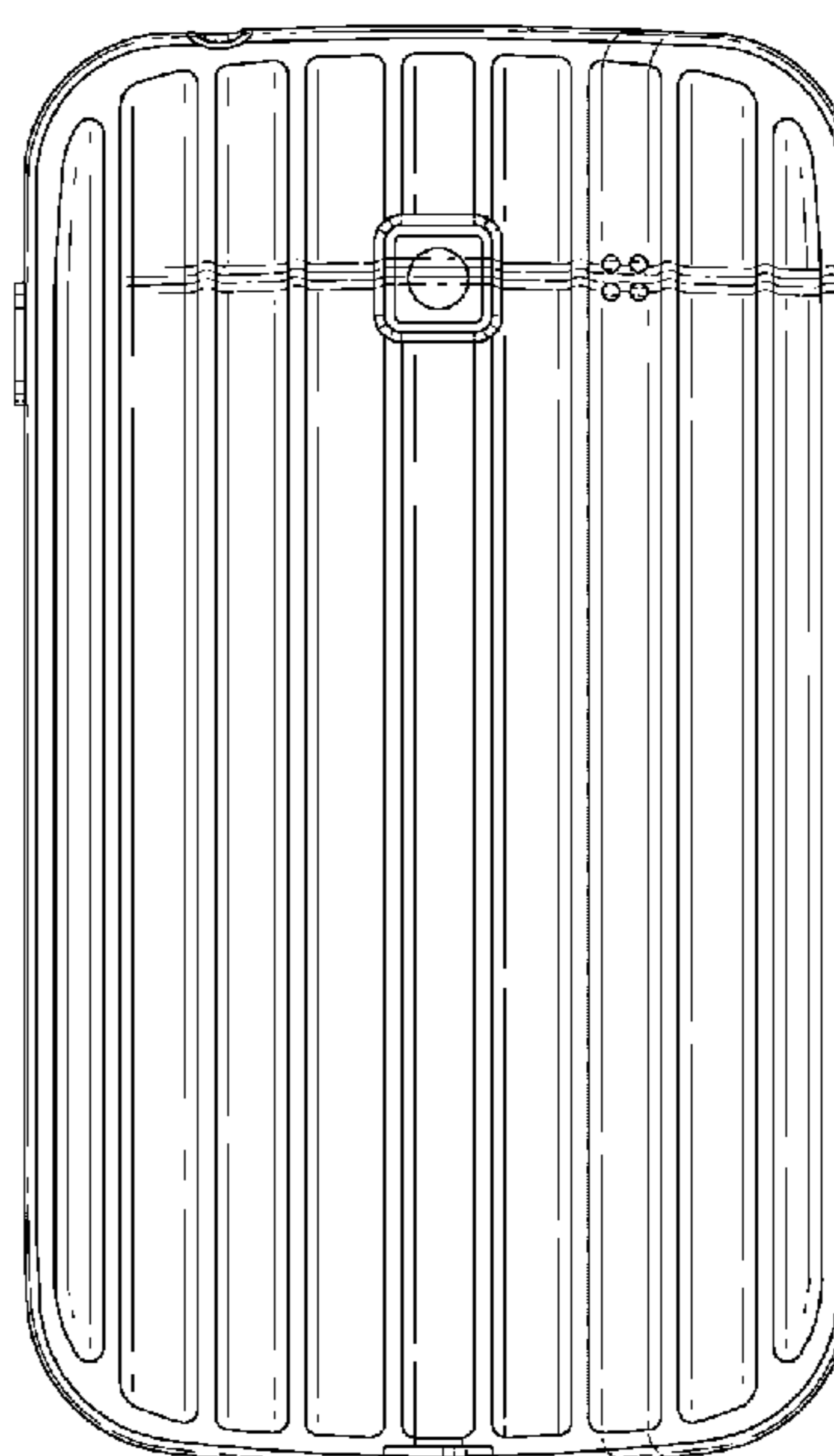
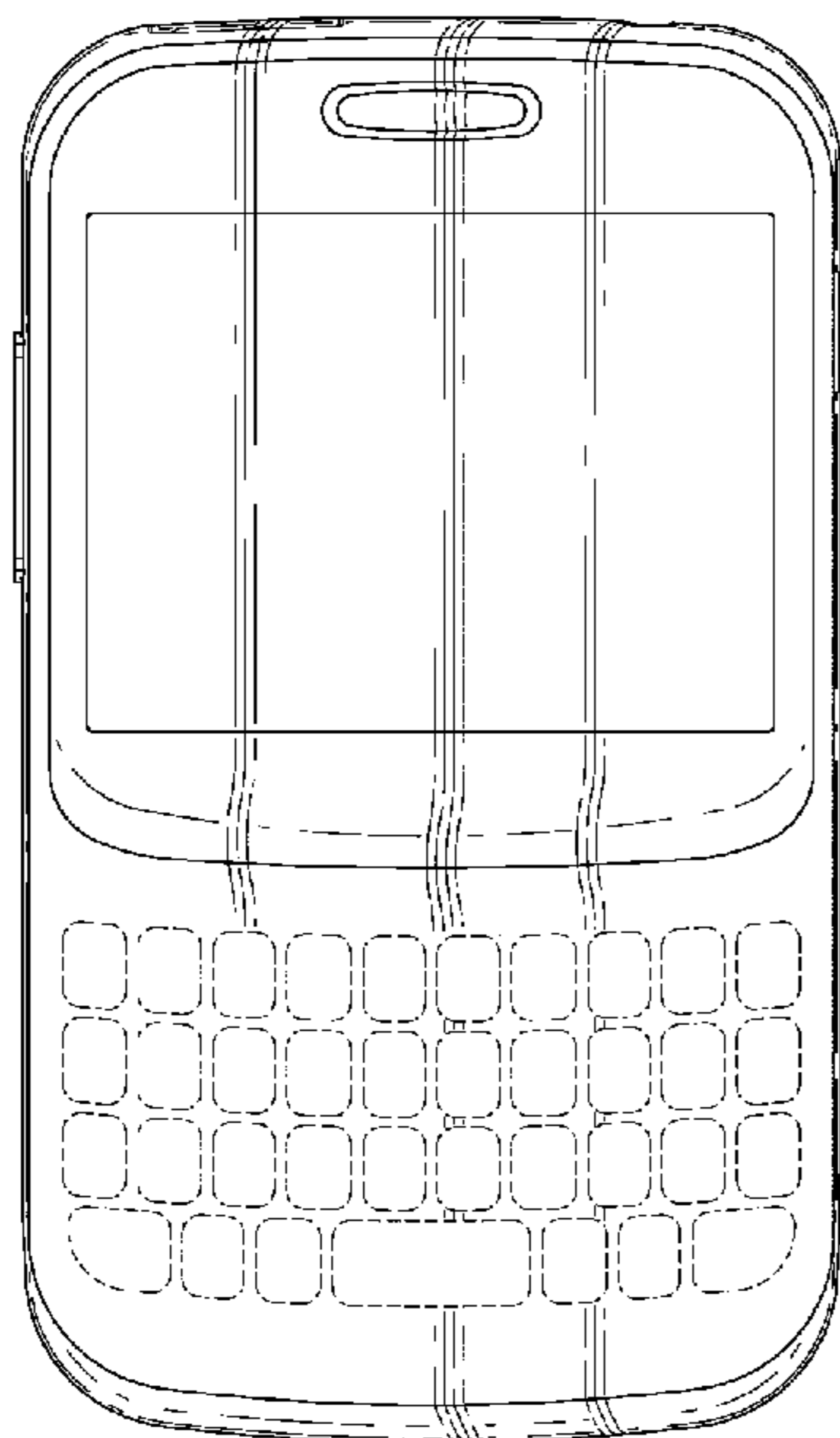
(57) **CLAIM**

The ornamental design for a mobile terminal, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a mobile terminal; FIG. 2 is a front view of the mobile terminal of FIG. 1; FIG. 3 is a rear view of the mobile terminal of FIG. 1; FIG. 4 is a left-side view of the mobile terminal of FIG. 1; FIG. 5 is a right-side view of the mobile terminal of FIG. 1; FIG. 6 is a top plan view of the mobile terminal of FIG. 1; and, FIG. 7 is a bottom plan view of the mobile terminal of FIG. 1. The broken lines shown in the figures, which are immediately adjacent to the shaded areas and define unshaded regions, represent the bounds of the claim and are directed to environment and are for illustrative purposes only; the broken lines form no part of the claimed design. The broken lines have not been shown in FIG. 7 for convenience of illustration.

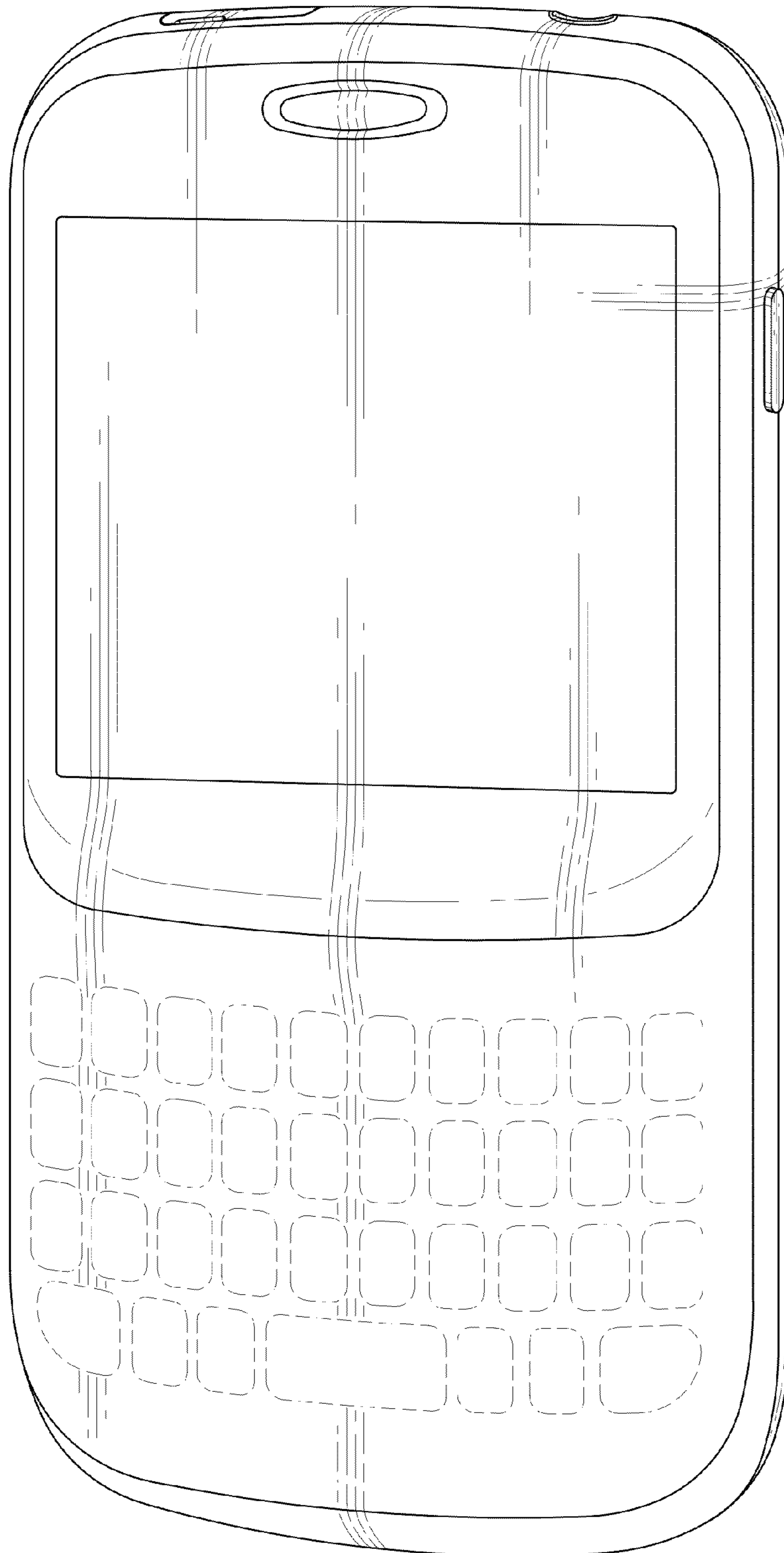

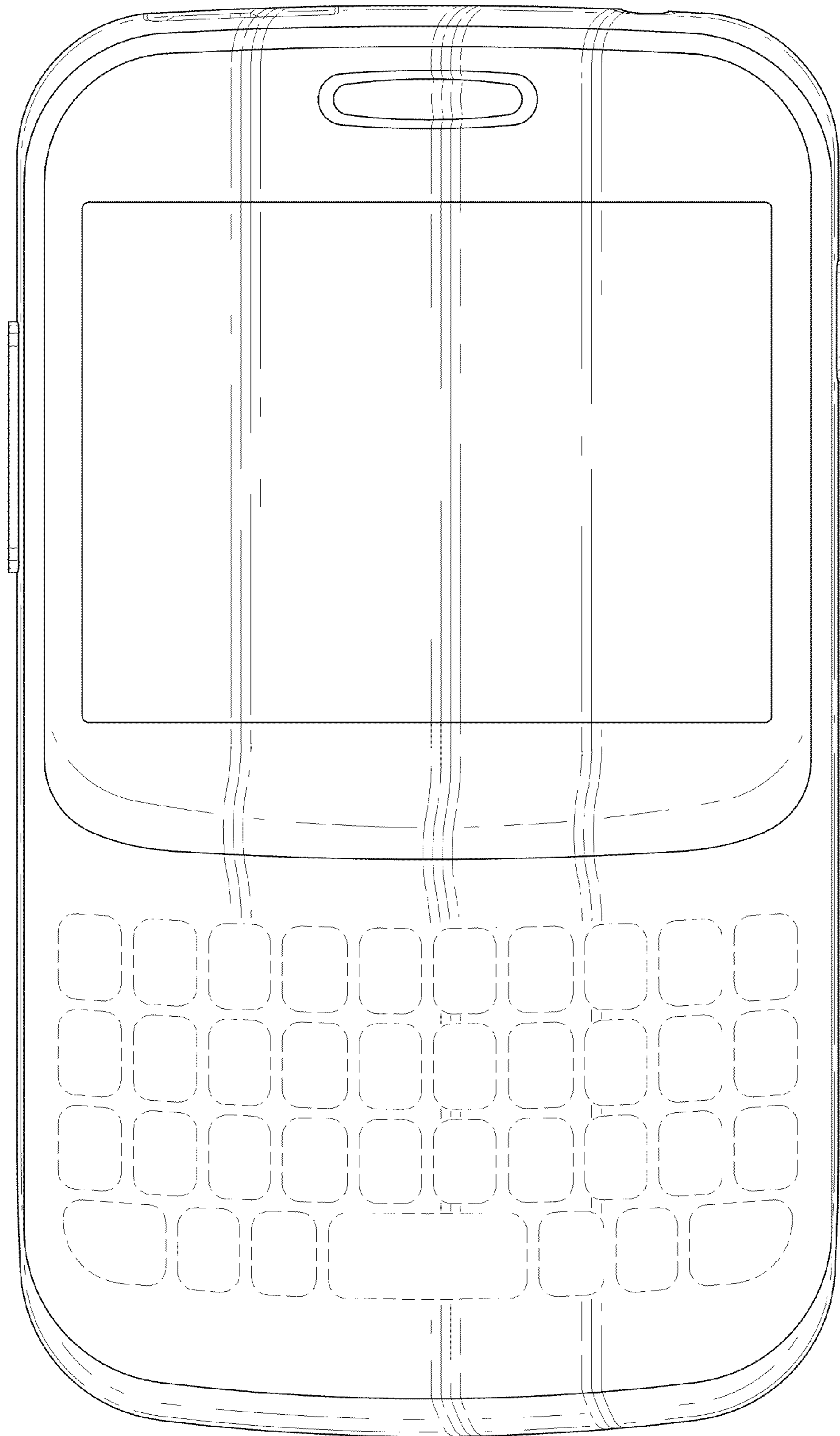

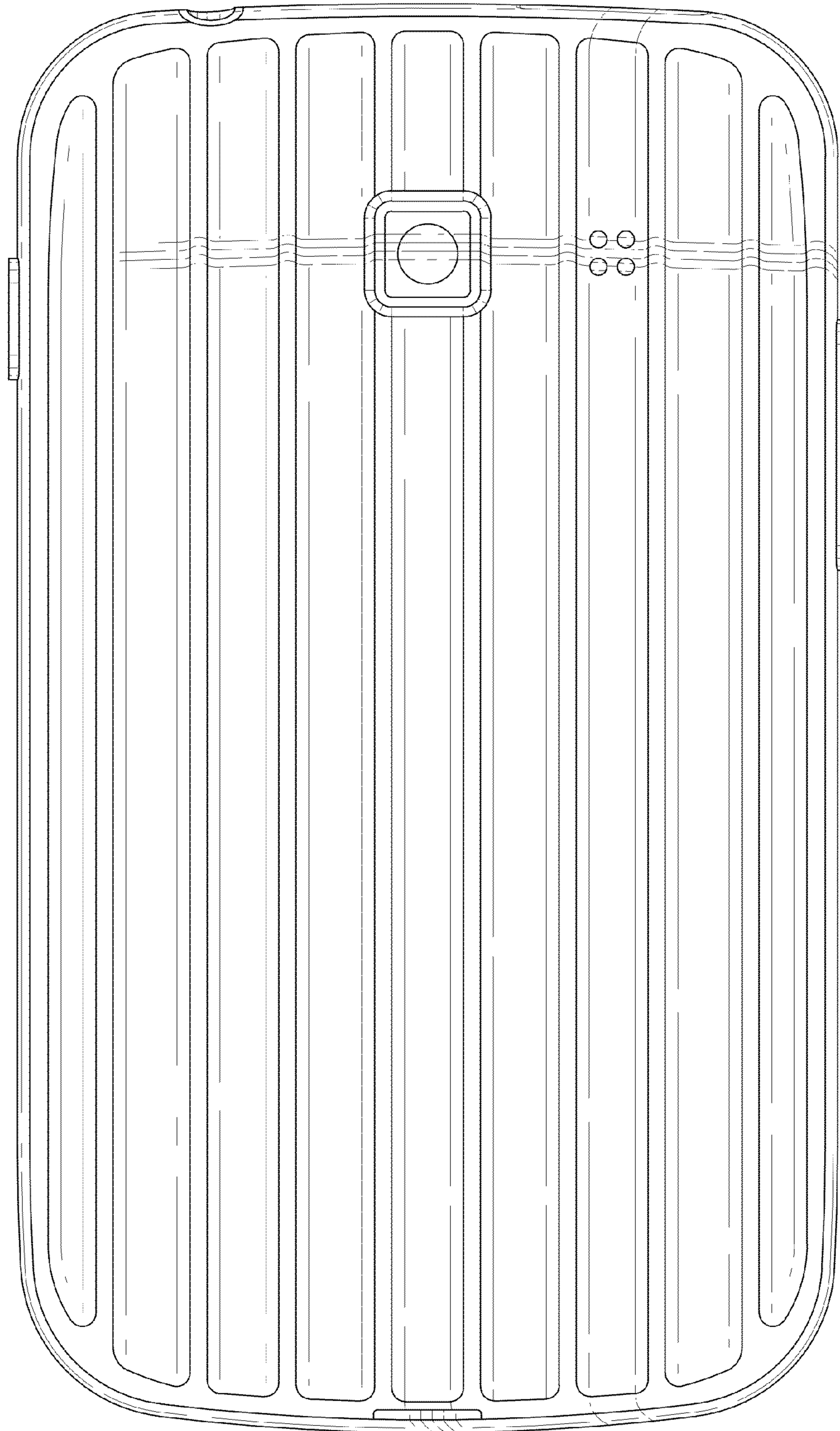

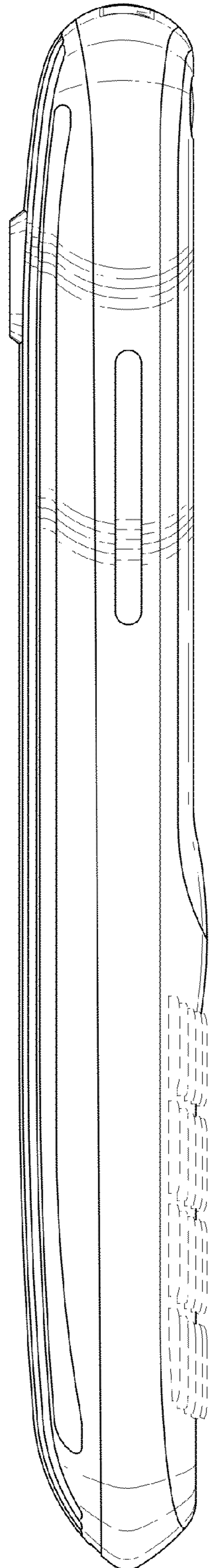

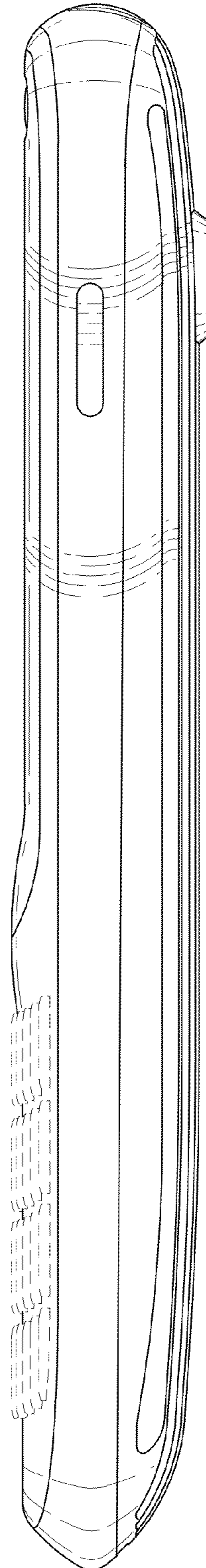

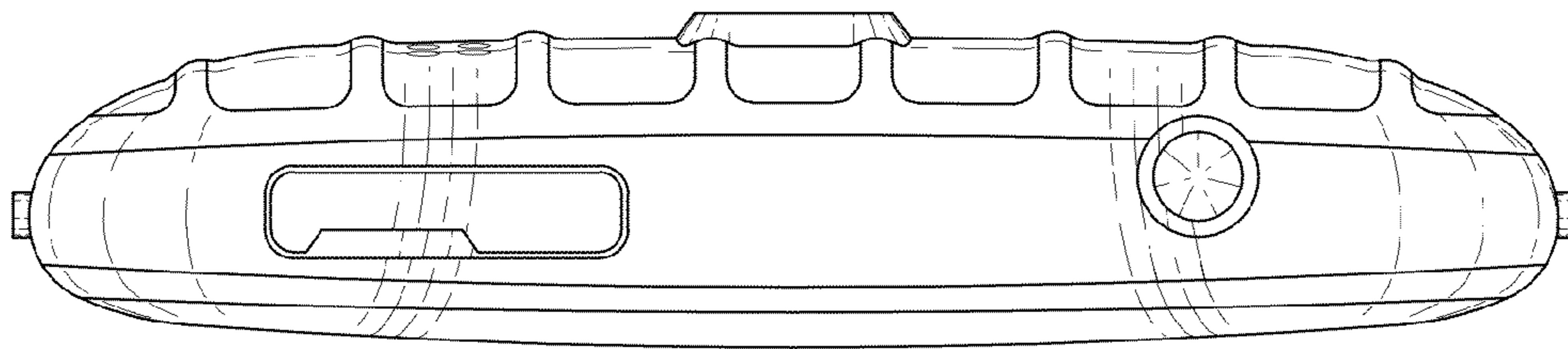
