DESCRIPTION

FIG. 1 is a perspective view as viewed from the front and right sides of a base portion of a combined telephone and base assembly;

FIG. 2 is a front view of the combined telephone and base assembly including the base portion illustrated in FIG. 1 and a telephone mounted to the base portion;

FIG. 3 is a side view of the combined telephone and base assembly illustrated in FIG. 2, as viewed from the right side of FIG. 2, the other side being a mirror image thereof;

FIG. 4 is a rear view of the combined telephone and base assembly illustrated in FIG. 2;

FIG. 5 is a top plan view of the combined telephone and base assembly illustrated in FIG. 2;

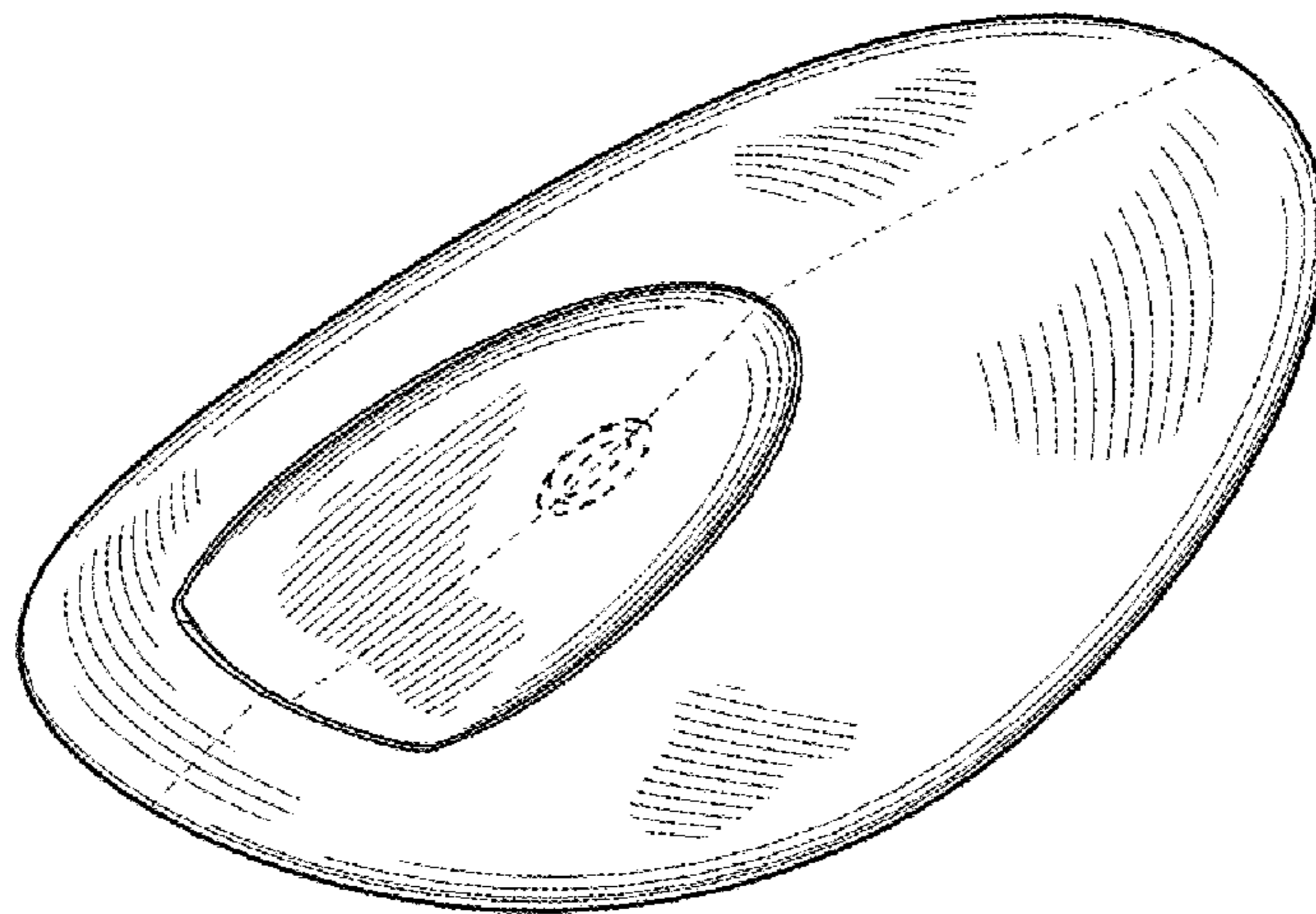
FIG. 6 is a bottom plan view of a telephone portion of the combined telephone and base assembly illustrated in FIG. 2;

FIG. 7 is a perspective view as viewed from the front and right sides of the combined telephone and base assembly illustrated in FIG. 2; and,

FIG. 8 is a bottom plan view of the combined telephone and base assembly illustrated in FIG. 2.

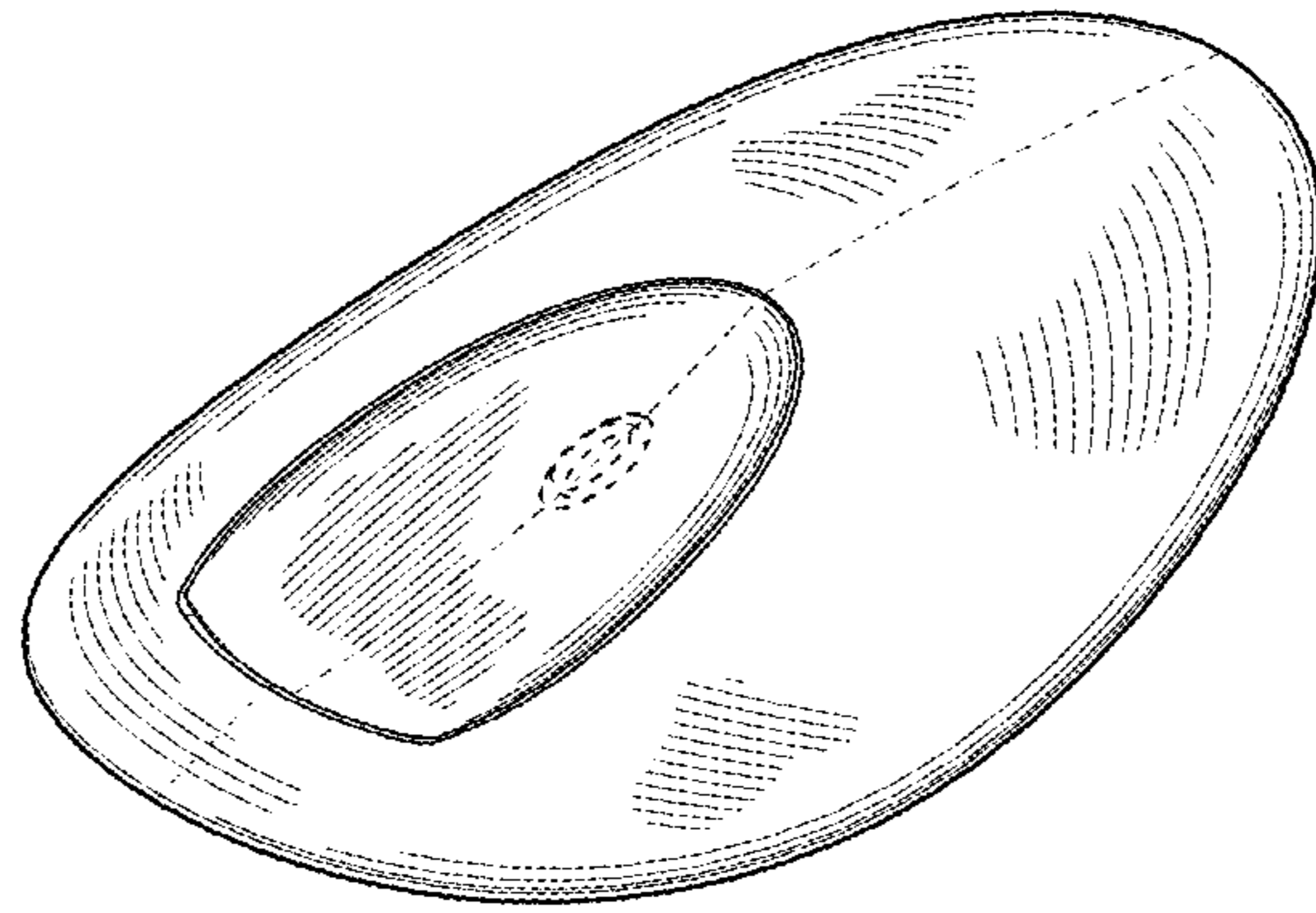

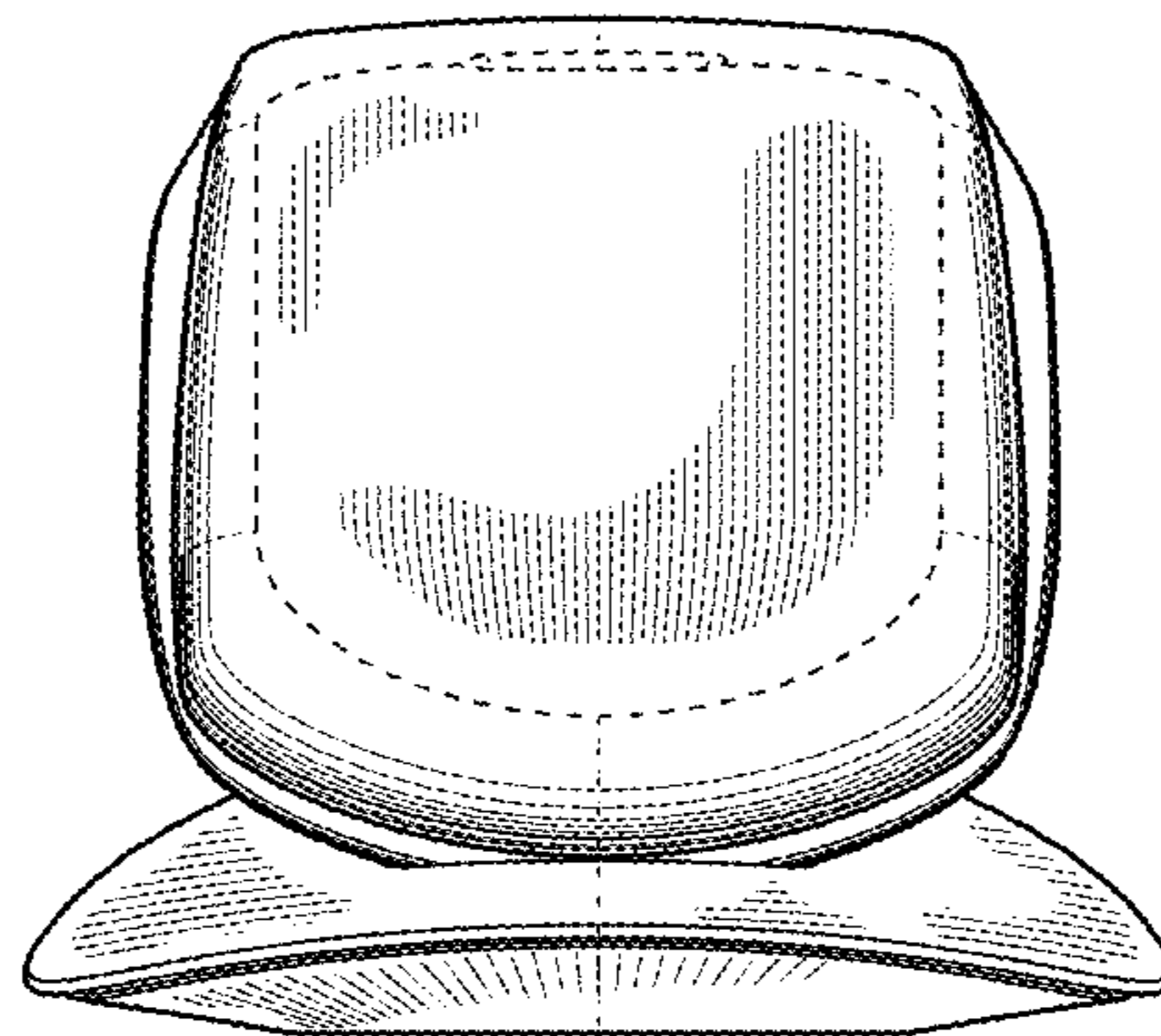

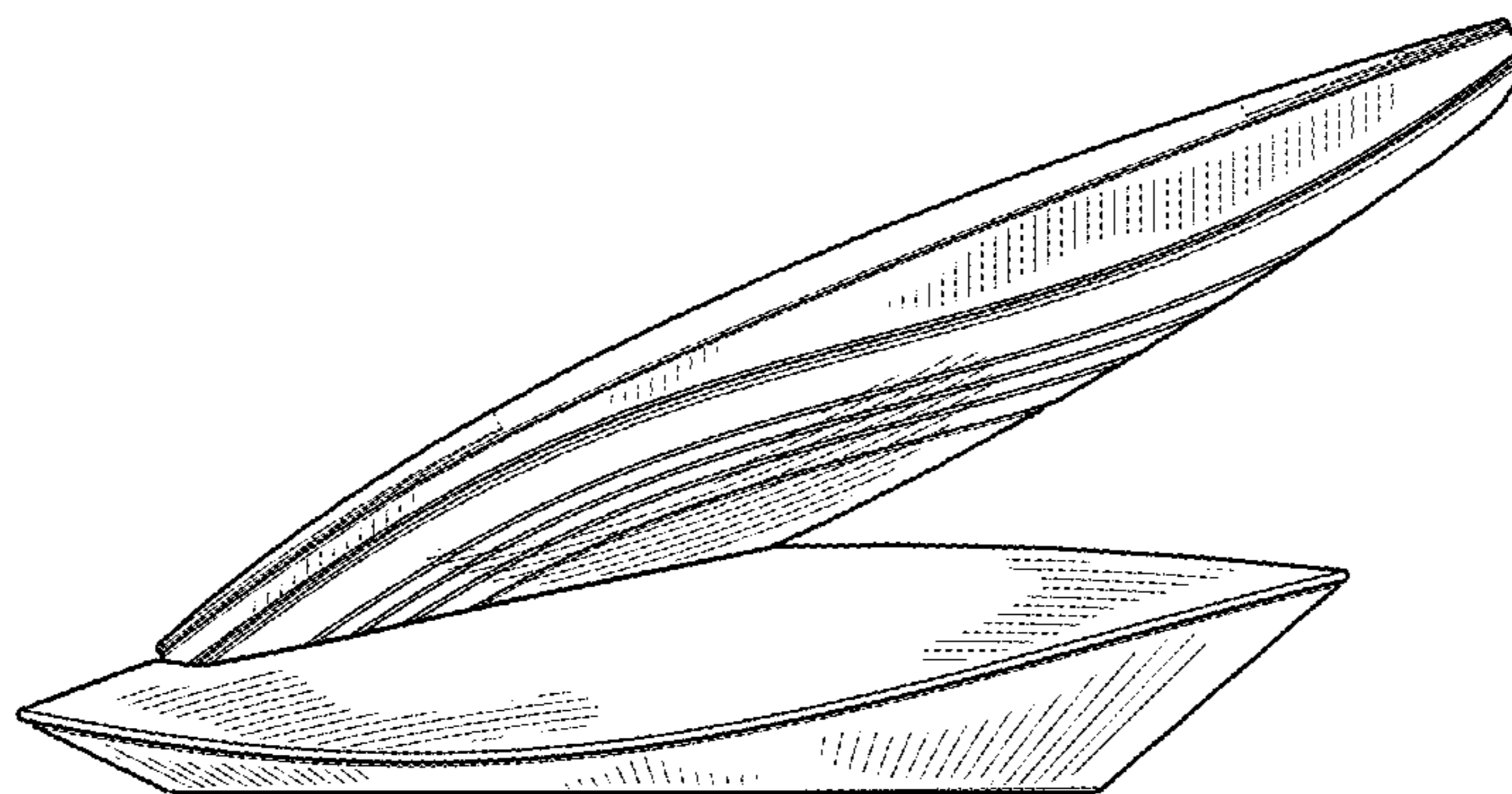

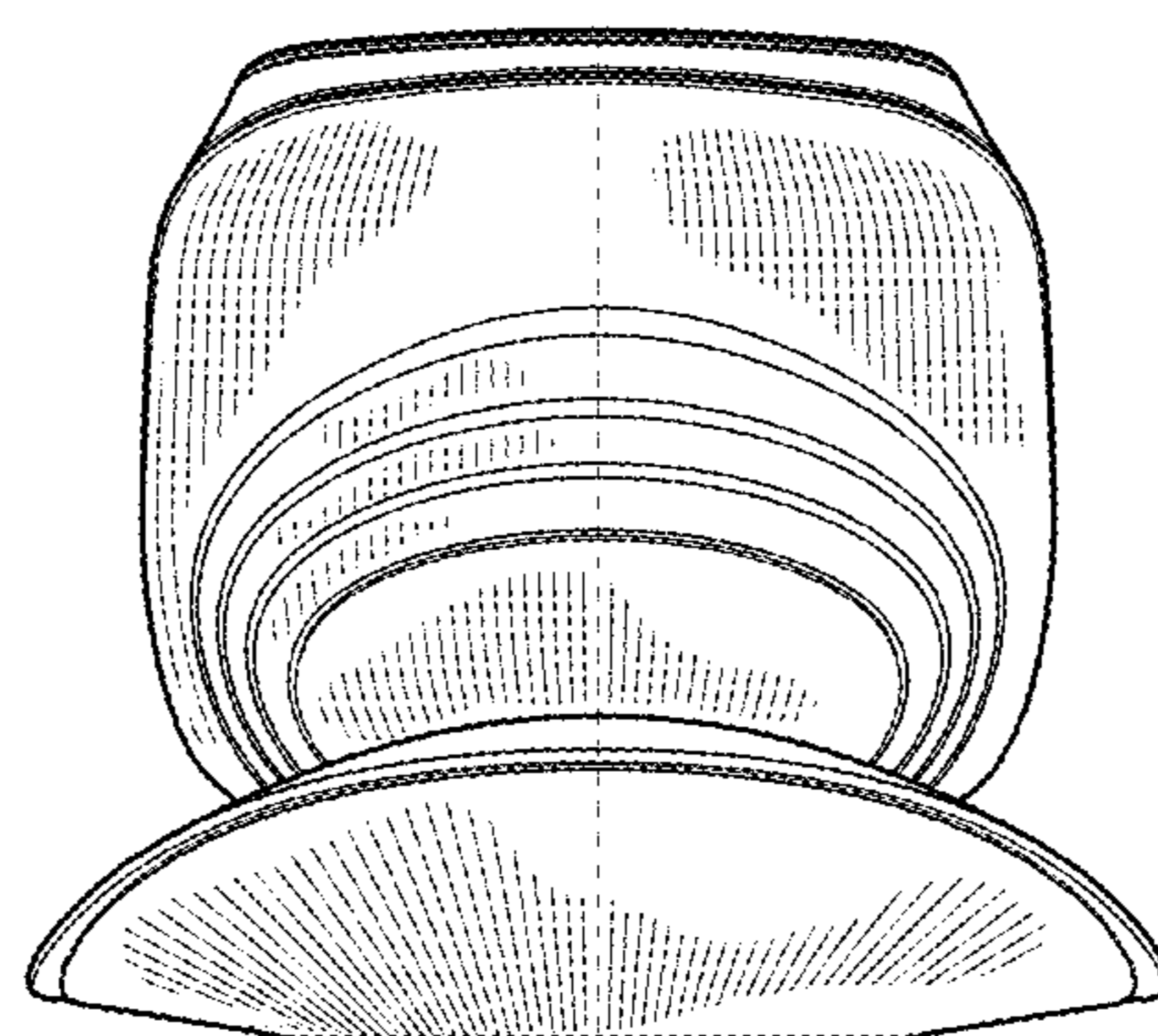

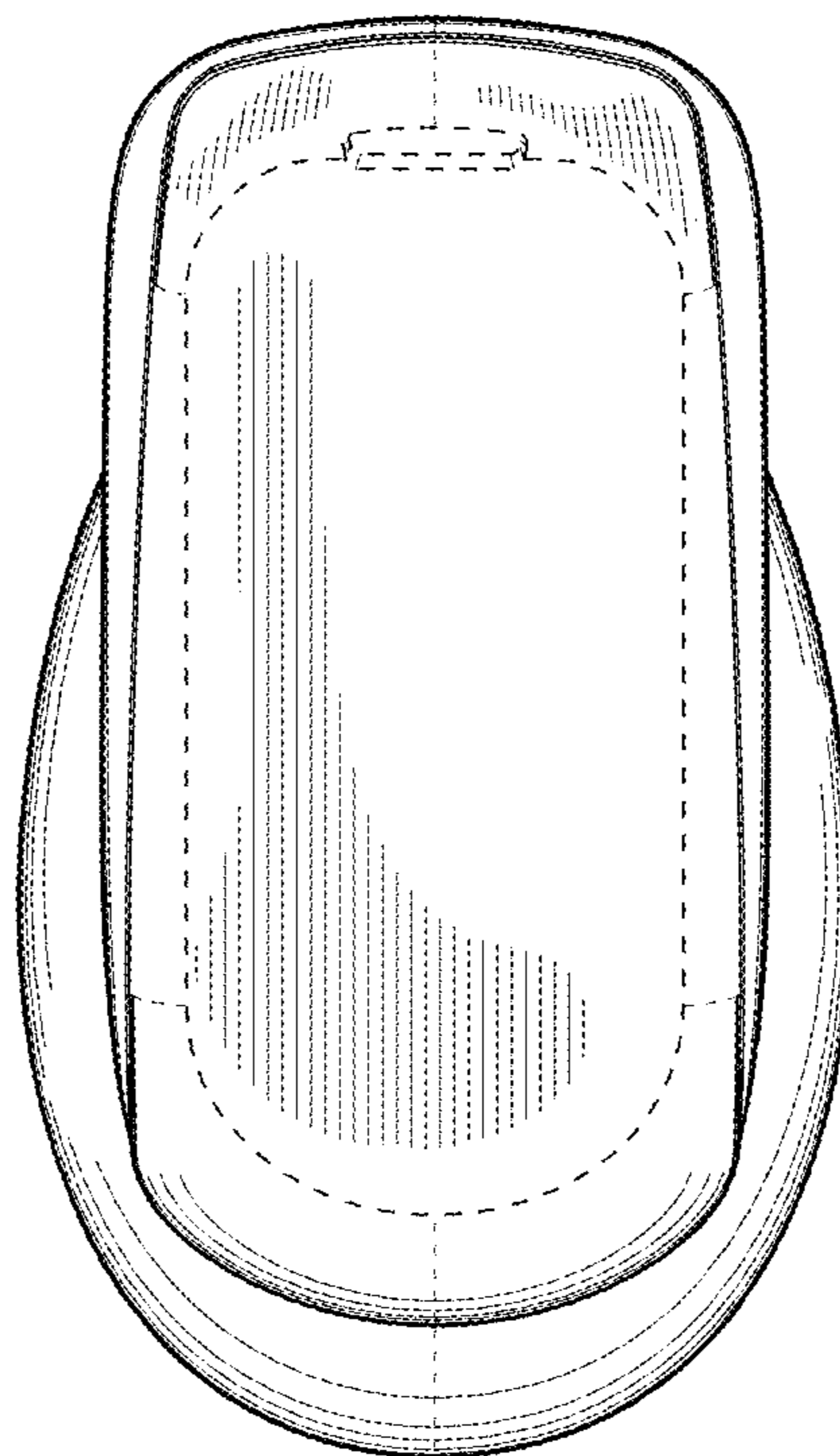

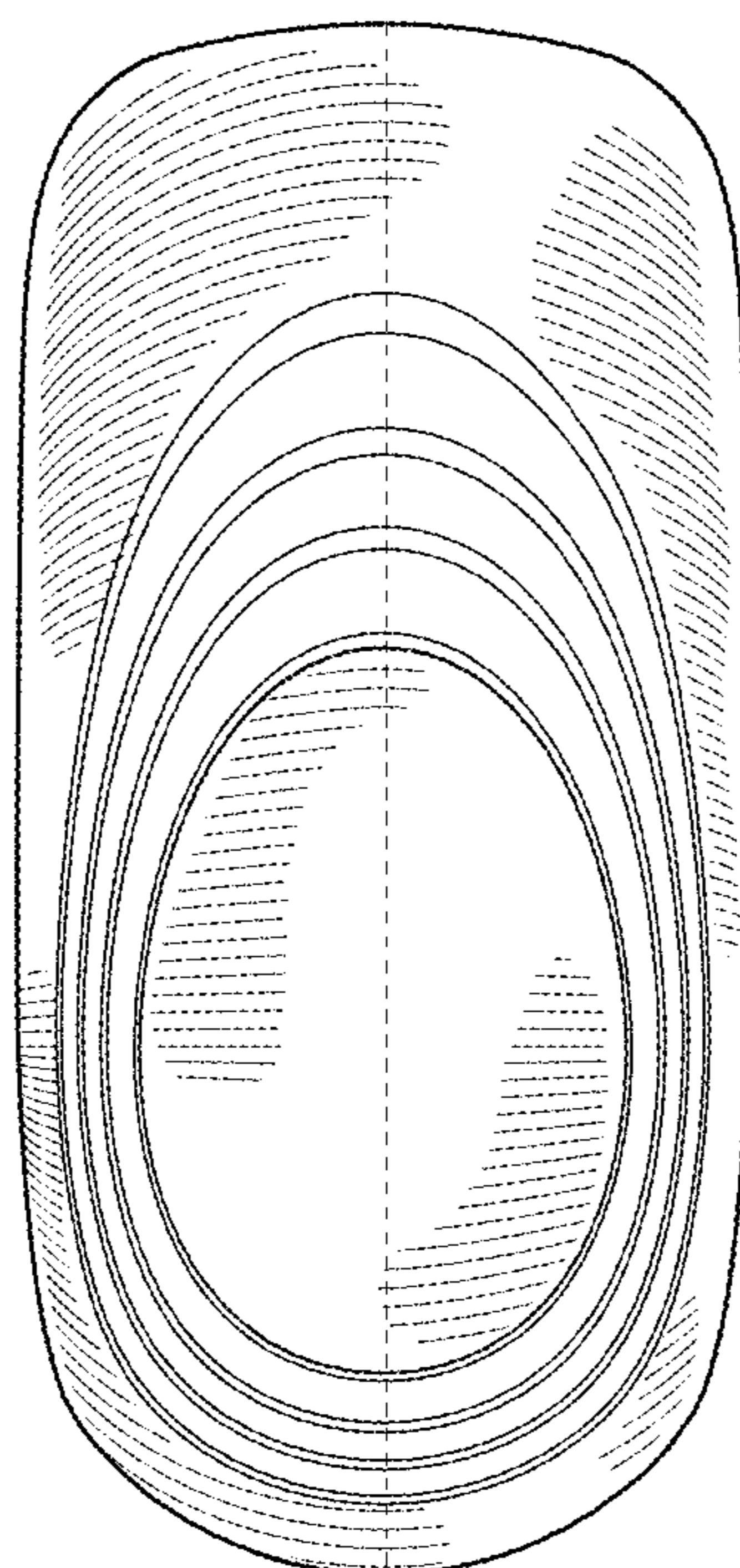

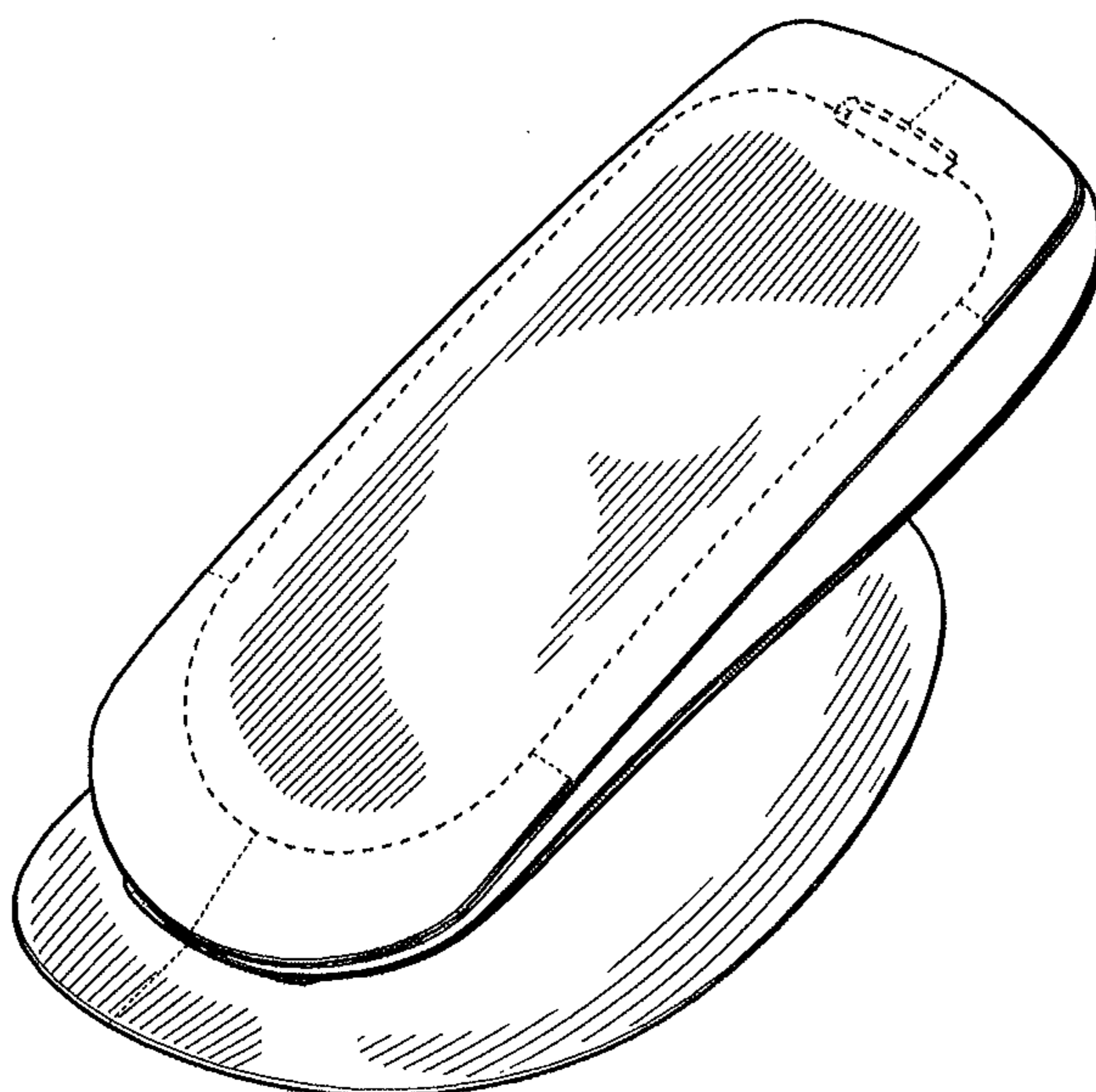

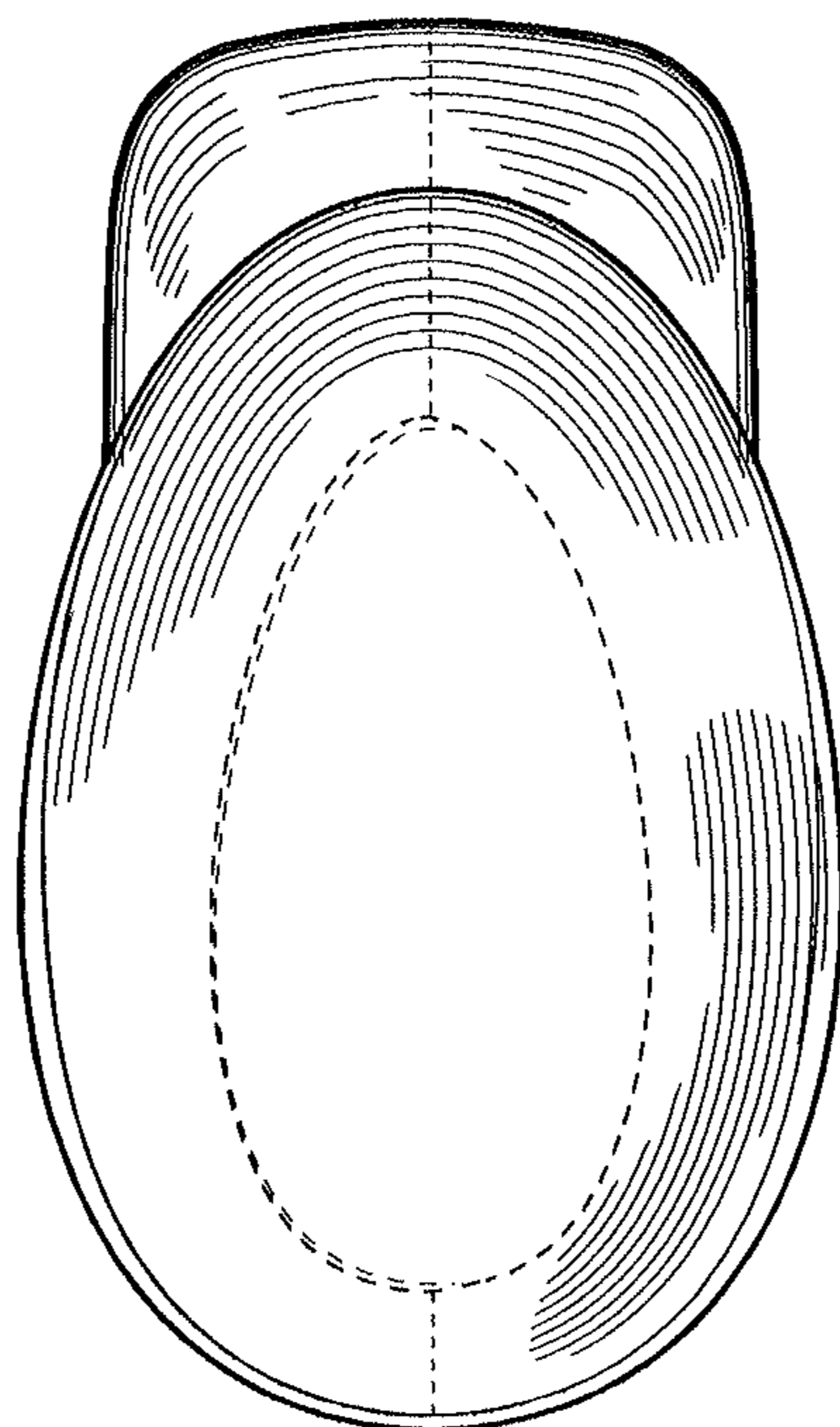
