**DESCRIPTION**

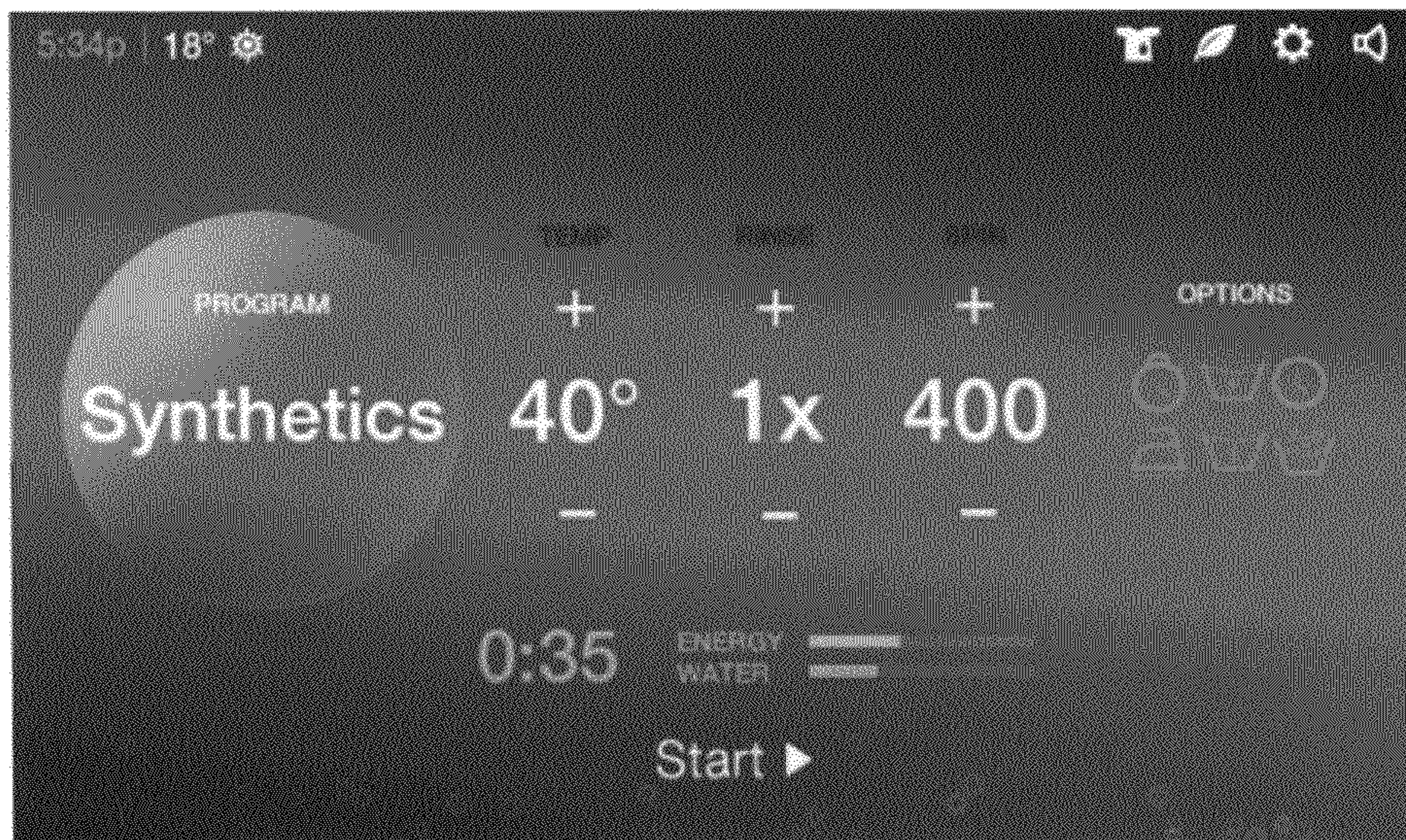

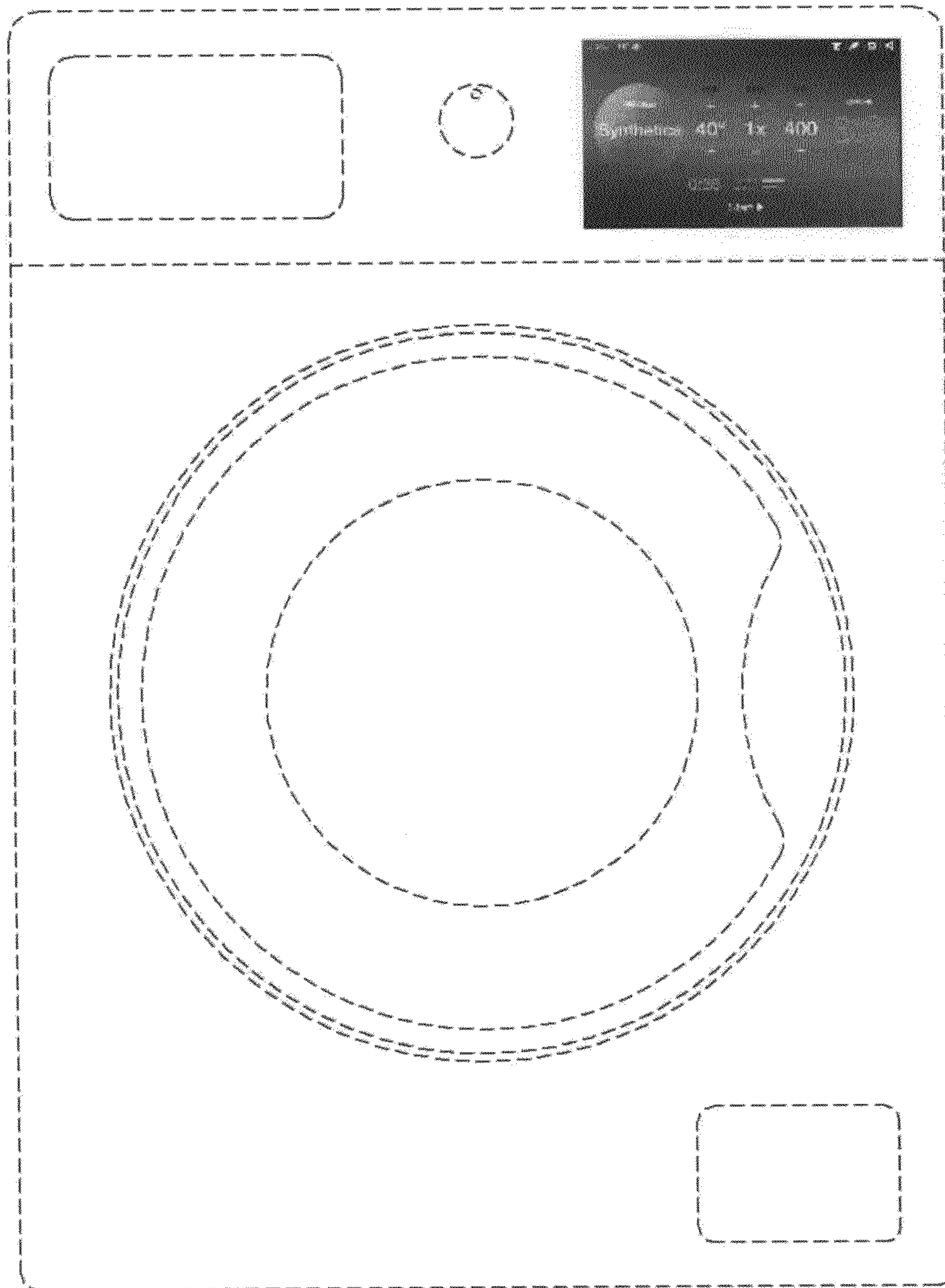
