We claim the ornamental design for a display screen with graphical user interface, as shown and described.

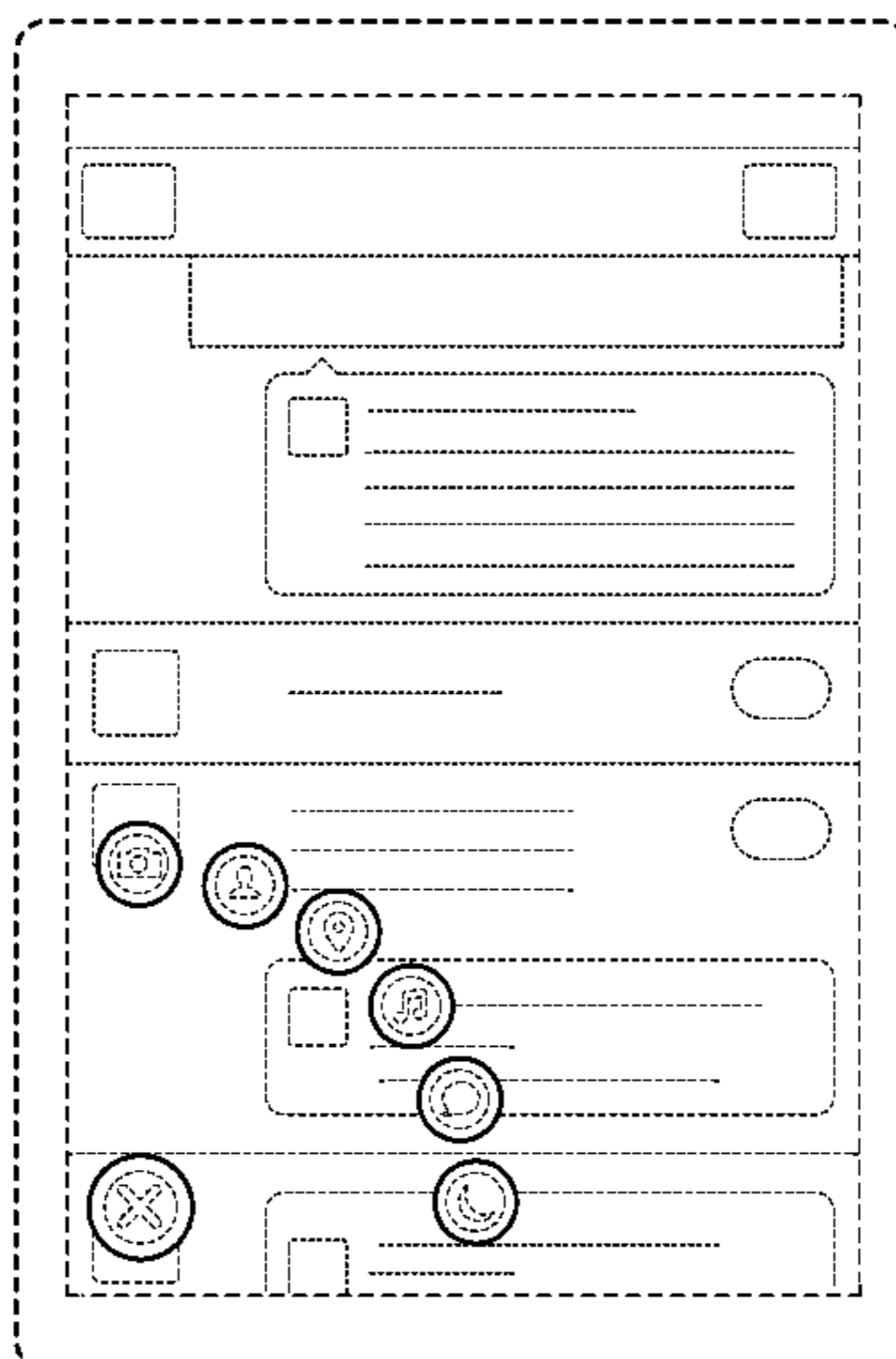
**DESCRIPTION**
