We claim the ornamental design for a display screen with an icon, as shown and described.

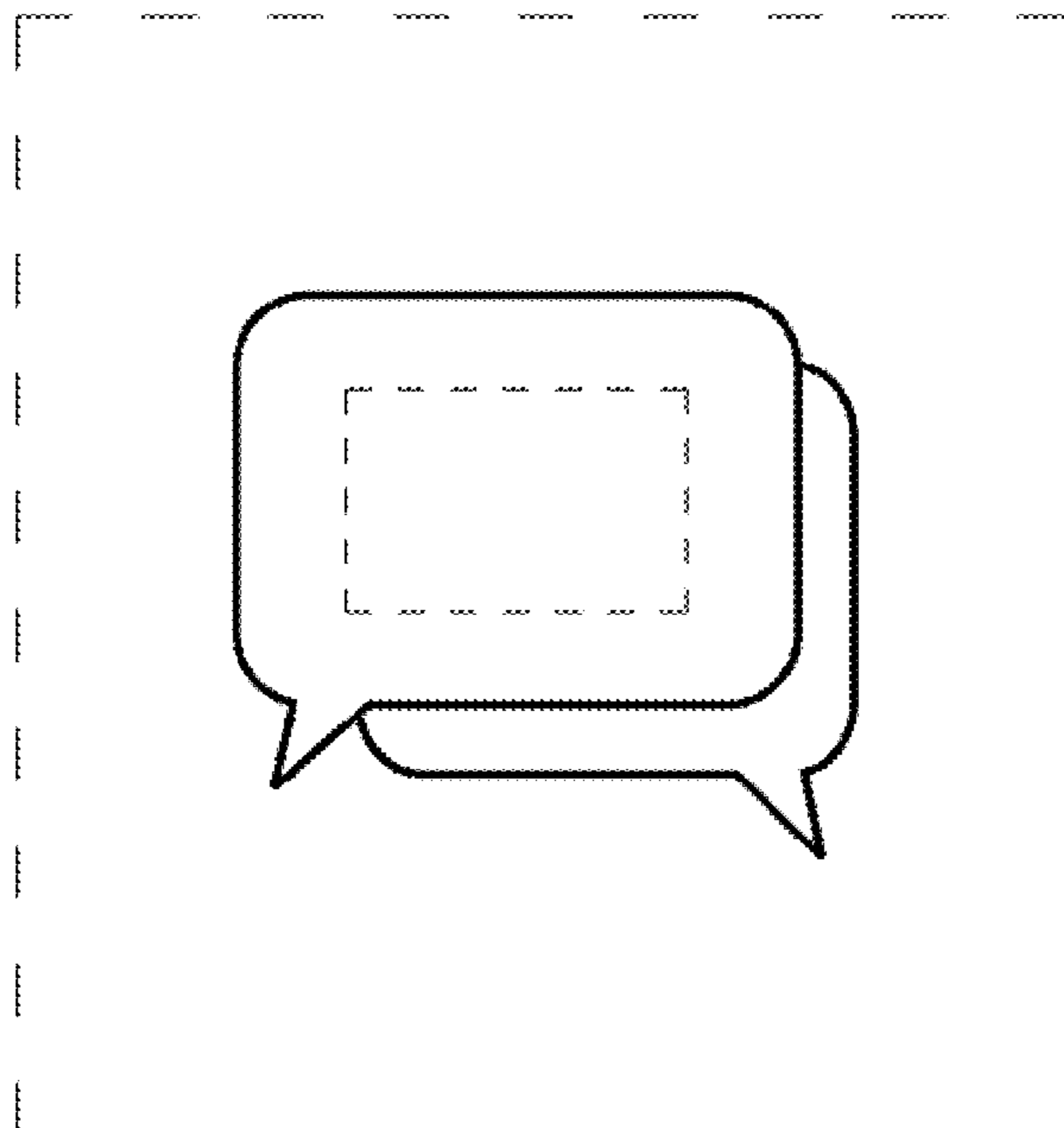
DESCRIPTION

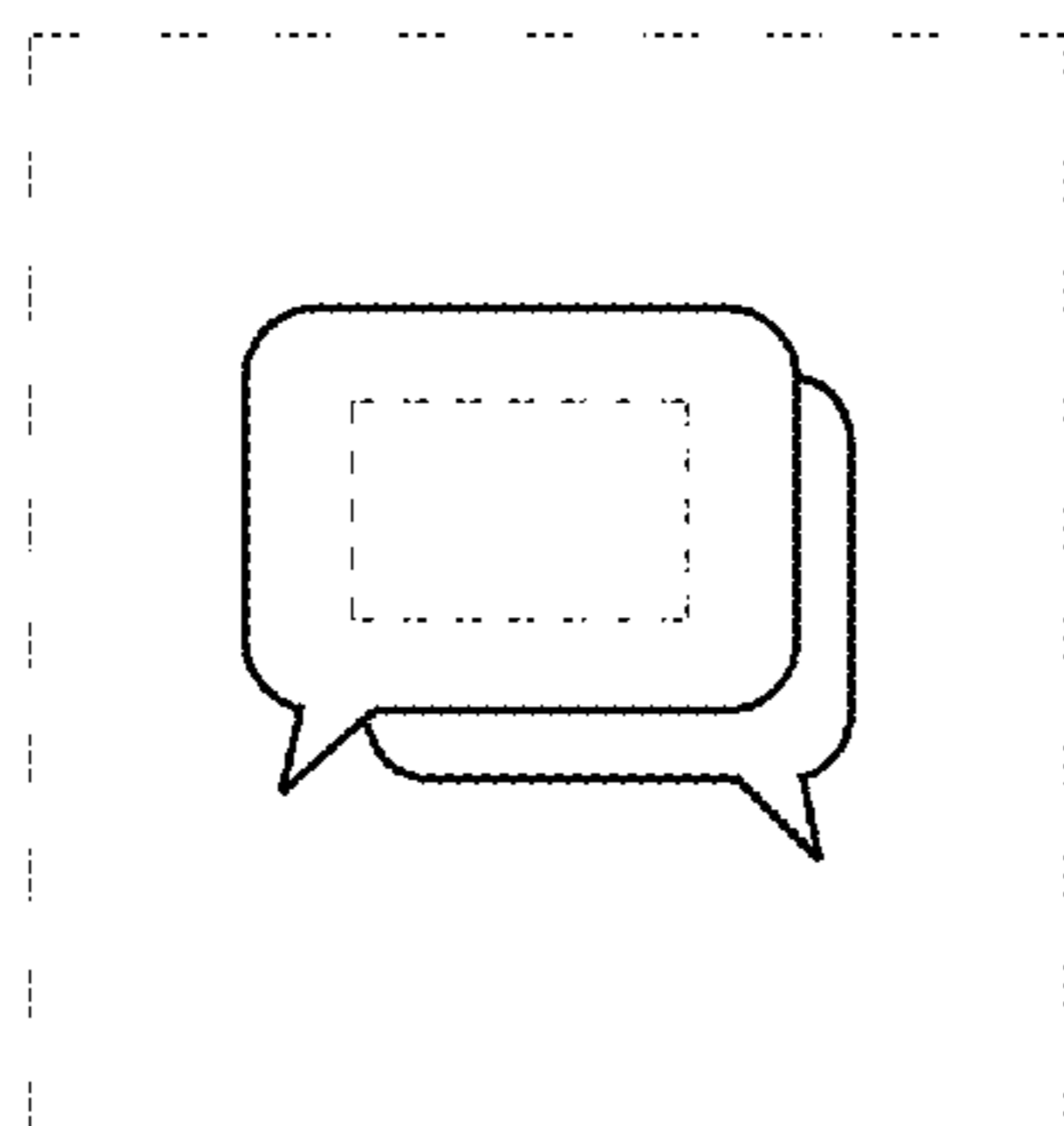

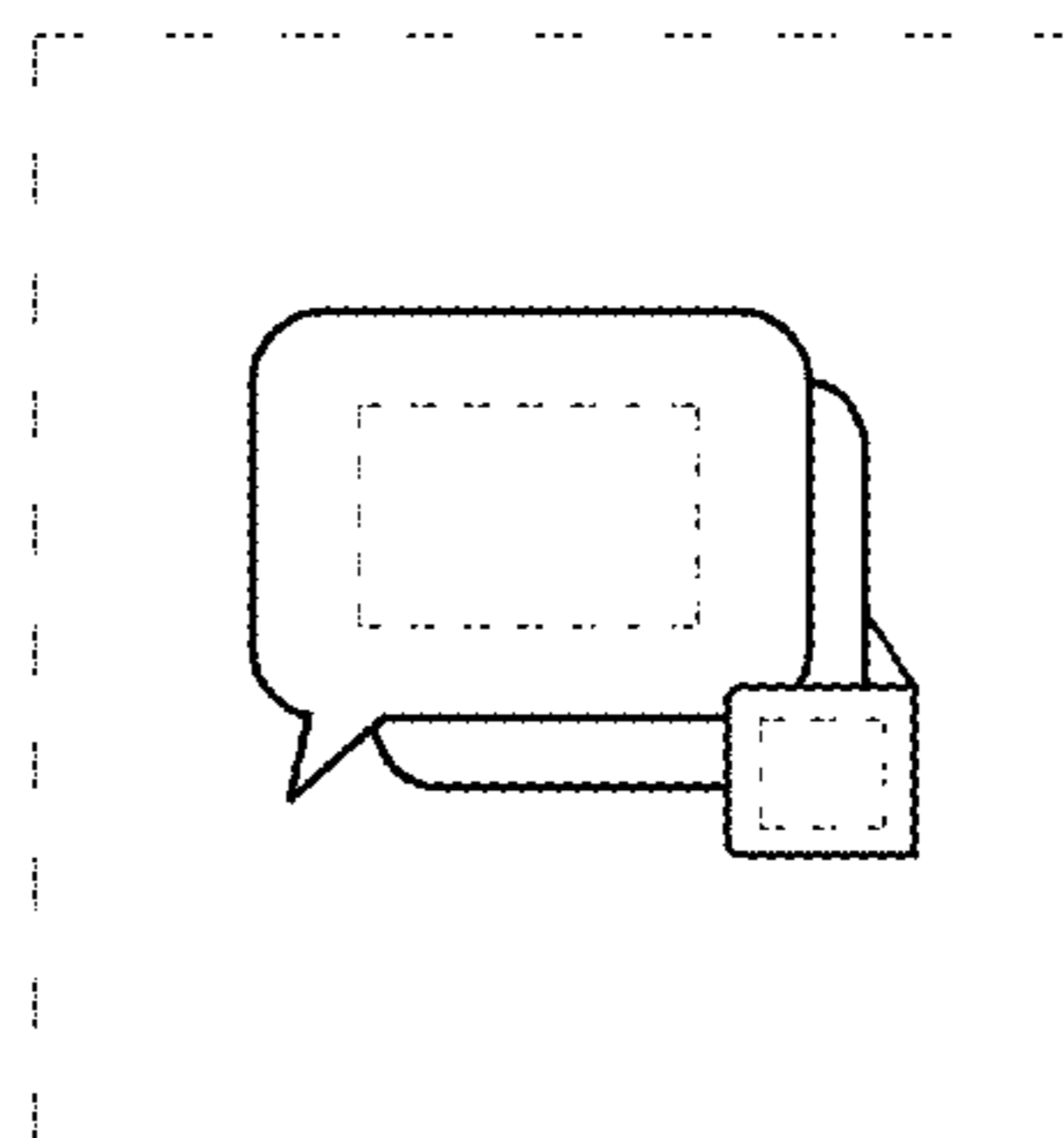
