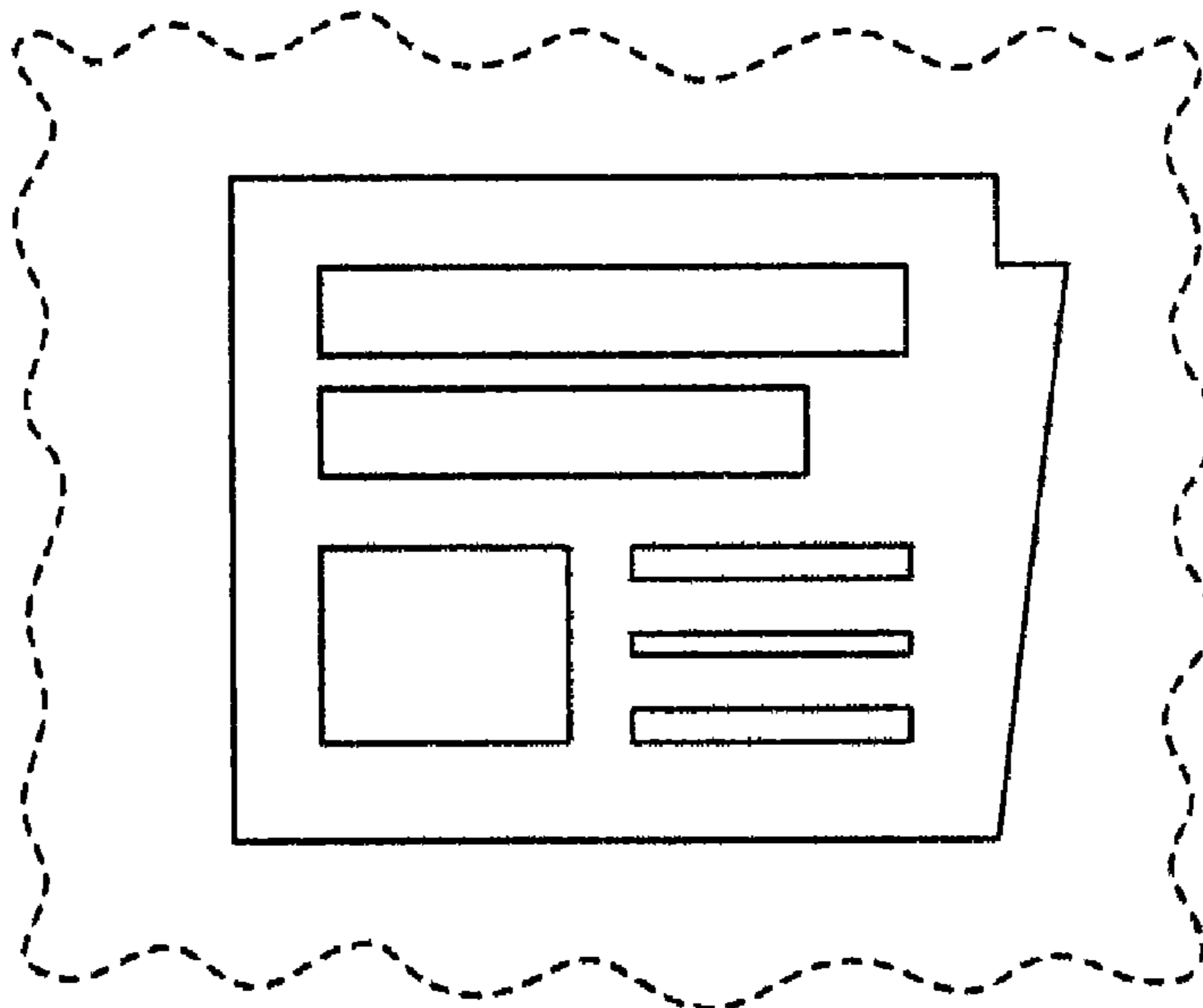

FIG. 1 is a front view of a display screen with icon showing the new design;
FIG. 2 is a front view of a display screen with icon showing an alternative embodiment of the new design;
FIG. 3 is a front view of a display screen with icon of FIG. 1 shown on a device; and,
FIG. 4 is a front view of a display screen with icon of FIG. 2 shown on a device.
The broken line showing of the remainder of the display screen and the remainder of the device having the display screen in FIGS. 3-4 is for environmental purposes only and forms no part of the claimed design.

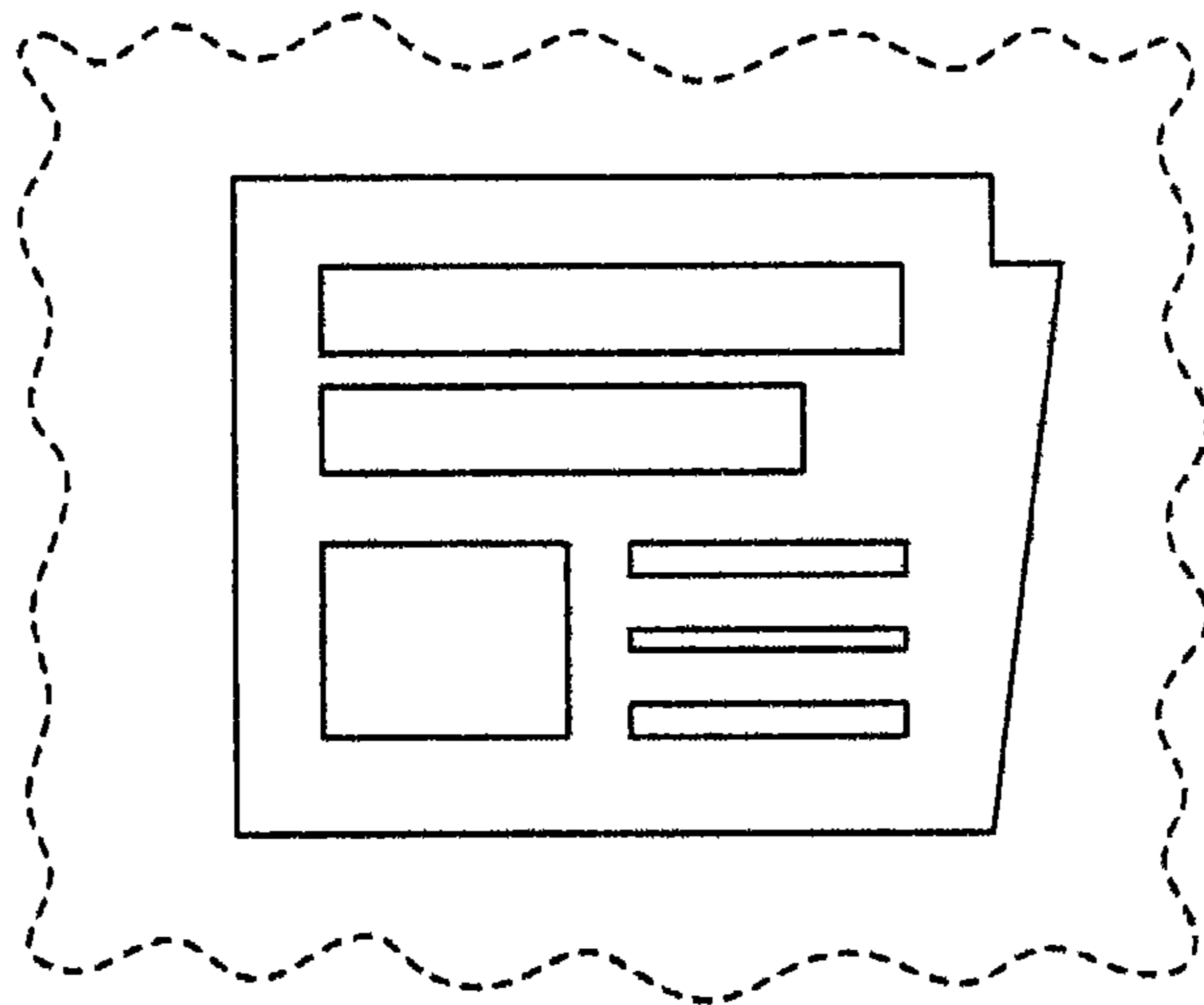

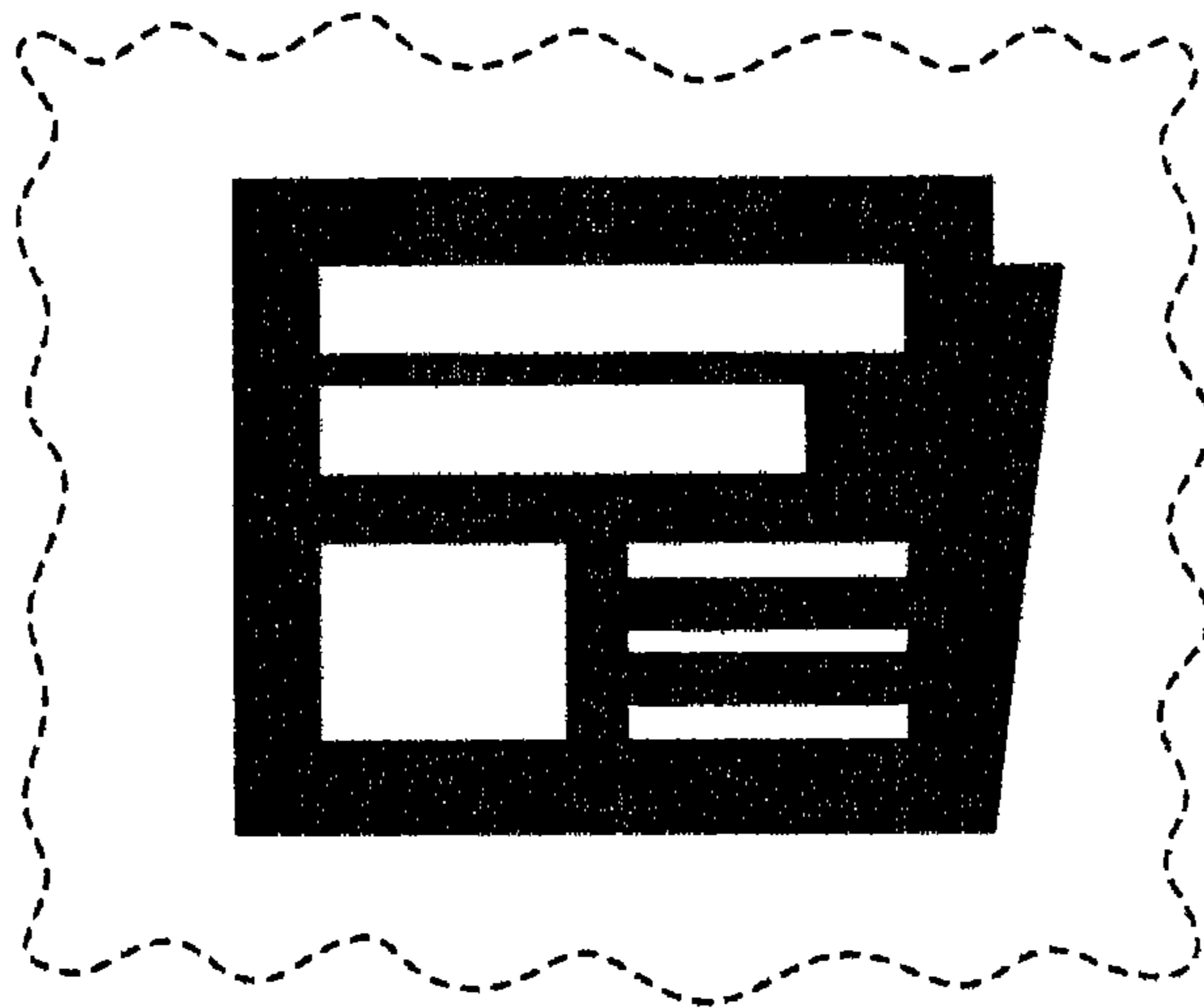

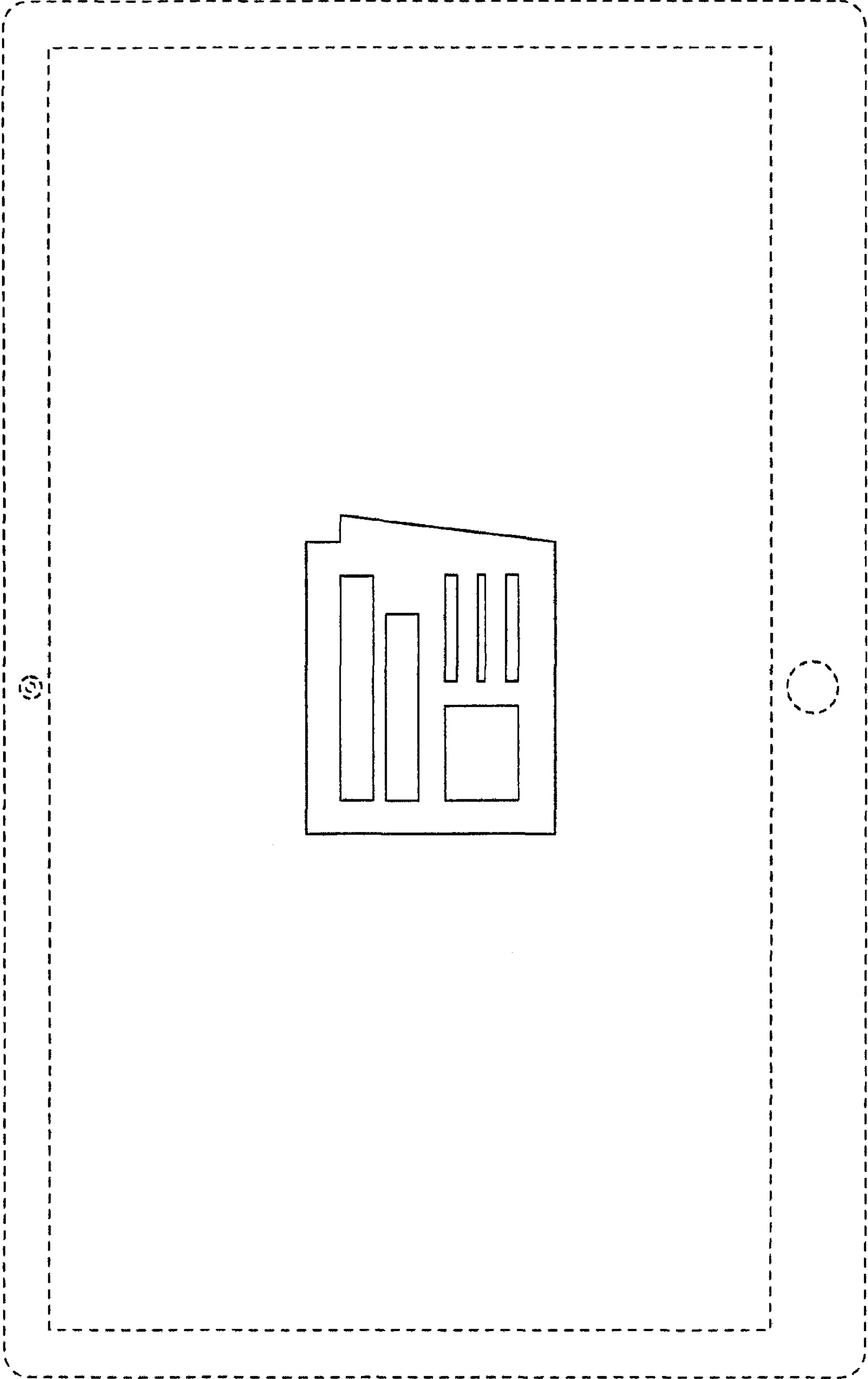
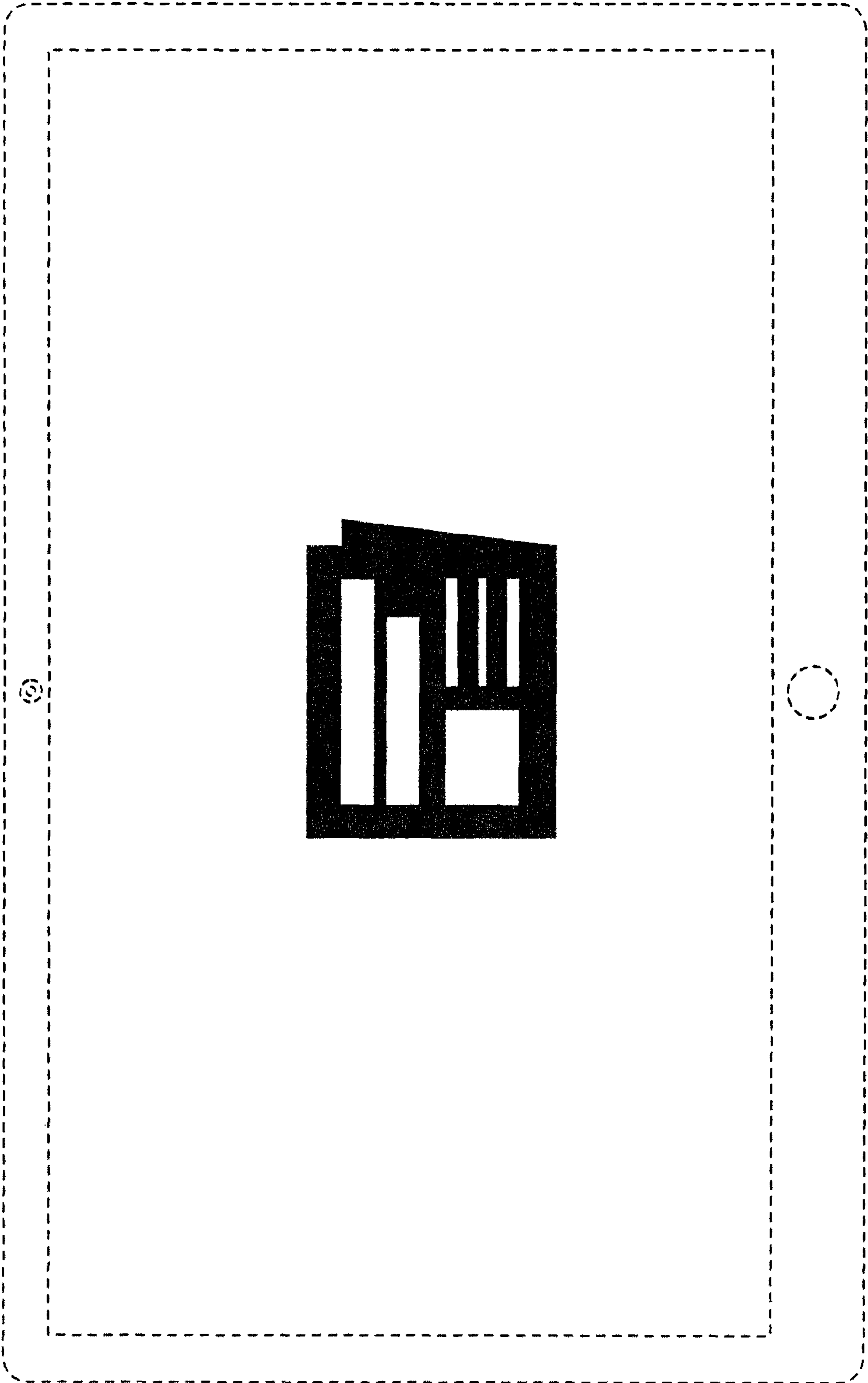
