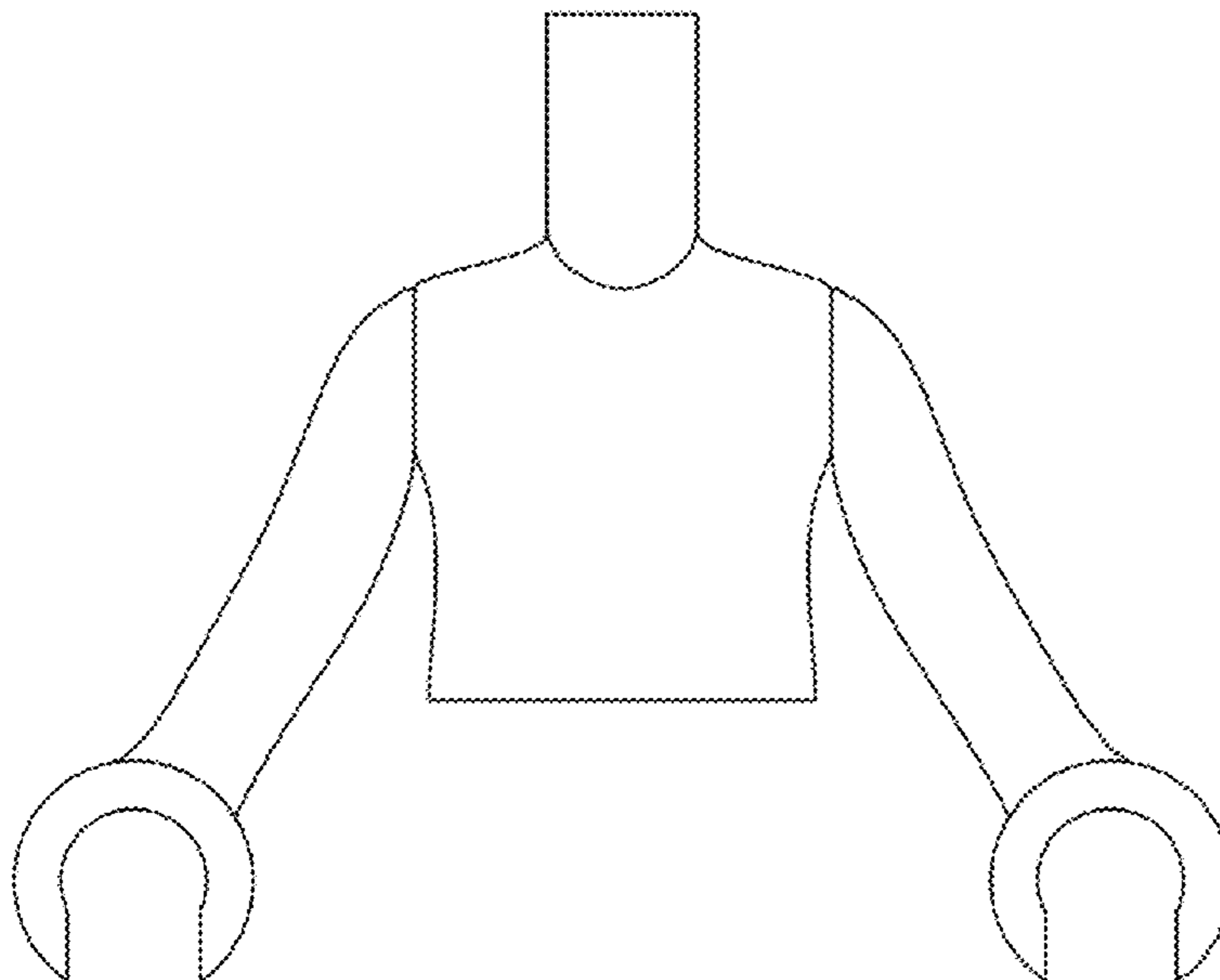
The ornamental design for a female toy figure, as shown and described.

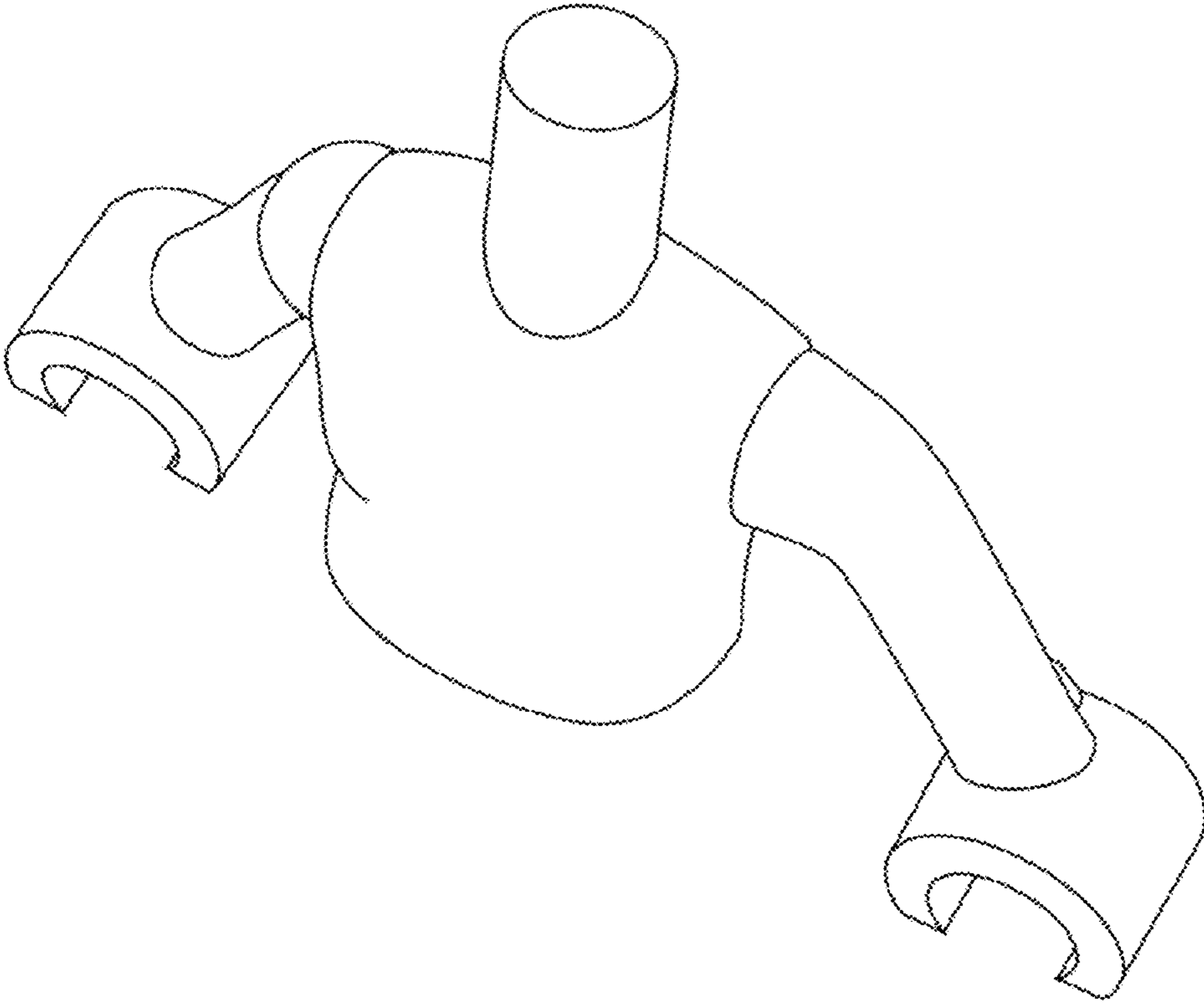

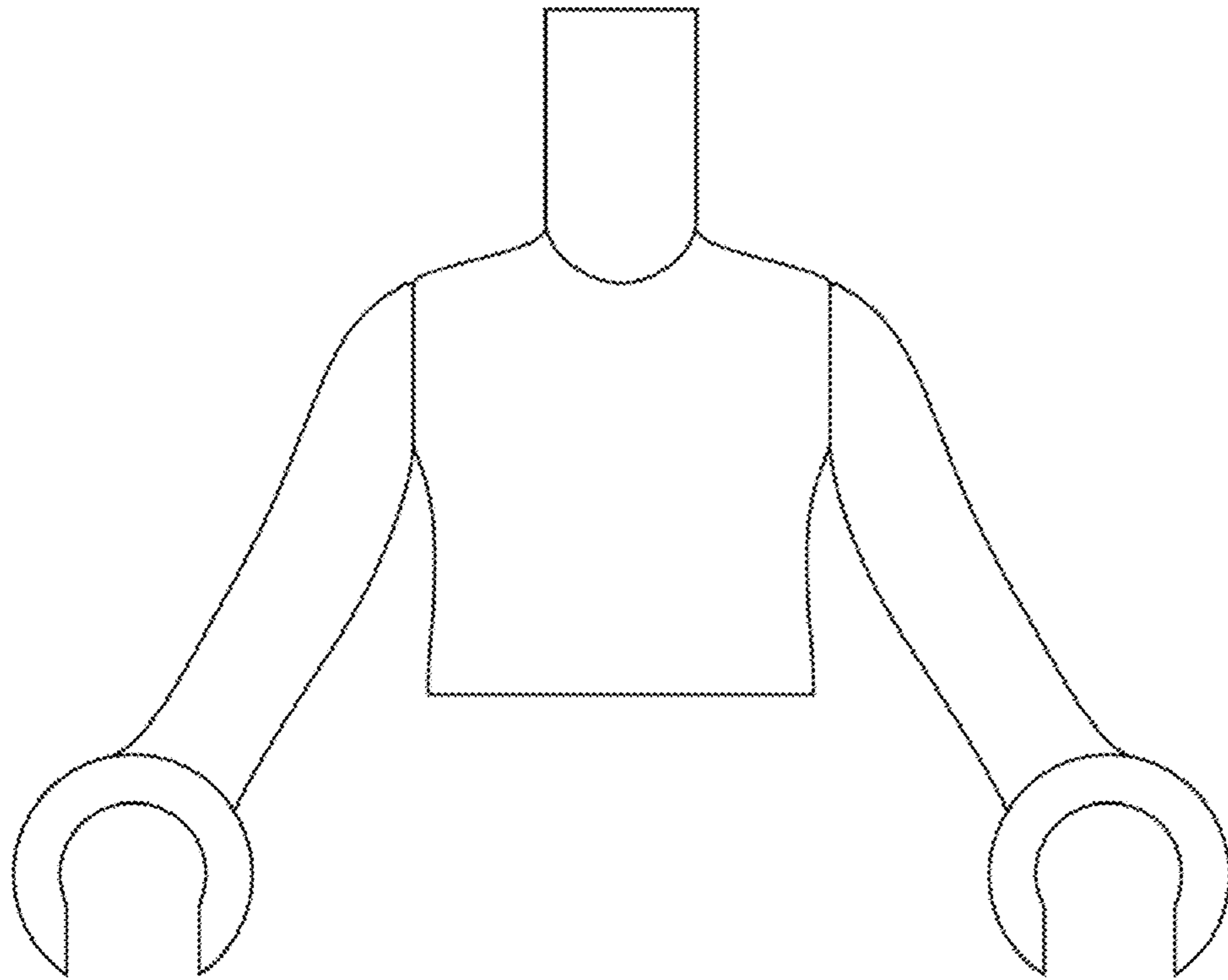

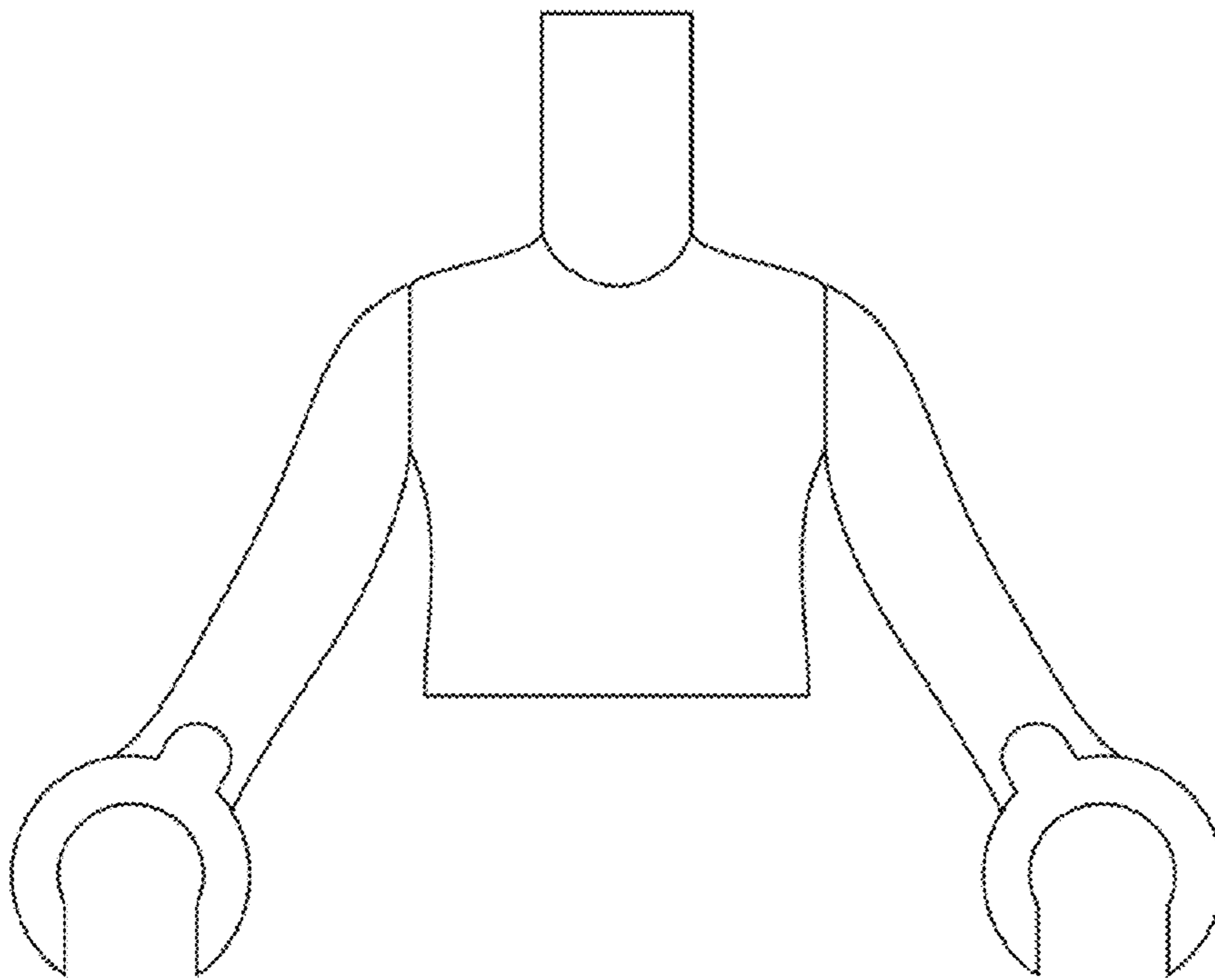

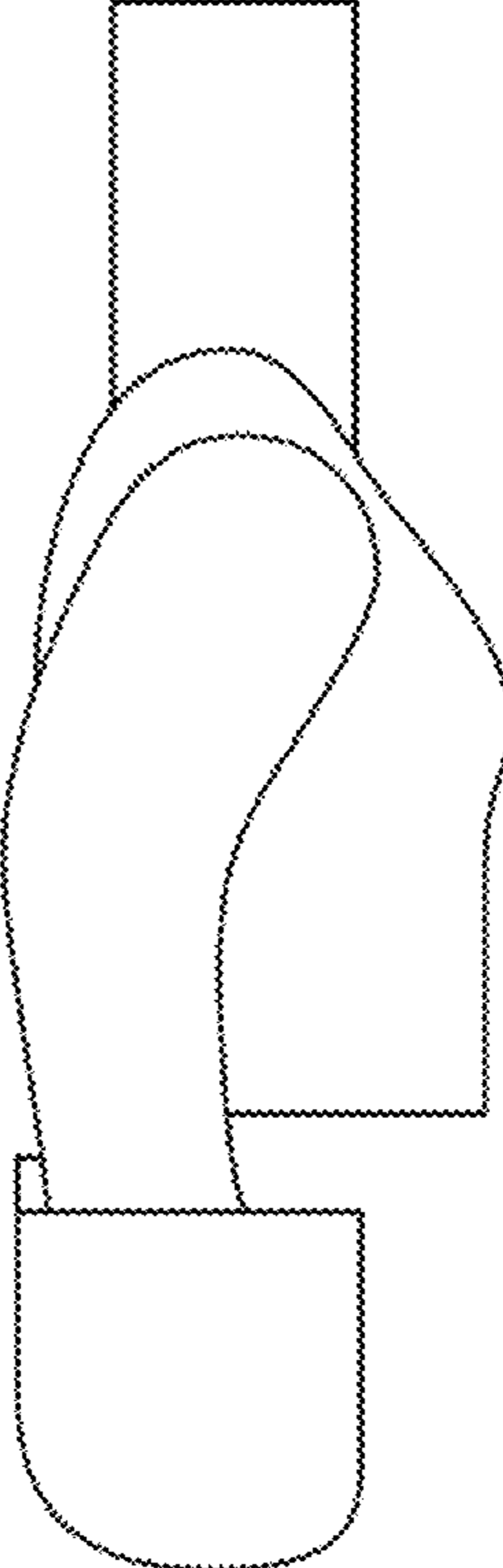

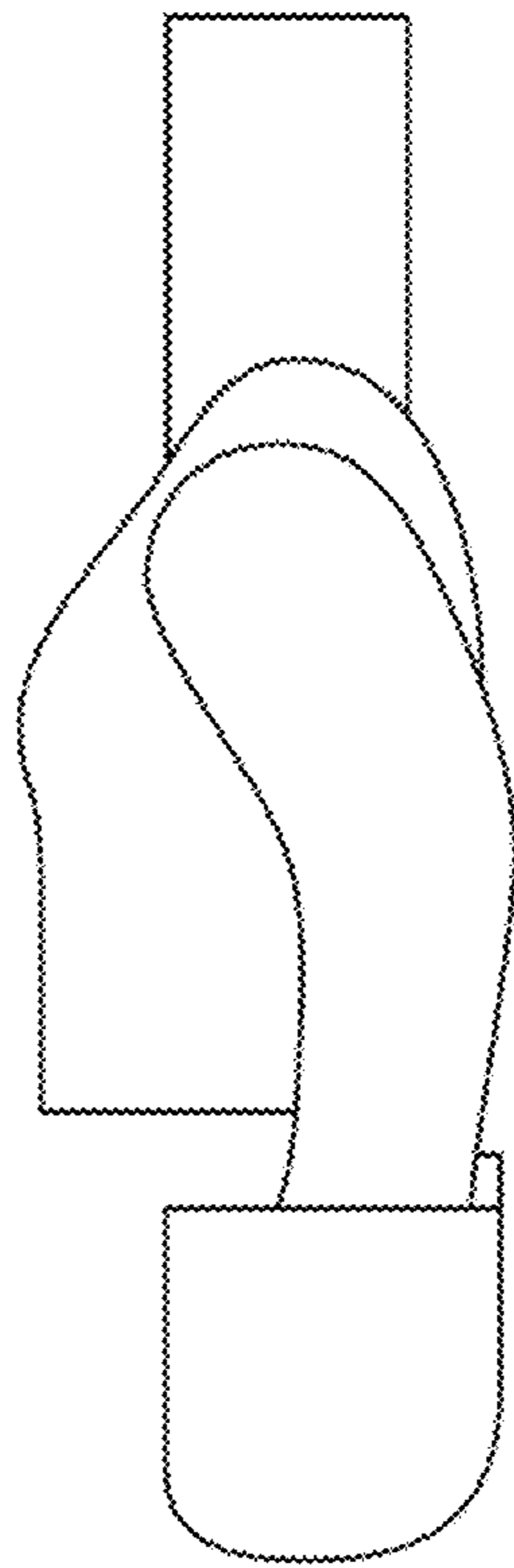

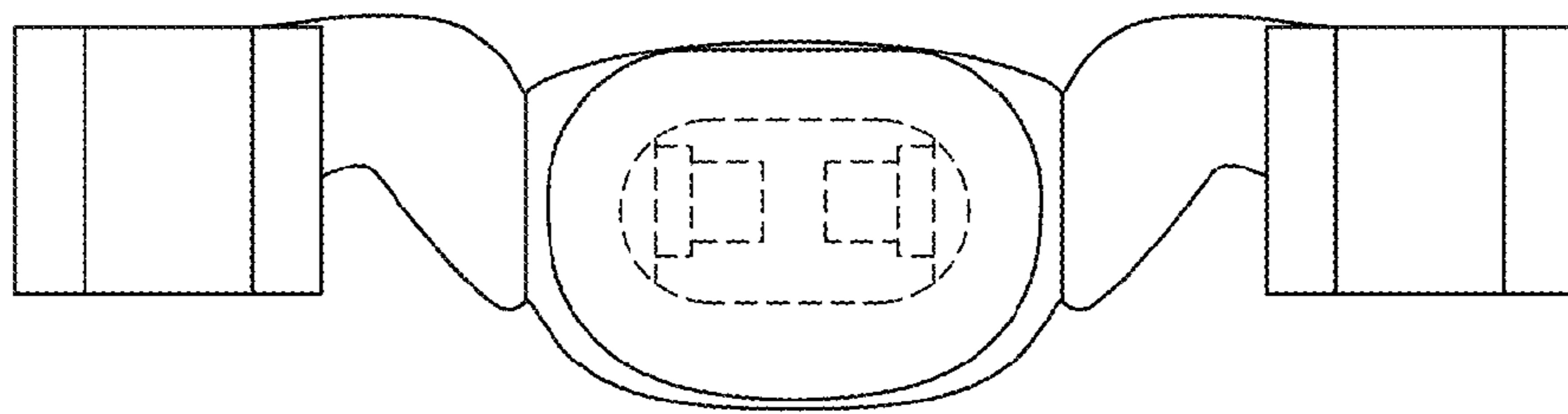

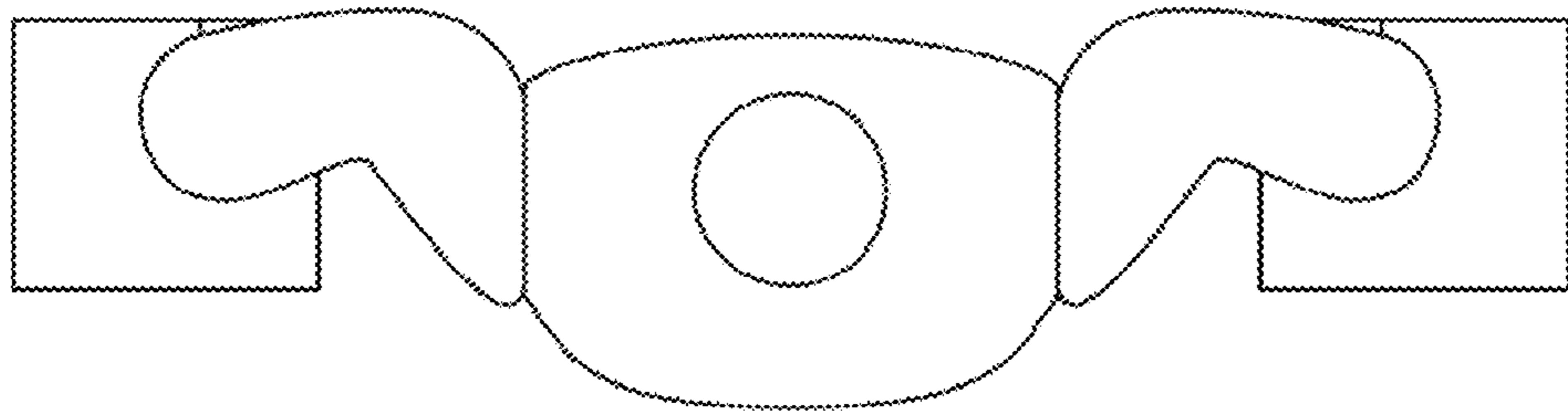
