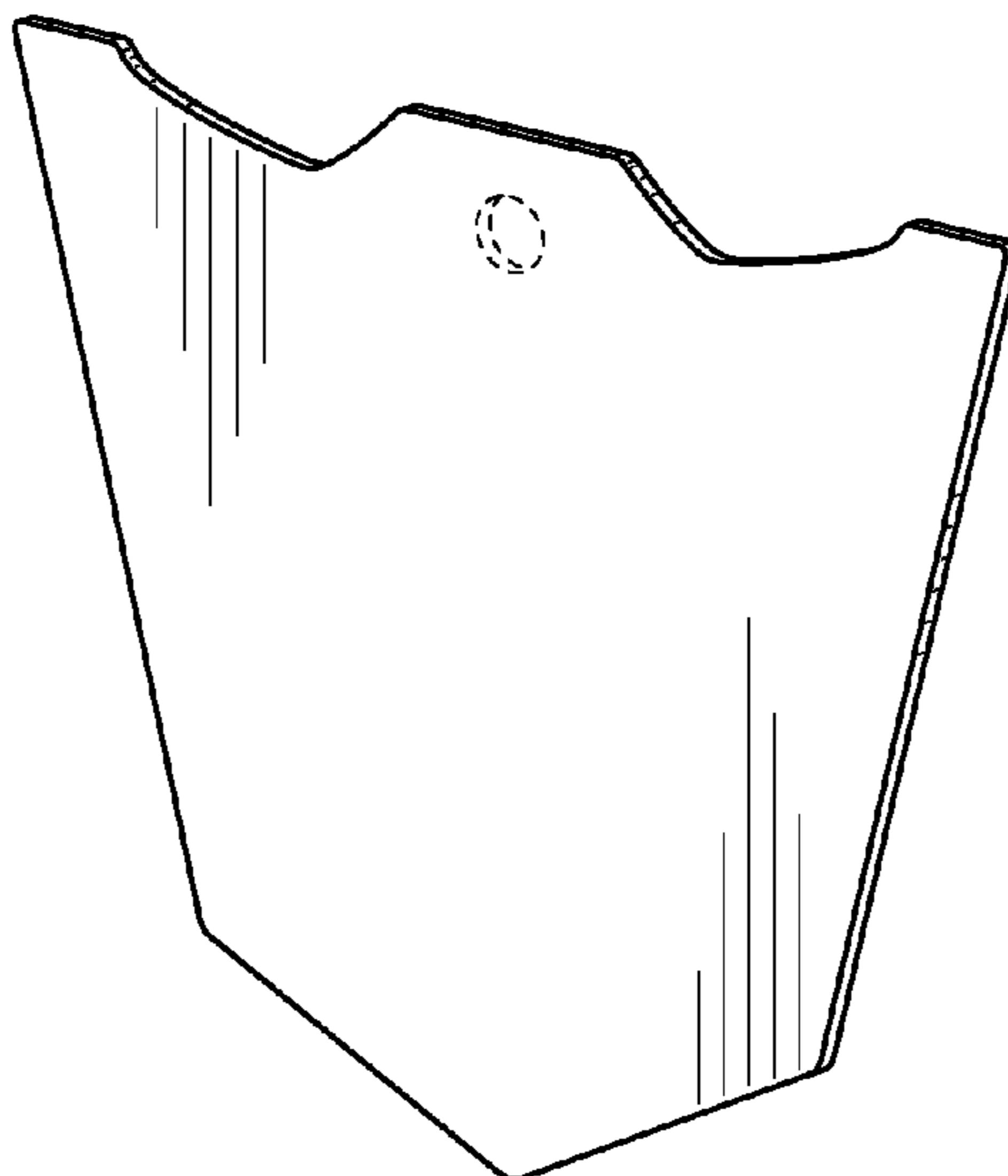
(57) **CLAIM**

The ornamental design for a substrate, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a front, top, and left side of an ornamental design for a substrate;
FIG. 2 is a front elevational view of the substrate of FIG. 1;
FIG. 3 is a rear elevational view of the substrate of FIG. 1;
FIG. 4 is a left side elevational view of the substrate of FIG. 1;
FIG. 5 is a right side elevational view of the substrate of FIG. 1;
FIG. 6 is a top plan view of the substrate of FIG. 1;
FIG. 7 is a bottom plan view of the substrate of FIG. 1;
FIG. 8 is an isometric view of a front, top, and left side of an ornamental design for another embodiment of a substrate;
FIG. 9 is a front elevational view of the substrate of FIG. 8;
FIG. 10 is a rear elevational view of the substrate of FIG. 8;
FIG. 11 is a left side elevational view of the substrate of FIG. 8;
FIG. 12 is a right side elevational view of the substrate of FIG. 8;
FIG. 13 is a top plan view of the substrate of FIG. 8;
FIG. 14 is a bottom plan view of the substrate of FIG. 8; and,
FIG. 15 is a front elevational view of a different embodiment of a substrate similar to the substrate of FIGS. 8-14.

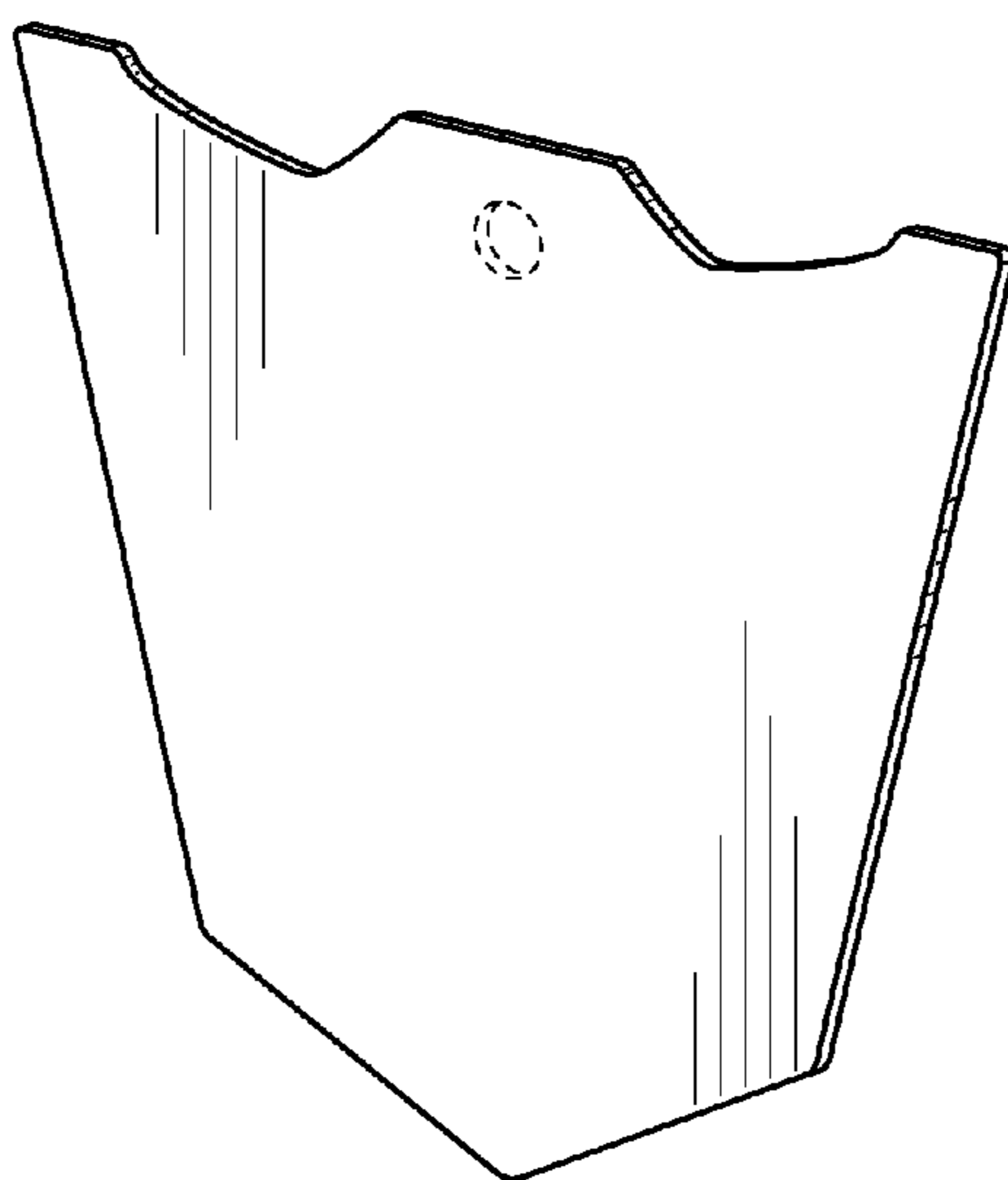

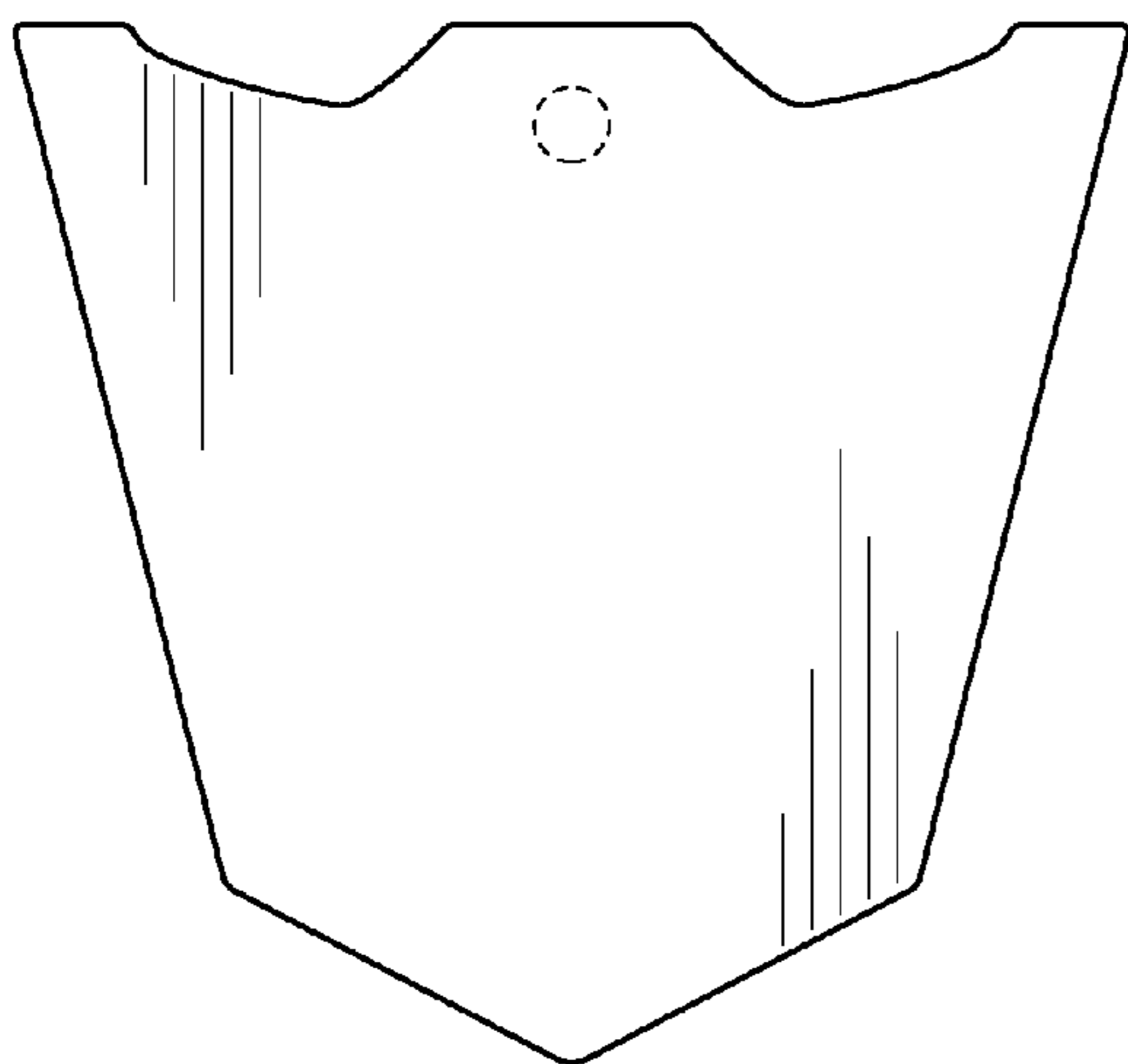

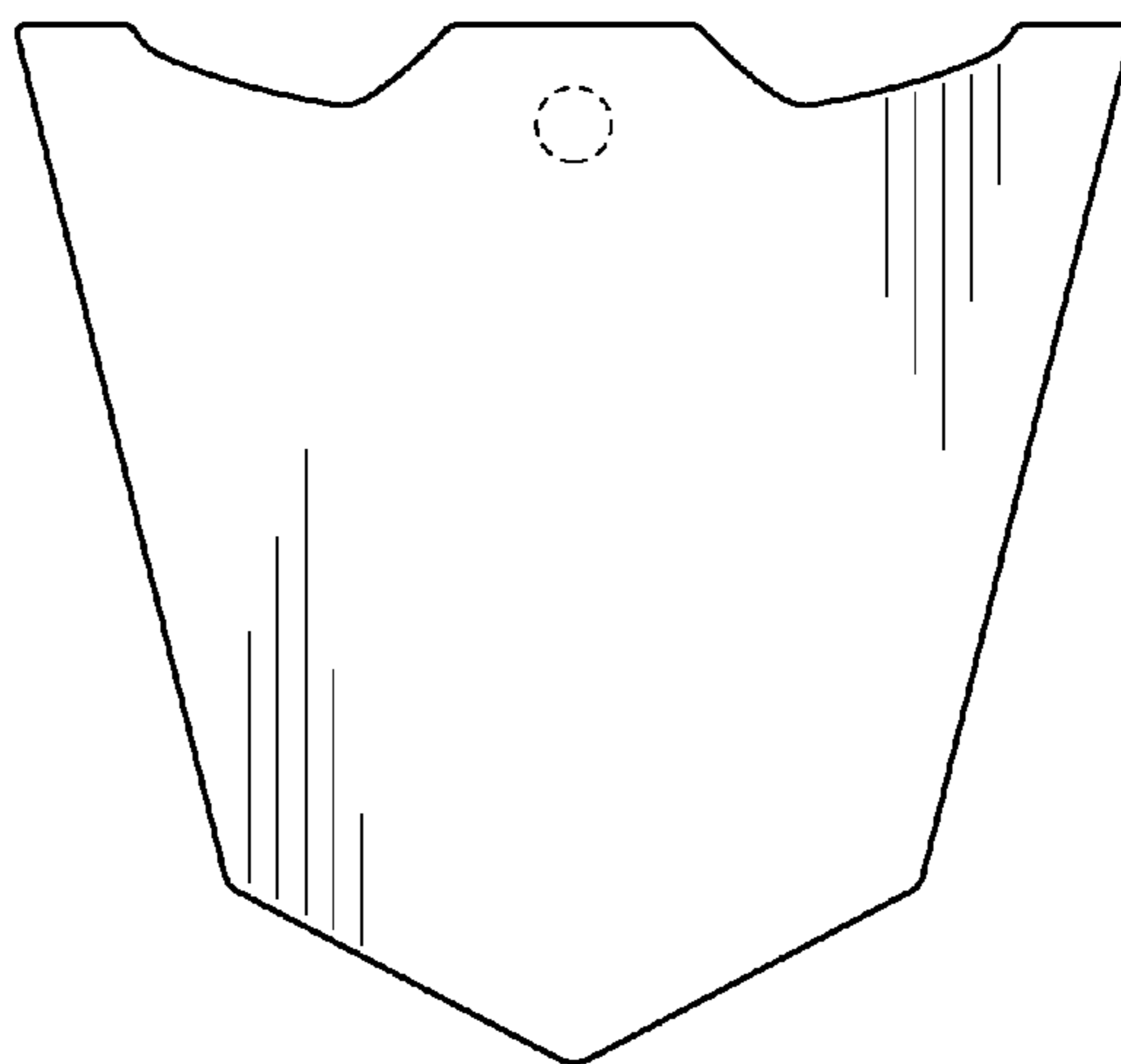

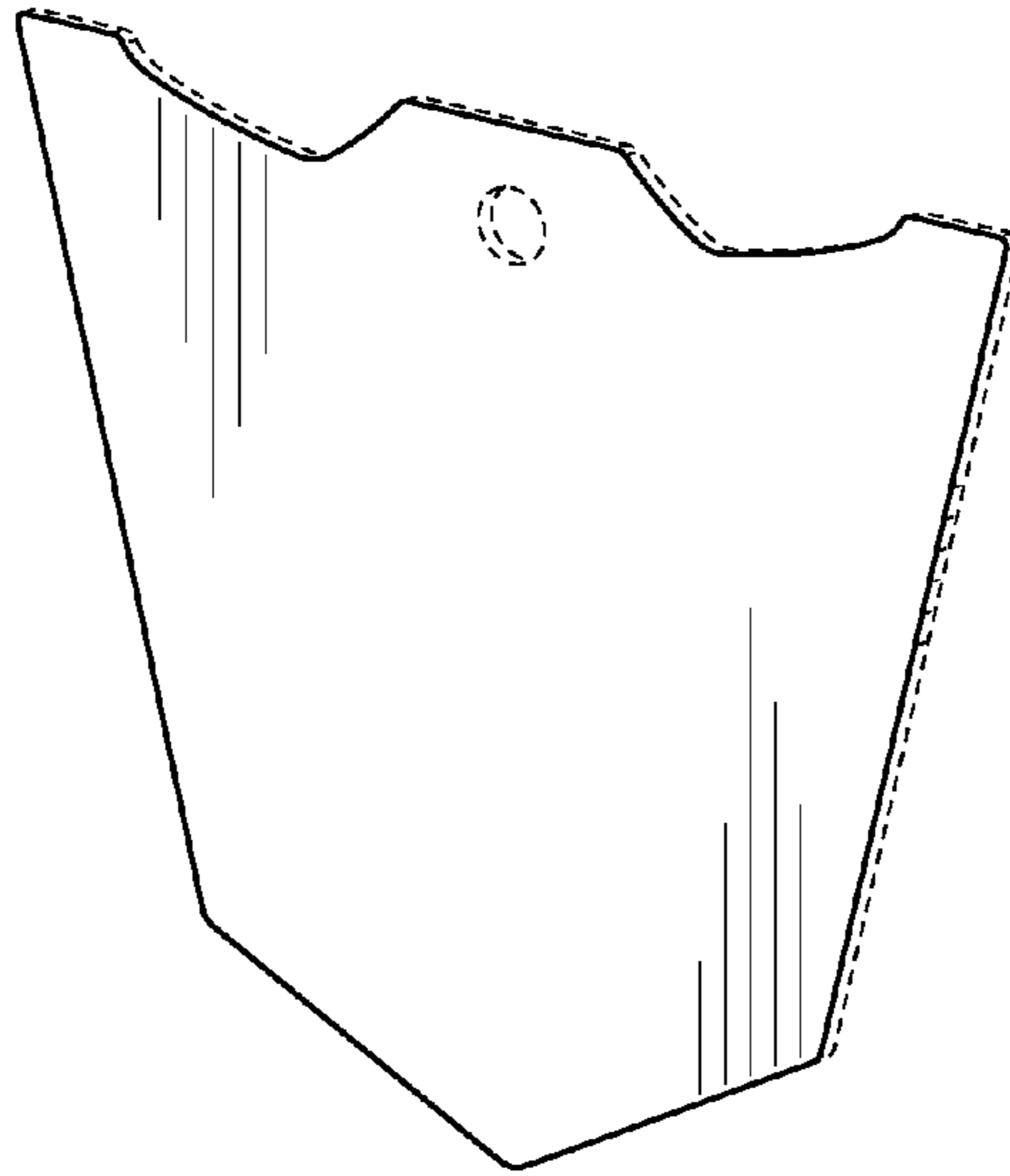

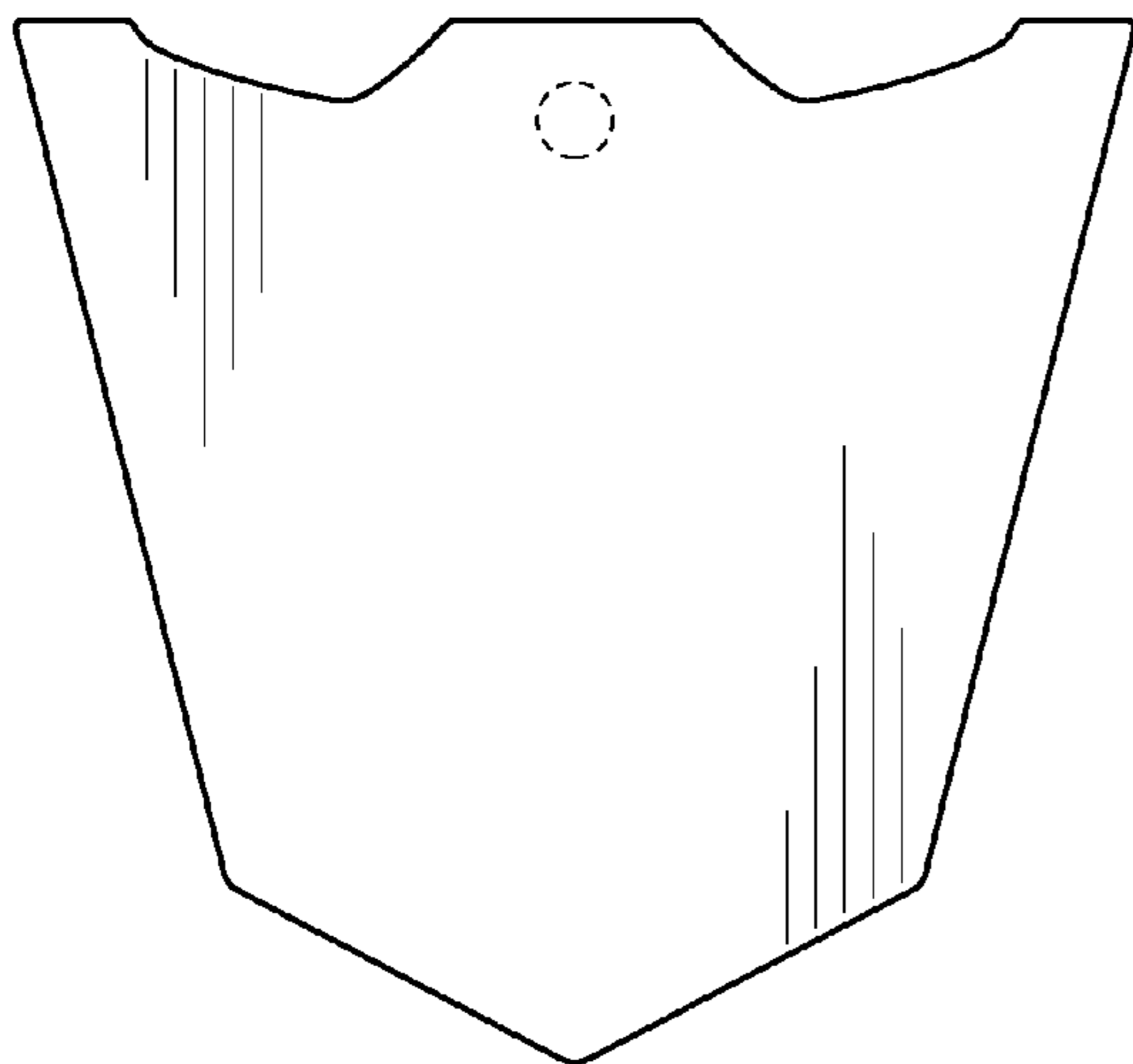

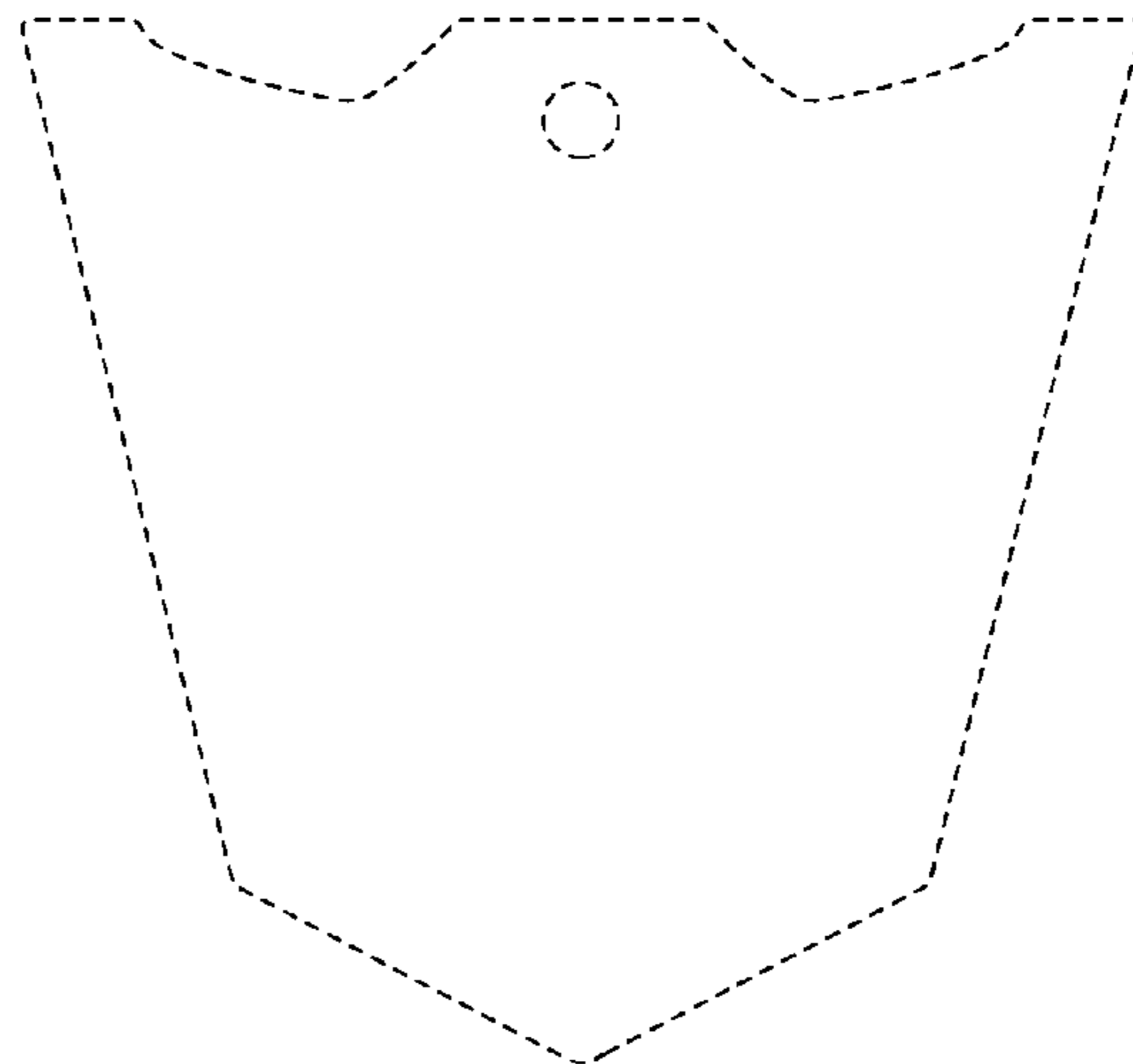

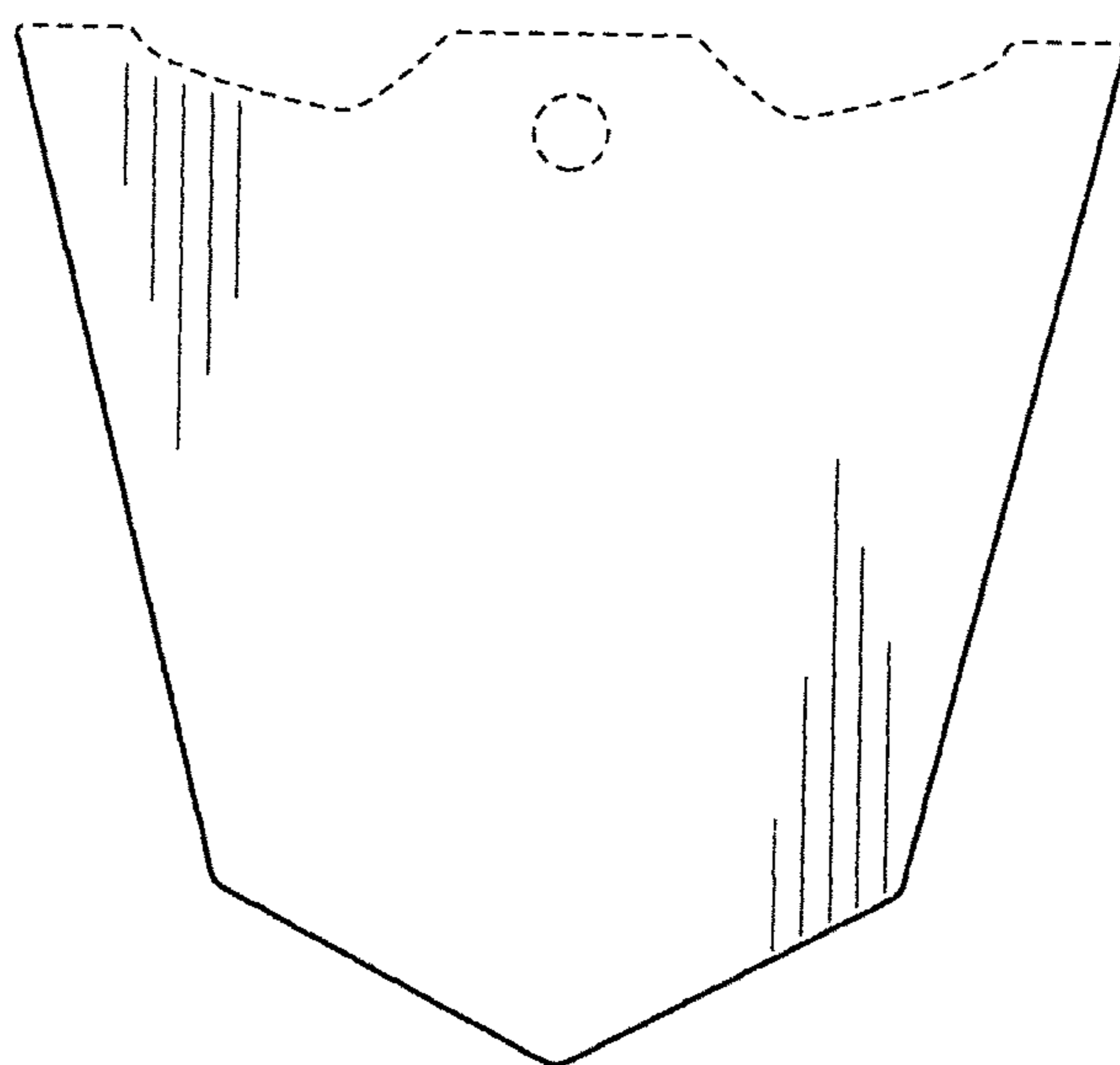
