(57) **CLAIM**

The ornamental design for a dental bite block, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a dental bite block showing an embodiment of the design of this invention.

FIG. 2 is a top view thereof, the bottom view being symmetrical.

FIG. 3 is a front view thereof. The broken lines shown in this Figure are for illustrative purposes only and form no part of the claimed design.

FIG. 4 is a back view thereof. The broken lines shown in this Figure are for illustrative purposes only and form no part of the claimed design.

FIG. 5 is a left side view thereof. The broken lines shown in this Figure are for illustrative purposes only and form no part of the claimed design.

FIG. 6 is a right side view thereof; and,

FIG. 7 is another perspective view thereof, showing the dental bite block in use. The broken lines shown in this Figure are for illustrative purposes only and form no part of the claimed design.

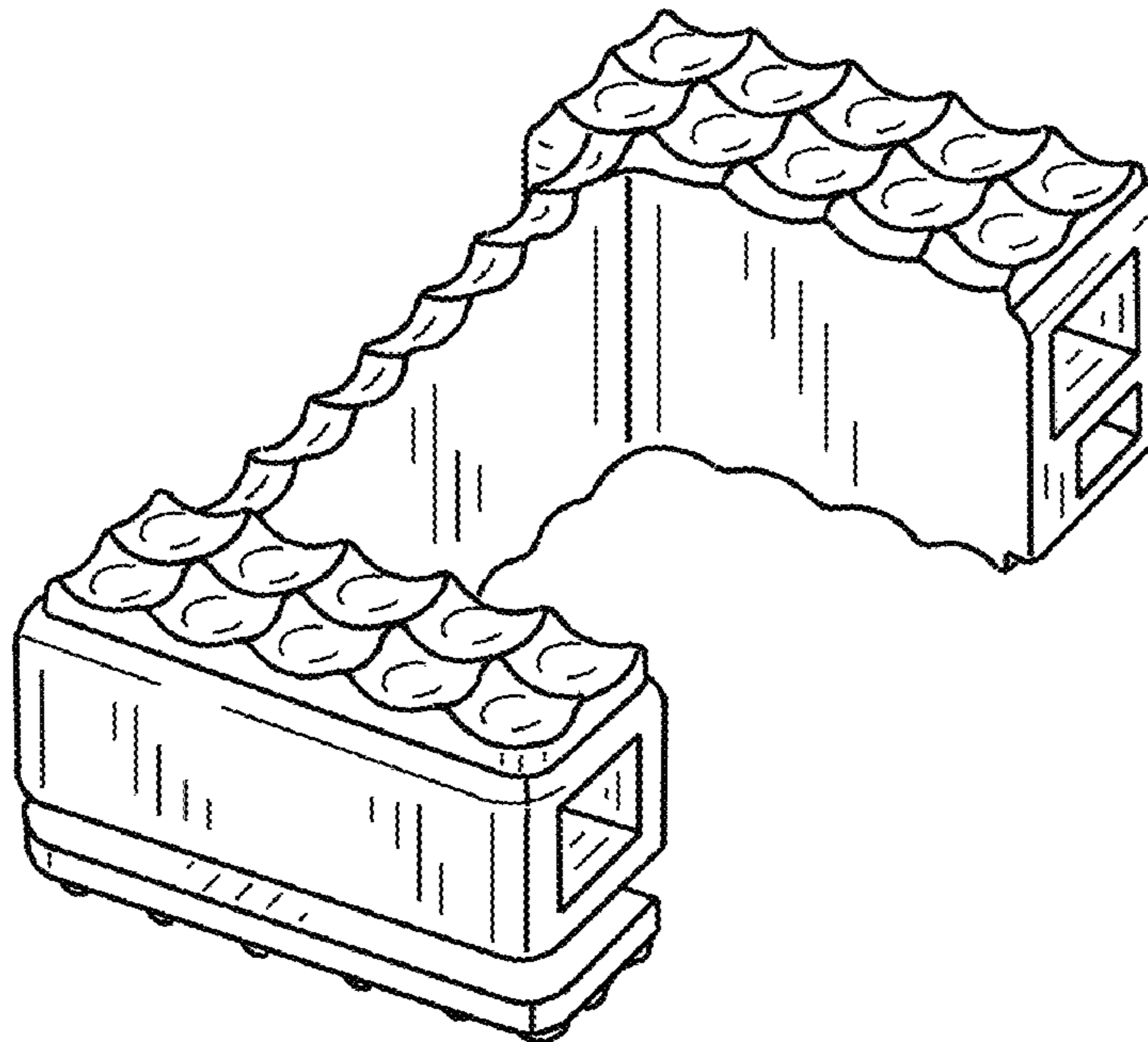

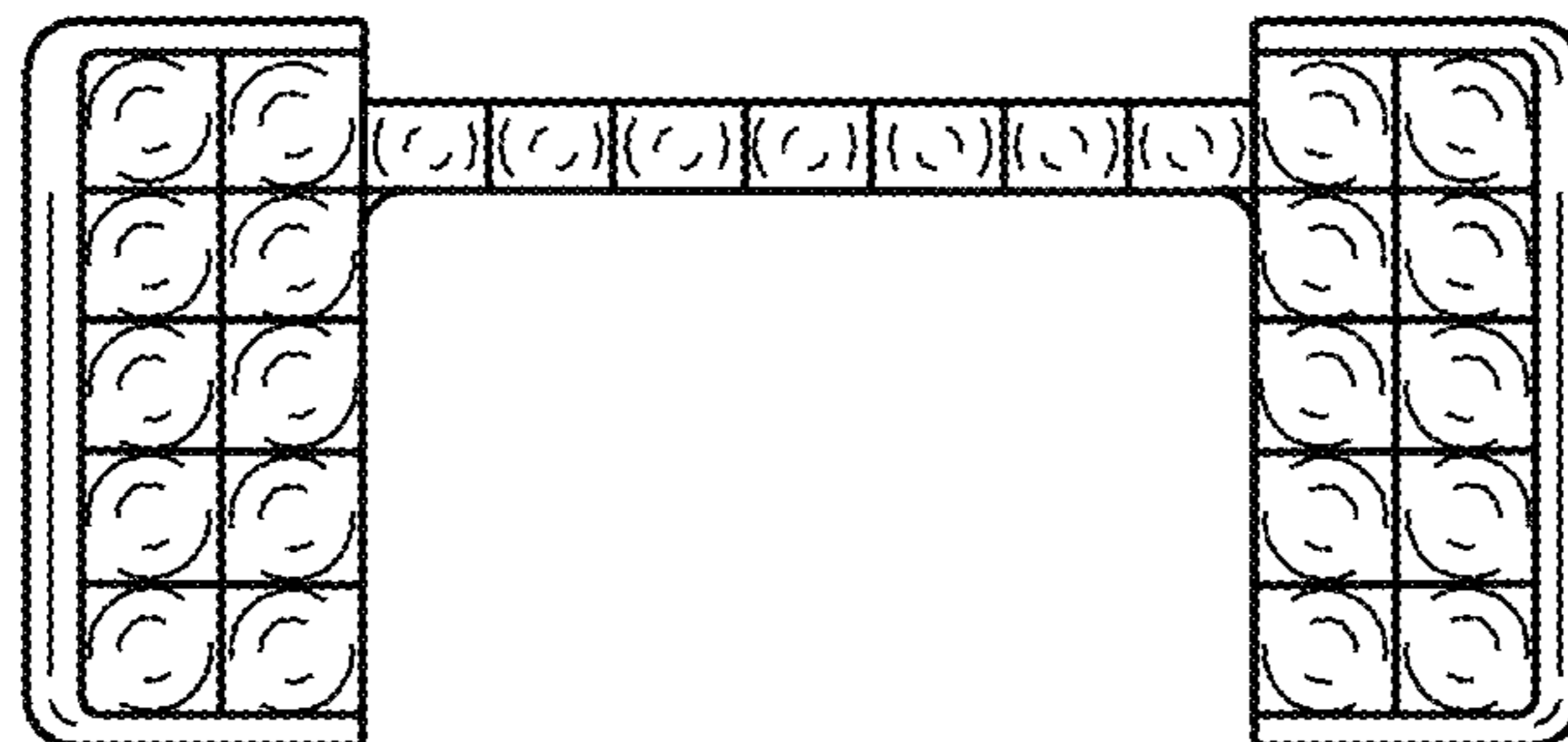
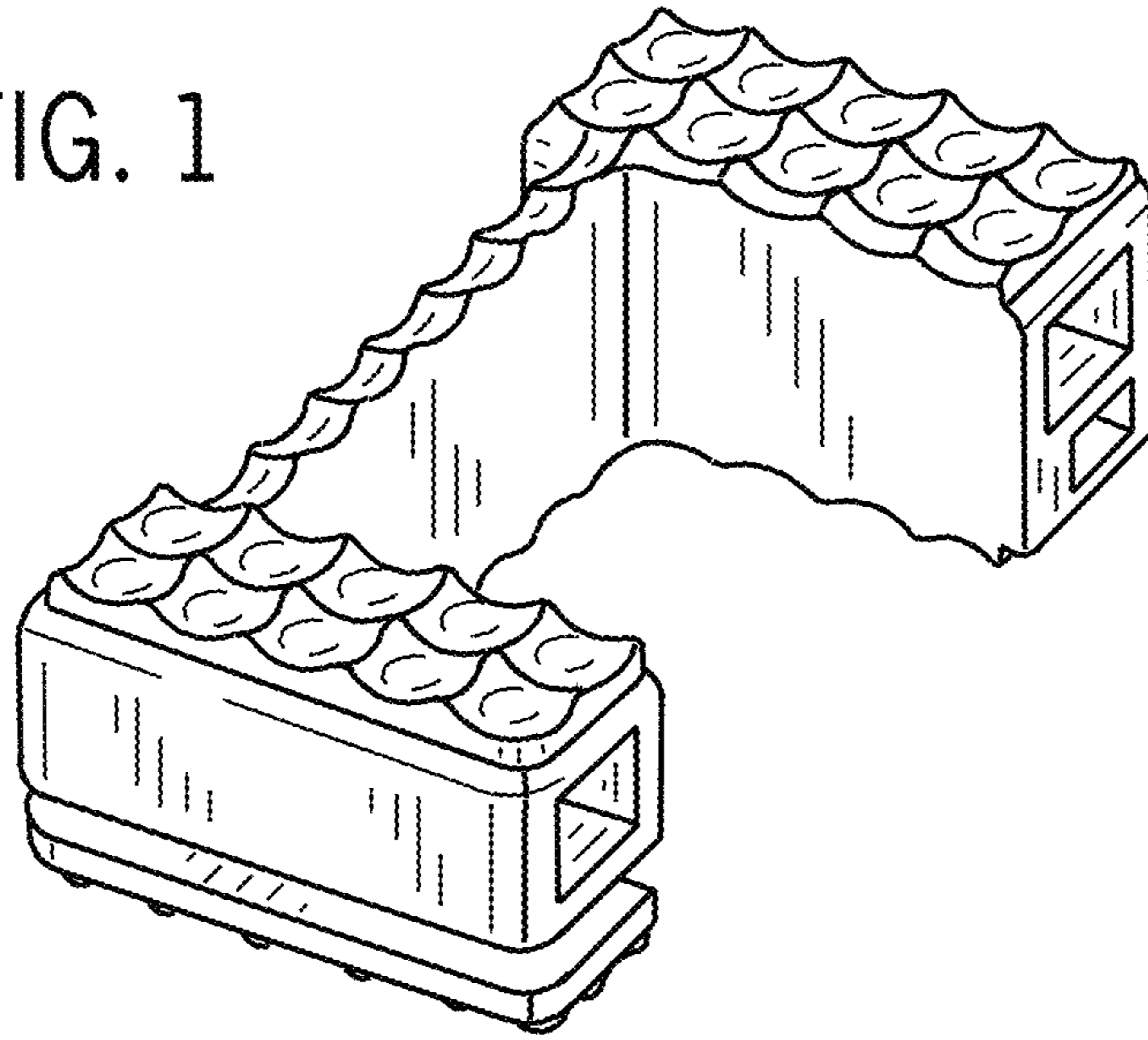

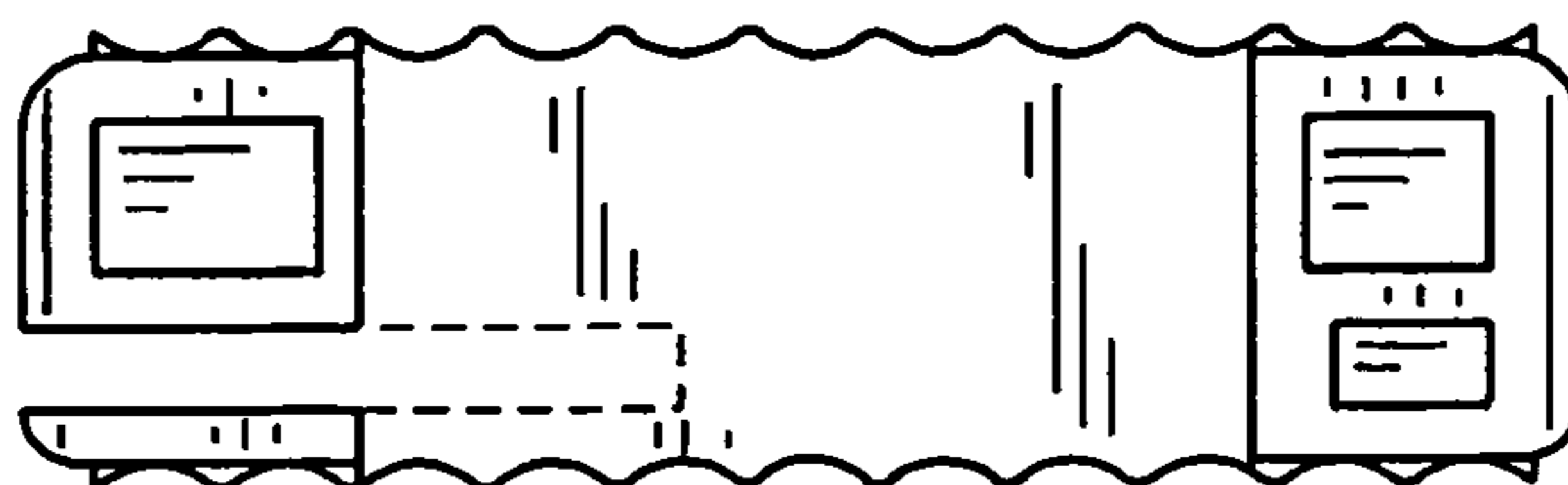

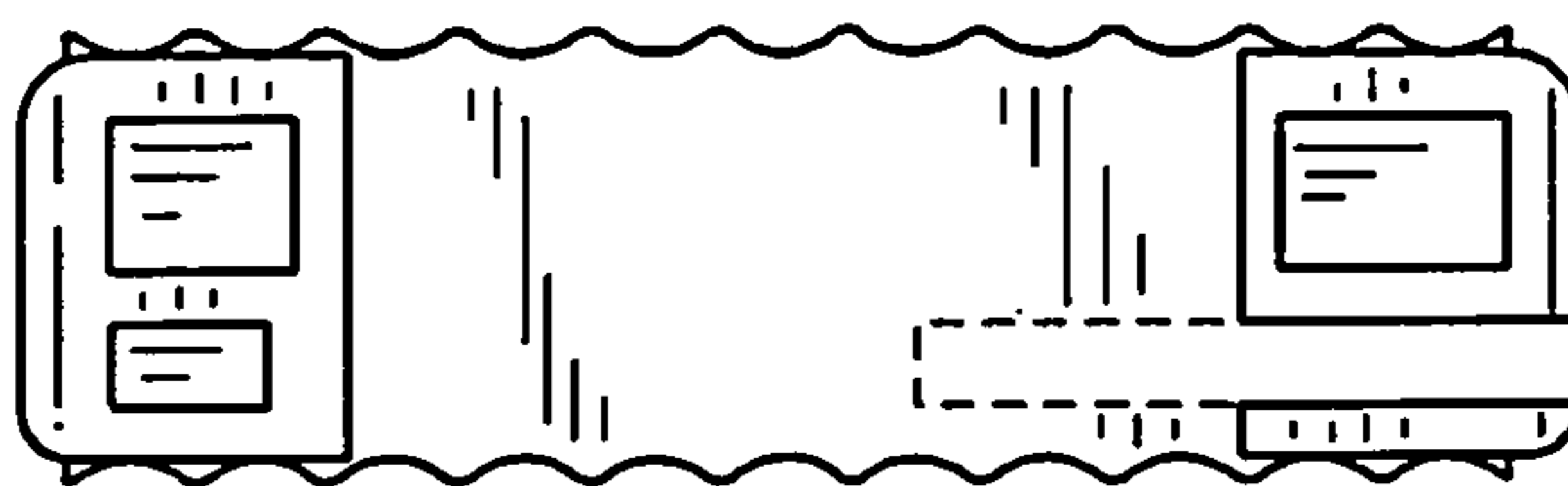

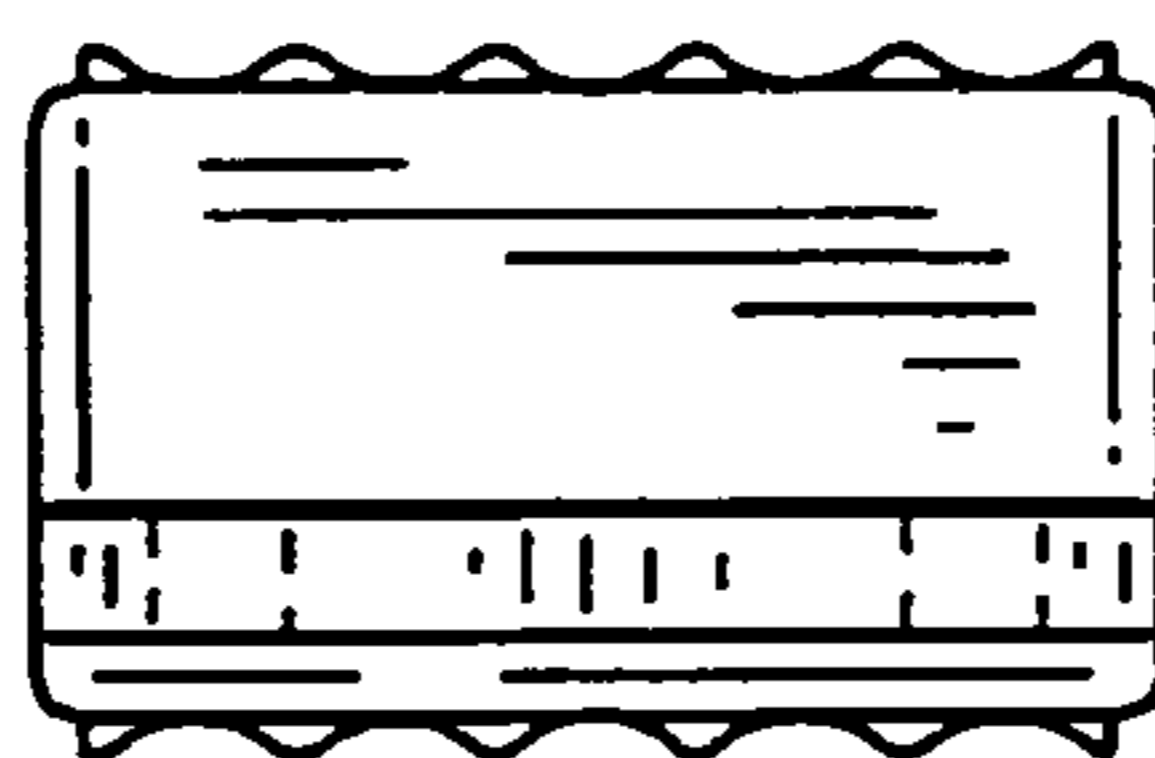
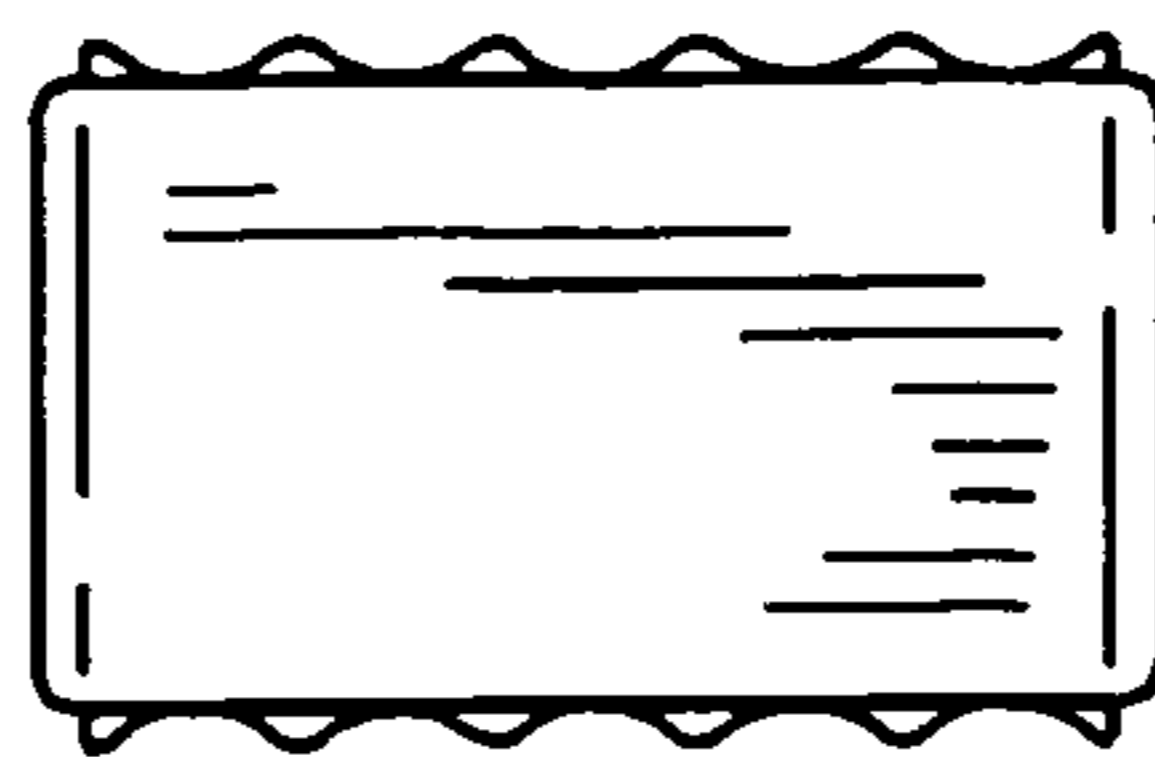

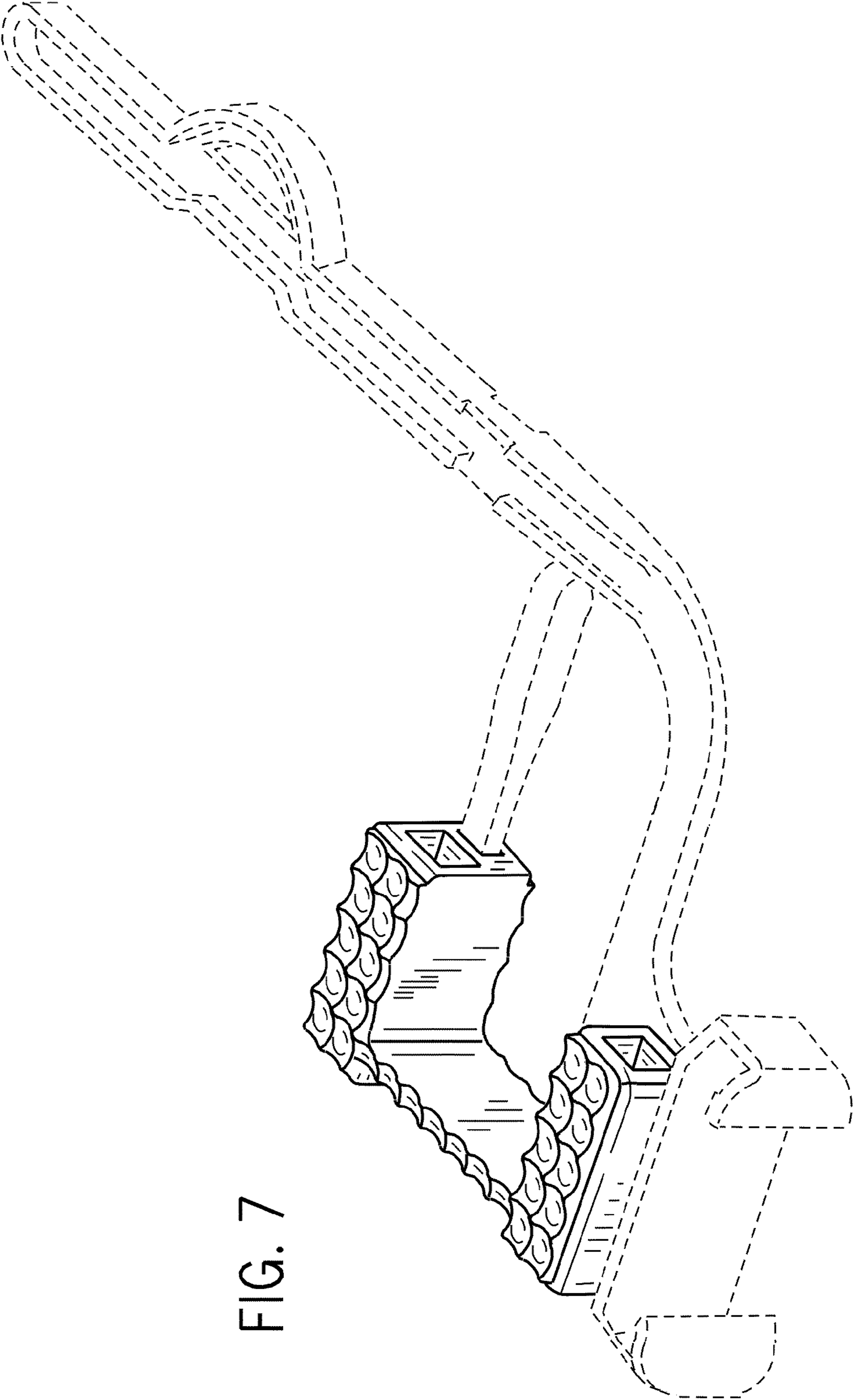
