FIG. 1 is a bottom perspective view of a light fixture showing our new design;

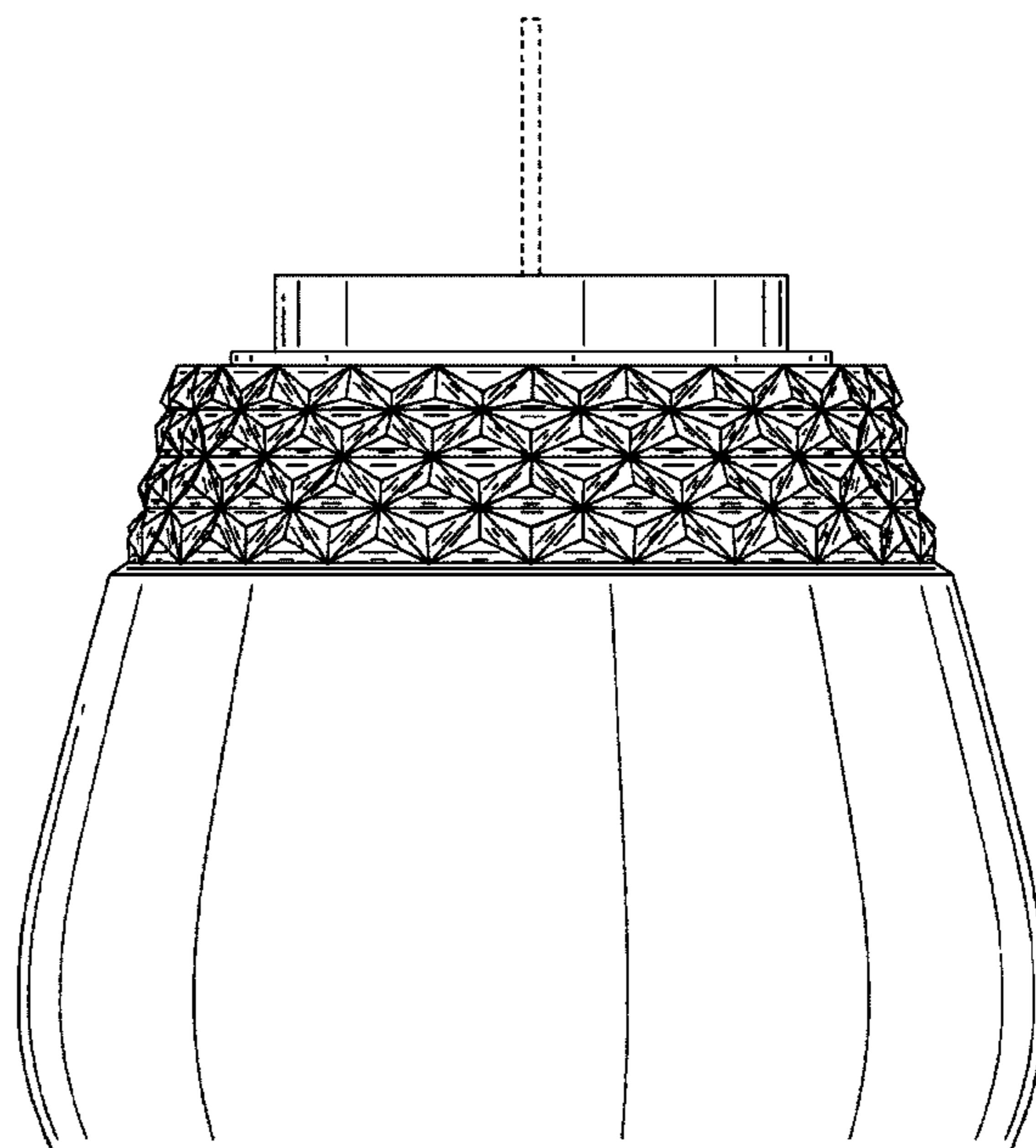
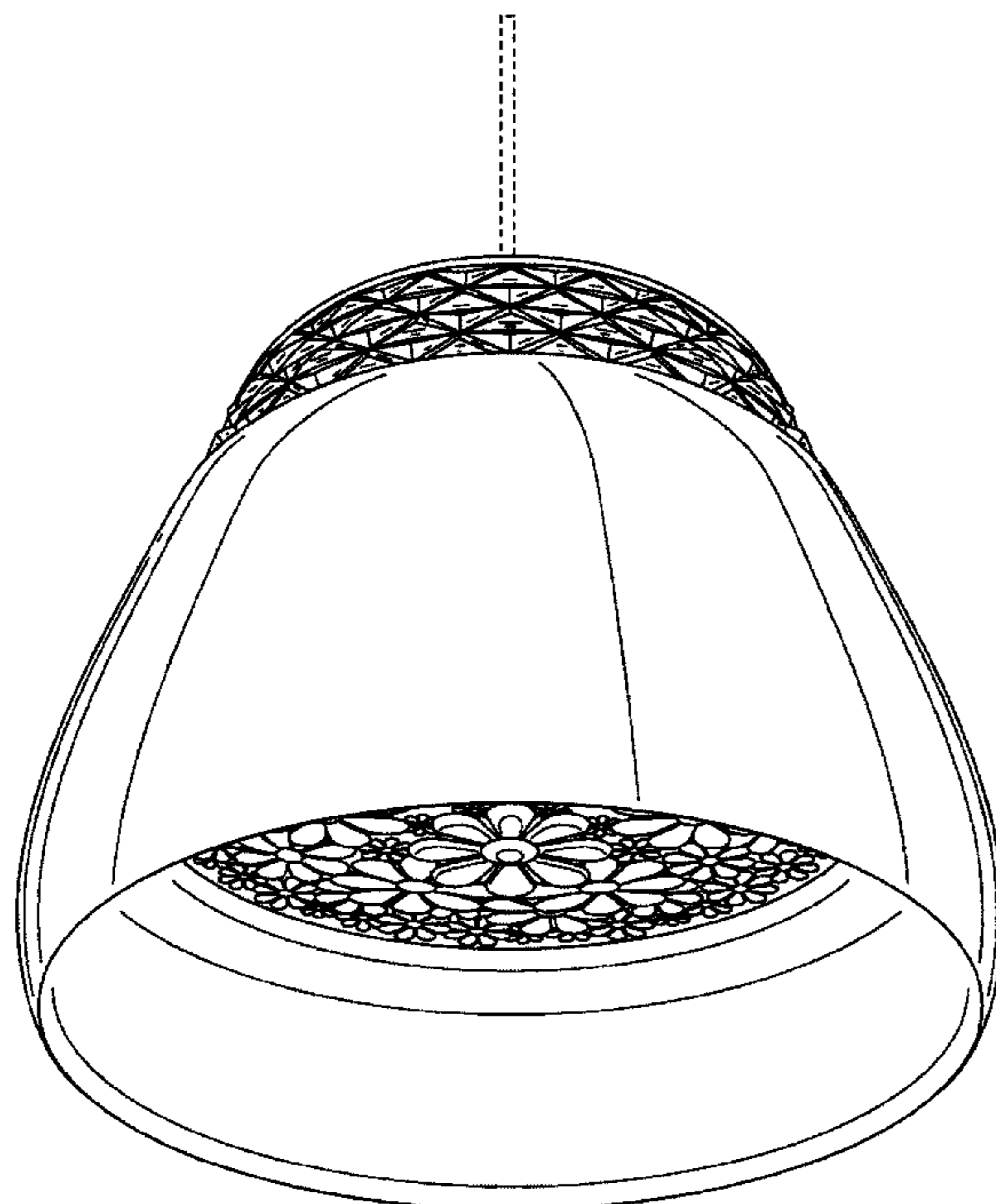
FIG. 2 is a front view thereof, the right side, left side and back side views being the same;

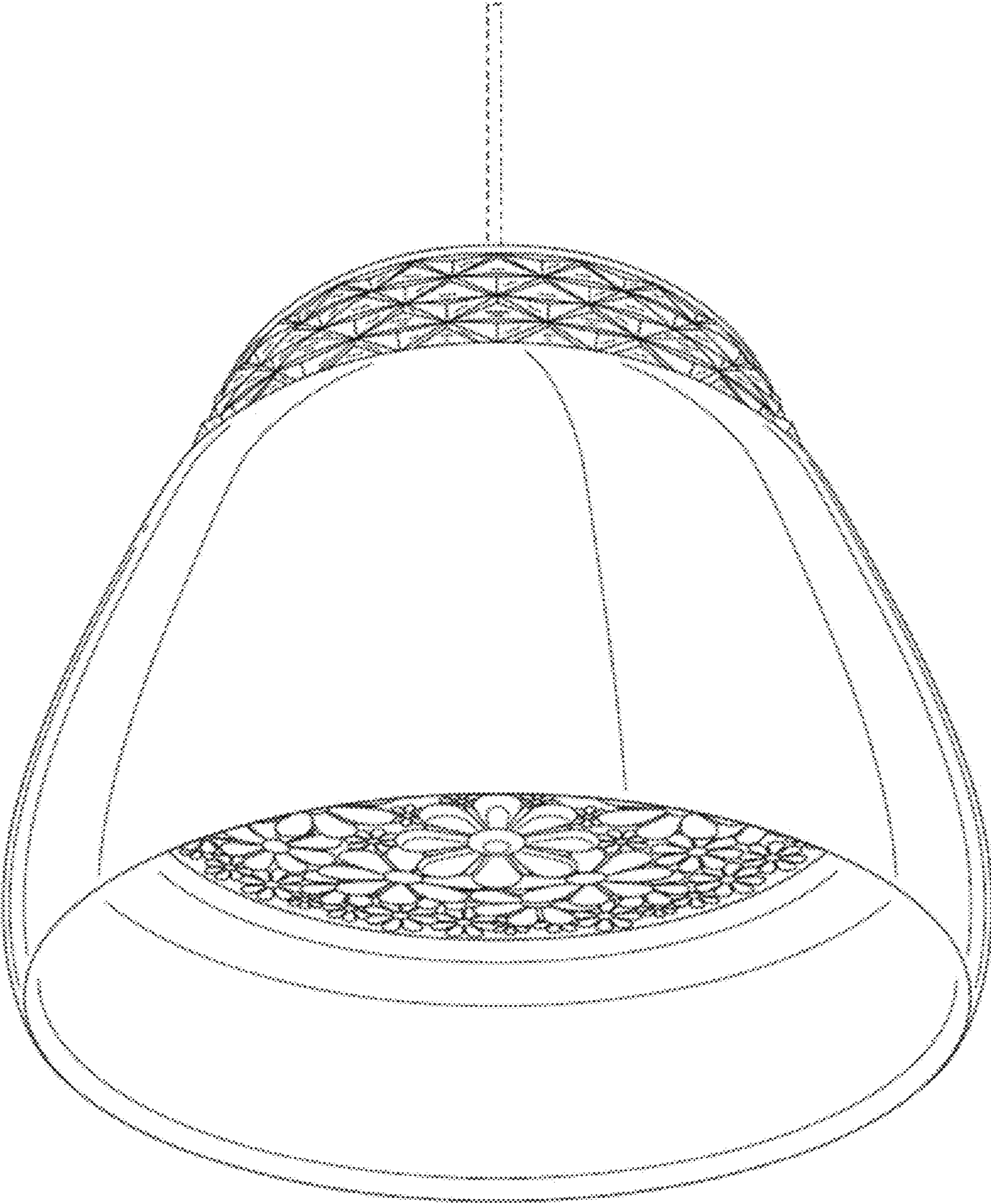

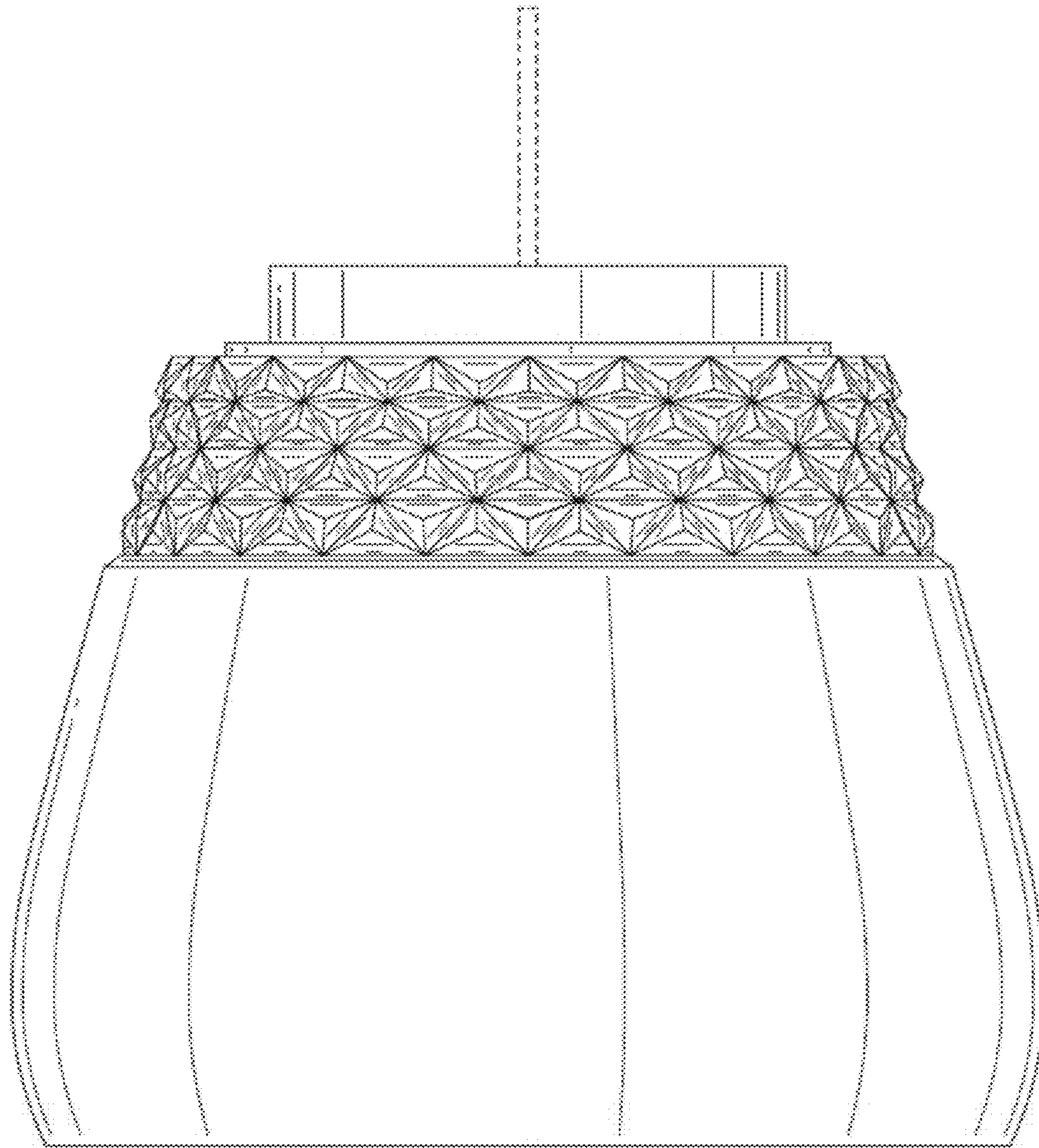

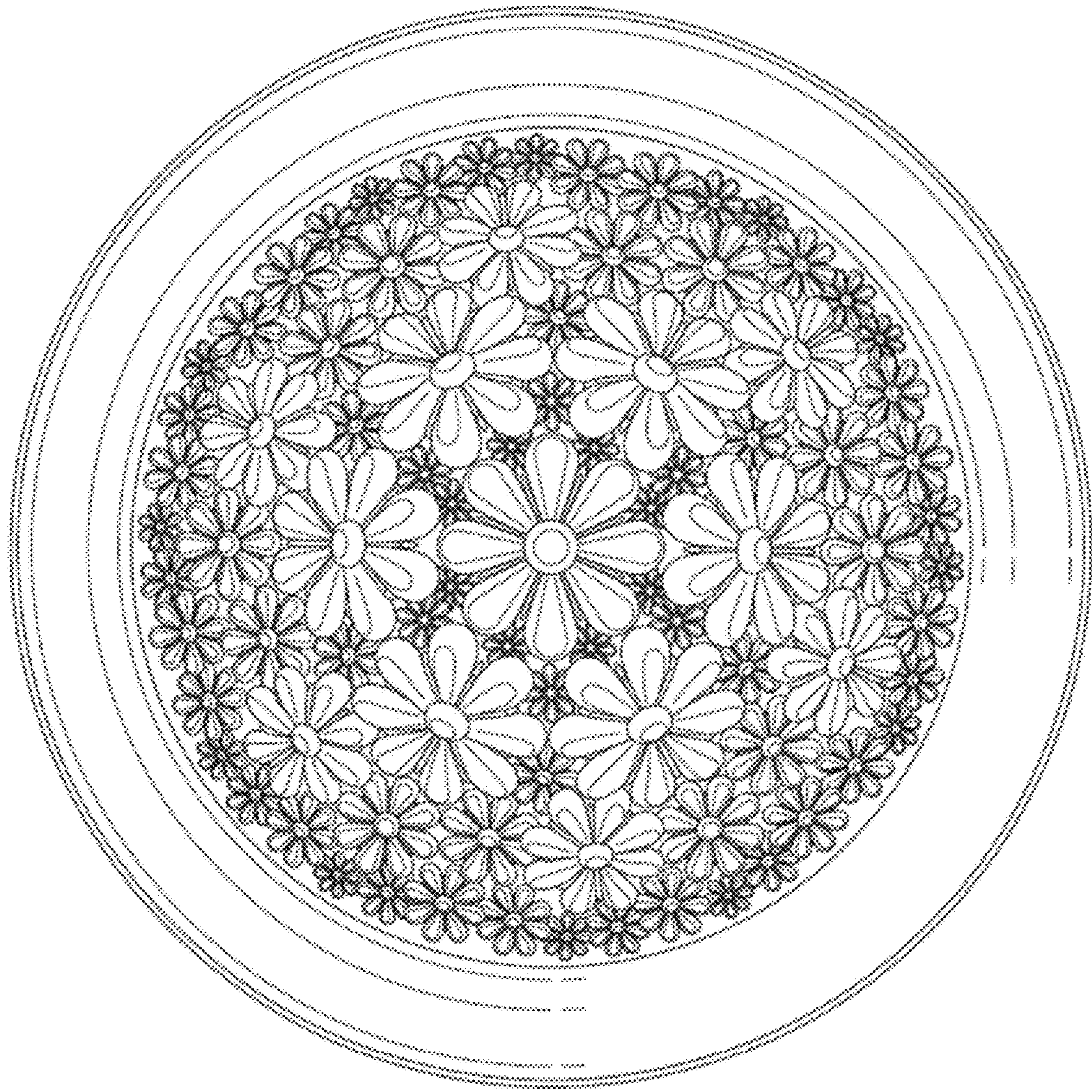

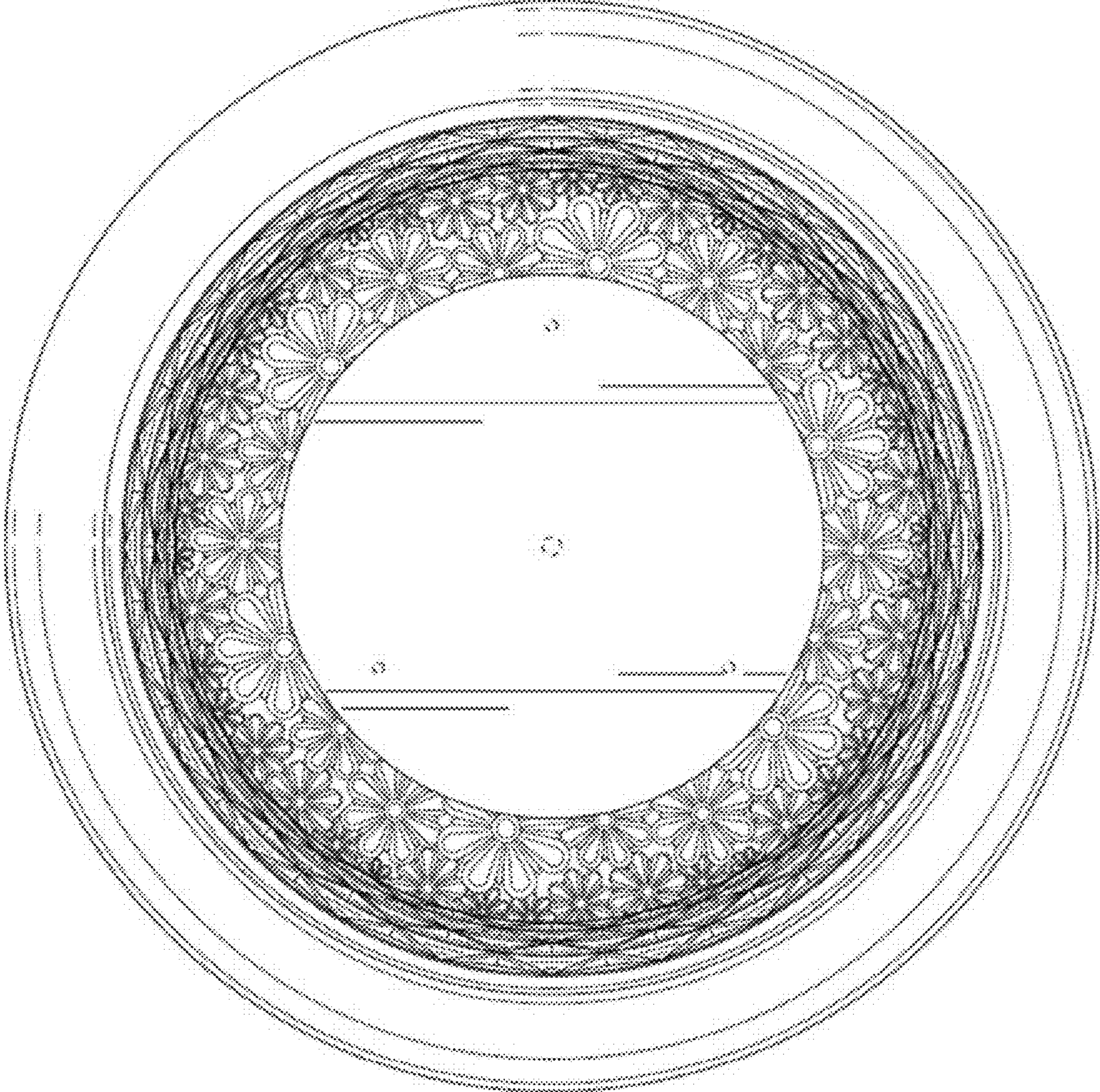
