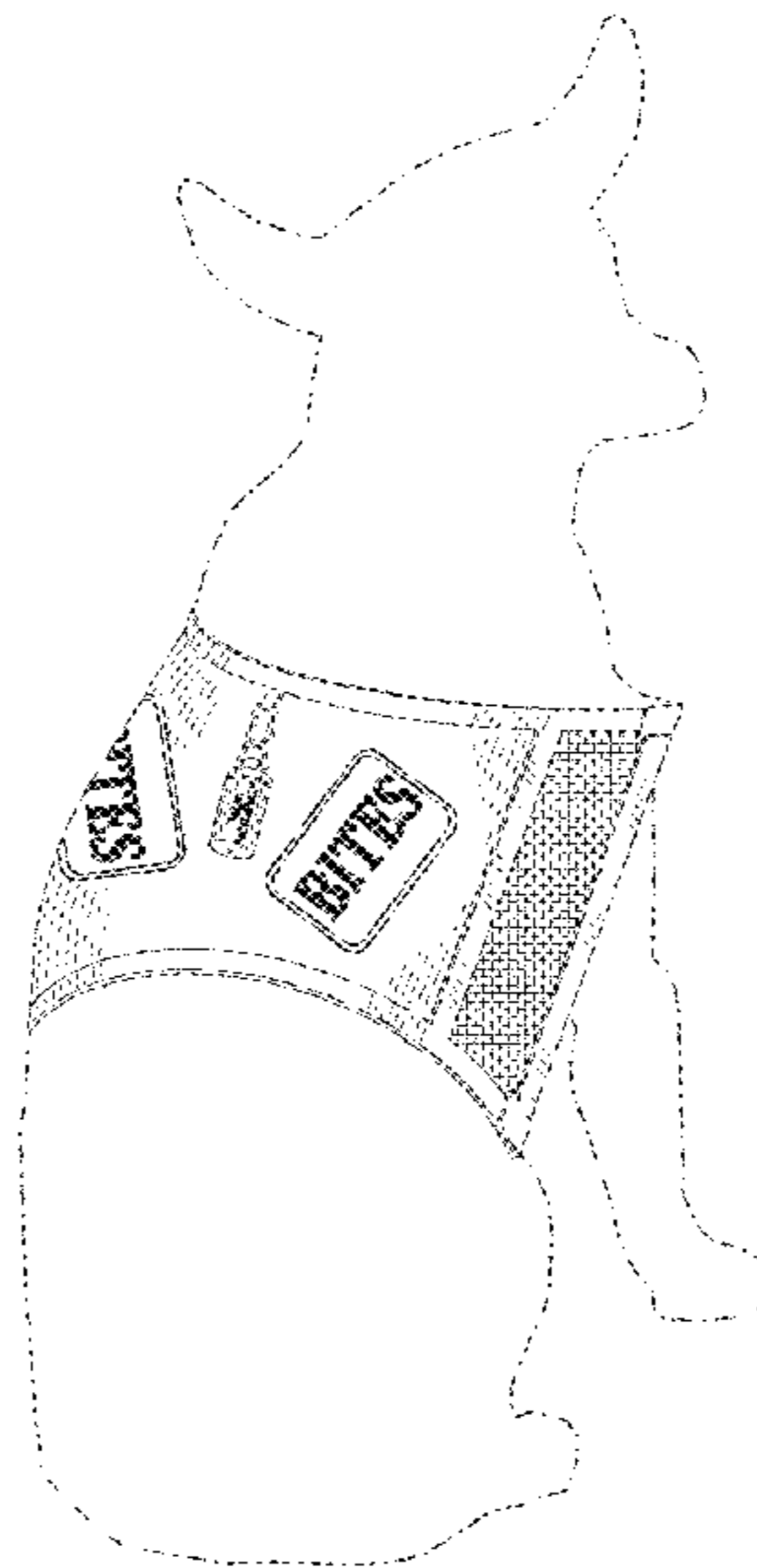
(57) **CLAIM**

I claim the ornamental design for an animal medical alert vest, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an animal medical alert vest; FIG. 2 is a front view of the animal medical alert vest of FIG. 1; FIG. 3 is a rear view of the animal medical alert vest of FIG. 1; FIG. 4 is a top view of the animal medical alert vest of FIG. 1; FIG. 5 is a bottom view of the animal medical alert vest of FIG. 1; FIG. 6 is a left side view of the animal medical alert vest of FIG. 1; and, FIG. 7 is a right side view of the animal medical alert vest of FIG. 1. Broken lines and portions contained within broken lines are not claimed.

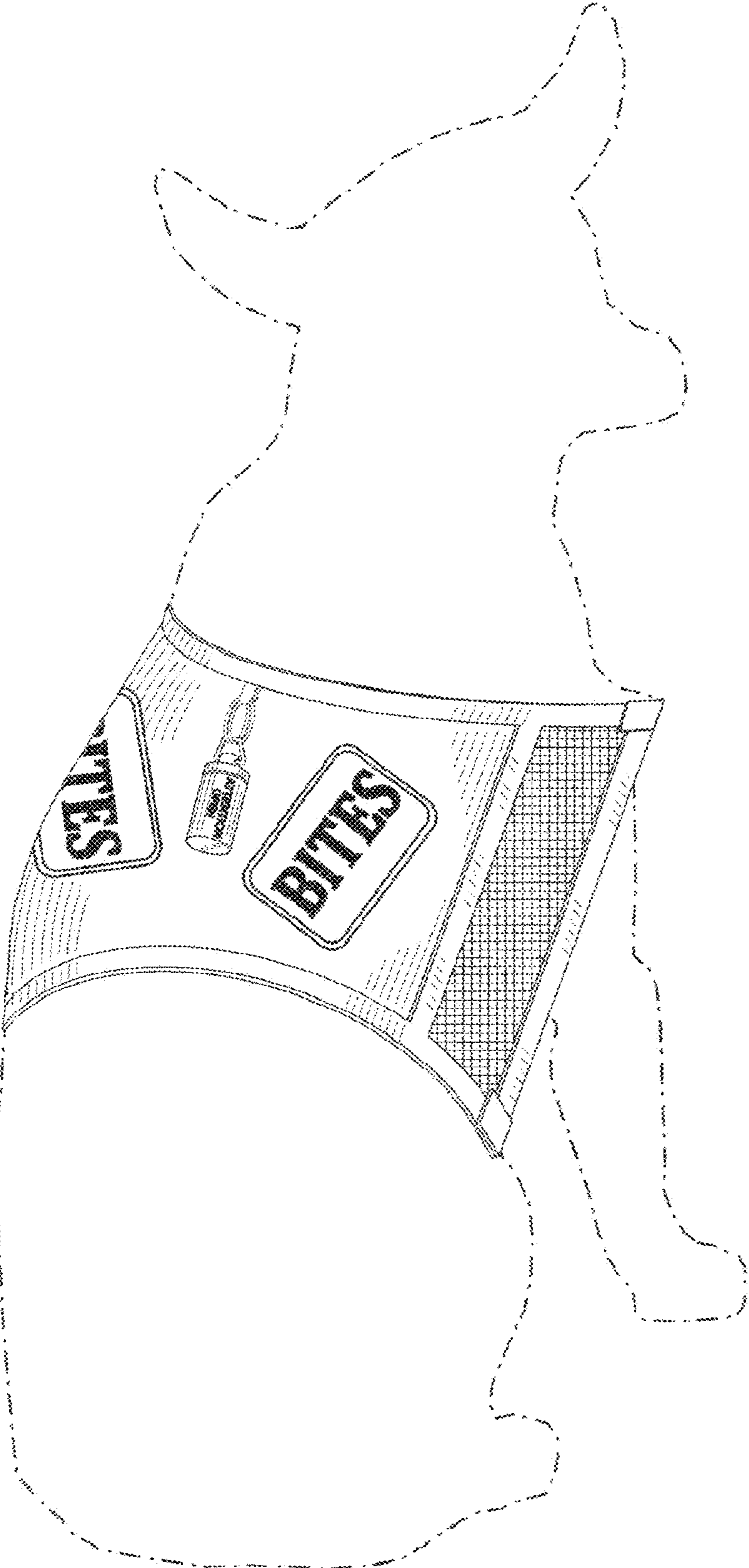

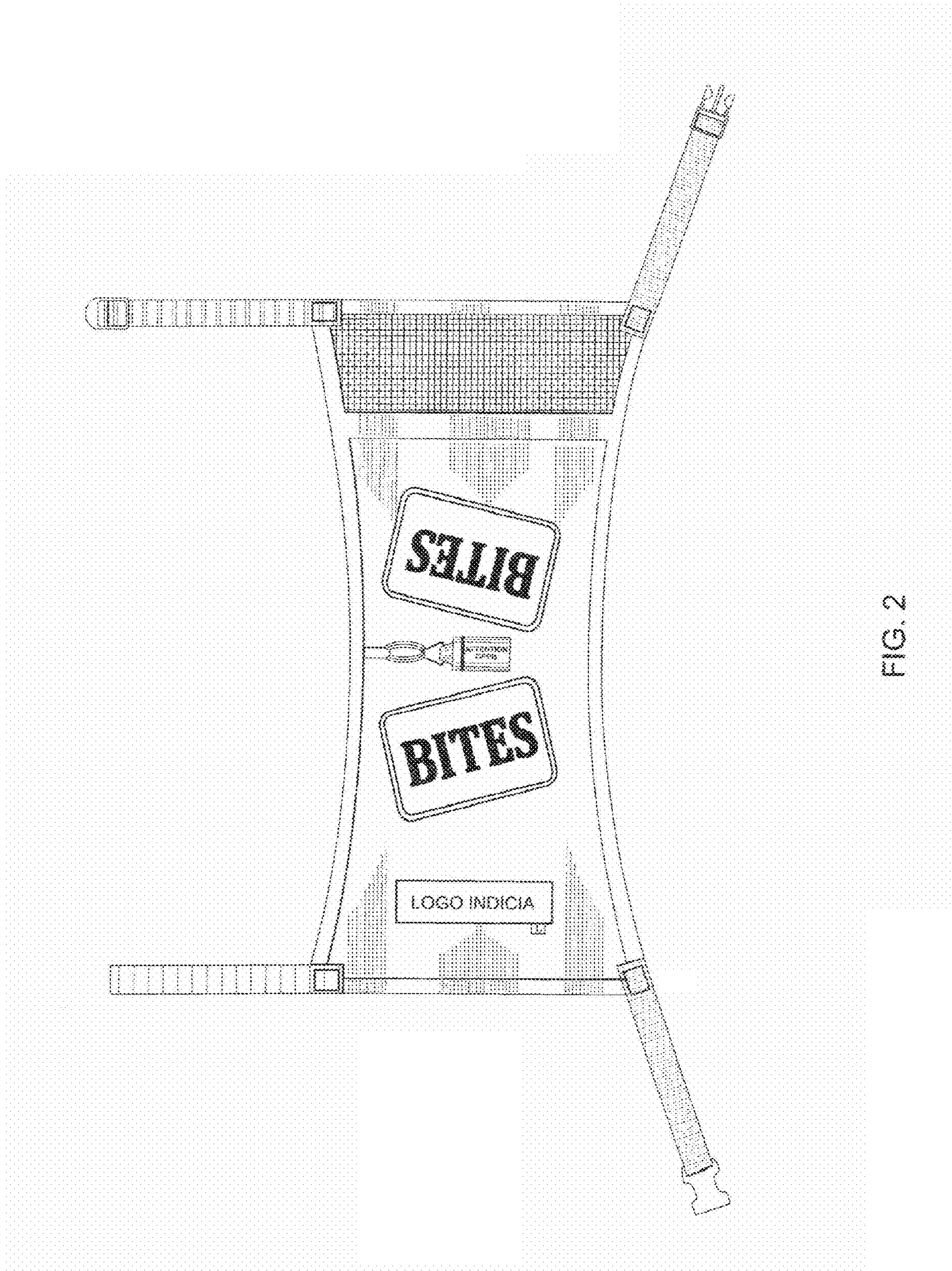

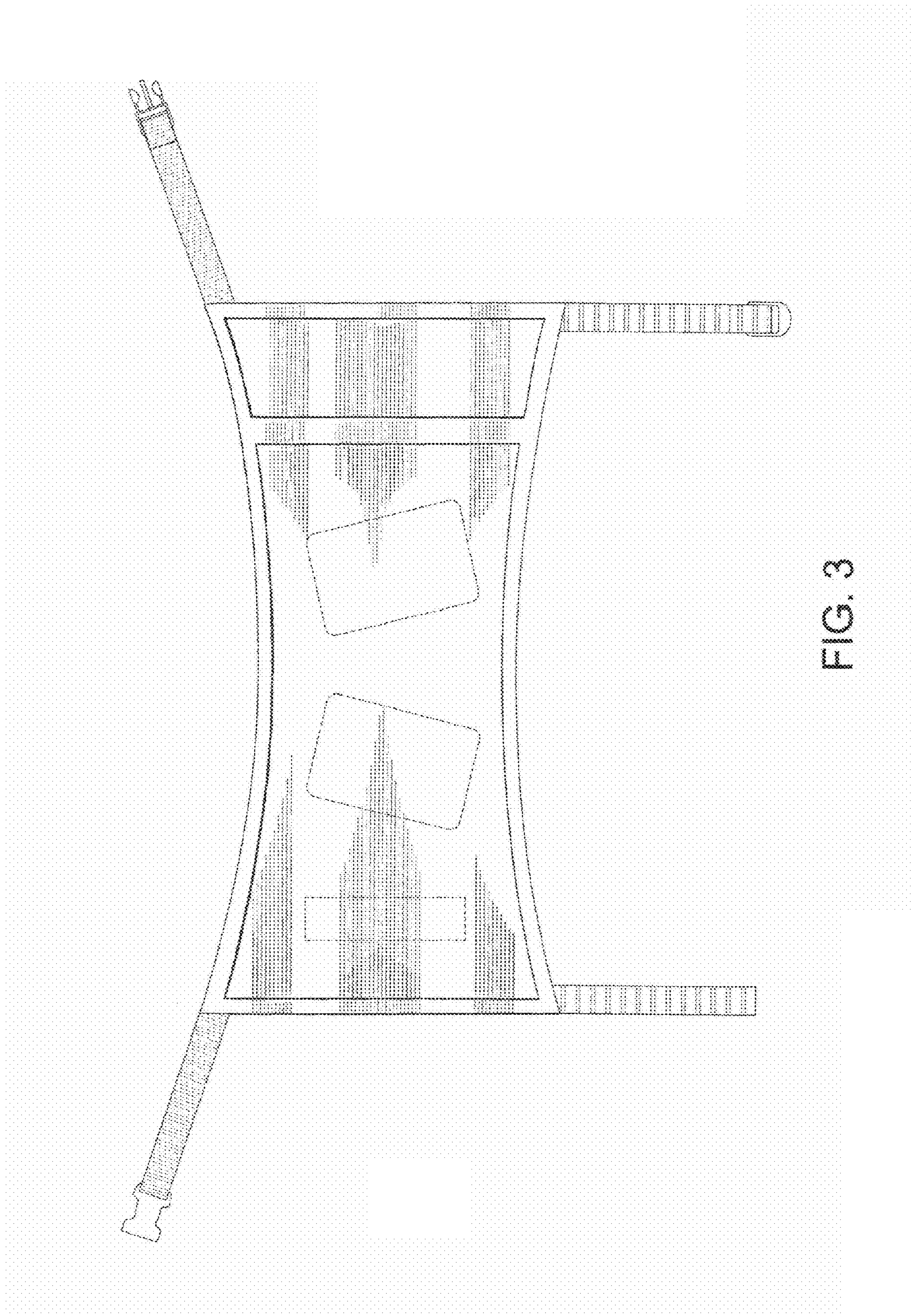
