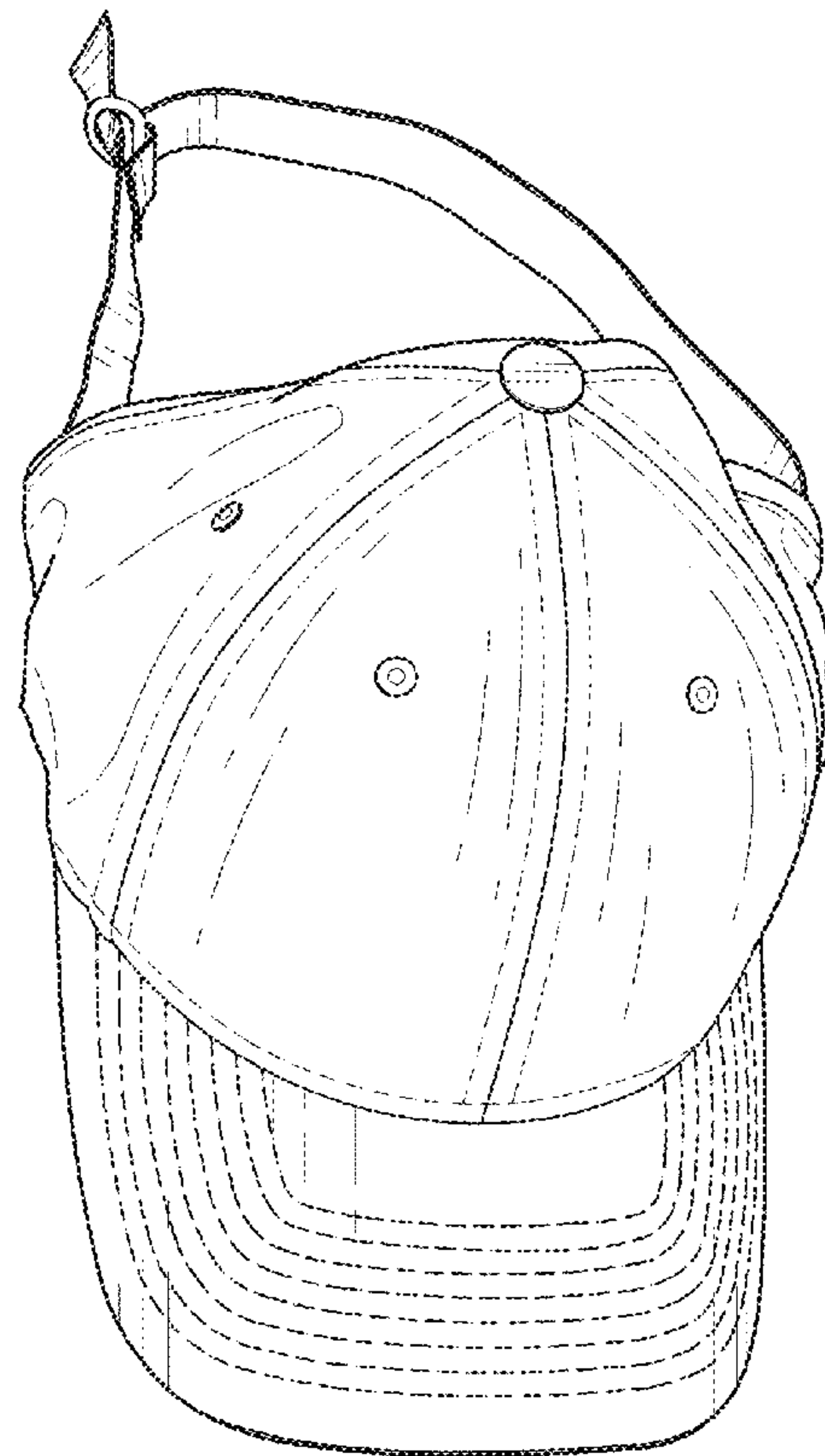
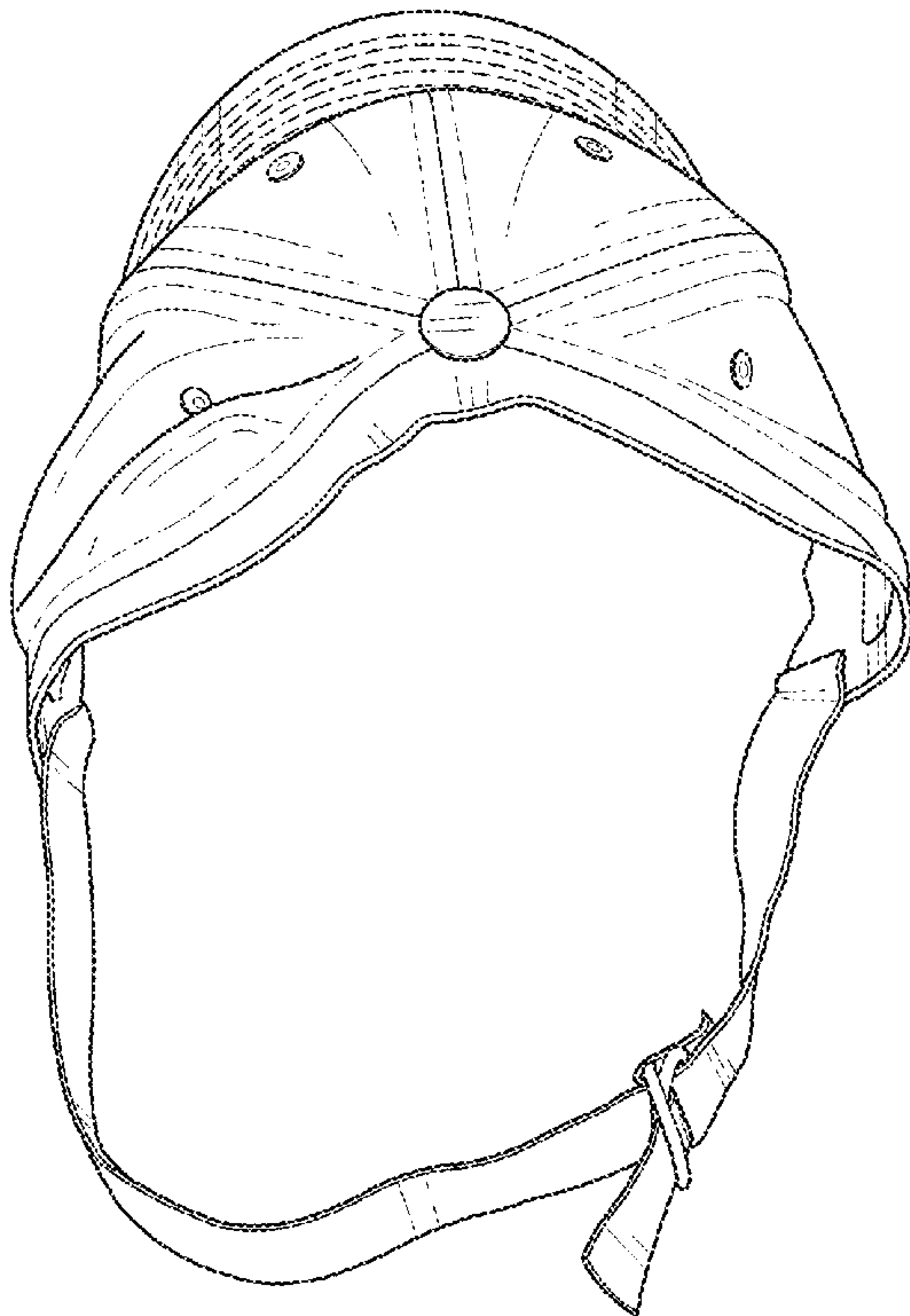
I claim the ornamental design for a backless sports cap, as shown and described.

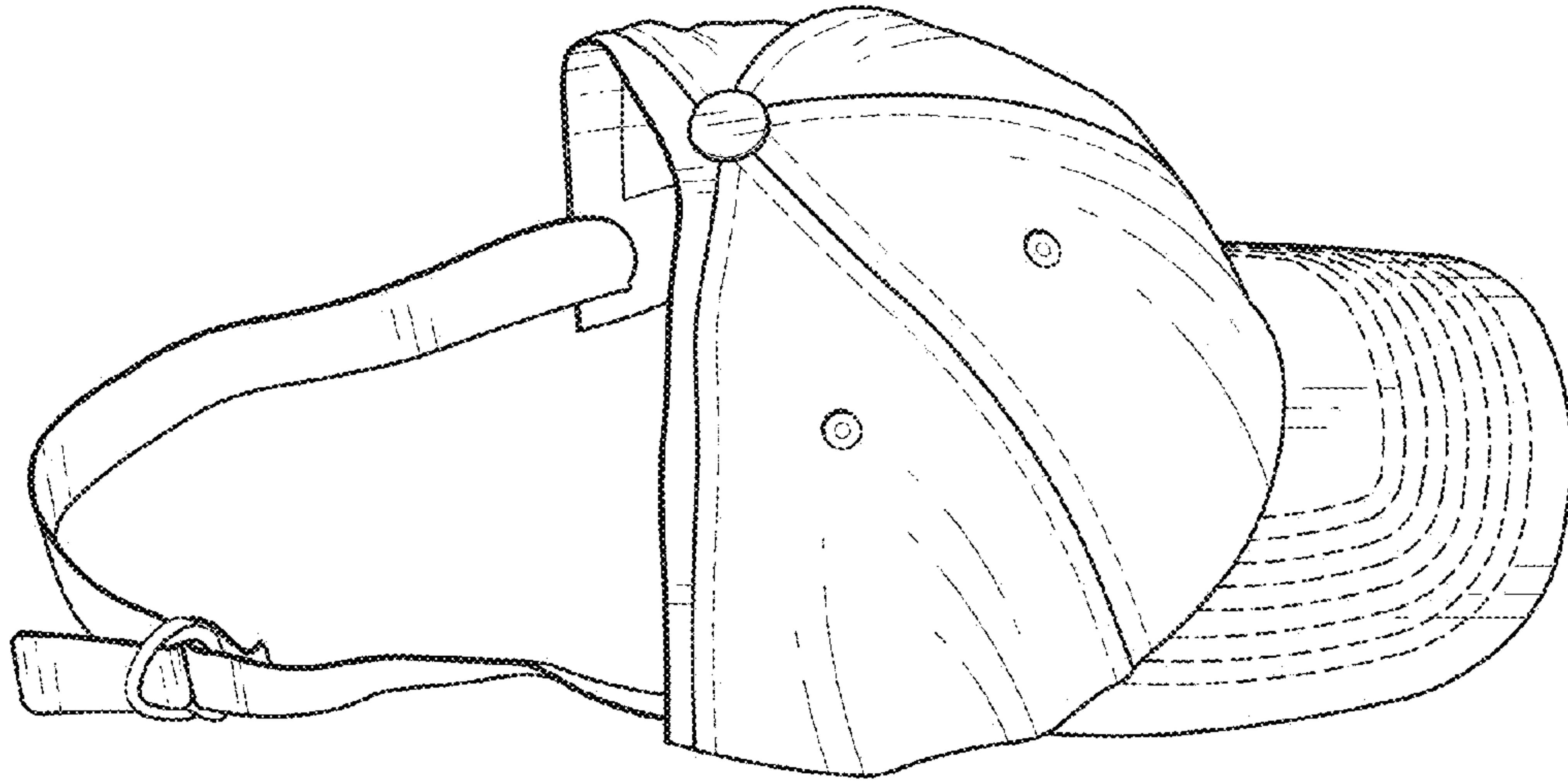

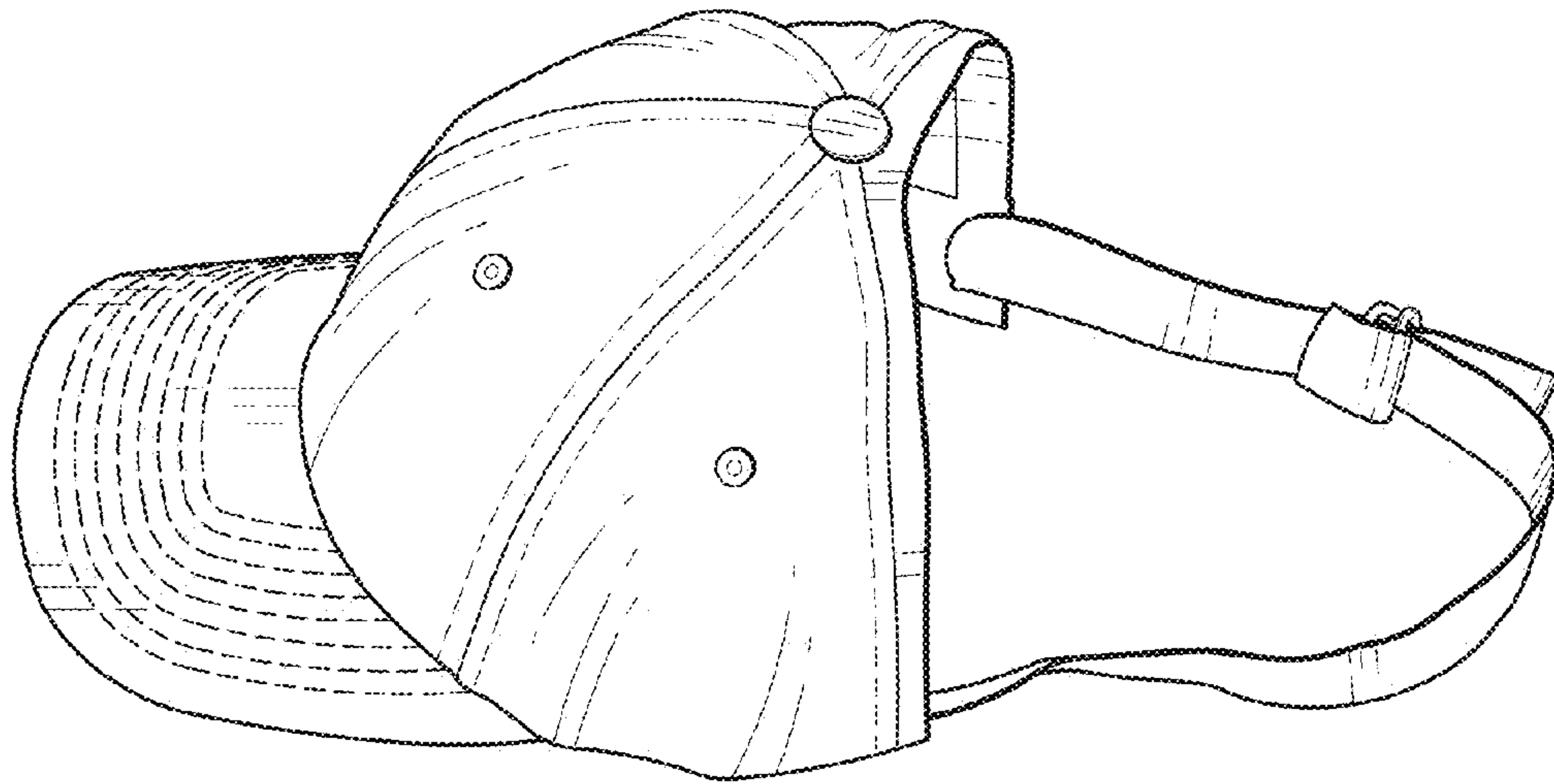
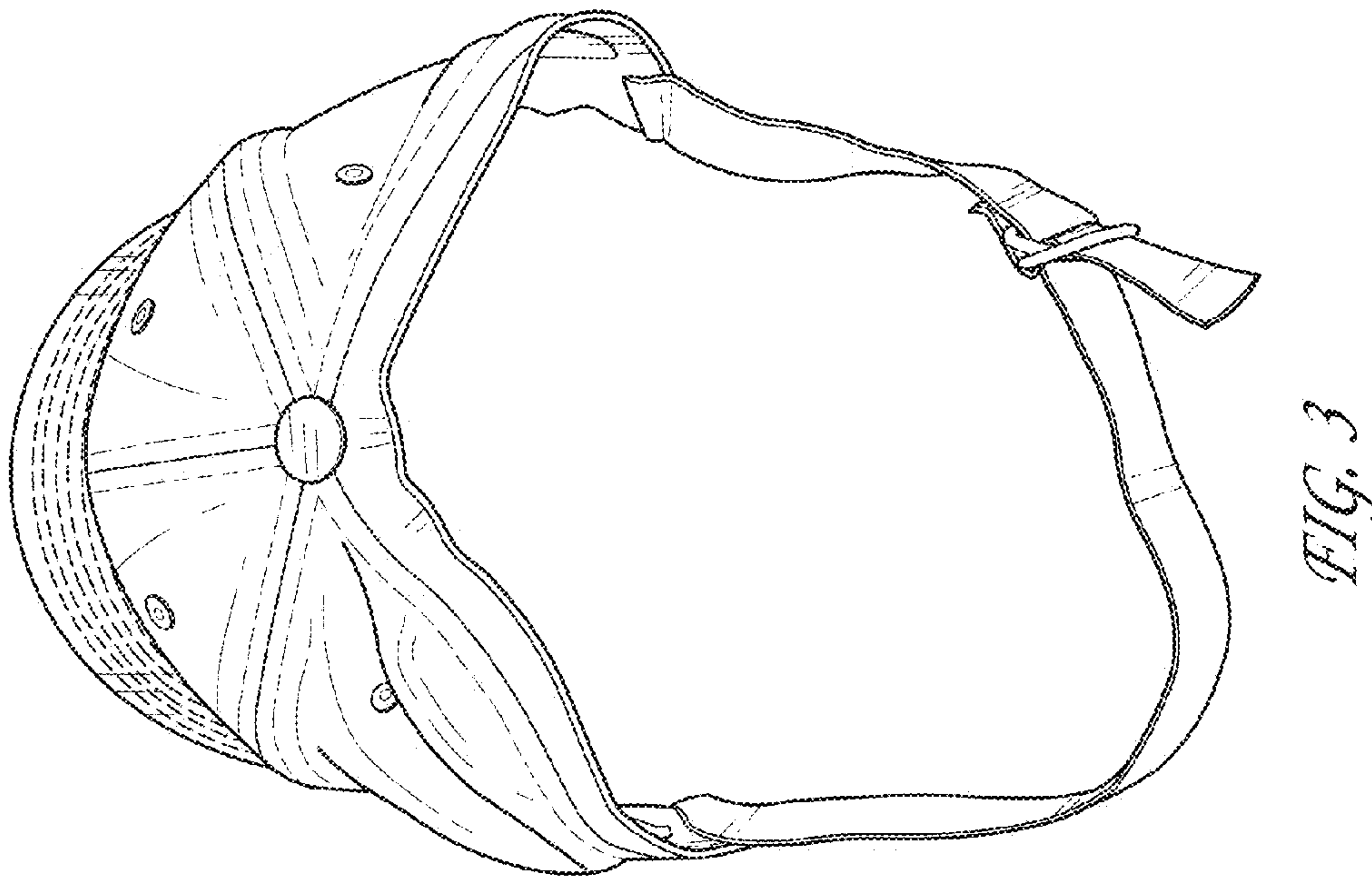
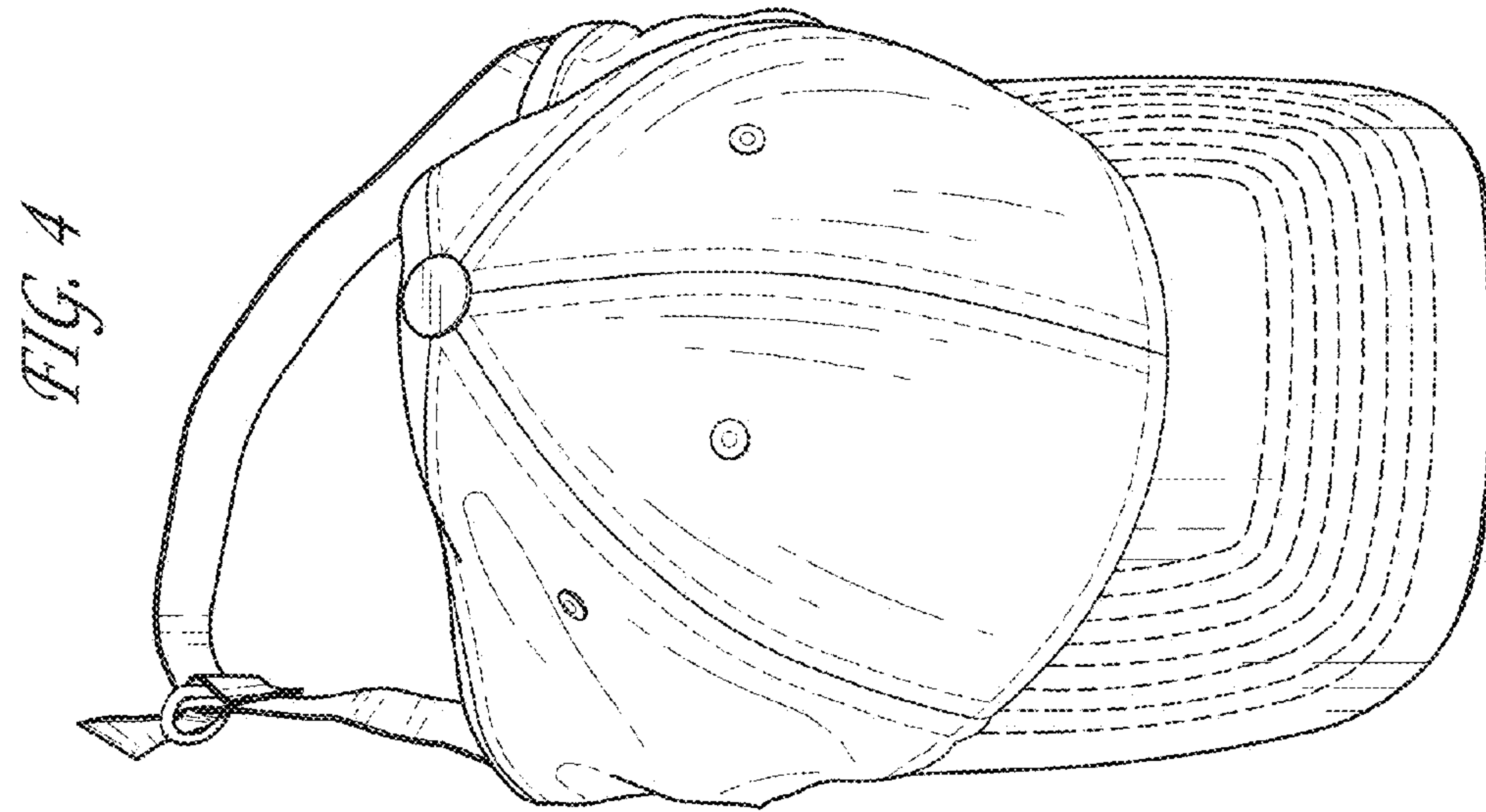

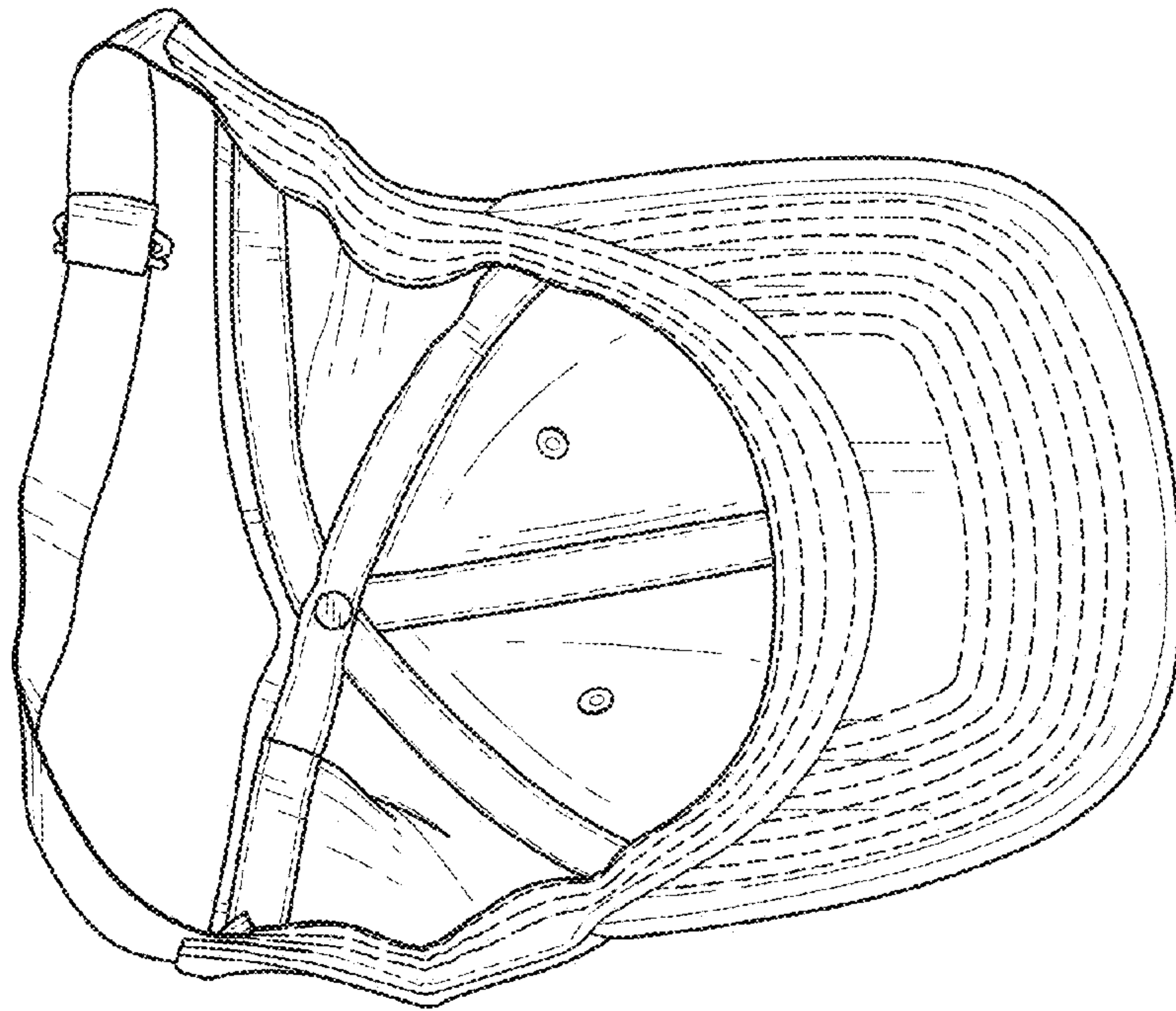

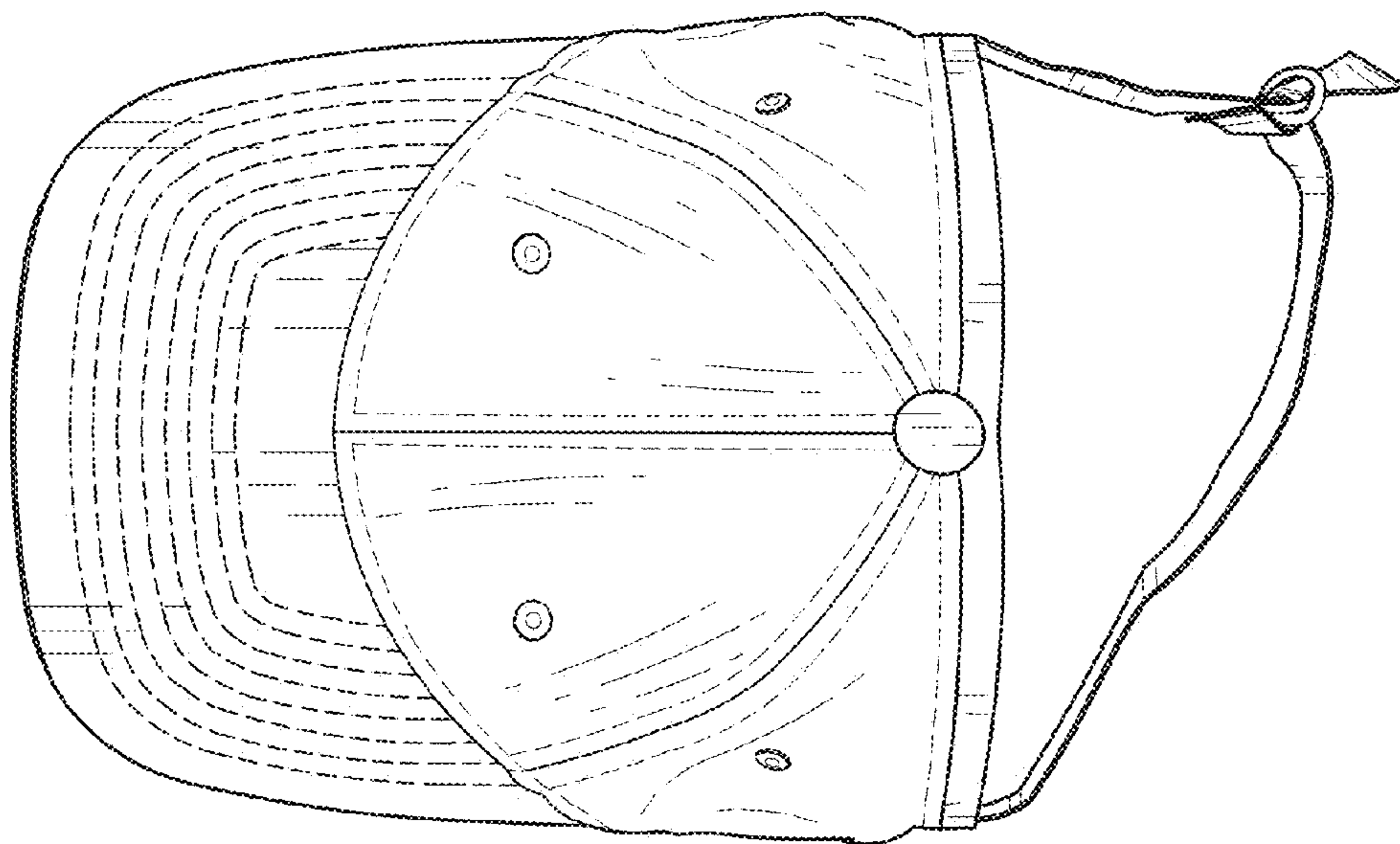
