(57) **CLAIM**

The ornamental design for a shoe outsole, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe outsole showing my new design;

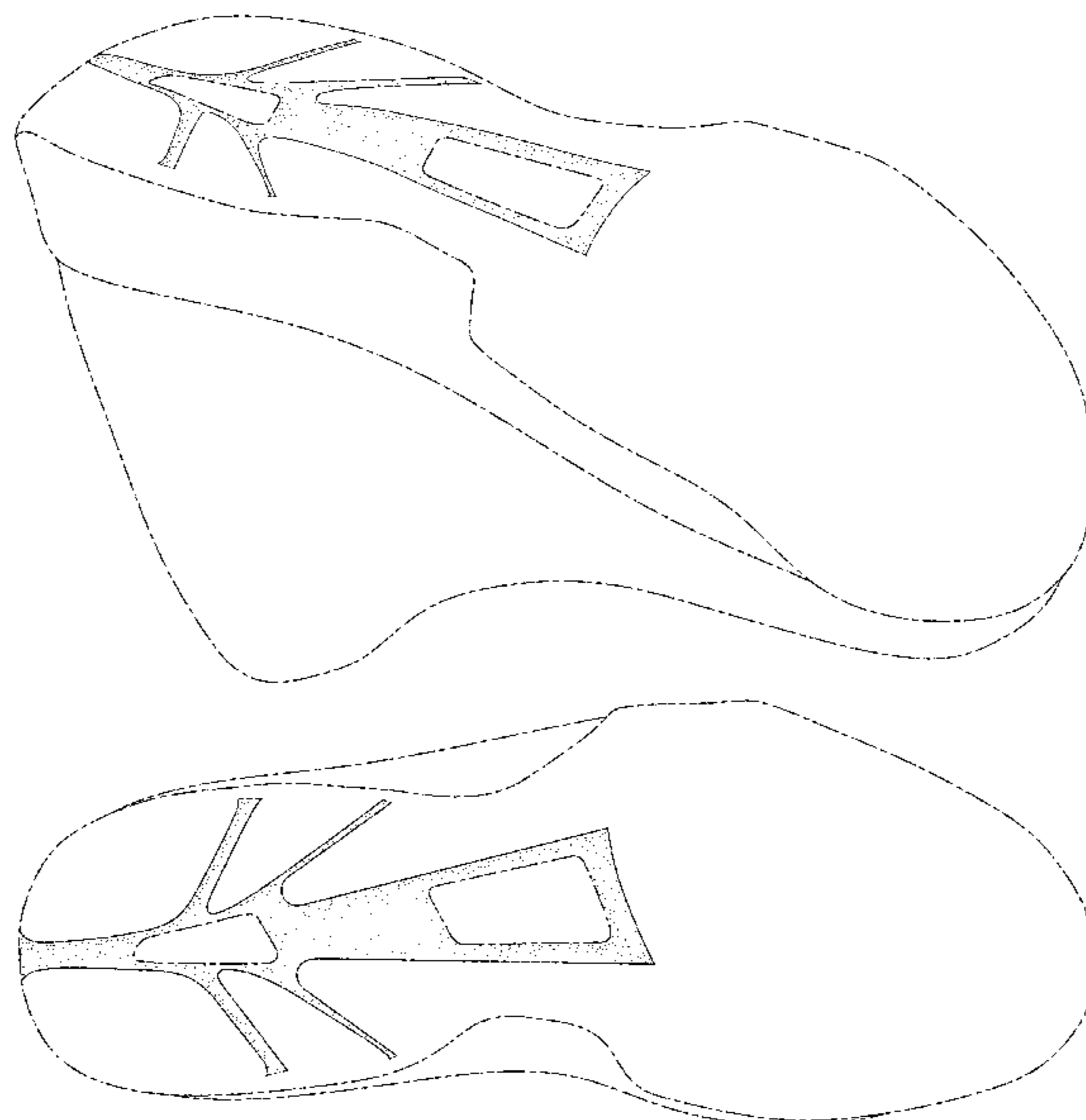
FIG. 2 is a plan view thereof;

FIG. 3 is a rear perspective view thereof; and,

FIG. 4 is an enlarged view of the claimed region in FIG. 2, shown in isolation.

The broken lines immediately adjacent to the shaded area represent unclaimed boundaries of the design. The two unshaded regions bordered by broken lines within the shaded region form no part of the claimed design. The broken lines showing the remainder of the shoe are for environmental purposes only and form no part of the claimed design.

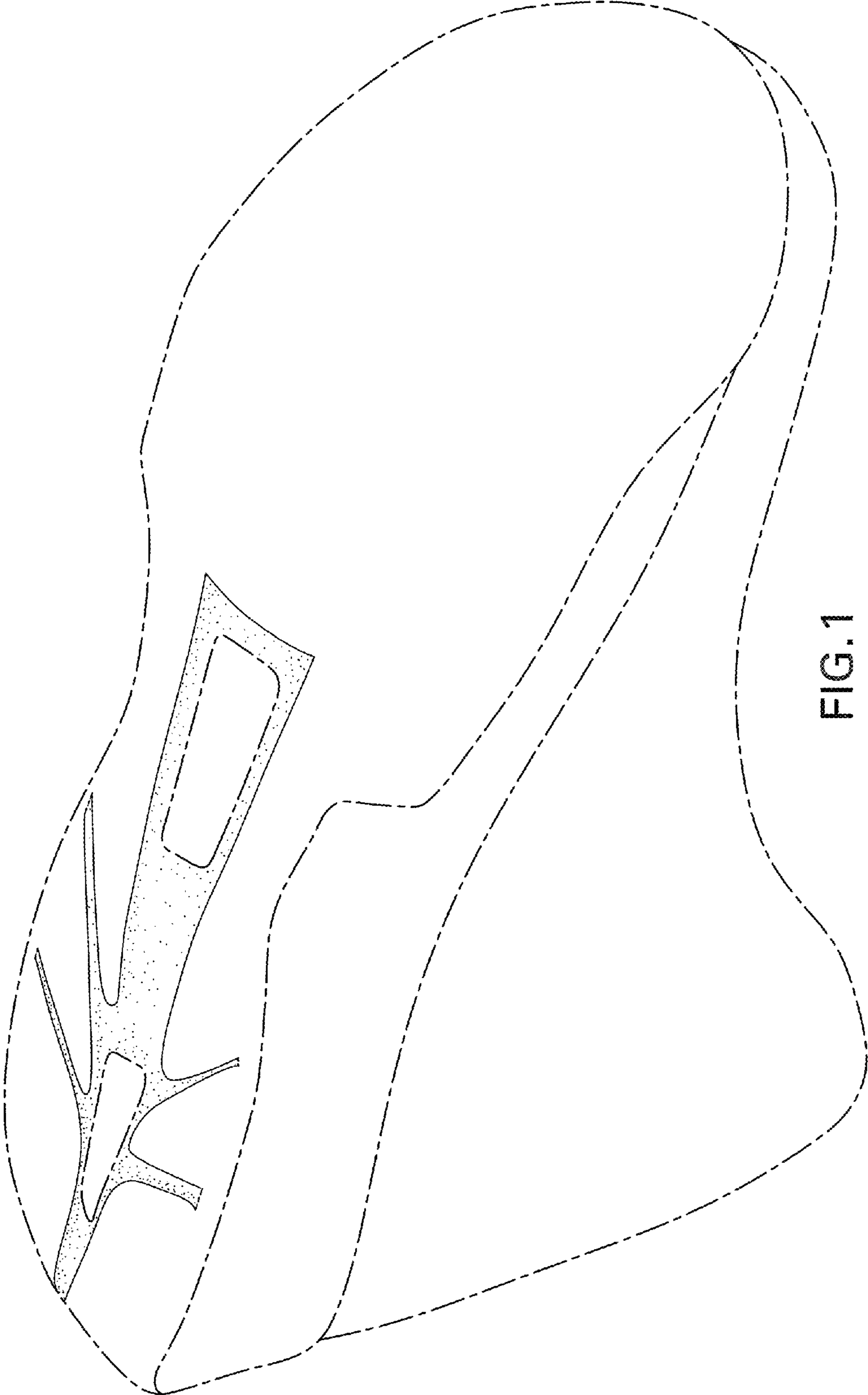

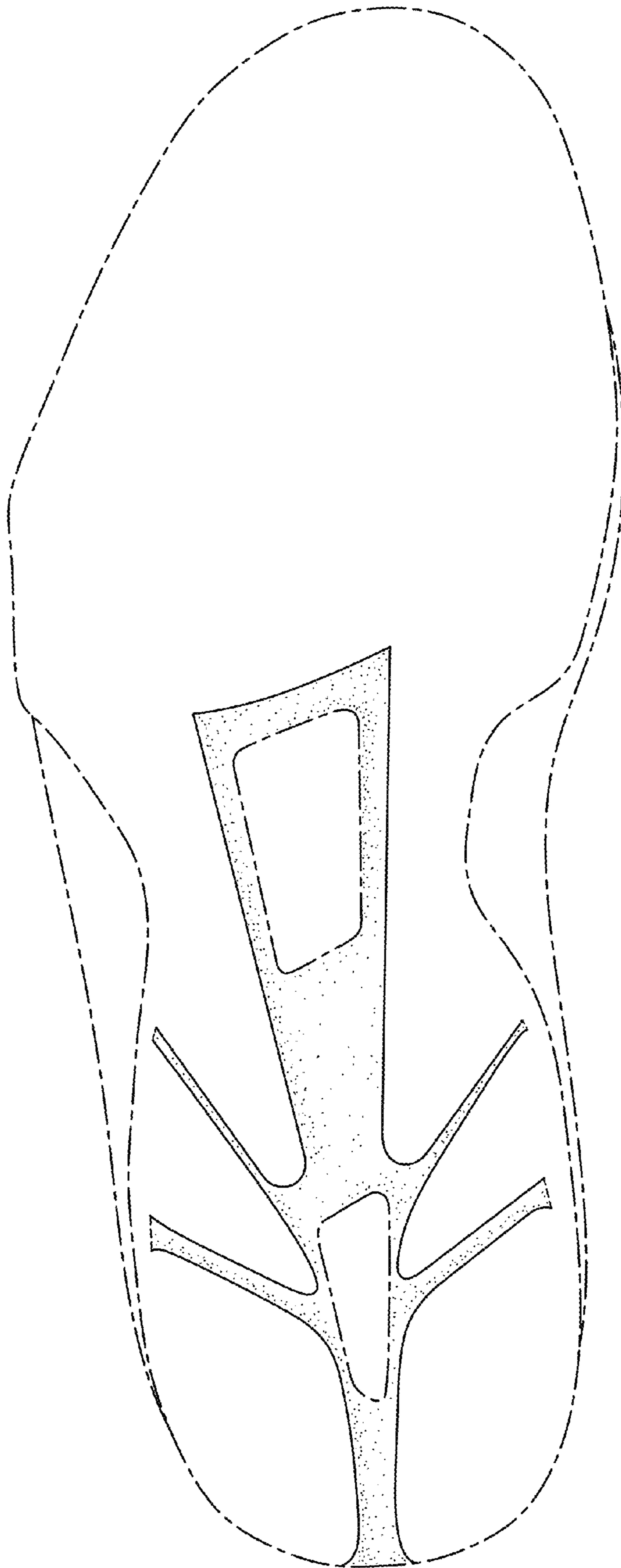

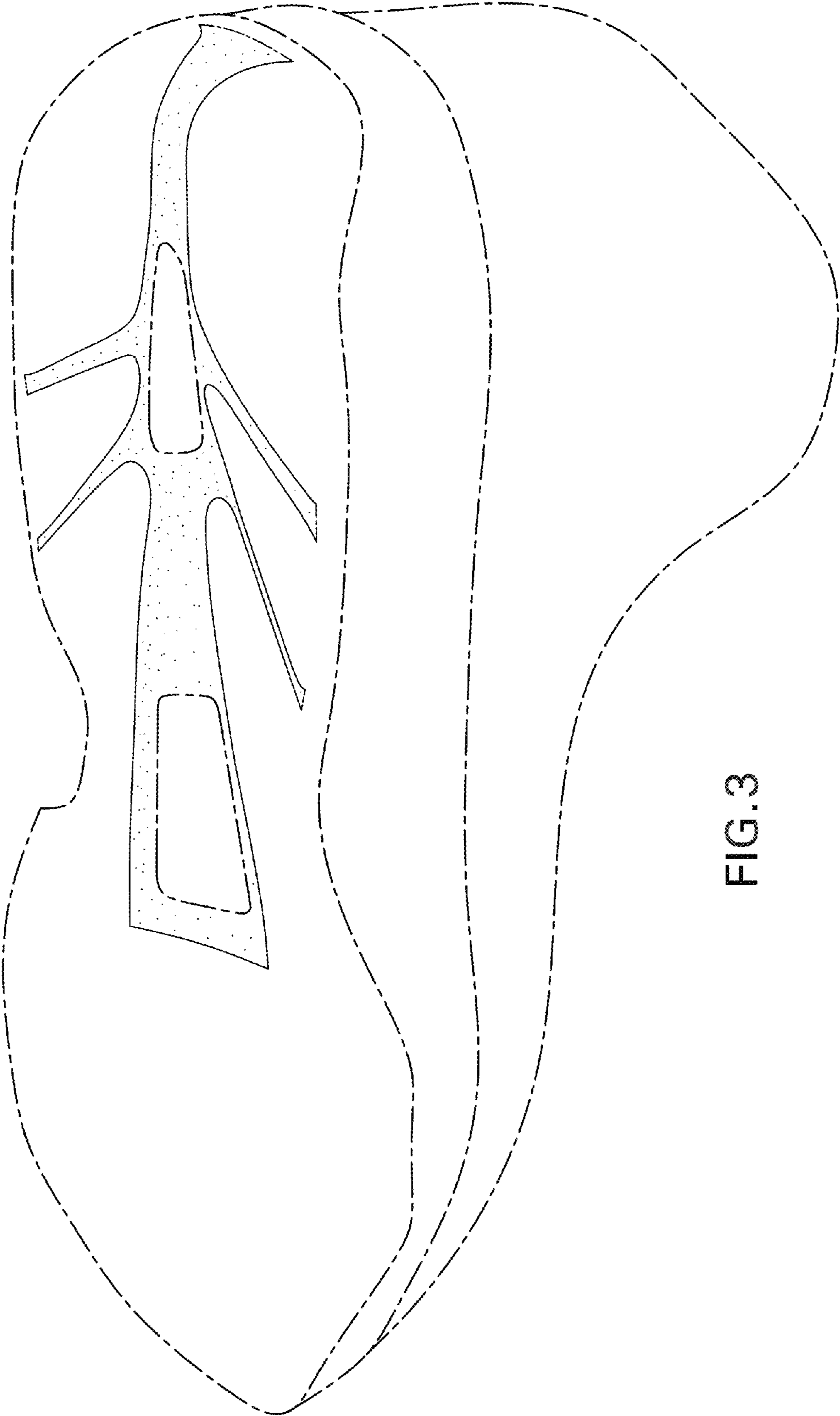

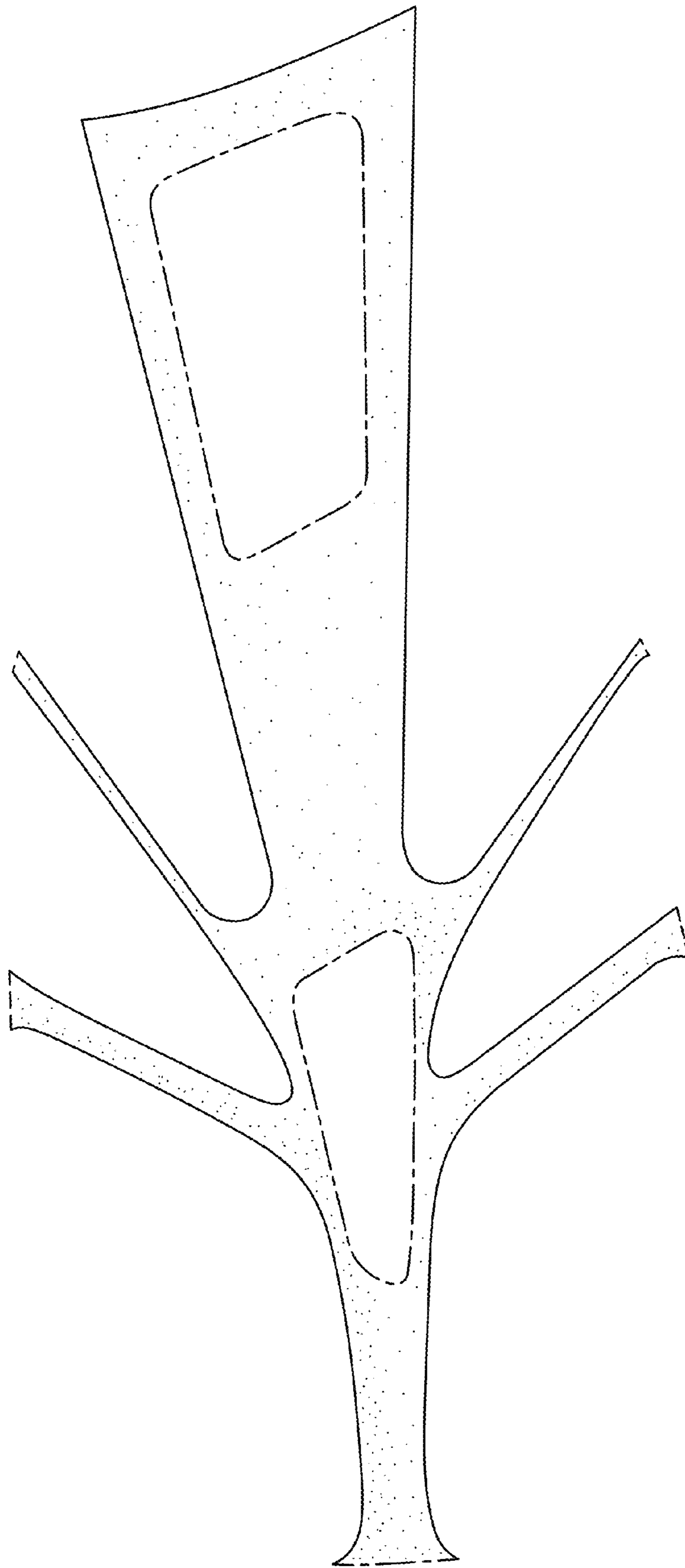
