DESCRIPTION

FIG. 1 is a front, side and top perspective view of the combined tennis racket and gear carry bag;

FIG. 2 is a front view of the combined tennis racket and gear carry bag;

FIG. 3 is a rear view of the combined tennis racket and gear carry bag;

FIG. 4 is a side elevation view of the combined tennis racket and gear carry bag;

FIG. 5 is a side elevation view of the opposite side of the combined tennis racket and gear carry bag;

FIG. 6 is a top plan view of the combined tennis racket and gear carry bag; and,

FIG. 7 is a bottom view combined tennis racket and gear carry bag.

The dashed lines in the drawings represent stitching and do form part of the claimed design.

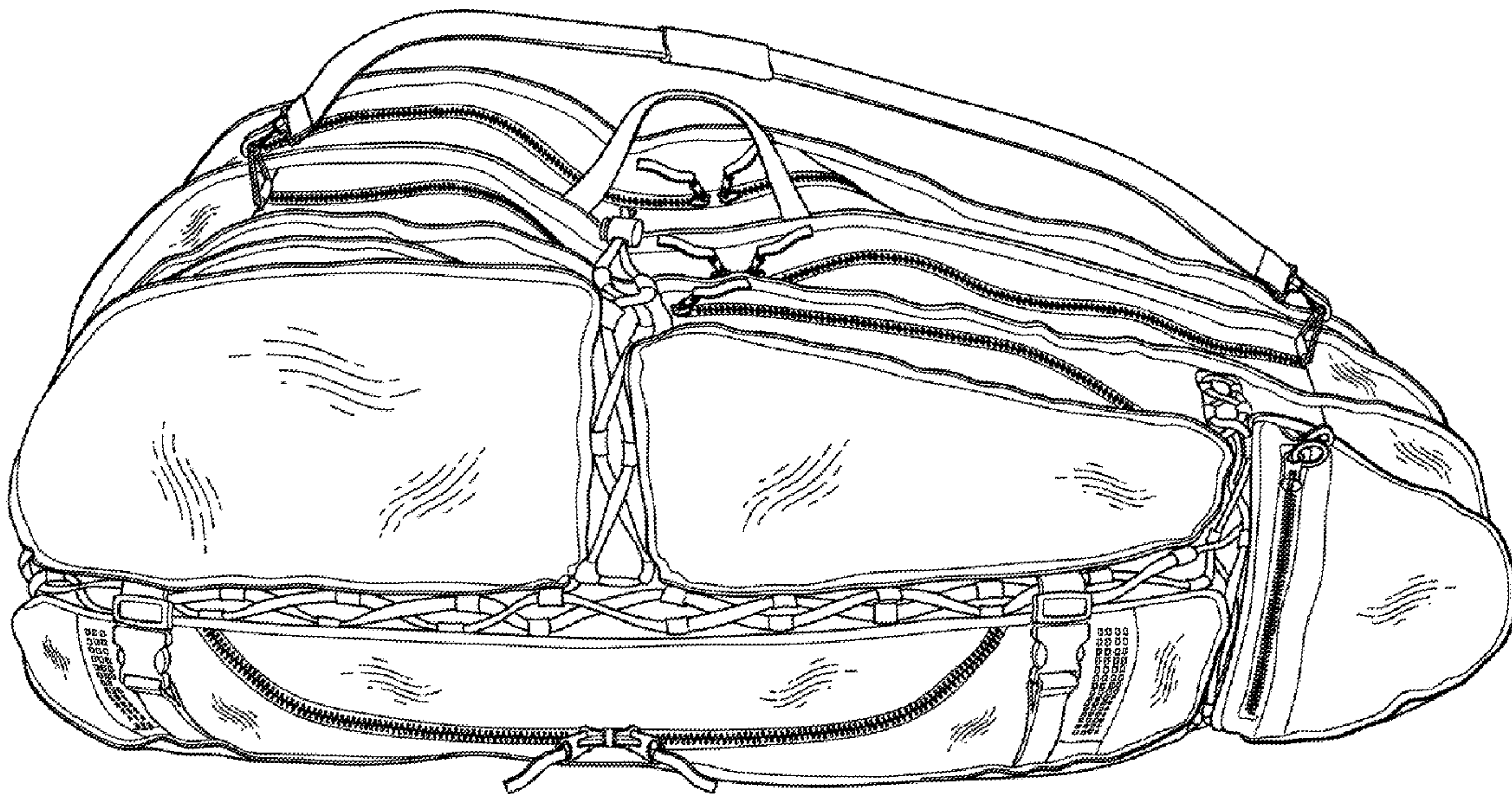

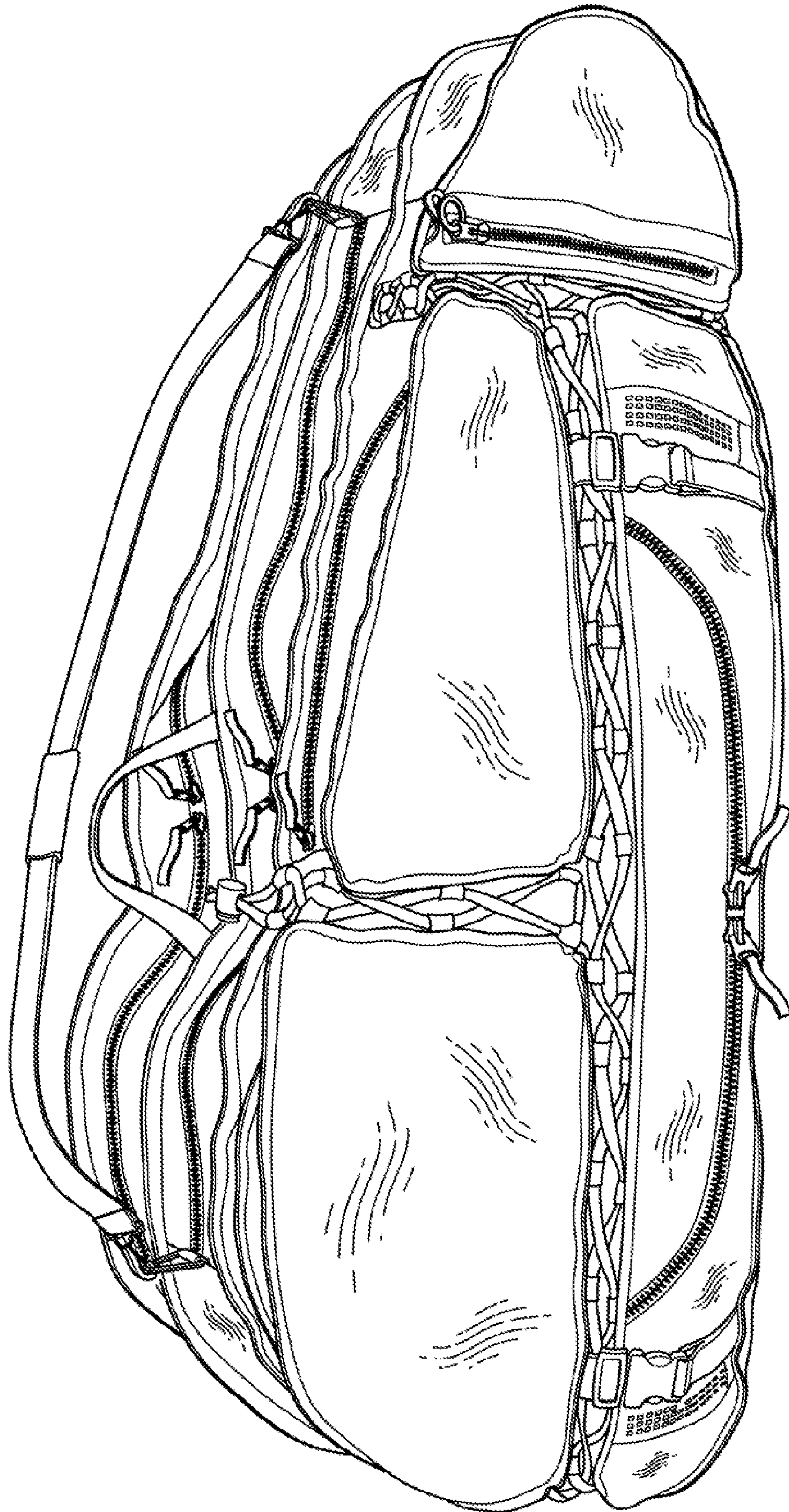

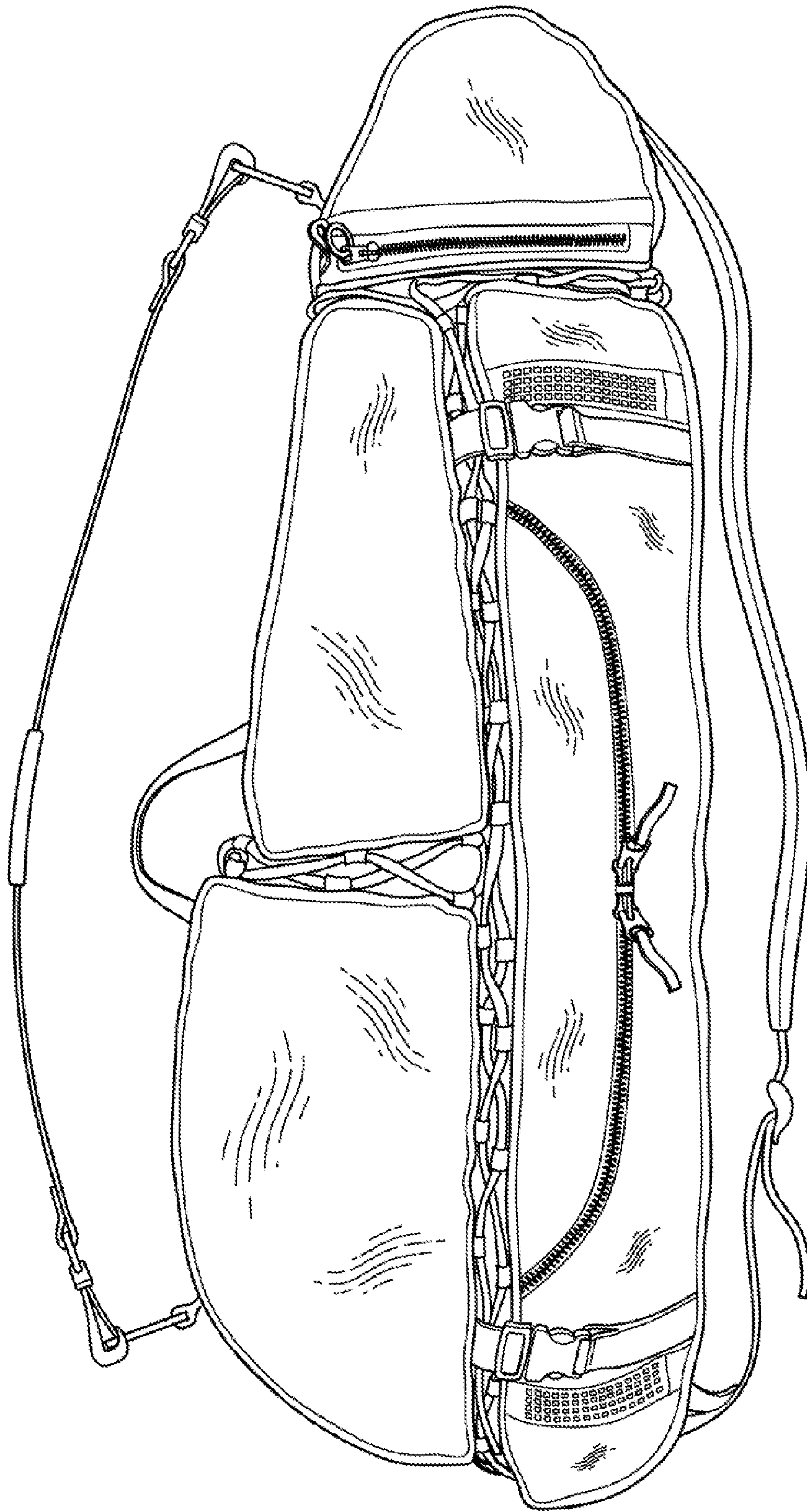

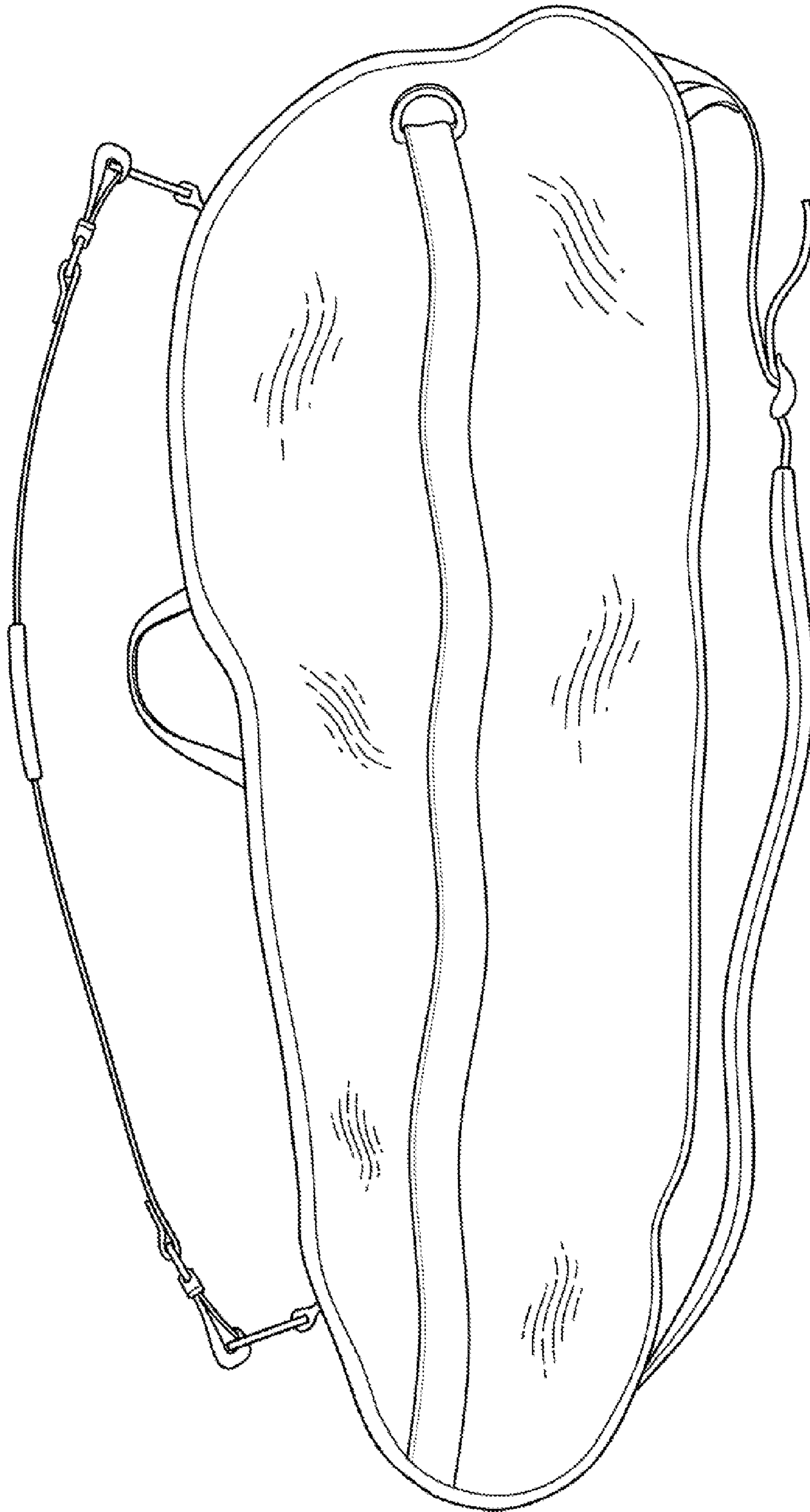

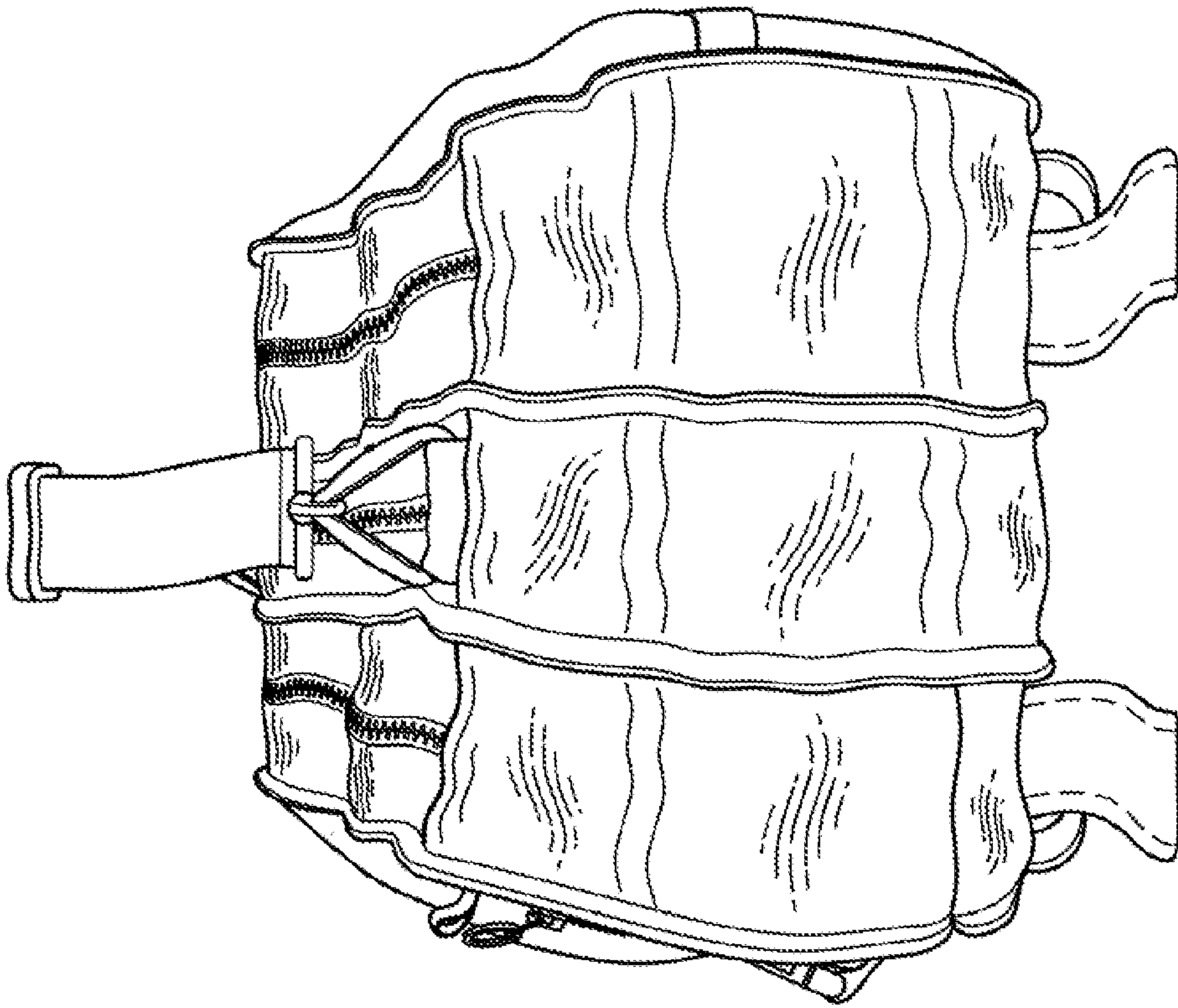

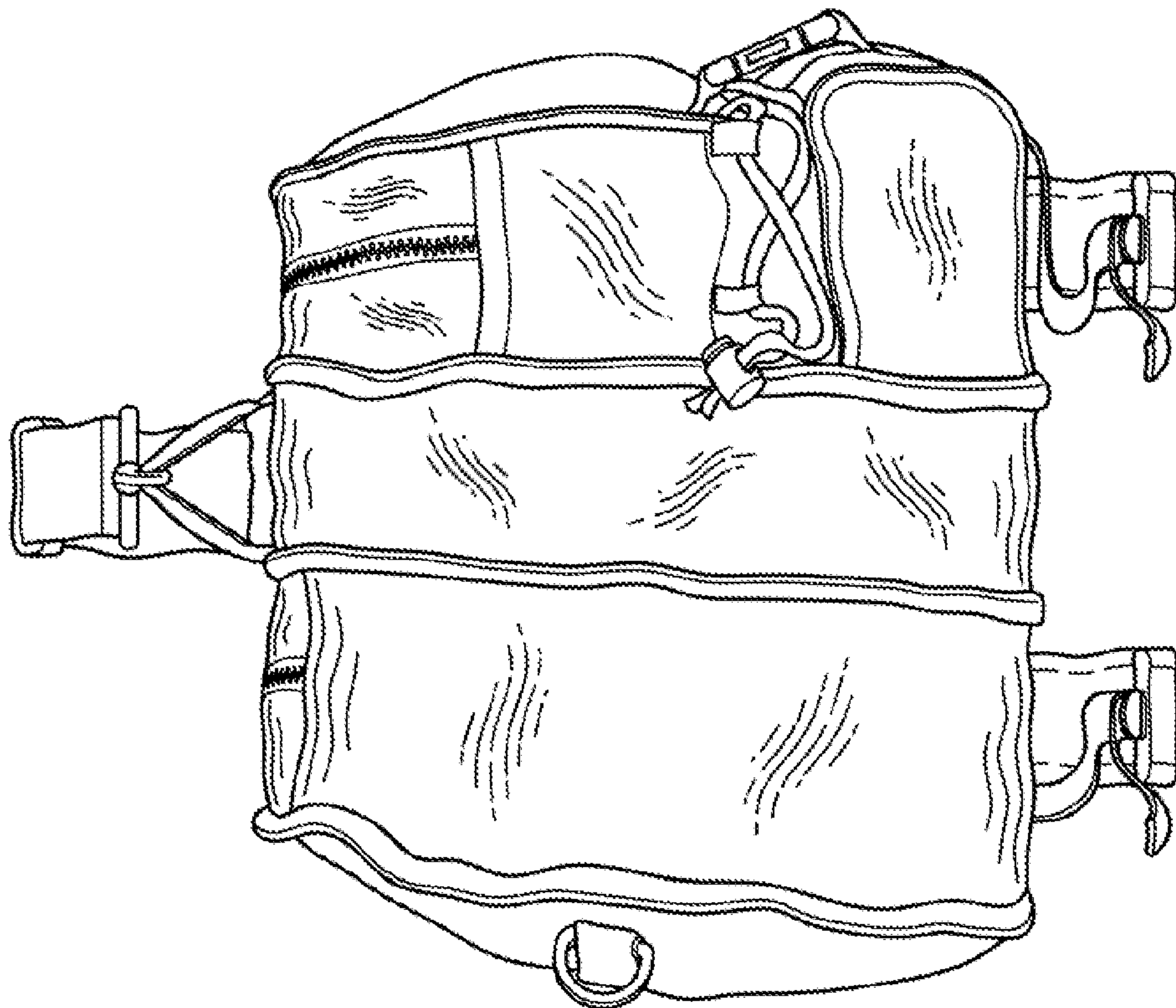

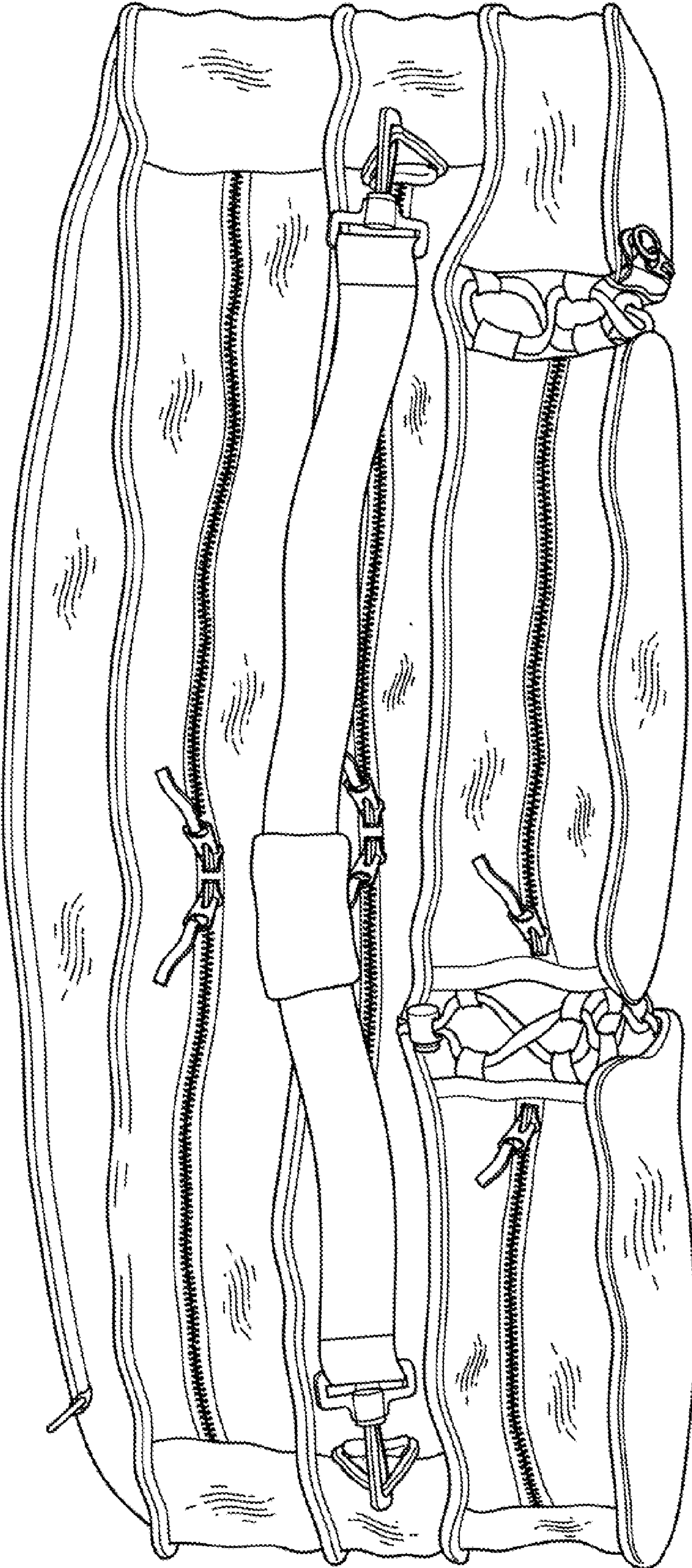

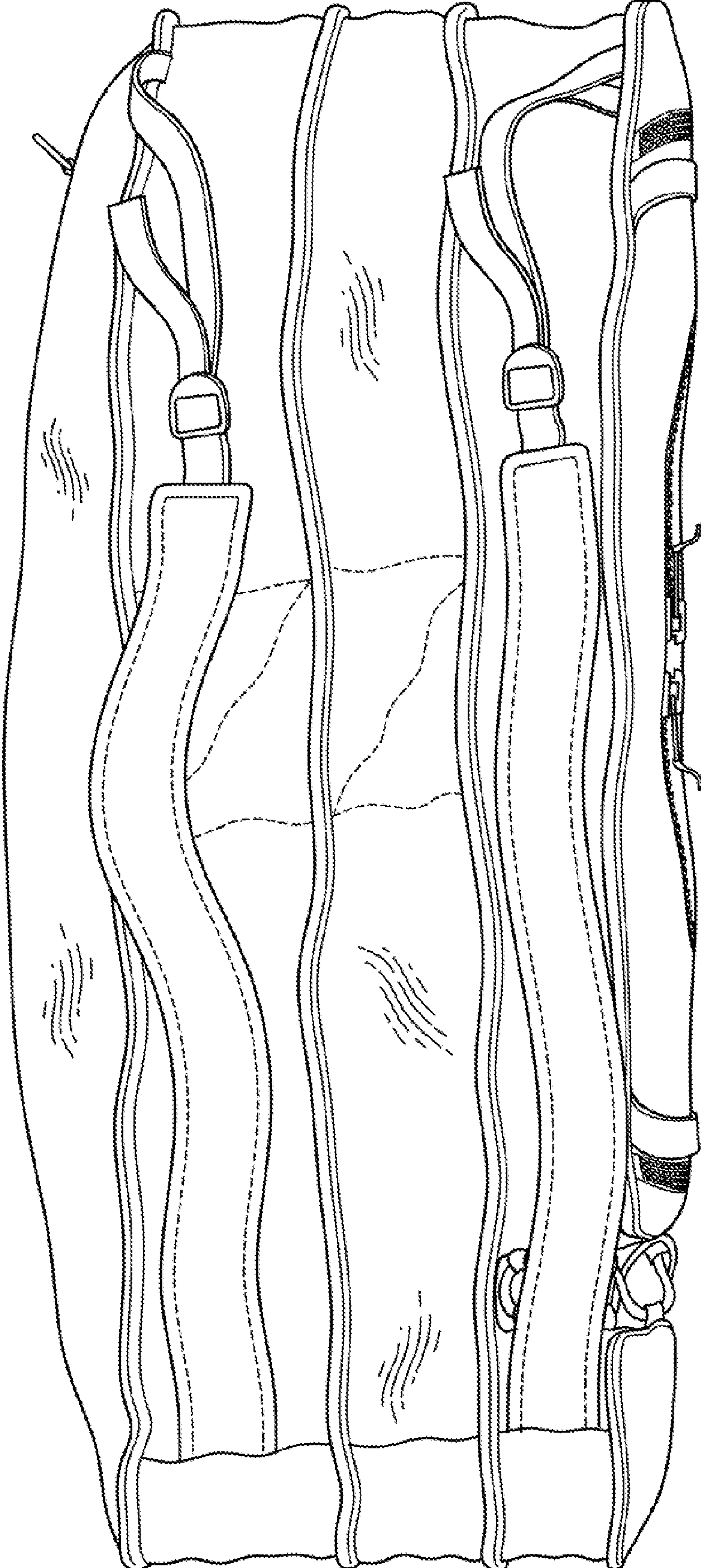
