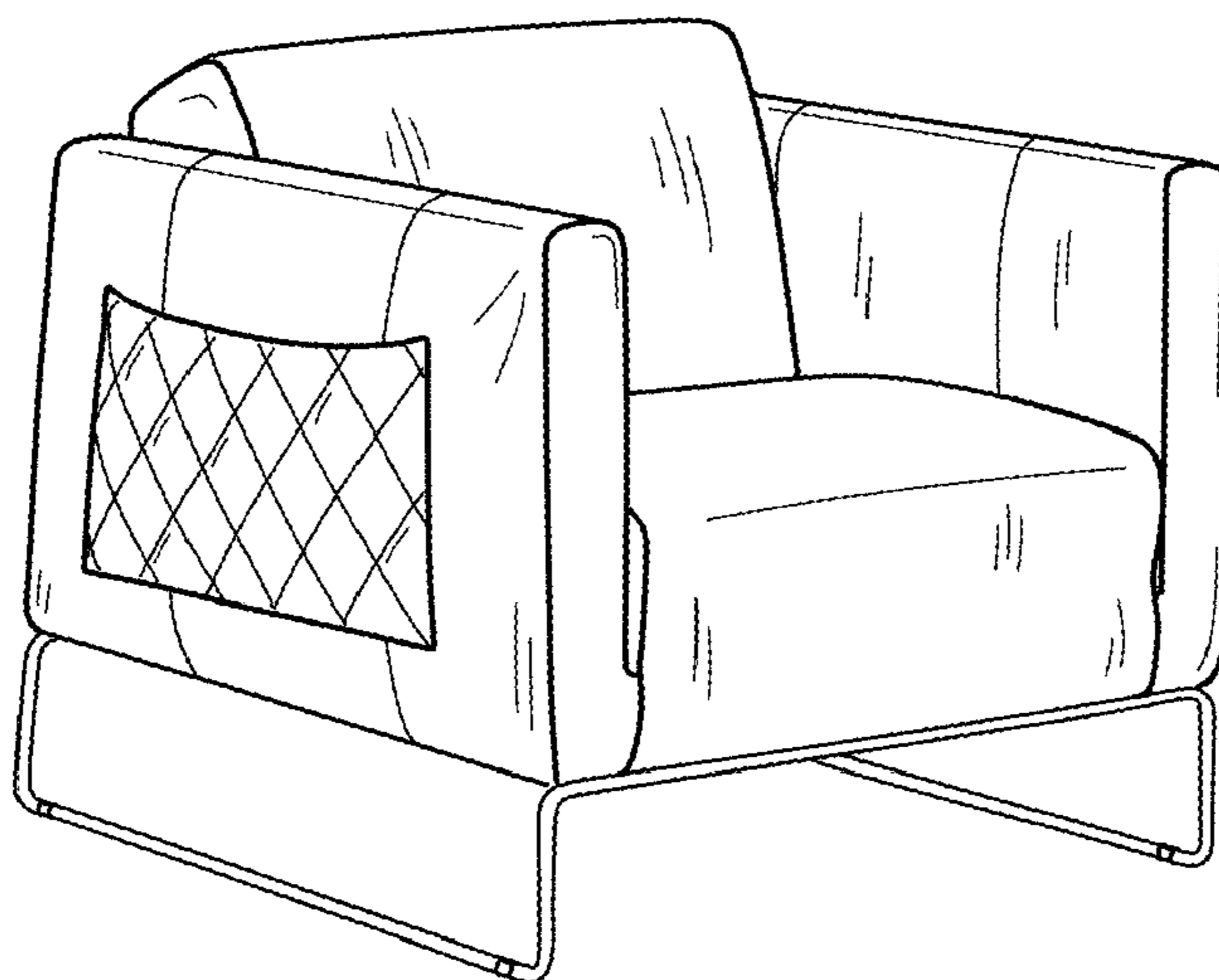

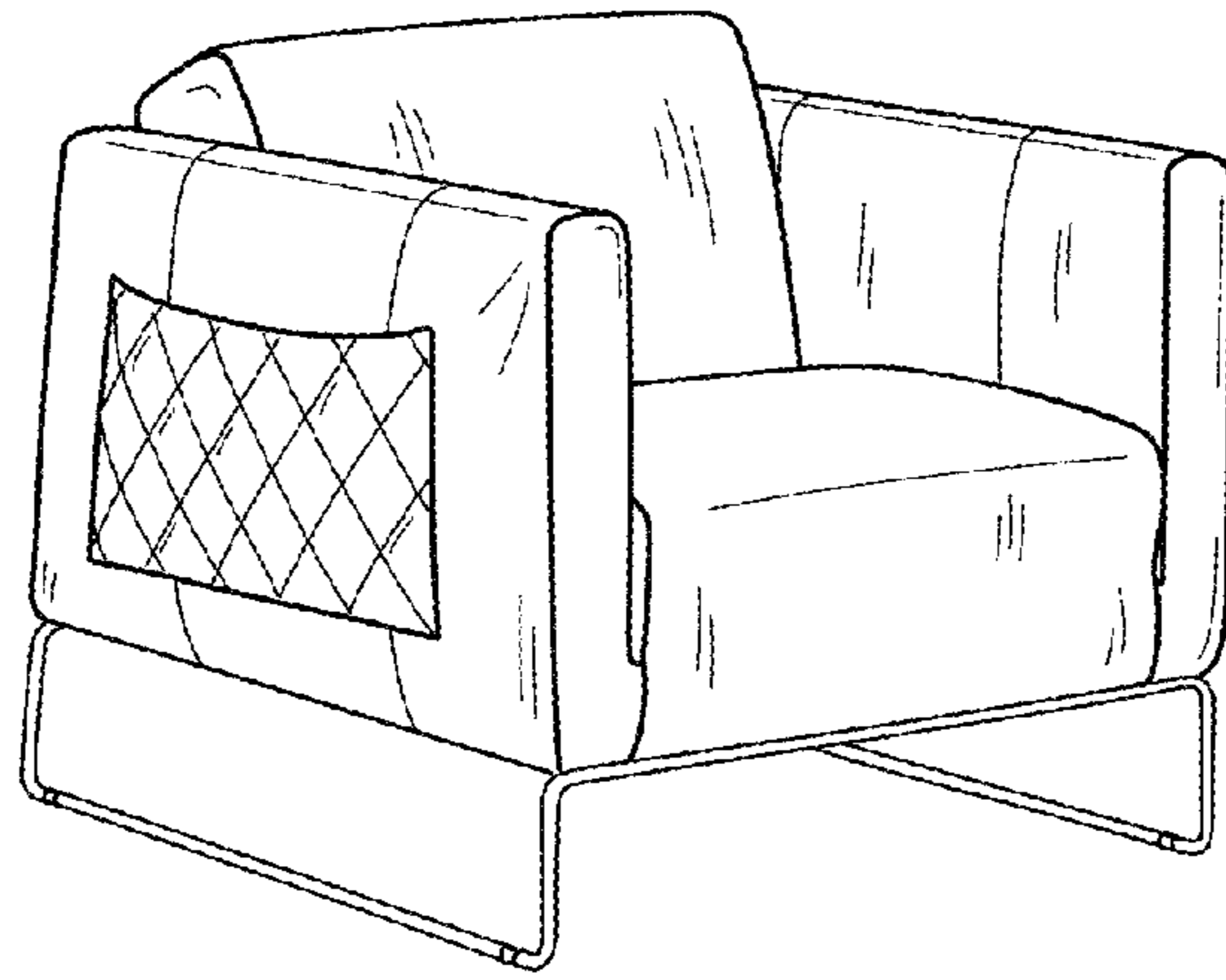
The ornamental design for a chair, as shown and described.

**DESCRIPTION**

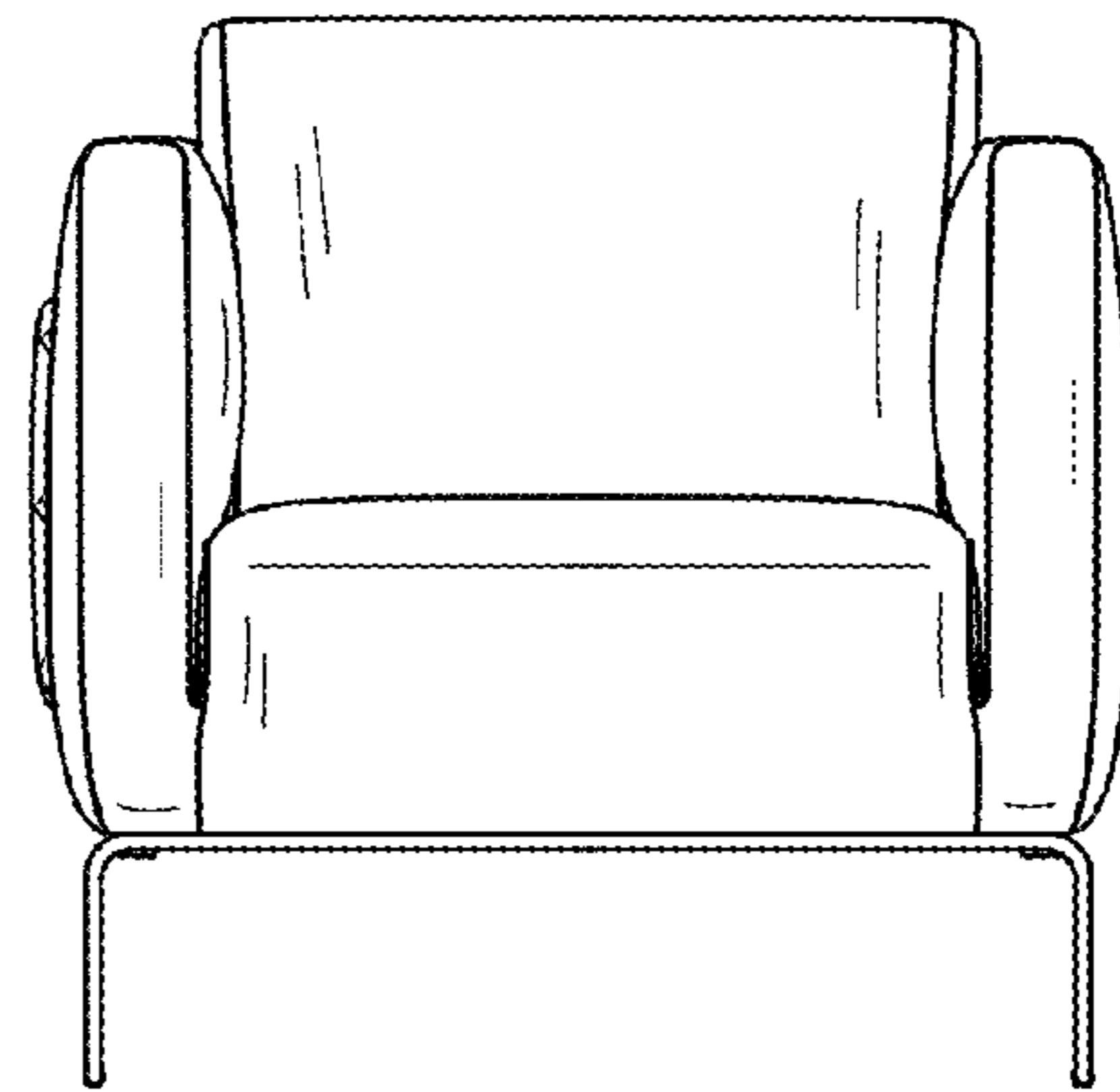
FIG. 1 shows a perspective view of the chair;

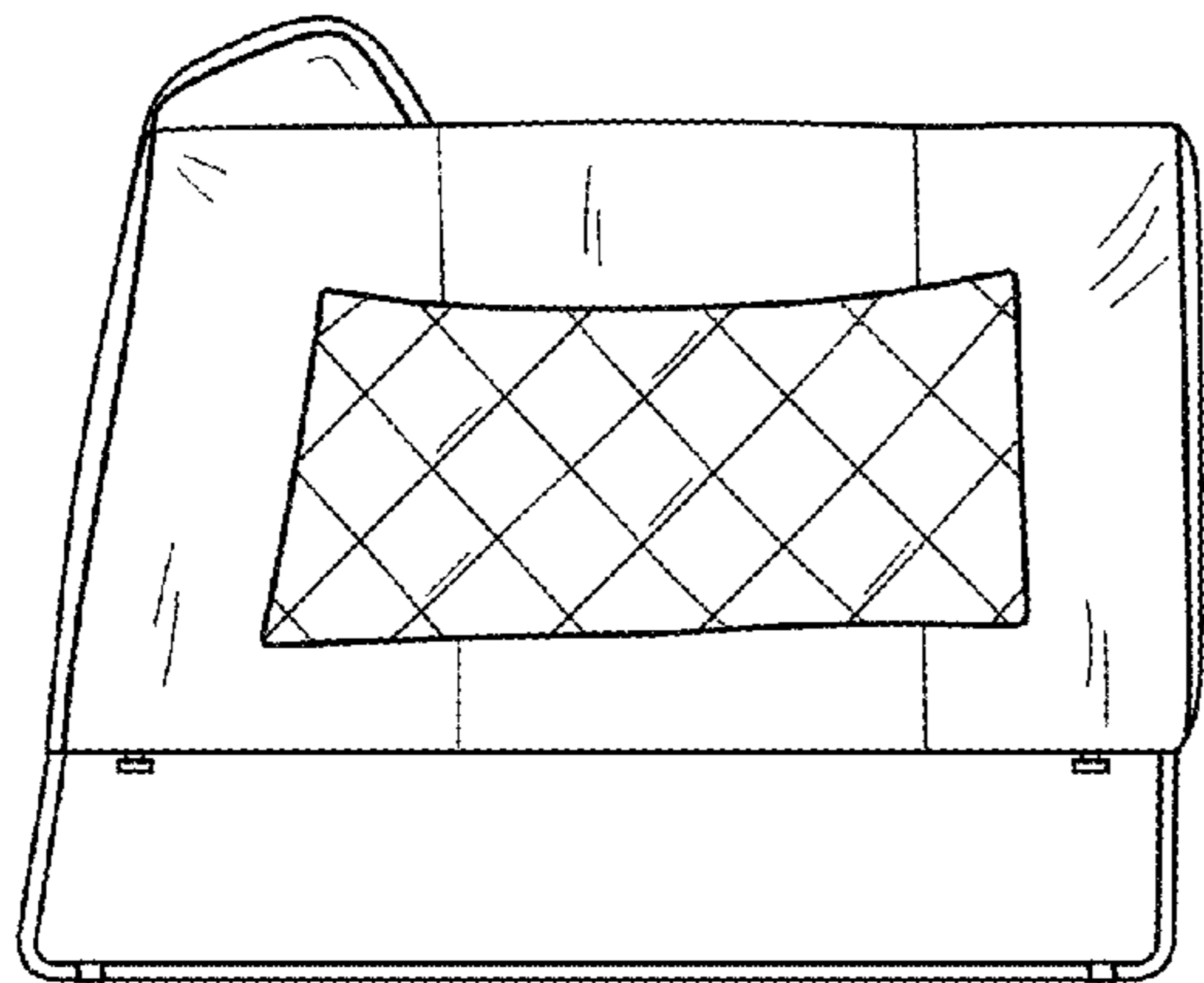




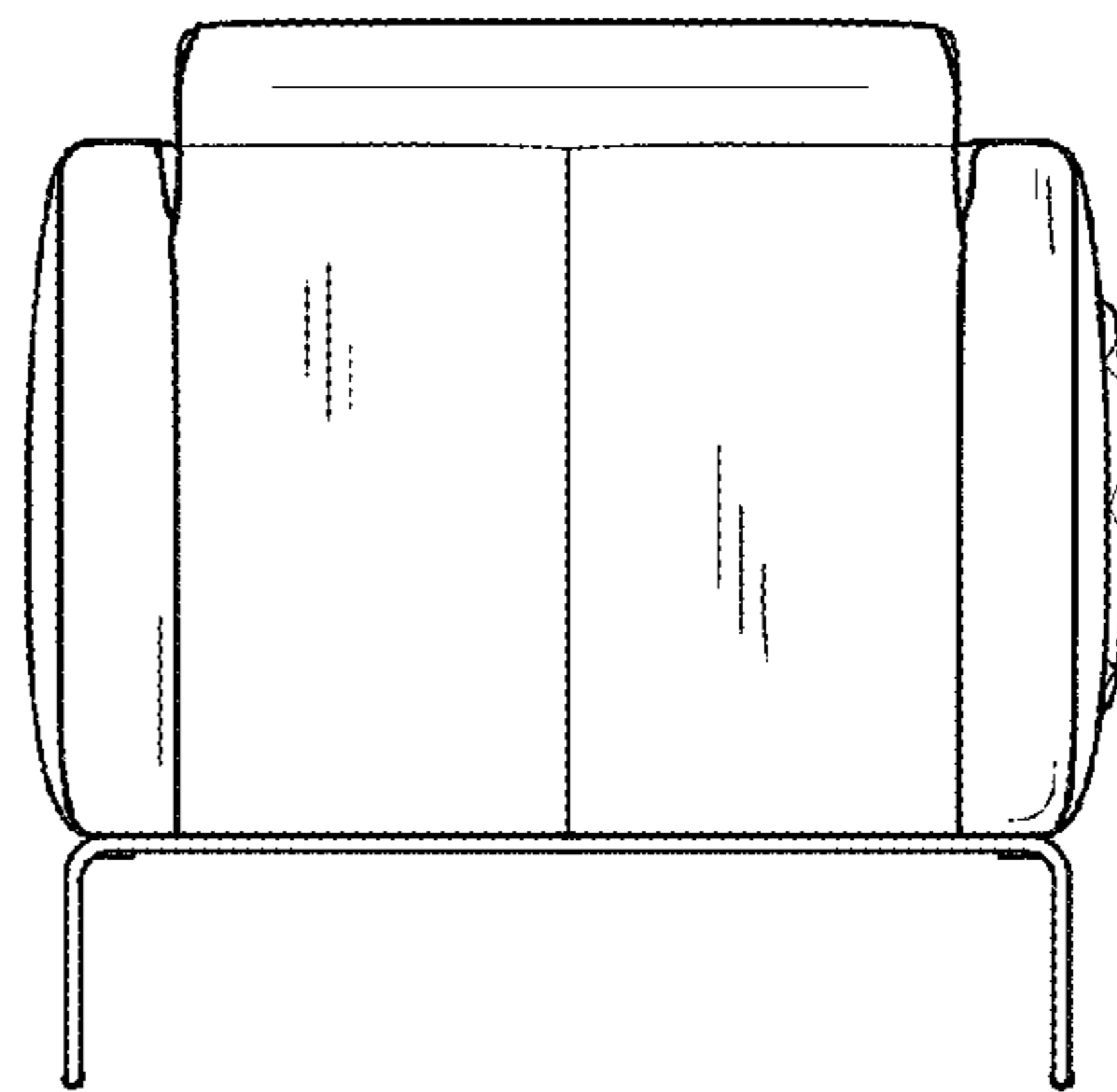

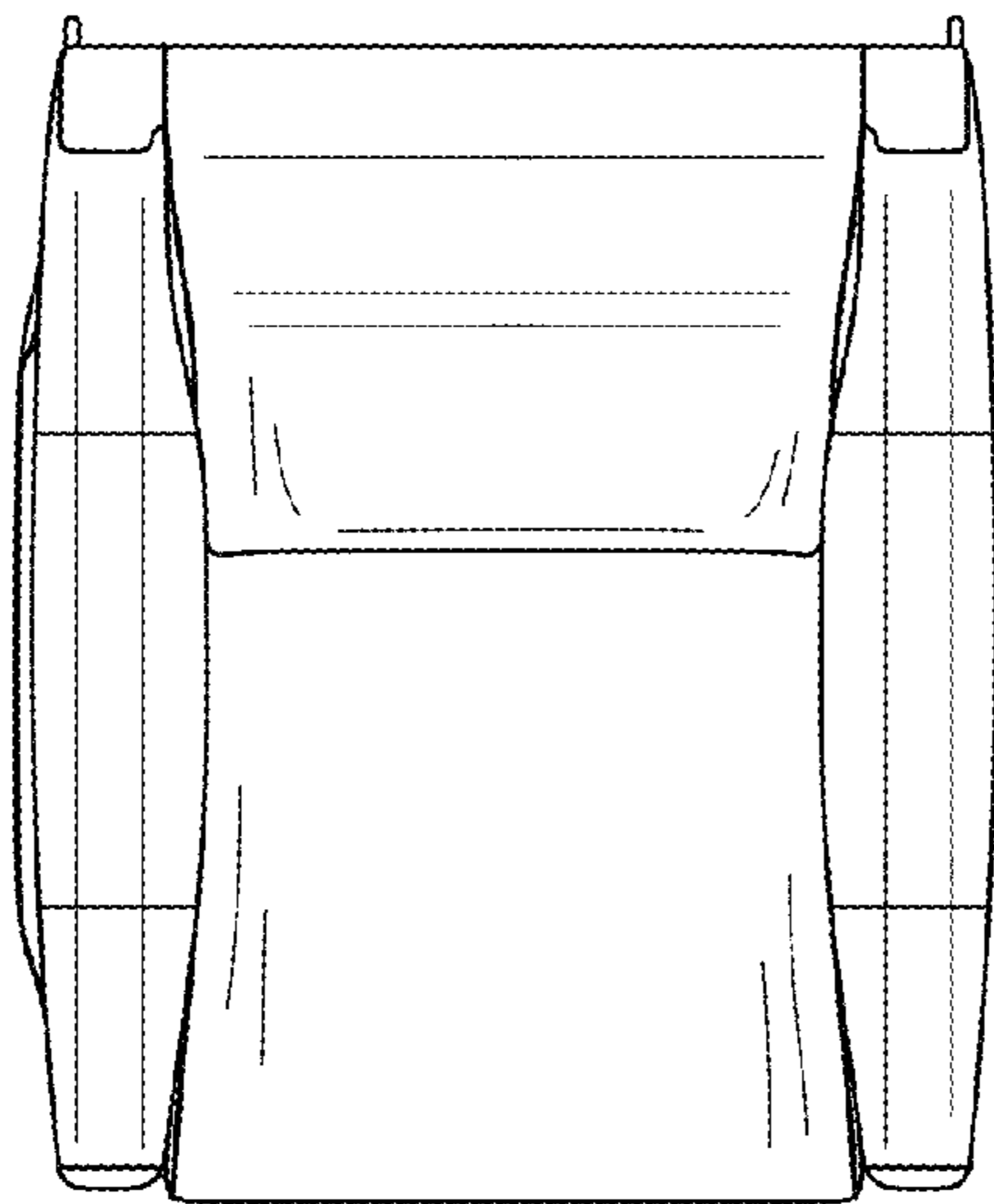
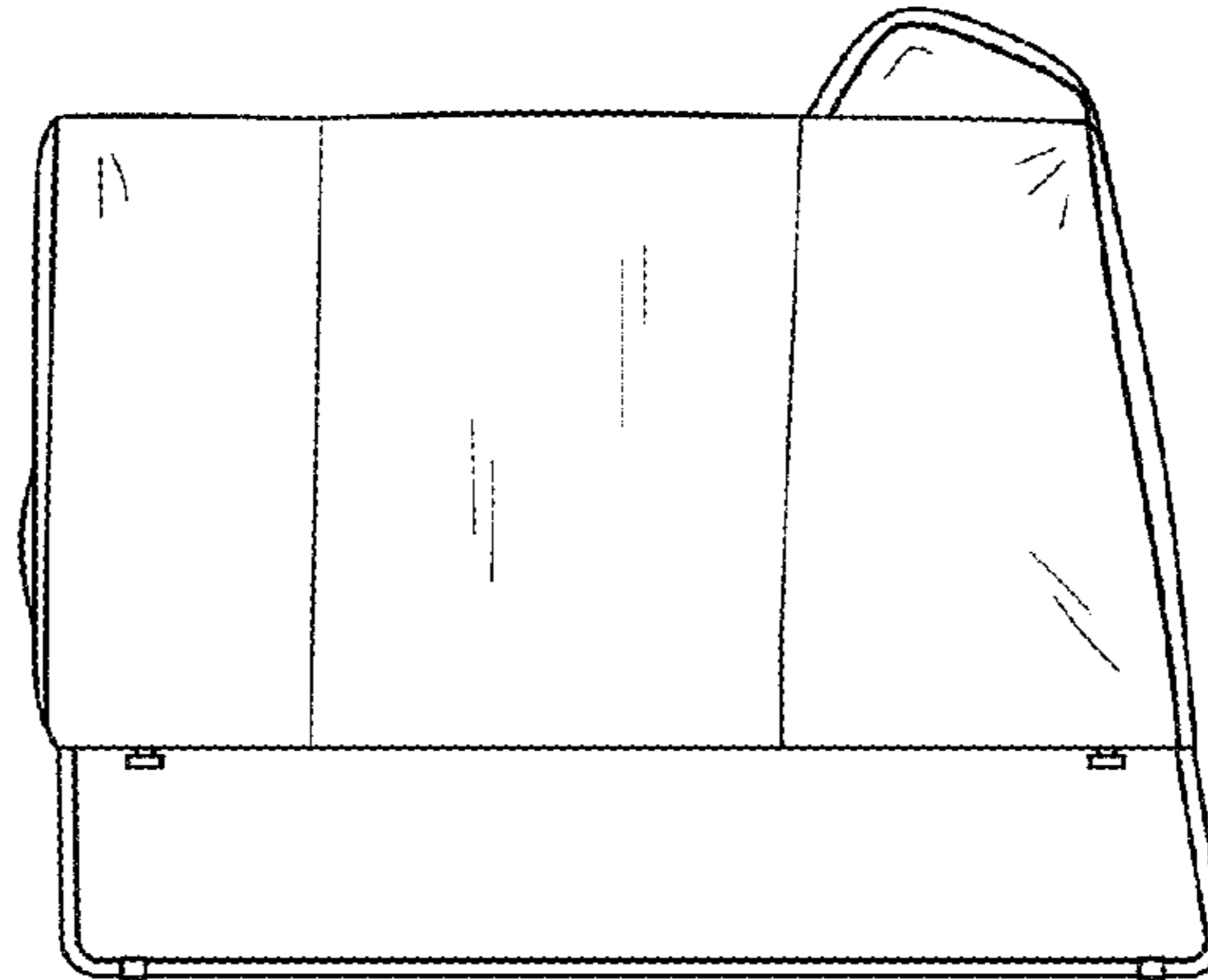
