(57) **CLAIM**

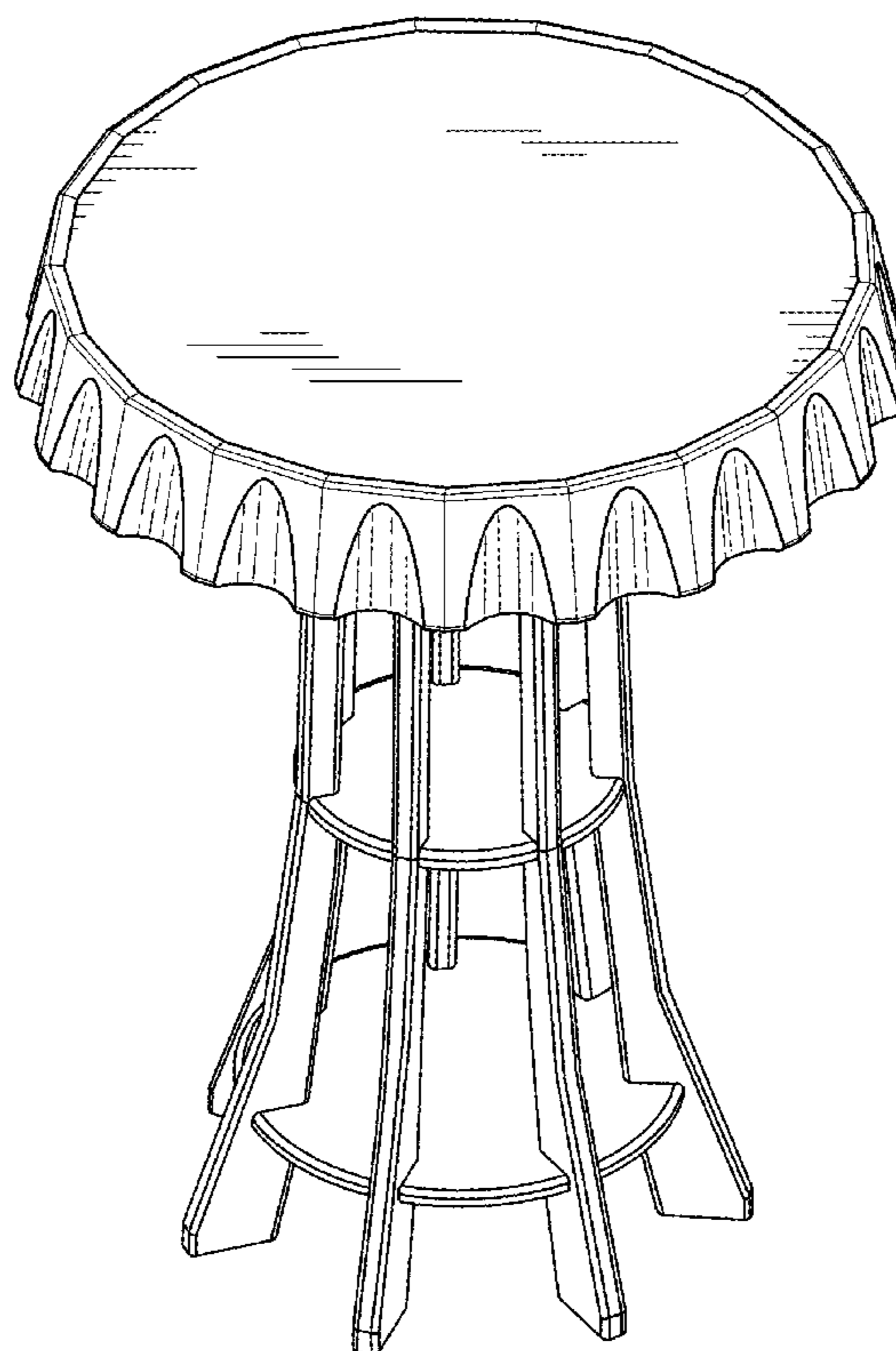
I claim the ornamental design for a bottle cap shaped table, as shown and described.

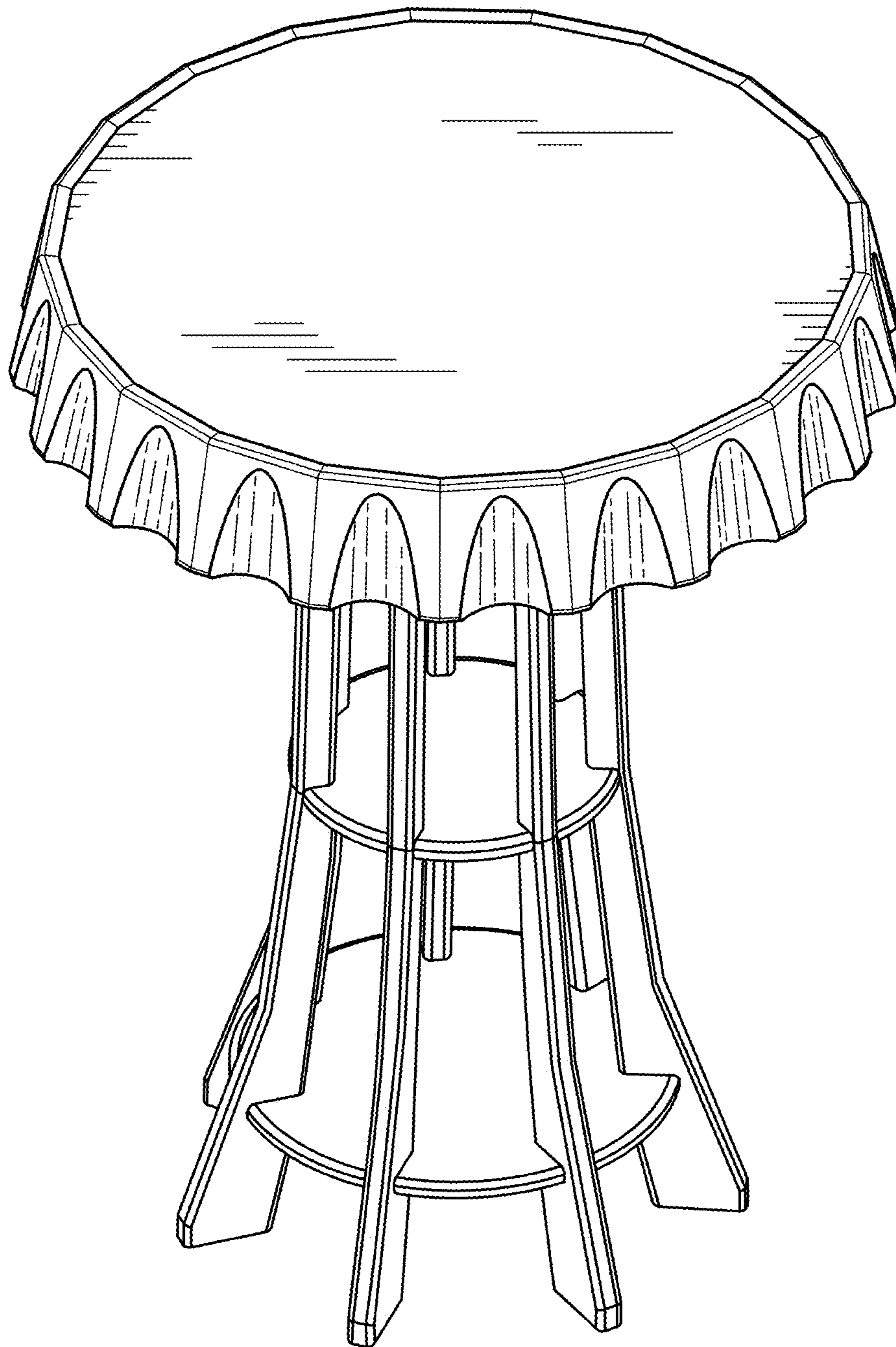
**DESCRIPTION**

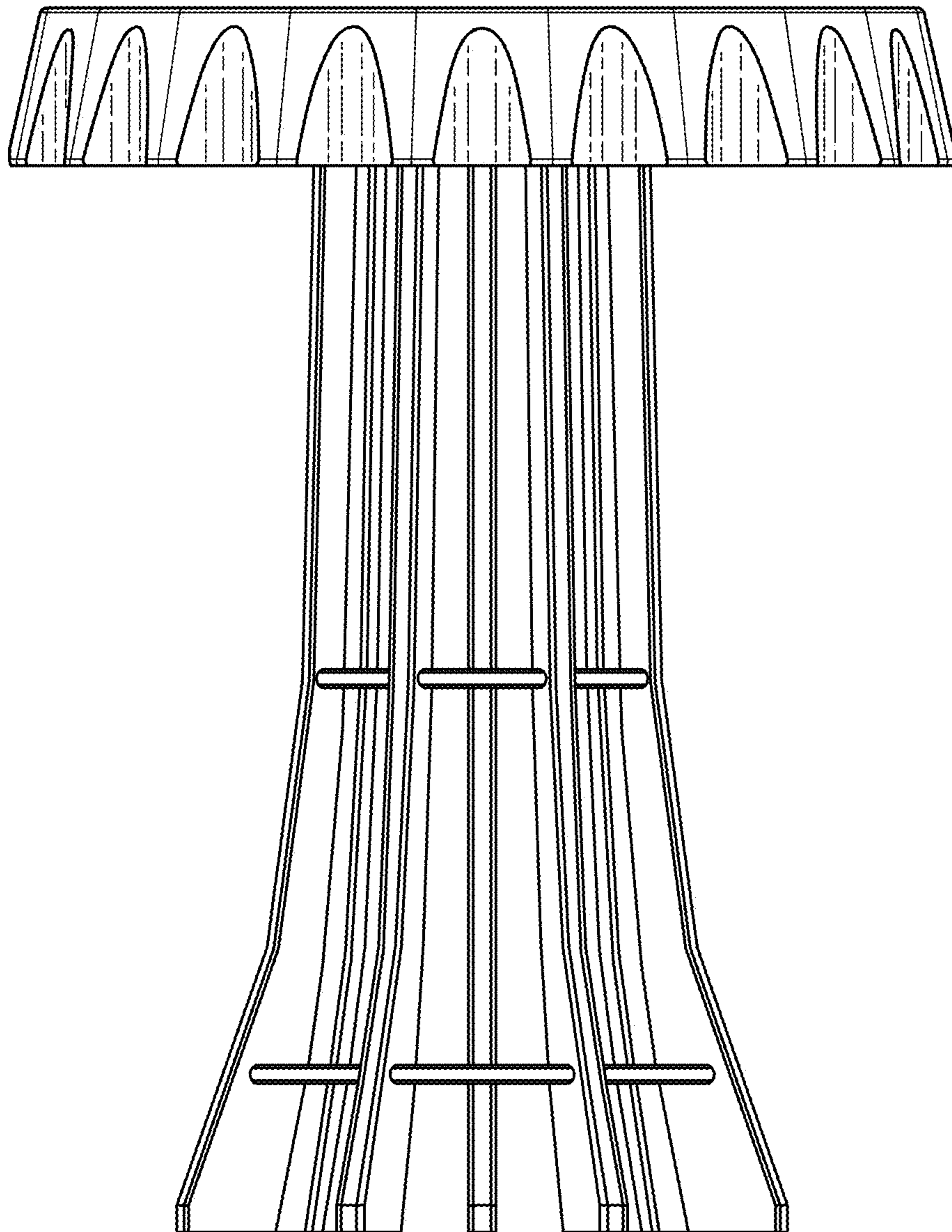
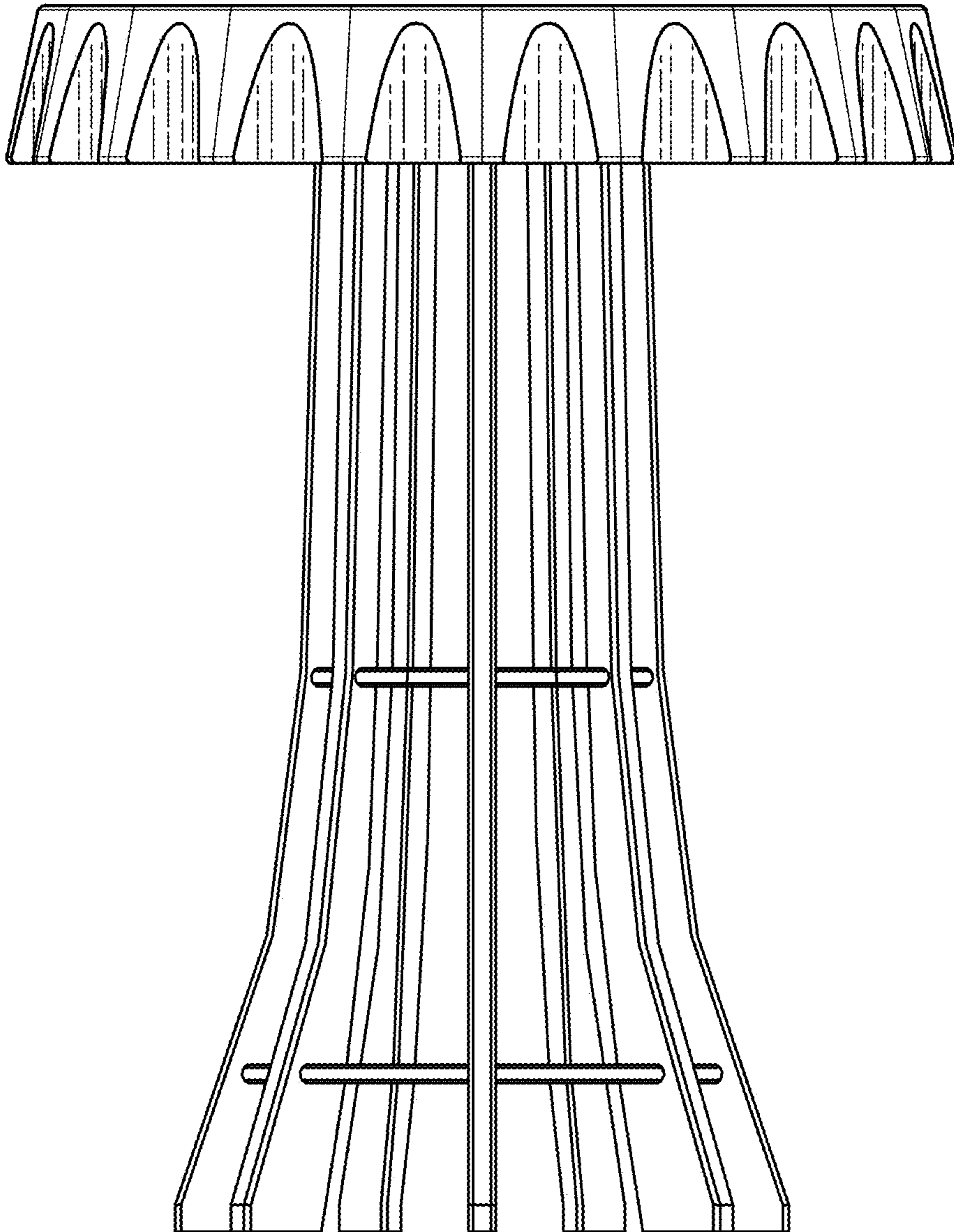

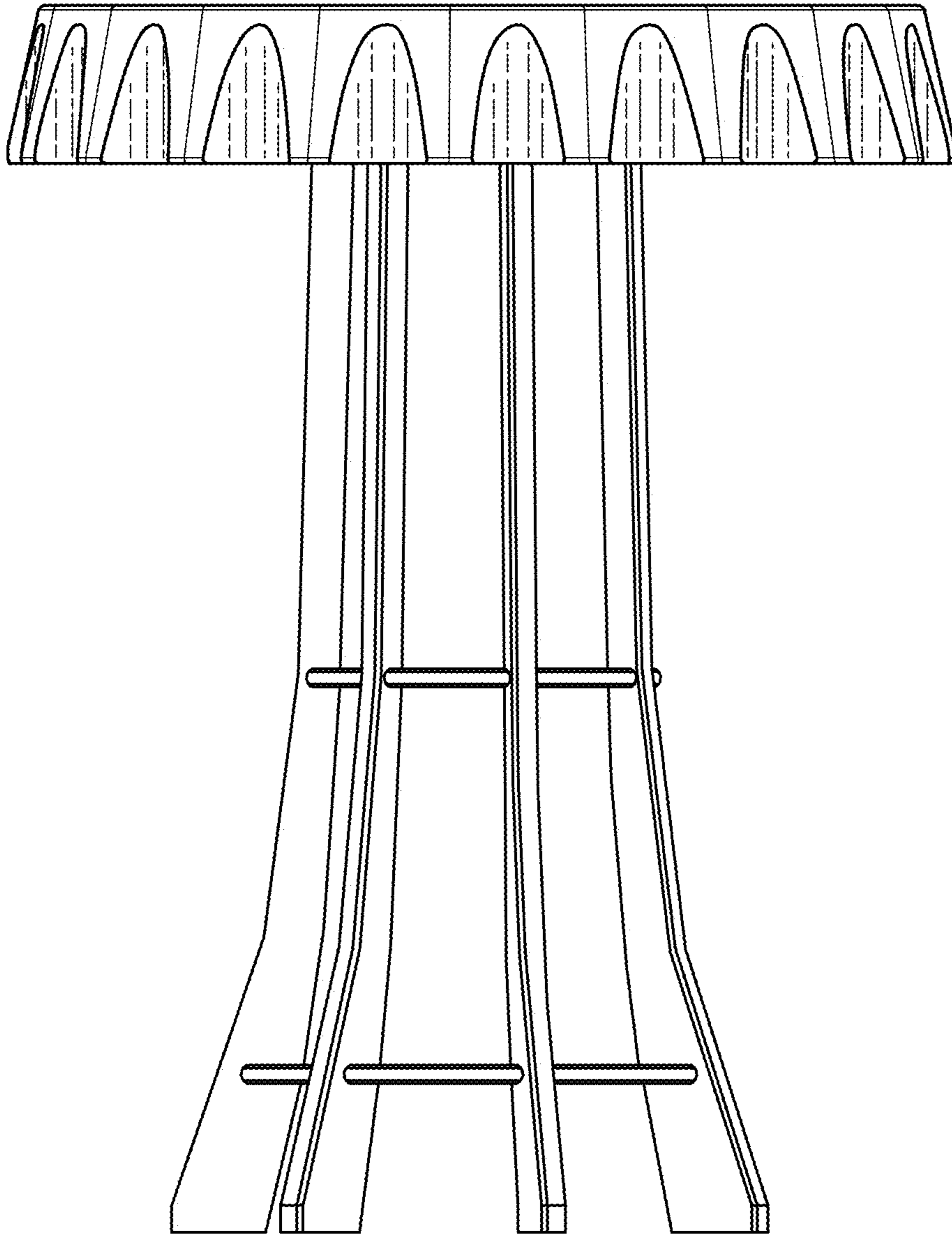
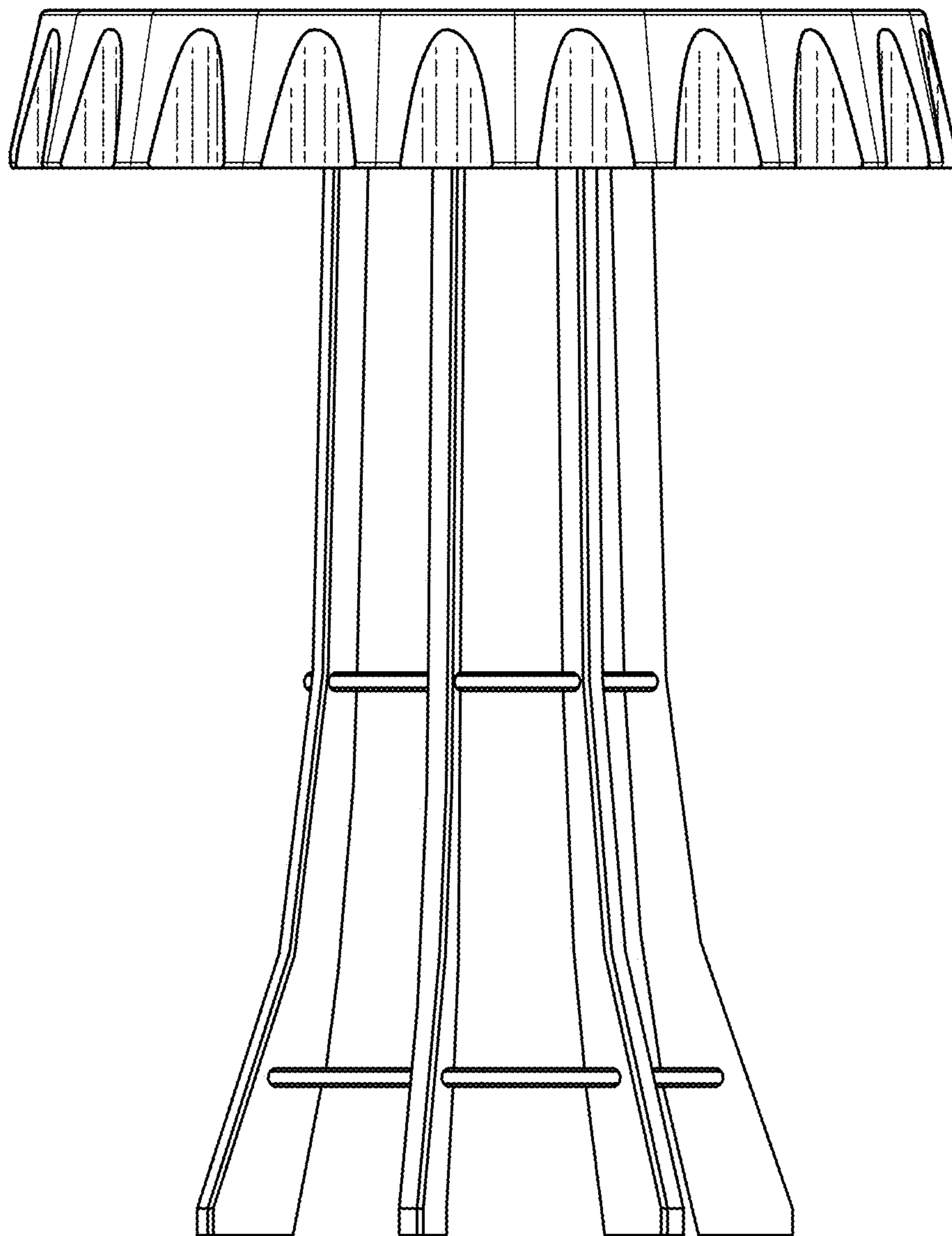

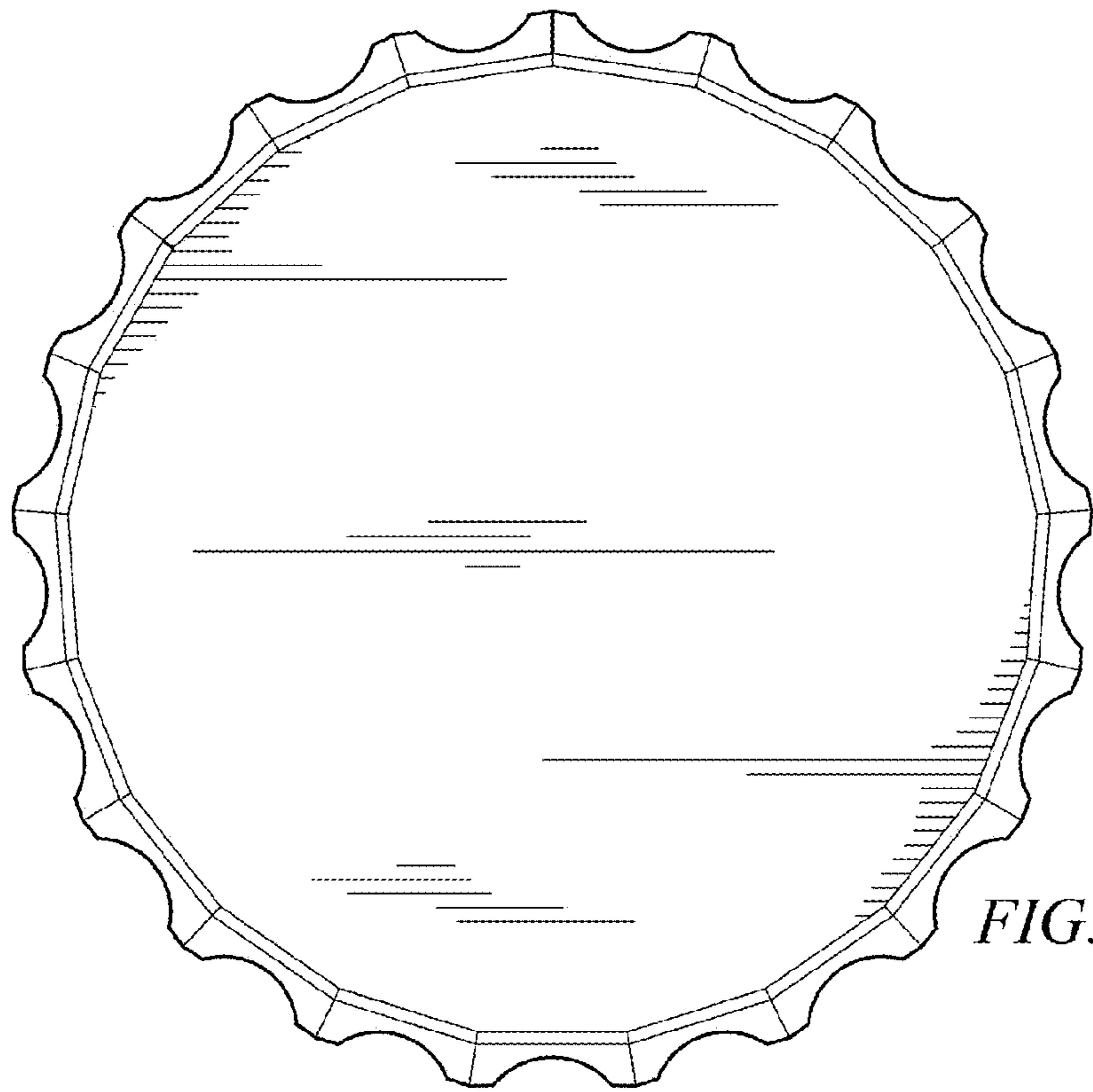

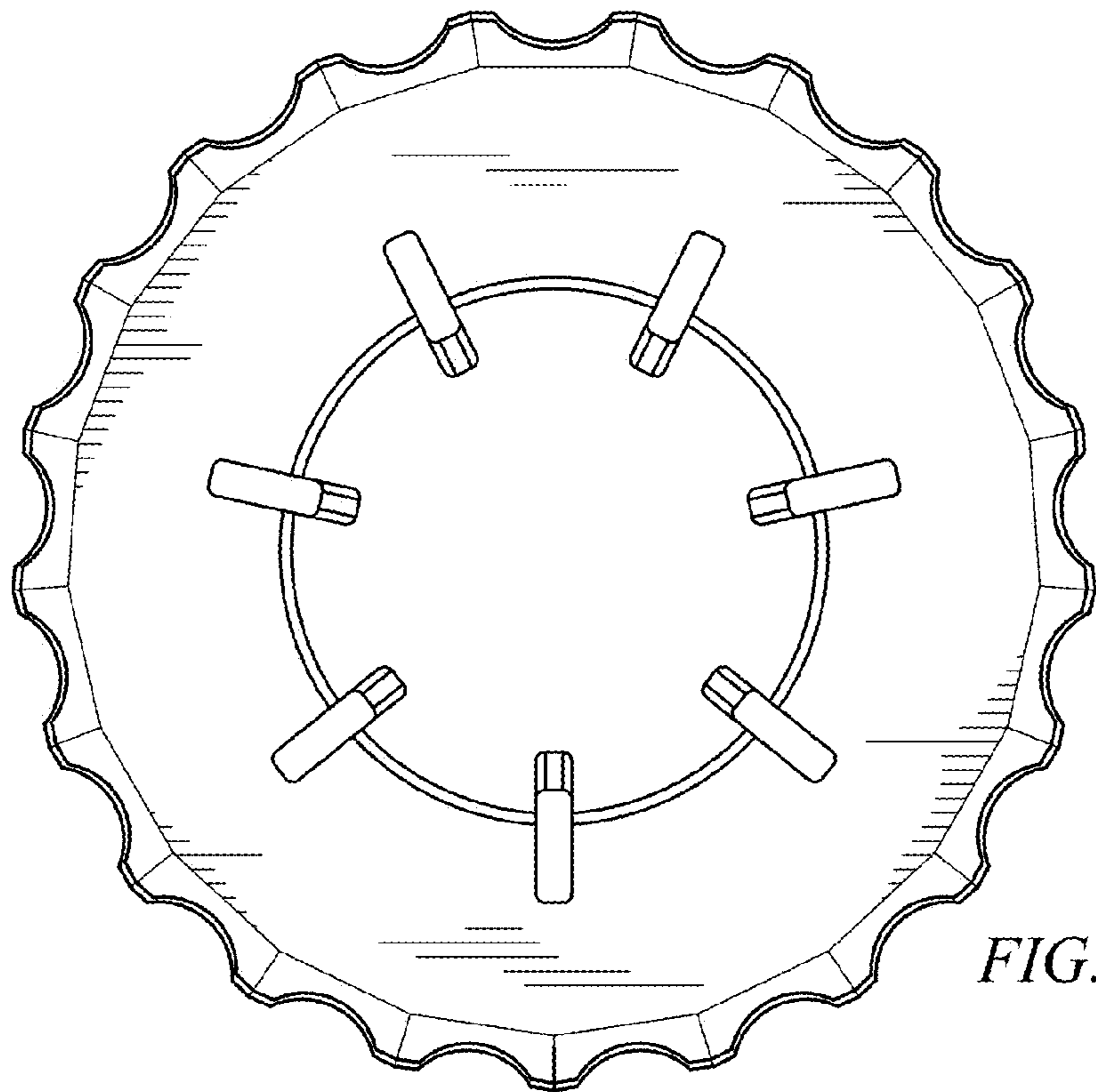

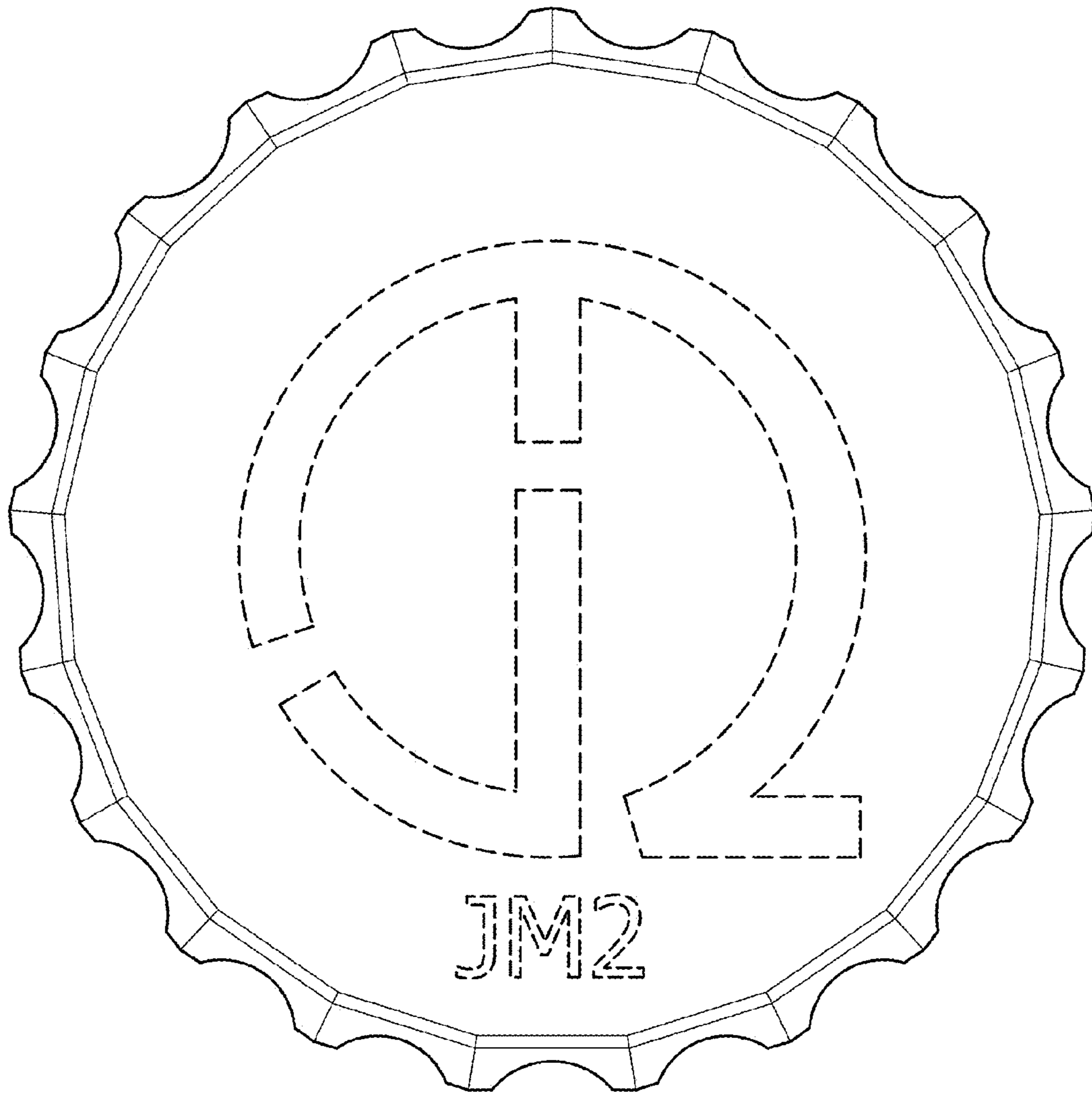
