(57) **CLAIM**

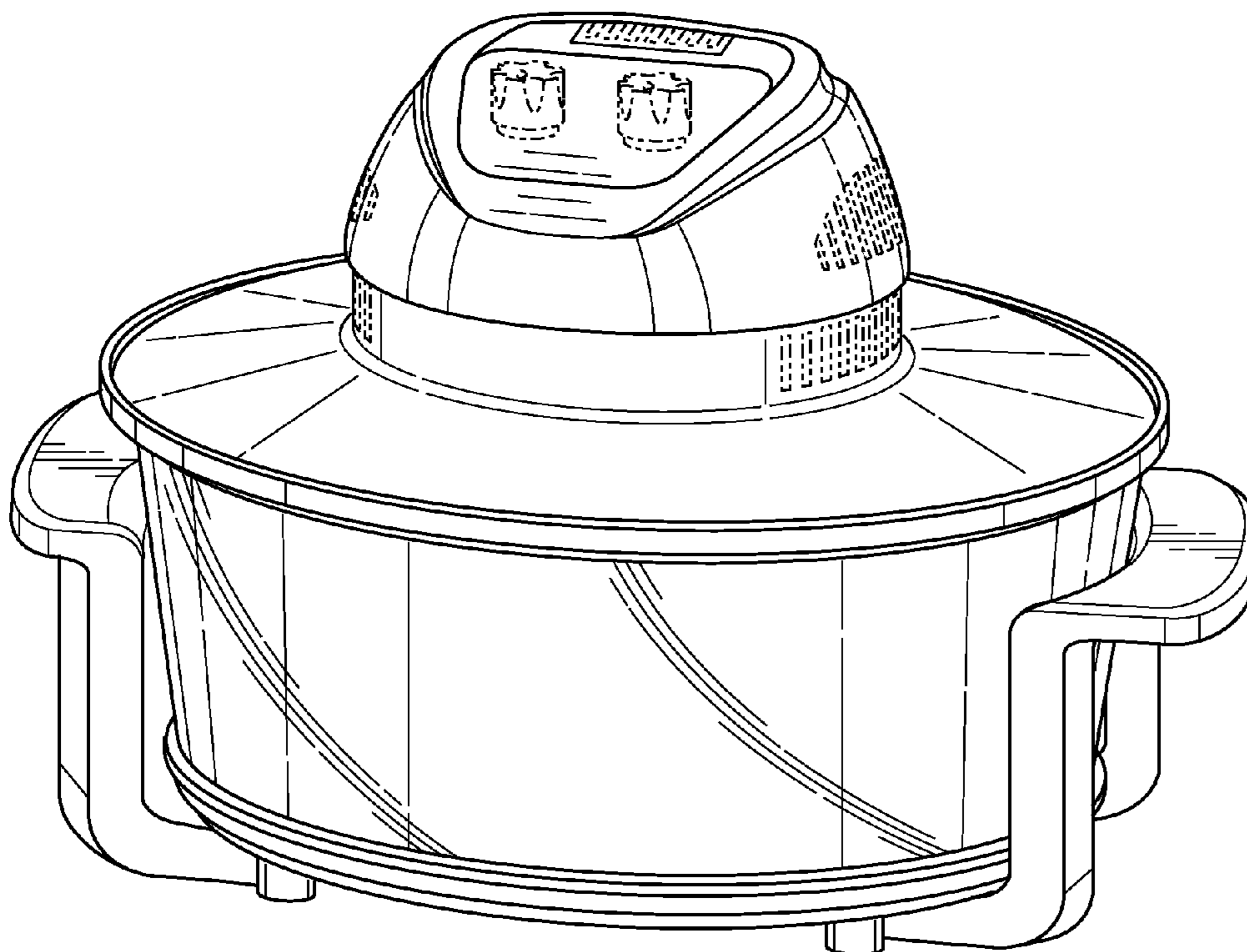
The ornamental design for an electric oven, as shown and described.

DESCRIPTION

FIG. 1 is a front, left, top, perspective view of an electric oven showing my new design;

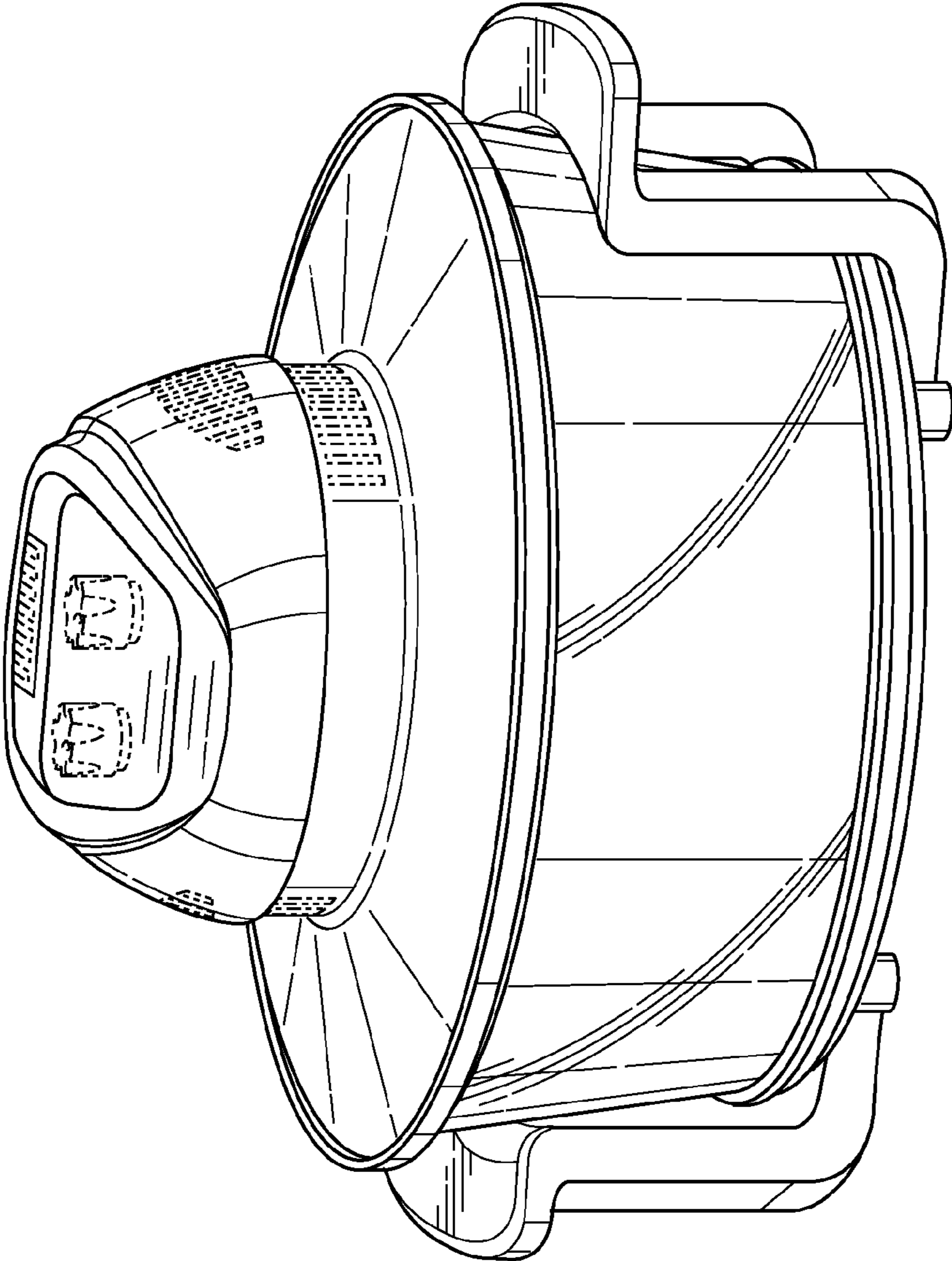

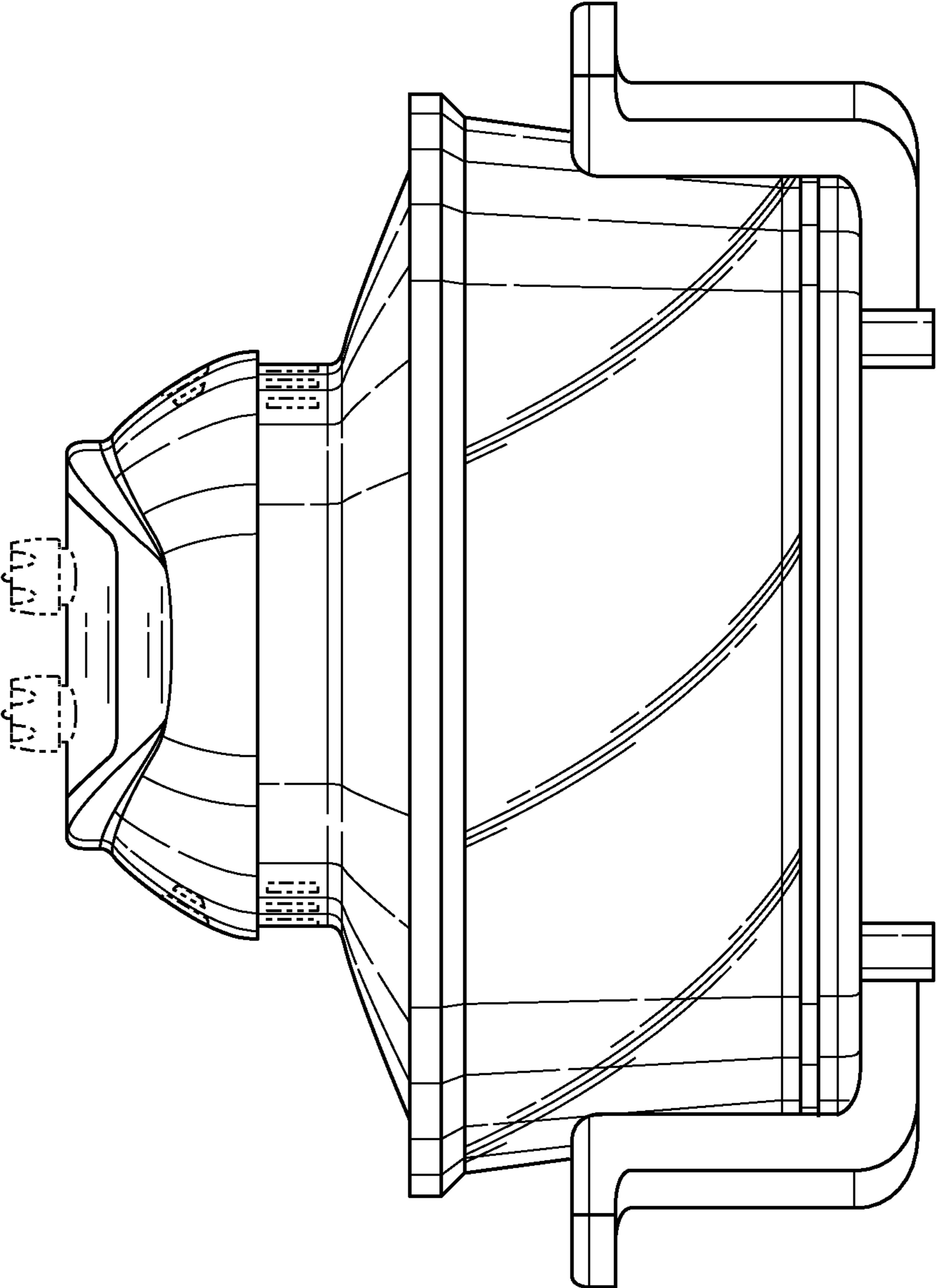

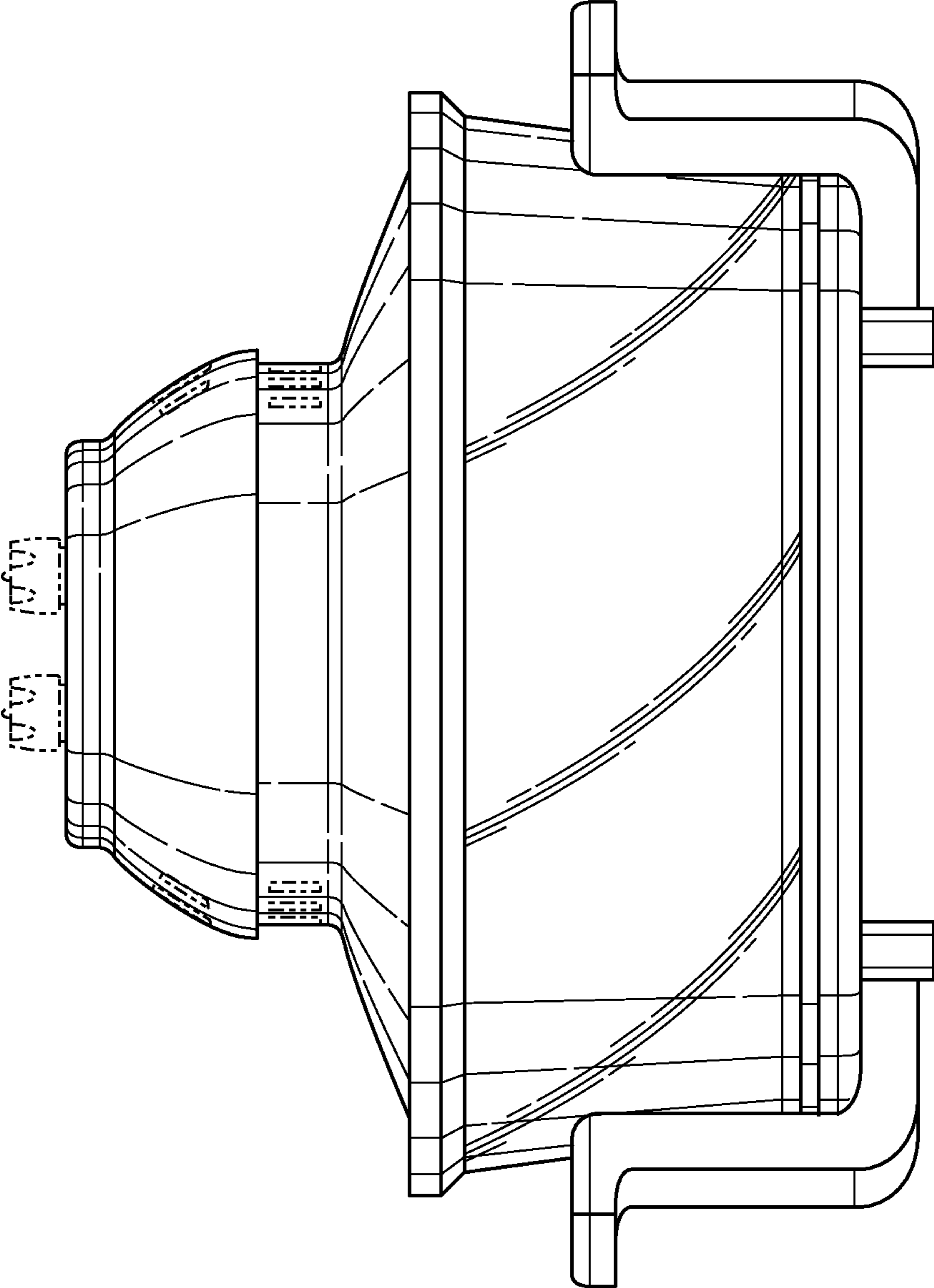

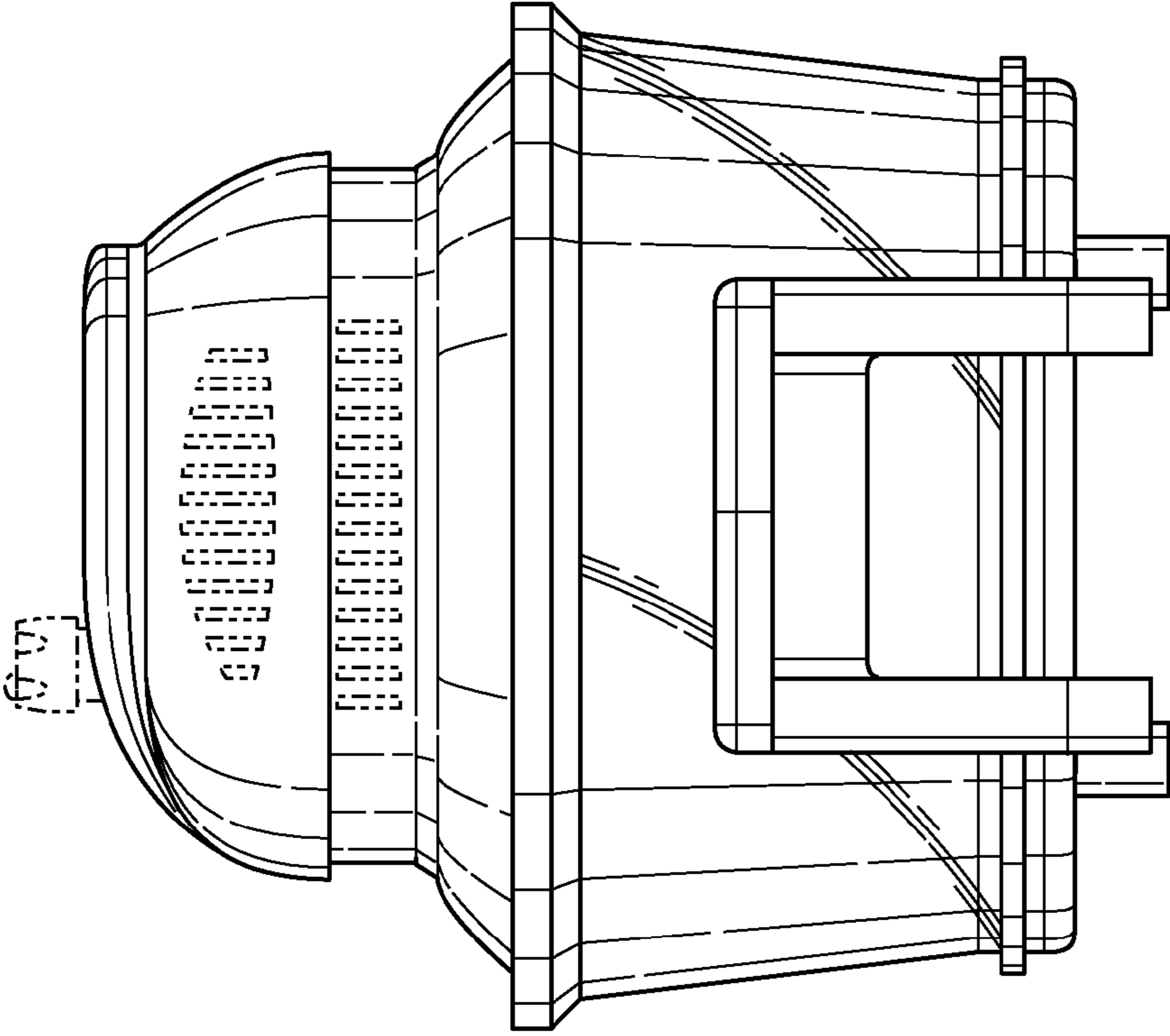

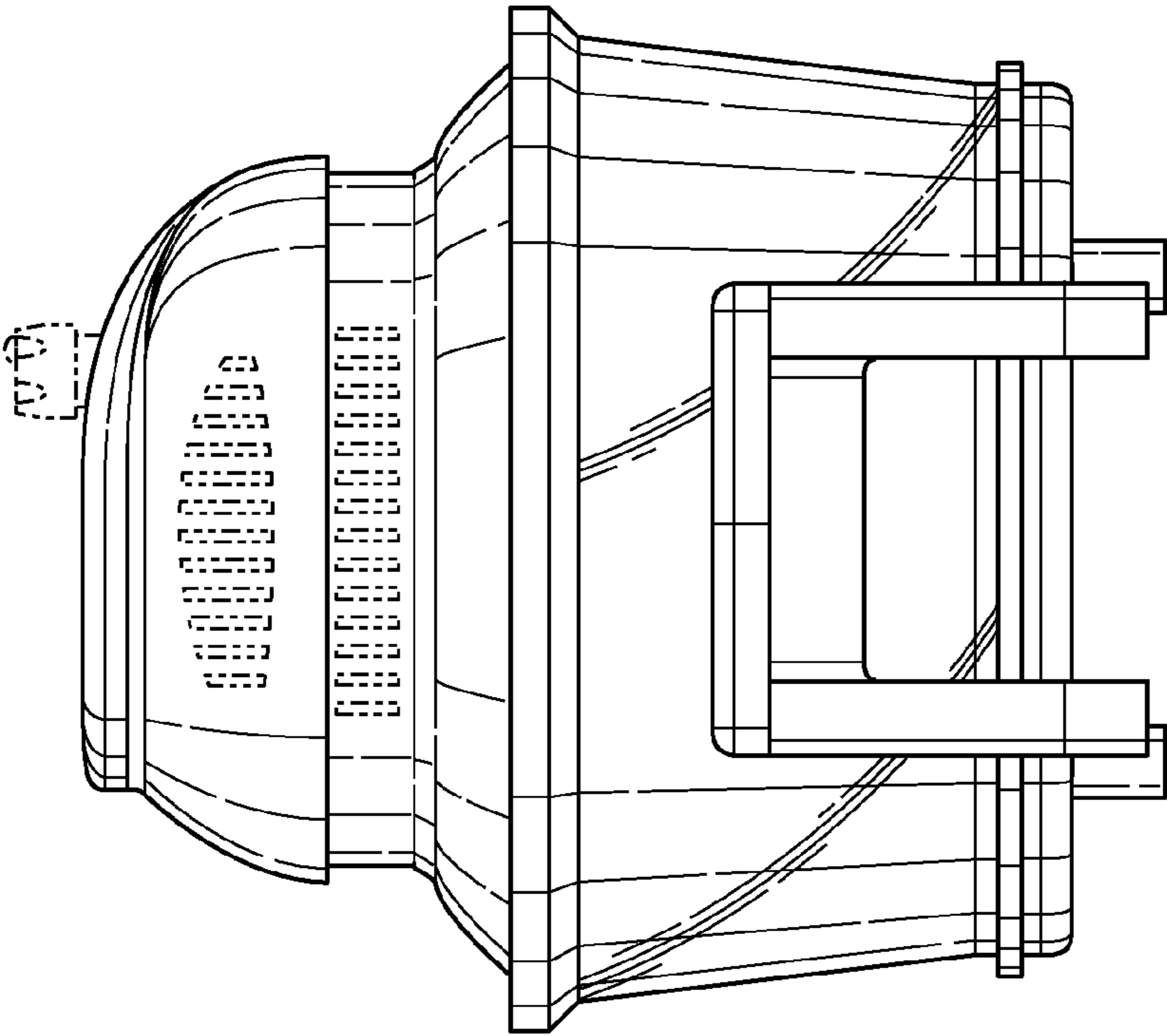

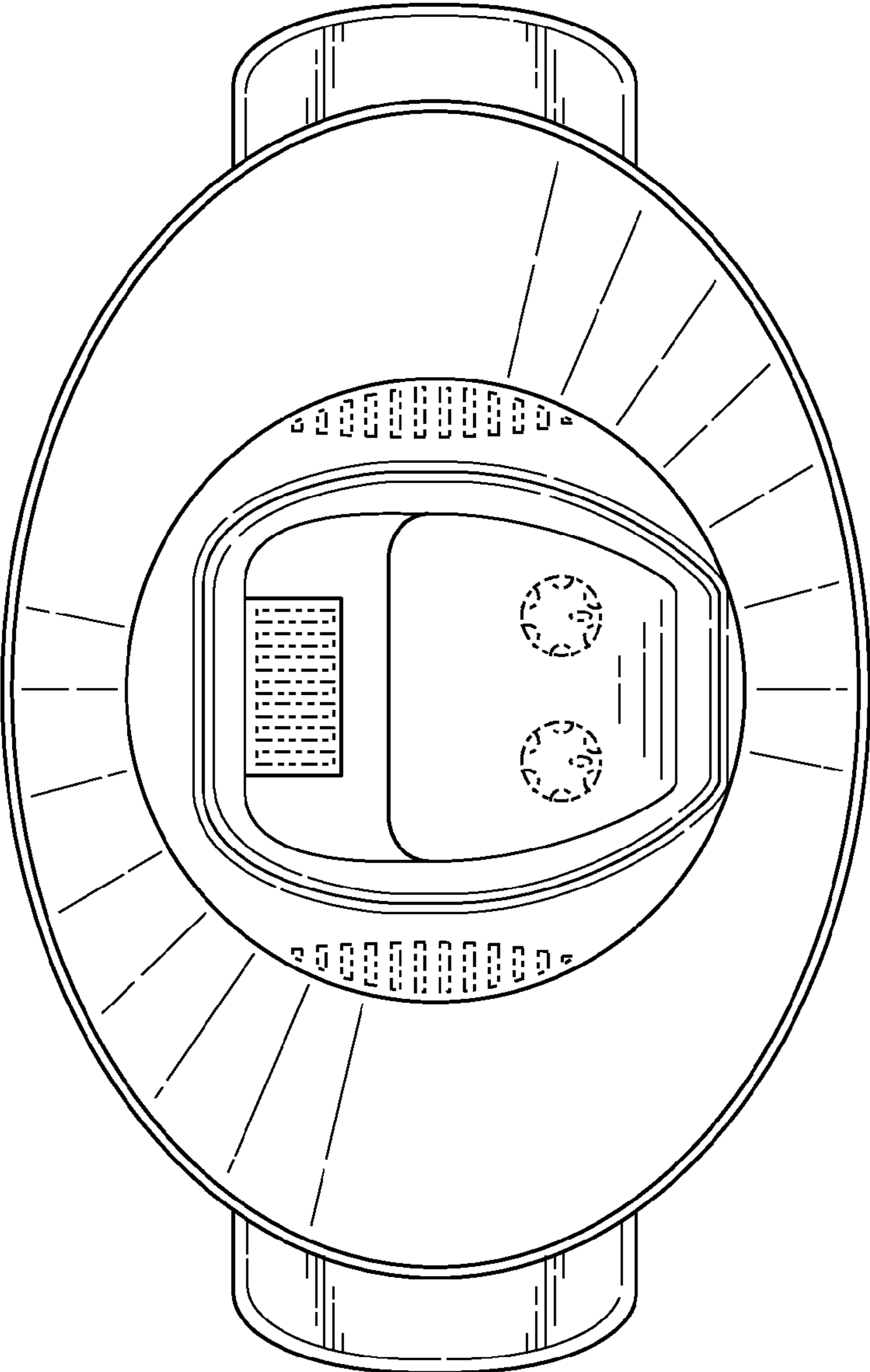

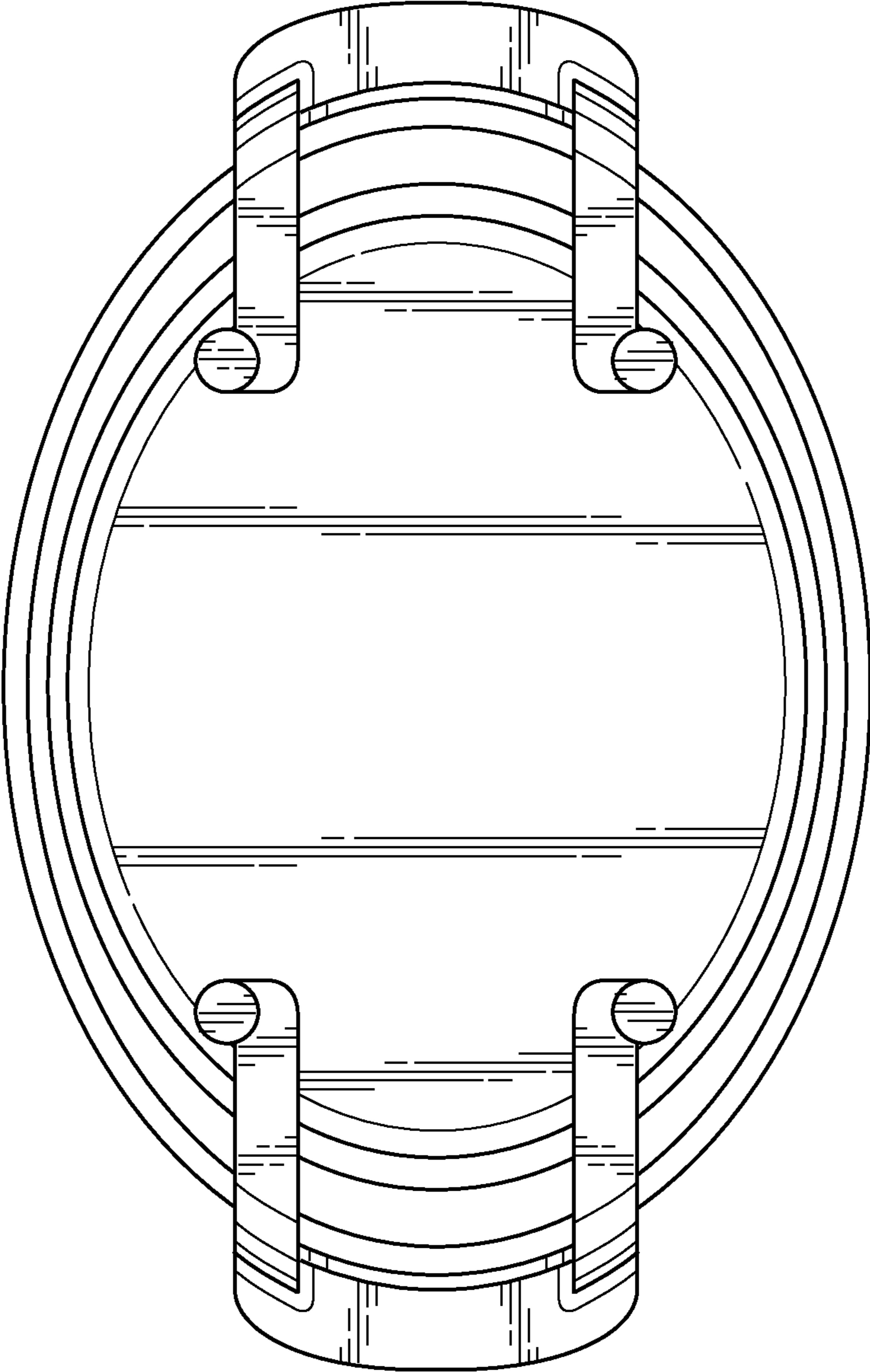
