(57) **CLAIM**

We claim, the ornamental design for the accessory interface for a tool, as shown and described.

DESCRIPTION

FIG. 3 is another side elevational view of the accessory interface for a tool of FIG. 1;

FIG. 6 is bottom perspective view of the accessory interface for a tool of FIG. 1.

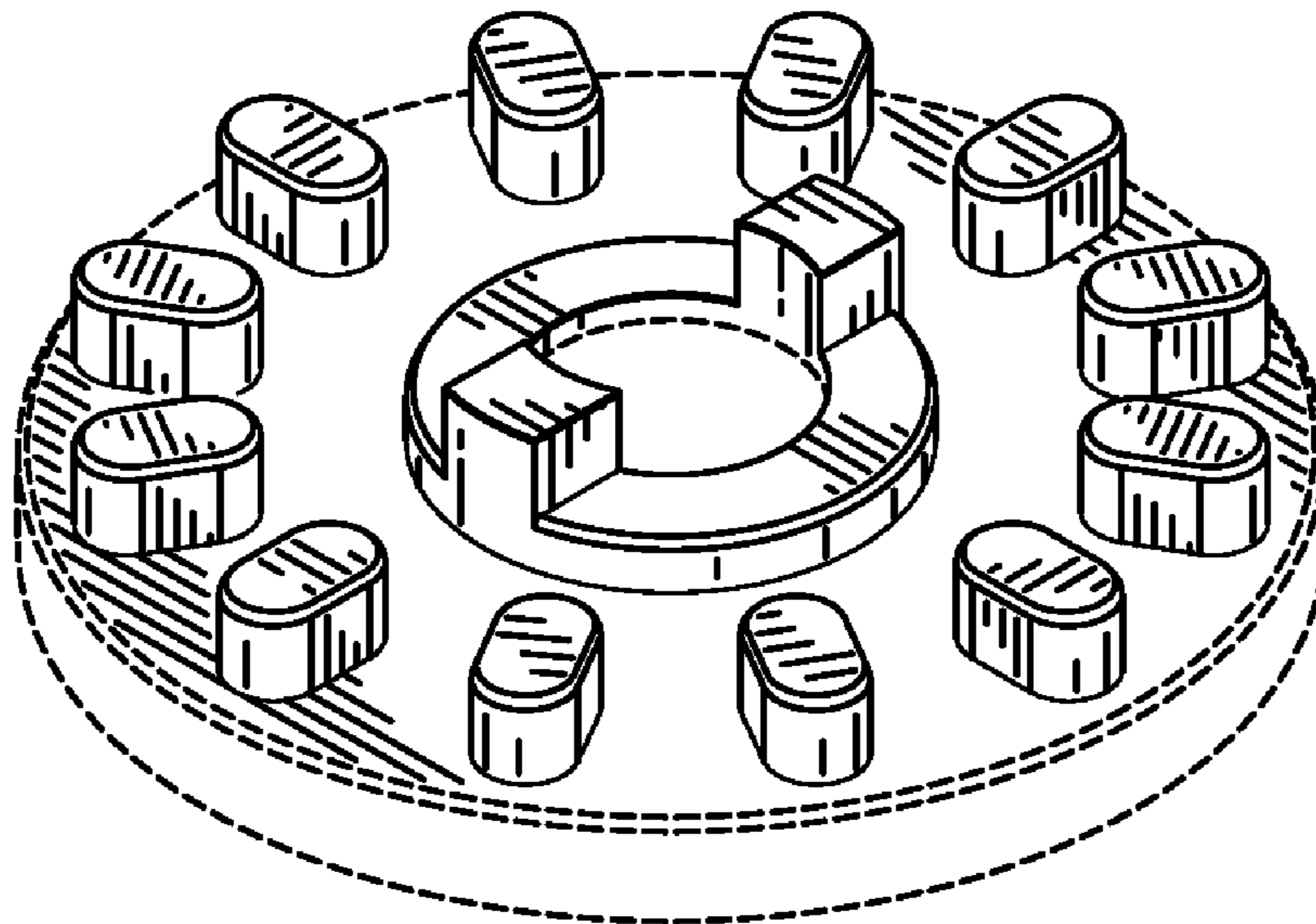
The broken lines shown illustrate portions of the accessory interface for a tool that form no part of claimed design.

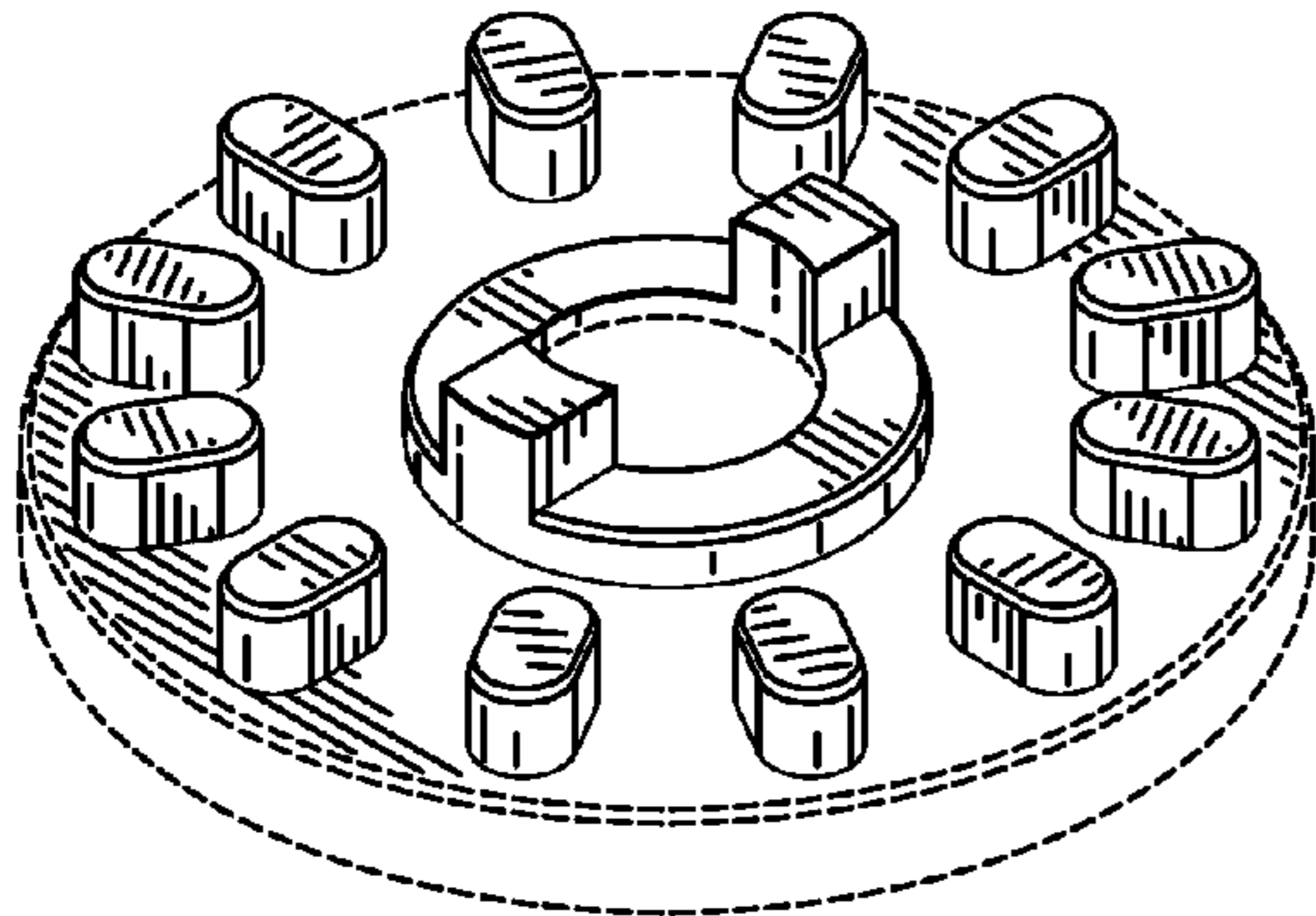

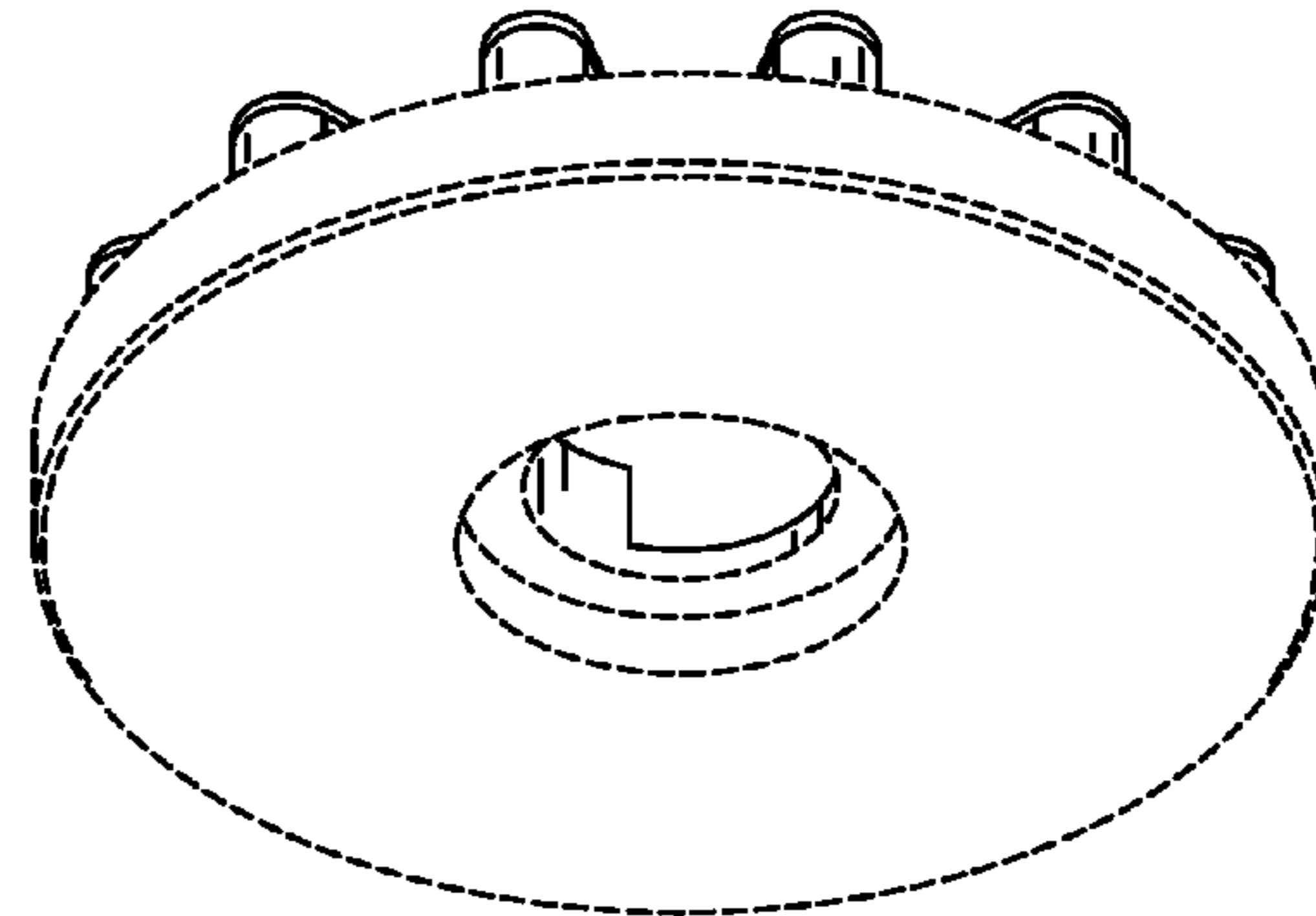

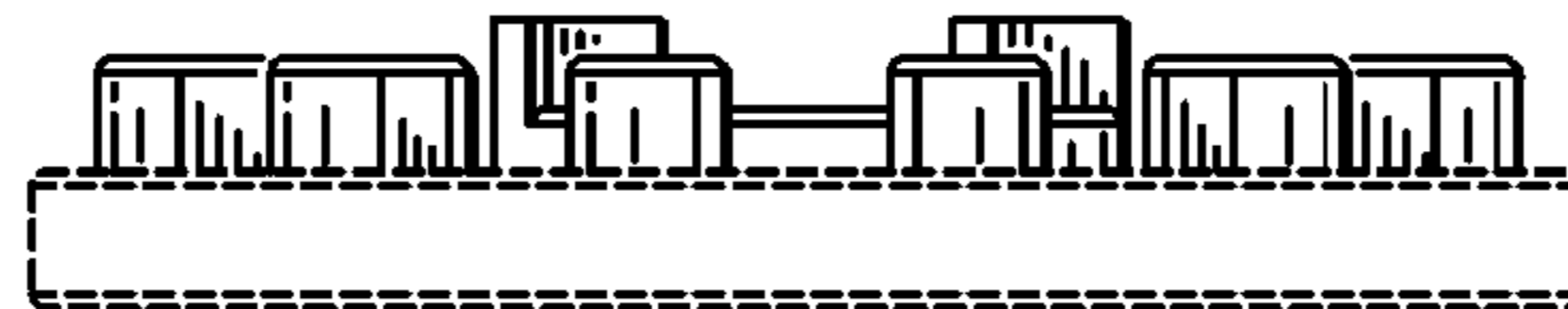

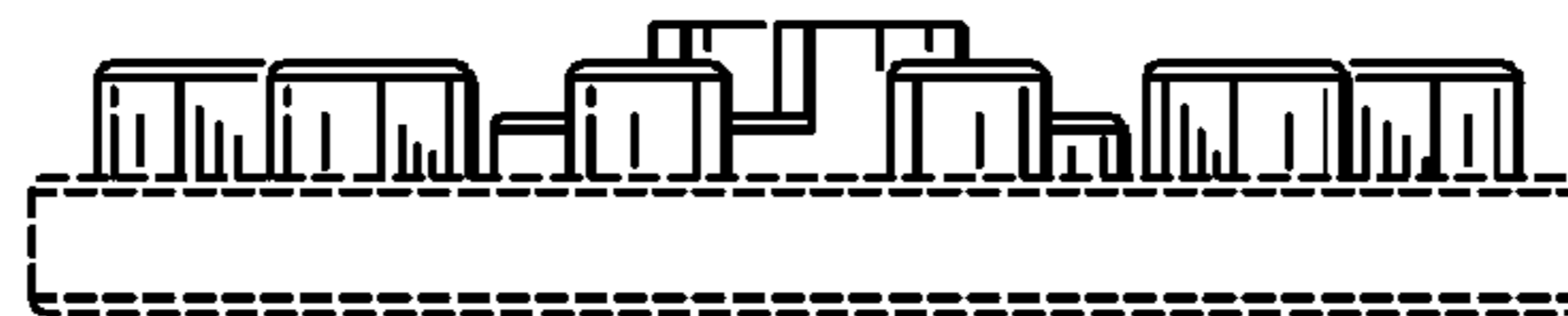

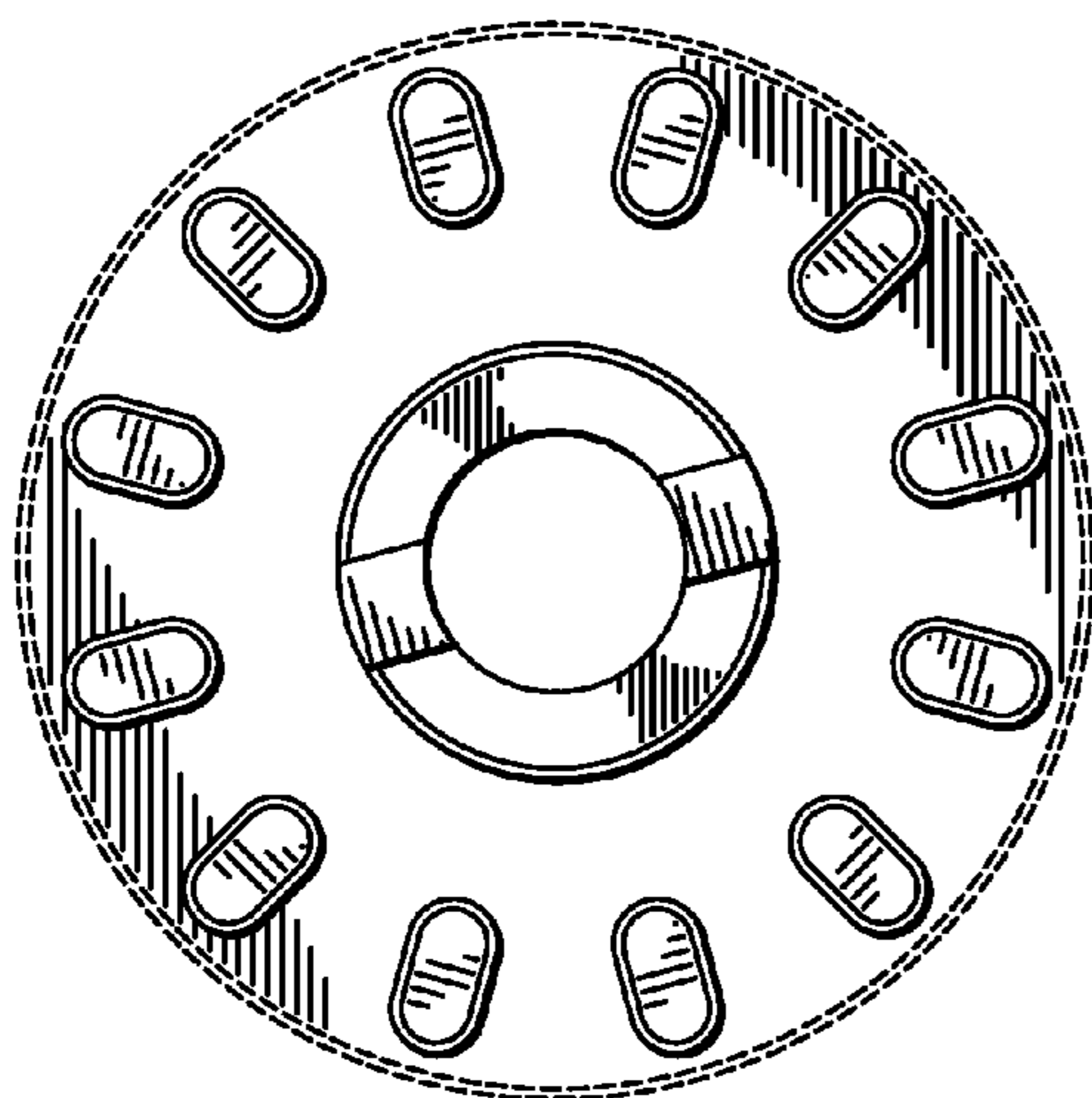

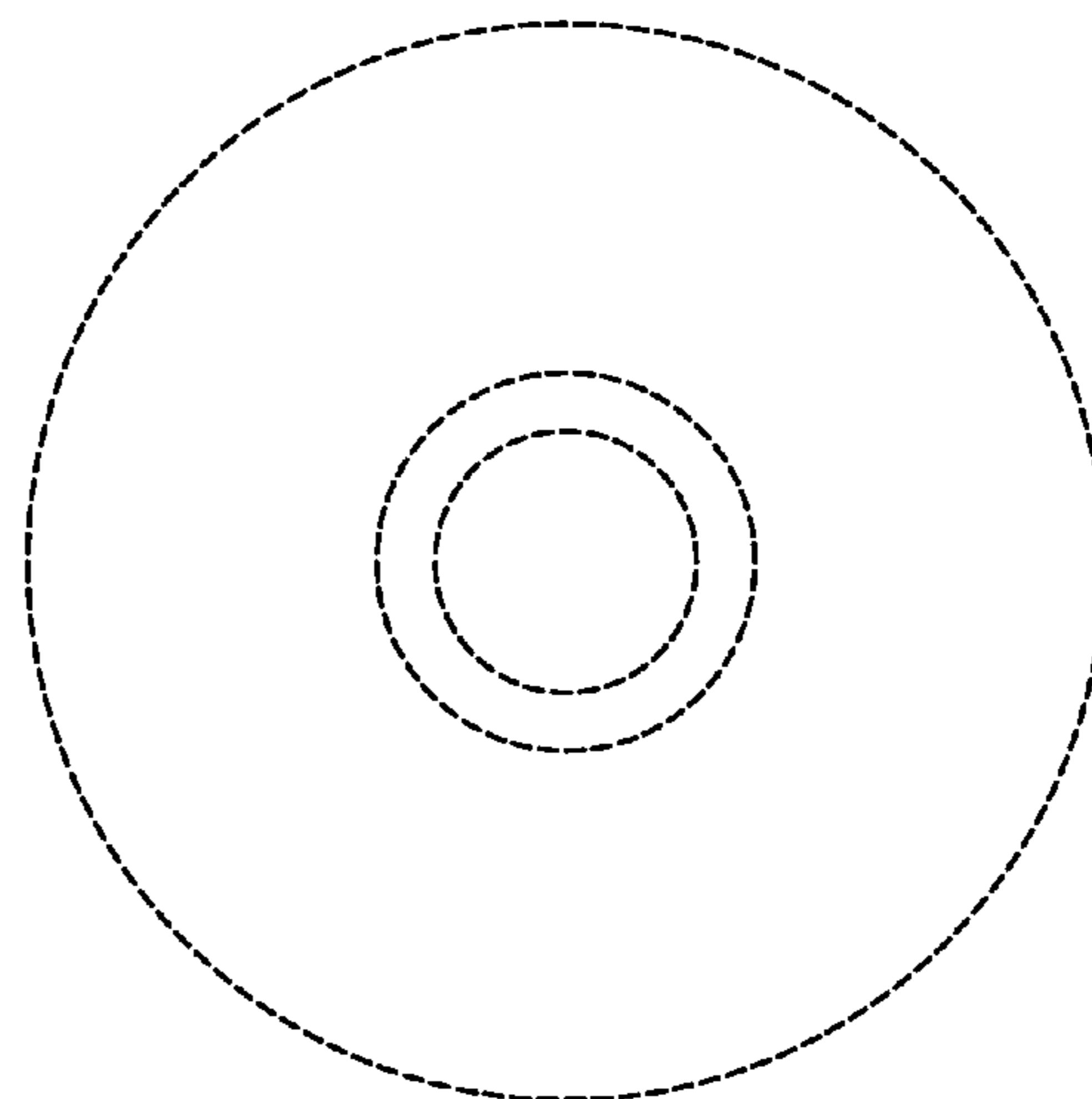
