(57) **CLAIM**

The ornamental design for a drinking bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of the drinking bottle with the cap on.

FIG. 2 is a front elevation view of the drinking bottle with the cap off.

FIG. 3 is a side elevation view of the drinking bottle with the cap off.

FIG. 4 is a top perspective view of the drinking bottle with the cap on.

FIG. 5 is a bottom perspective view of the drinking bottle with the cap on.

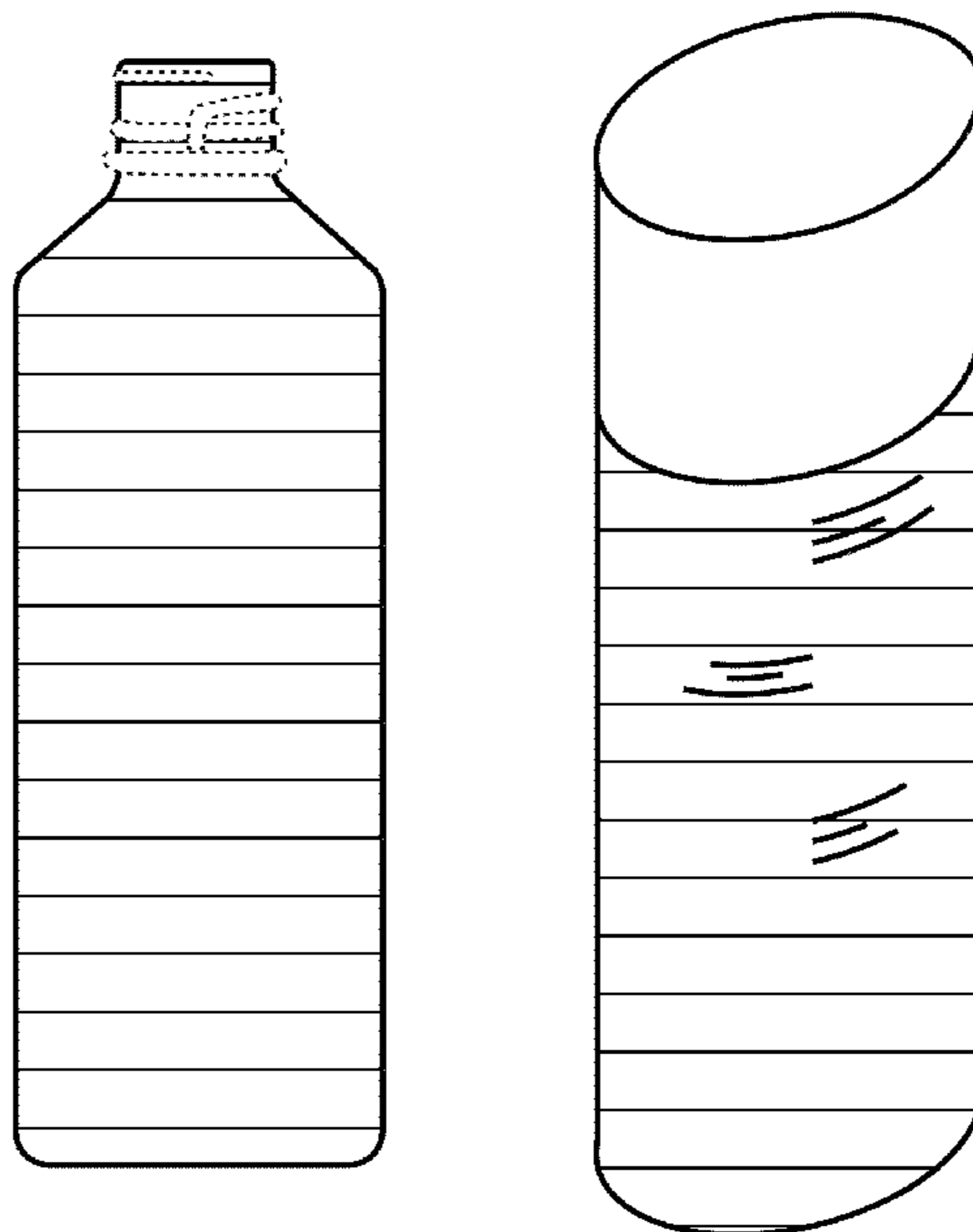
FIG. 6 is a top plan view of the drinking bottle with the cap on; and,

FIG. 7 is a bottom plan view of the drinking bottle.

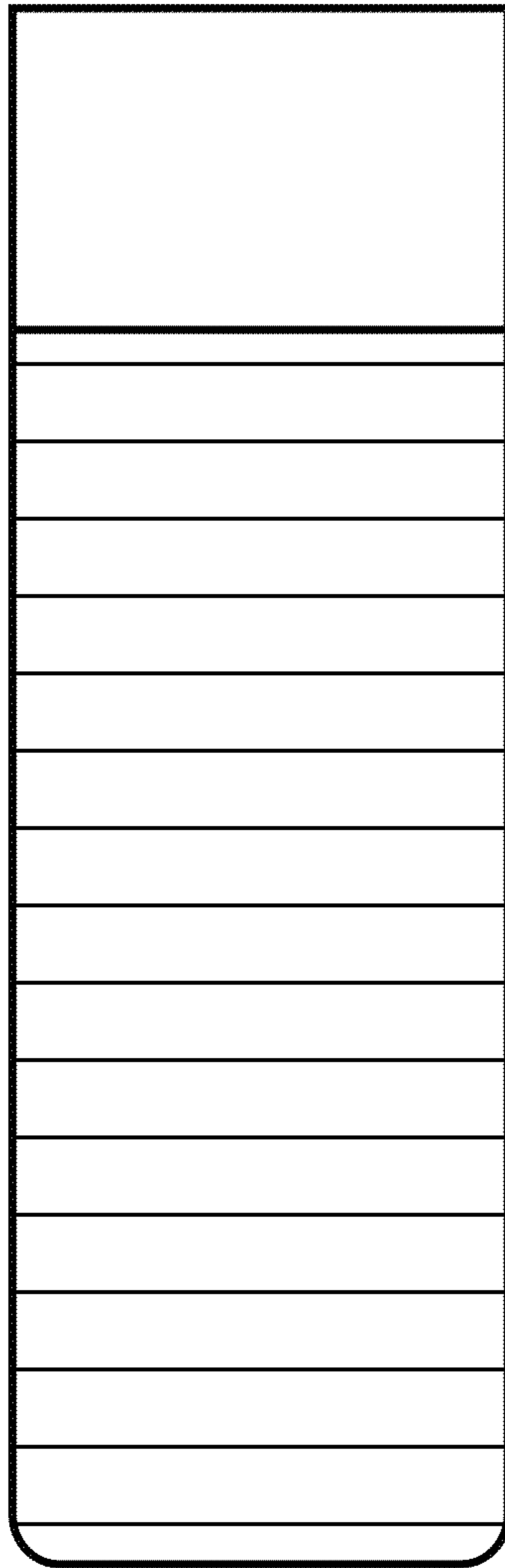

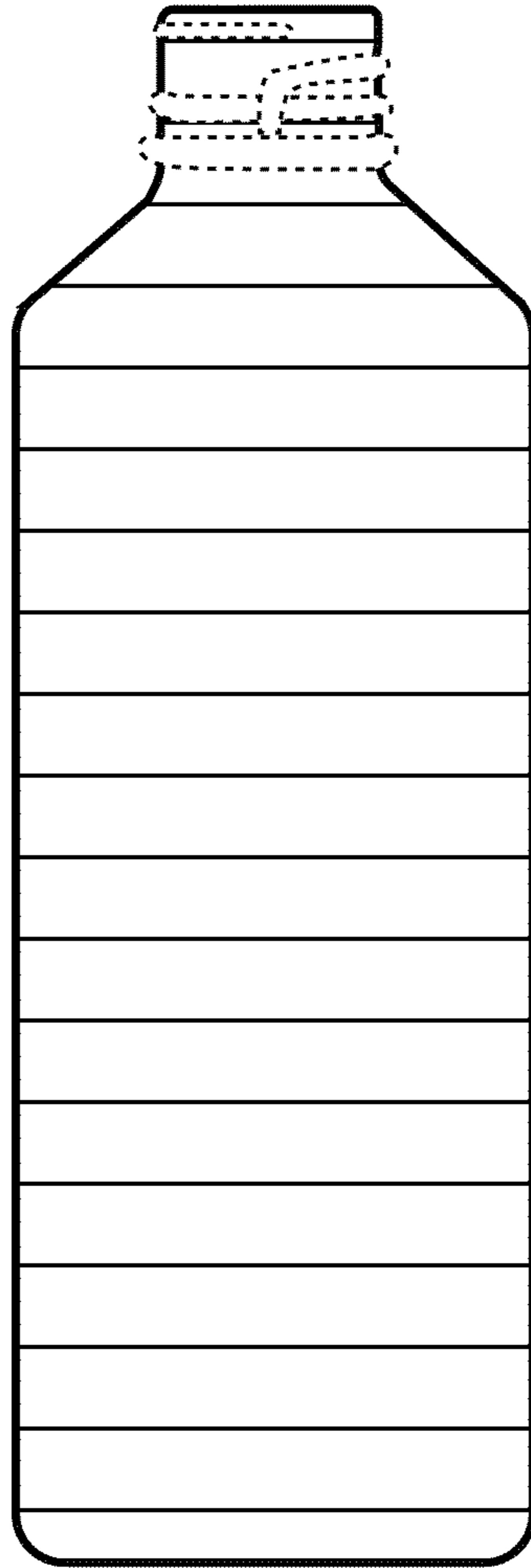

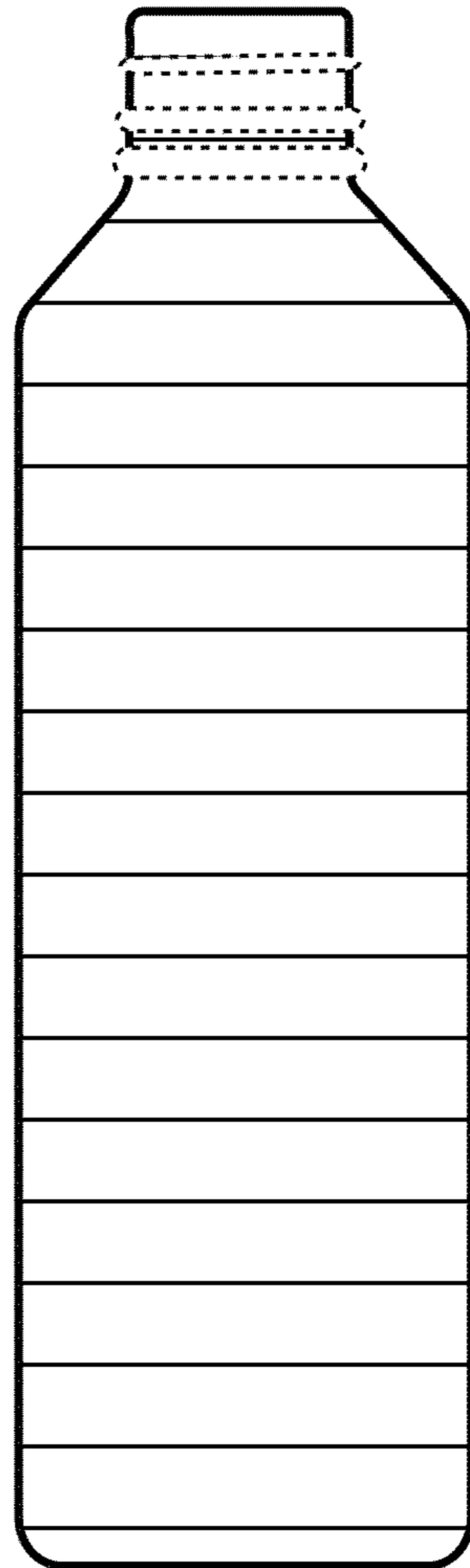

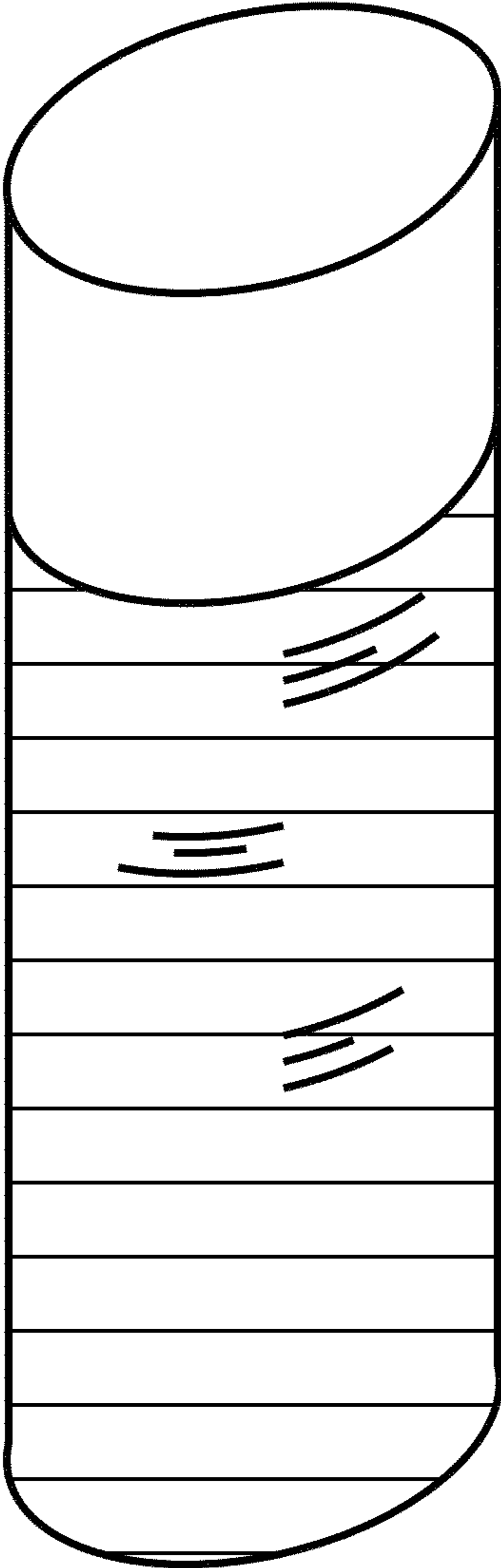

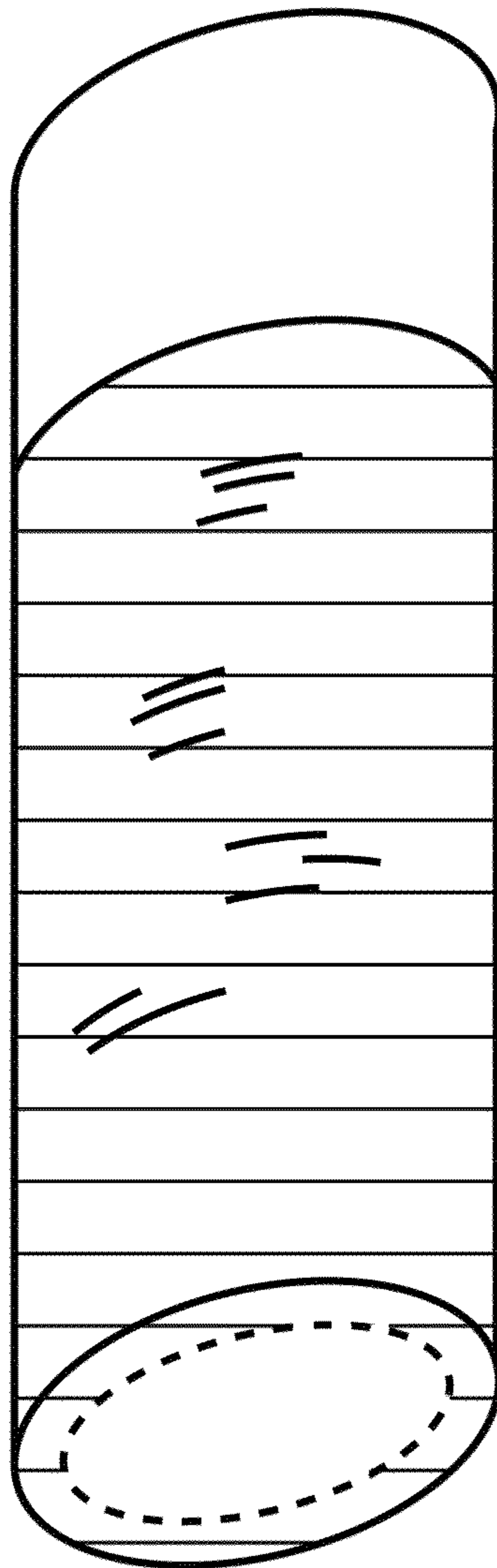

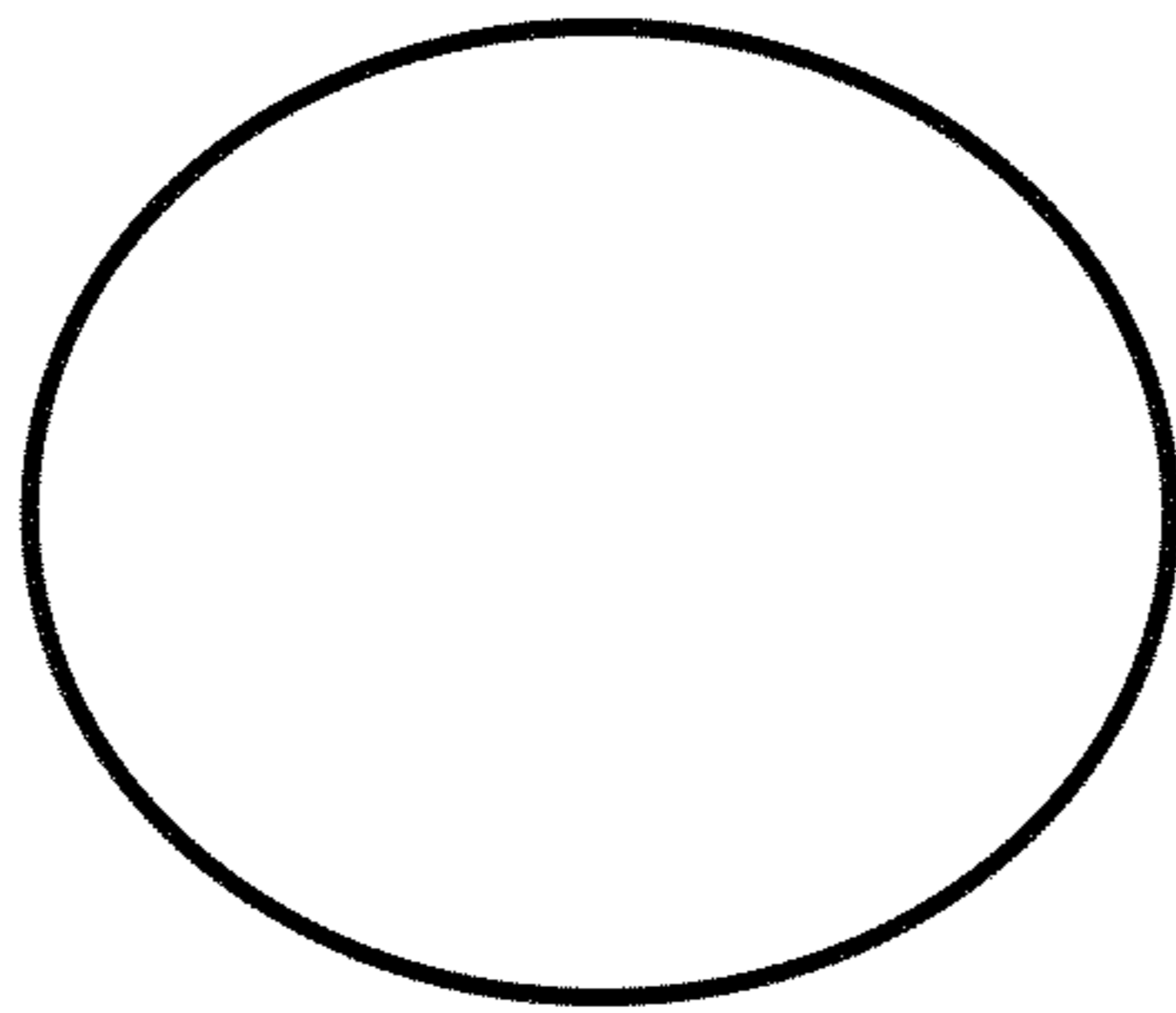

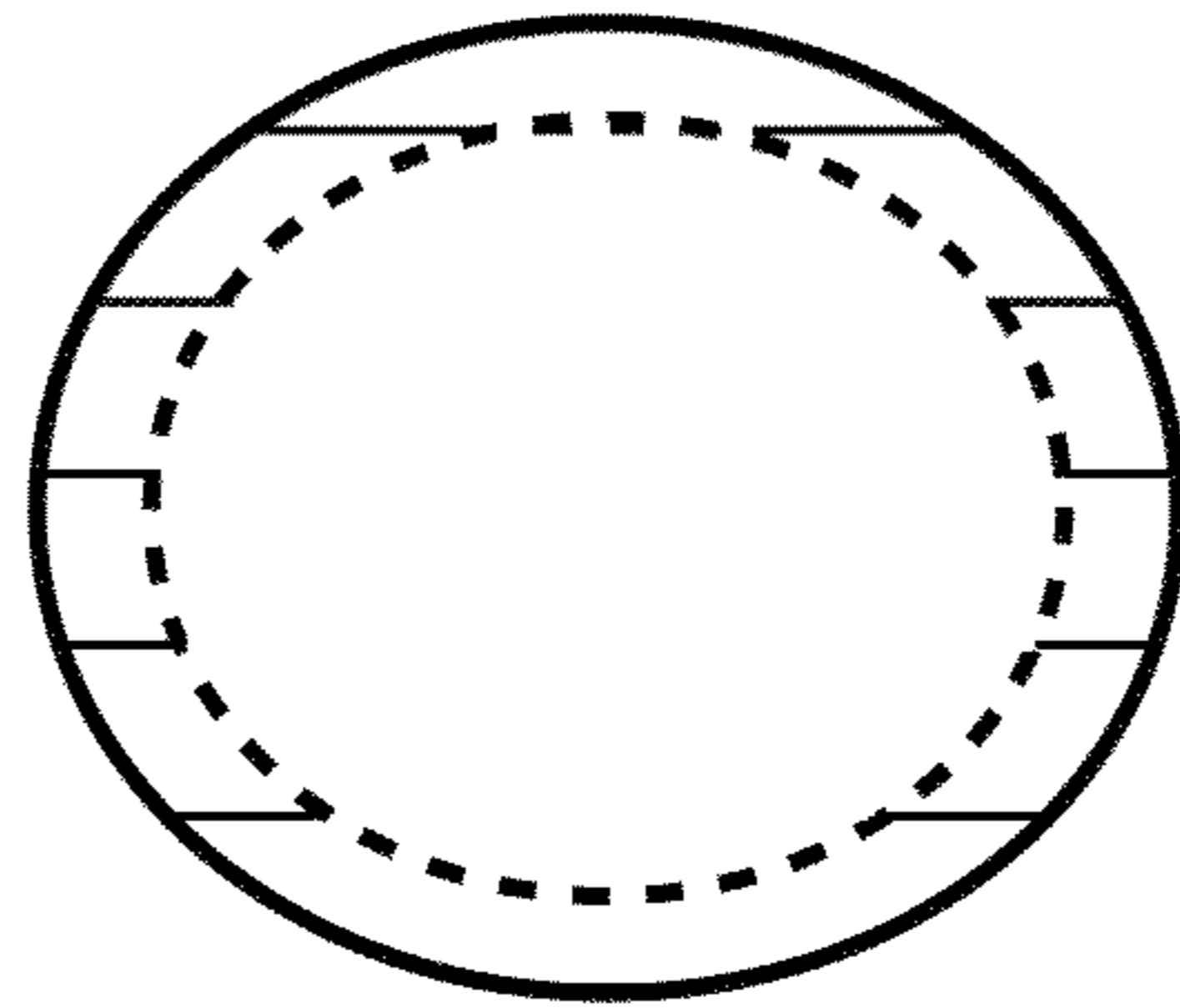
