(57) **CLAIM**

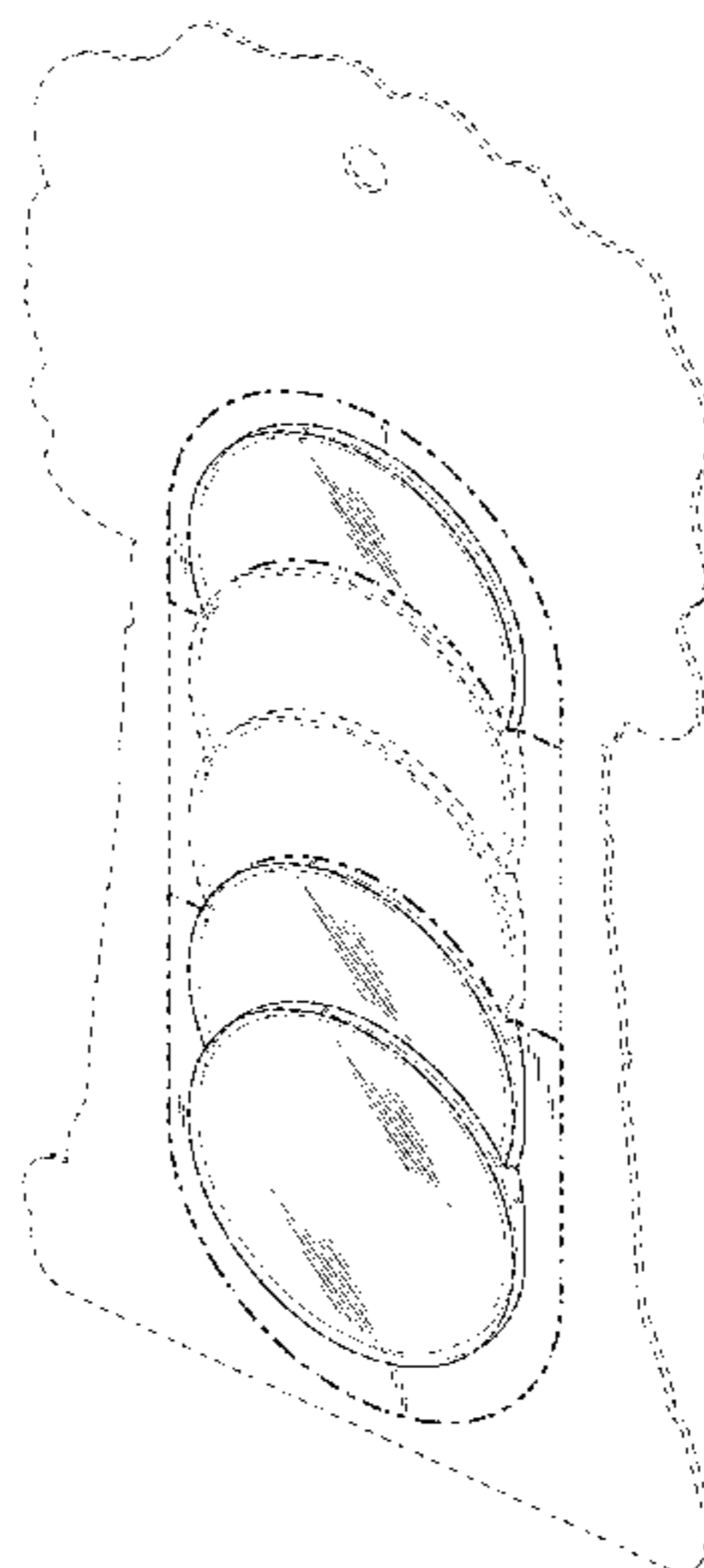
The ornamental design for packaged transaction cards, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top perspective view of packaged transaction cards showing our new design; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a left side view thereof; FIG. 6 is a top view thereof; and, FIG. 7 is a bottom view thereof.

The broken line showing of a packaged transaction cards represents unclaimed subject matter and forms no part of the claimed design. The bolded long dash-short dash lines represent the bounds of the claim and form no part of the claimed design.

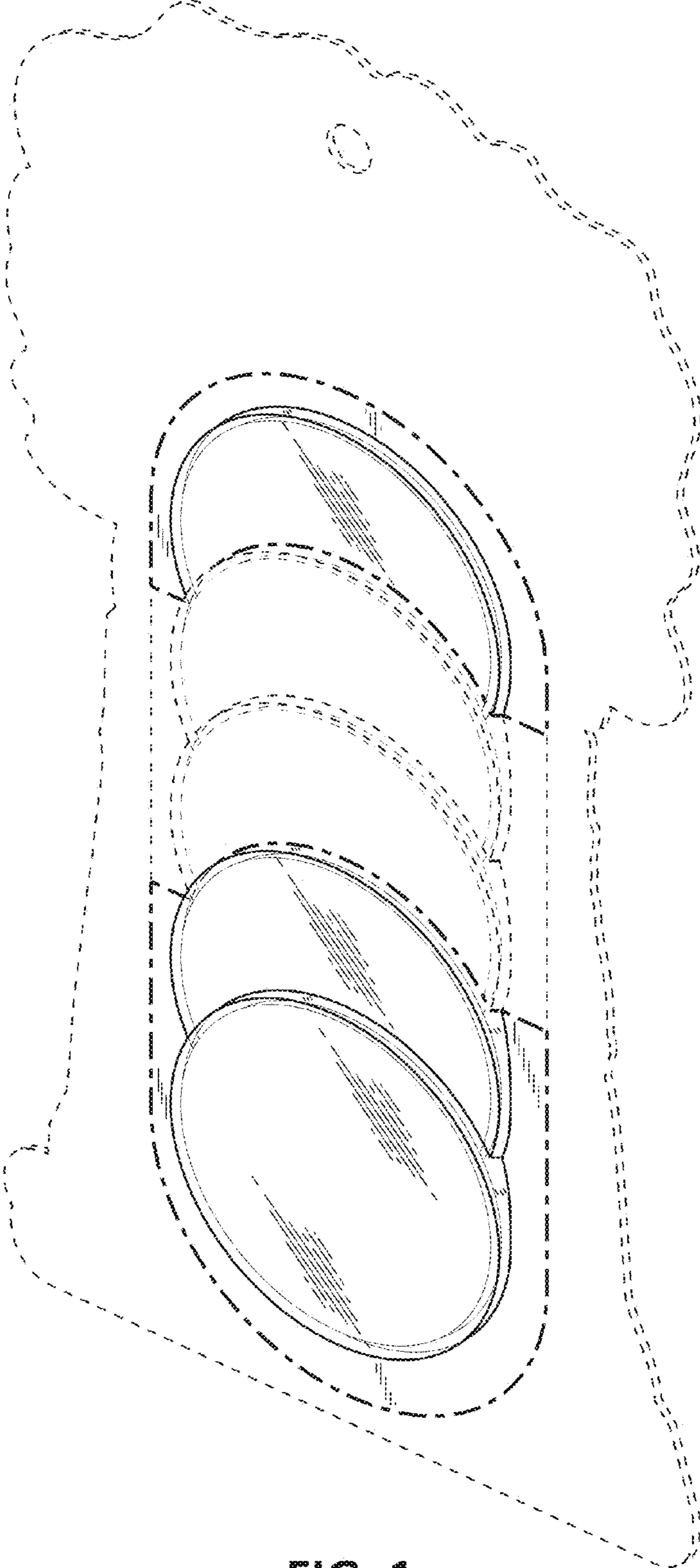

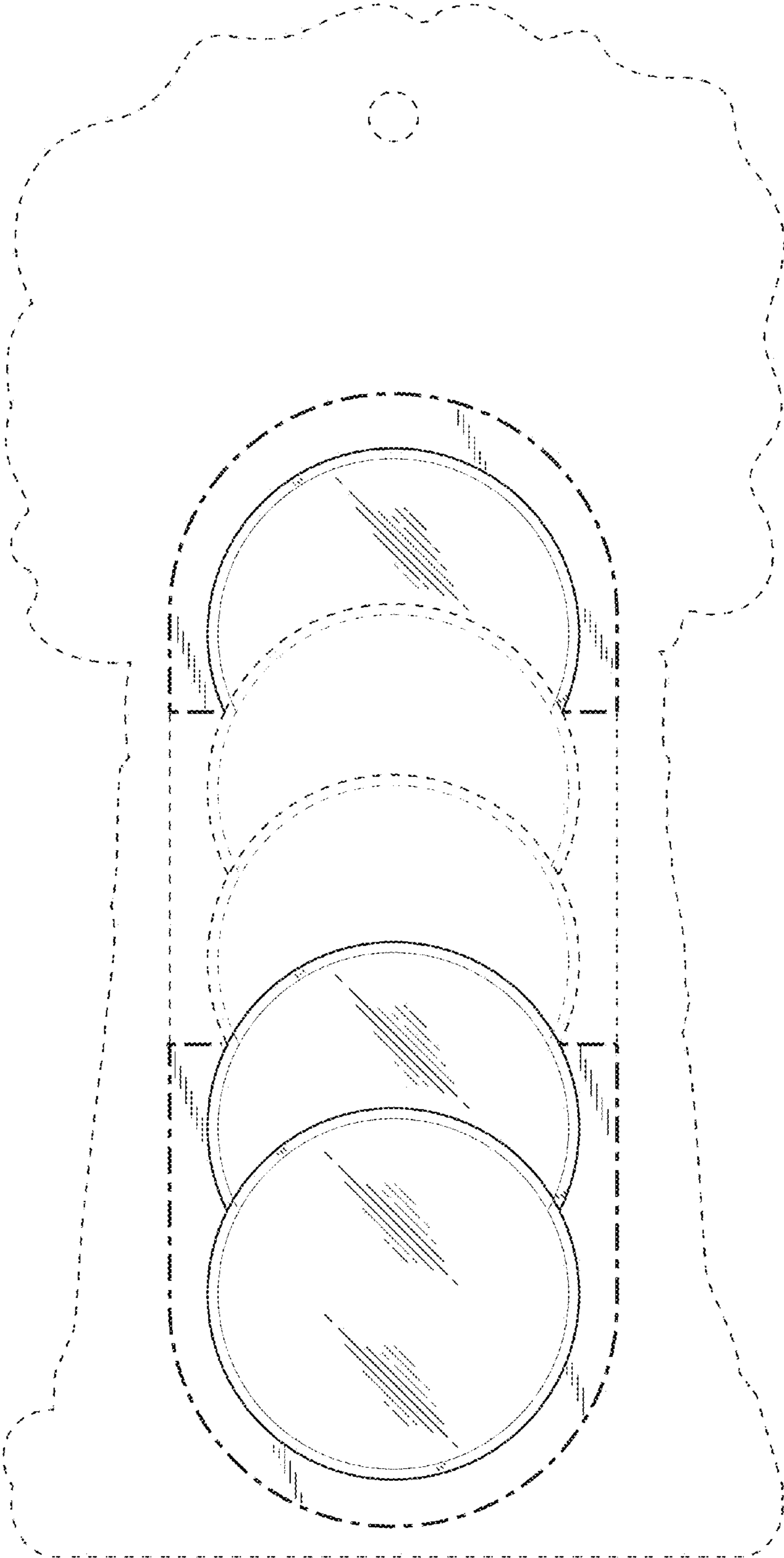

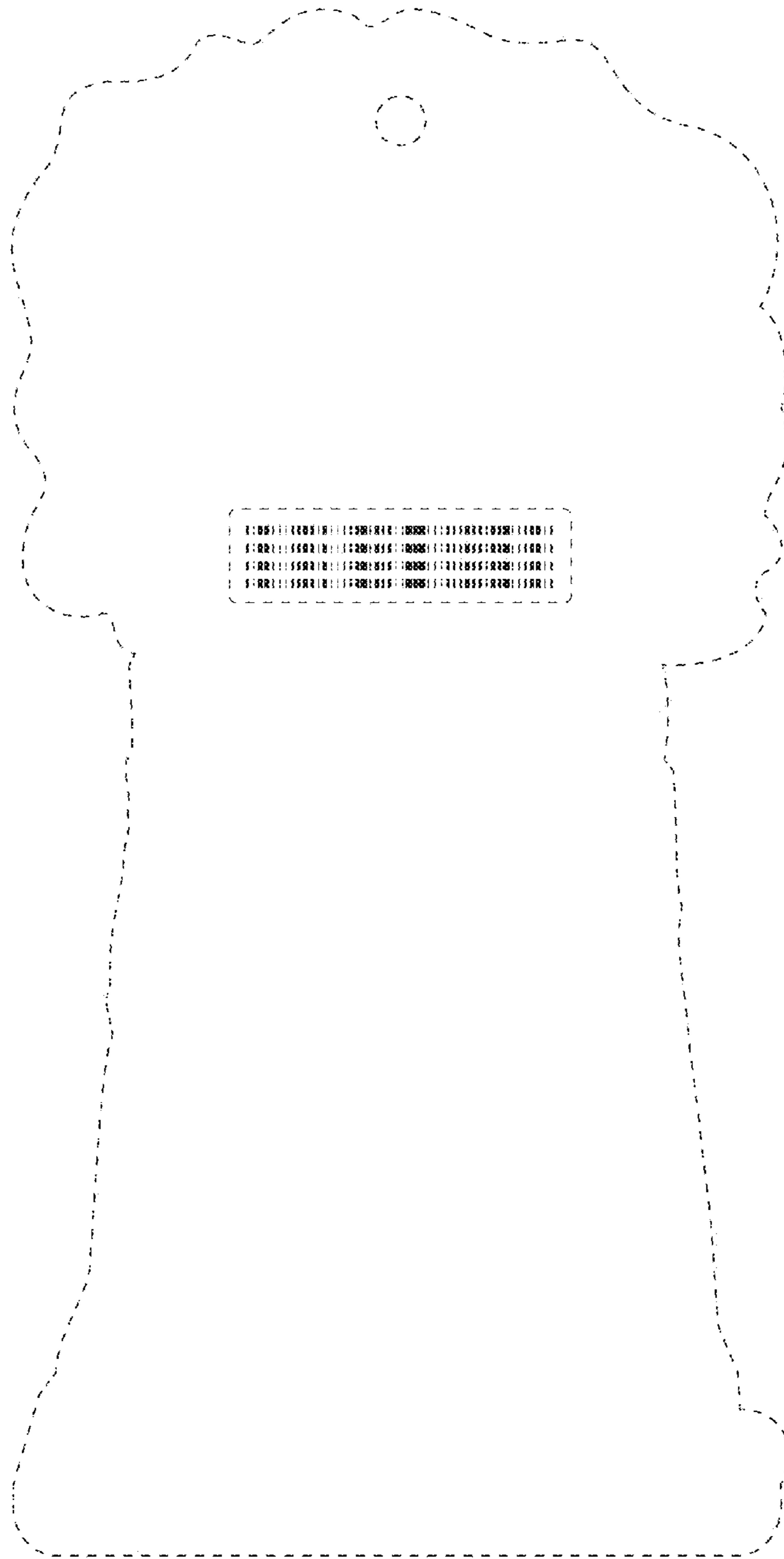

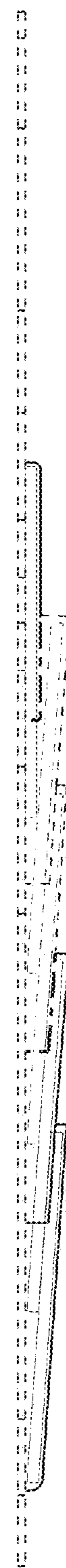
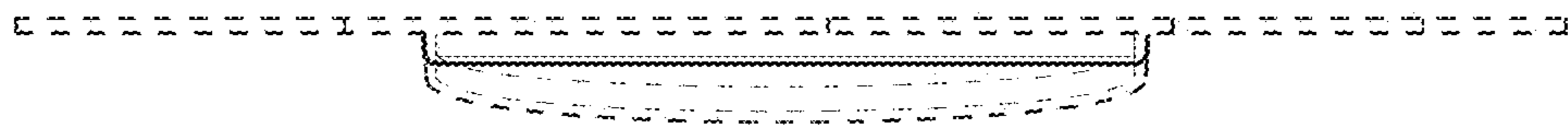
