The ornamental design for a burned calories meter, as shown and described.

DESCRIPTION

FIG. 1 is a front, right side, bottom perspective view of a burned calories meter showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side view thereof;

FIG. 5 is a right side view thereof;

FIG. 9 is a reference front elevational view thereof showing a state in which a cap part is detached;

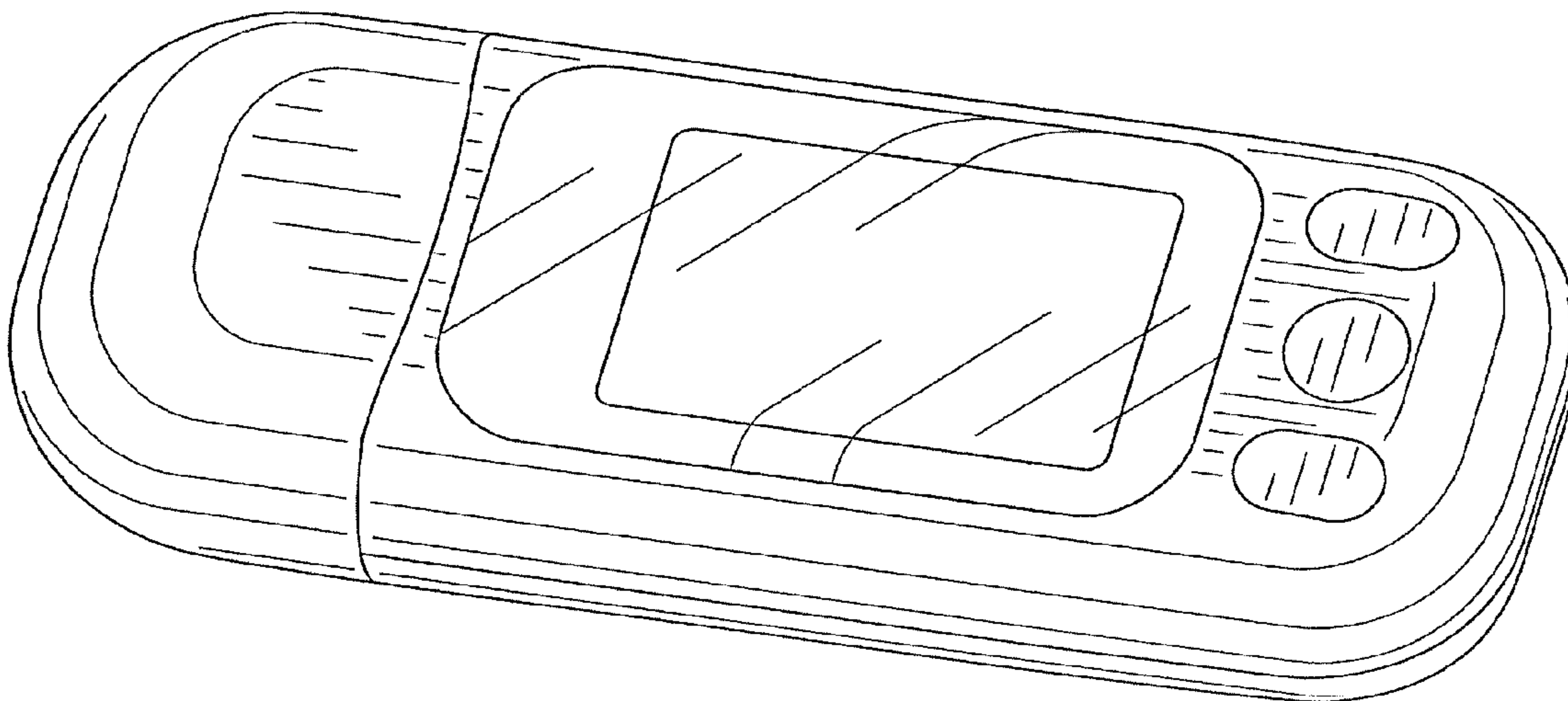
FIG. 10 is a reference rear elevational view thereof showing a state in which a cap part is detached;

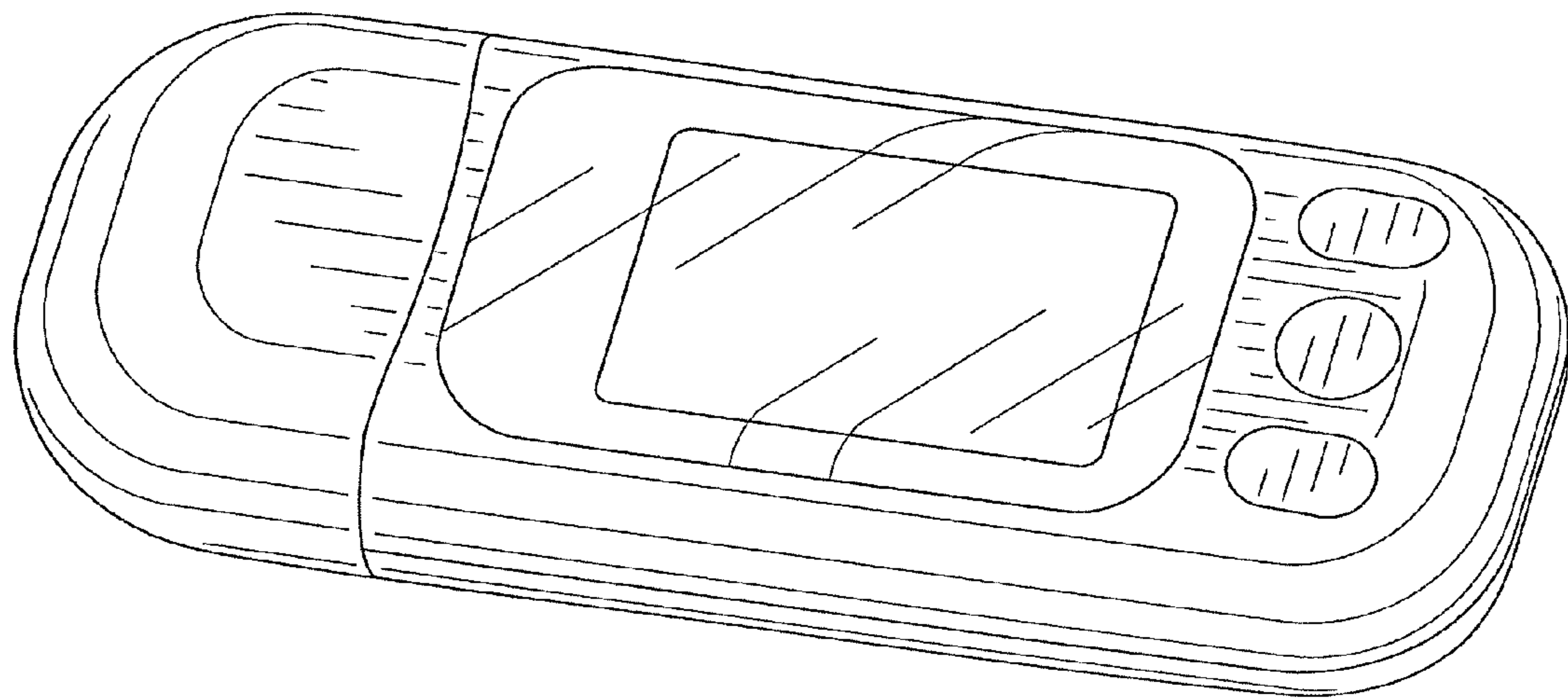

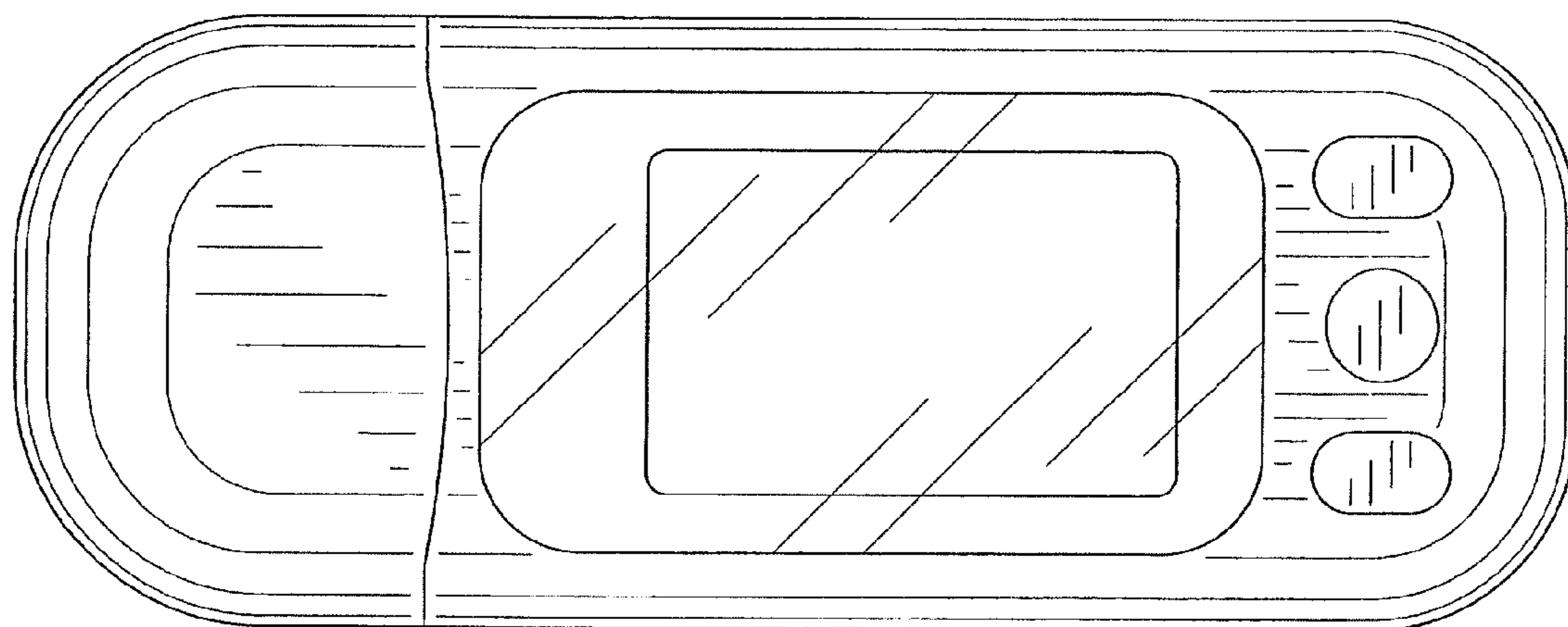

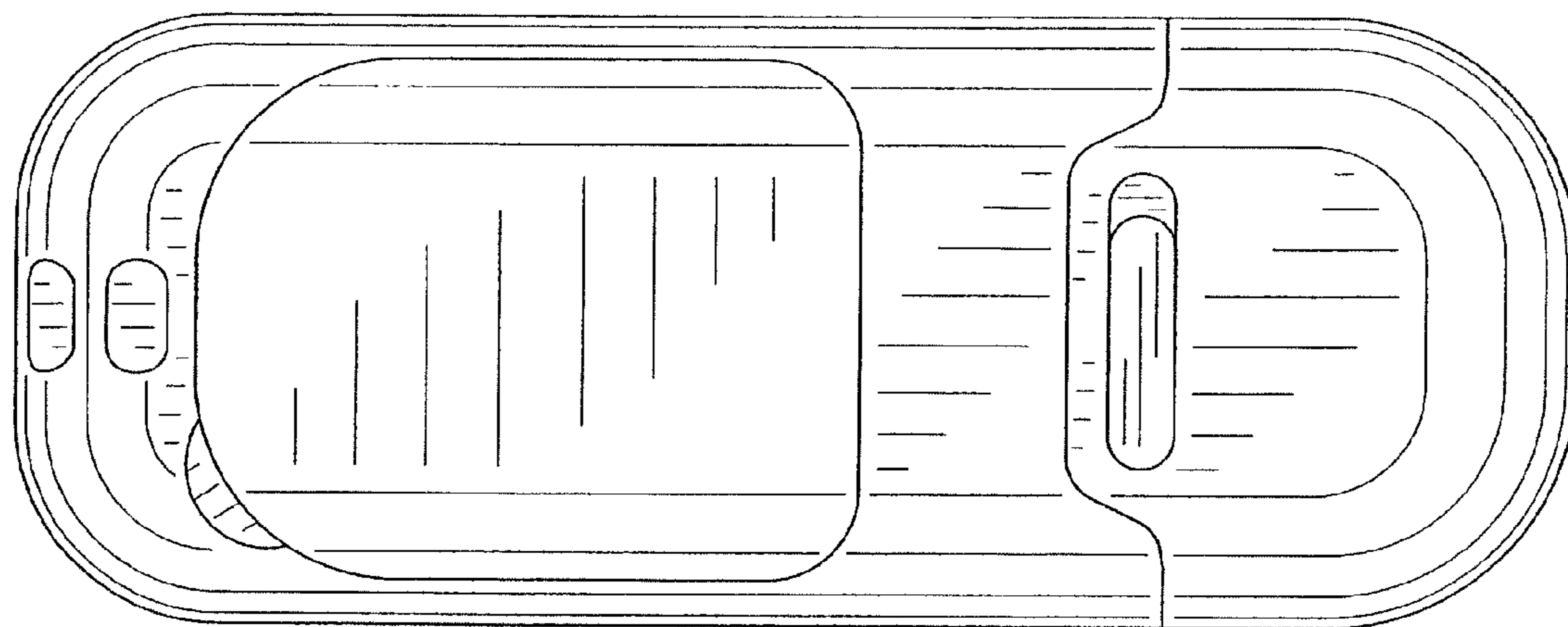

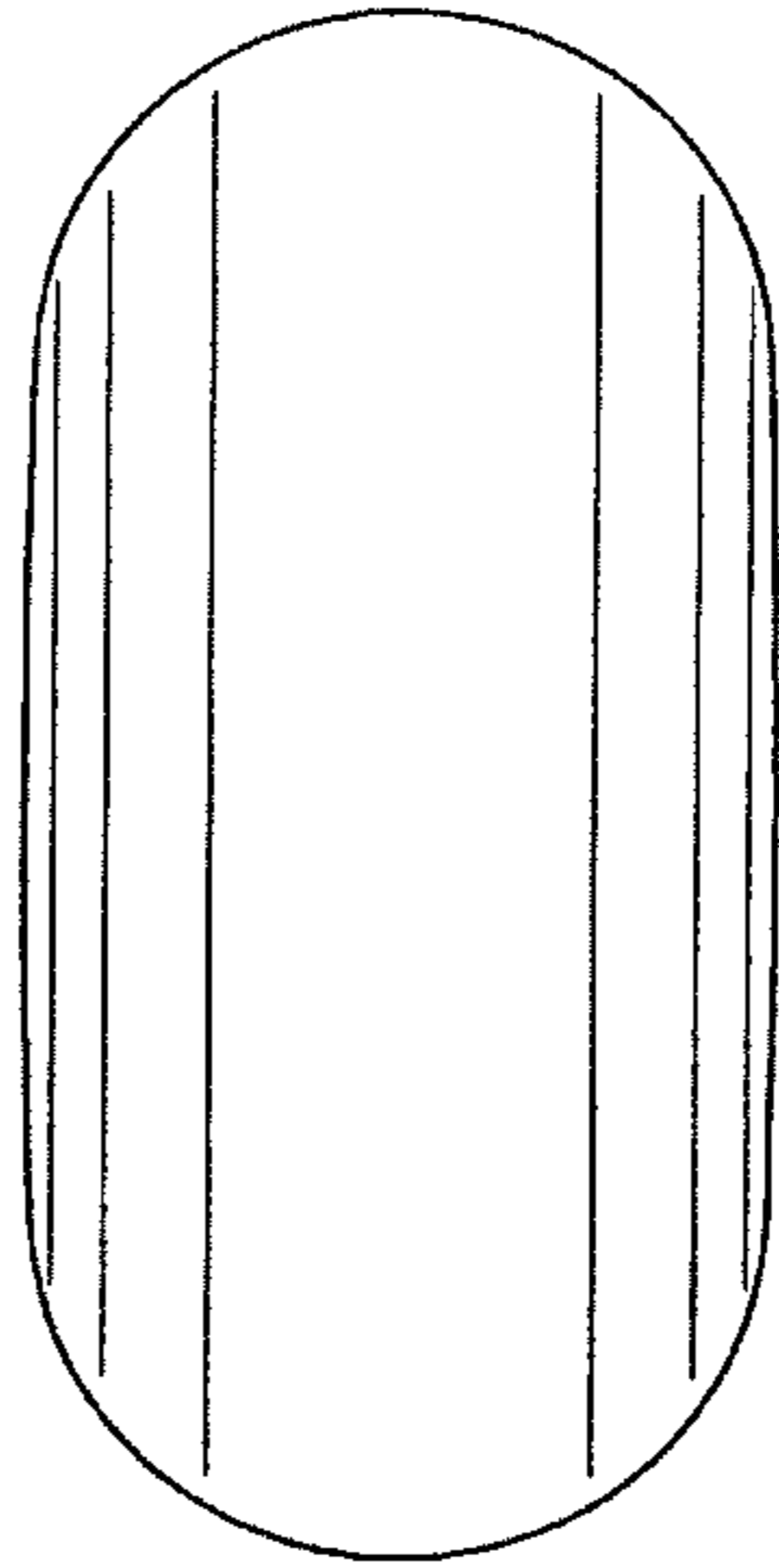

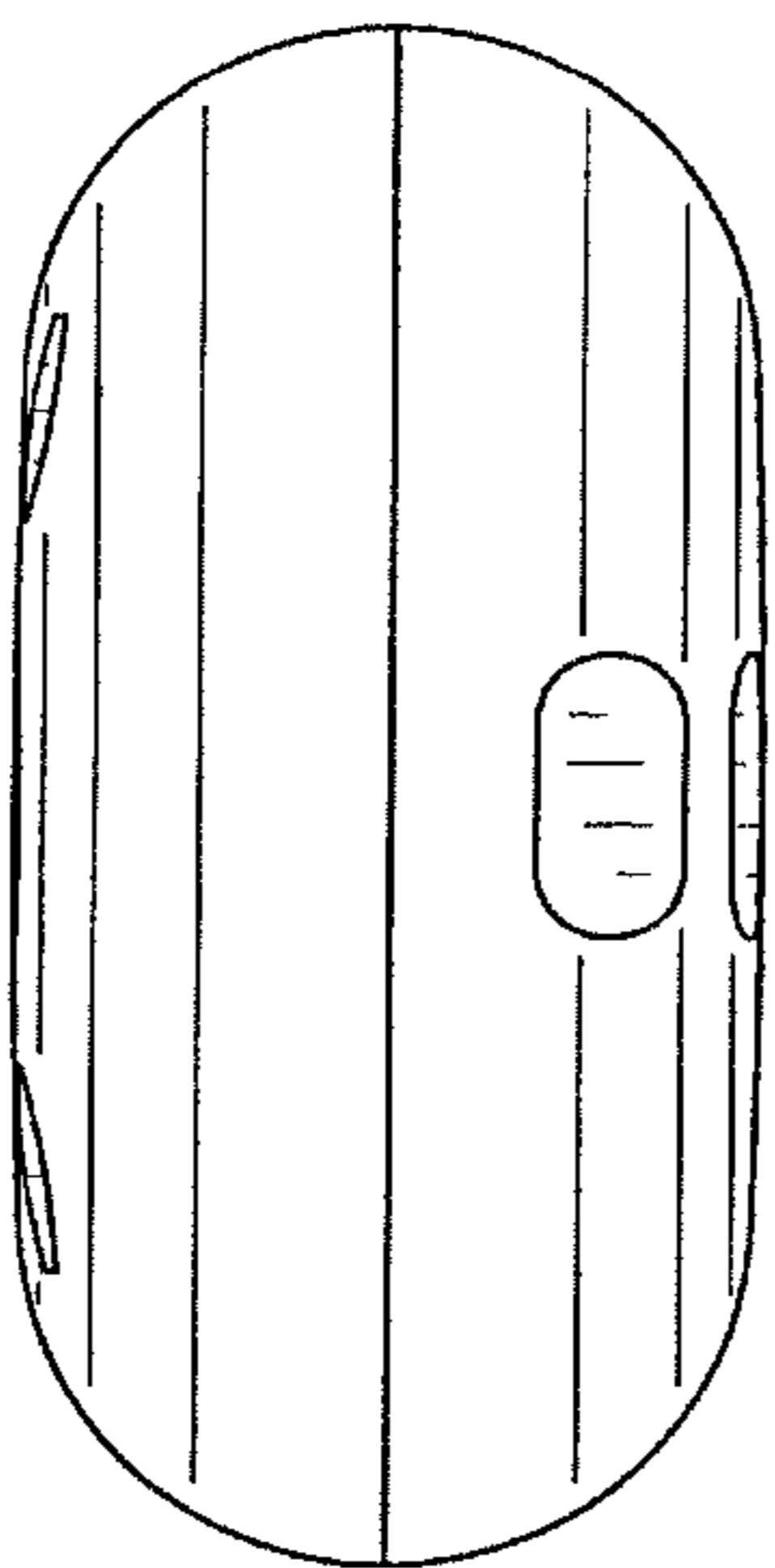

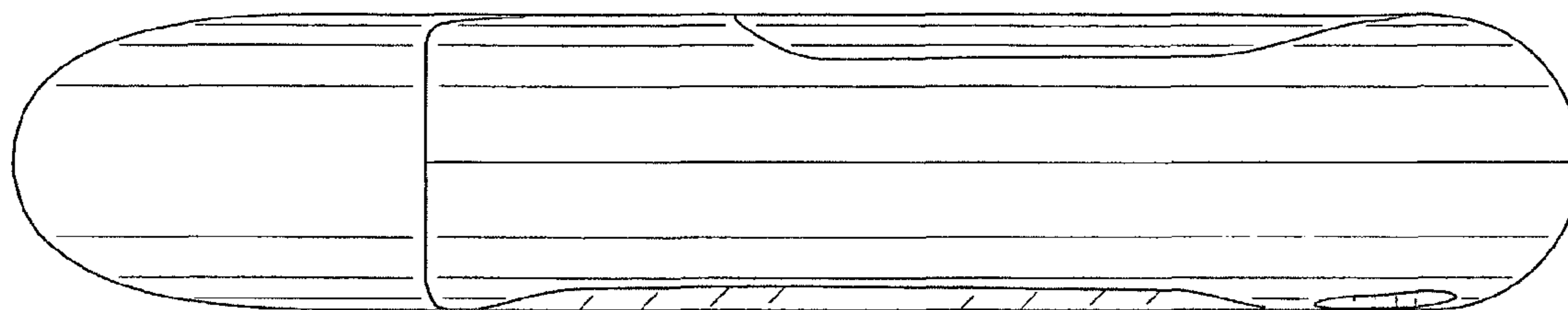

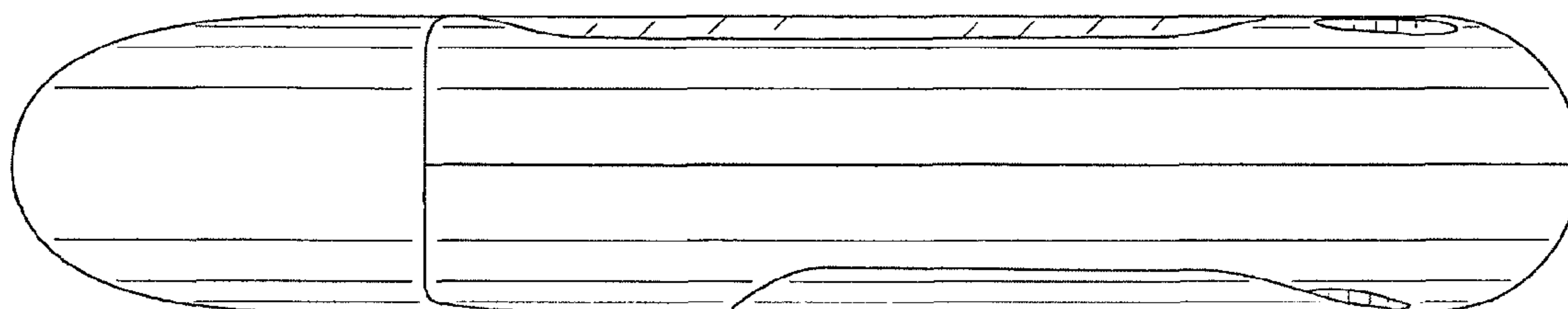

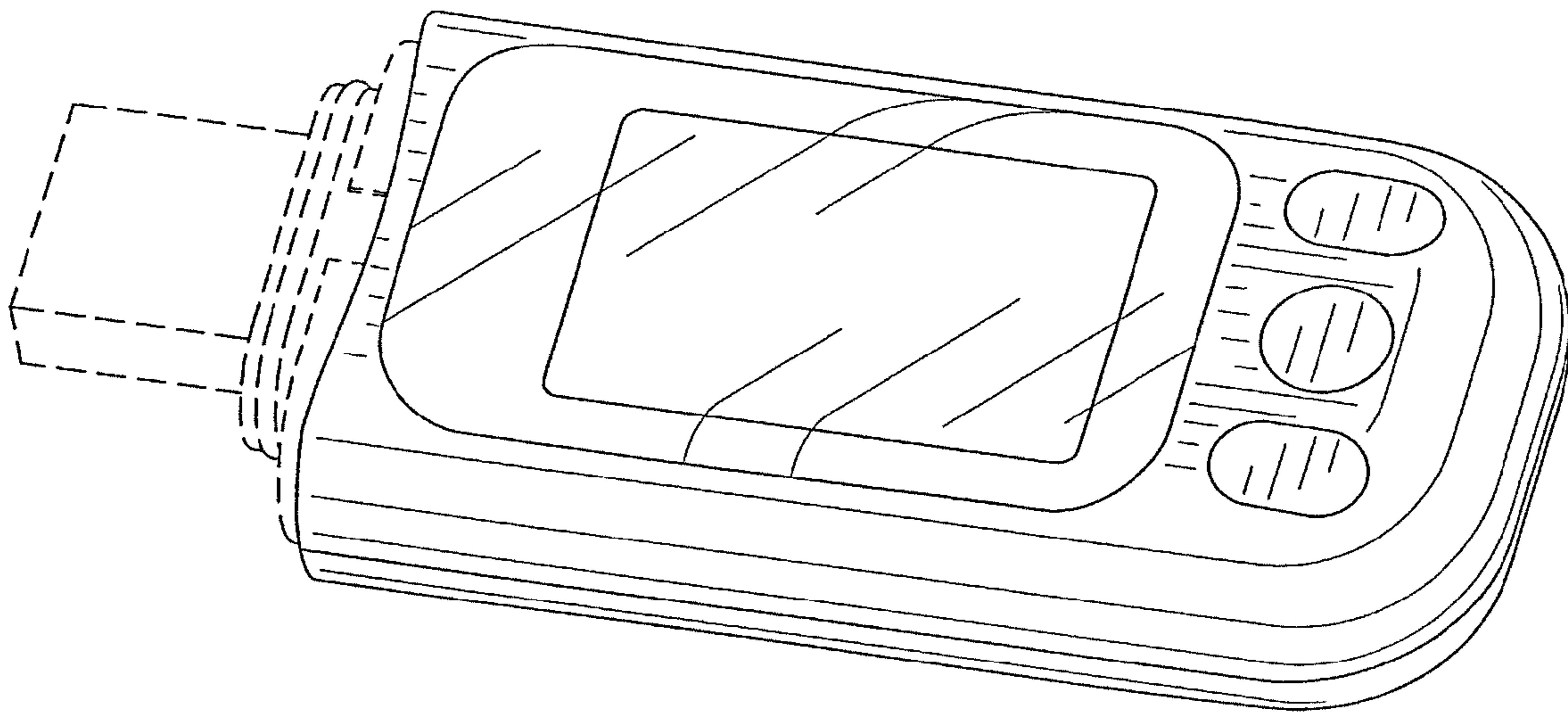

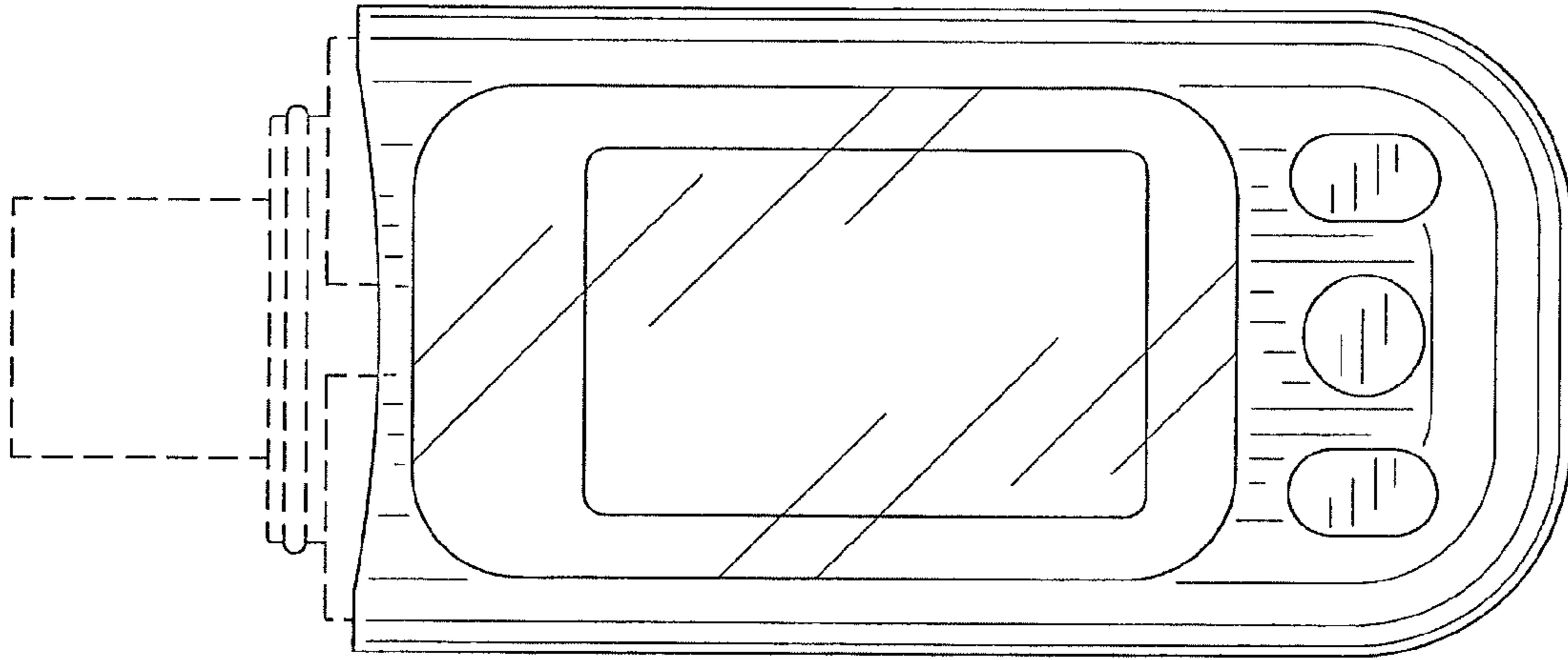

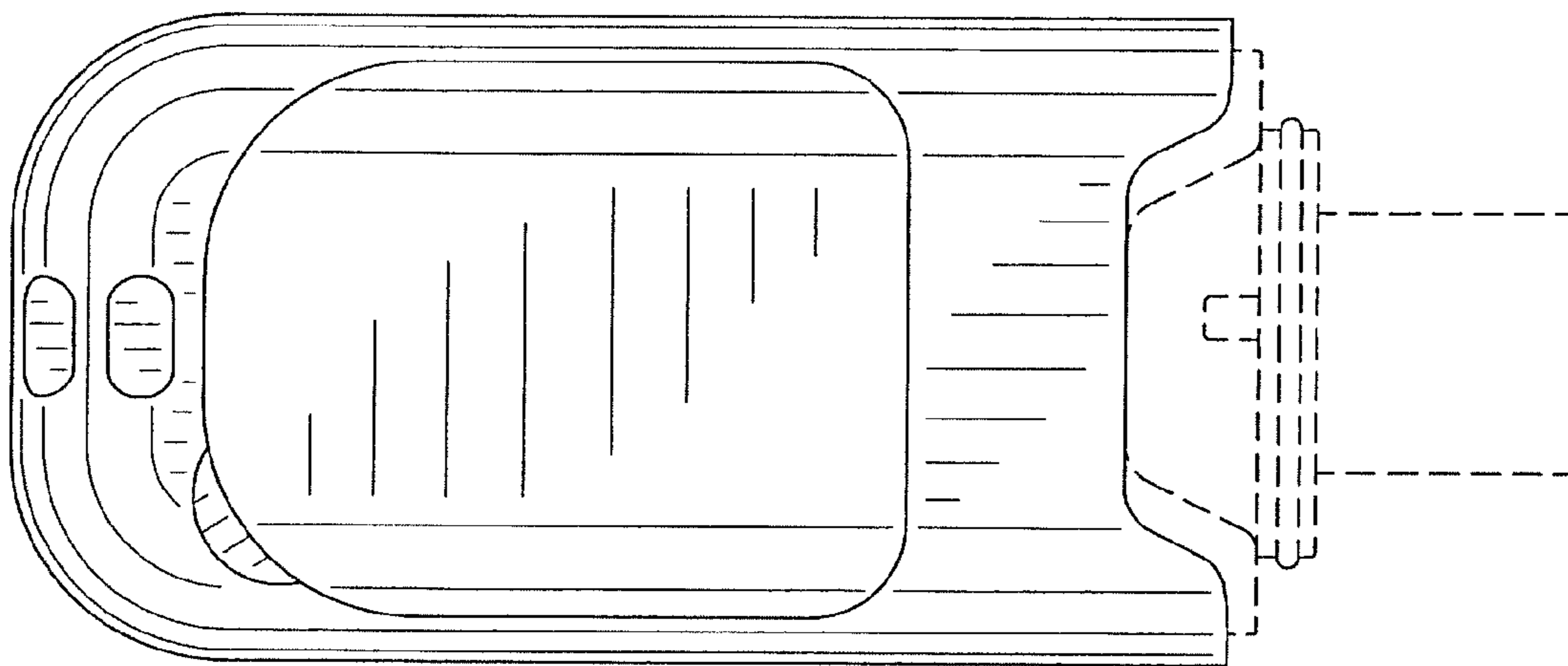

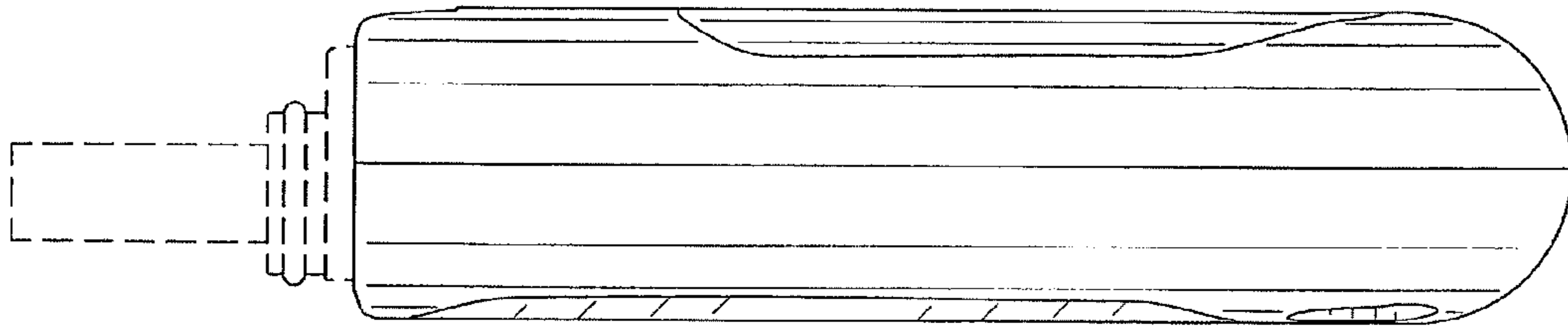

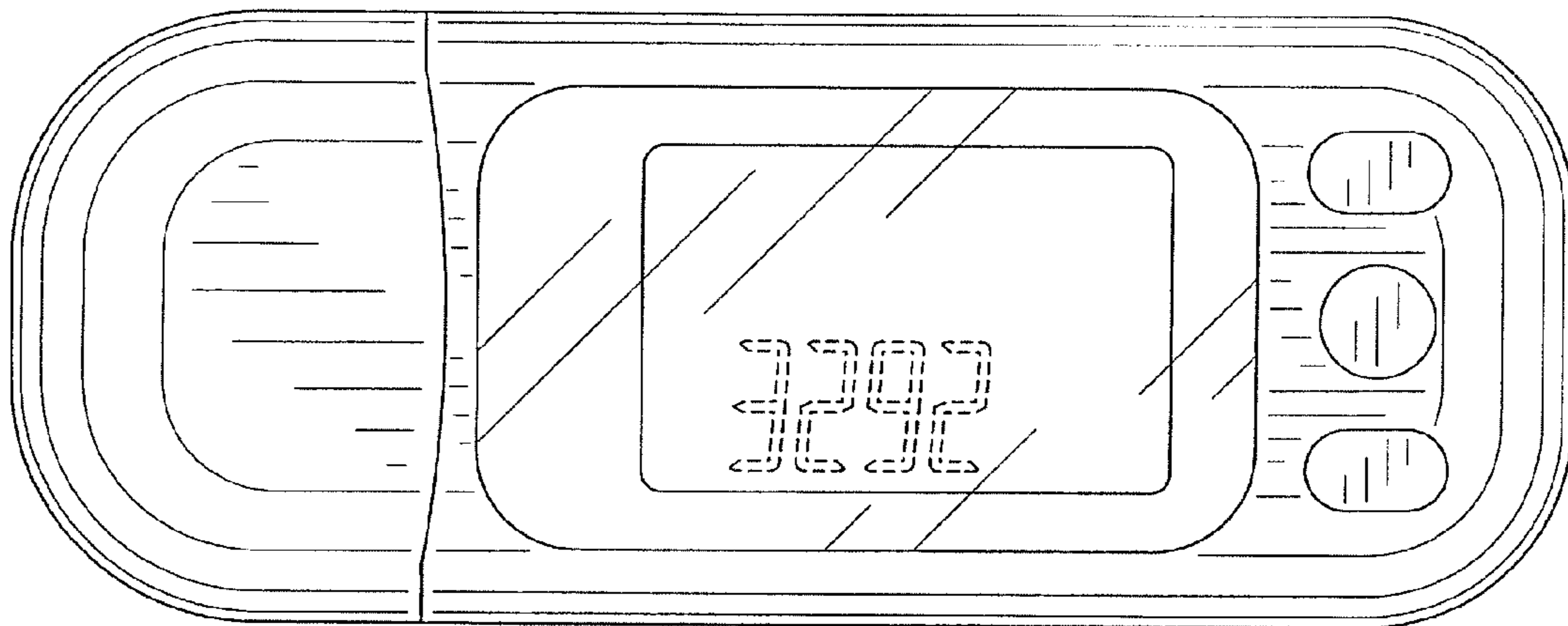
