**DESCRIPTION**

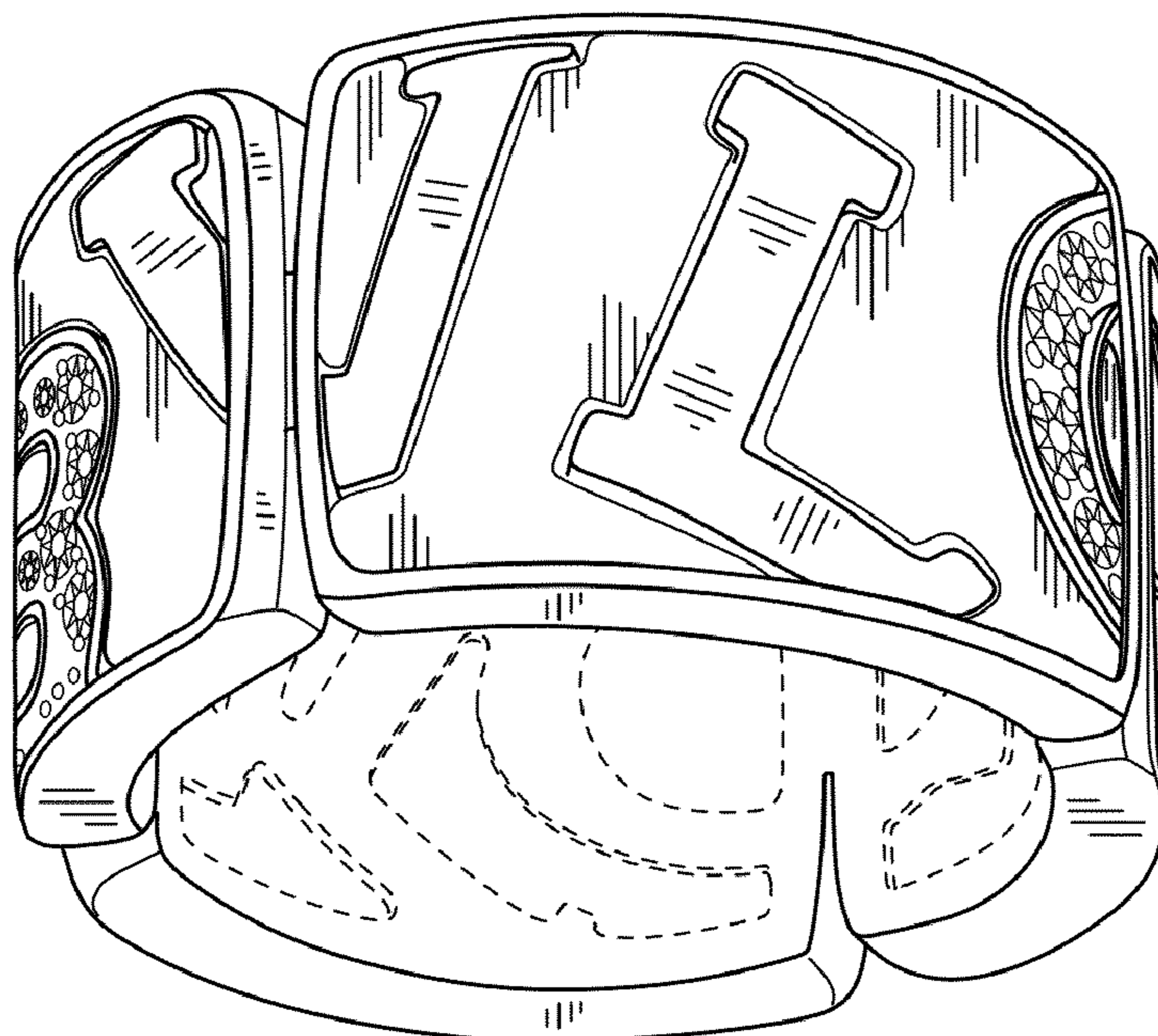
FIG. 1 shows a perspective view of the ring;

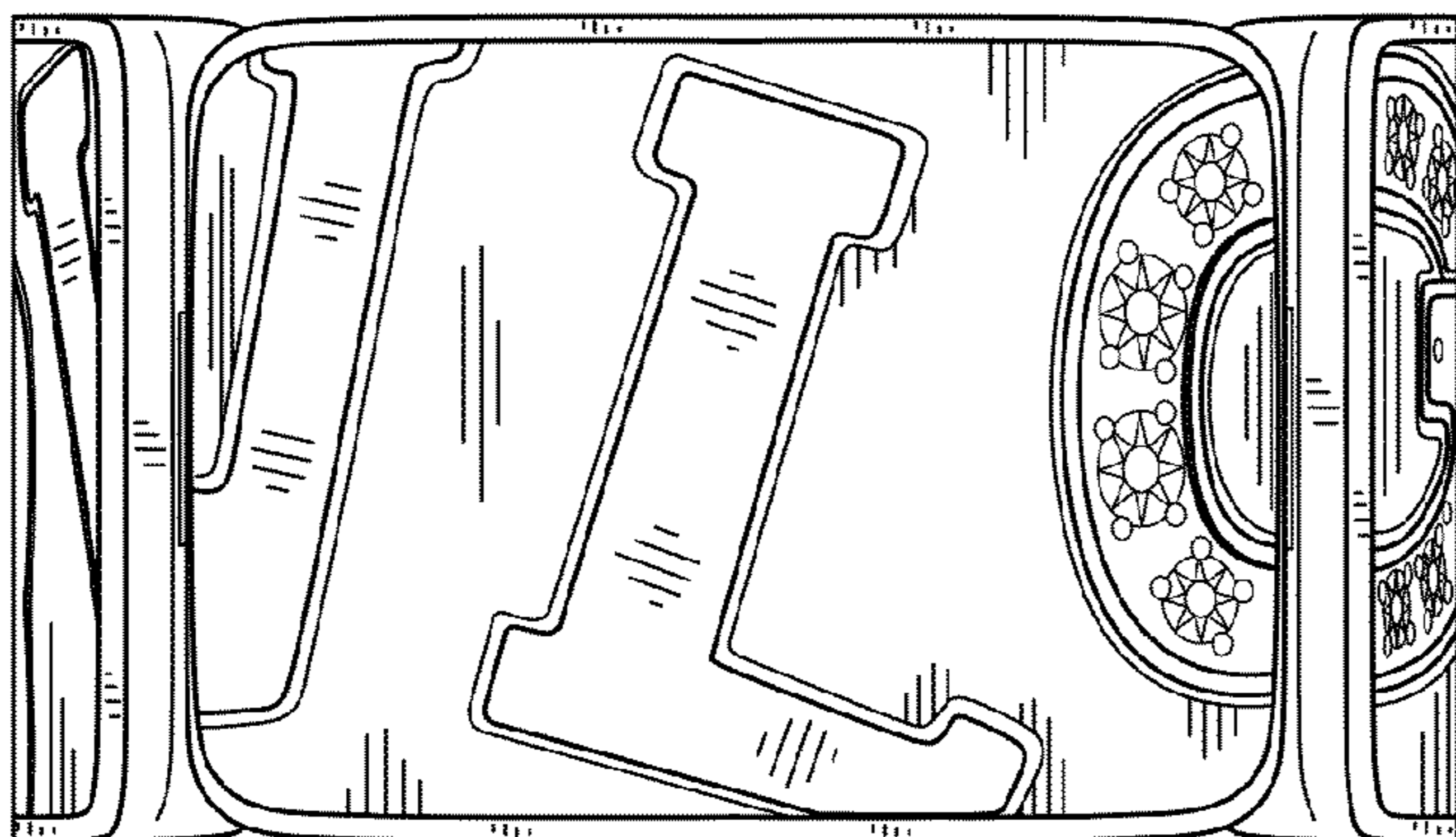
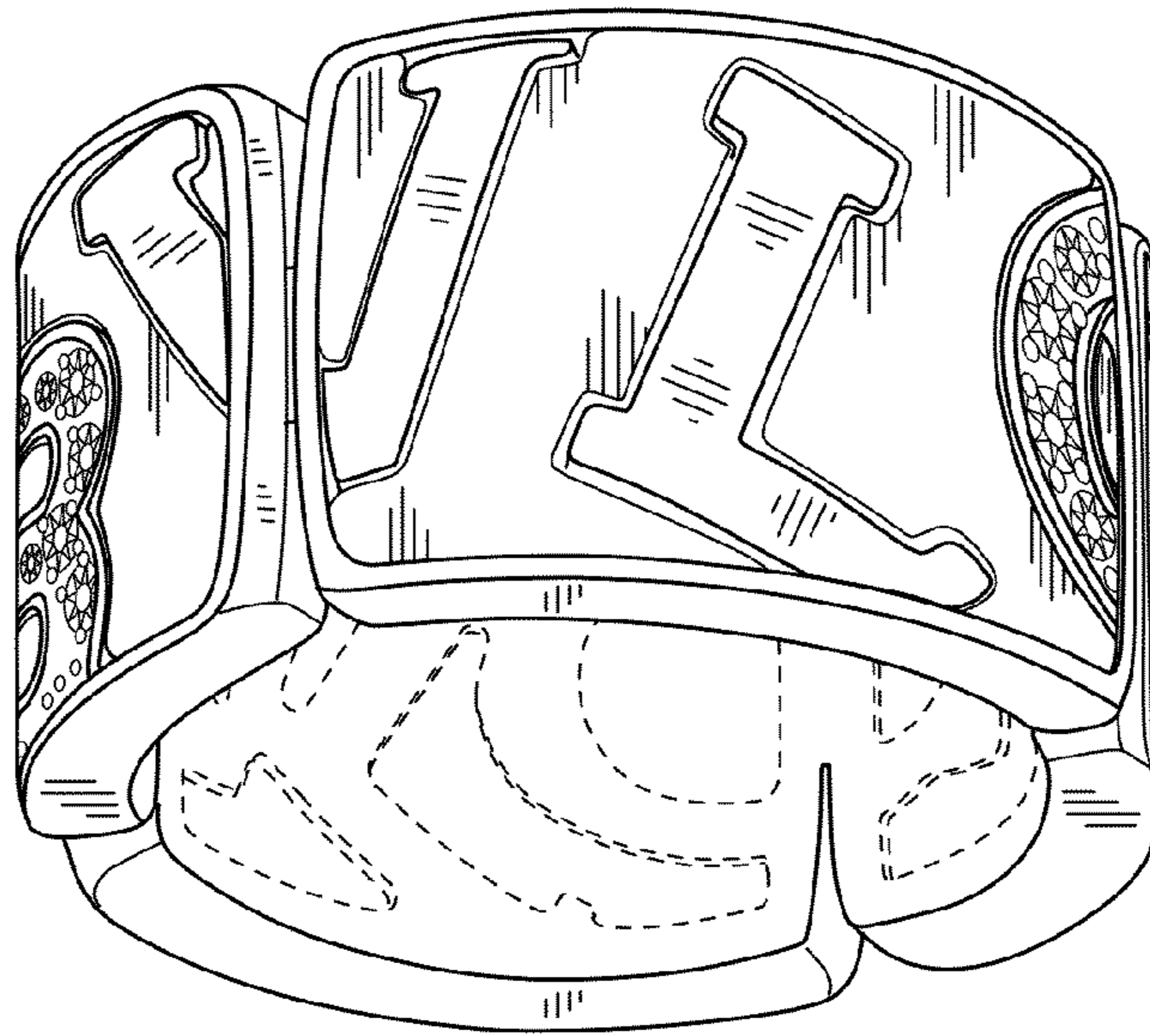

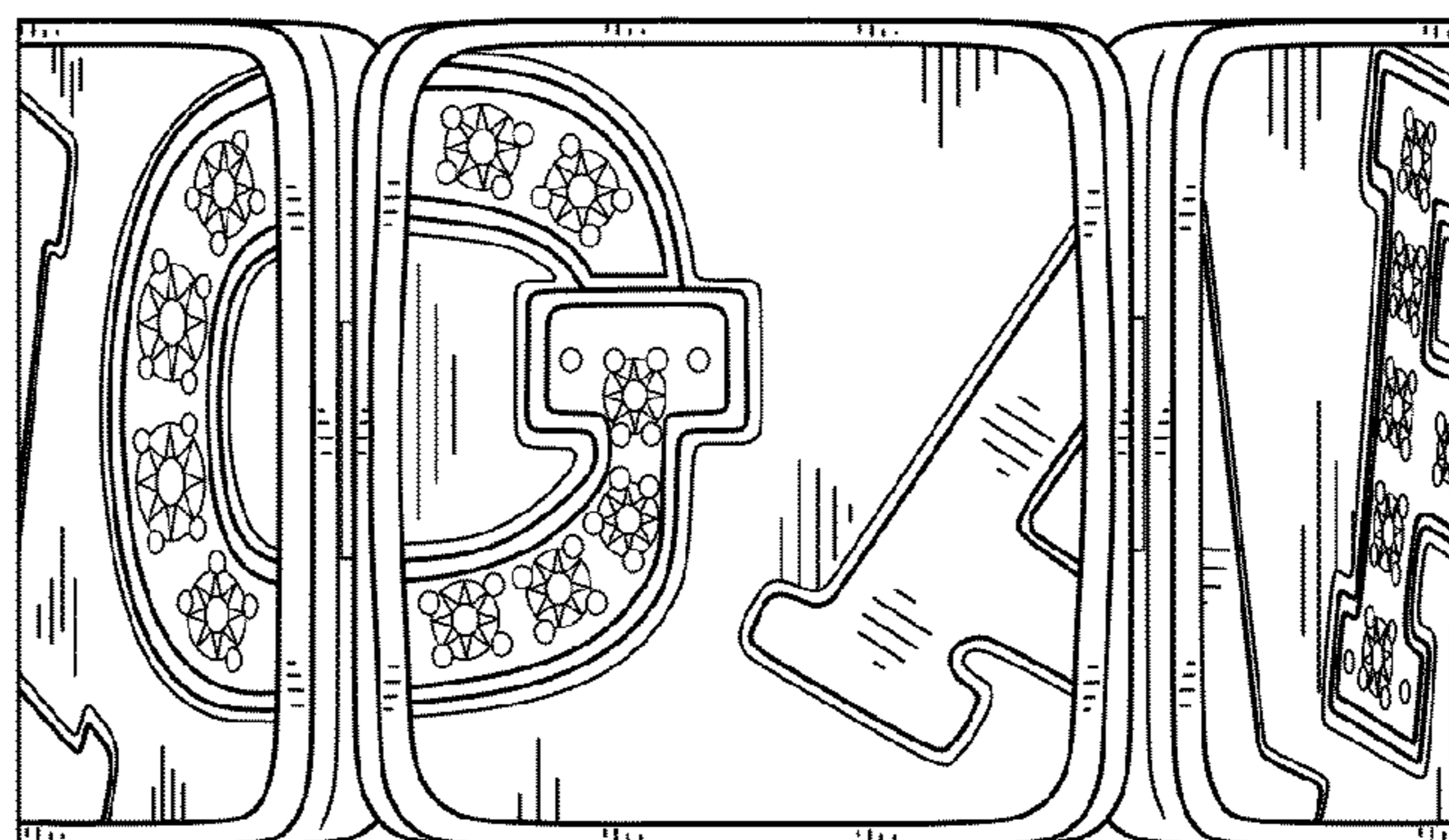

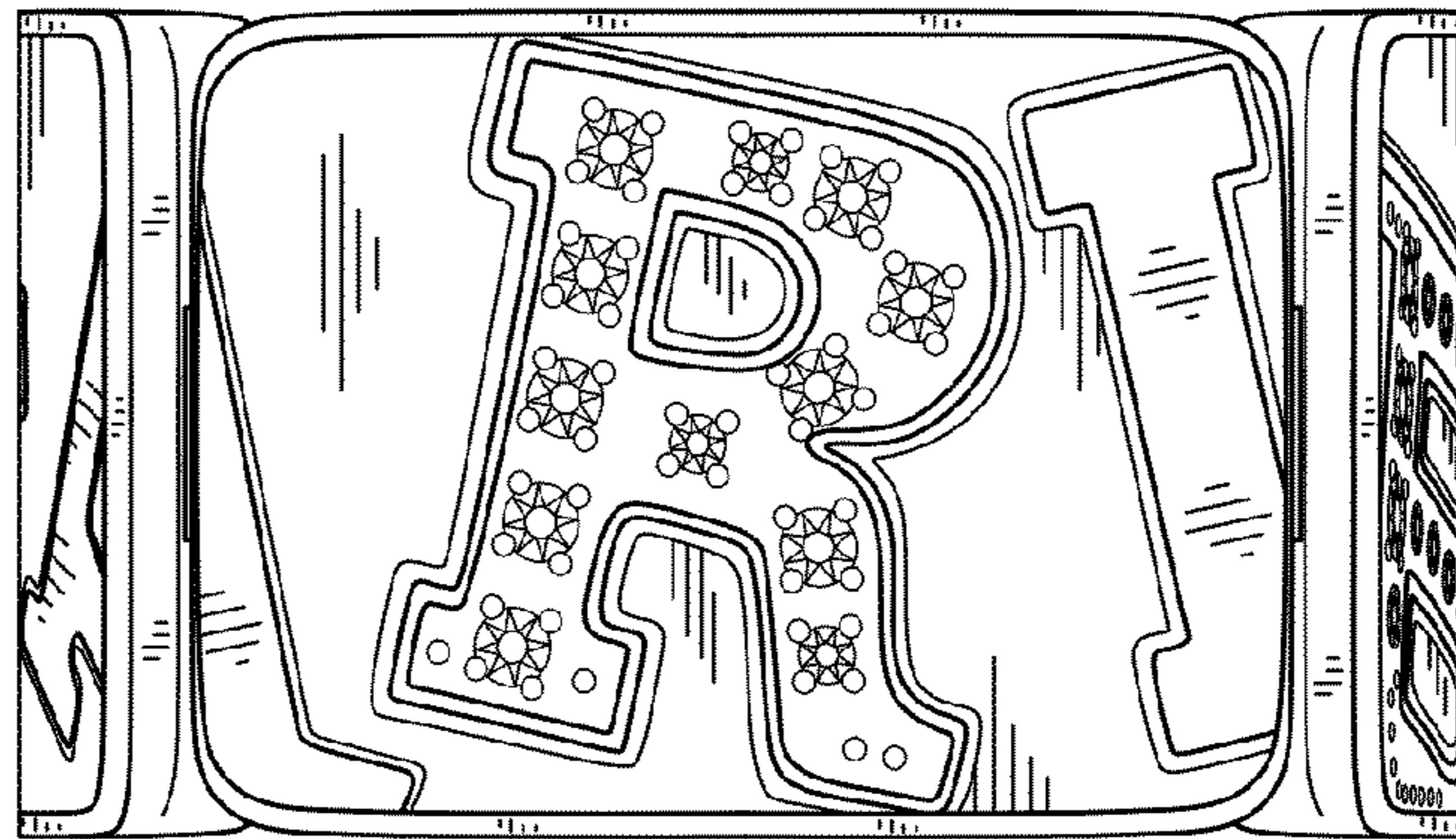

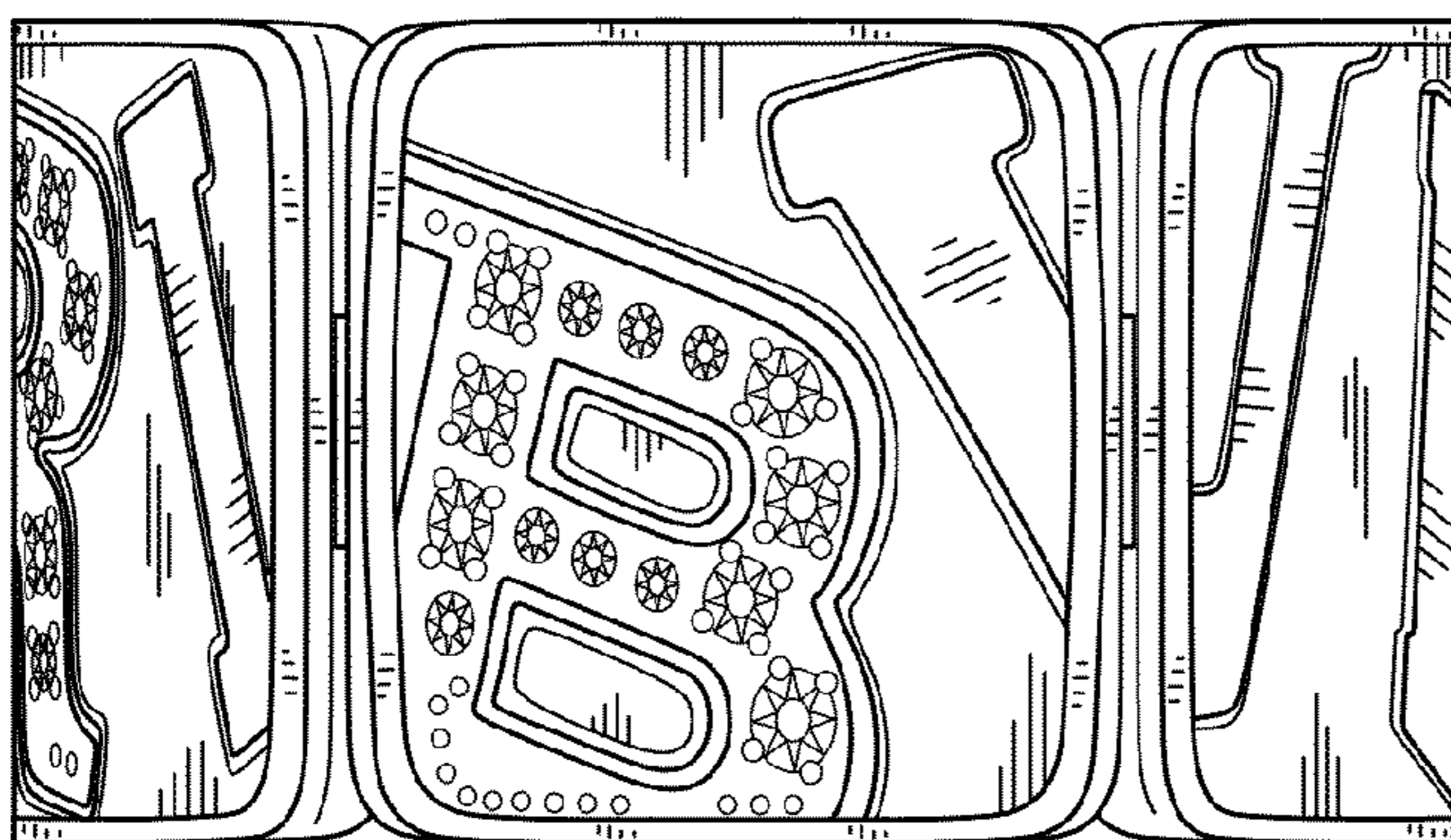

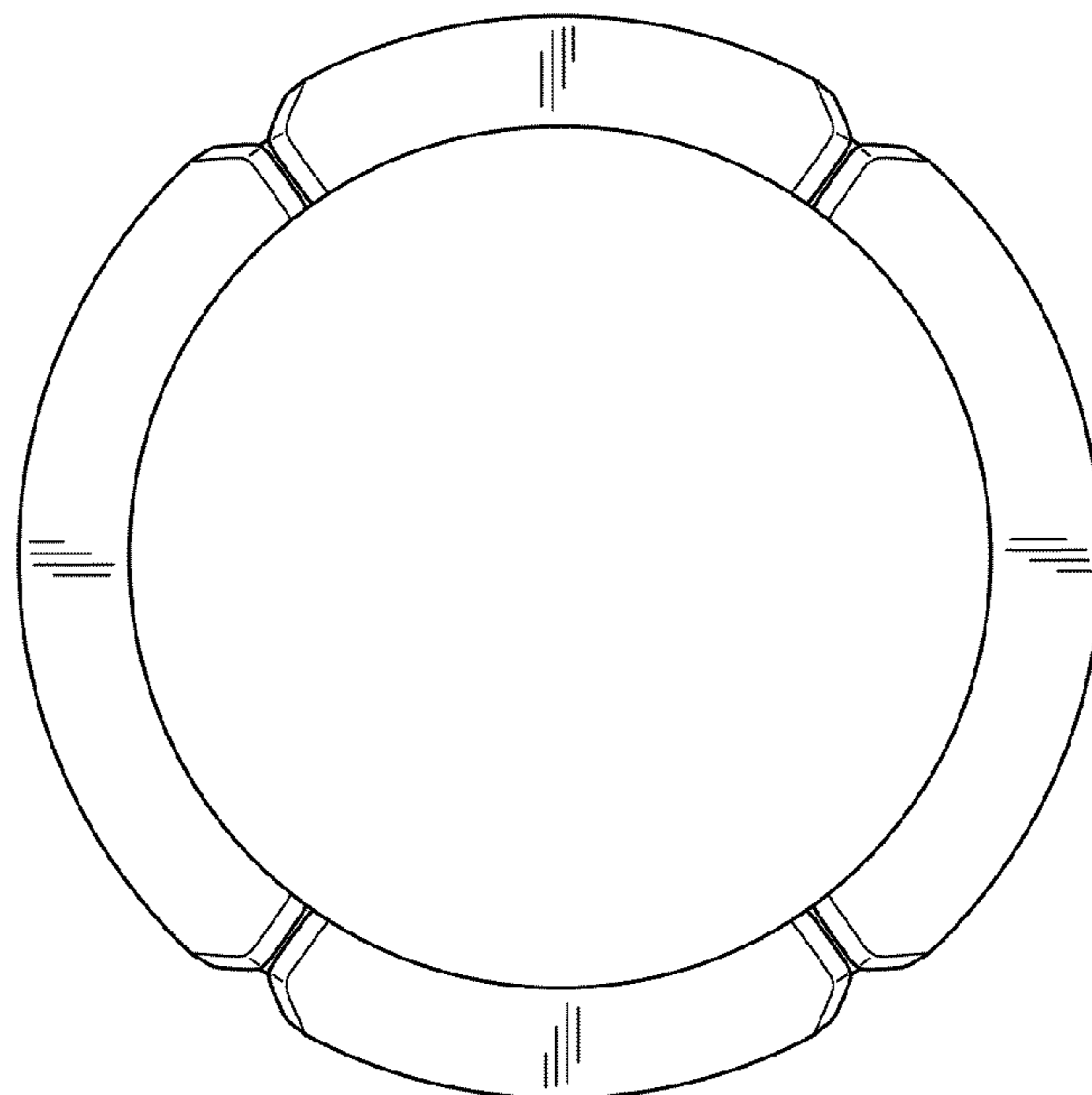
