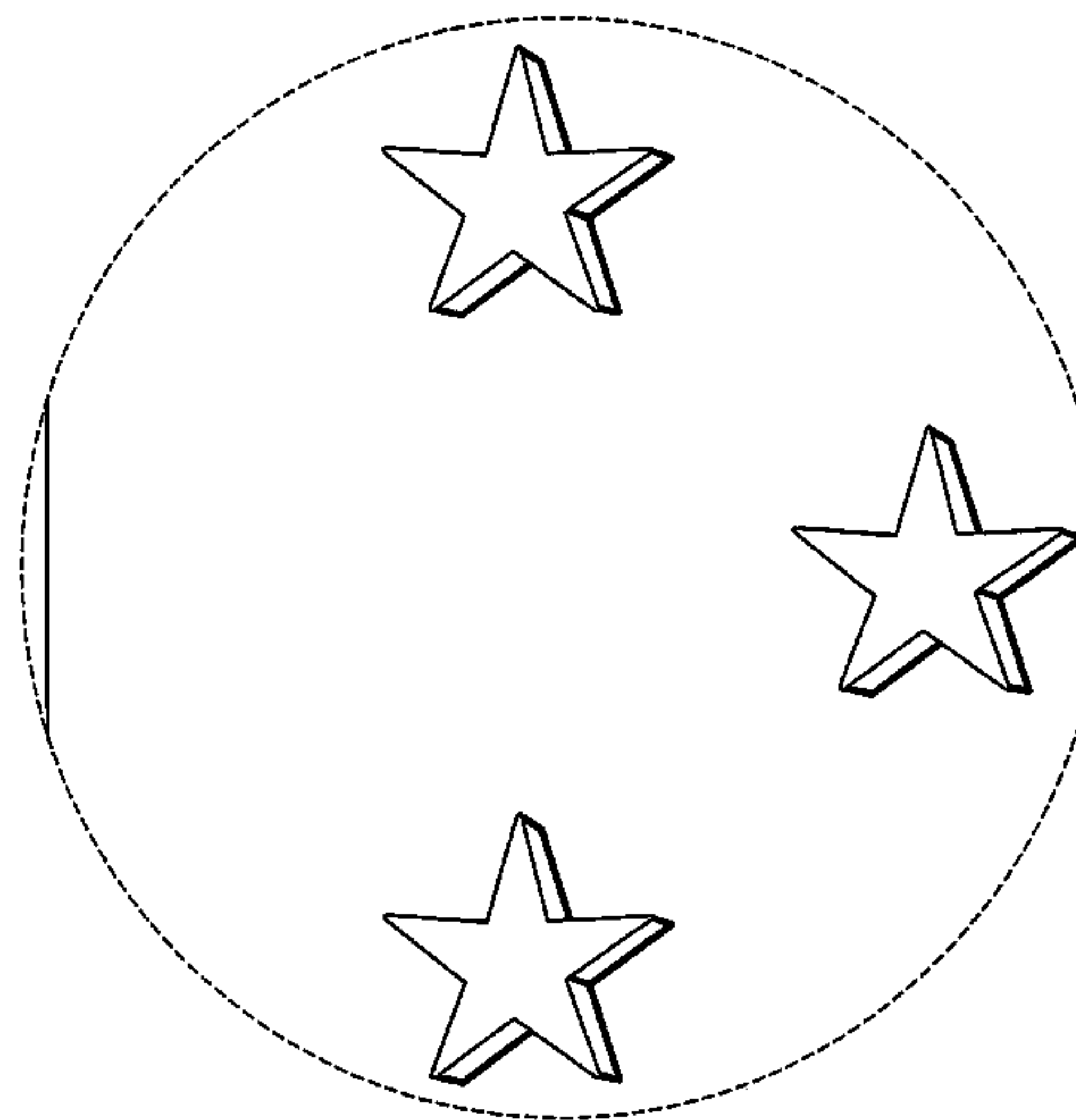
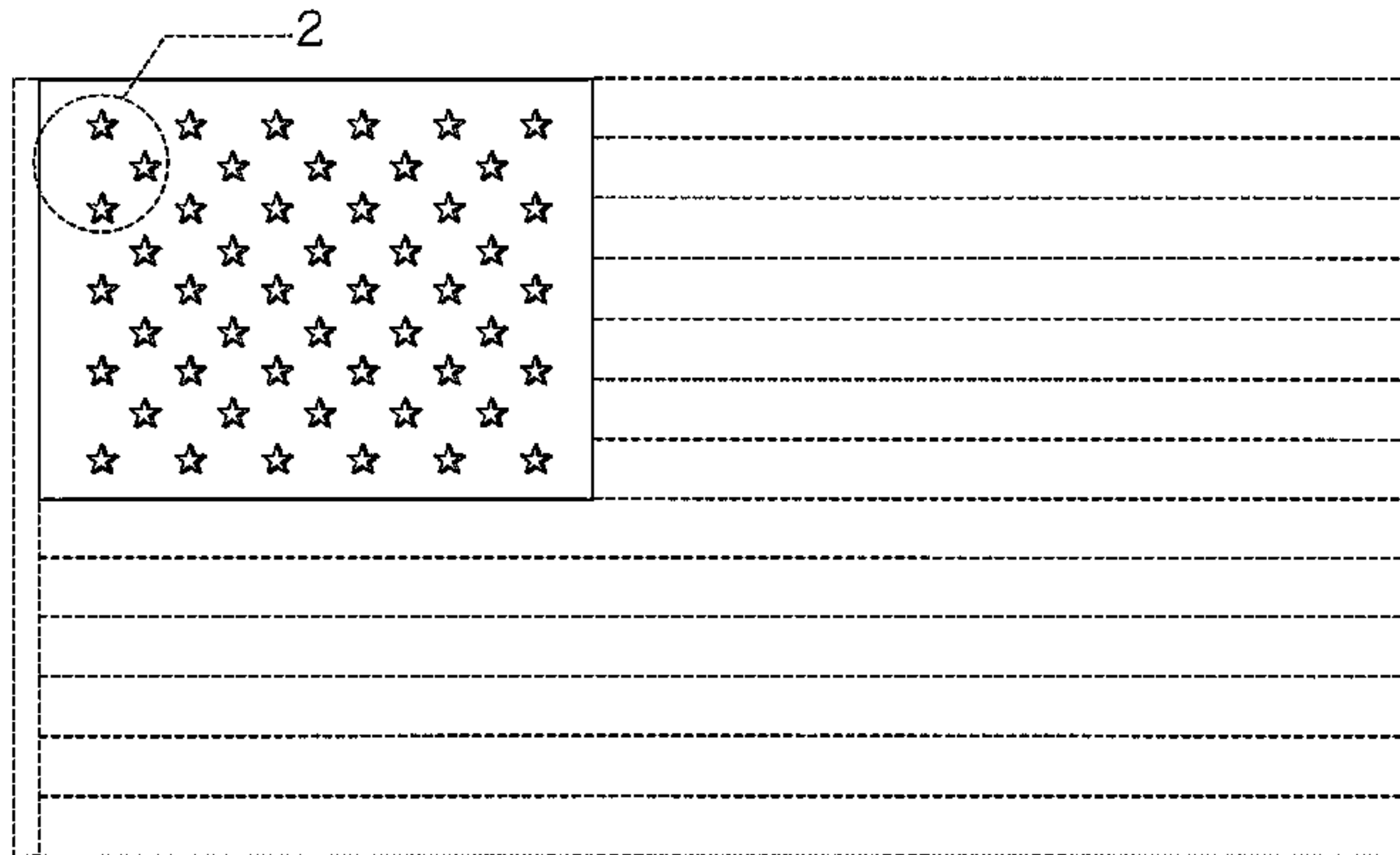
(57) **CLAIM**

I claim the ornamental design for a flag with three dimensional stars, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of a flag with three-dimensional stars according to my new design; FIG. 2 is an enlarged detail of the area marked 2 on FIG. 1; FIG. 3 is a second embodiment of the flag with three-dimensional stars. The star features are lined for color; and, FIG. 4 is an enlarged detail of the area marked 4 on FIG. 3. The broken lines in the drawings represent environmental subject matter that forms no part of the claimed design.

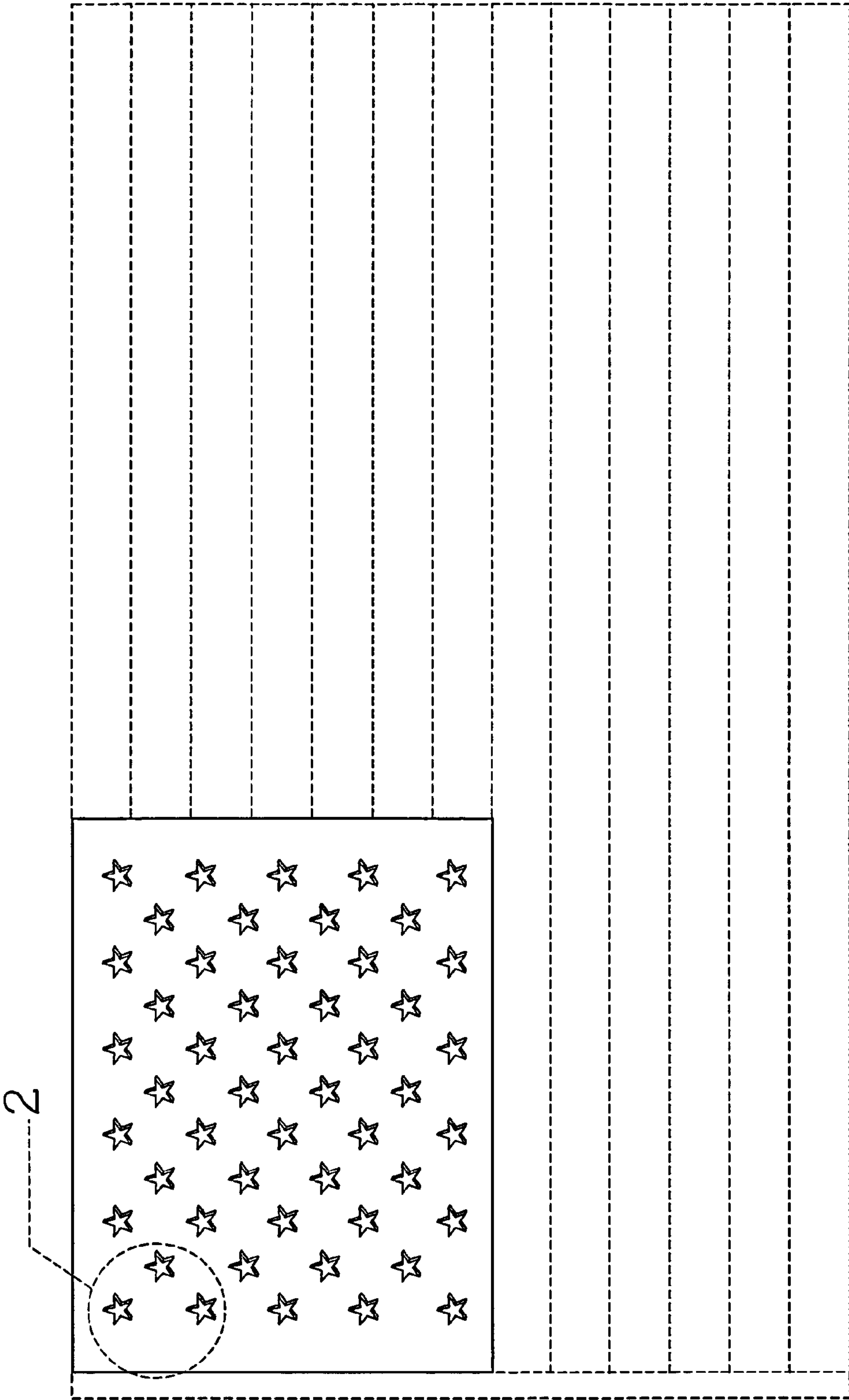
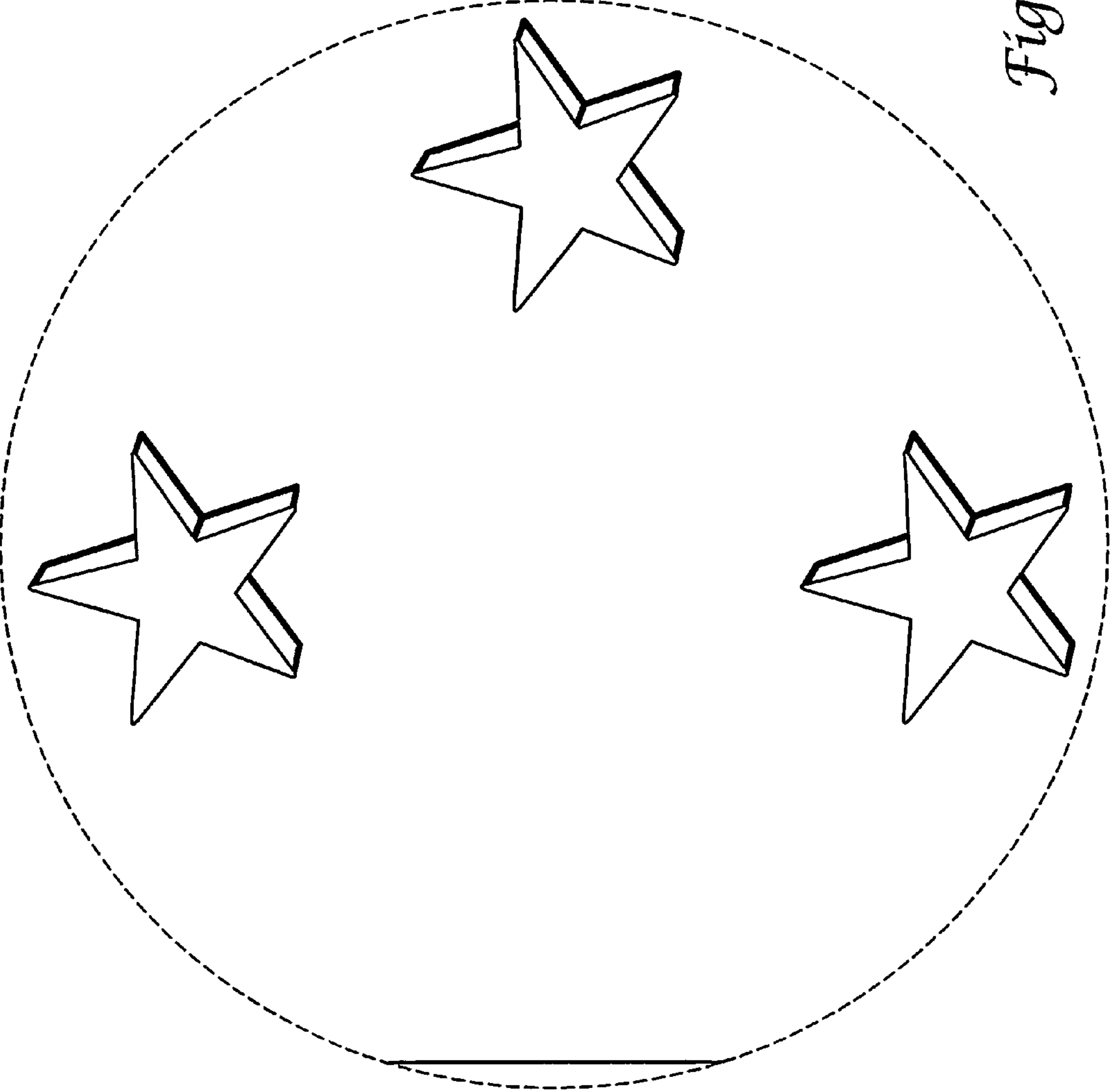

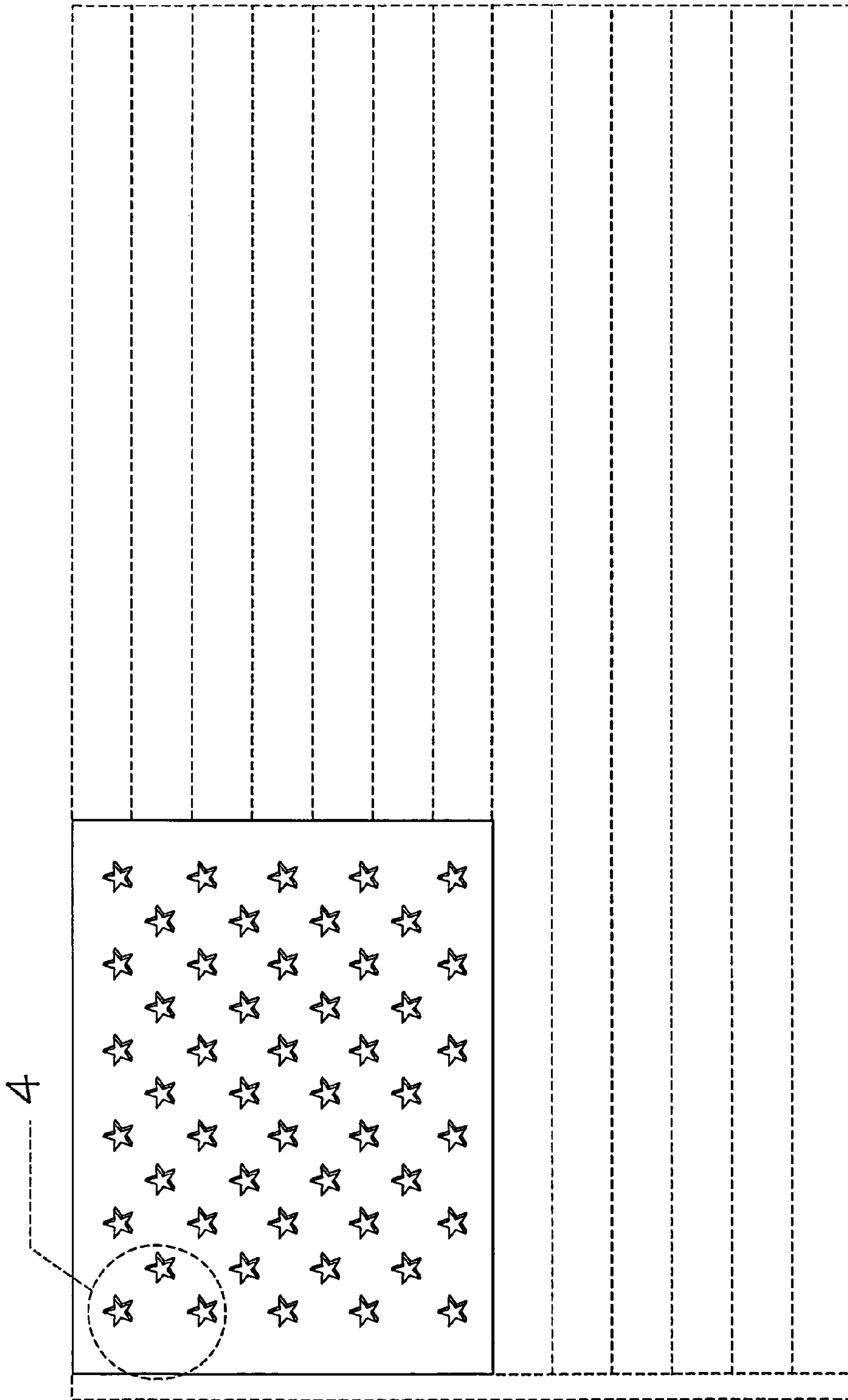
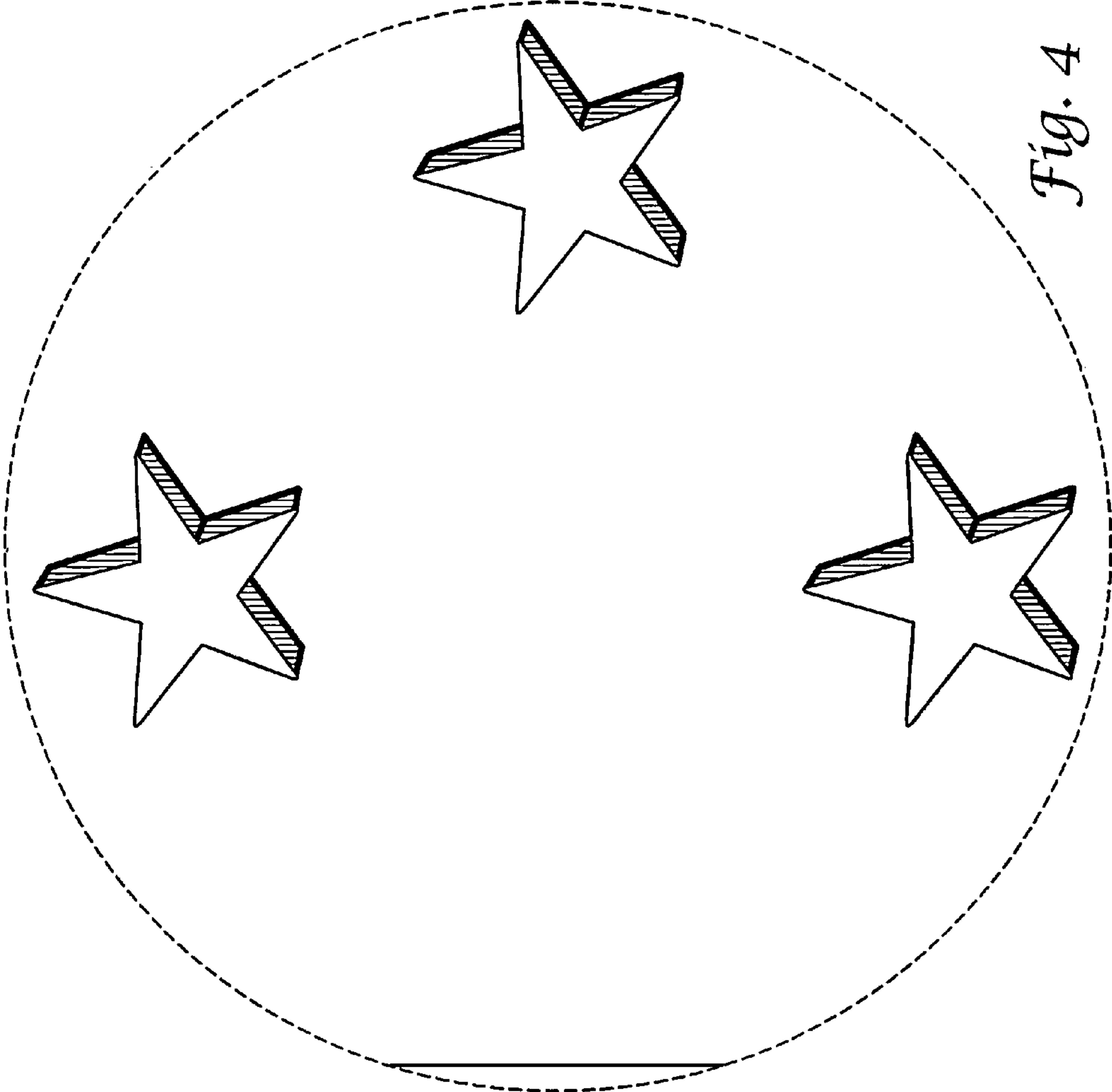
