The ornamental design for a cover for telephonic earpiece, as shown and described.

DESCRIPTION

FIG. 1 is a perspective bottom view of a cover for telephonic earpiece, showing our new design; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a top view thereof; and, FIG. 7 is a bottom view thereof.

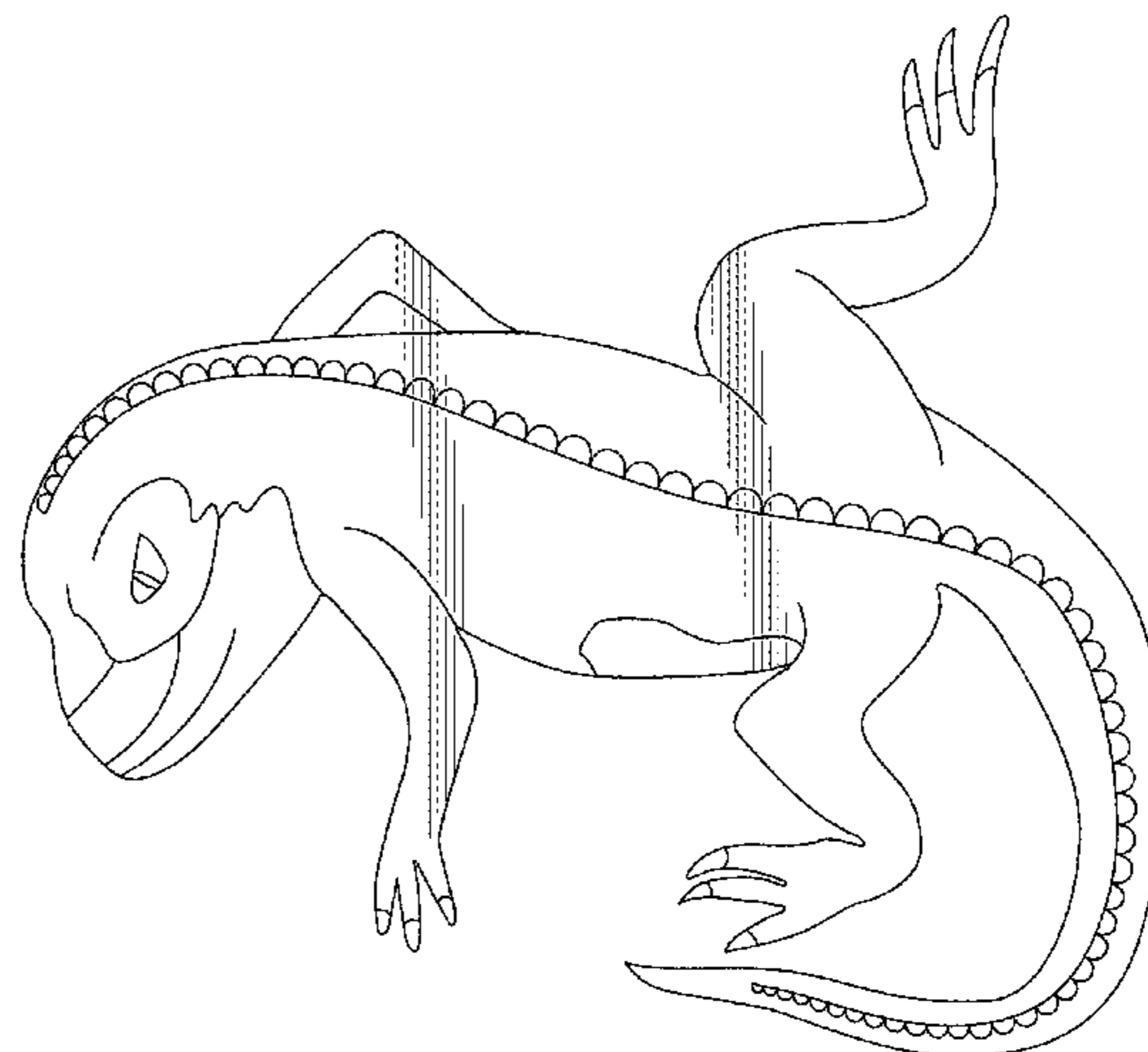
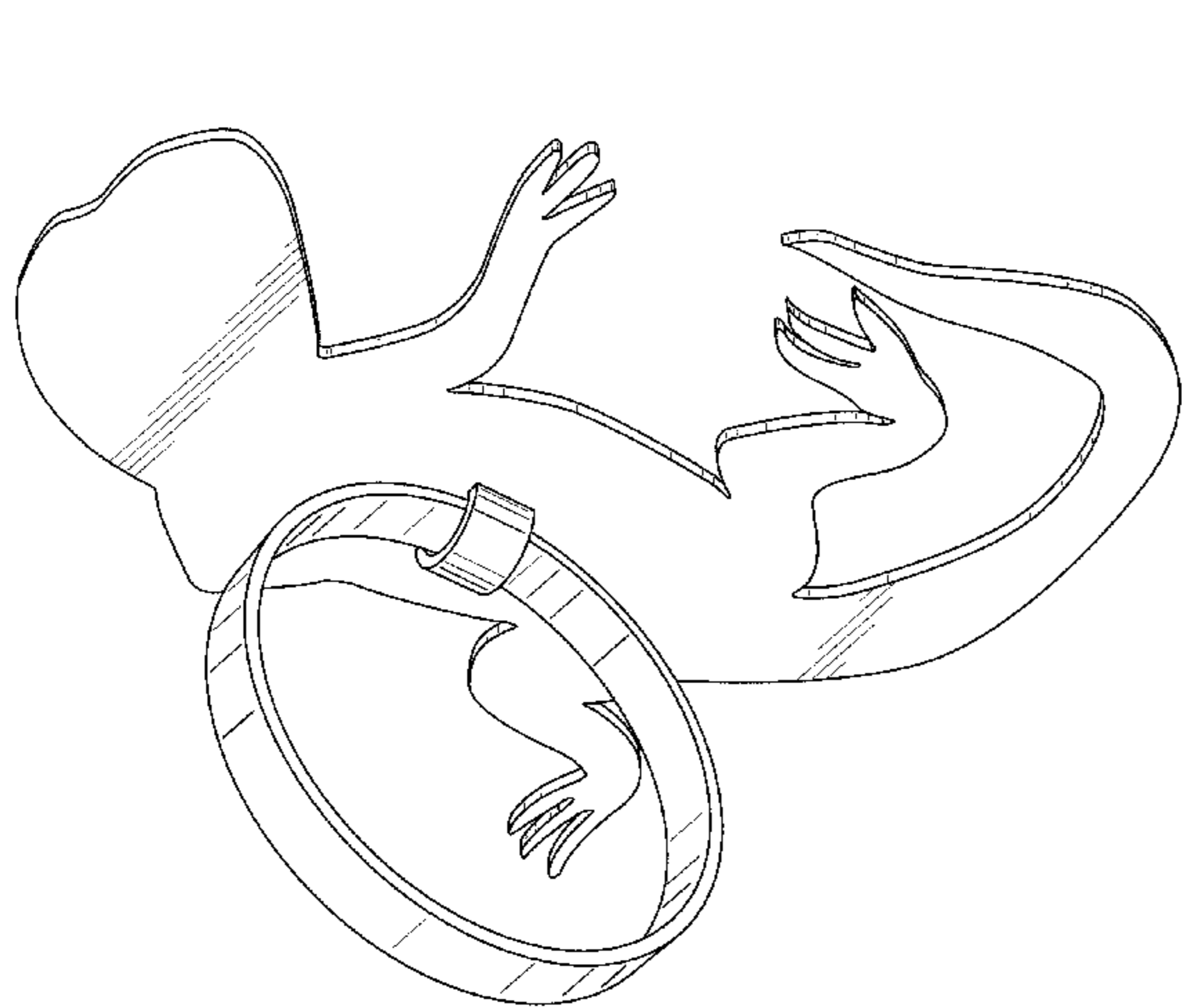

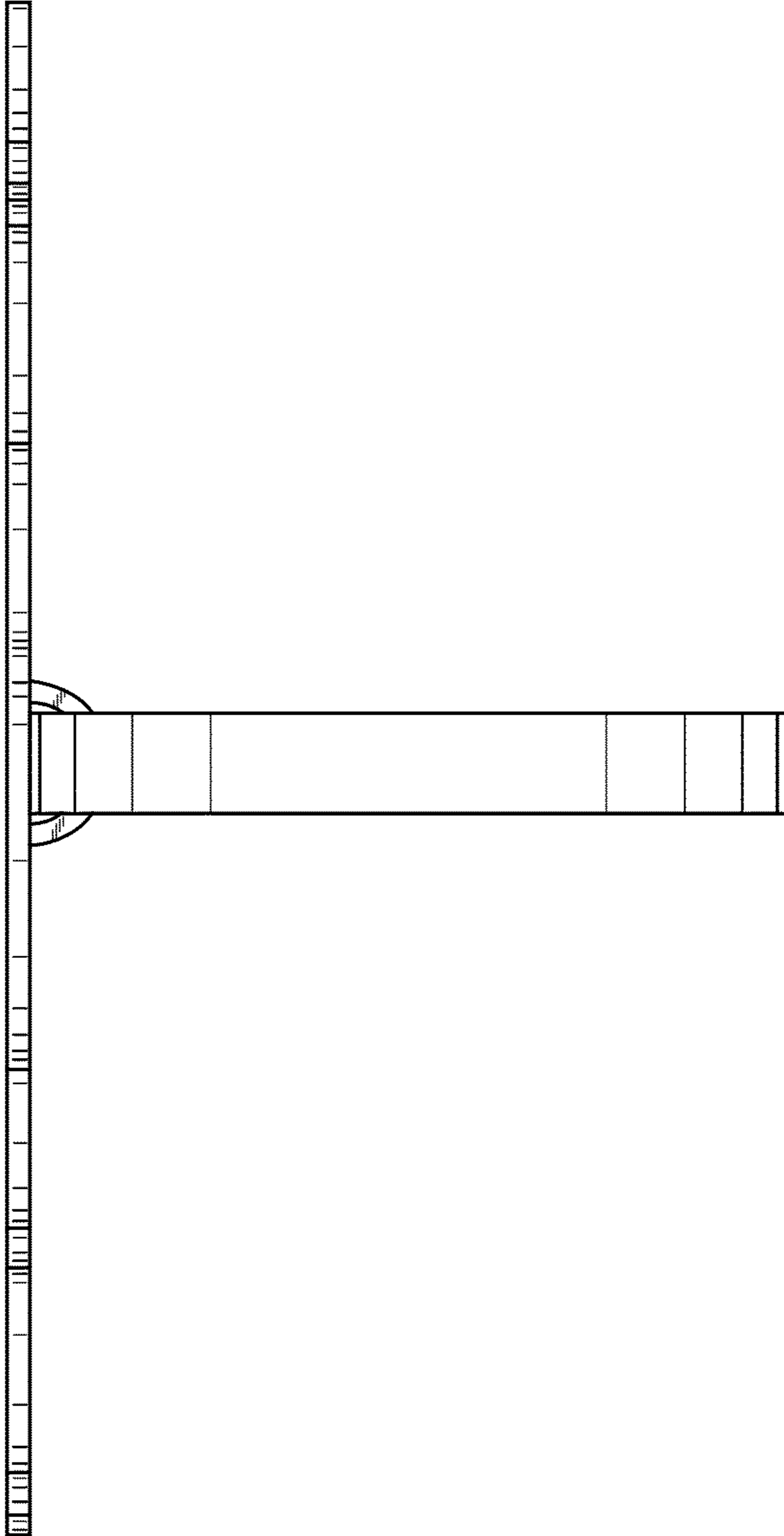

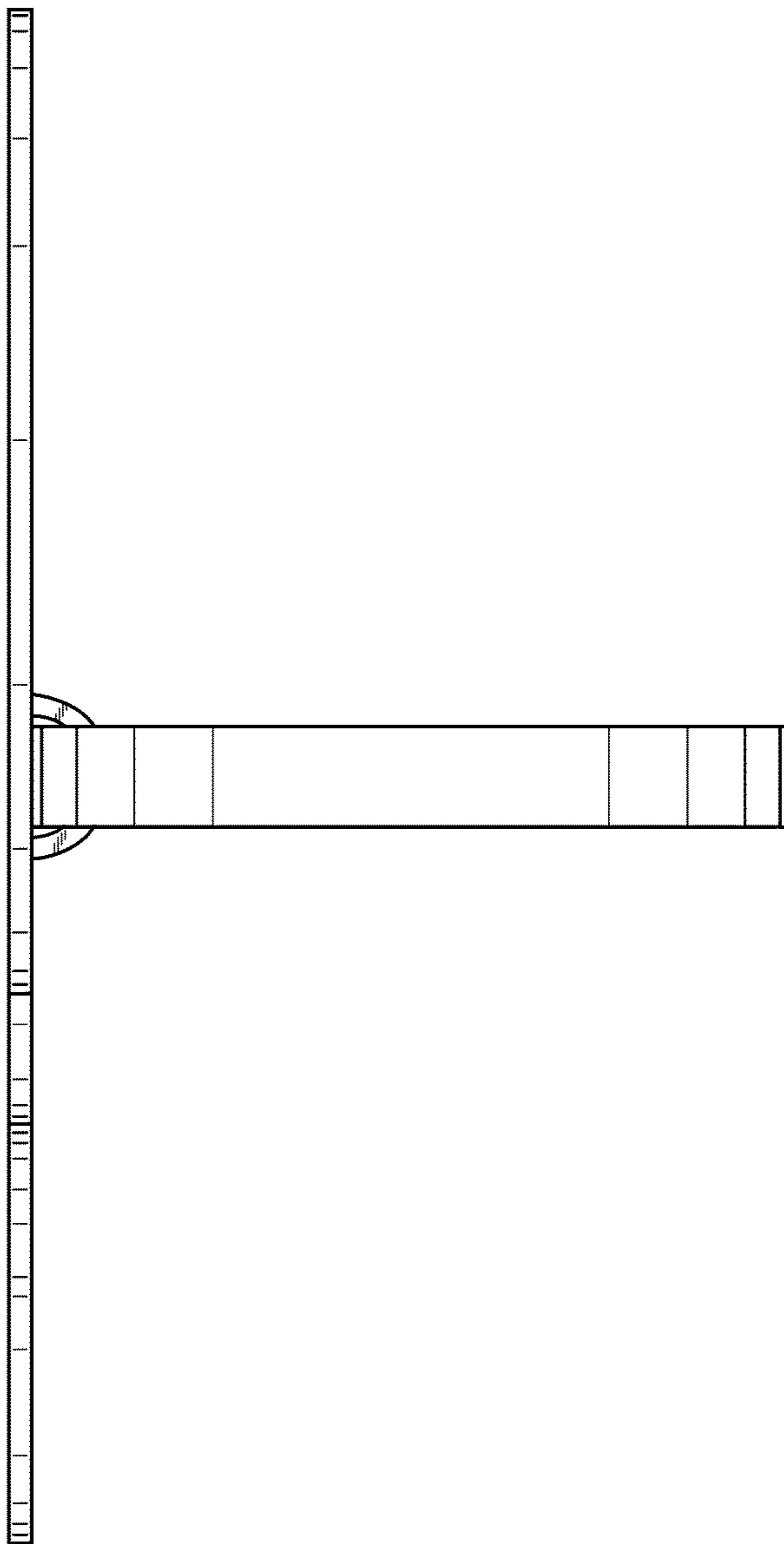

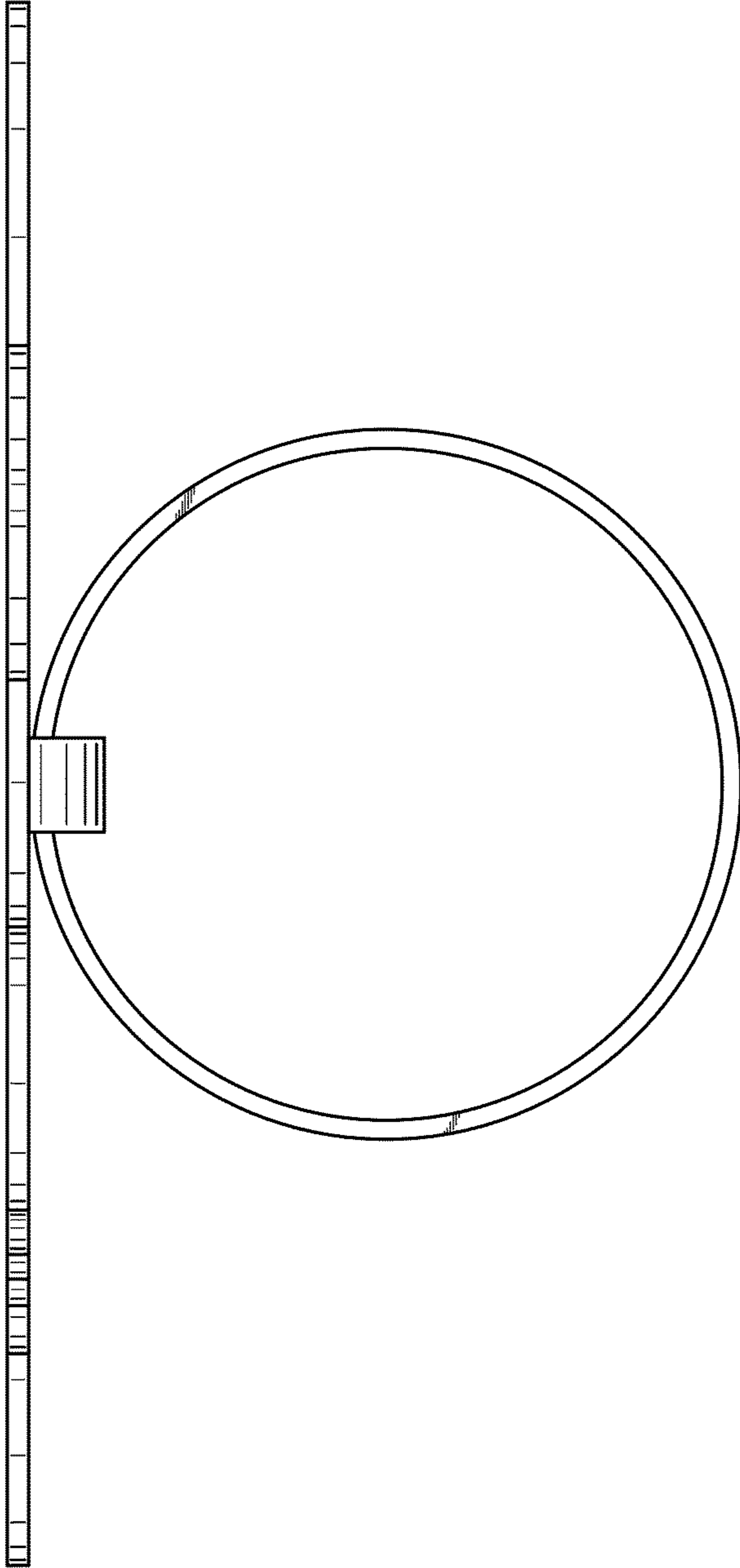

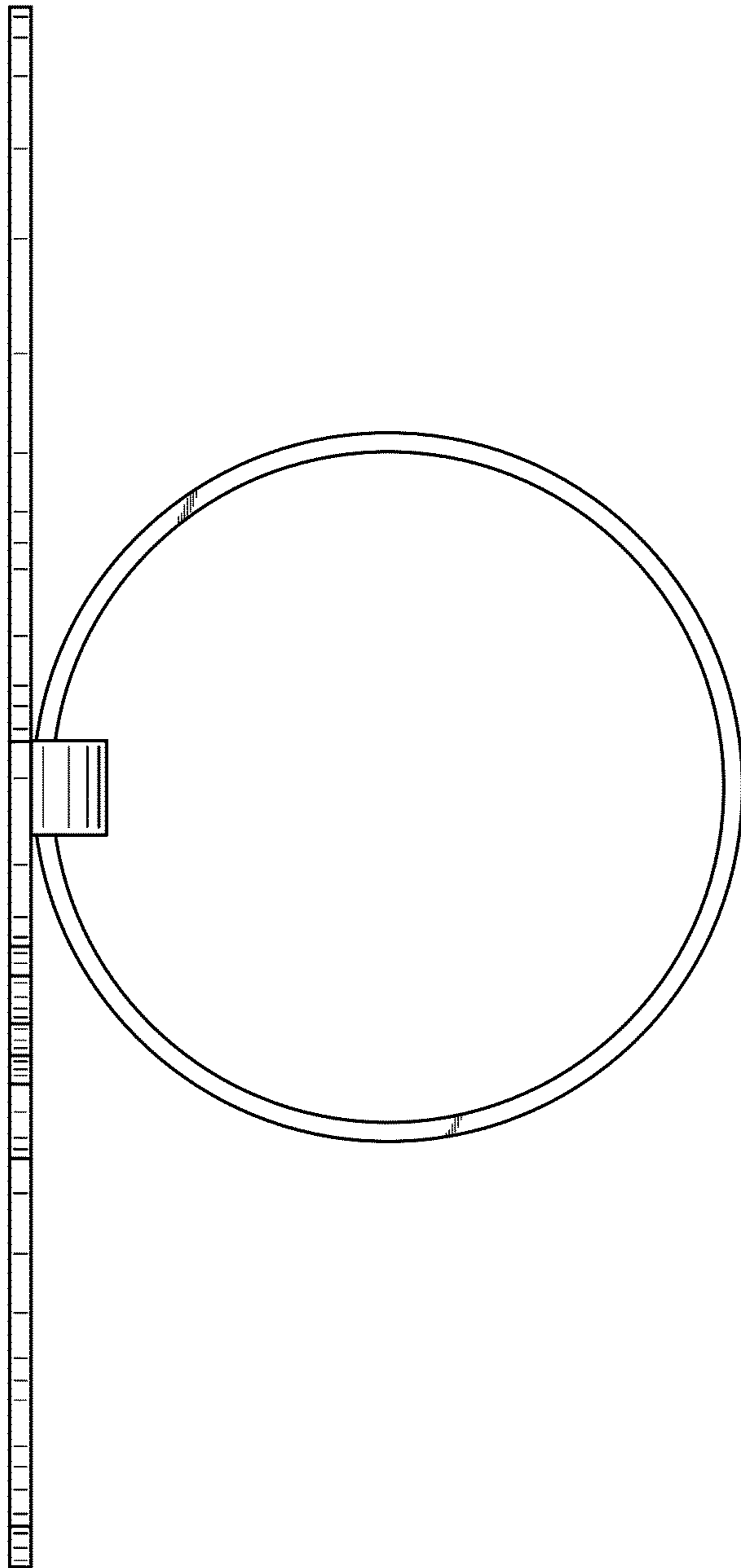

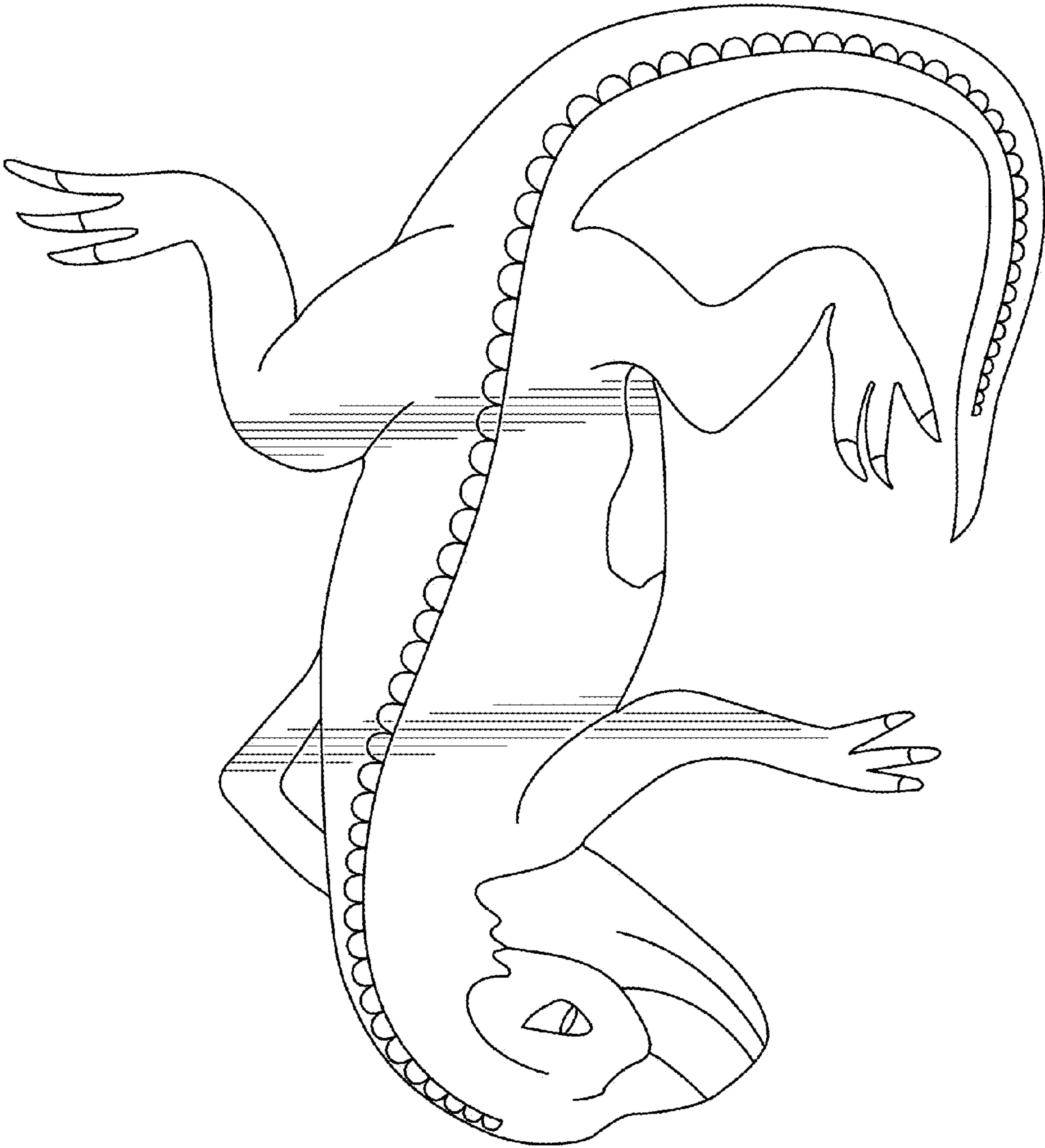

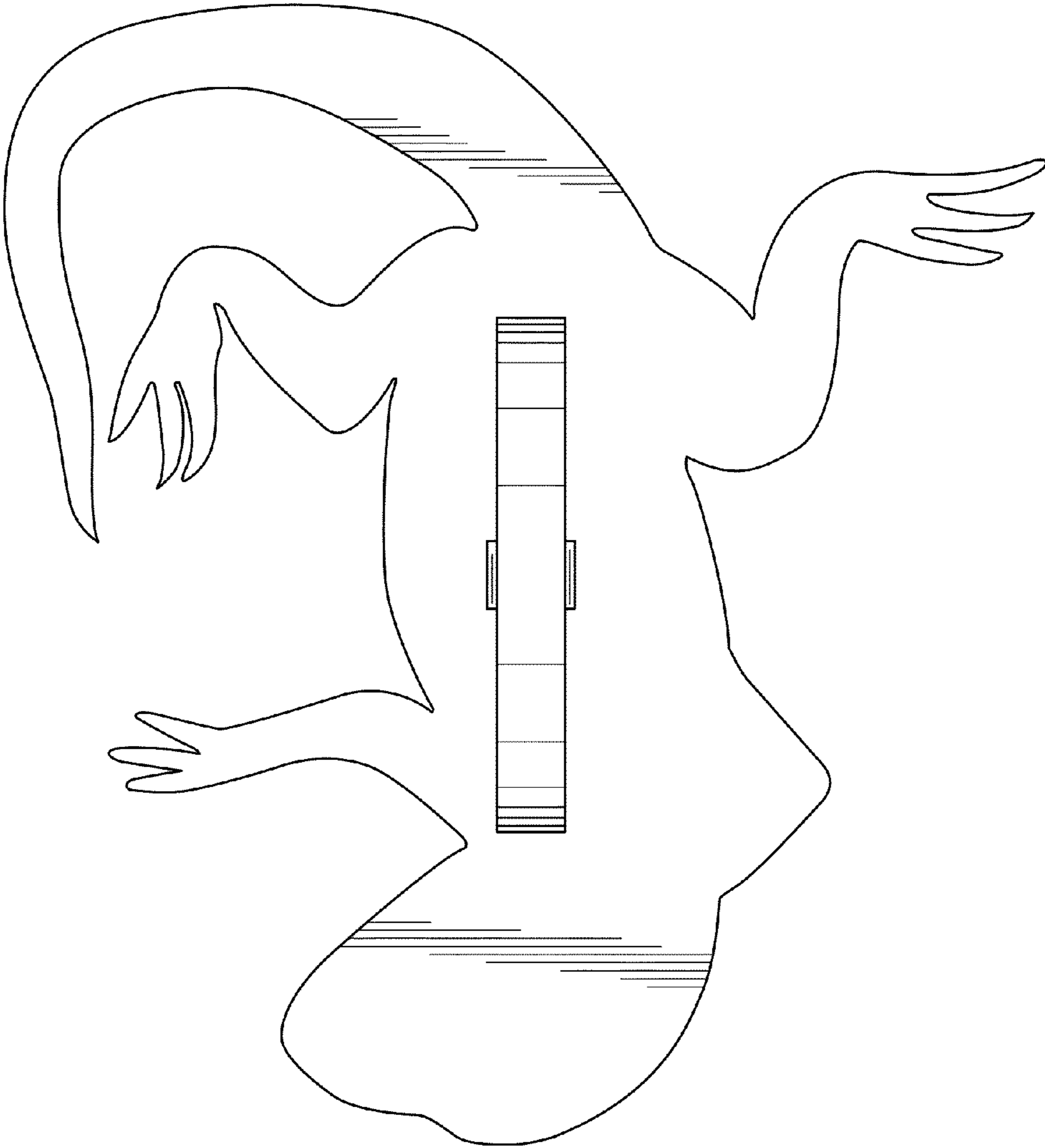
