DESCRIPTION

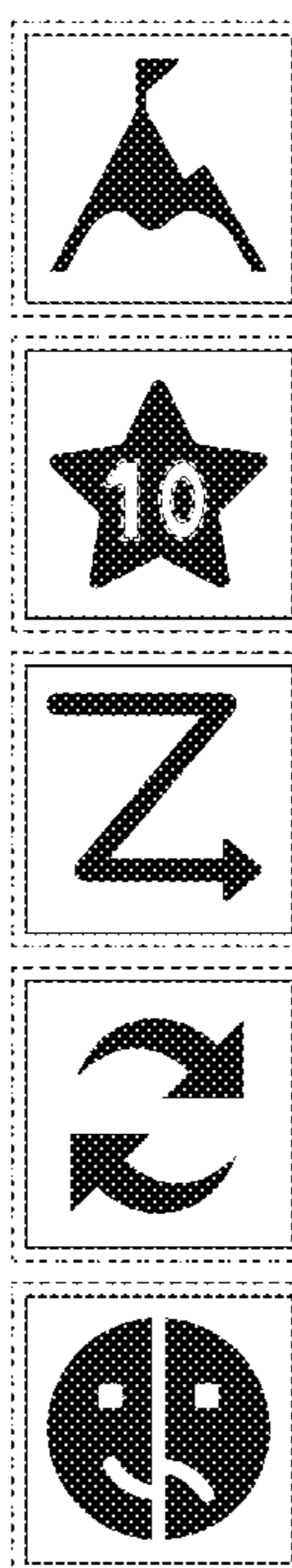
FIG. 1 is a front view of a display screen with icon set showing our new design;

FIG. 2 is a front view of a display screen with icon set showing an alternative embodiment of our new design; and,

FIGS. 3-4 show the display screen with icon set of FIGS. 1-2 on a device.

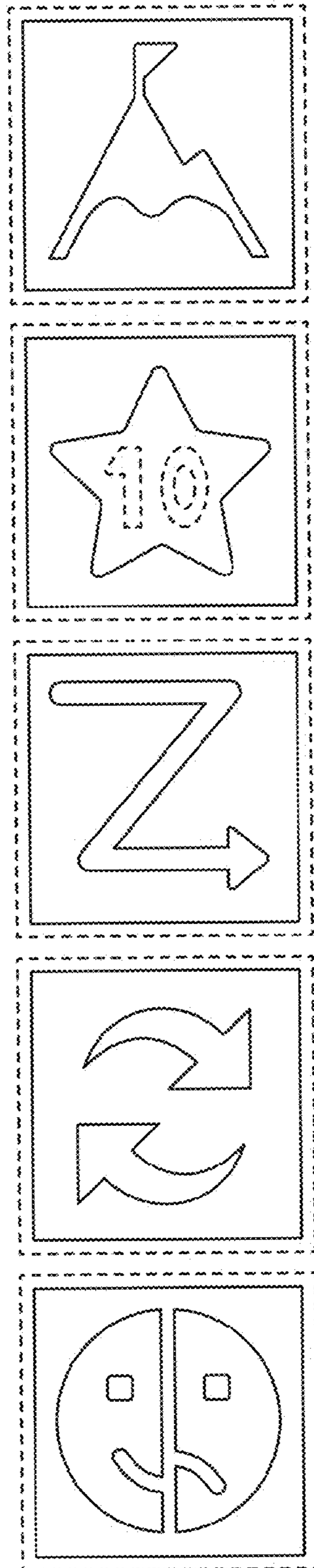

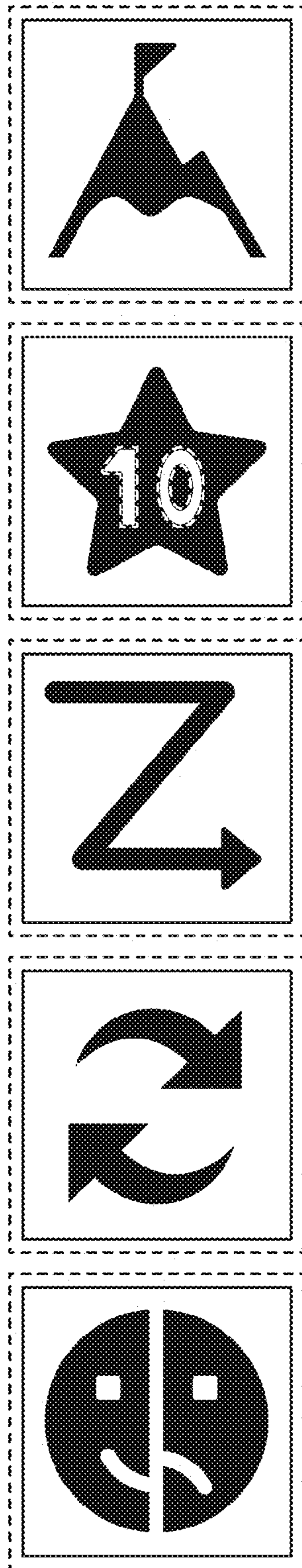

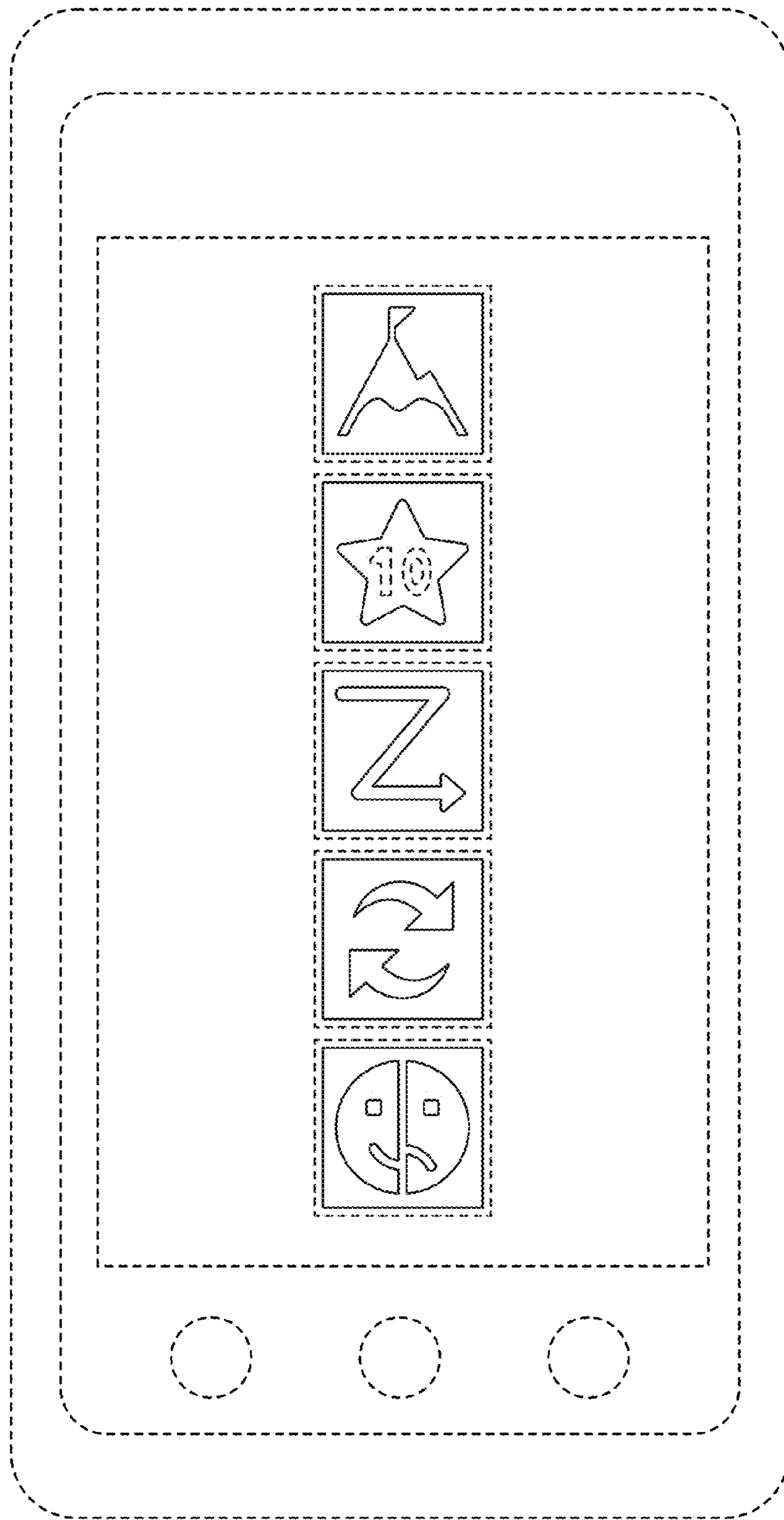

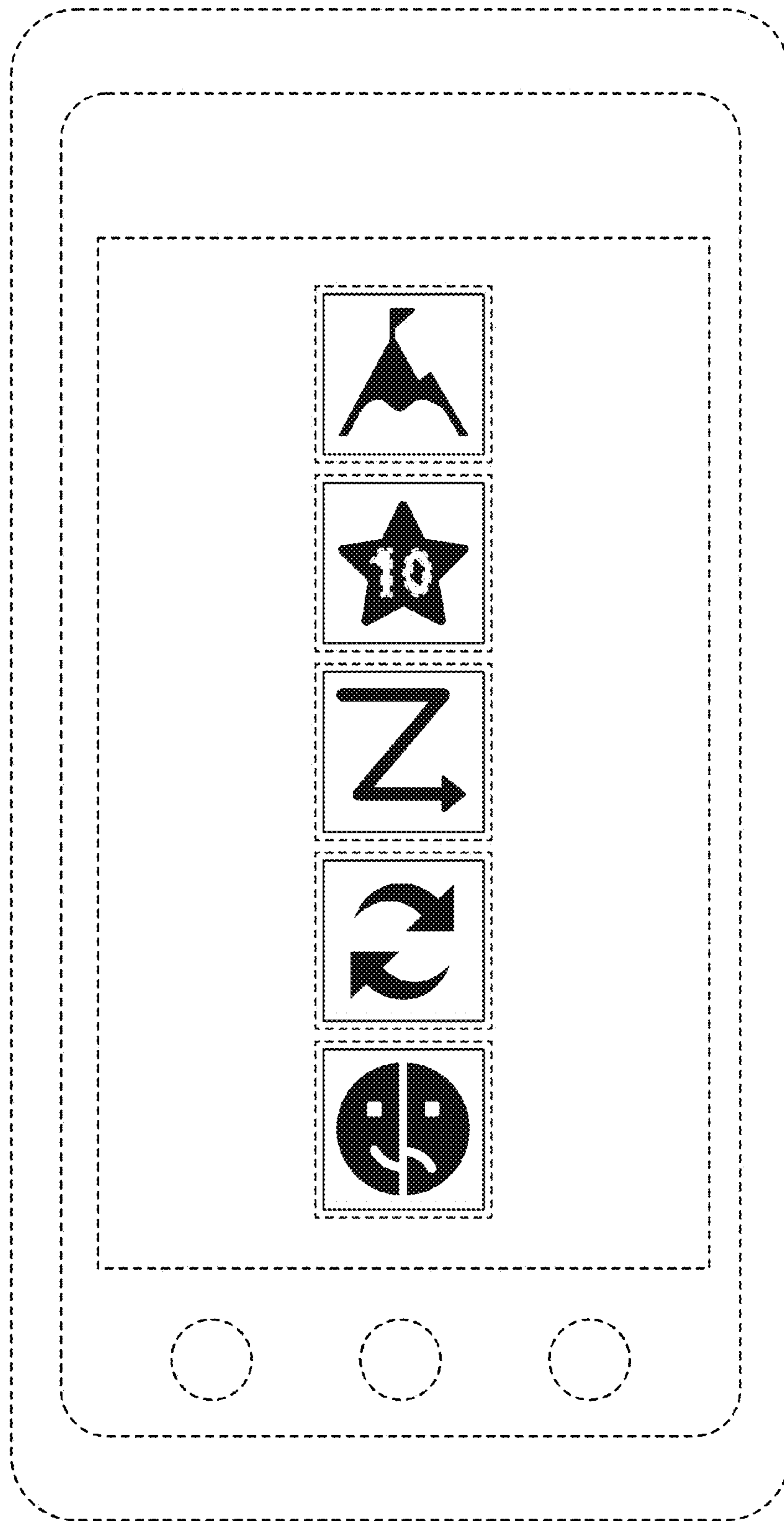
