(57) **CLAIM**

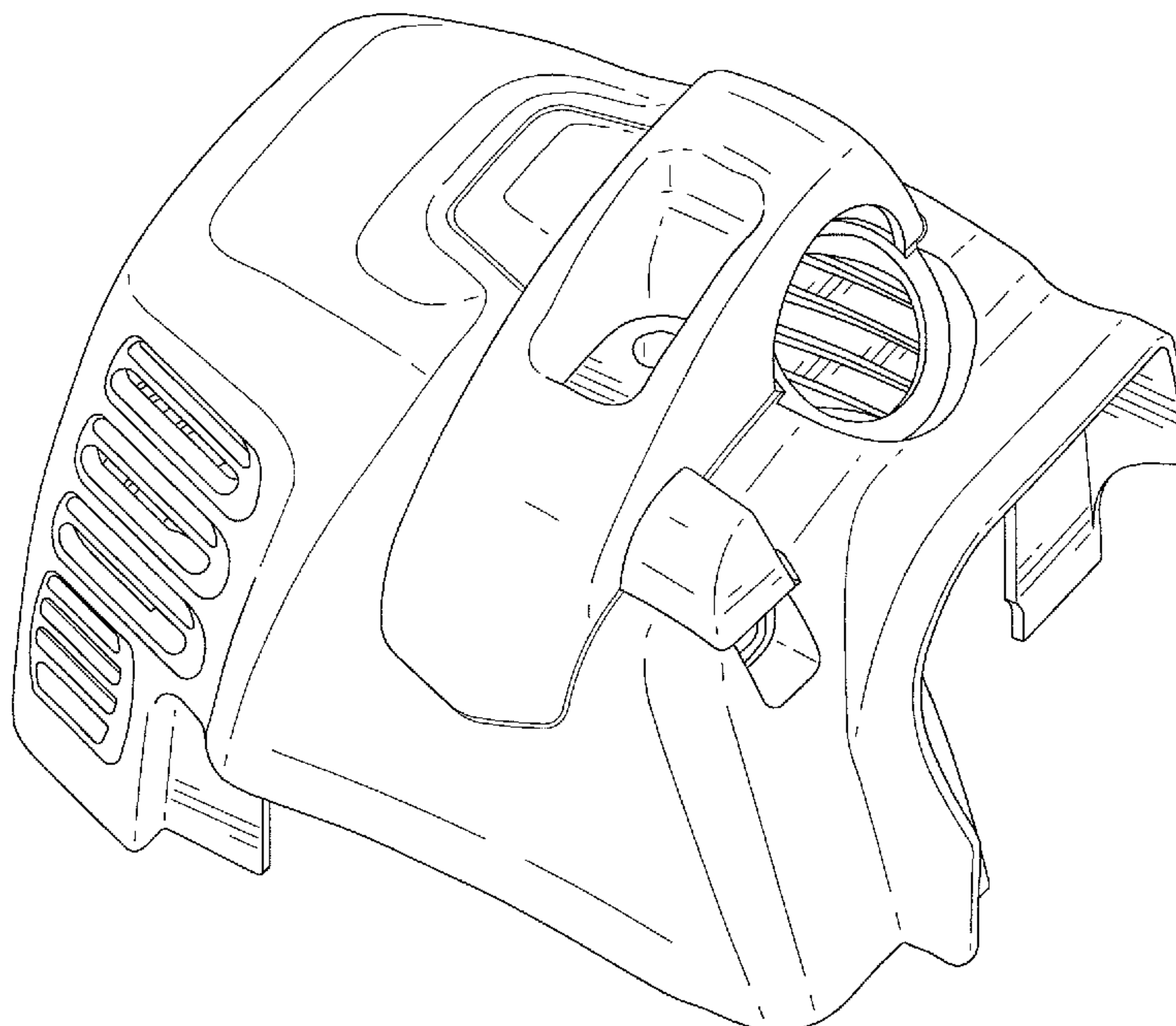
The ornamental design for a cover for internal combustion engine, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a cover for internal combustion engine in accordance with the present design; FIG. 2 is a rear perspective view thereof; FIG. 3 is a front view thereof; FIG. 4 is a rear view thereof; FIG. 5 is a left side view thereof; FIG. 6 is a right side view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom plan view thereof.

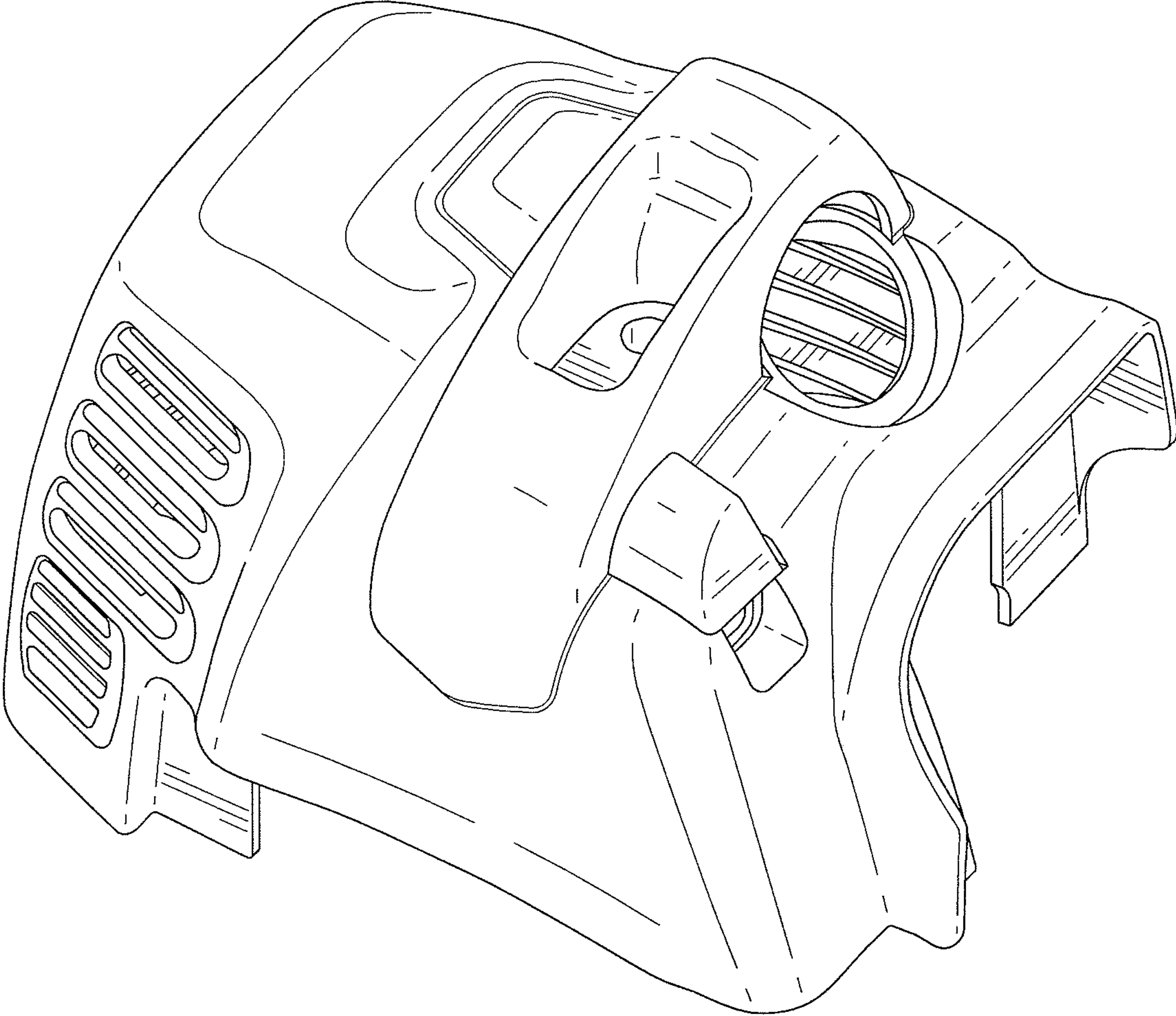

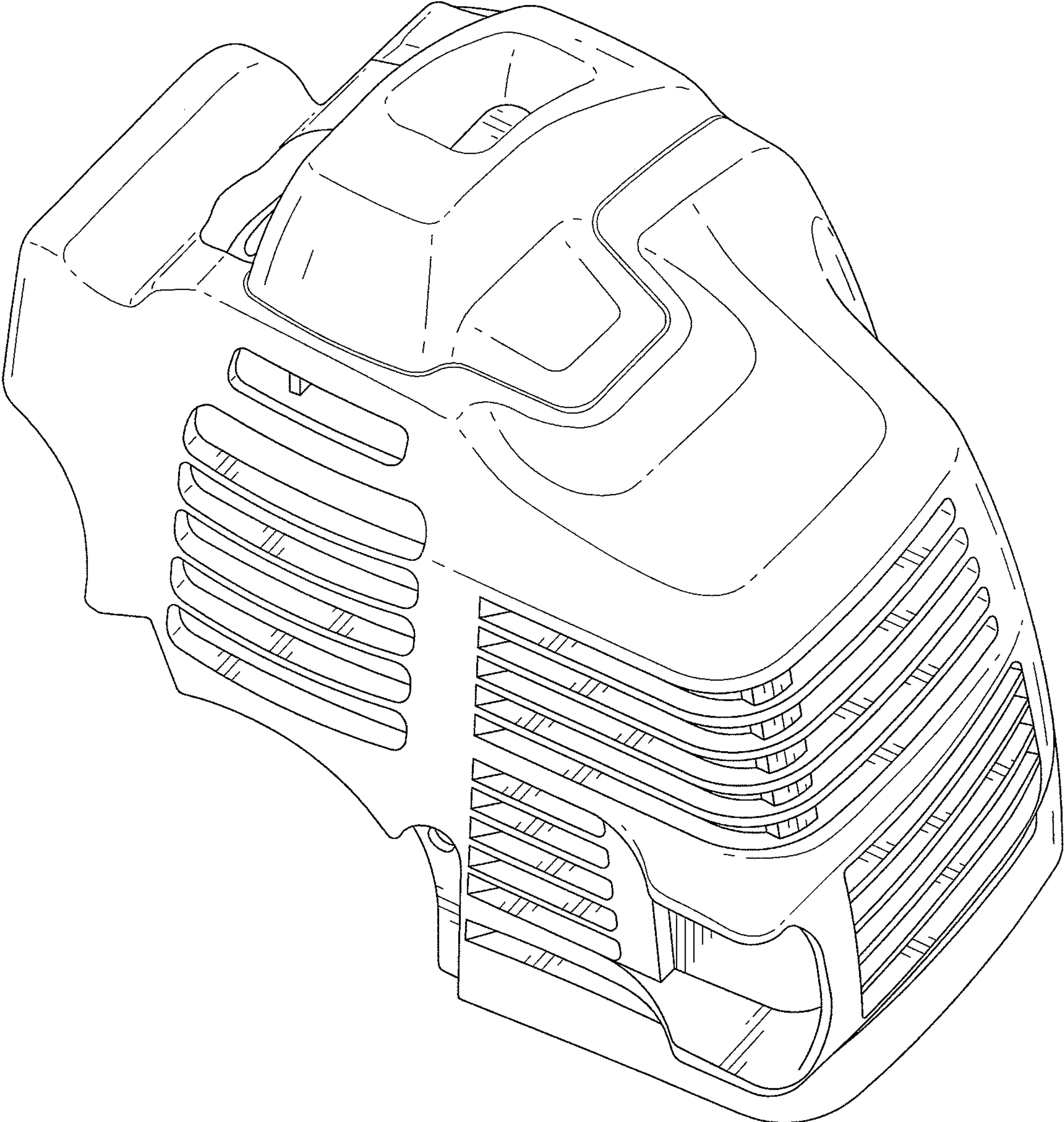

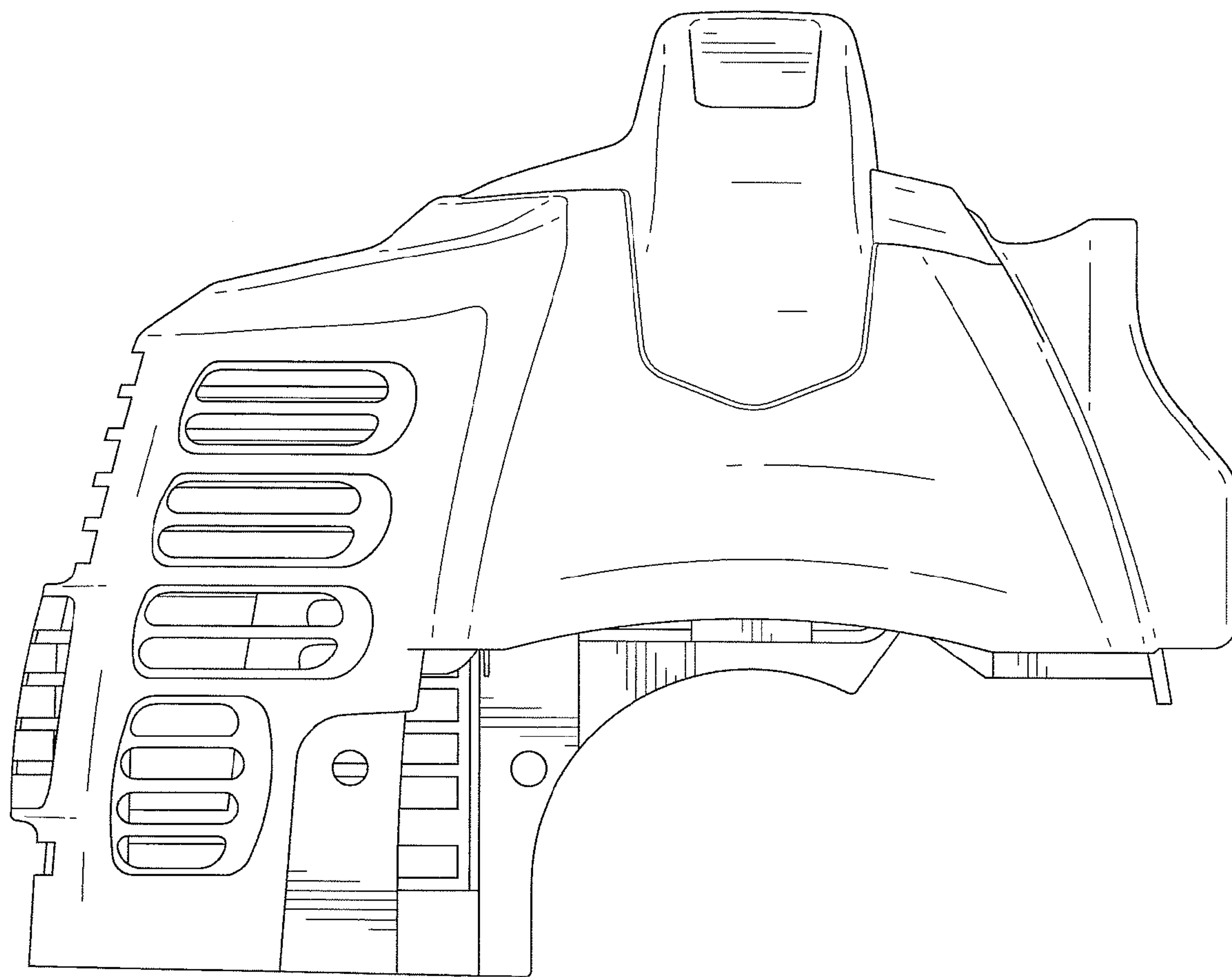

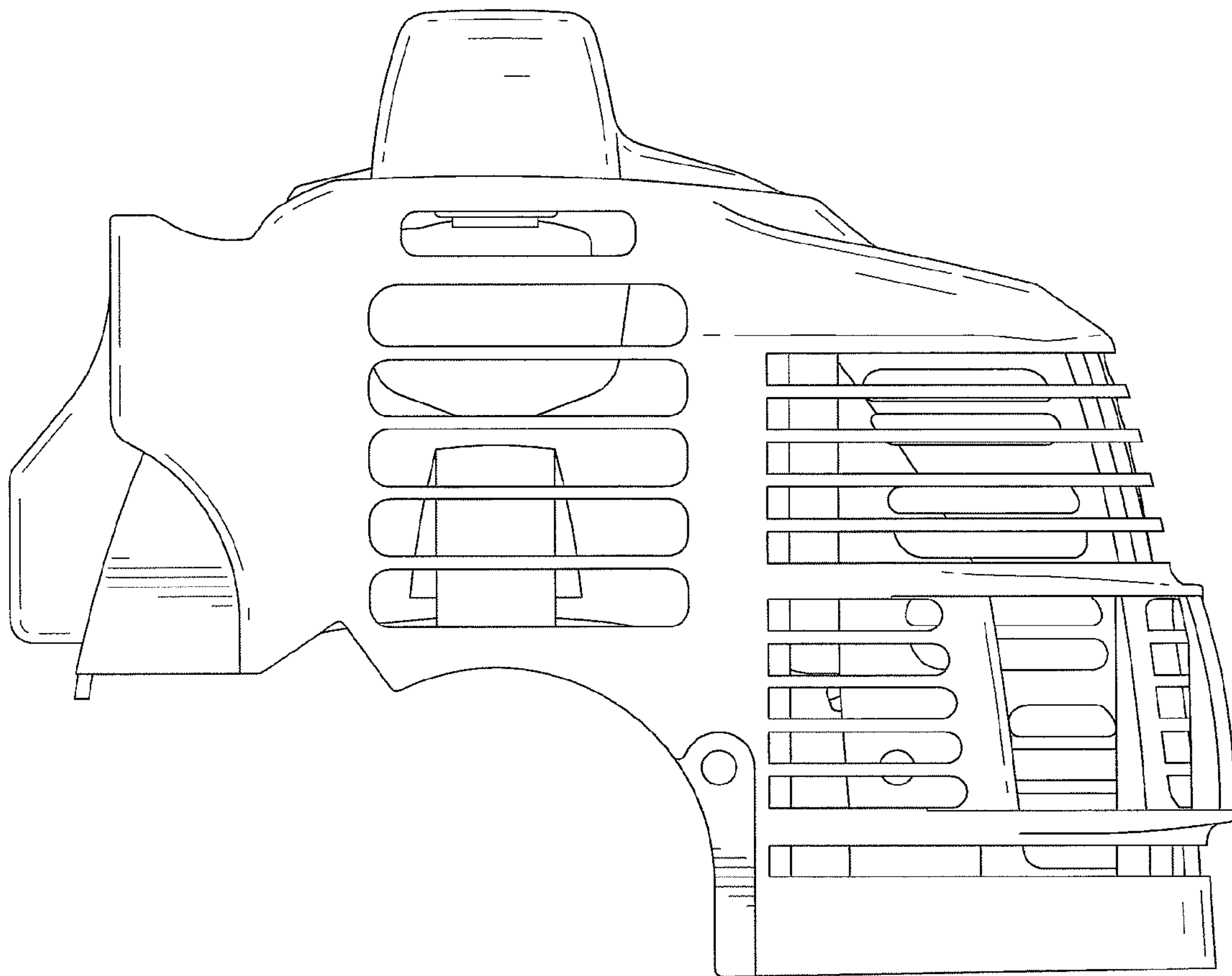

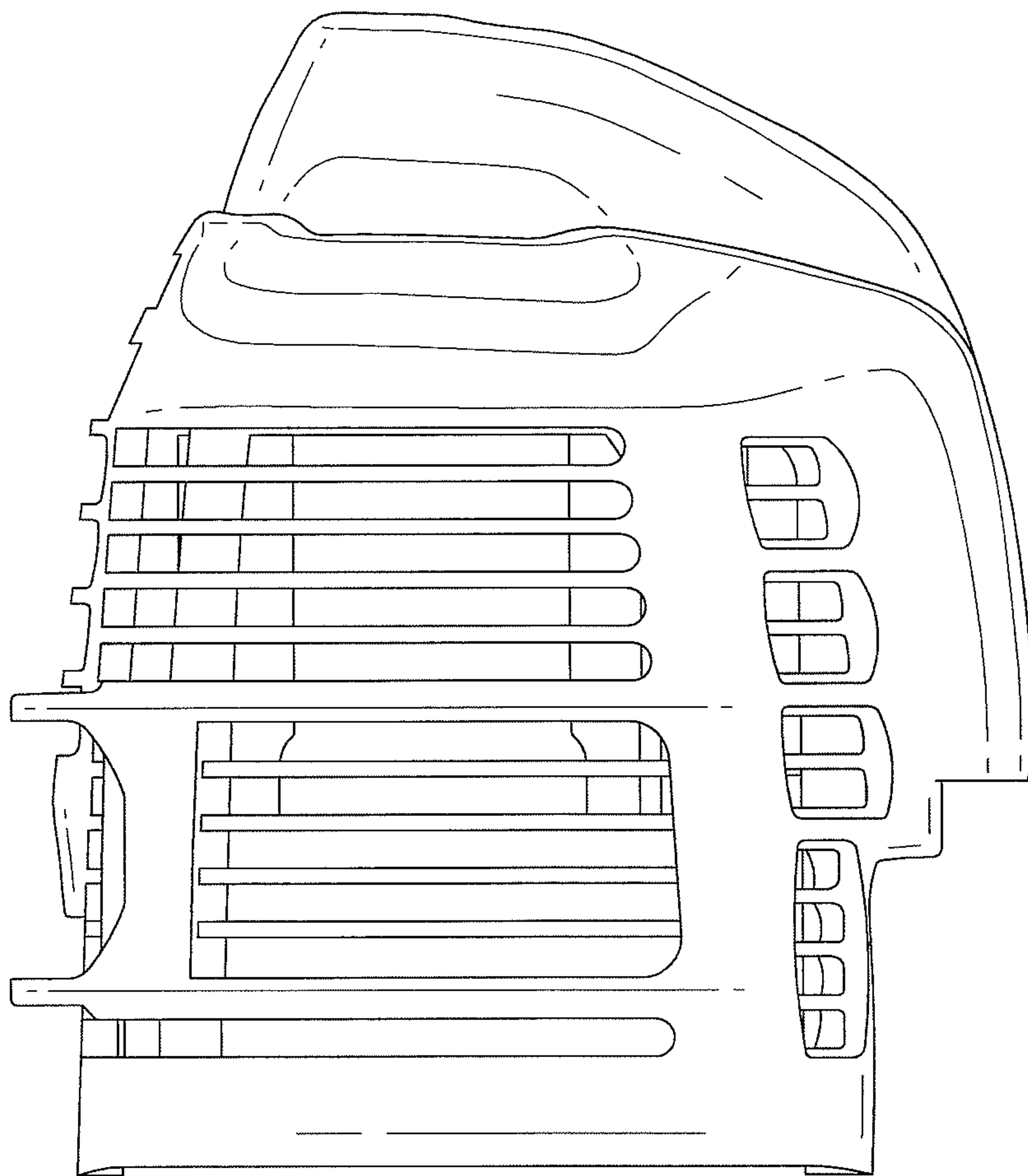

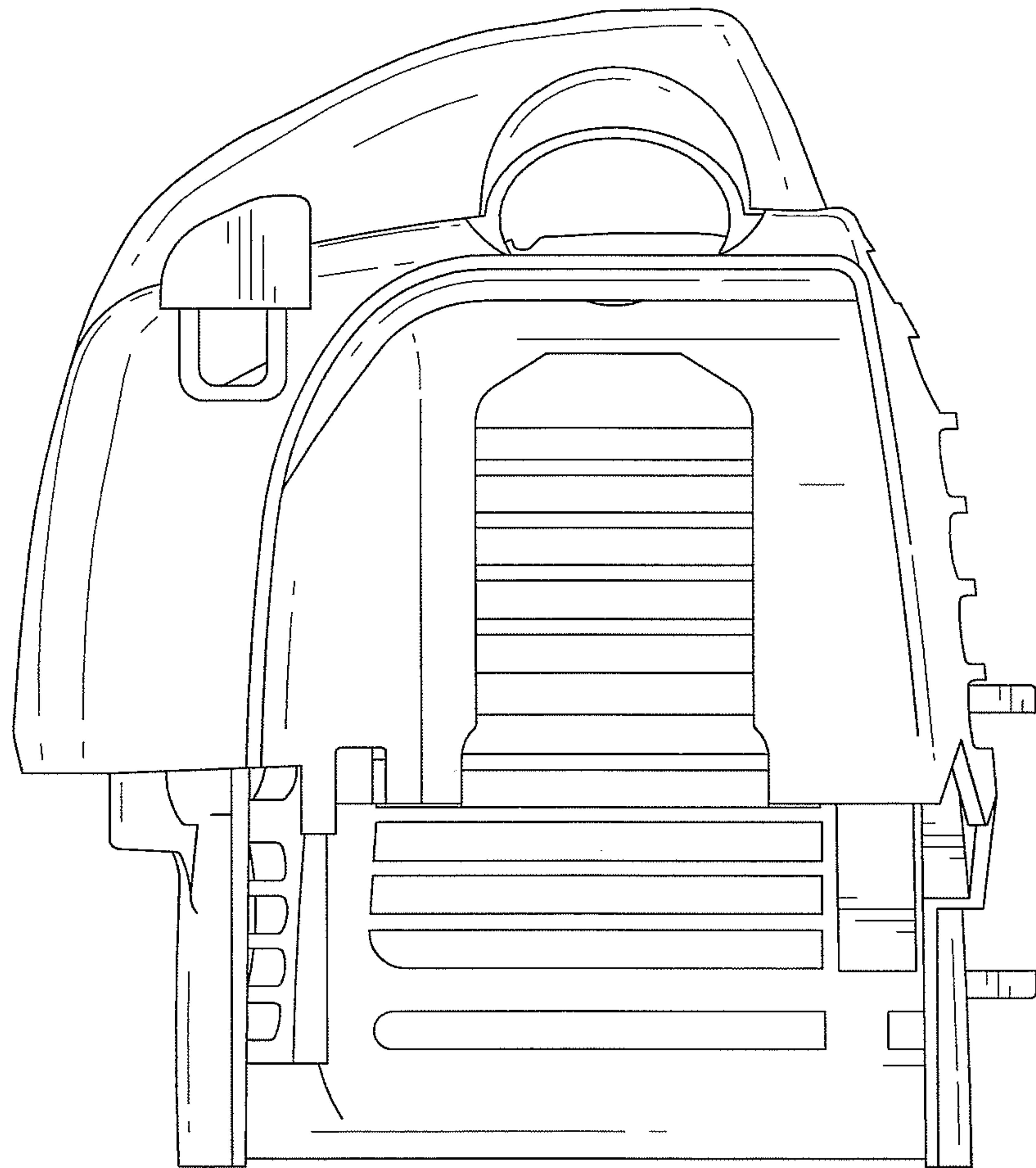

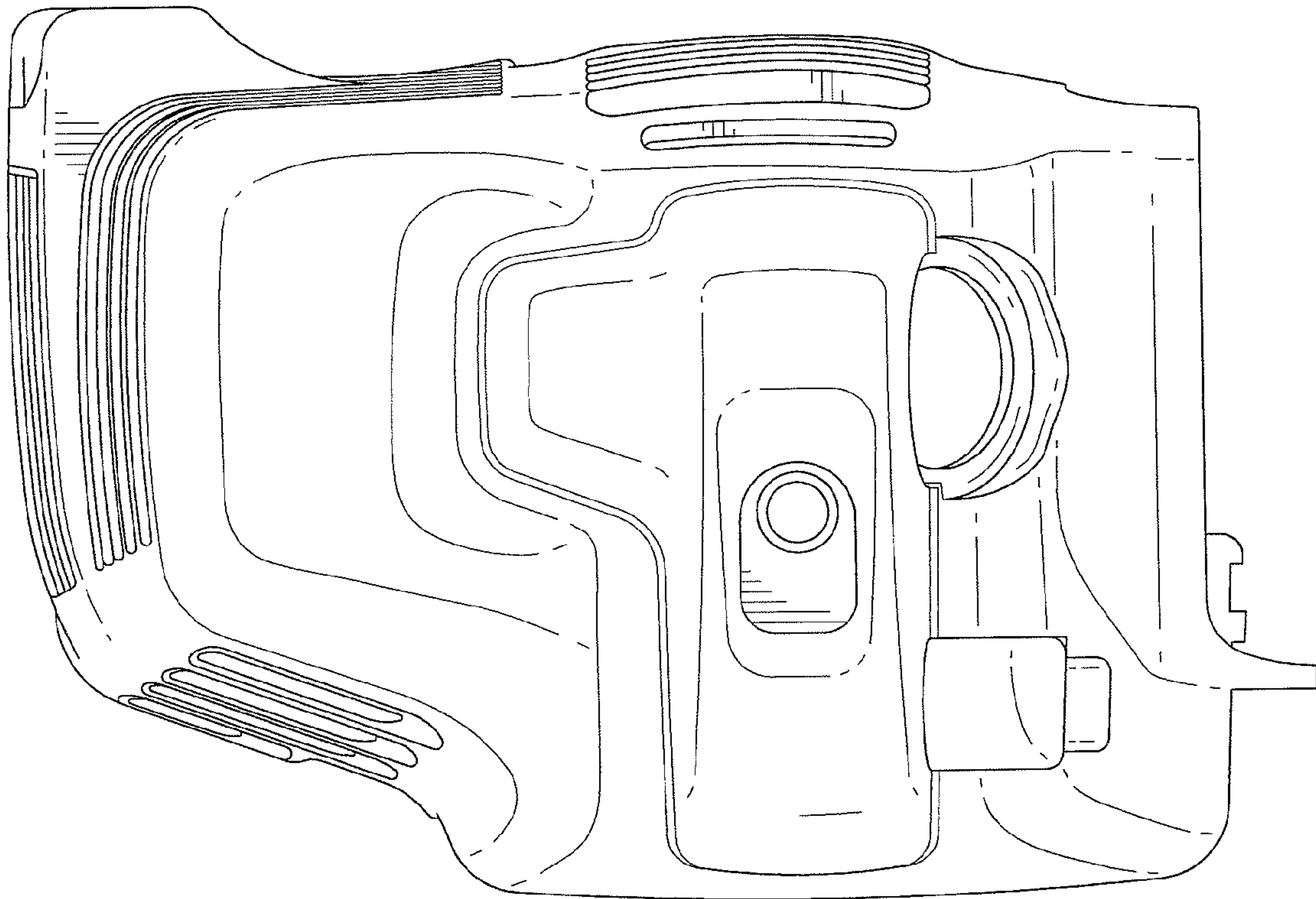

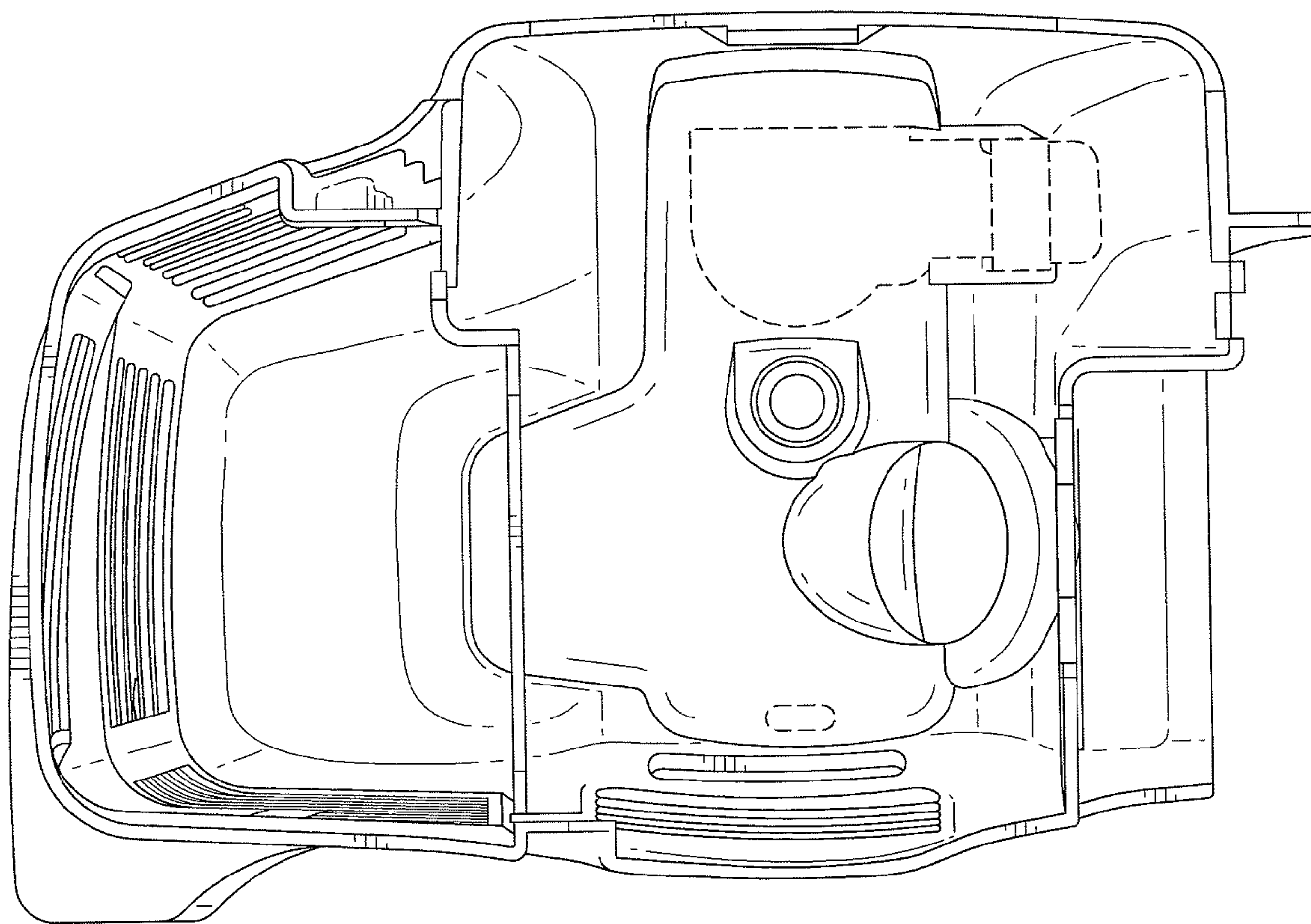
