**DESCRIPTION**

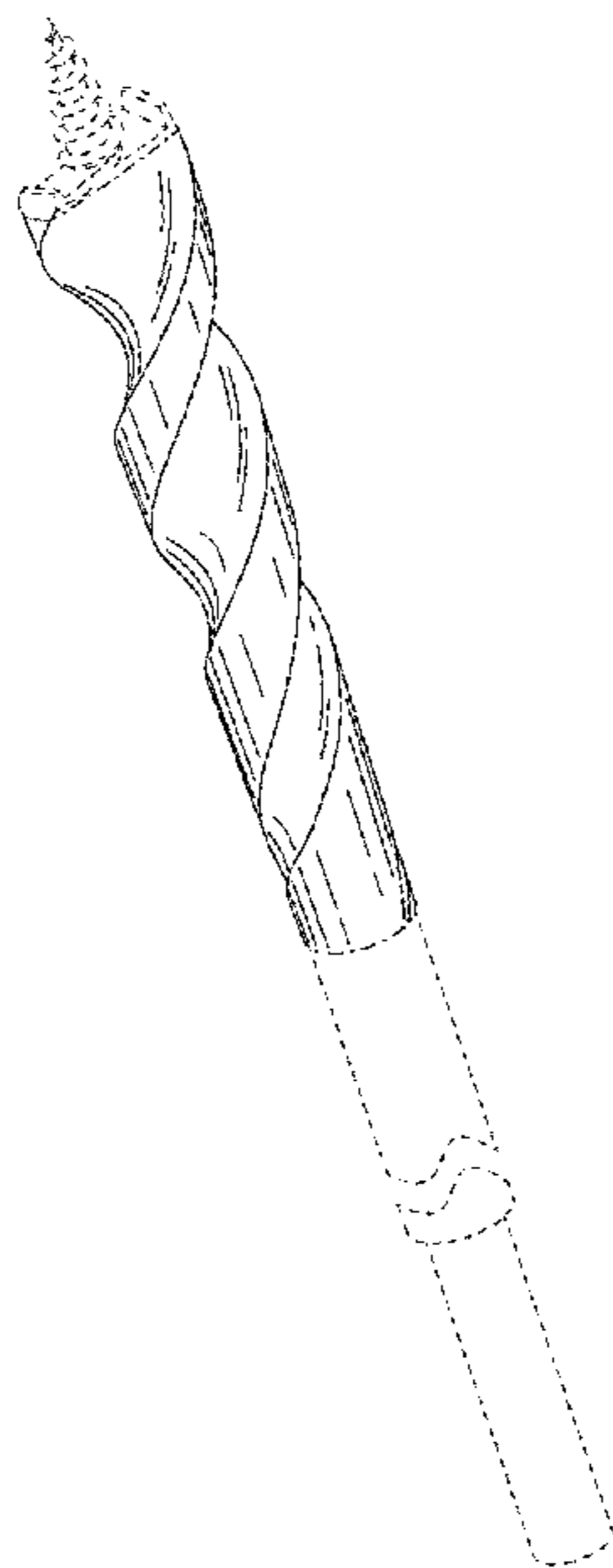
FIG. 1 is a perspective view of a wood boring bit embodying the invention.

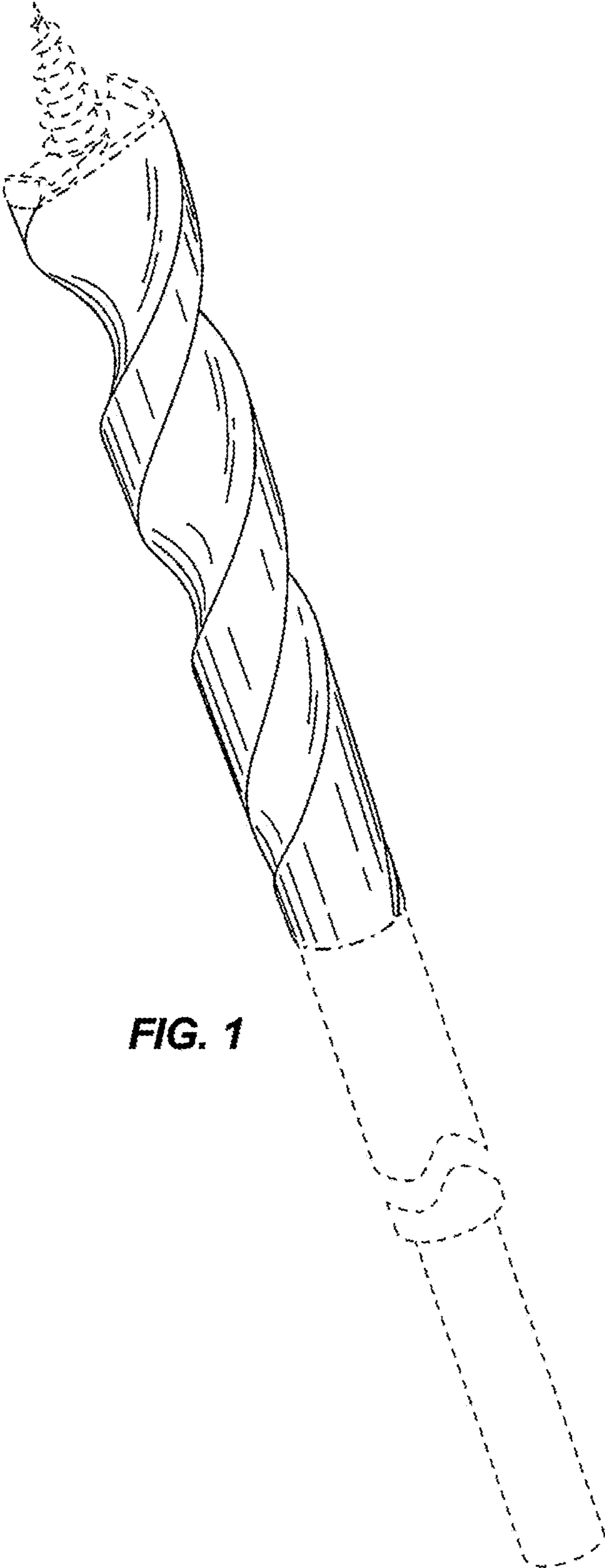
FIG. 2 is a front view of the wood boring bit shown in FIG. 1; and,

FIG. 3 is a left side view of the wood boring bit shown in FIG. 1.

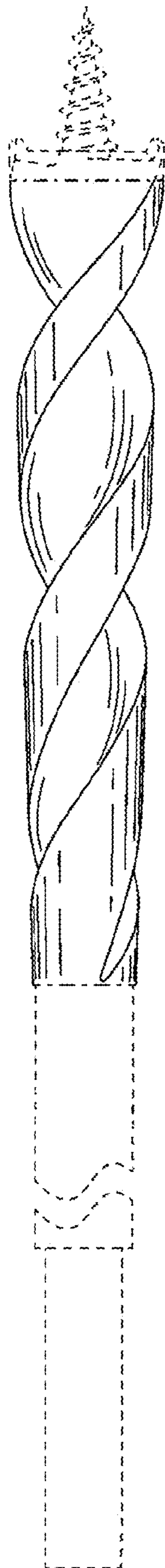
The elements shown in broken lines are included for the purpose of illustrating environment and form no part of the claimed design.

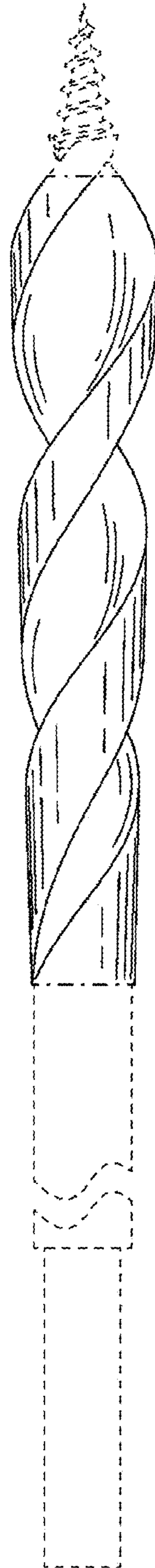
