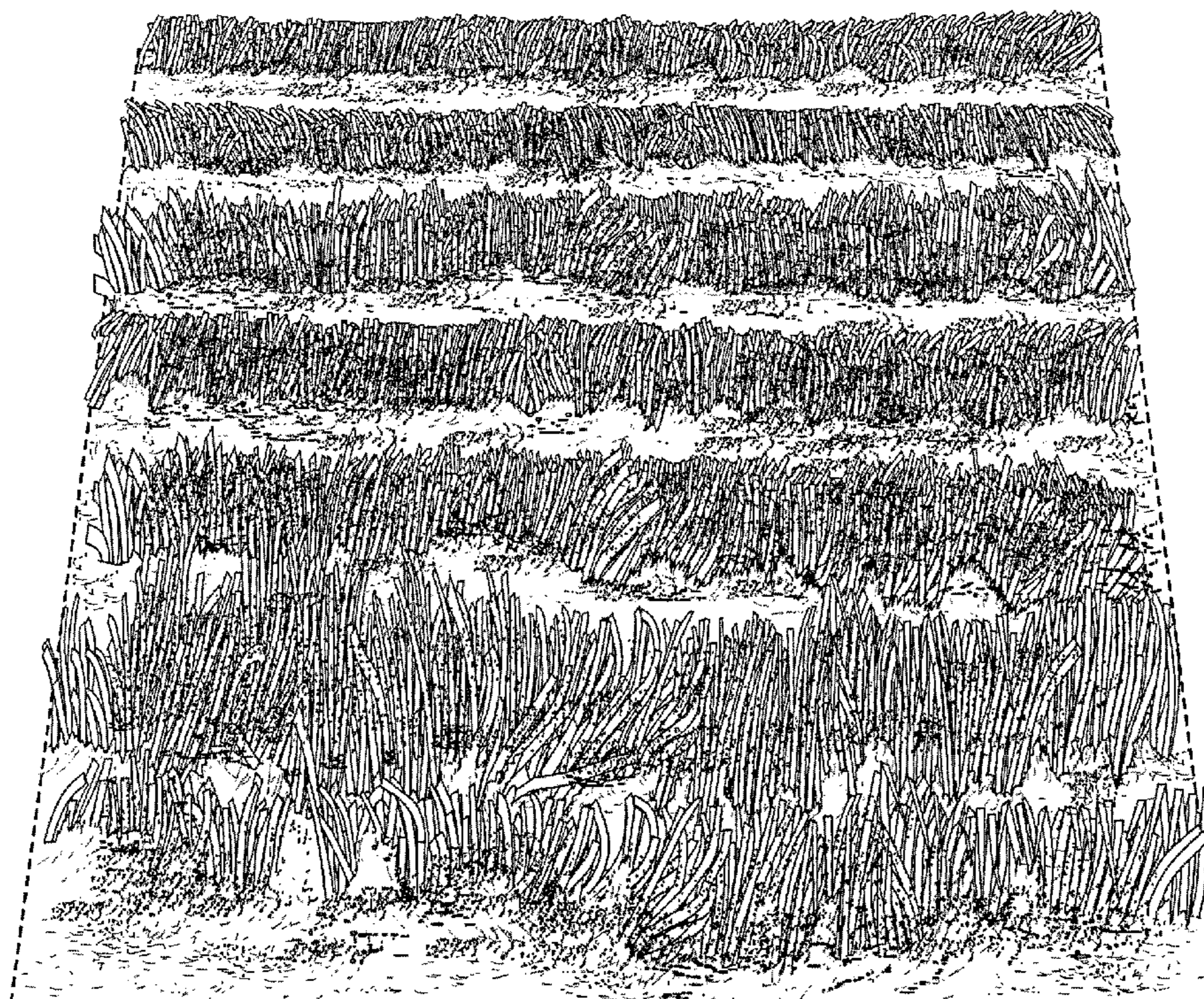
(57) **CLAIM**

The ornamental design for a golf course bunker, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the golf course bunker; FIG. 2 is a front perspective view of the golf course bunker as seen from a distance; FIG. 3 is a perspective view of the golf course bunker as seen from the right hand side; and, FIG. 4 is a perspective view of the golf course bunker as seen from the left hand side.

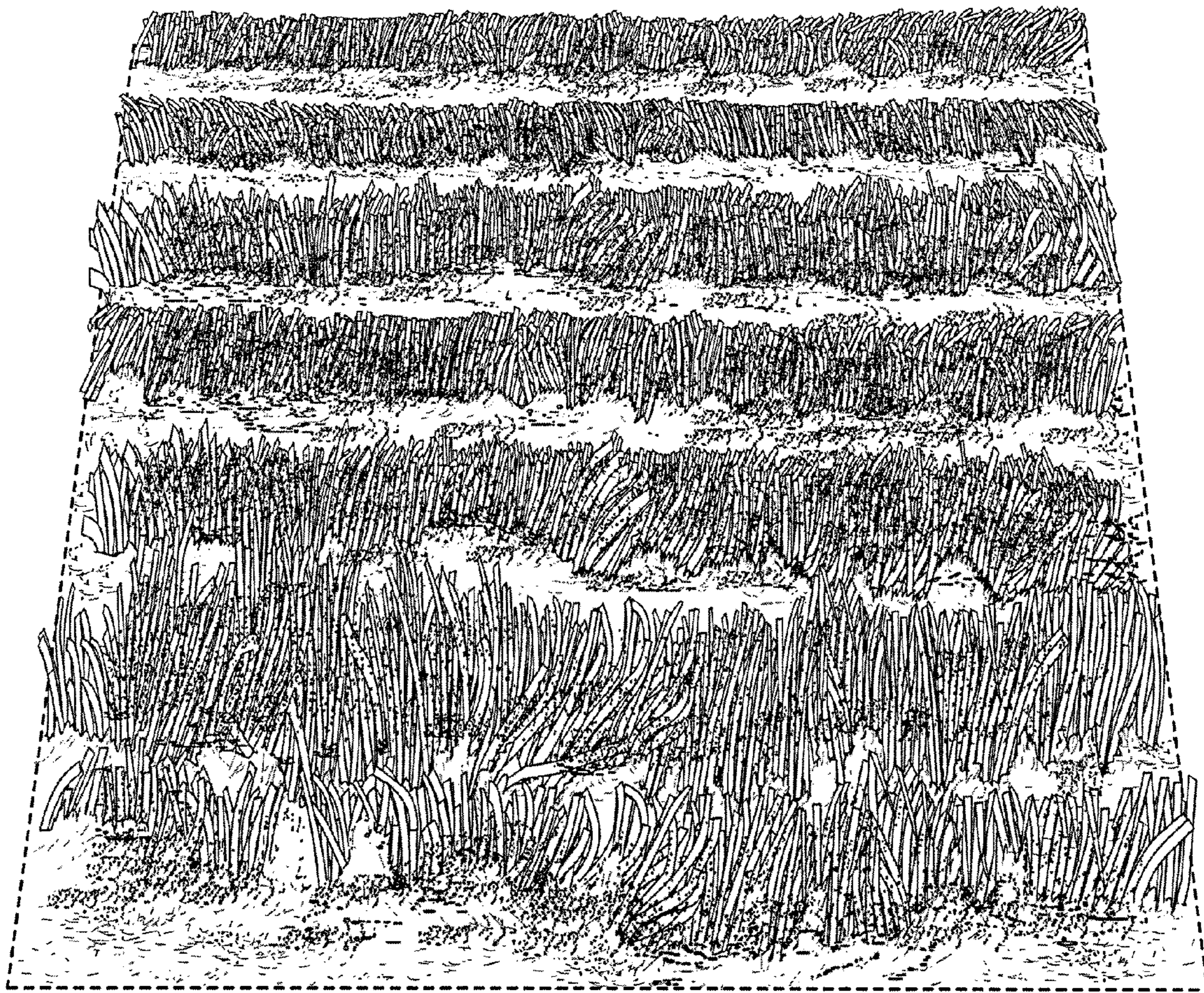
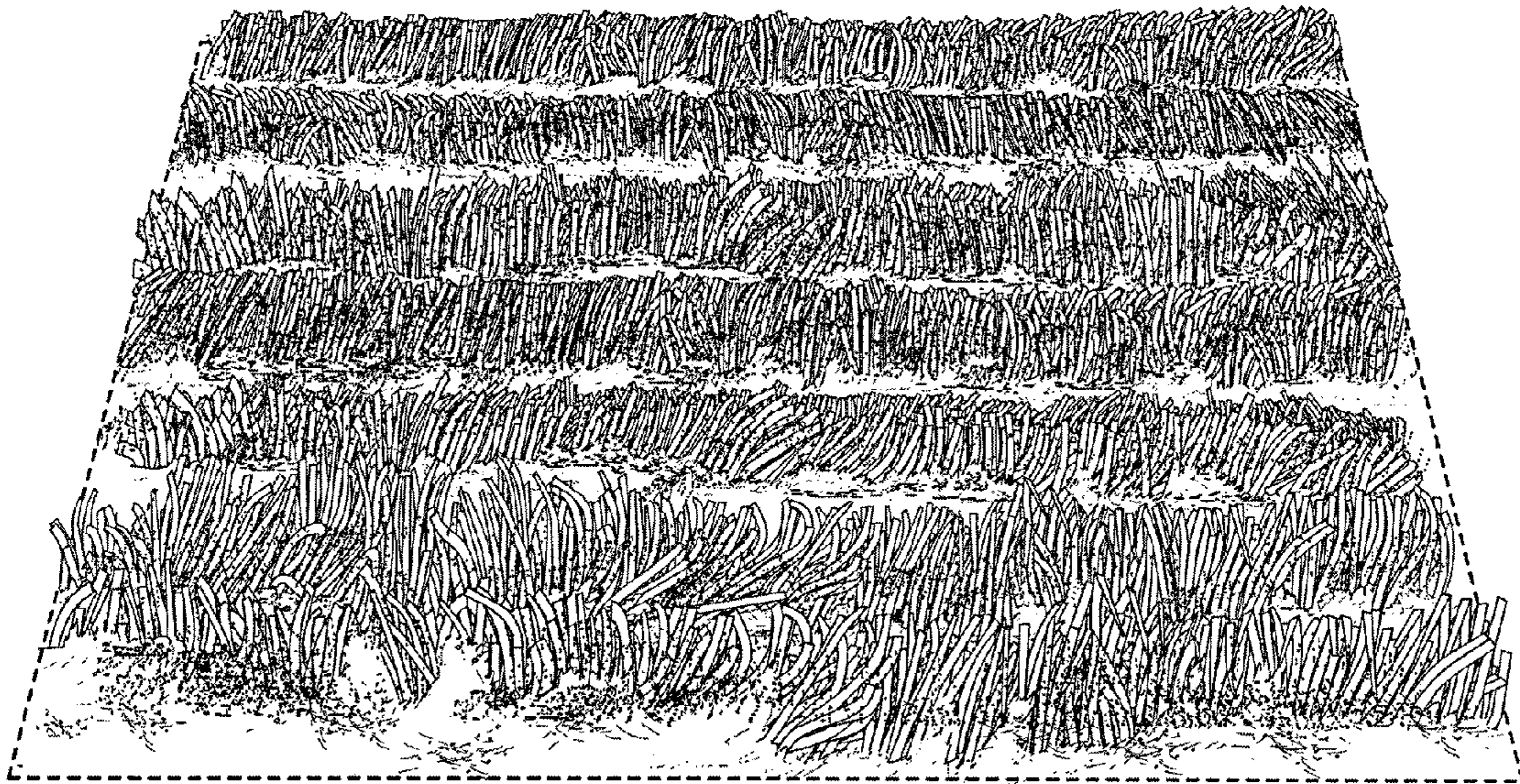
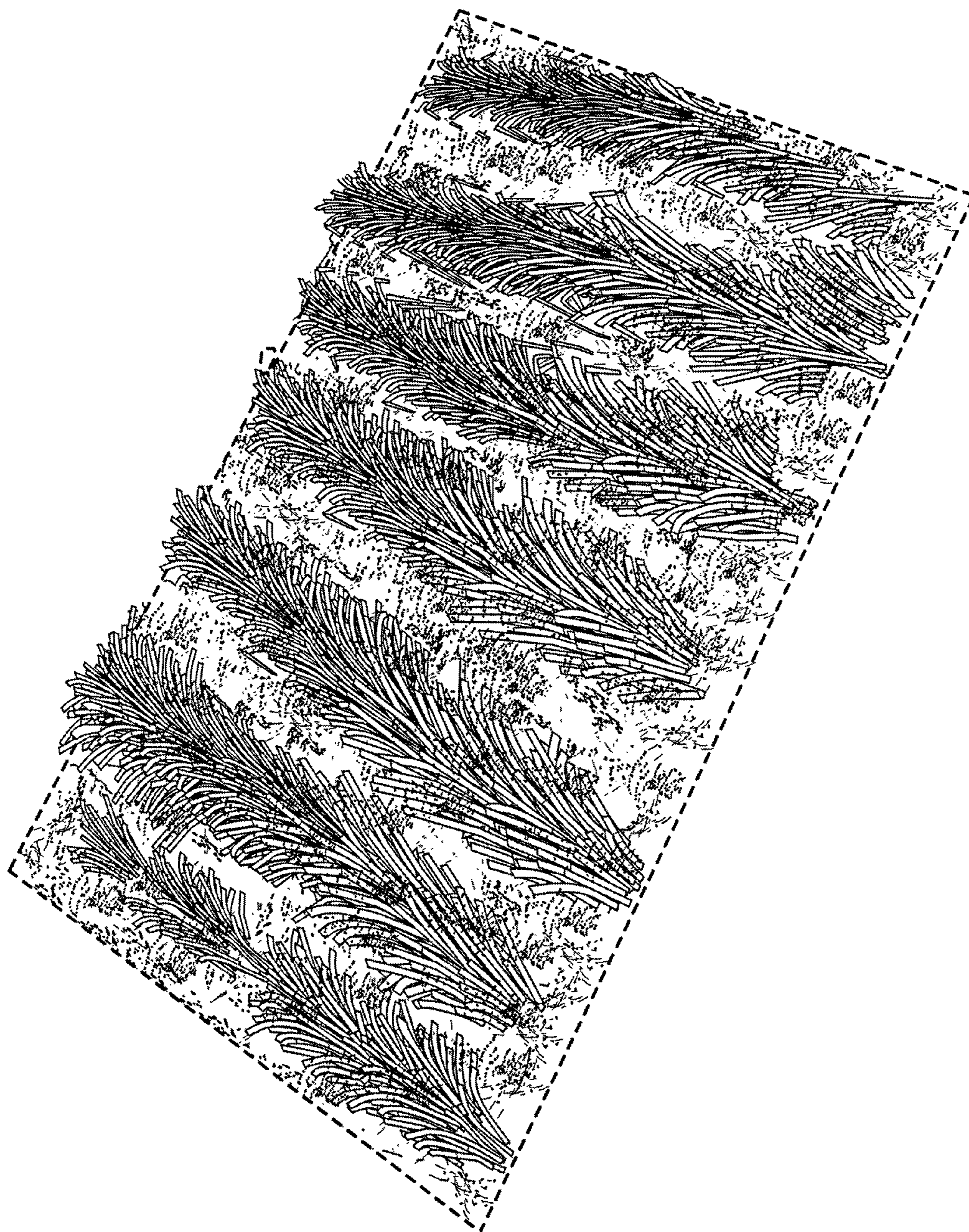


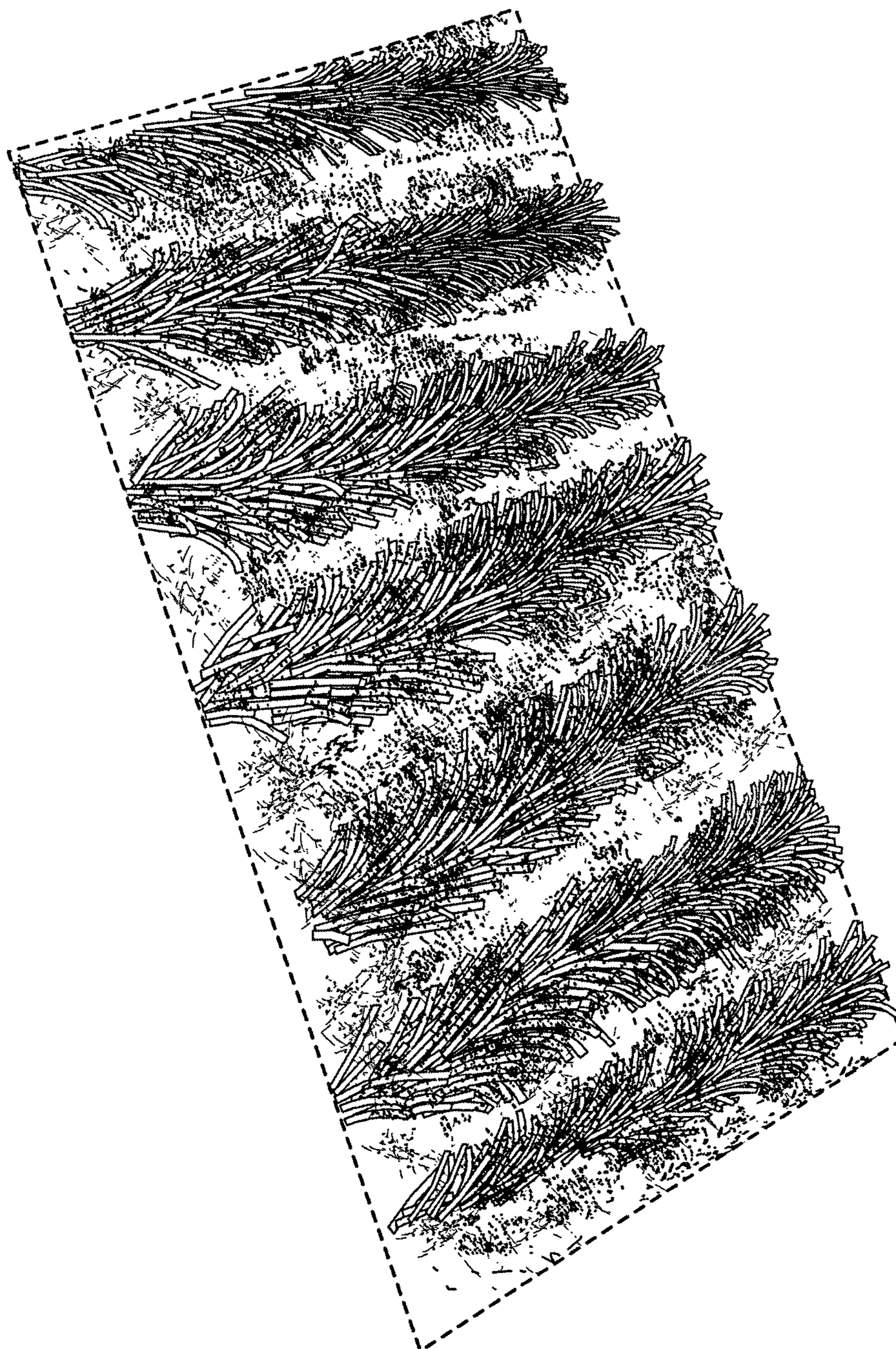
