(57) **CLAIM**

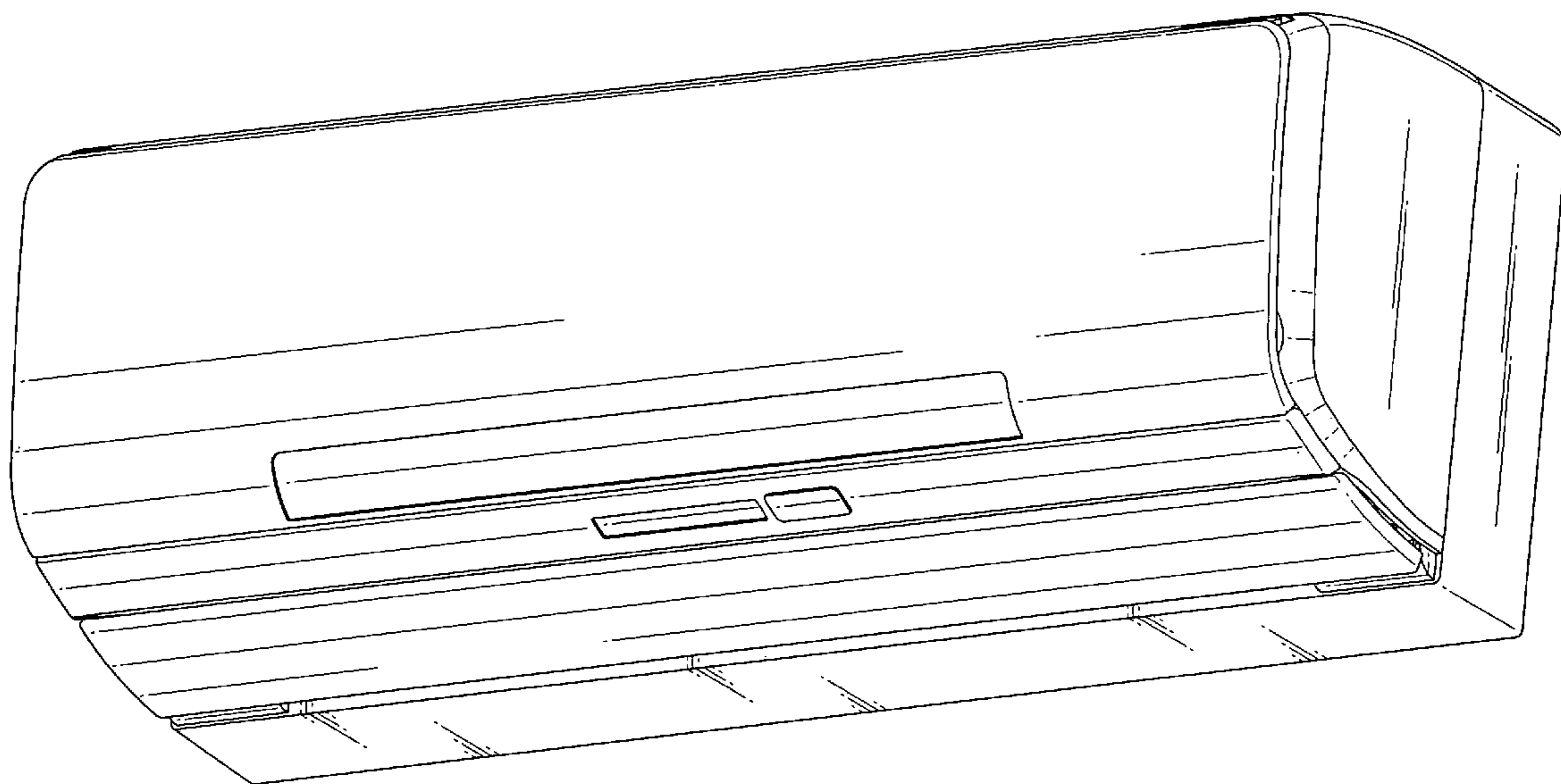
The ornamental design for an air-conditioner, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an air-conditioner showing my new design;  
 FIG. 2 is another perspective view thereof, wherein the wind directing plate is open;  
 FIG. 3 is a front view thereof;  
 FIG. 4 is a rear view thereof;  
 FIG. 5 is a plan view thereof;  
 FIG. 6 is a bottom view thereof;  
 FIG. 7 is a left side view thereof;  
 FIG. 8 is a right side view thereof; and,  
 FIG. 9 is a cross-sectional view thereof taken along line 9-9 of FIG. 3.

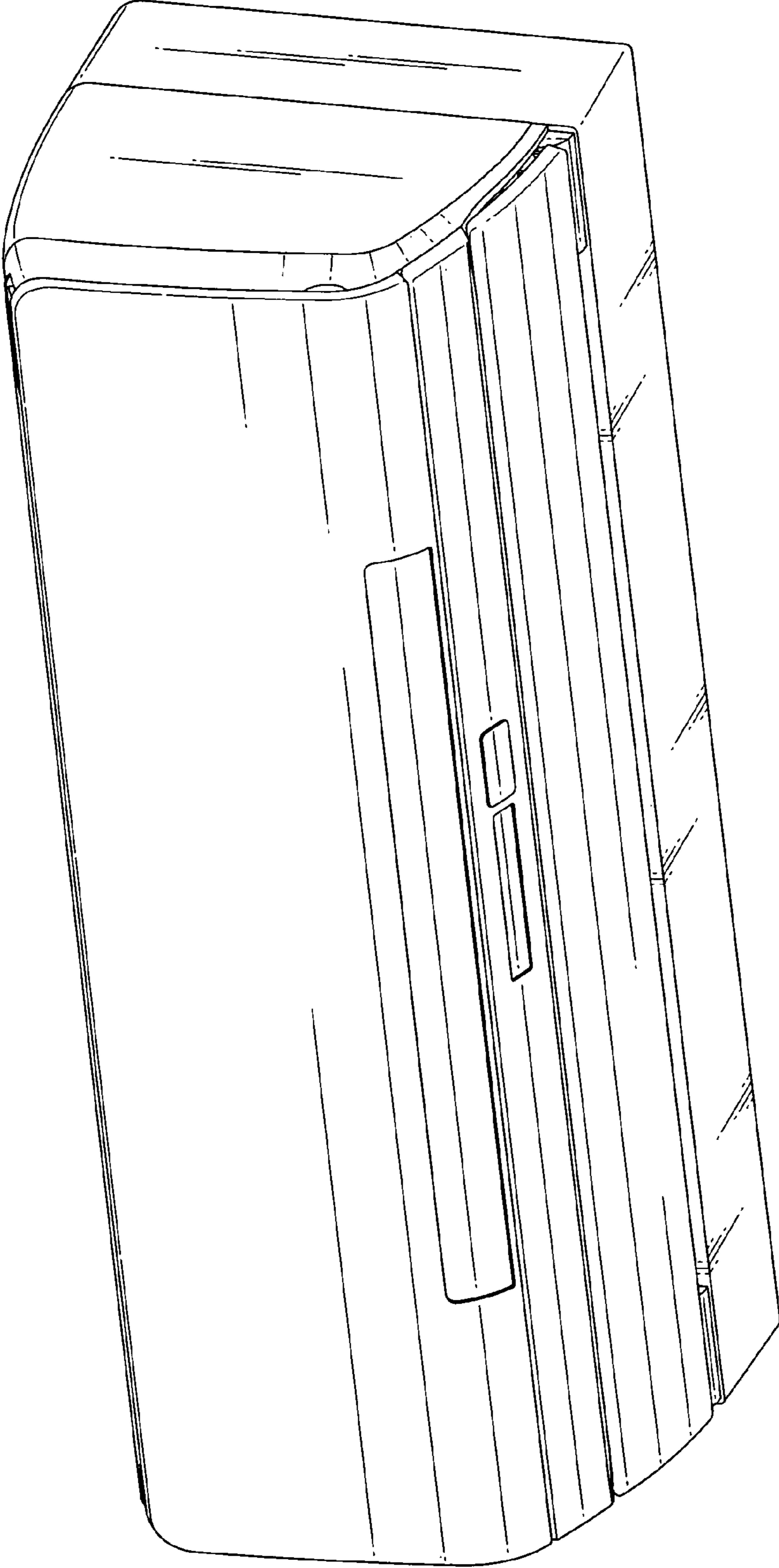

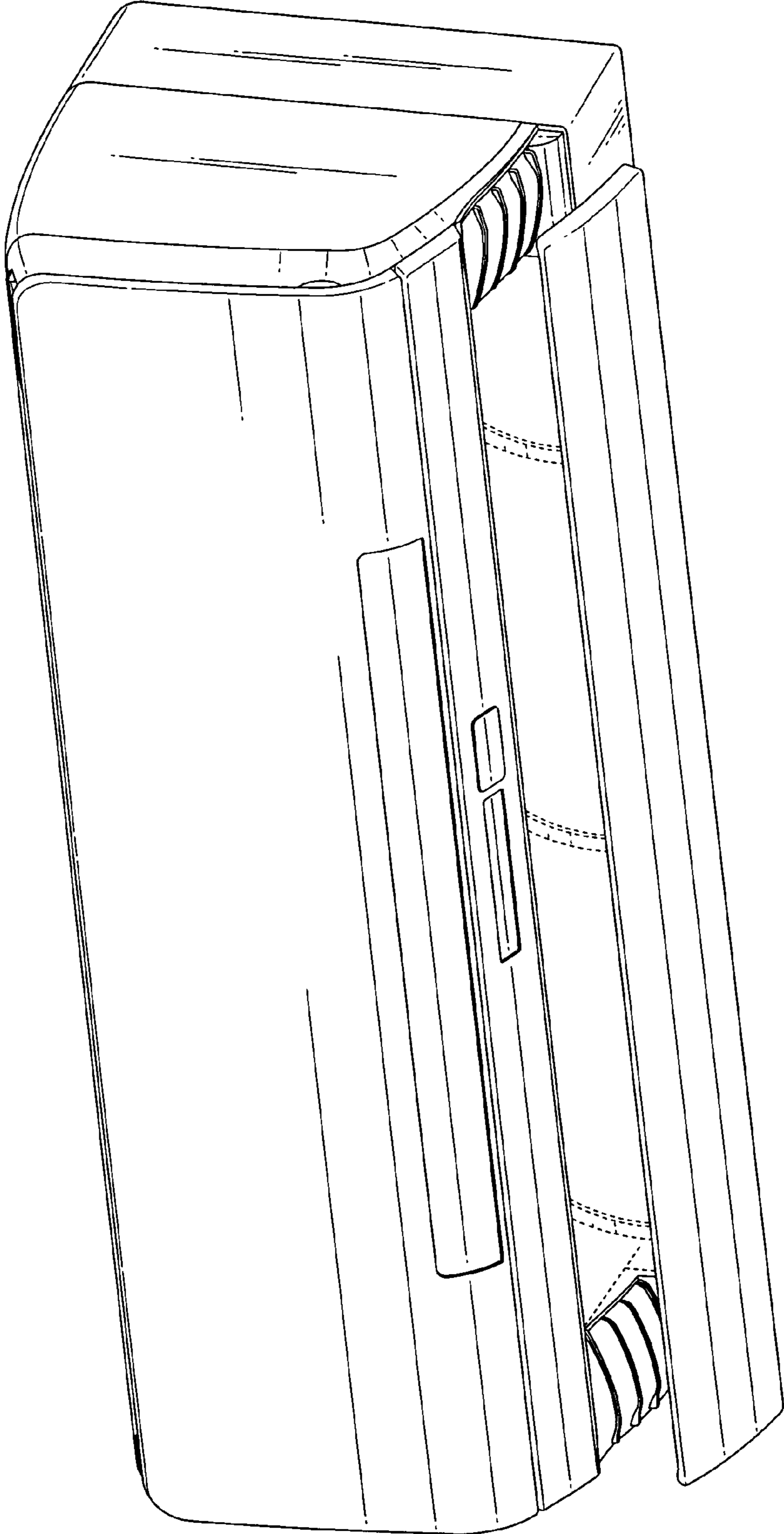
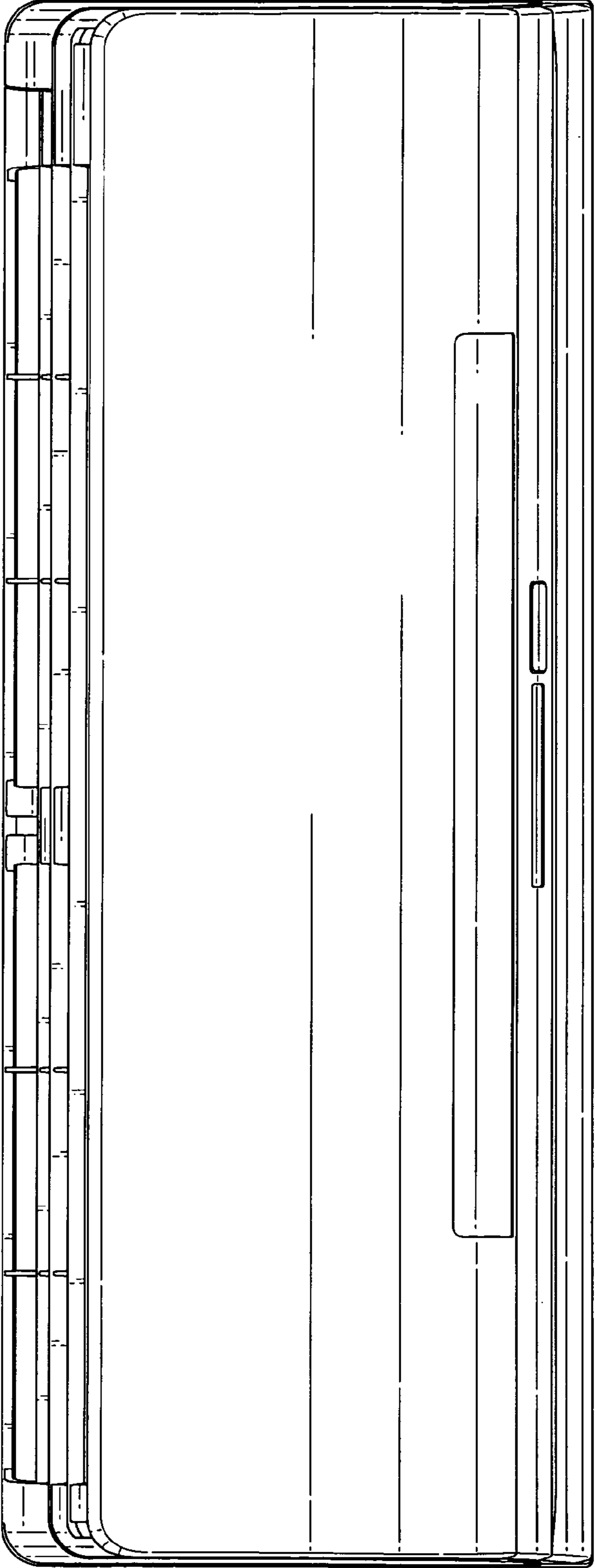

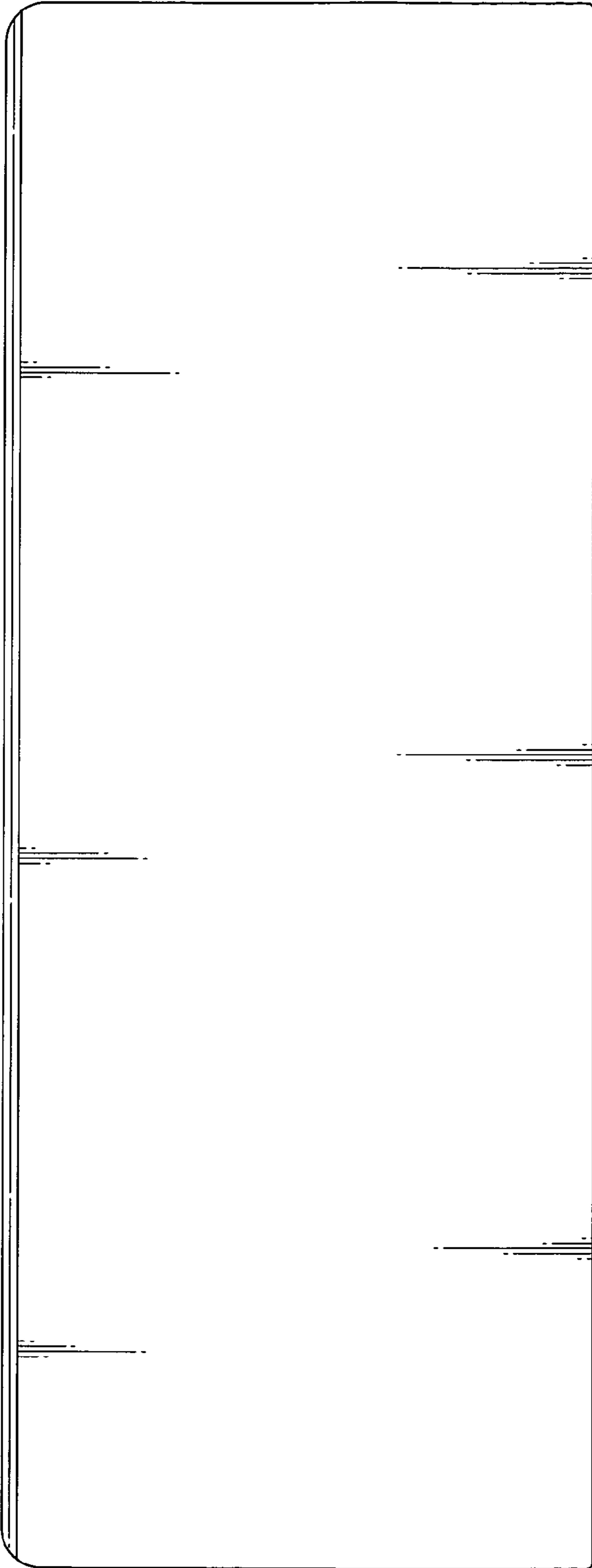

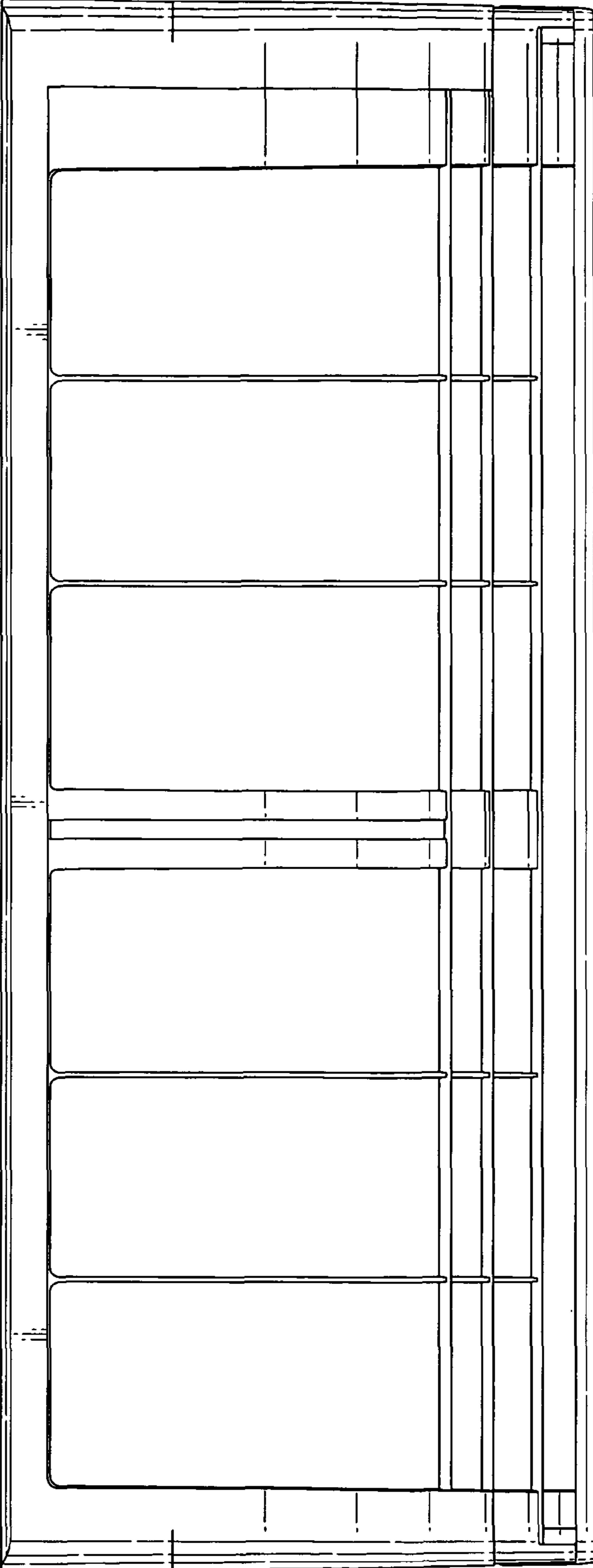

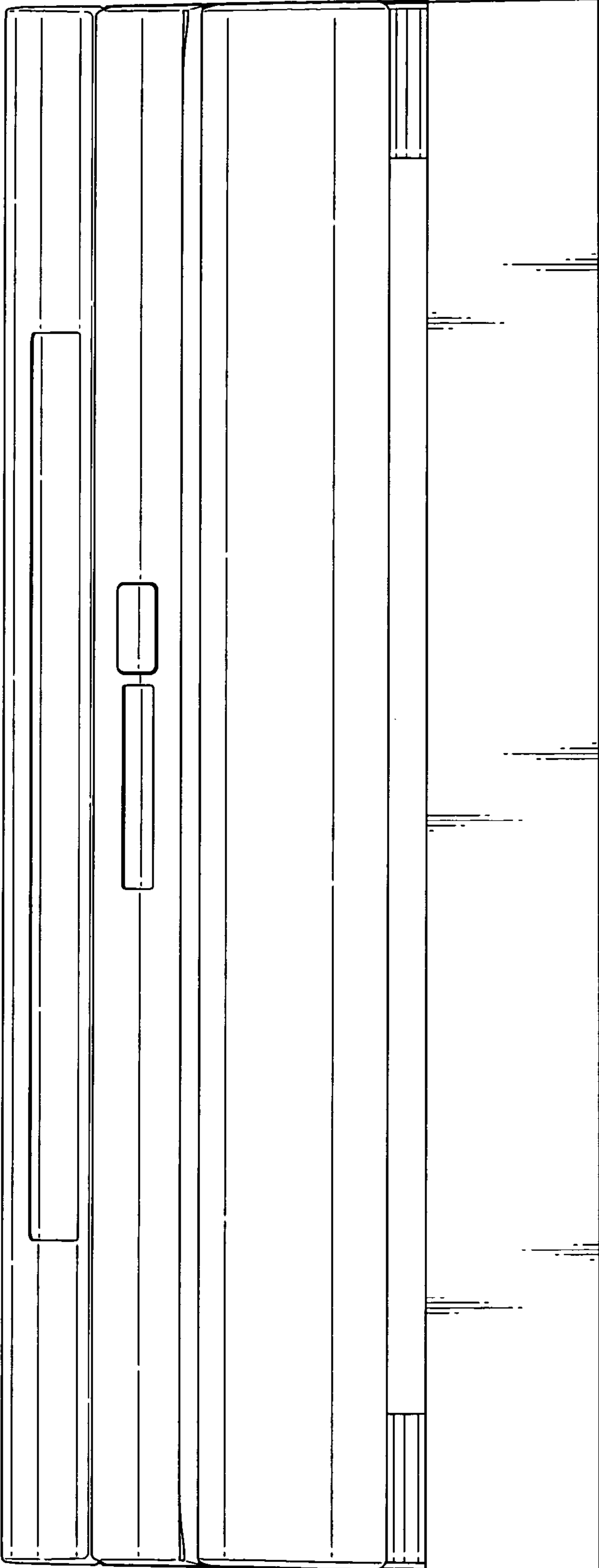

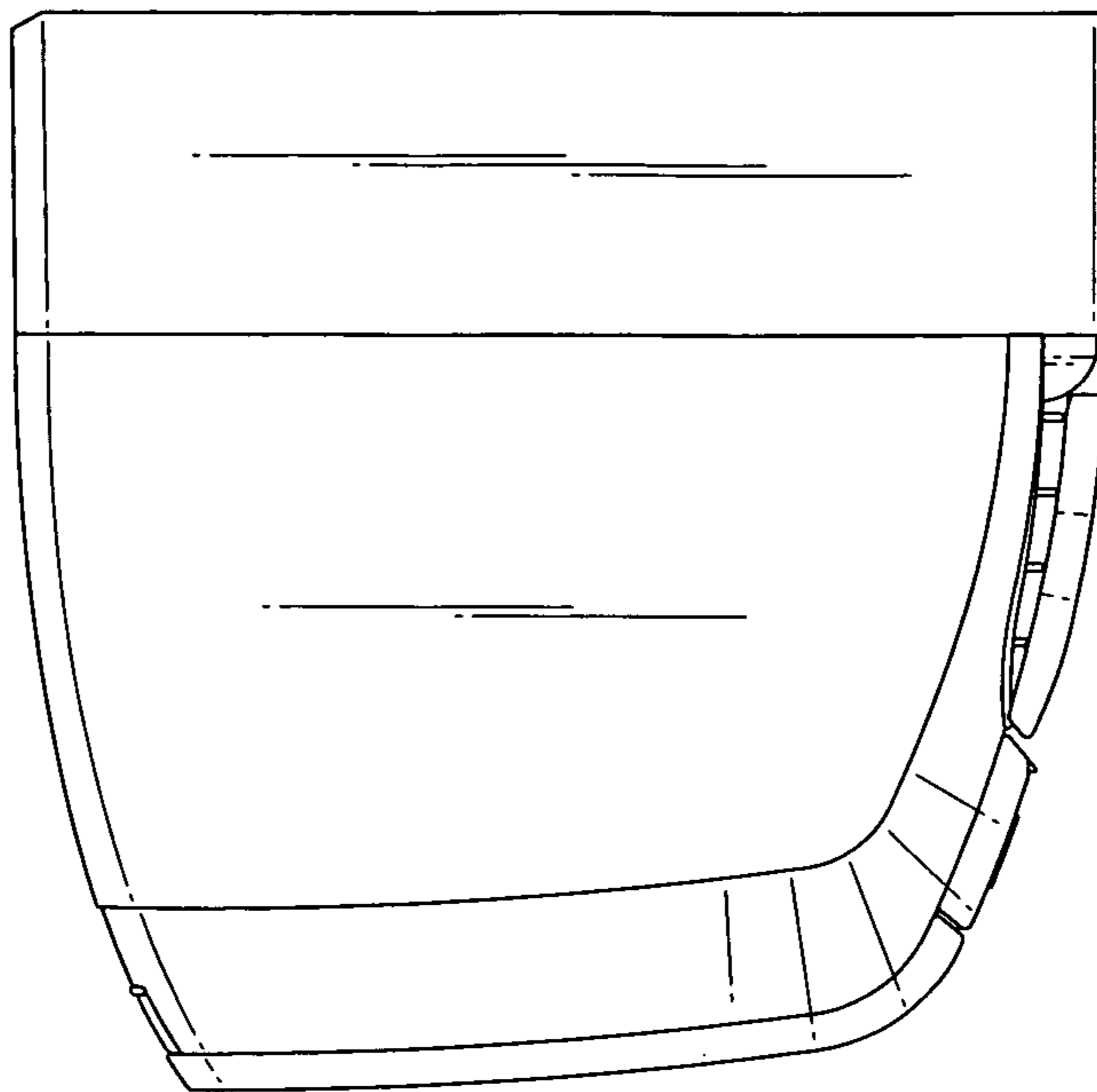

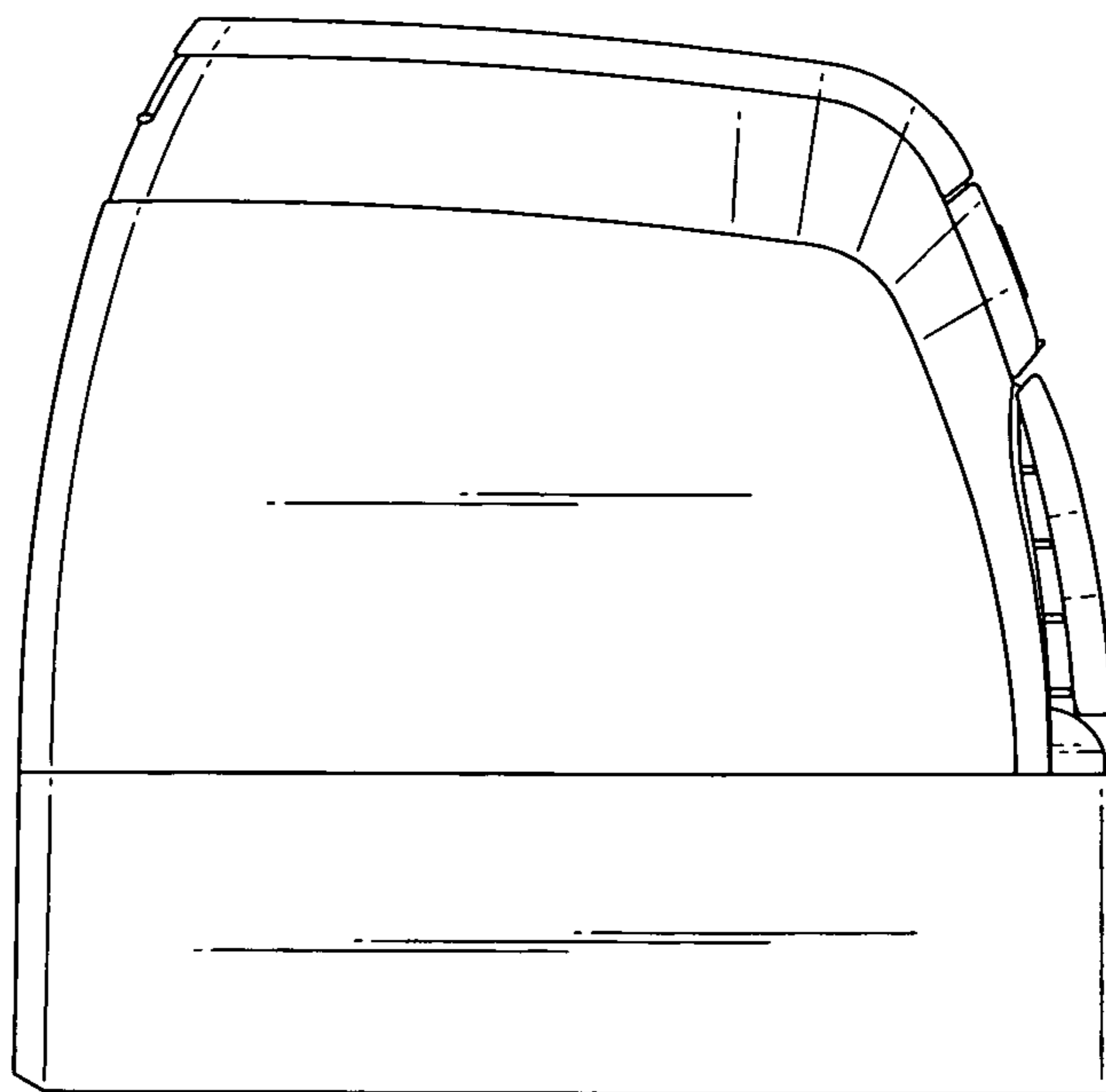
