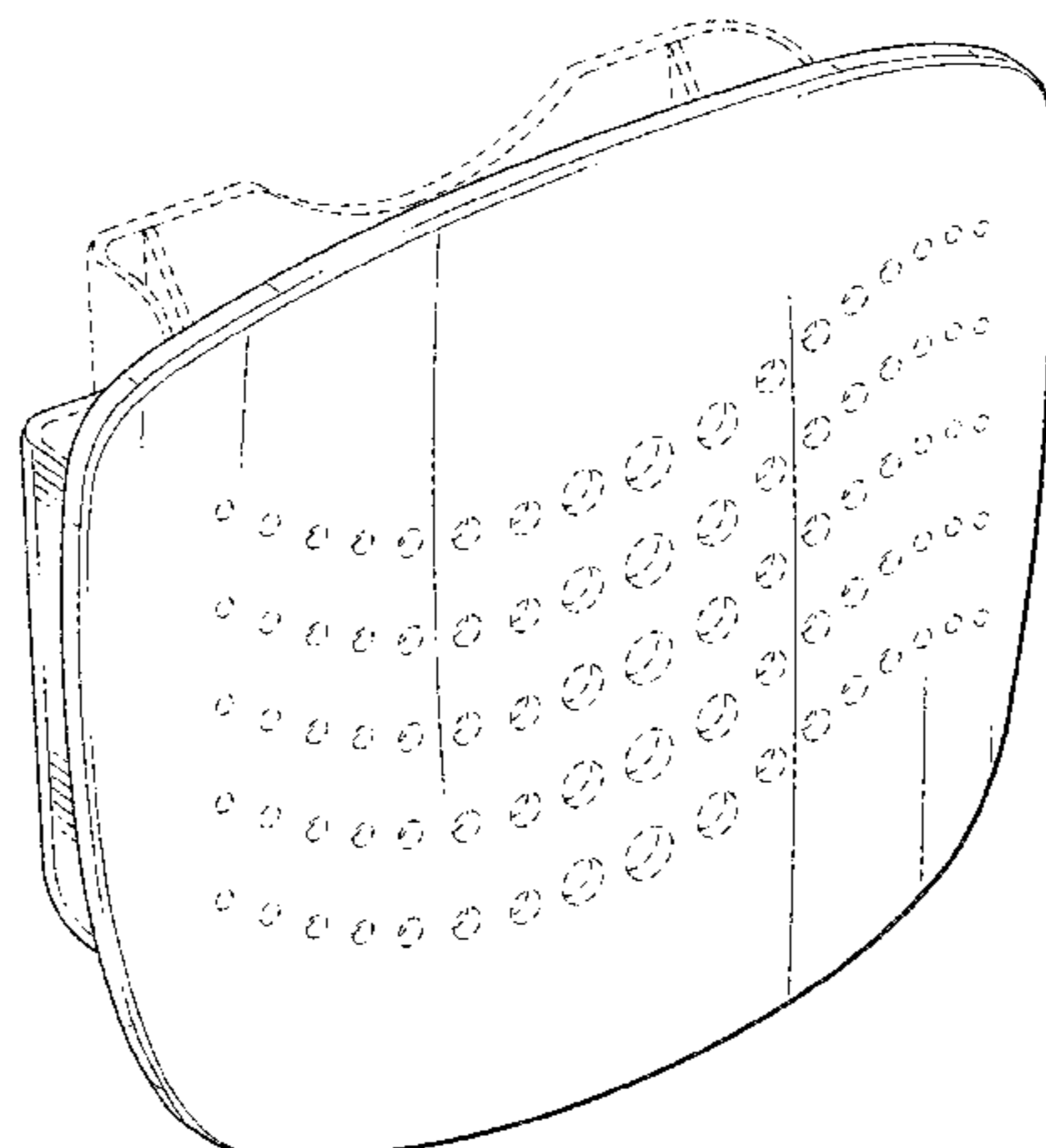
The ornamental design for an air freshener housing, as shown

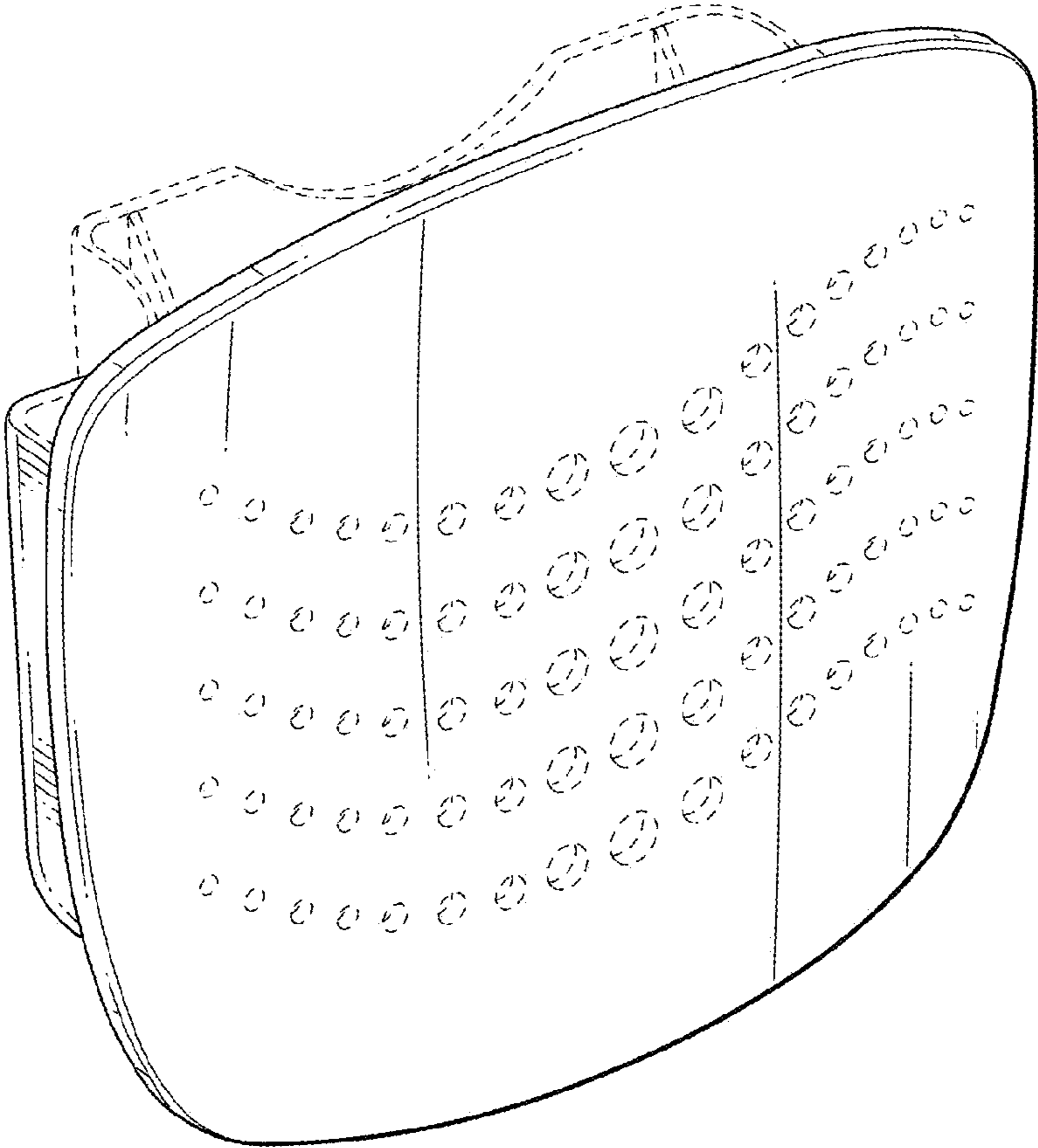

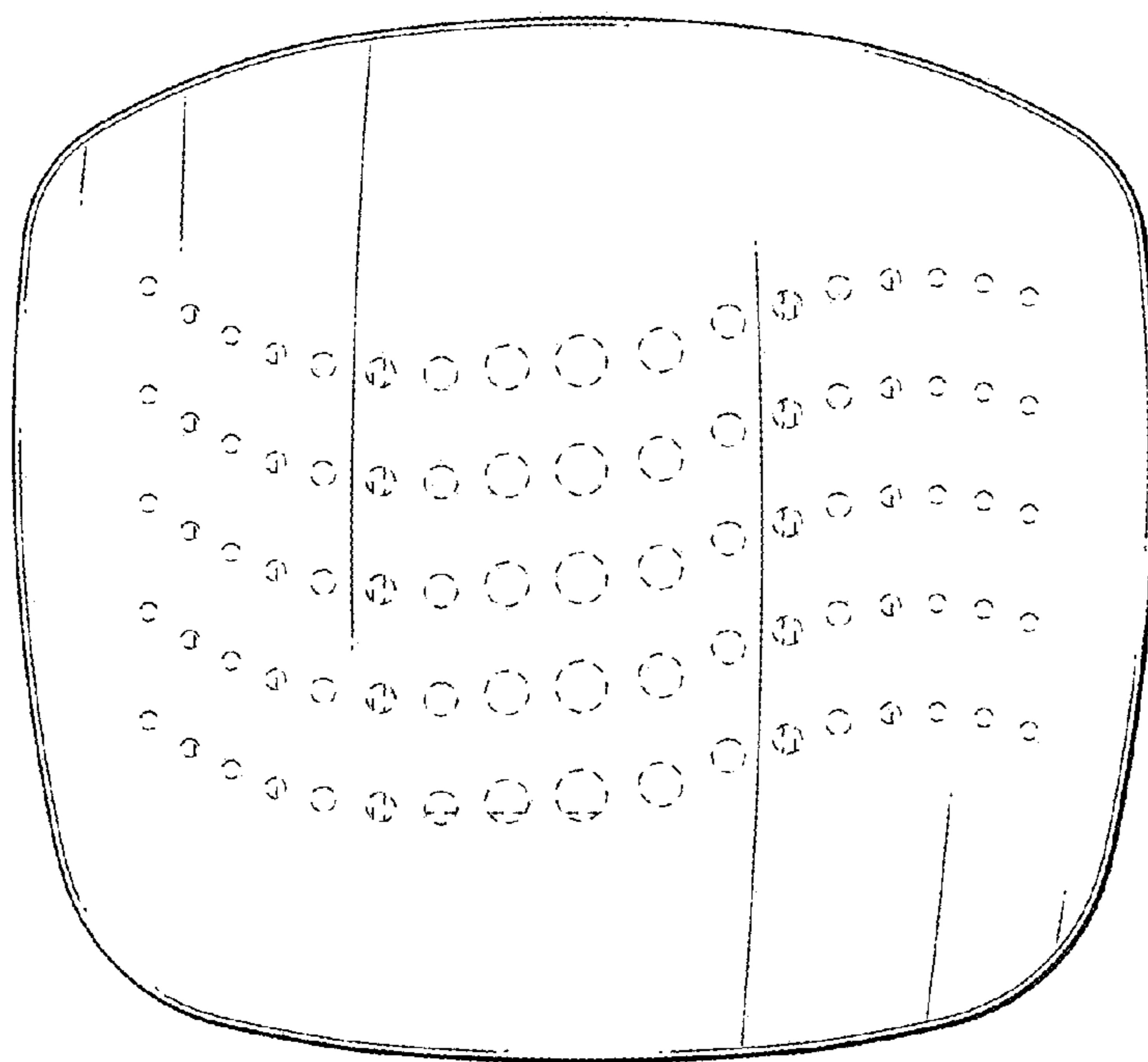

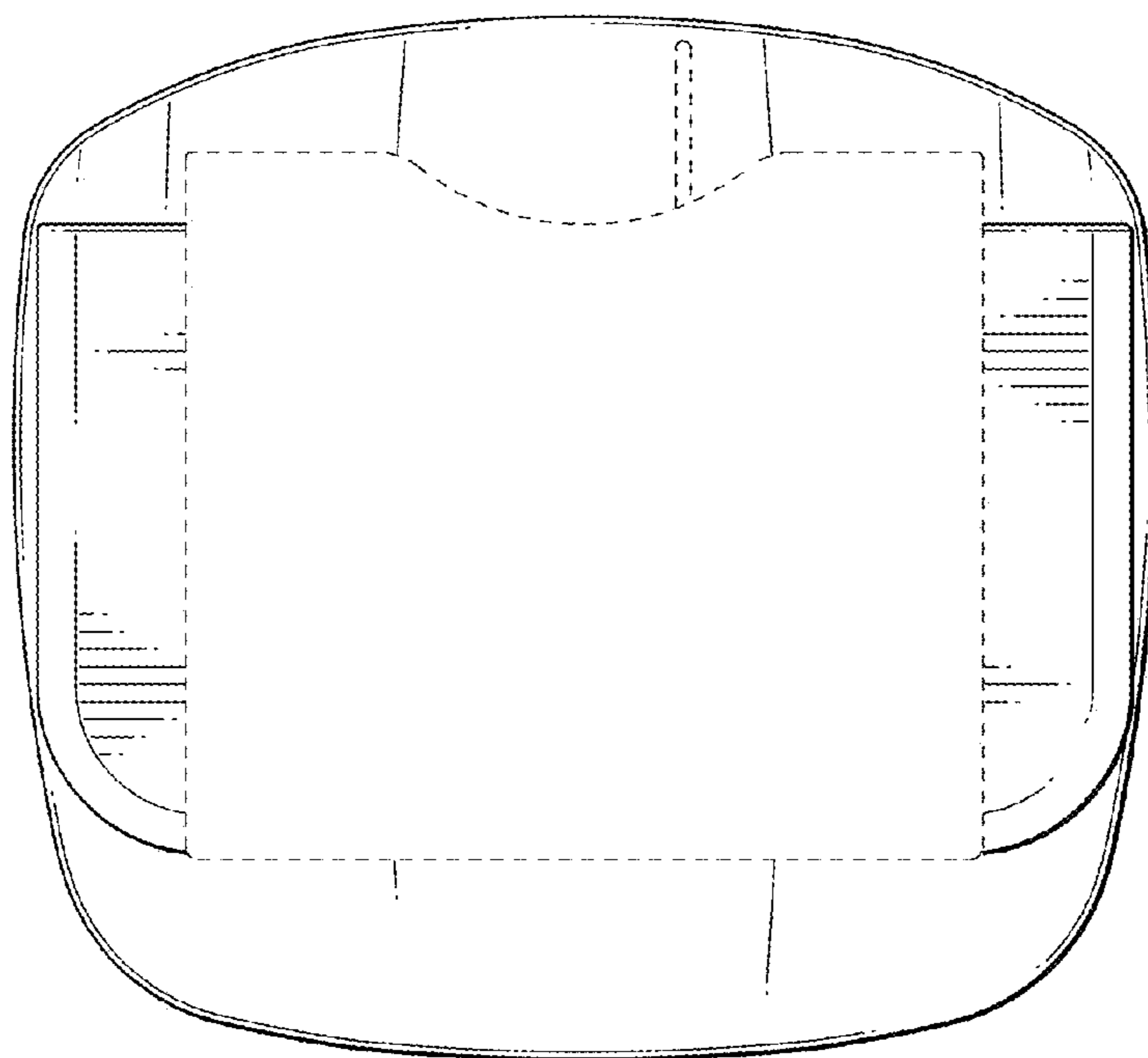

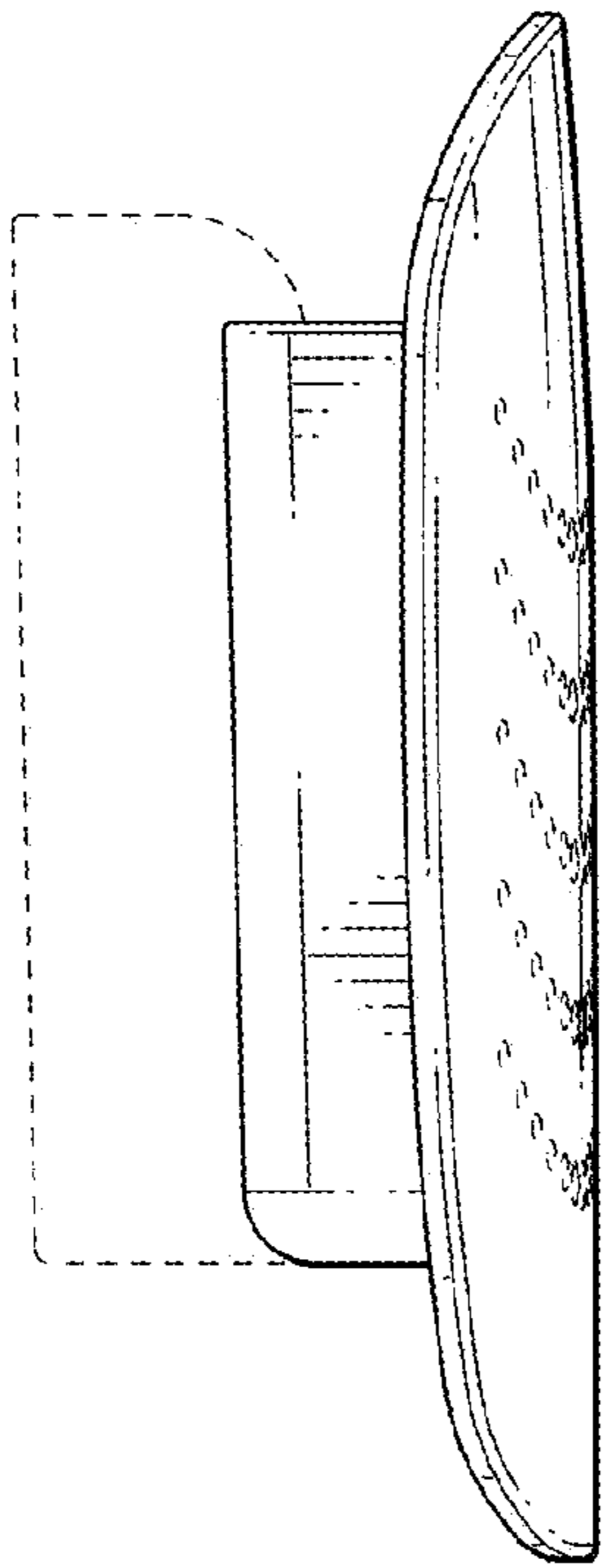

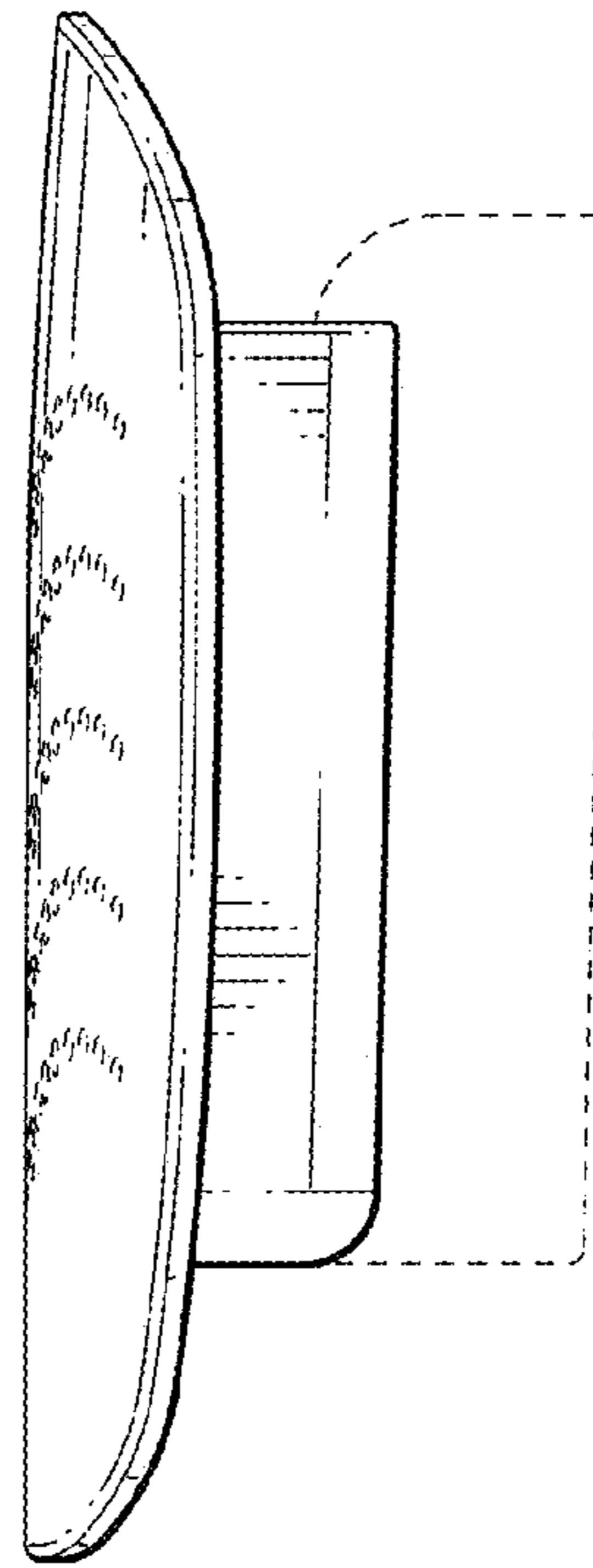

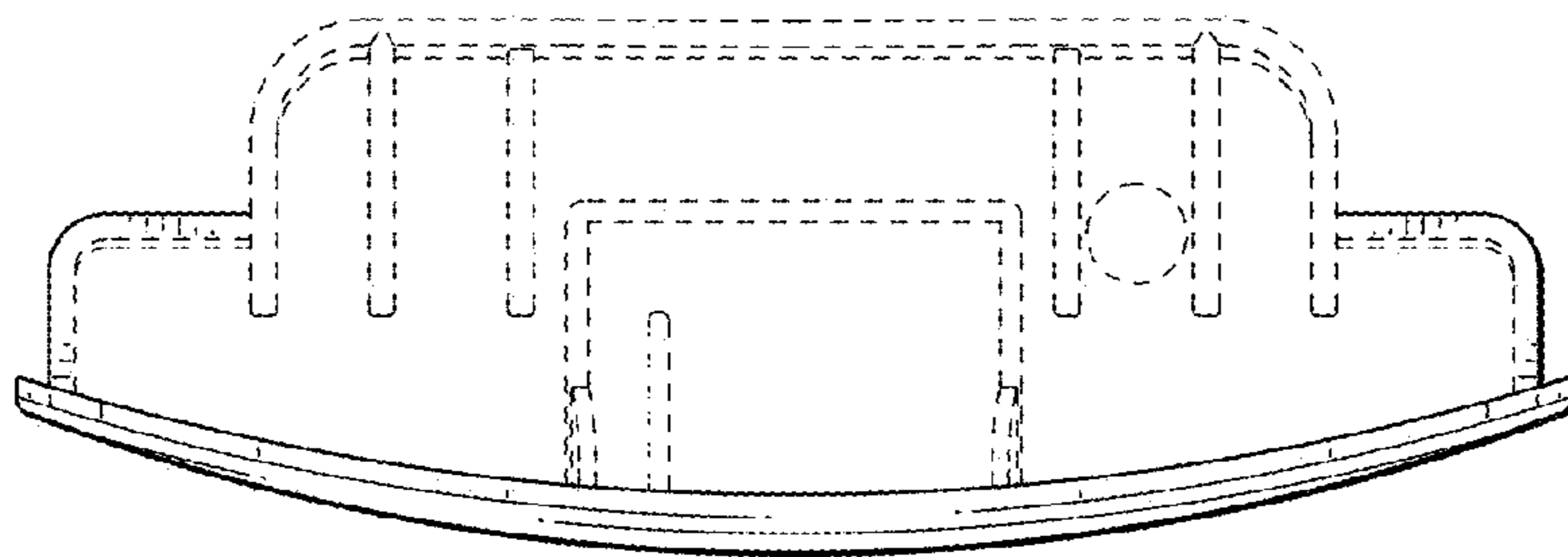

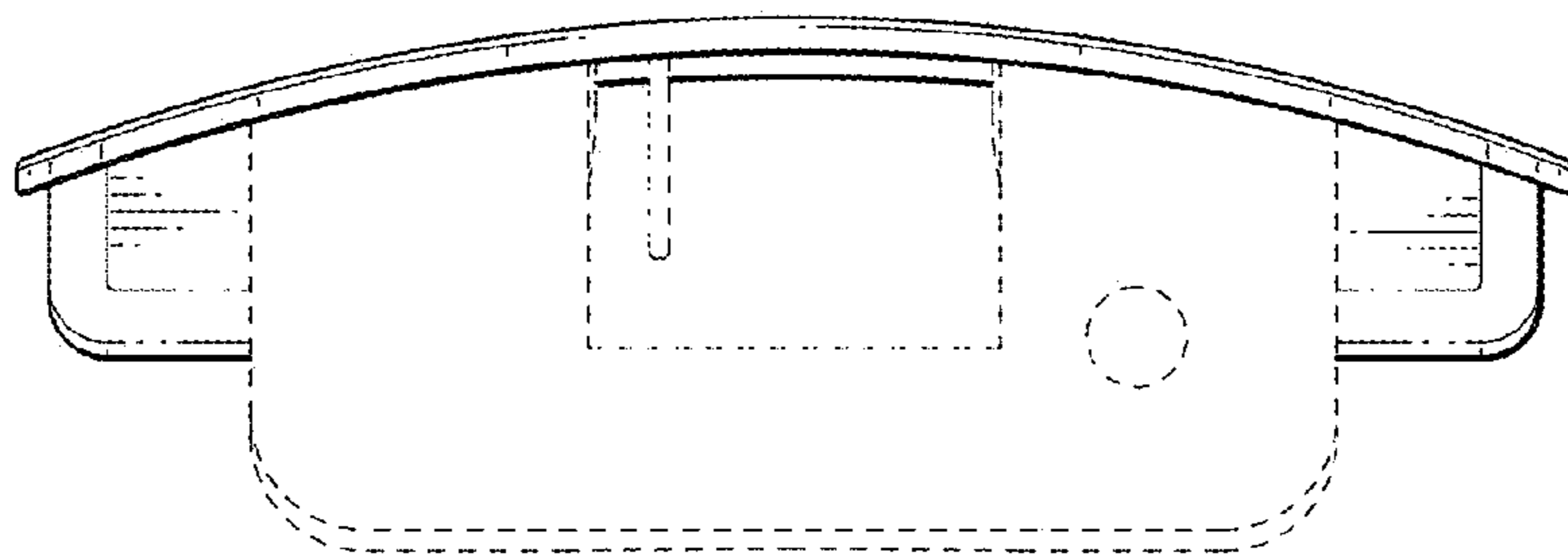
