(57) **CLAIM**

An ornamental design for a foot sleeve with bunion cushion, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a foot sleeve with bunion cushion showing my new design in condition of use on a human foot;

FIG. 2 is a front view of my new design;

FIG. 3 is a top view thereof;

FIG. 4 is a right side view thereof;

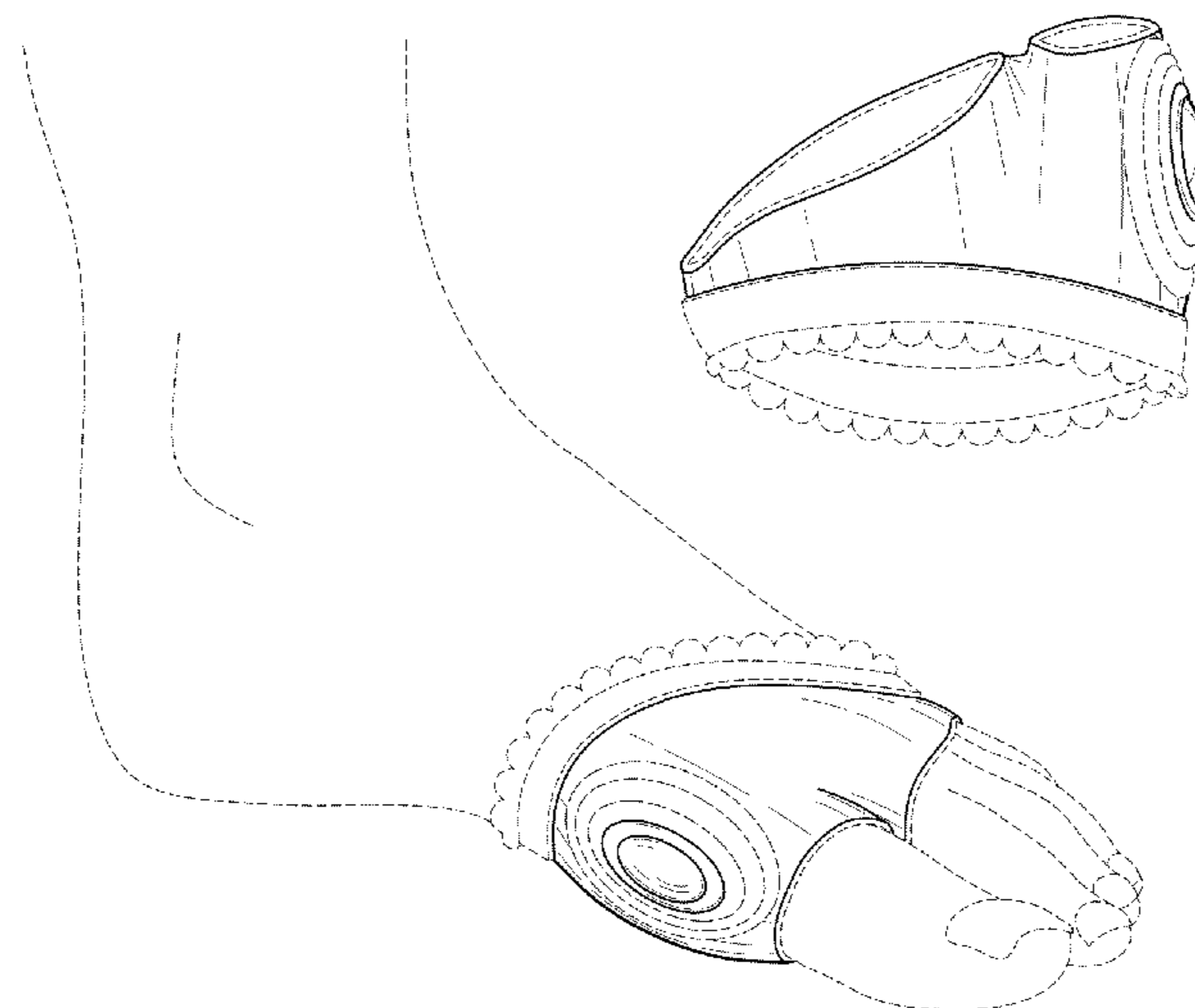
FIG. 5 is a rear view thereof;

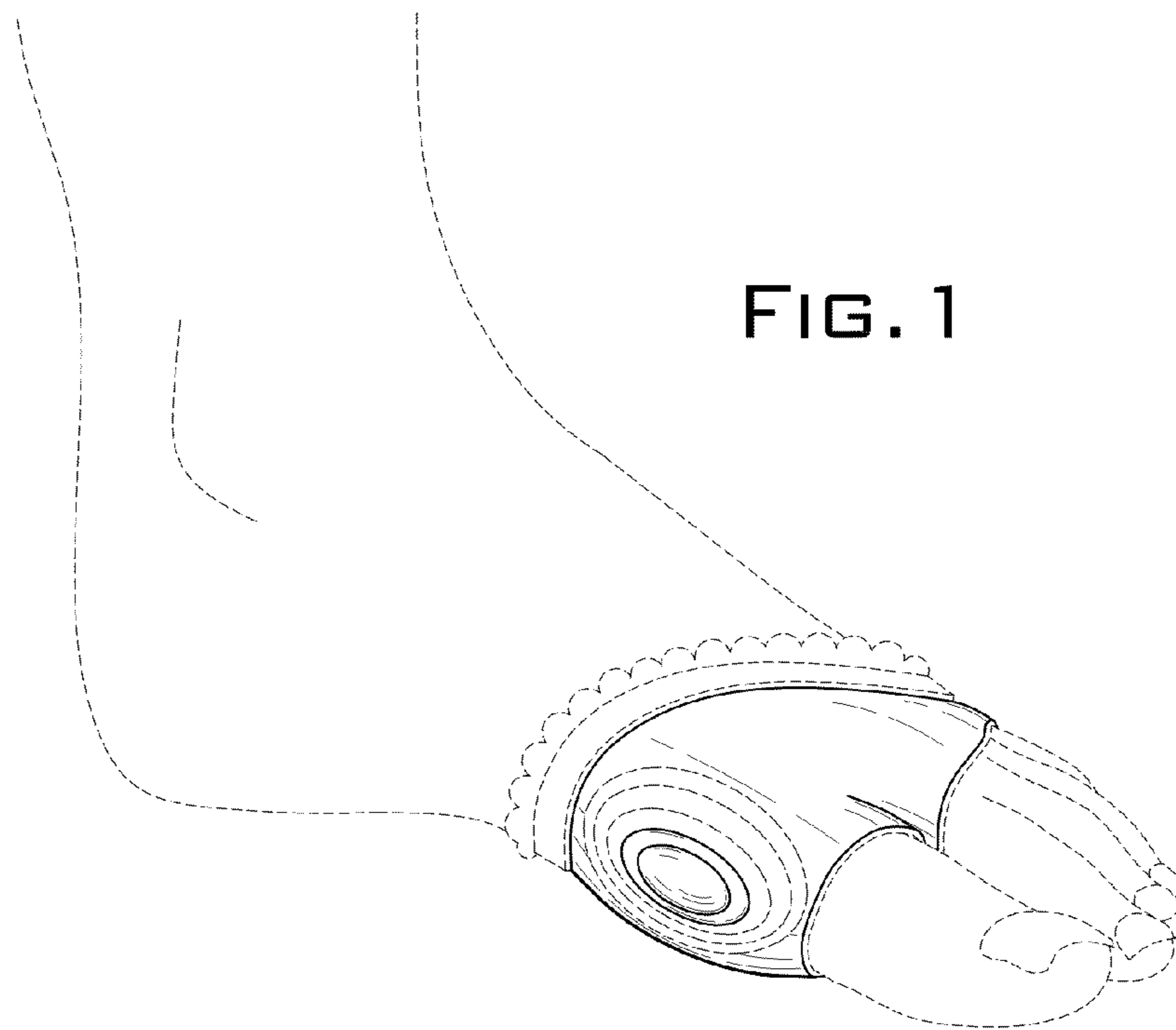

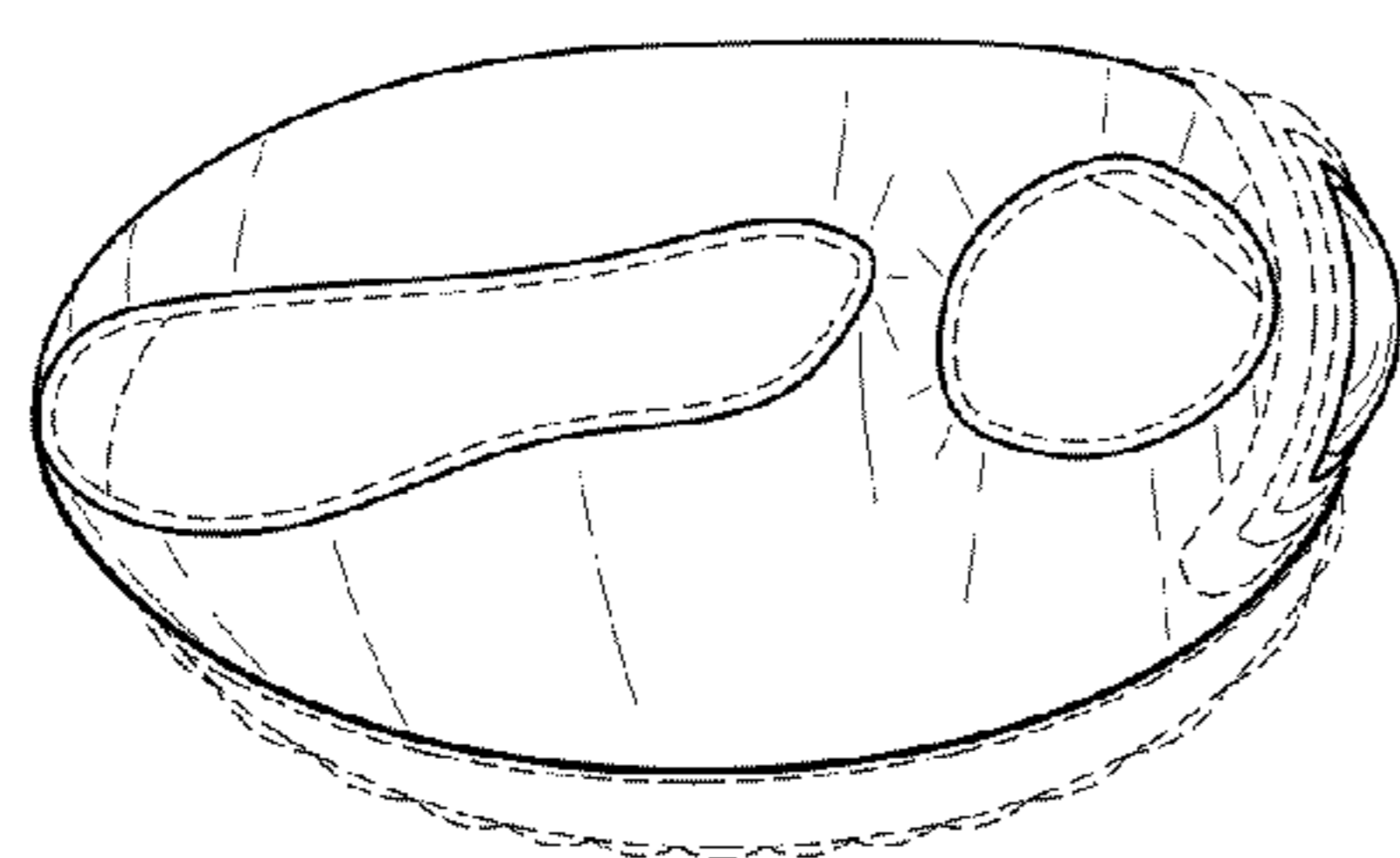

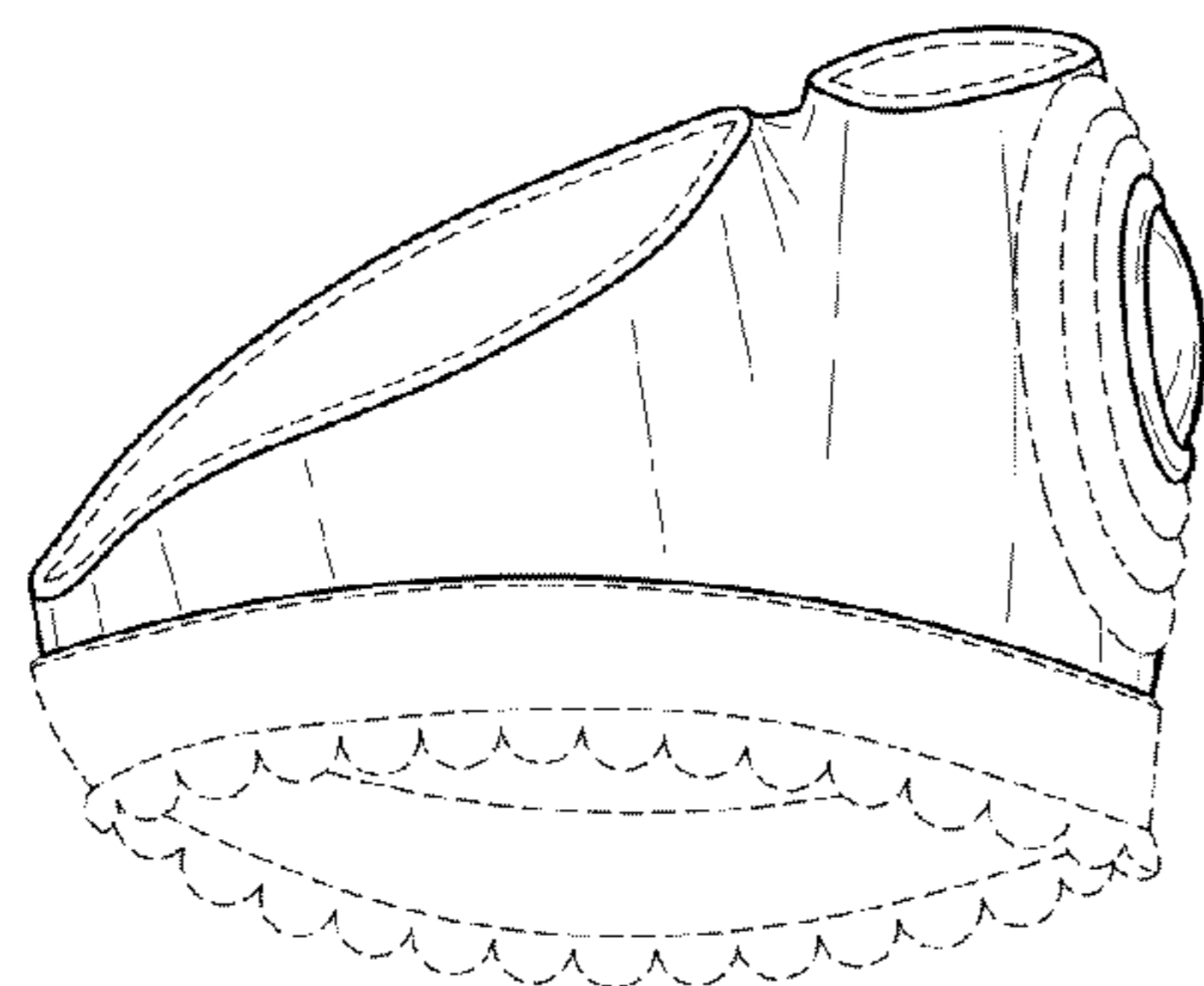

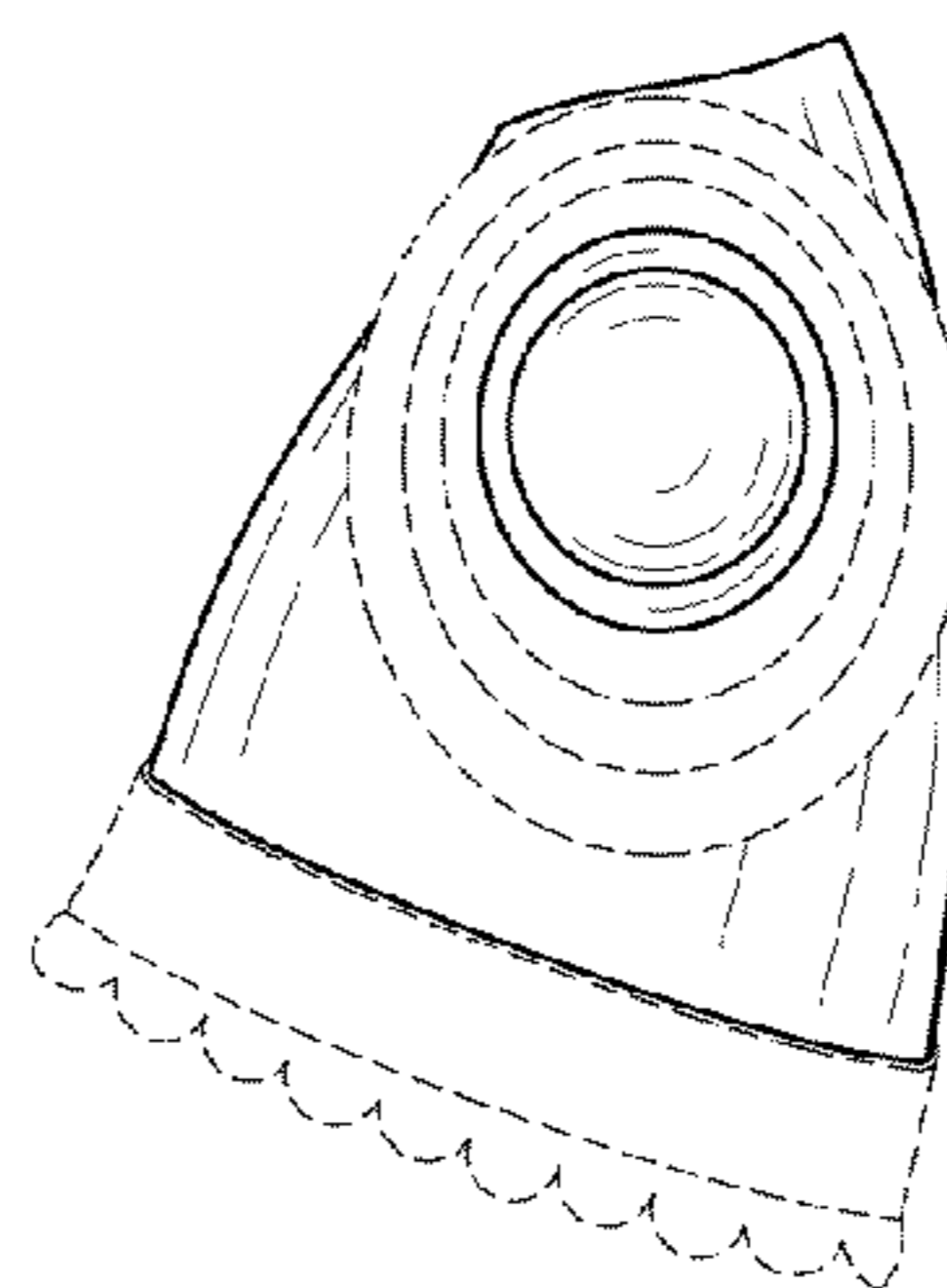

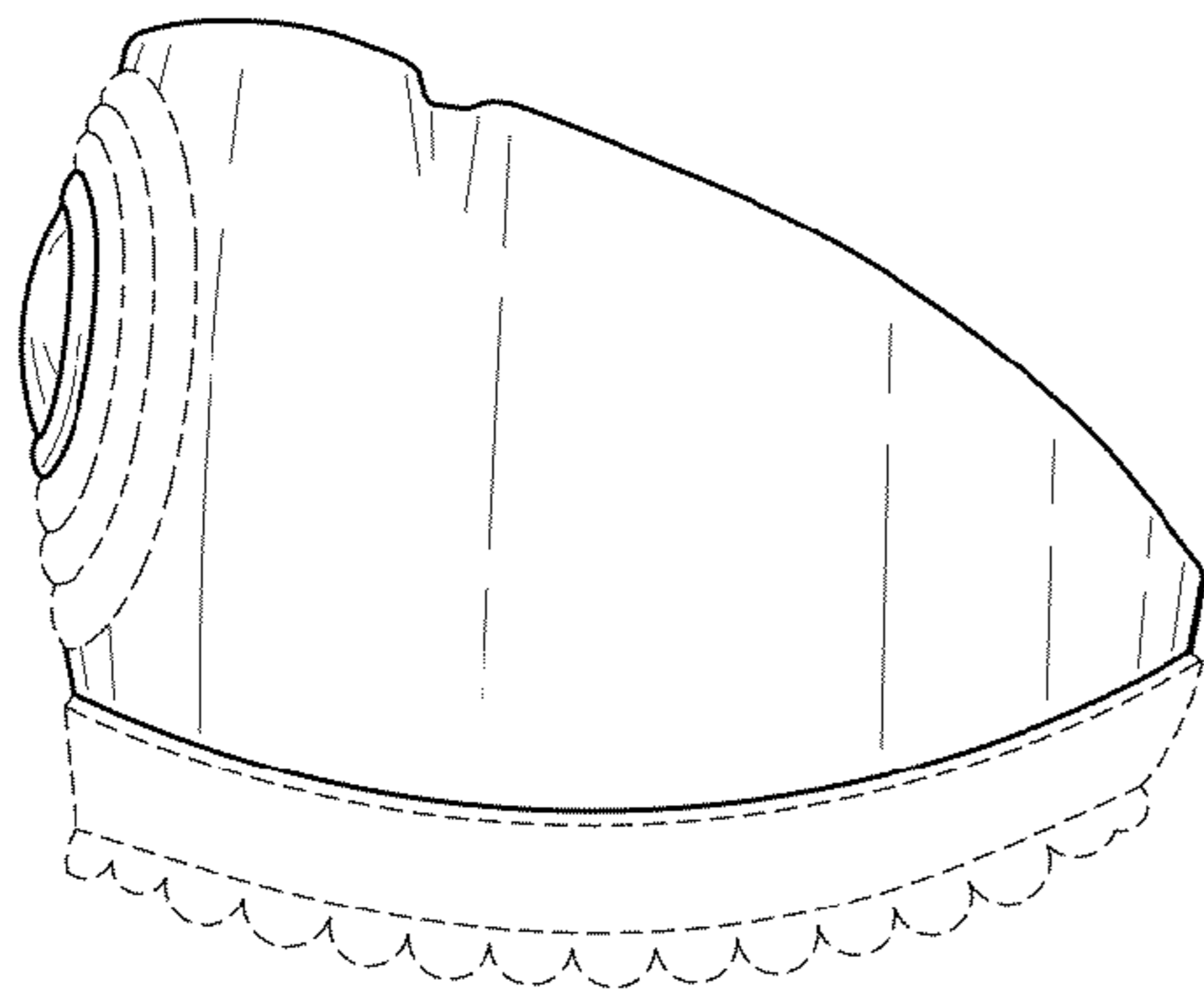

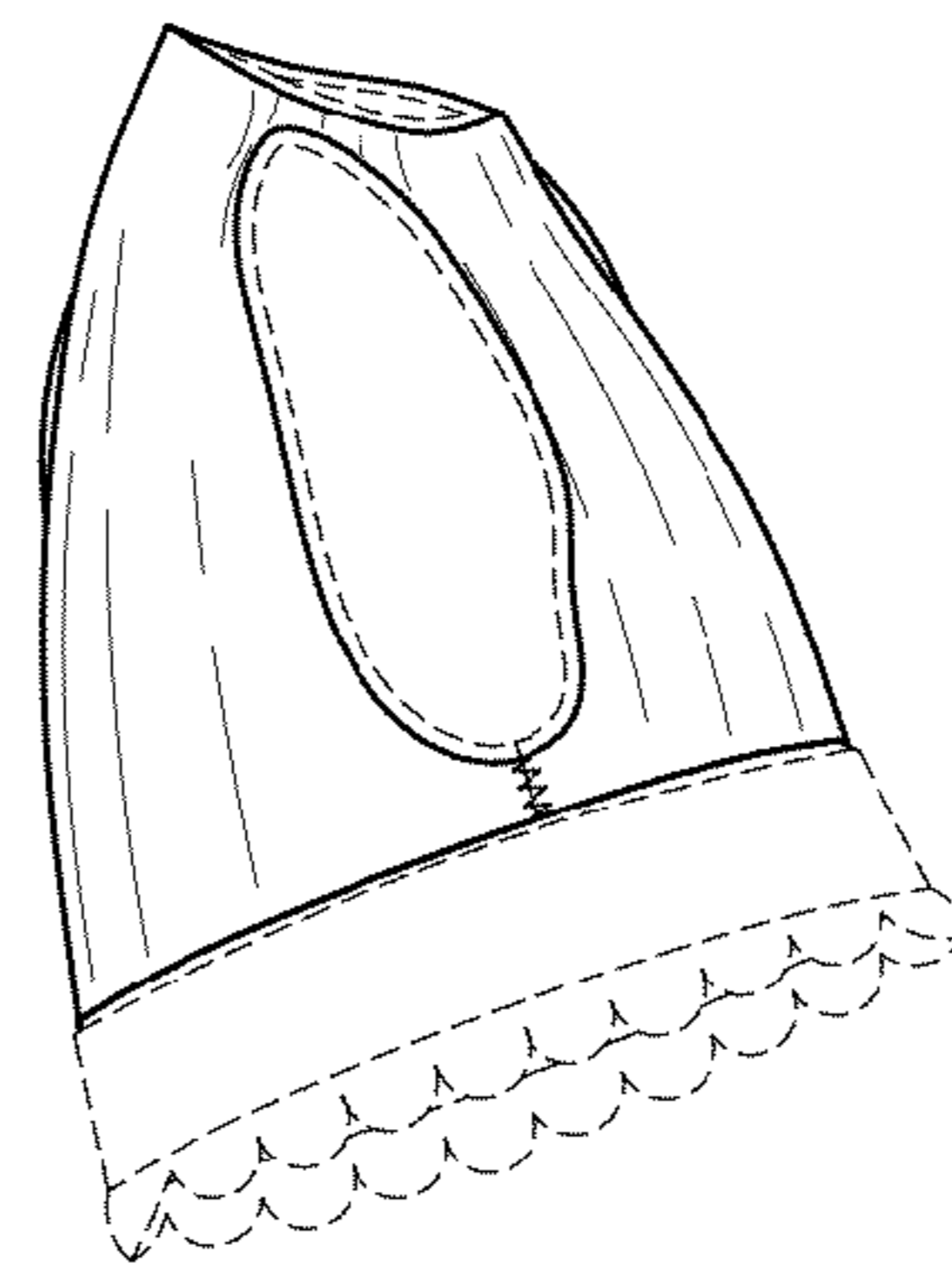

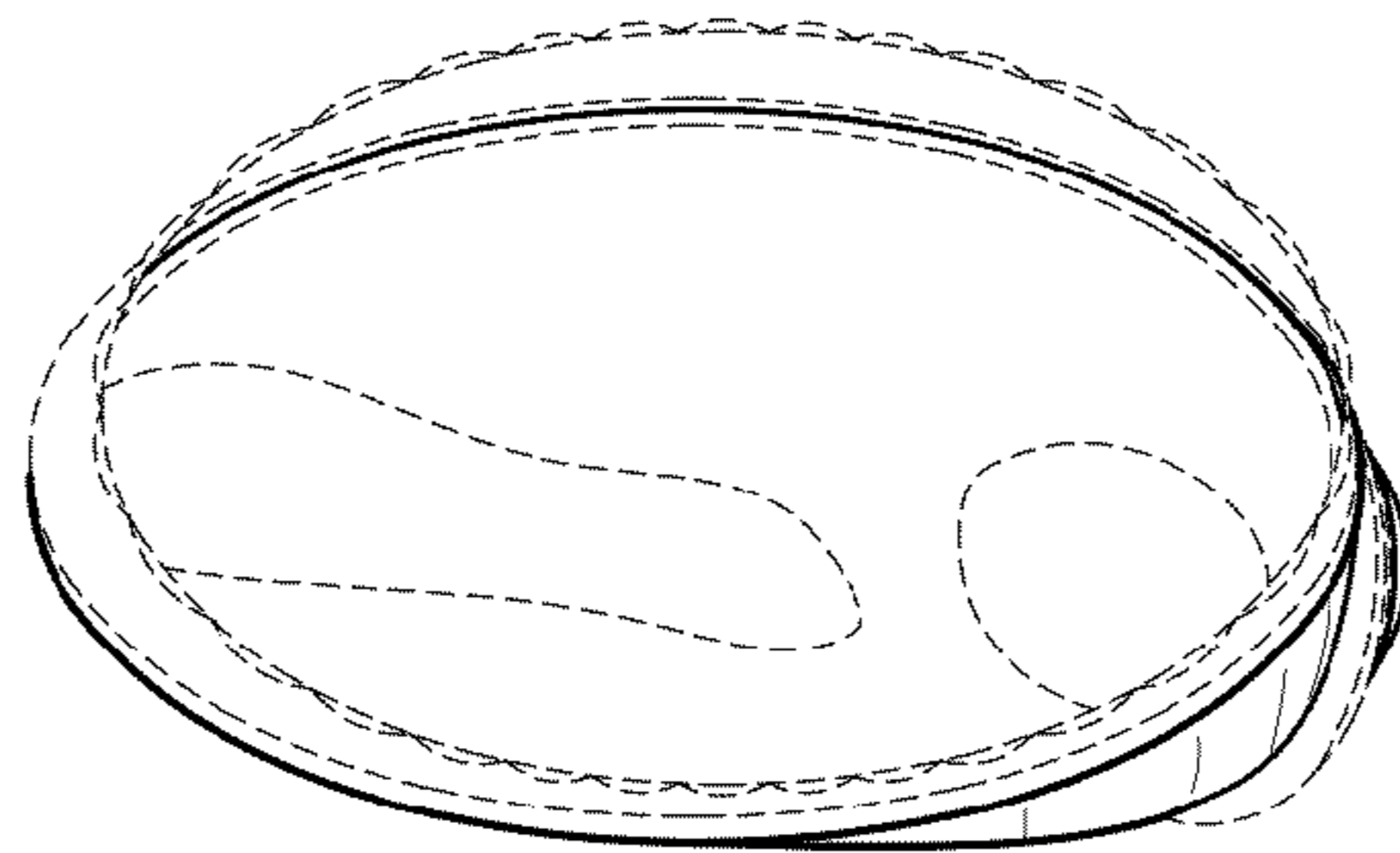
